(57) **CLAIM**

The ornamental design for a pillow case for infants with outer appendages and attached blanket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pillow case for infants with outer appendages and attached blanket showing my new design;

FIG. 2 is a top view of the pillow case for infants with outer appendages and attached blanket;

FIG. 3 is a right side view of the pillow case for infants with outer appendages and attached blanket;

FIG. 4 is a left side view of the pillow case for infants with outer appendages and attached blanket;

FIG. 5 is a front view of the pillow case for infants with outer appendages and attached blanket;

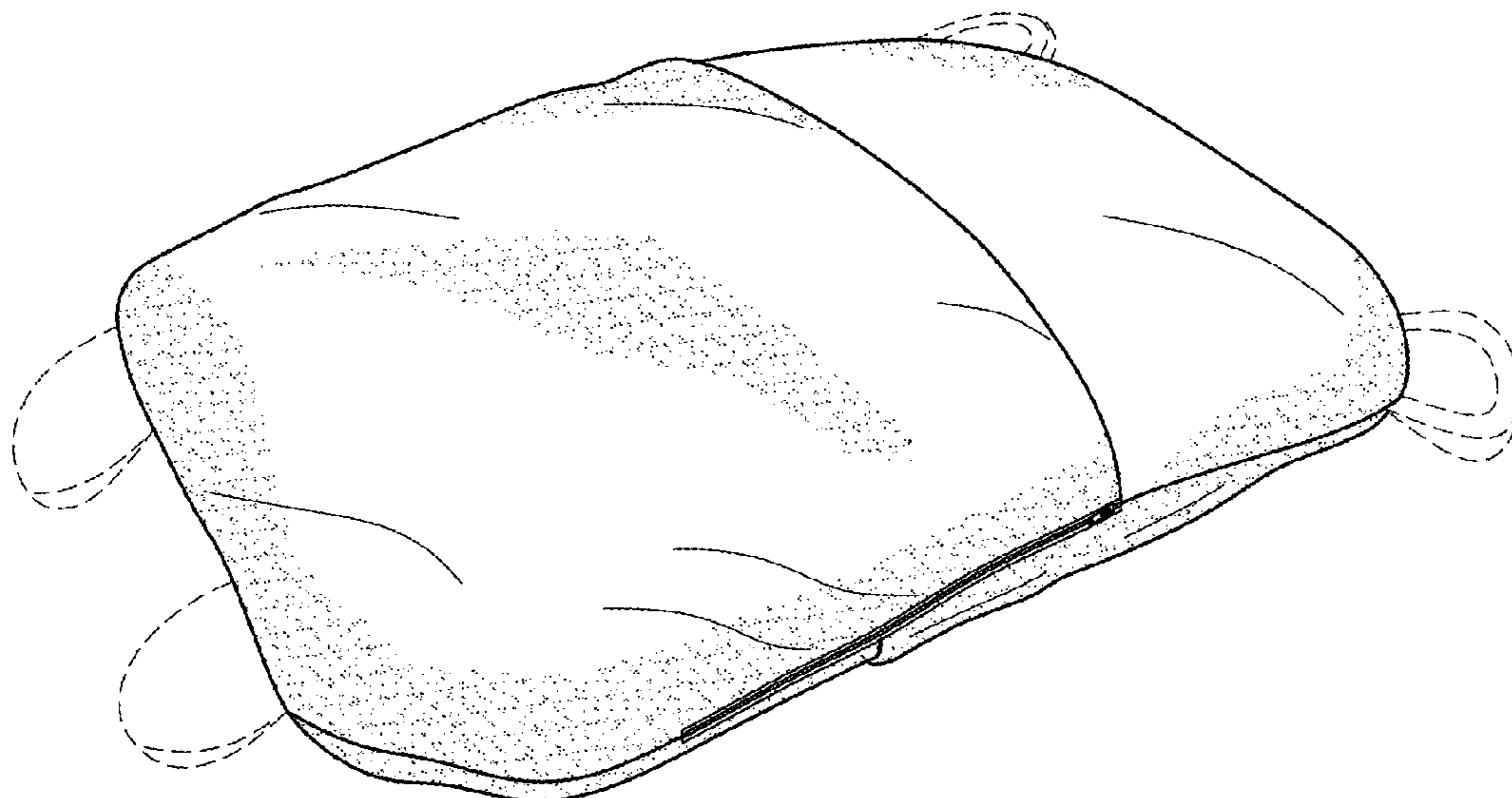
FIG. 6 is a rear view of the pillow case for infants with outer appendages and attached blanket;

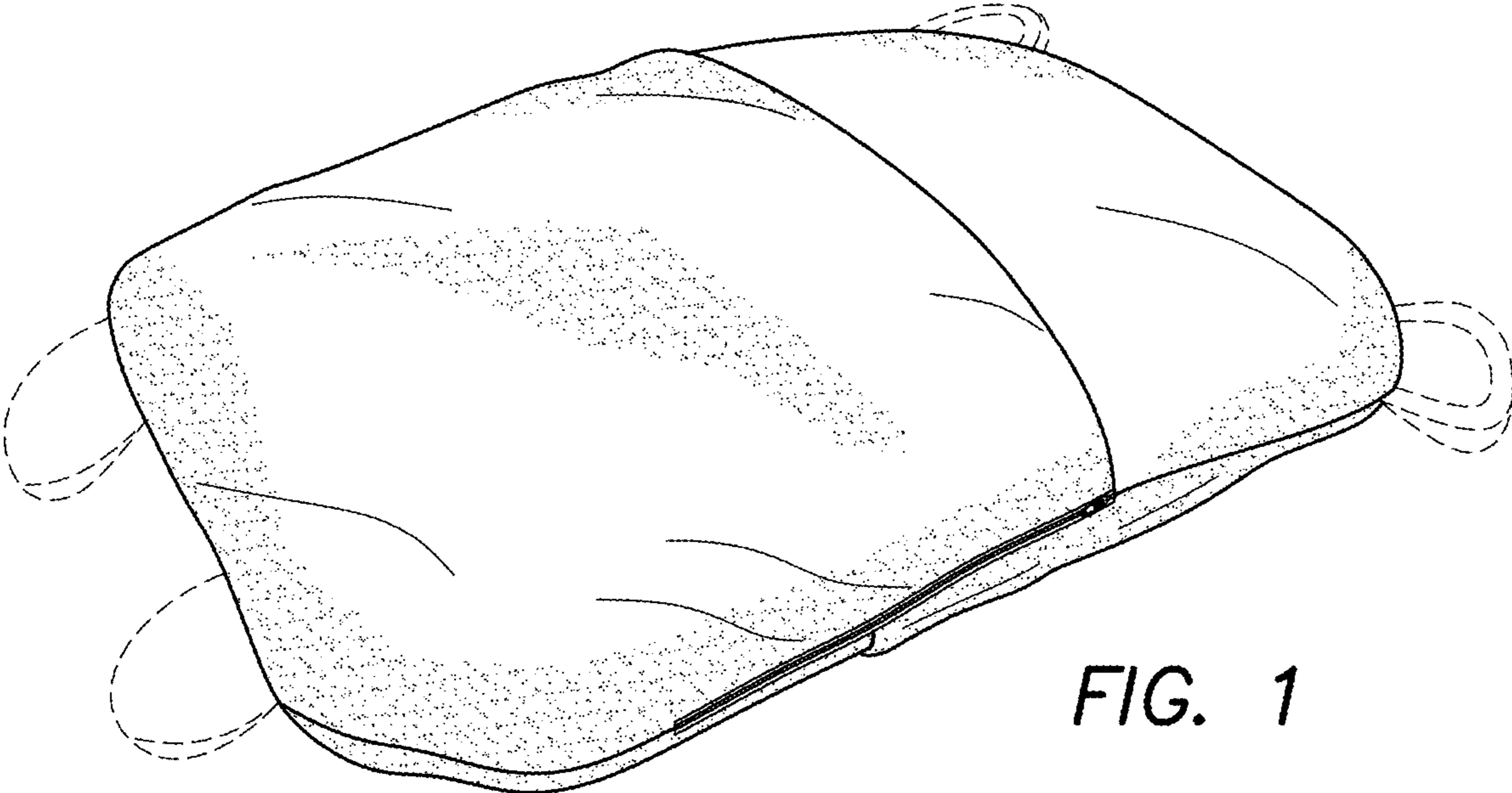
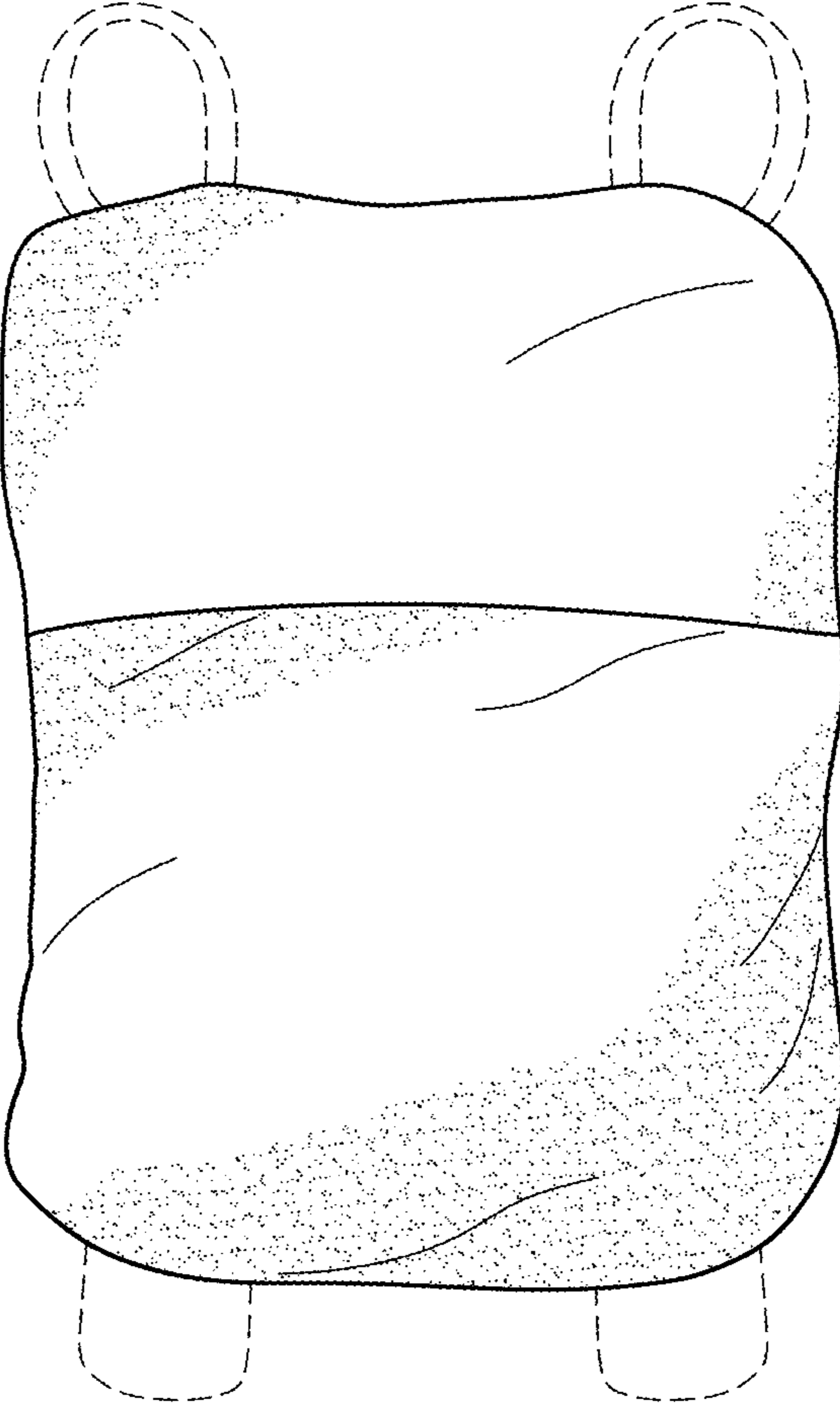

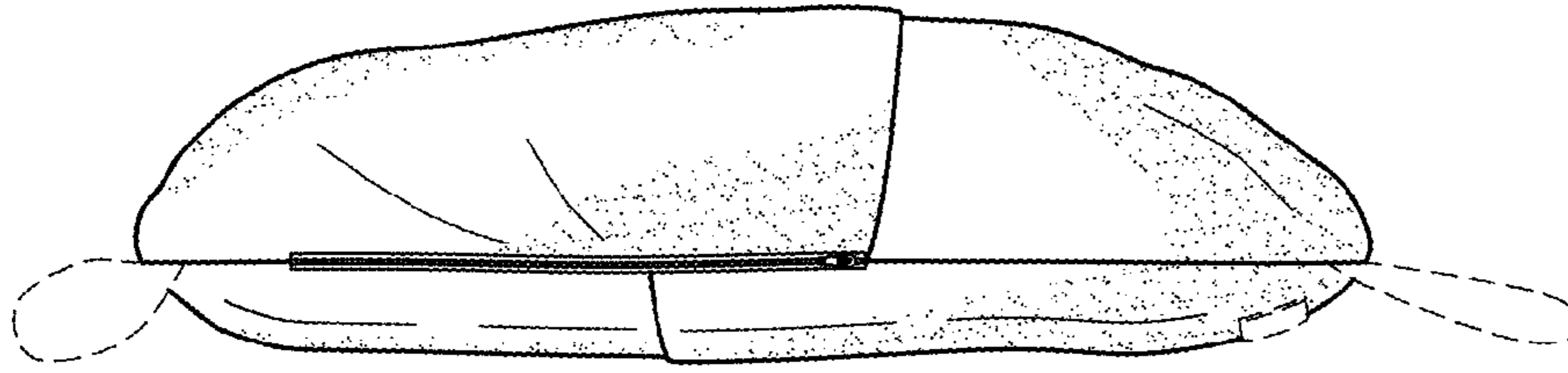

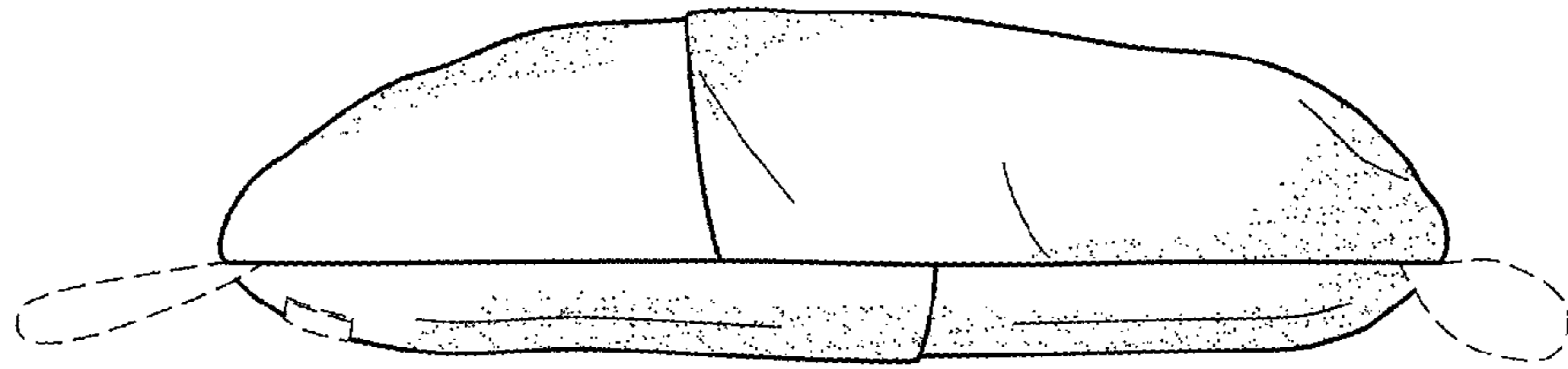

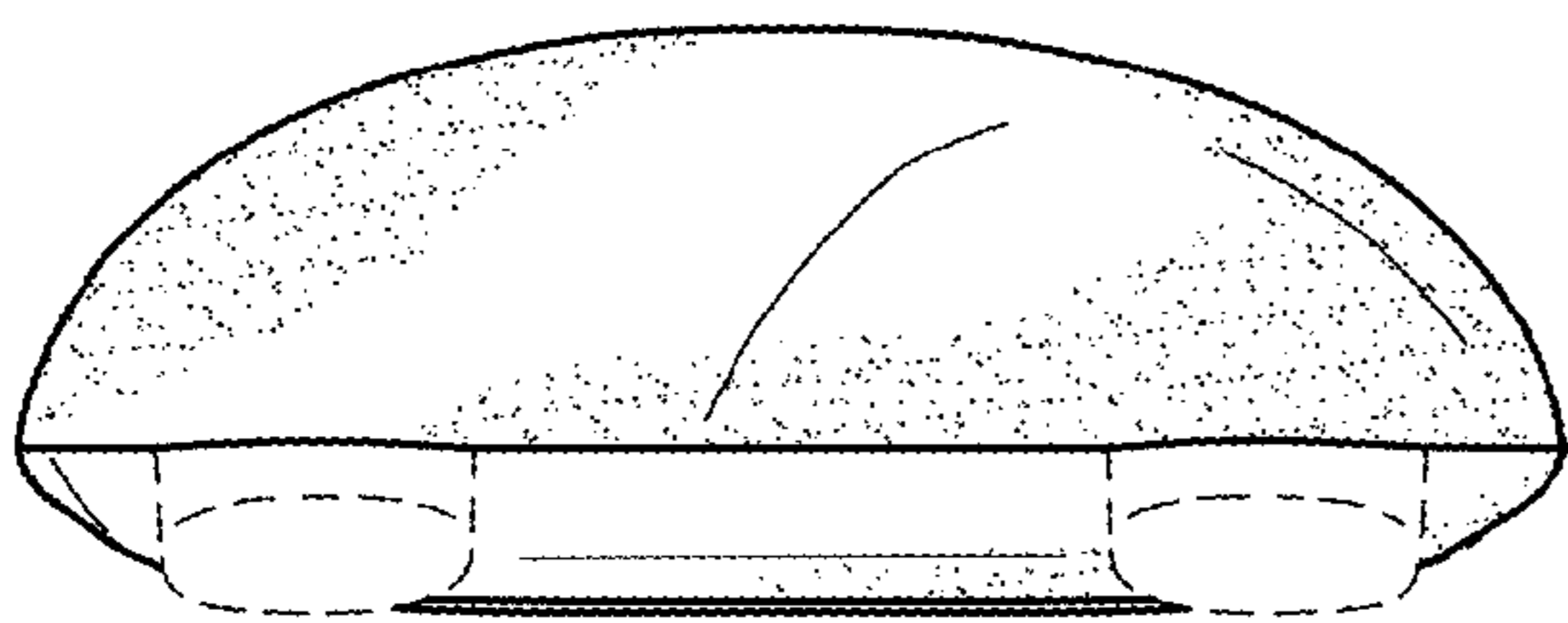

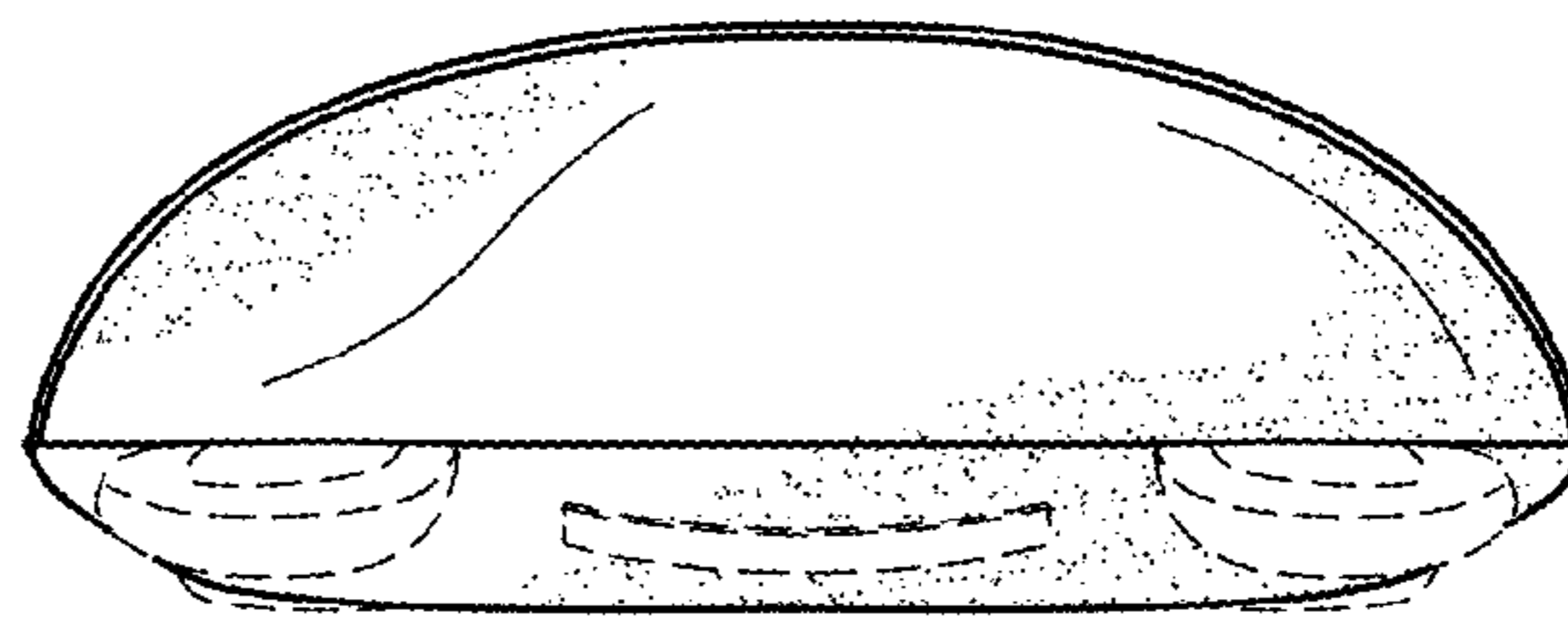

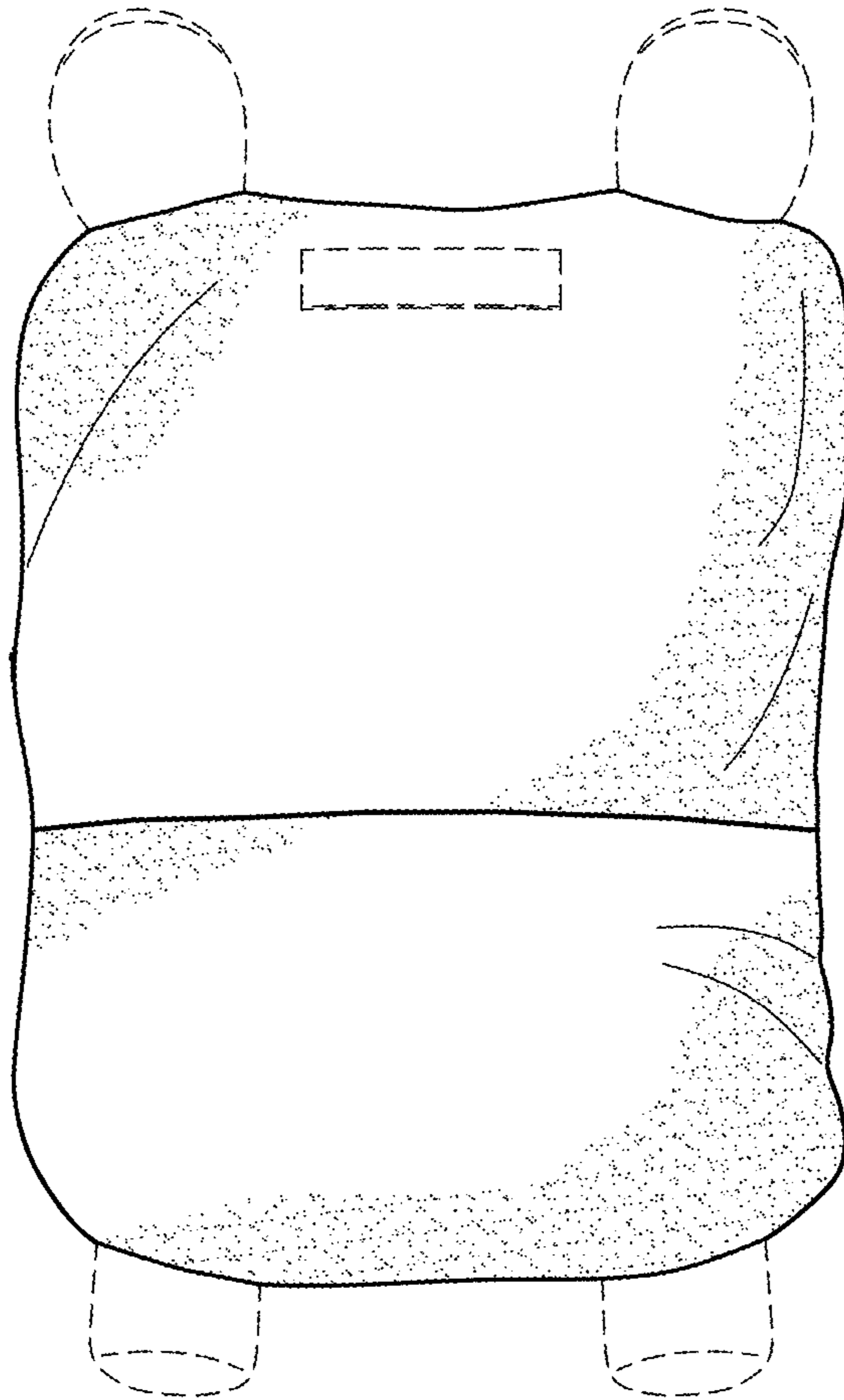

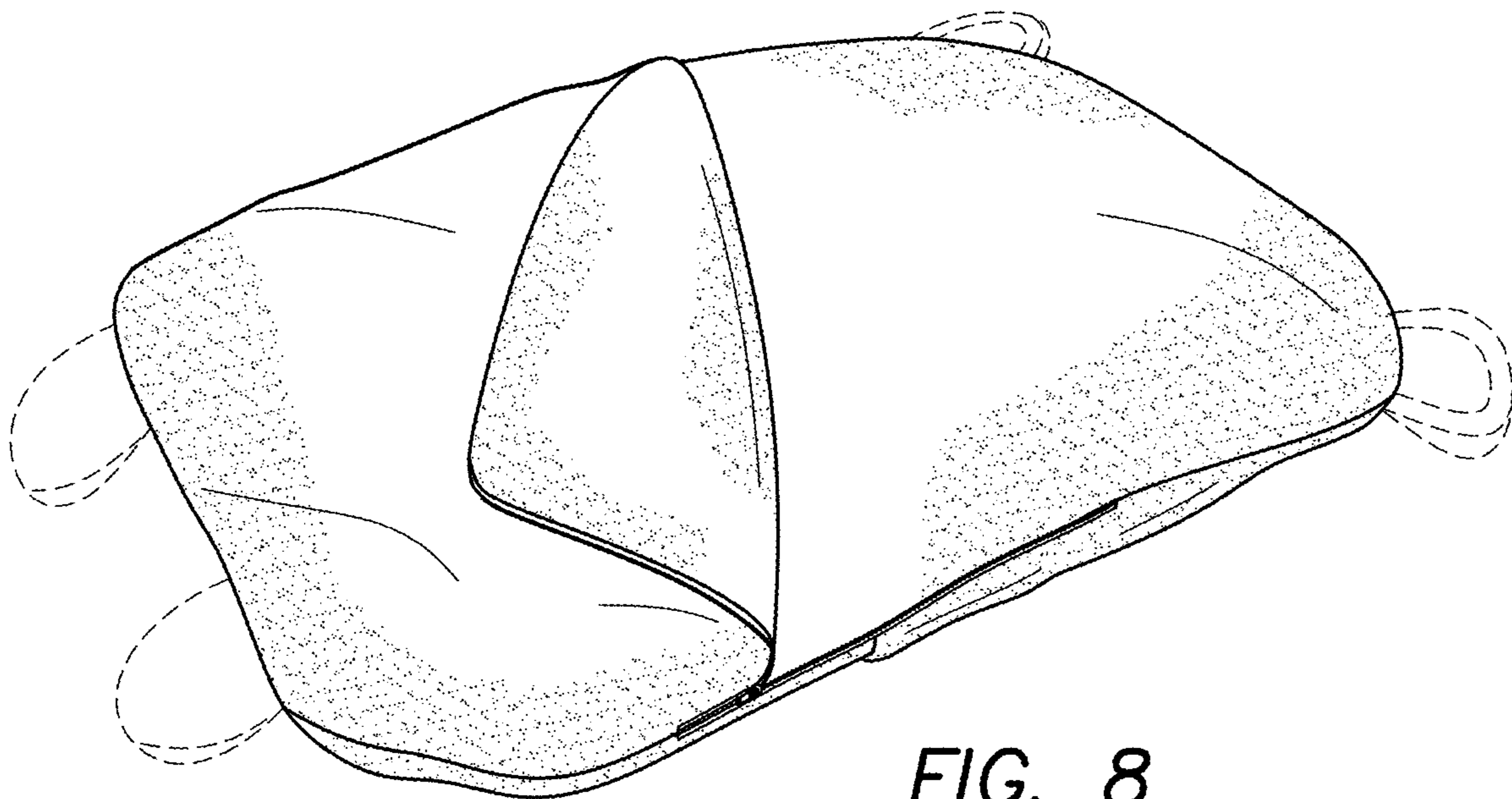
