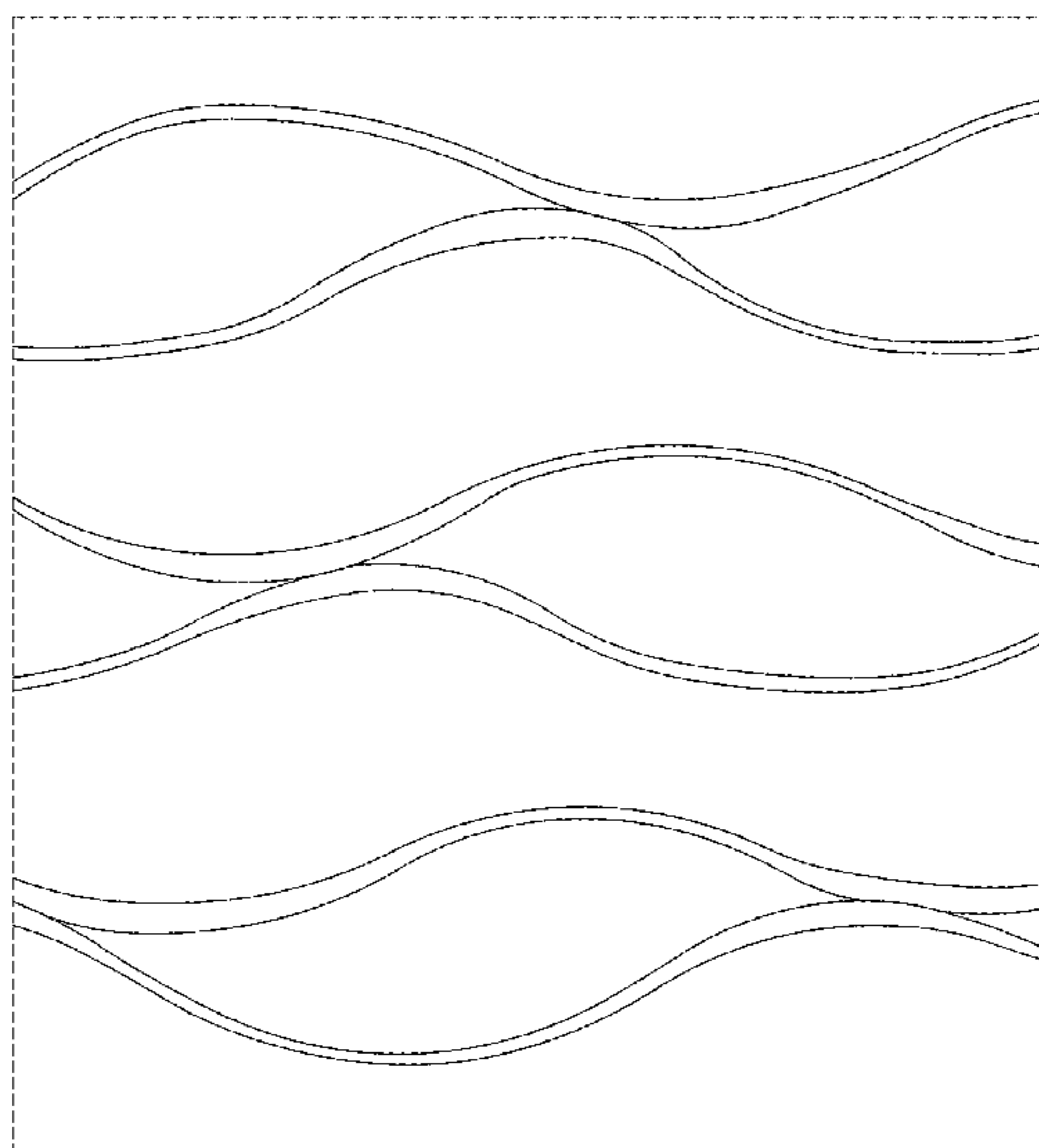
The ornamental design for a pattern for a mattress cover, as shown and described.
