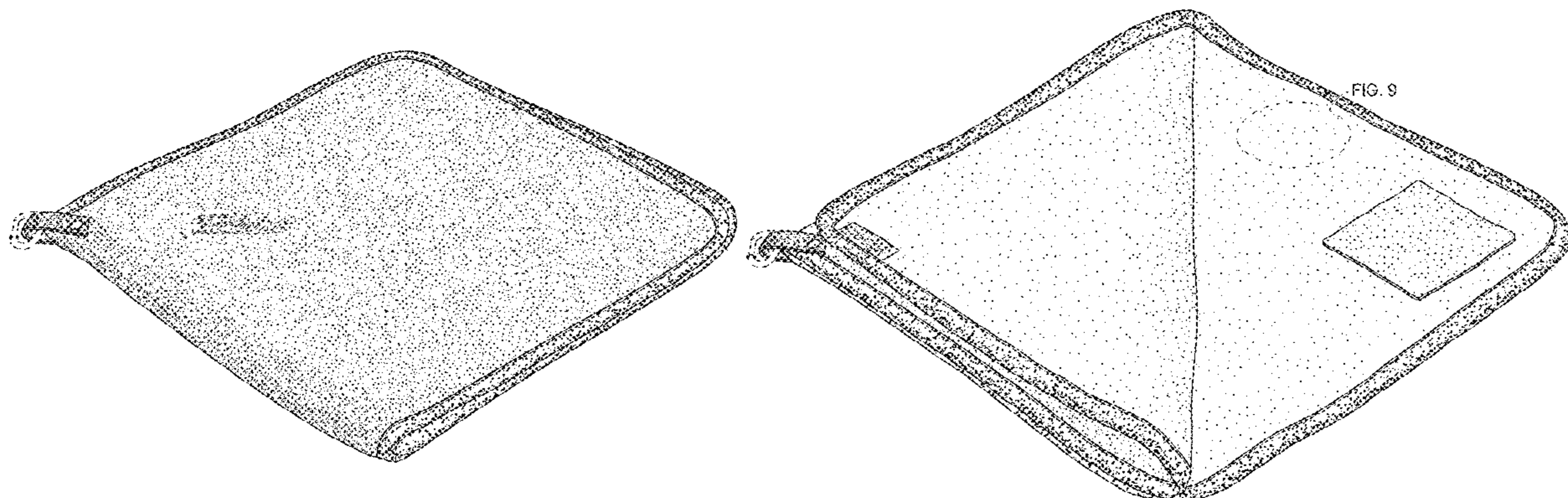
(57) **CLAIM**

The ornamental design for a towel, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of one embodiment of the towel of this invention;
 FIG. 2 is a first side elevation view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a second side elevation view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a third side elevation view thereof;
 FIG. 7 is a fourth side elevation view thereof;
 FIG. 8 is a second perspective view thereof;
 FIG. 9 is an enlarged view of a portion of the towel of this invention that is identified with the reference, "FIG. 9" in FIG. 8;
 FIG. 10 is a side elevation view thereof; and,
 FIG. 11 is a perspective view of a second embodiment of the towel of this invention.
 In FIGS. 1-11, the broken lines depict unclaimed portions of the towel. The different stippling shown in the exterior surface of the towel as shown in FIG. 1 versus the stippling in the interior surface of the towel as shown in FIG. 8 indicates a contrast in appearance between the respective surfaces.

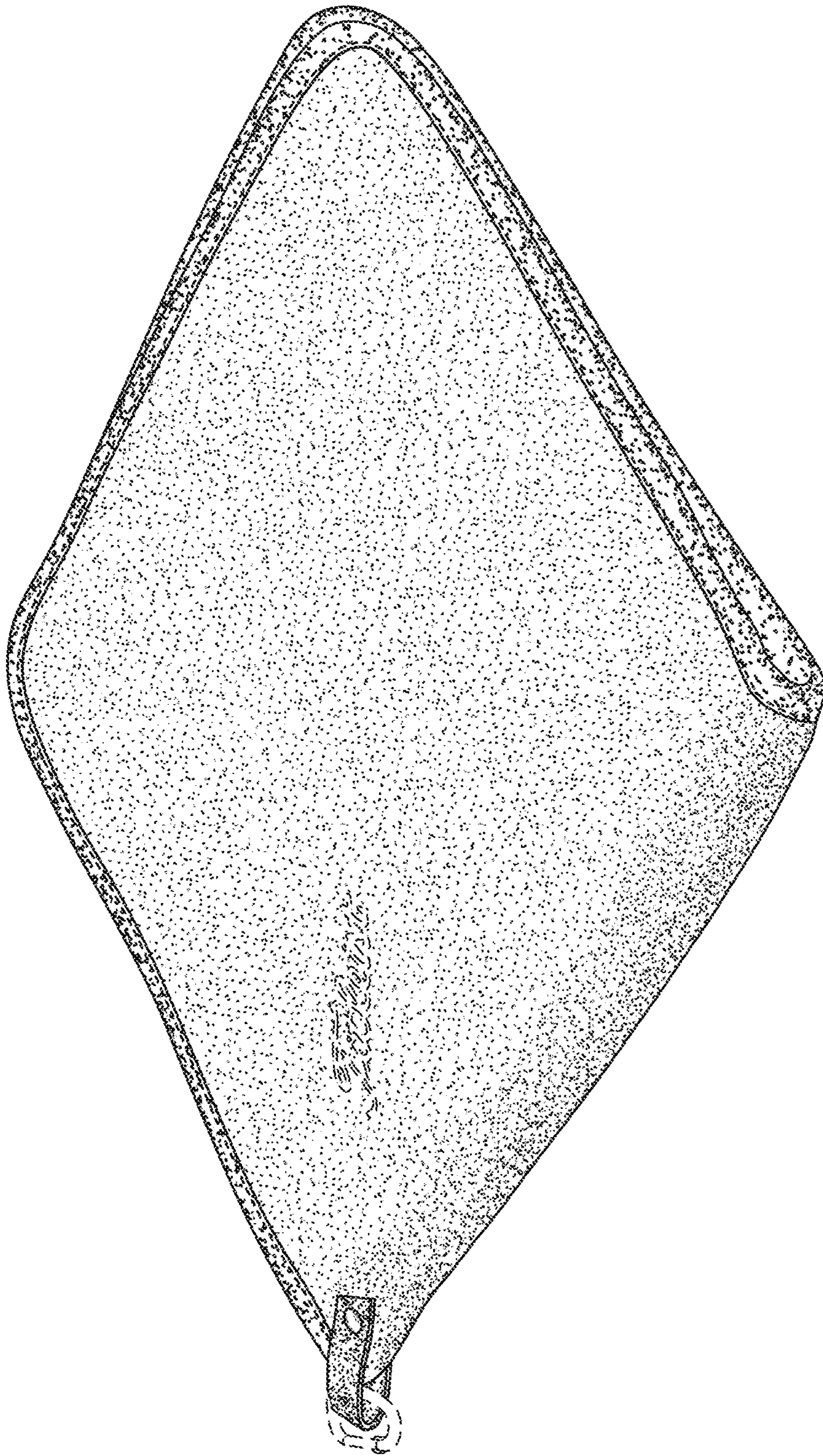

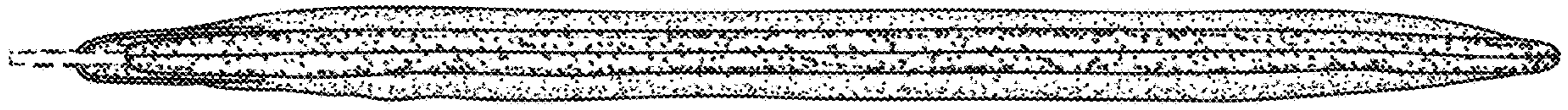

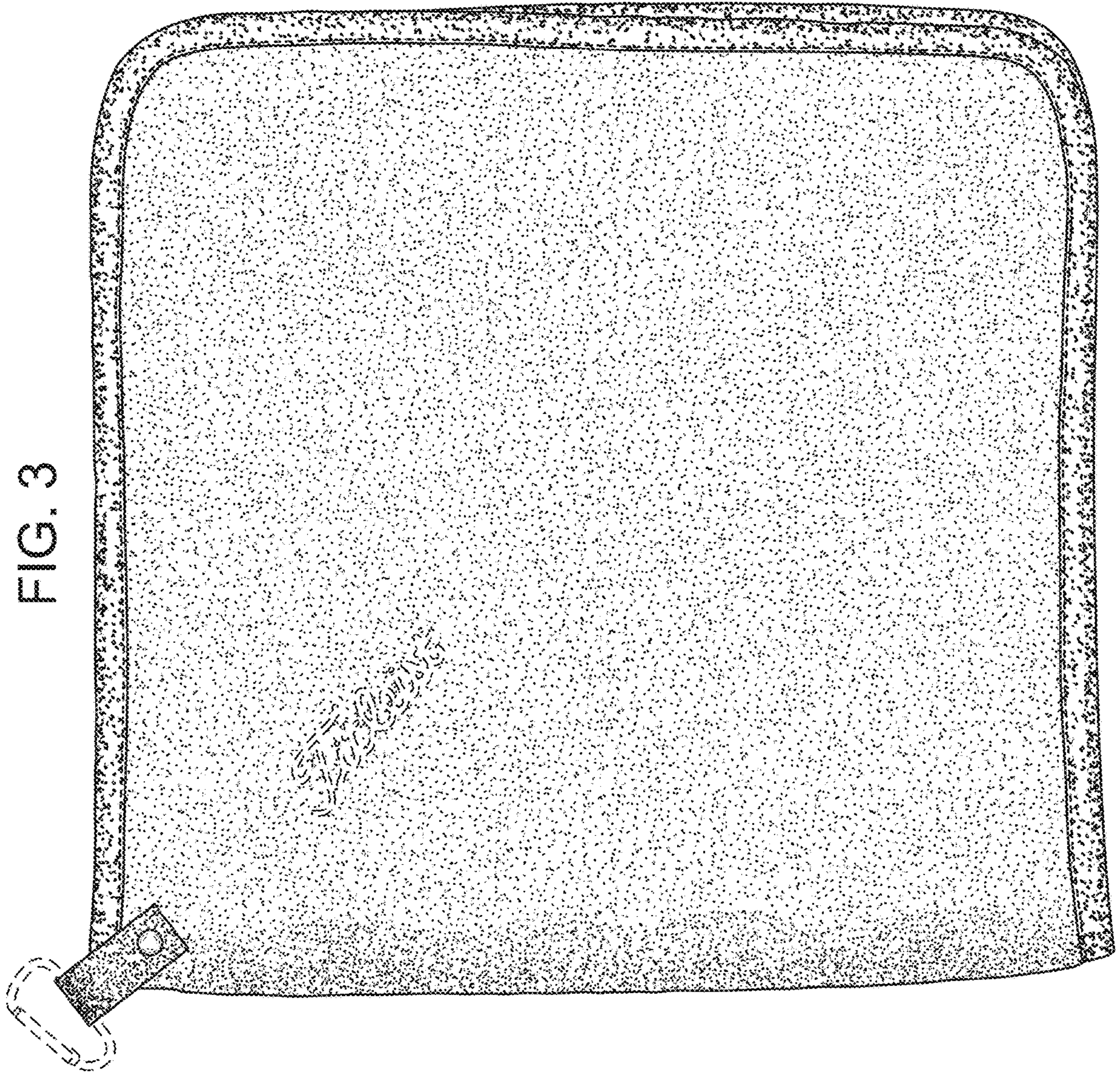

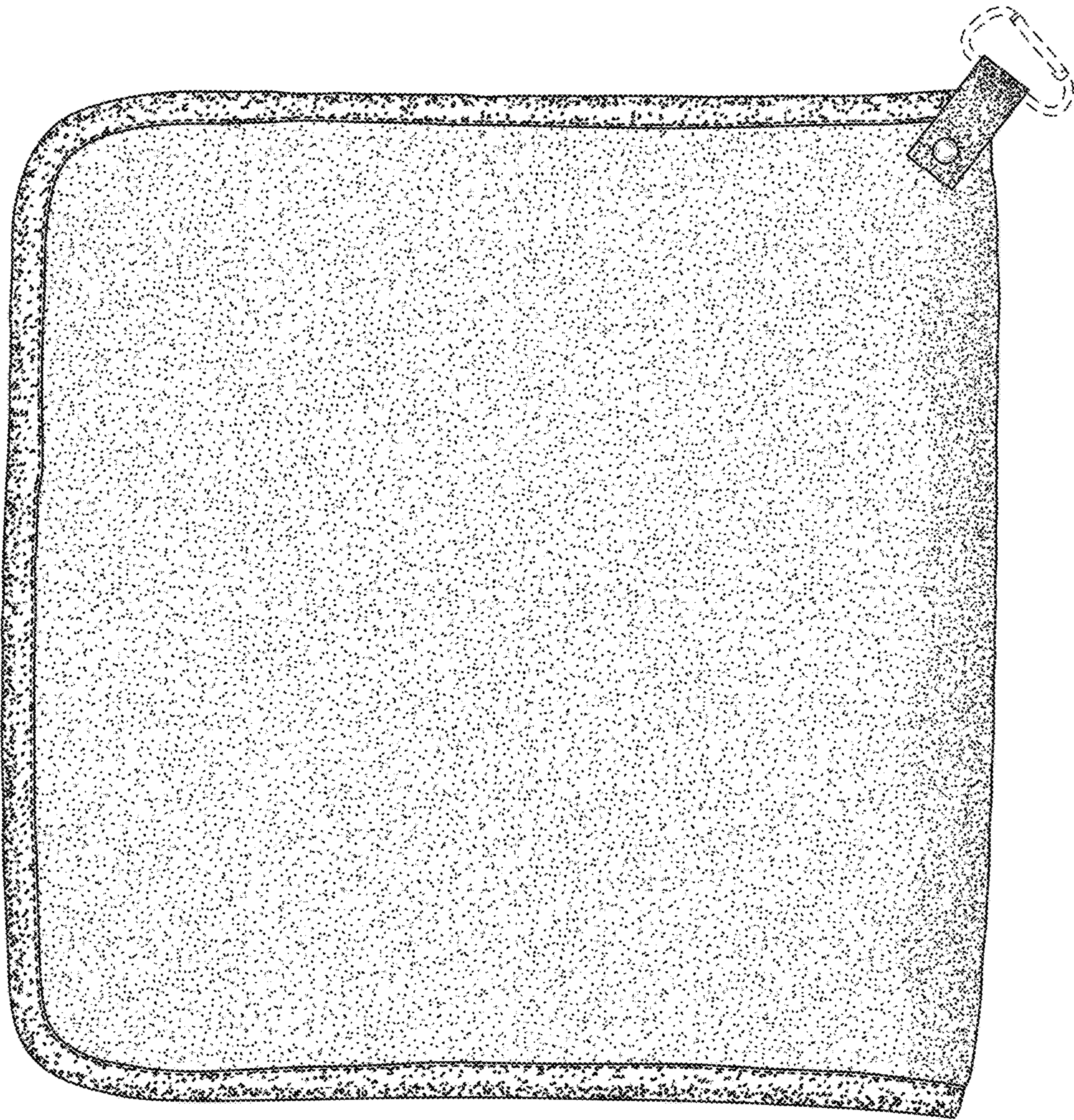

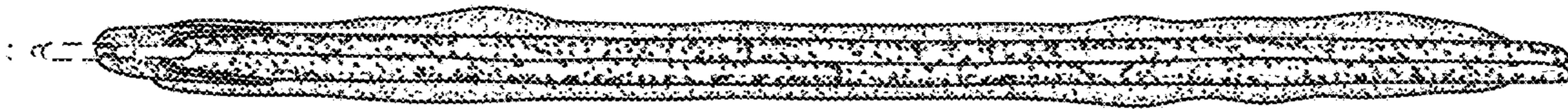

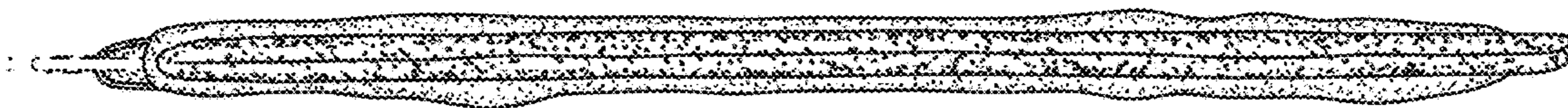

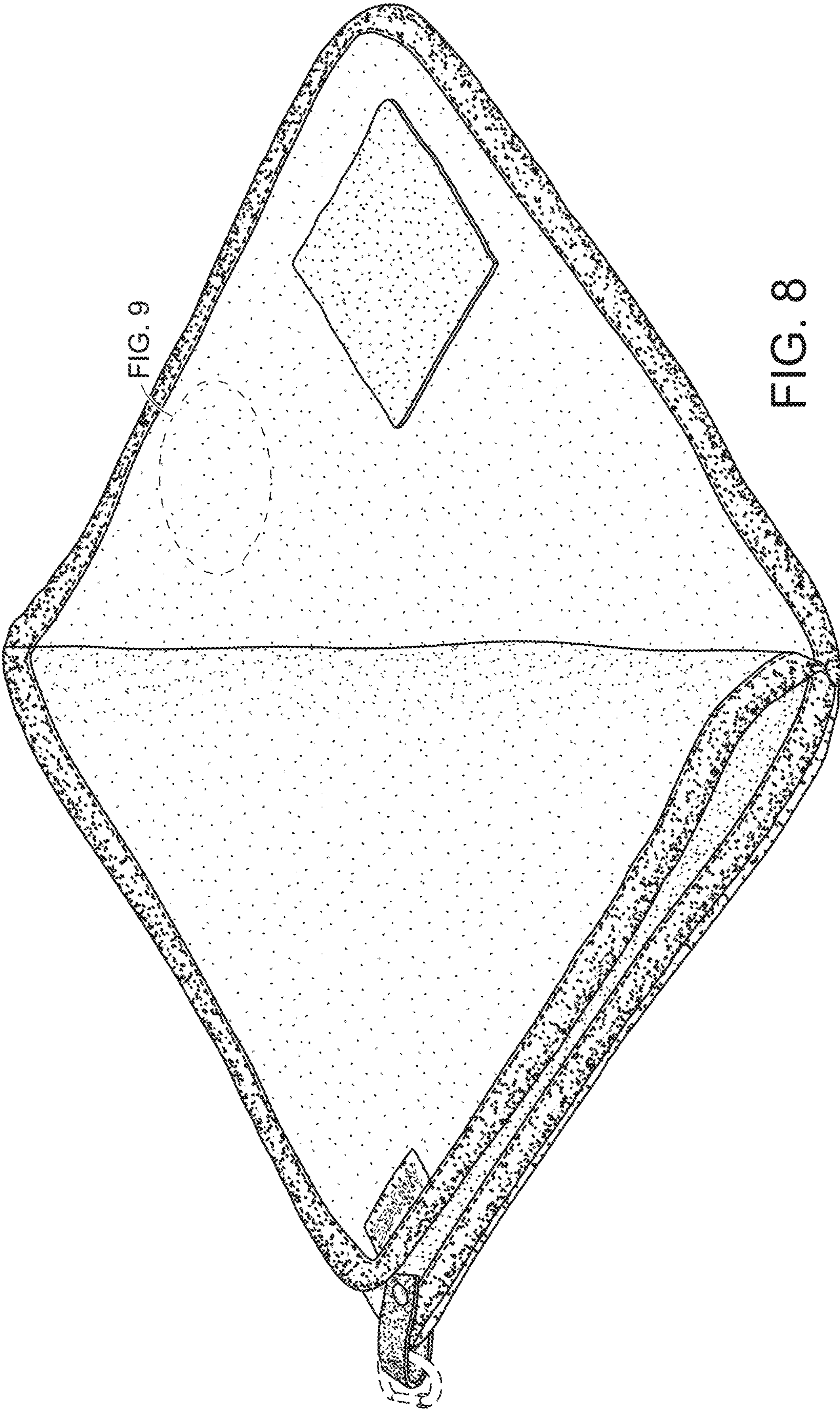

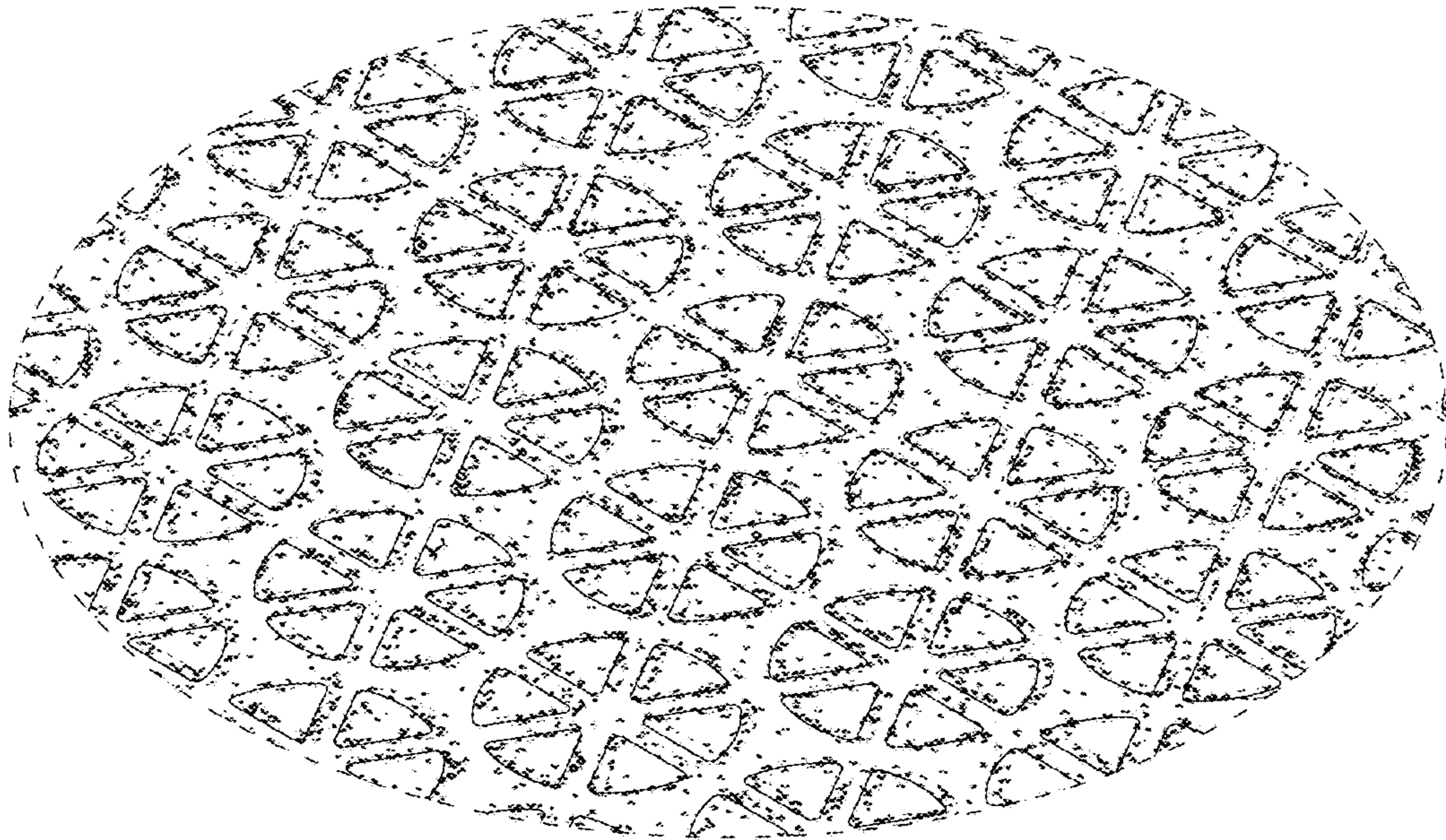

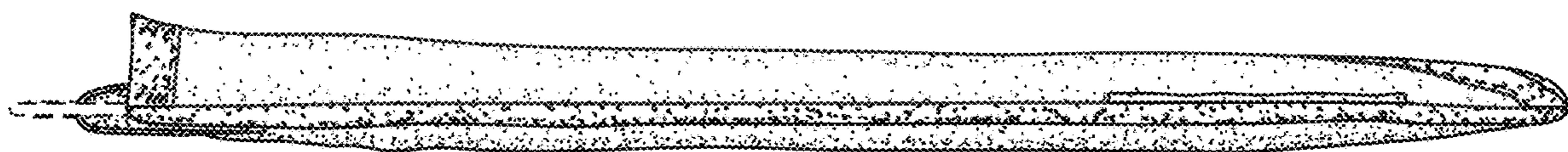

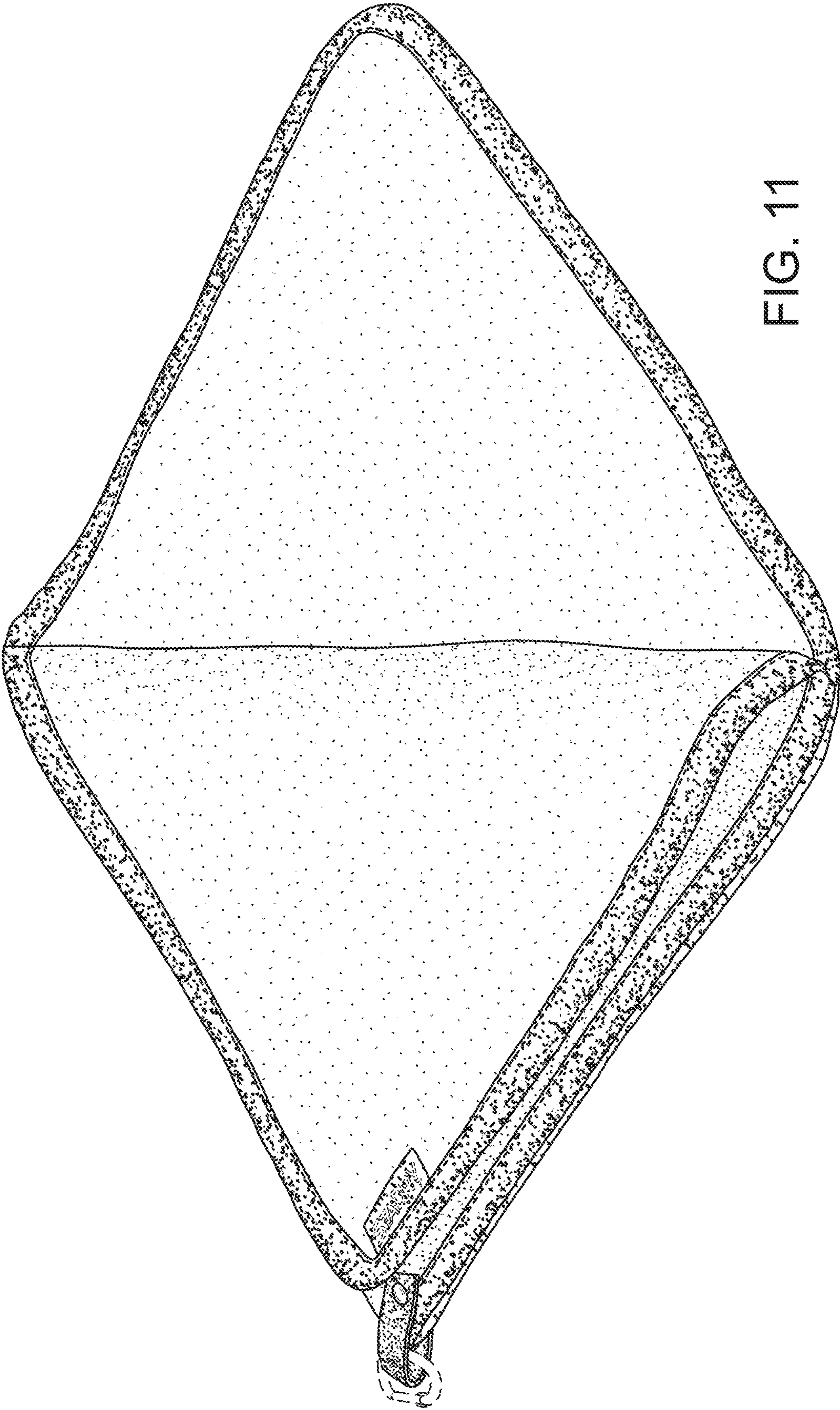
