(57) **CLAIM**

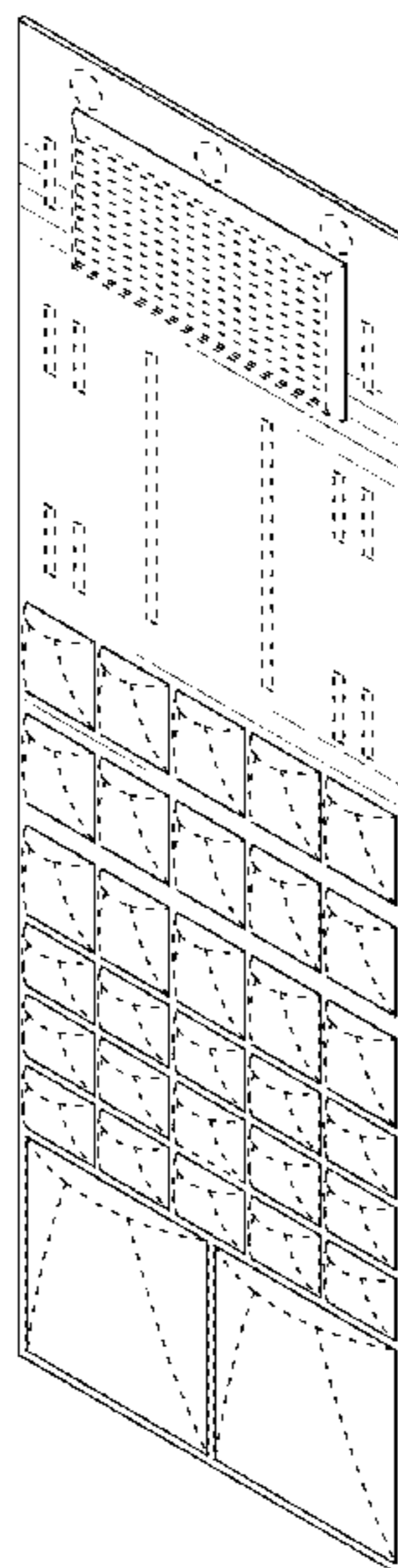
The ornamental design for a hanging jewelry and cosmetics organizer, as shown and described.

DESCRIPTION

FIG. 1 is a top-front-left perspective view of a hanging jewelry and cosmetics organizer showing my new design; FIG. 2 is a bottom-front-right perspective view thereof; FIG. 3 is a front elevated view thereof; FIG. 4 is a rear elevated view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a right elevated view thereof; FIG. 8 is a left elevated view thereof; FIG. 9 is a top-front-left perspective view thereof with a mirror; and, FIG. 10 is a bottom-front-right perspective view with the mirror.

The broken lines showing of pockets in FIG. 1-3 and FIG. 5-10, the broken lines showing of a jewelry holder in FIG. 1-3, FIG. 5, and FIG. 7-10, the broken lines showing of orifices in FIG. 1-4 and FIG. 9-10, the broken lines showing of hook and loop fasteners in FIG. 1-3 and FIG. 9-10, and the broken lines showing of a mirror in FIG. 9-10 are included for the purpose of showing environmental structure and form no part of the claimed design.

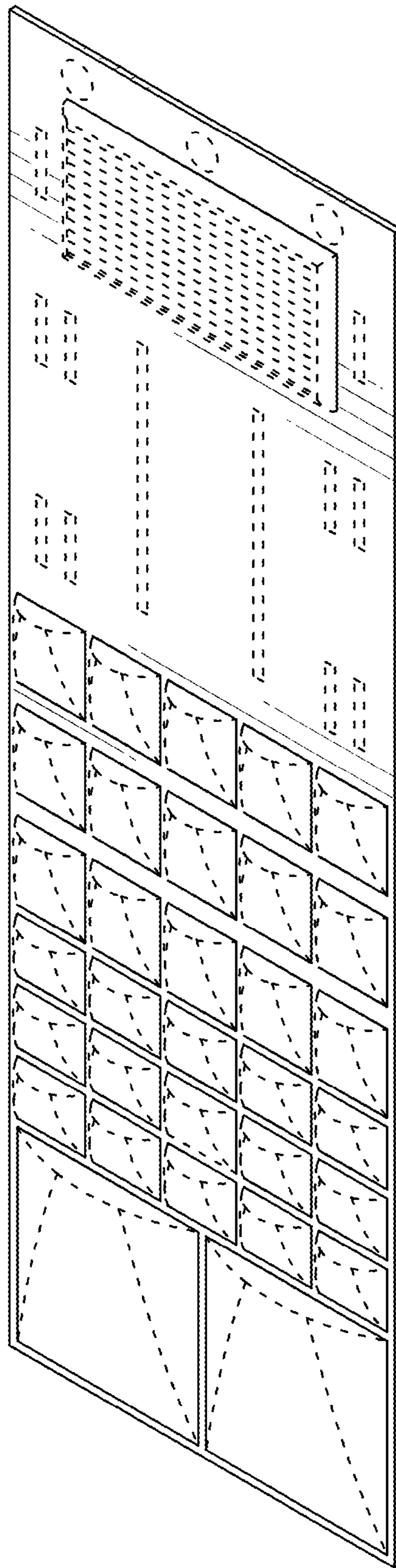

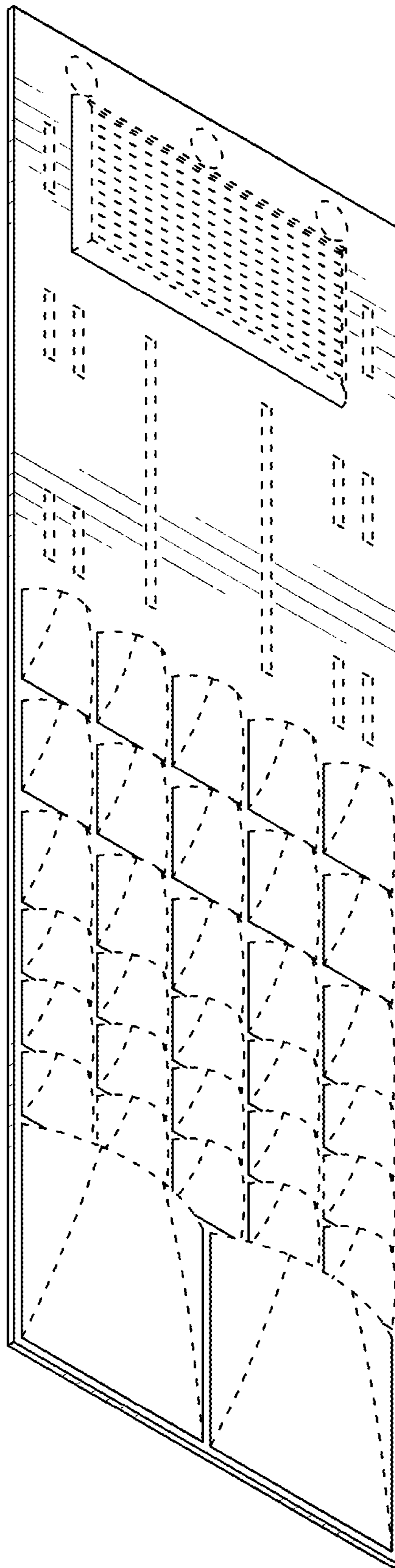

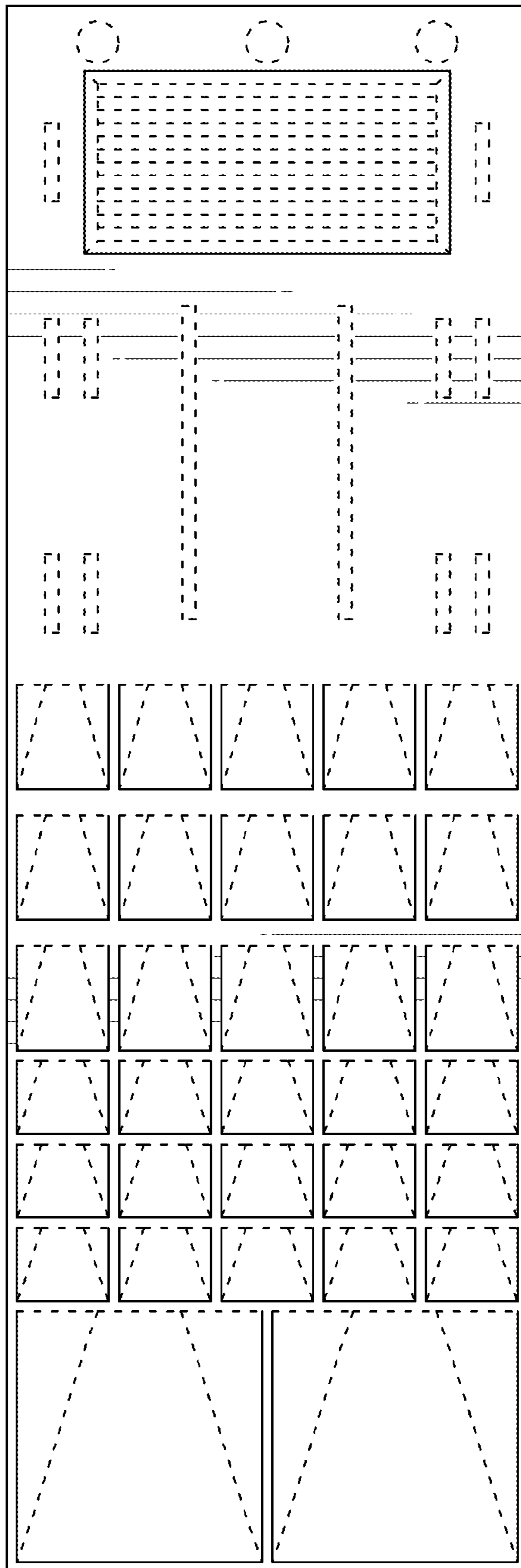

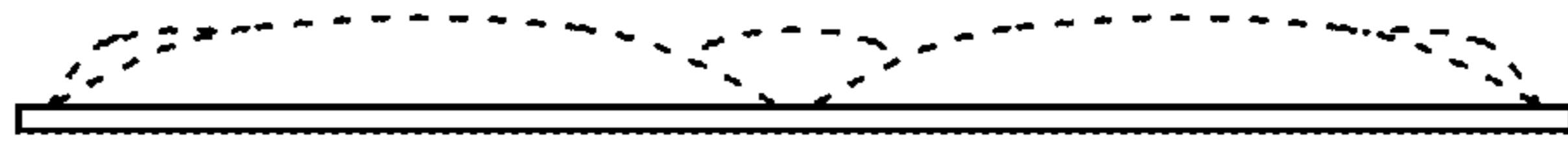

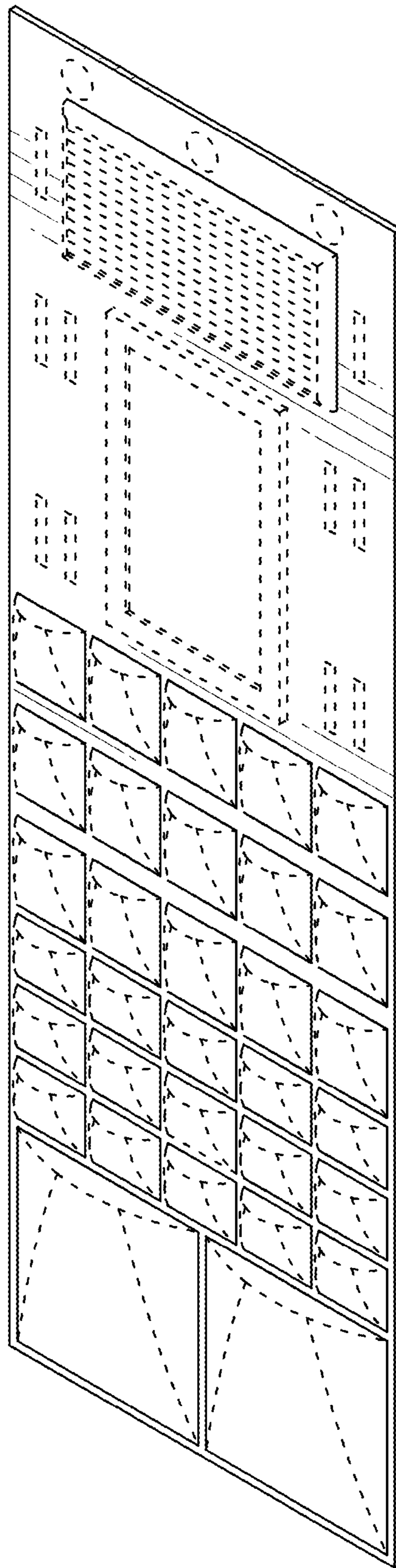

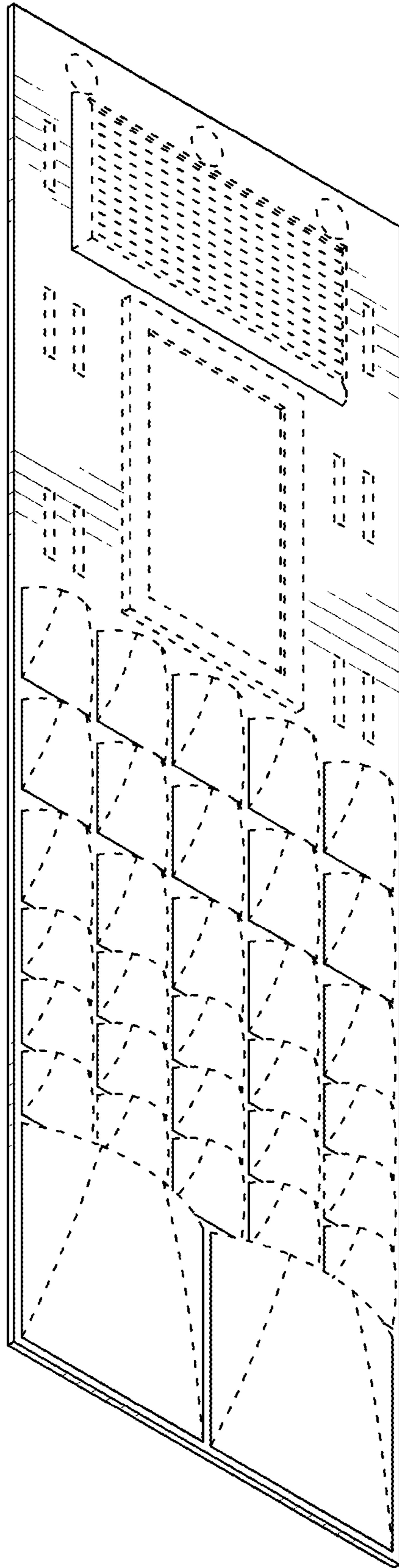
