We claim the ornamental design for a jug, as shown and
described.

DESCRIPTION

FIG. 1 is a front, top, and left side perspective view of a jug,
showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines in FIGS. 6 and 7 depict portions of the jug
that form no part of the claimed design.

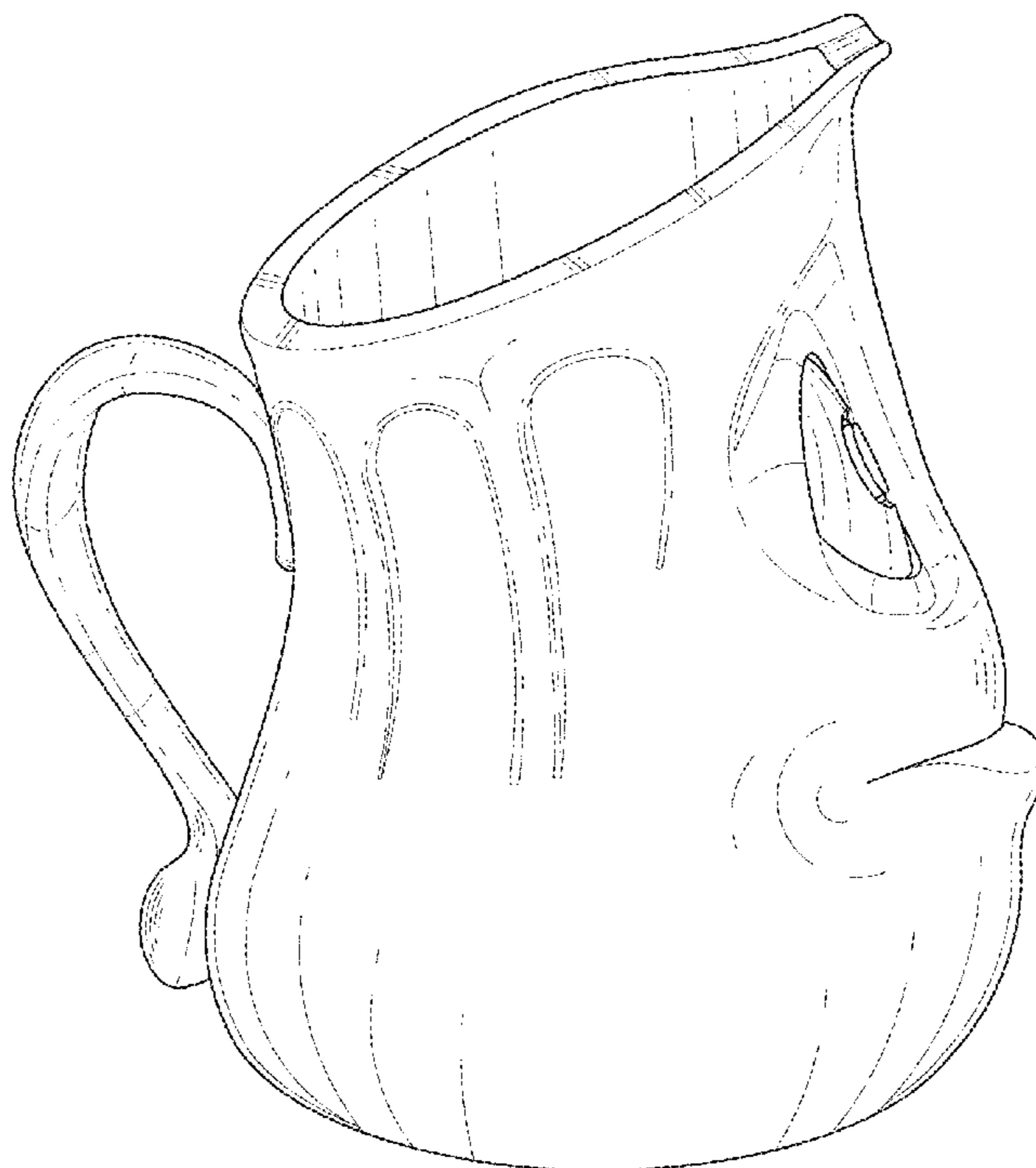

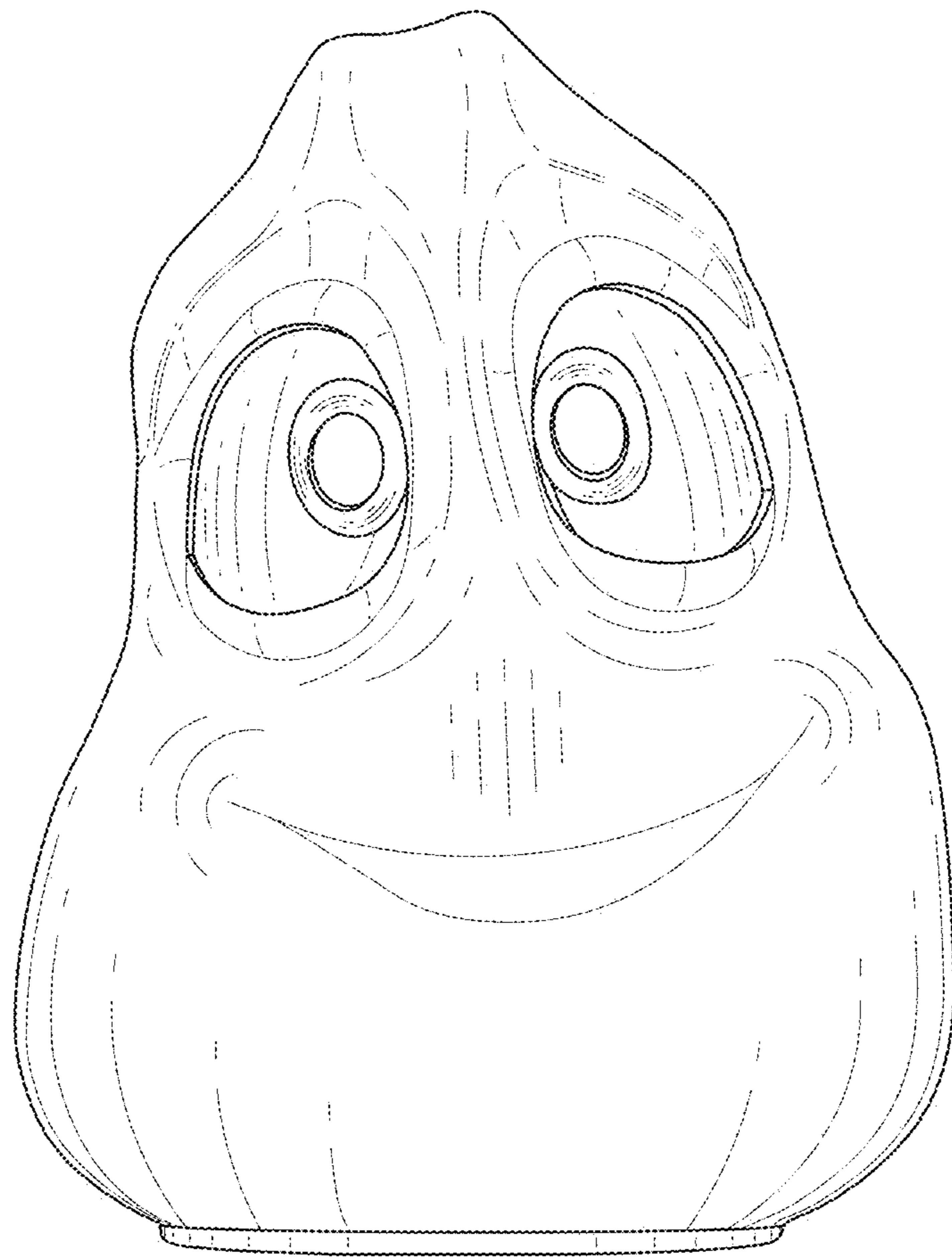

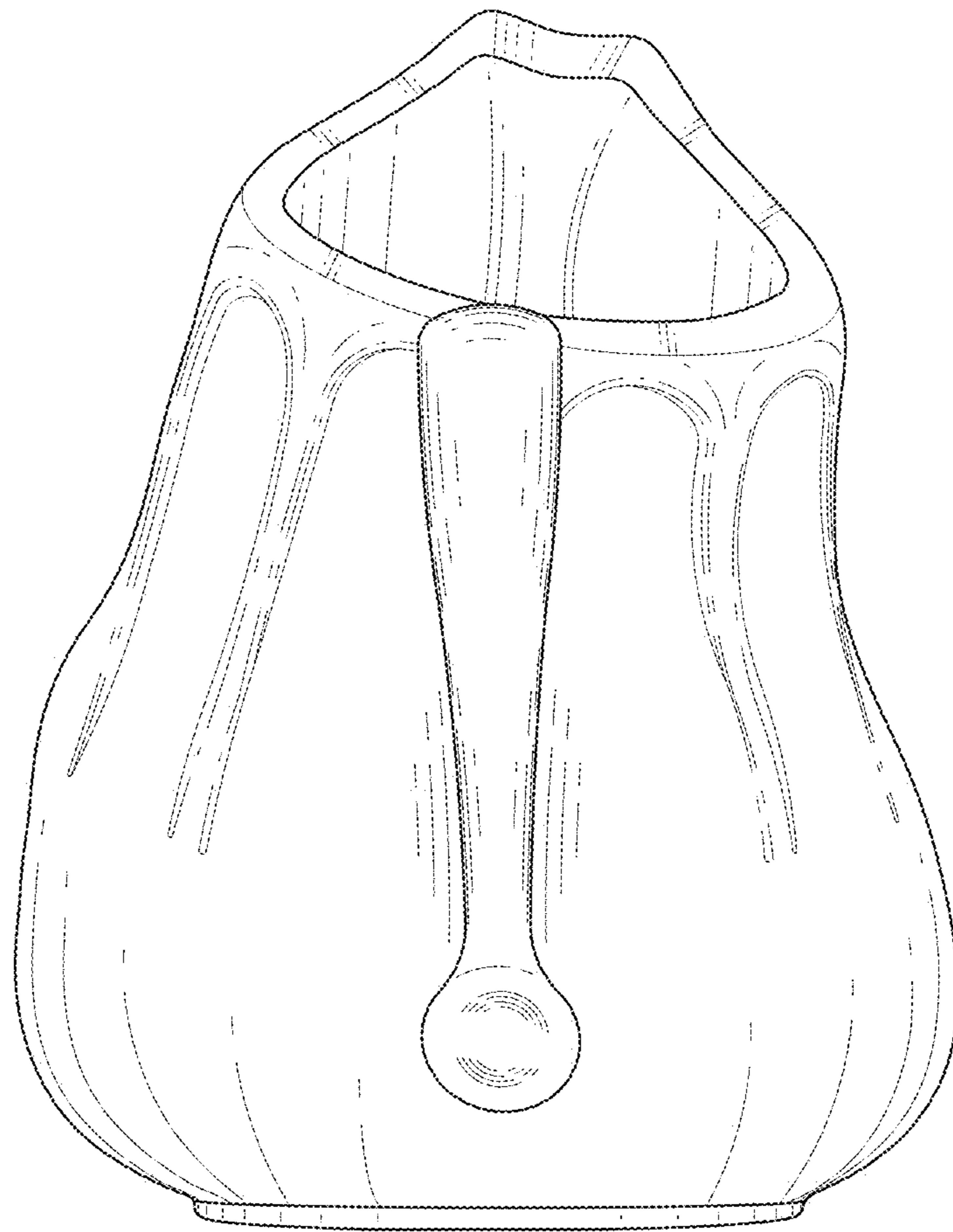

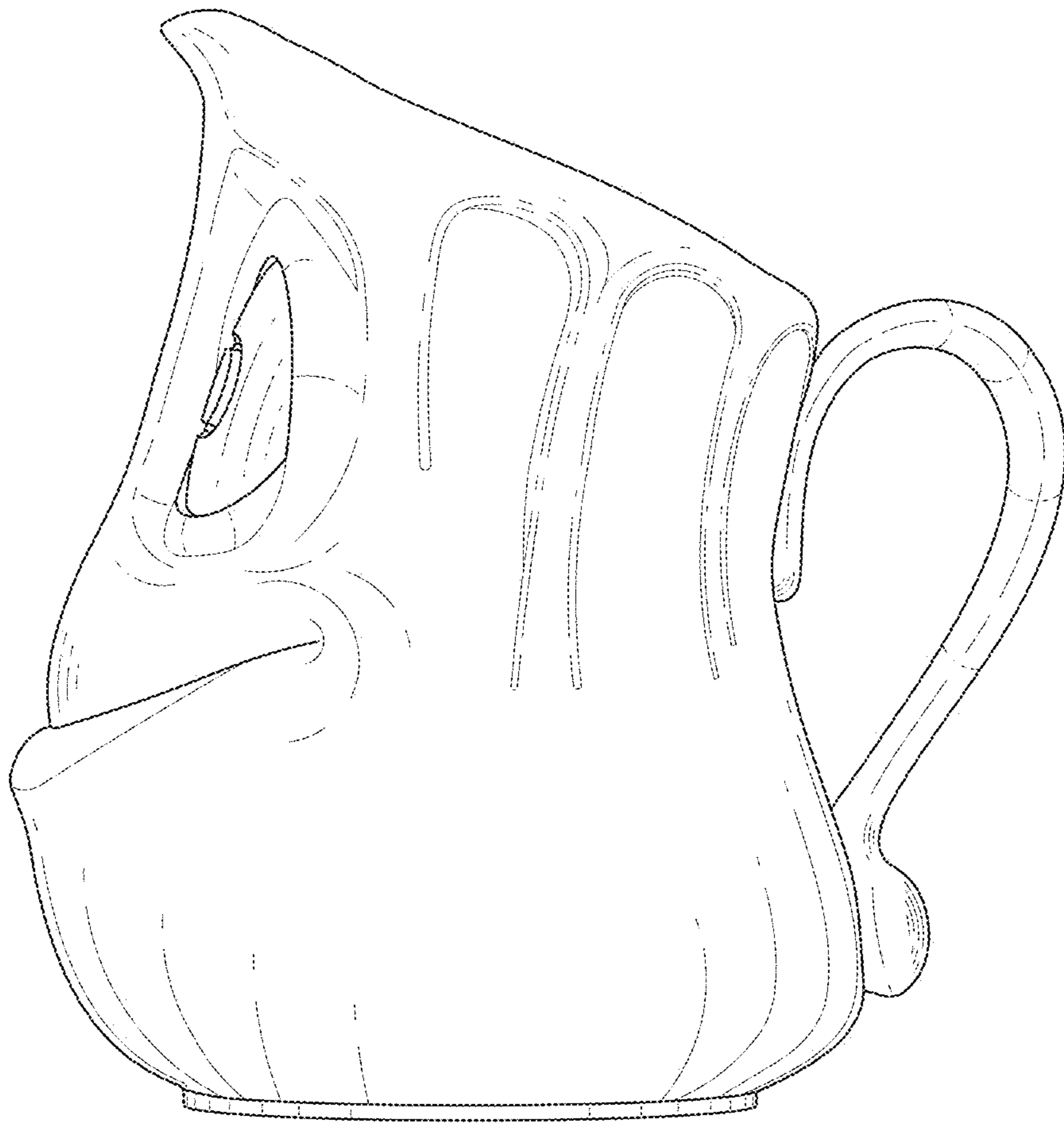

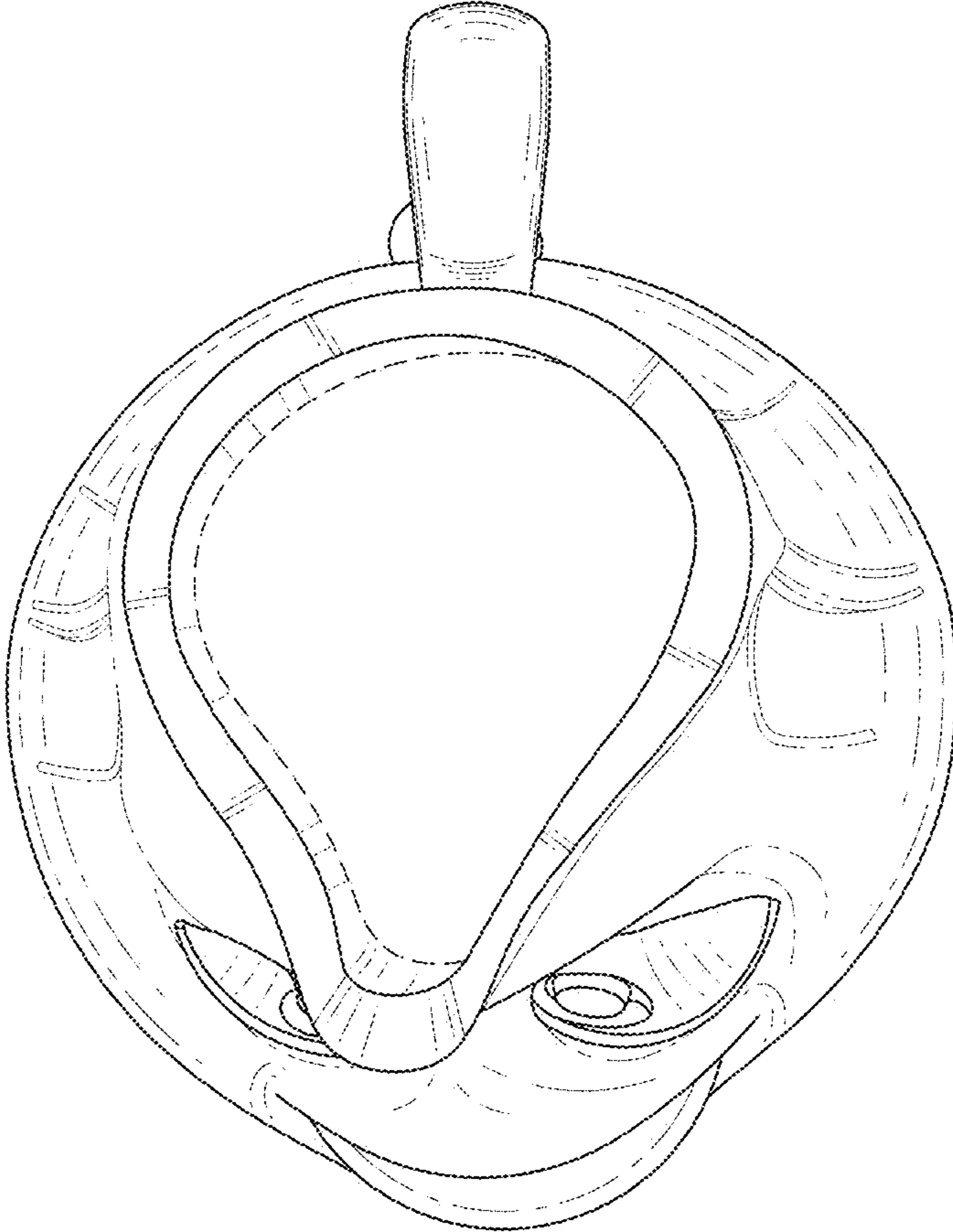

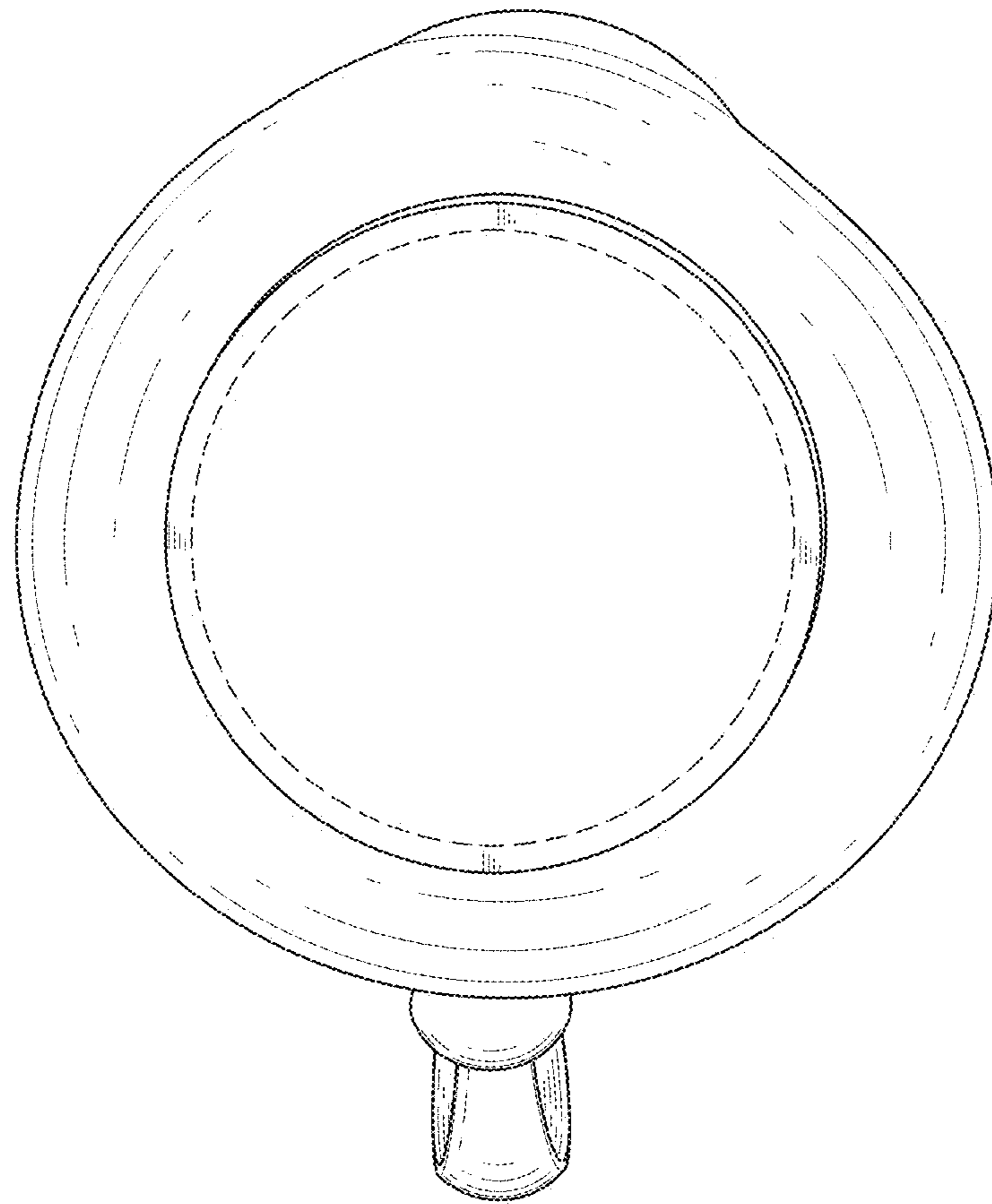
