(57) **CLAIM**

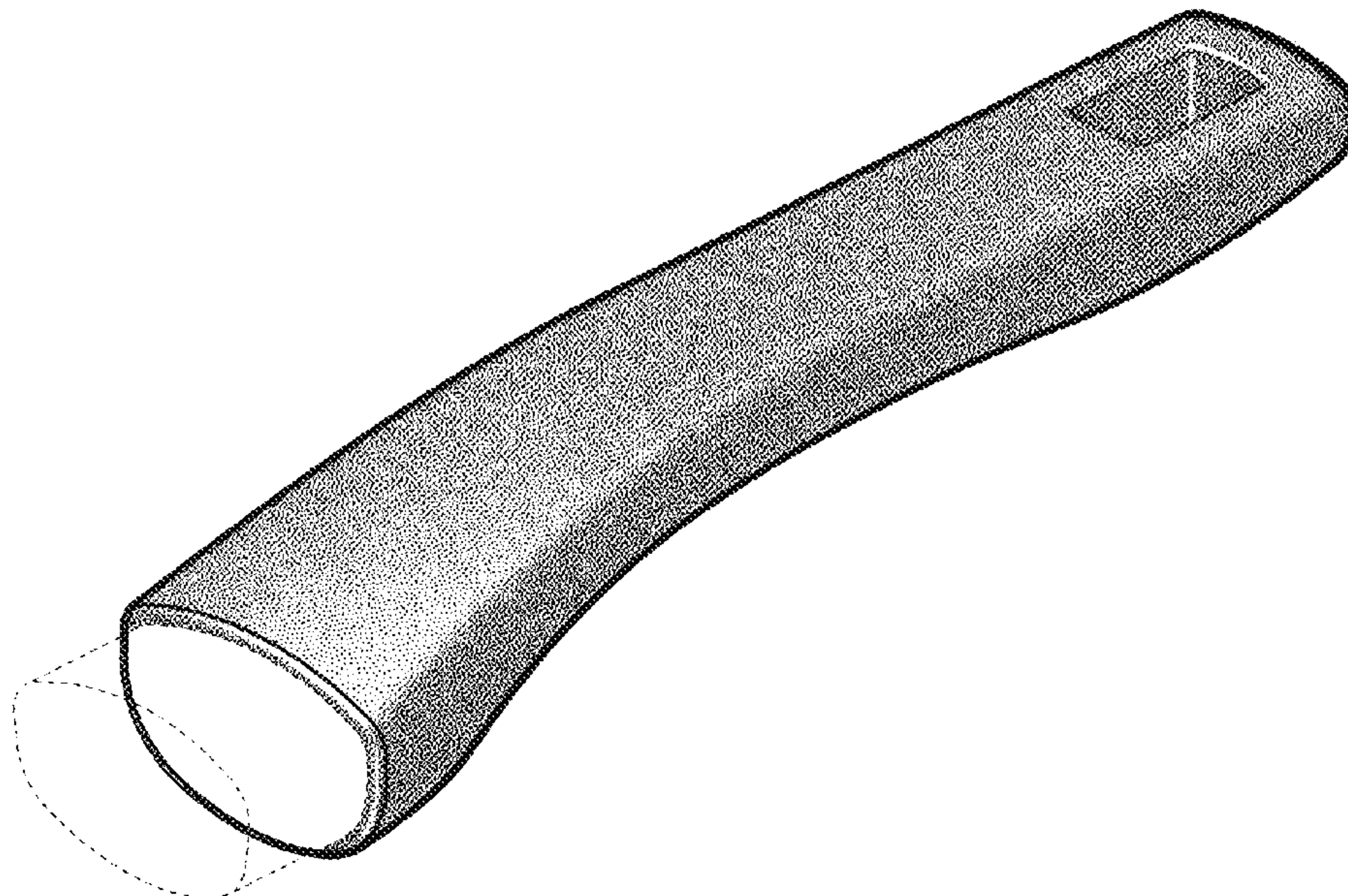
The ornamental design for an elongated side handle for cookware, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an elongated side handle for cookware, showing my new design;  
FIG. 2 is a right side elevational view thereof, being the mirror image of the left side elevation view;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a front elevation thereof;  
FIG. 6 is a back elevation view thereof; and,  
FIG. 7 is a cross-sectional side elevational view taken at section line 7-7 in FIG. 3.

The broken lines in FIGS. 1-7 depict a portion of the elongated handle for cookware that forms no part of the claimed design.

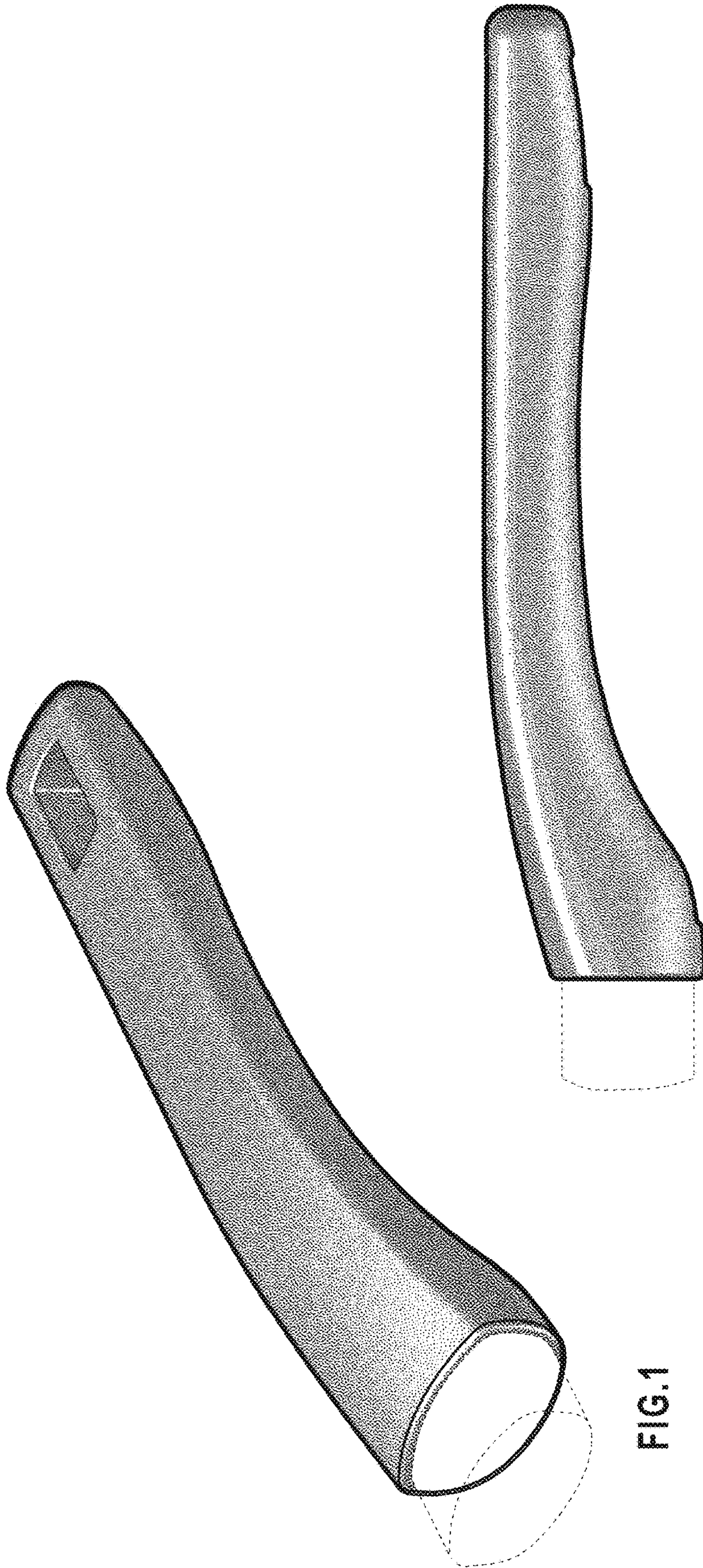
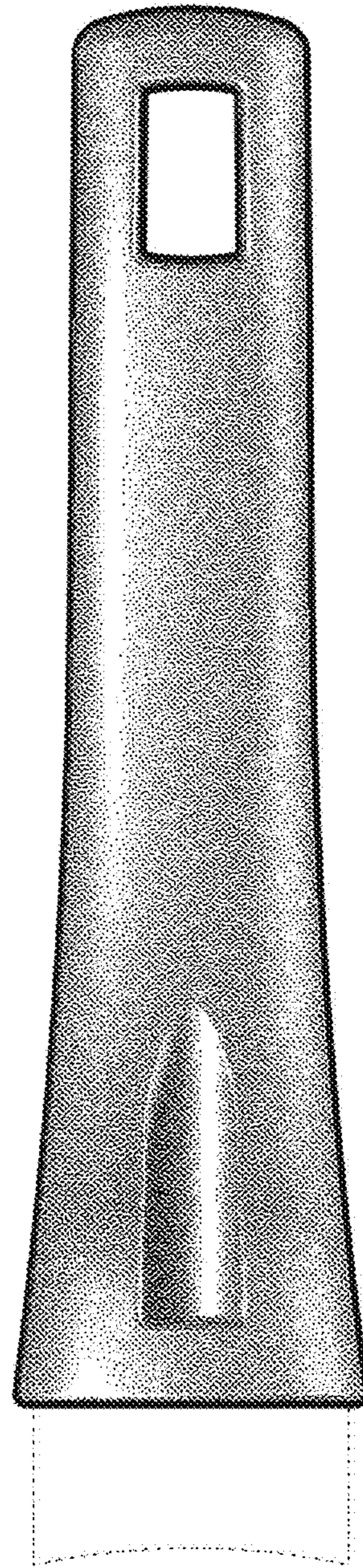
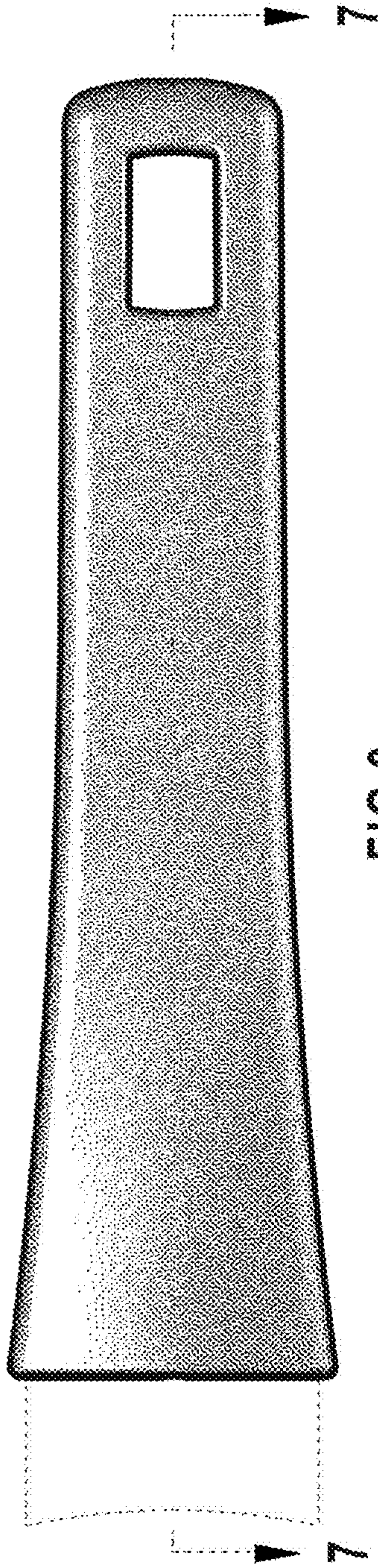

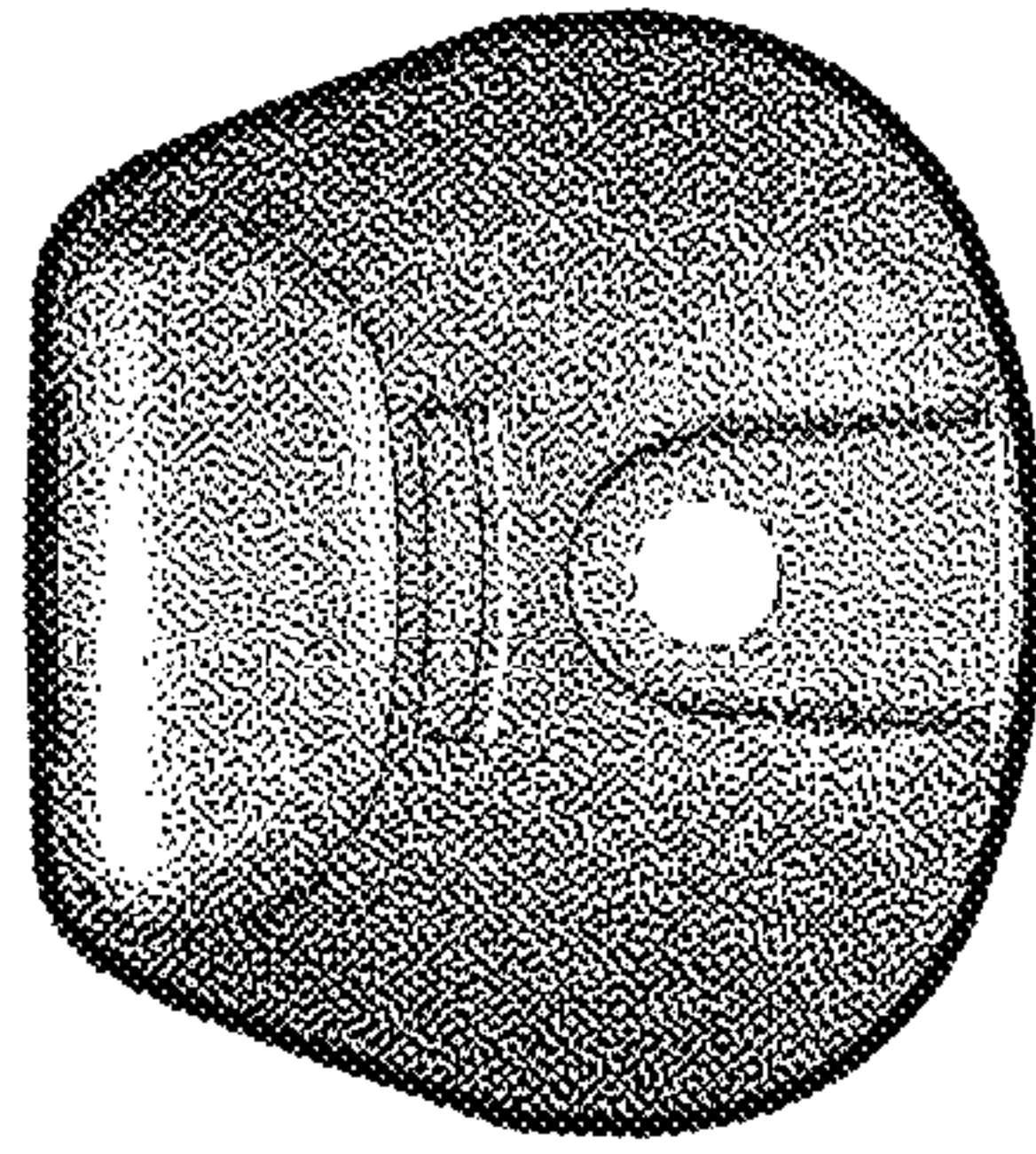

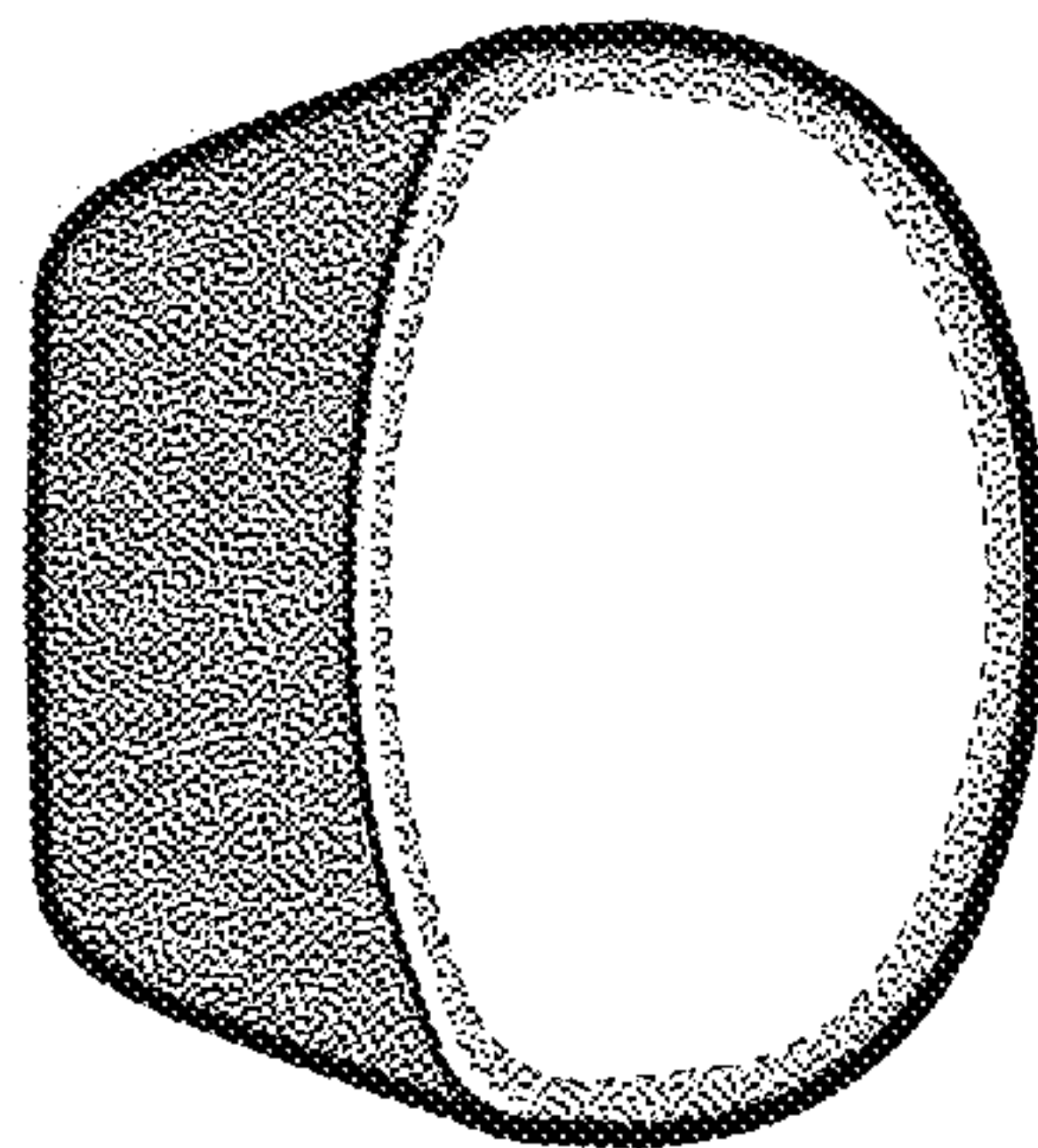

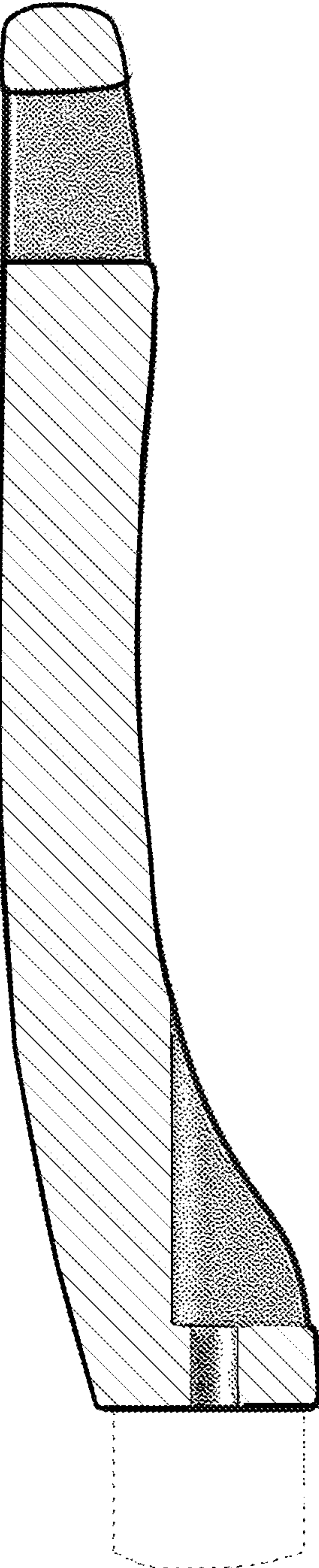
