(57) **CLAIM**

The ornamental design for a container with cover, as shown and described.

DESCRIPTION

This application is related to co-pending Ser. Nos. 29/621, 340; 29/621,343; and 29/621,345, filed Oct. 6, 2017, which are incorporated herein by reference.

FIG. 1 is a top, front and left side perspective view of a container with cover showing my new design;

FIG. 2 is a bottom, front and right side perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left side elevation view, the right side being a mirror image thereof;

FIG. 6 is a front elevation view, the rear elevation being a mirror image thereof; and,

FIG. 7 is a cross-sectional view taken along line 7-7 of FIG. 3.

The broken lines in FIG. 7 depict a portion of the container with cover that forms no part of the claimed design.

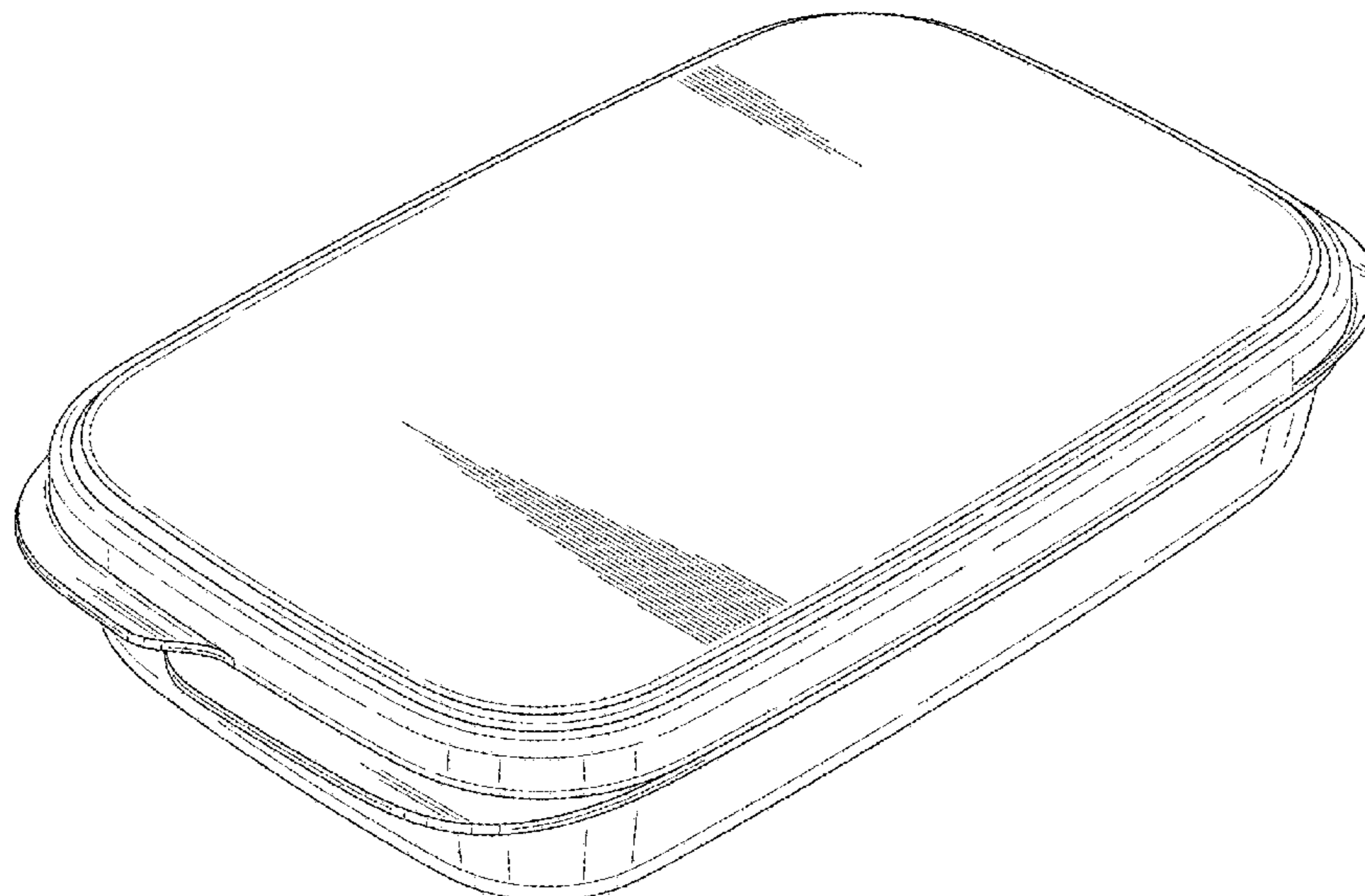

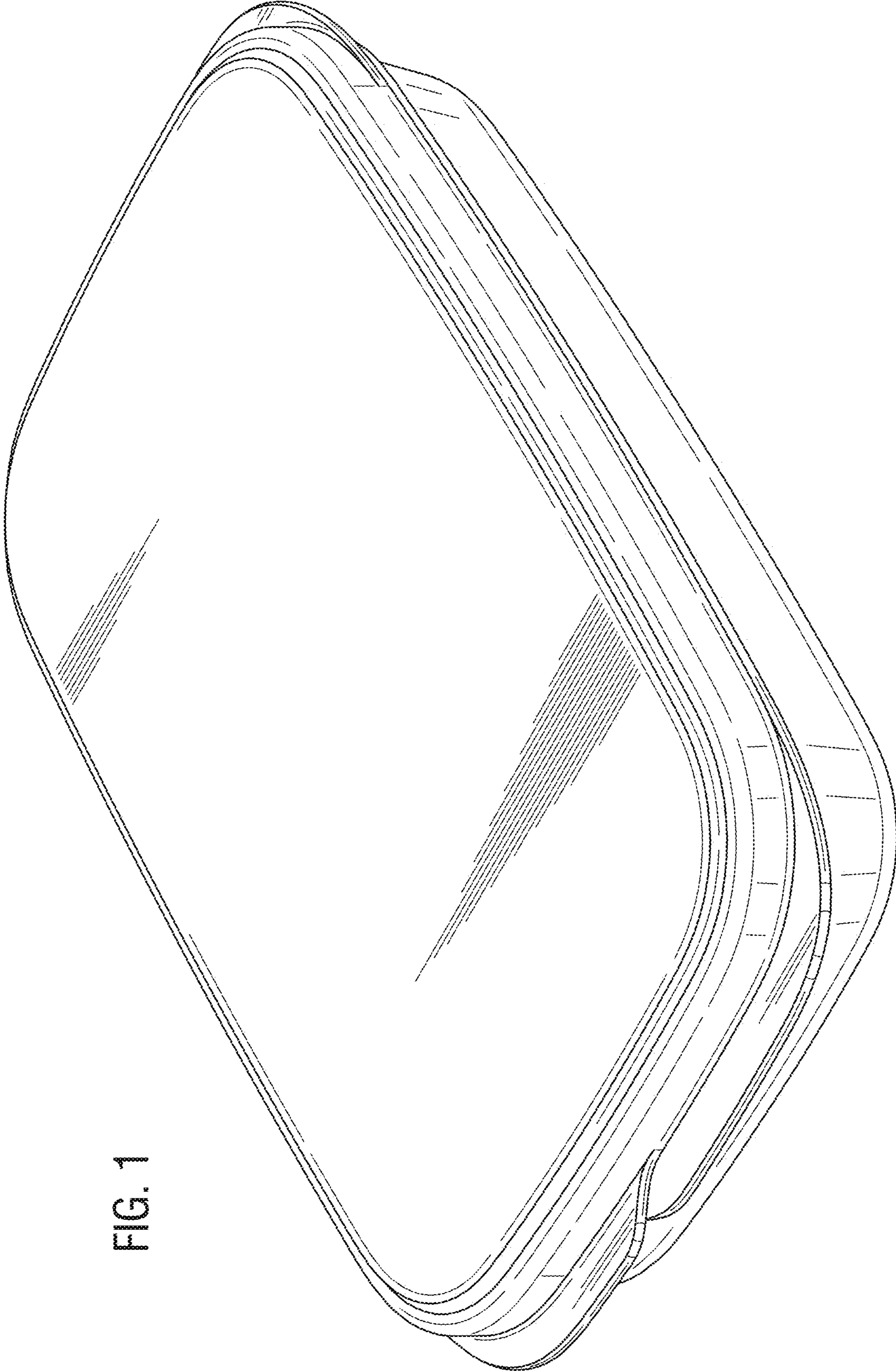

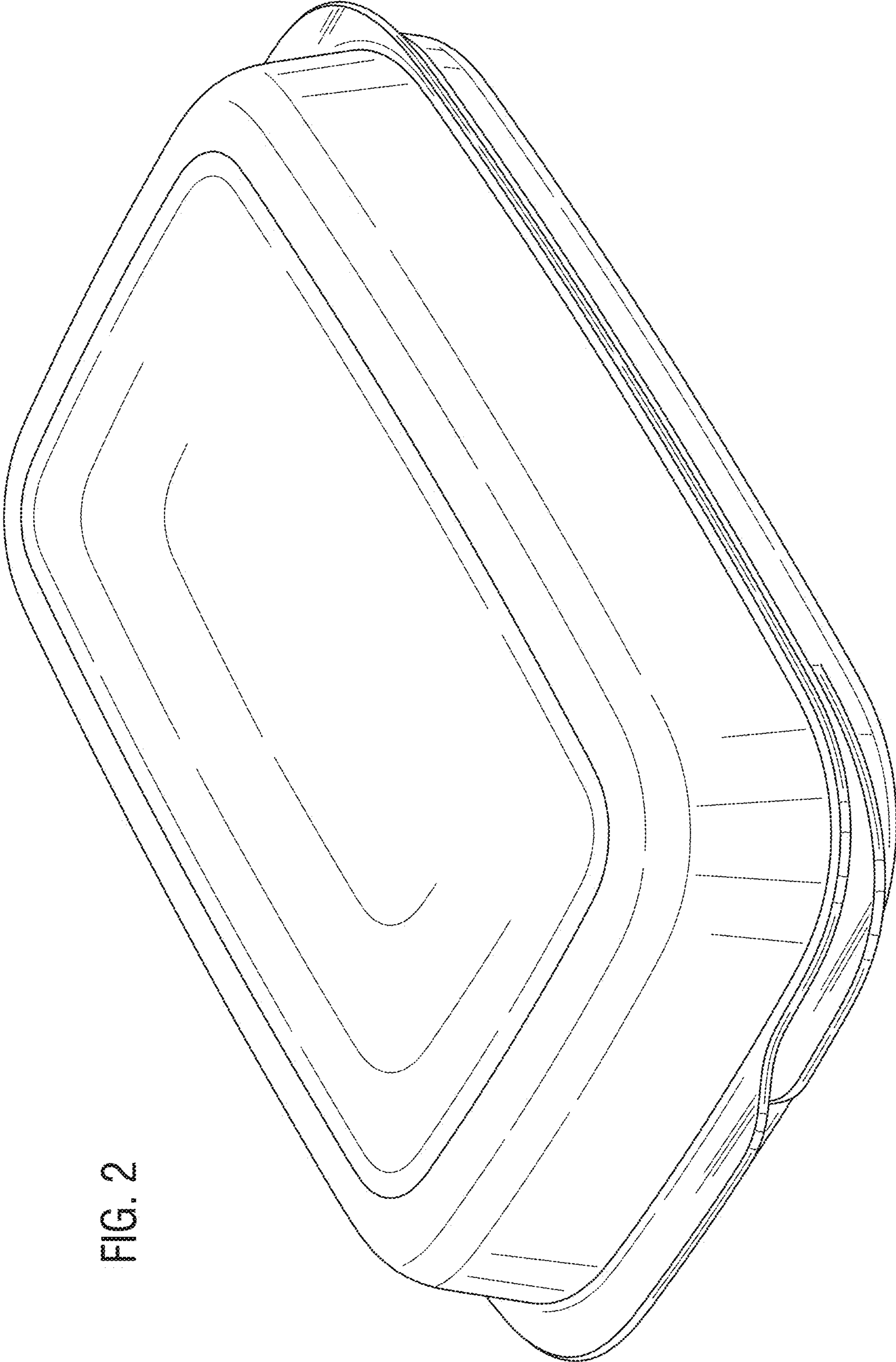

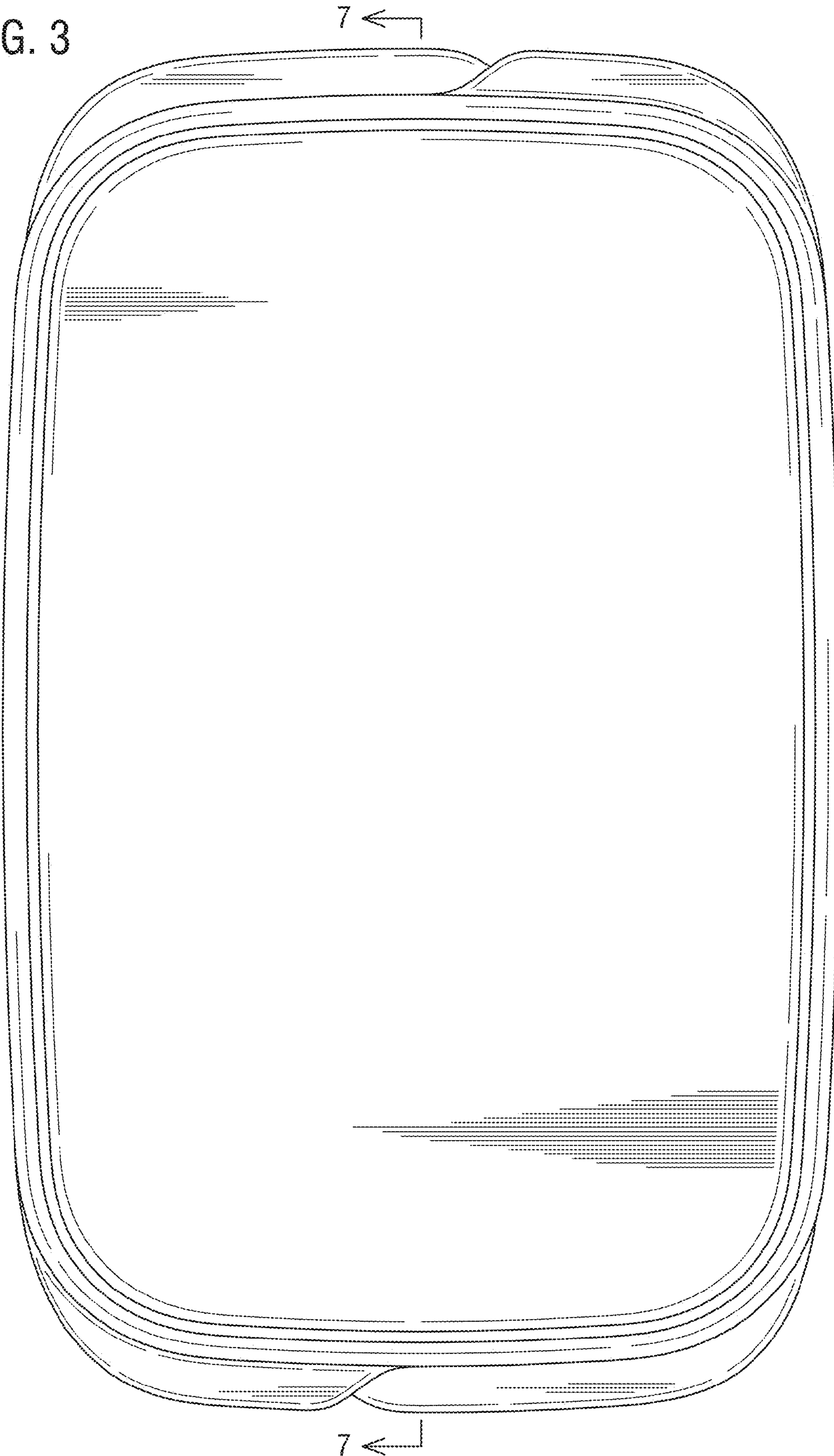

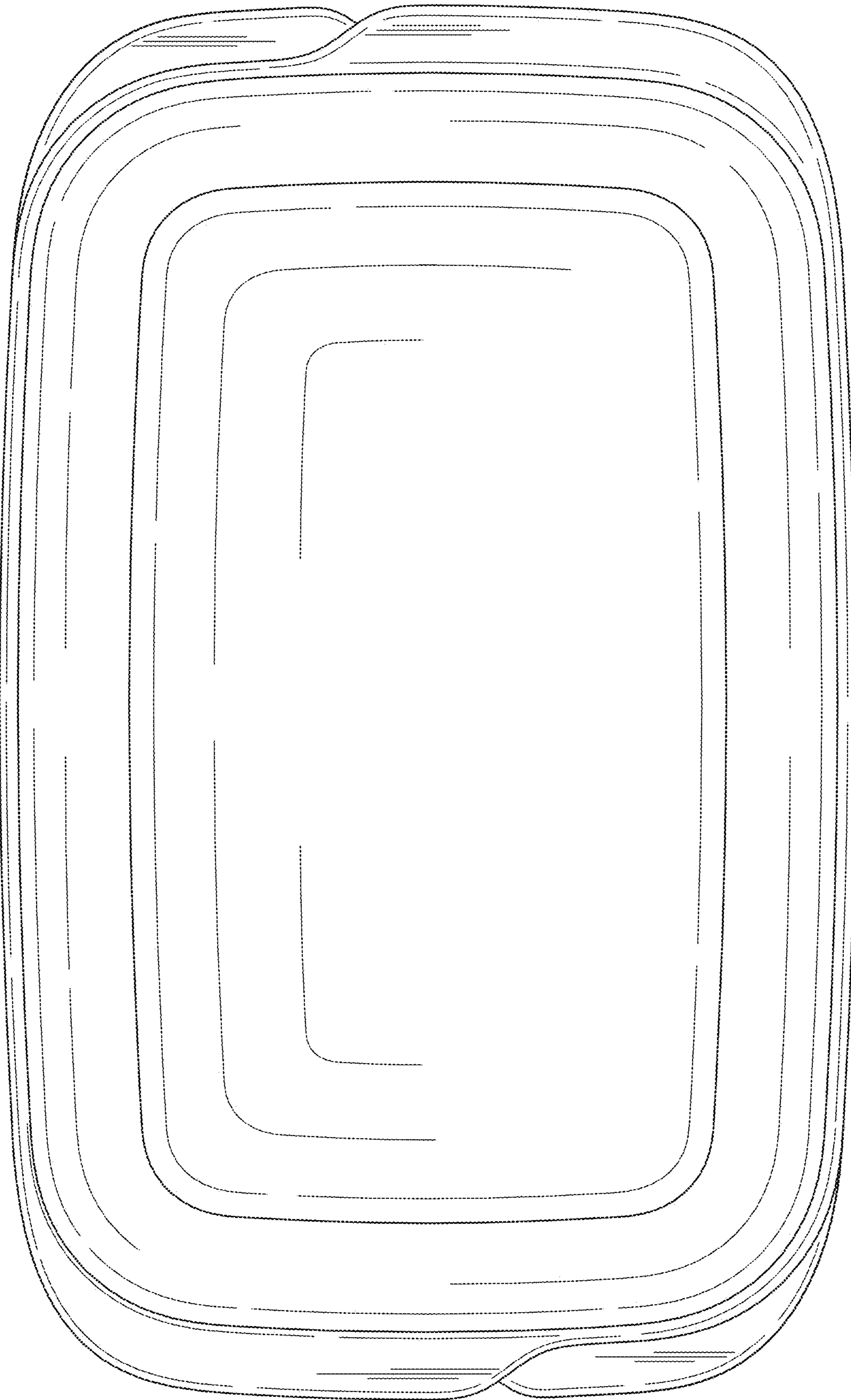

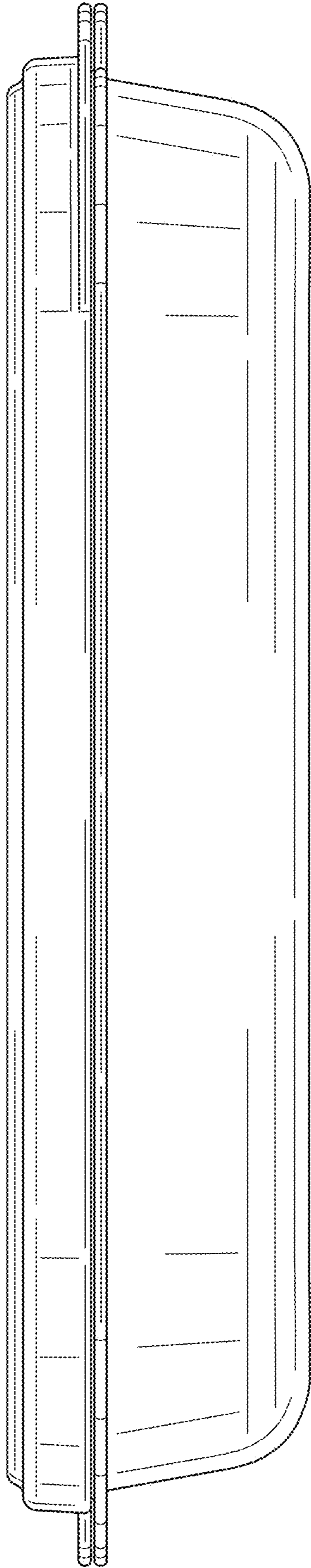

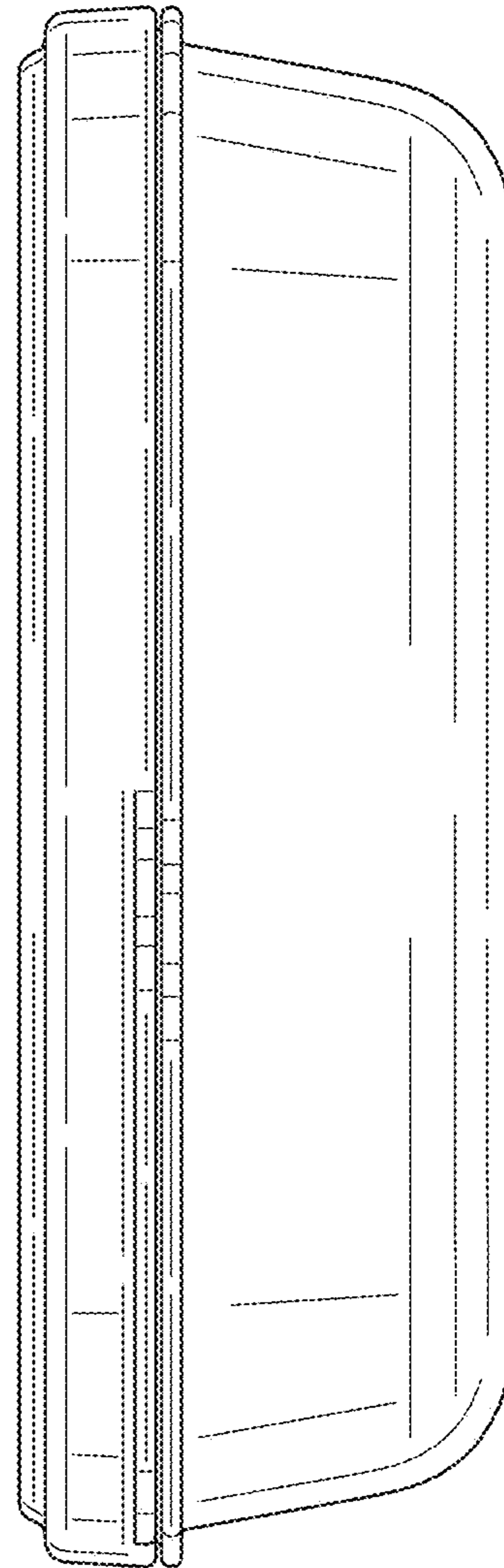
