(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a bottle showing my new design; the rear, right side, and left side views being identical thereto;

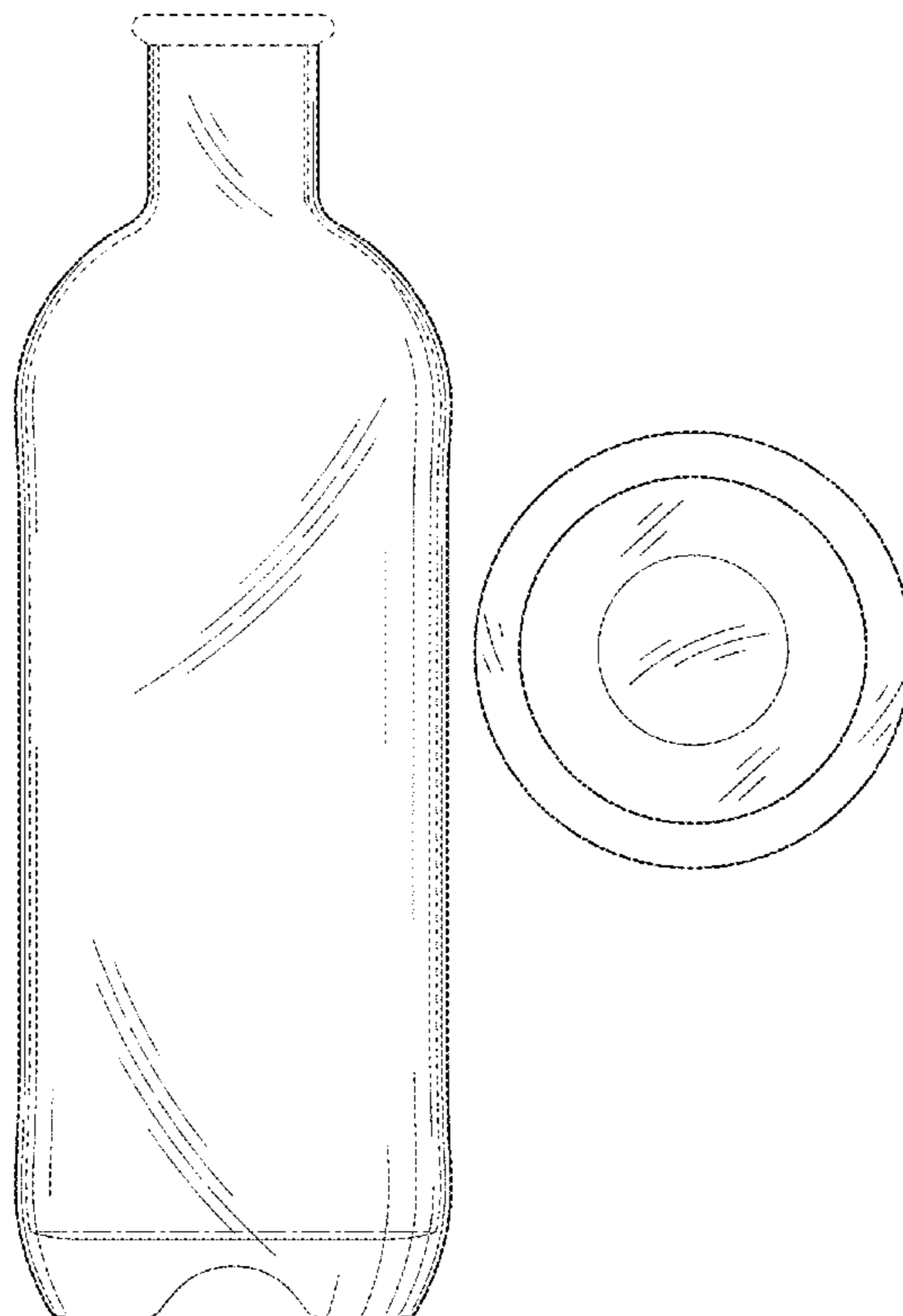
FIG. 2 is a top view thereof with details of the bottom portion omitted for clarity purposes;

FIG. 3 is a bottom view thereof with details of the spout omitted for clarity purposes; and,

FIG. 4 is a perspective view thereof with the interior surfaces of the bottle omitted for clarity purposes.

The even-length dashed broken lines in the drawings illustrate the portions of the bottle that form no part of the claim. The dot-dash broken horizontal line defines a boundary of the claim and forms no part thereof.

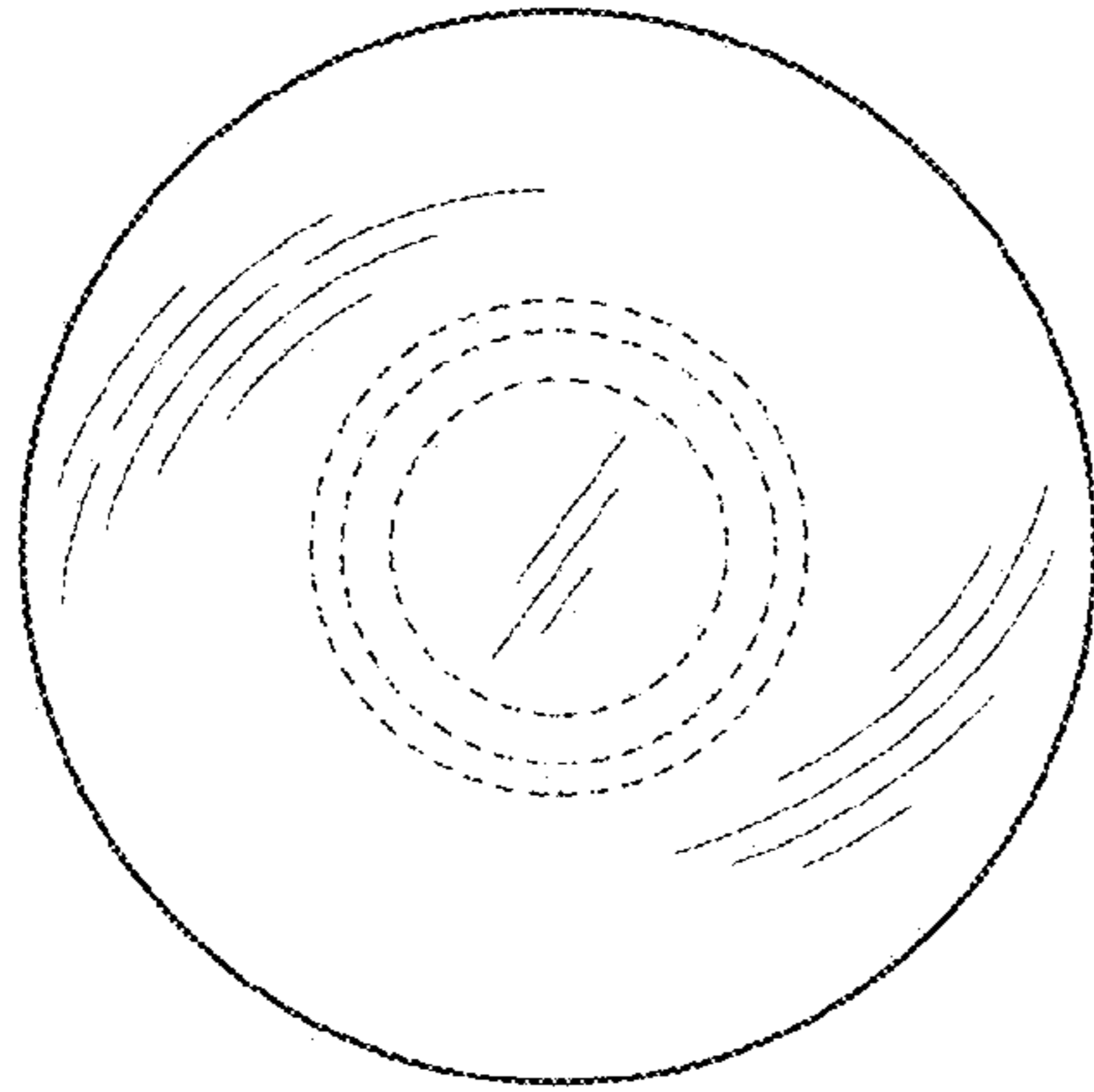

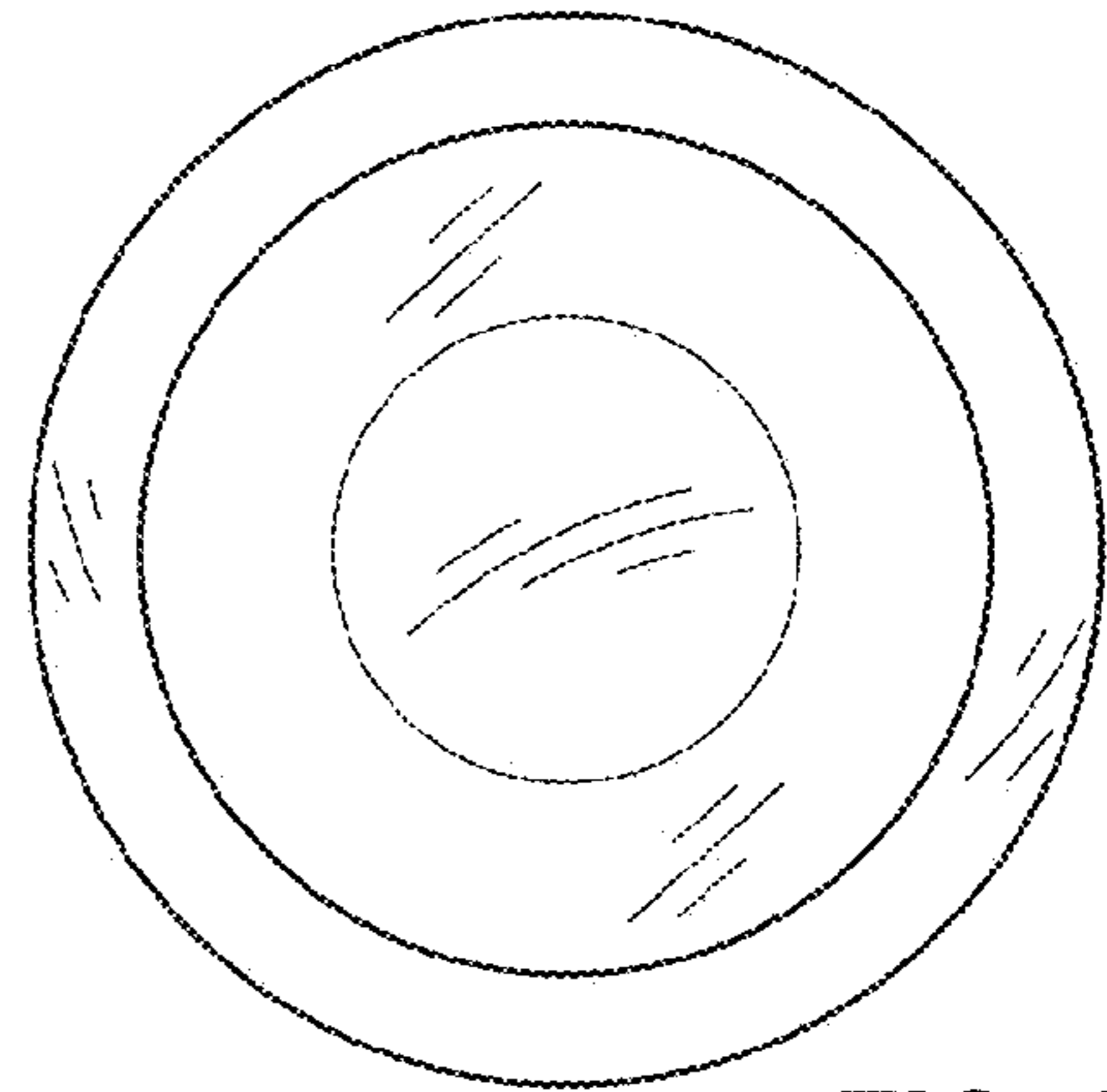

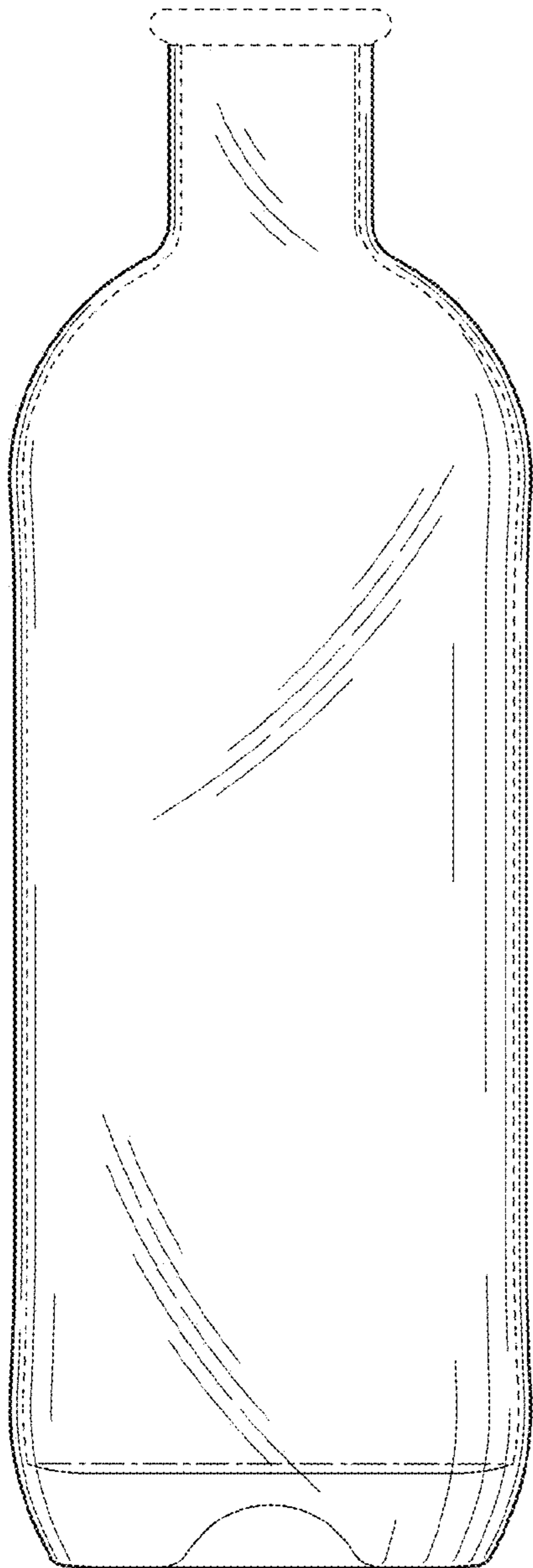

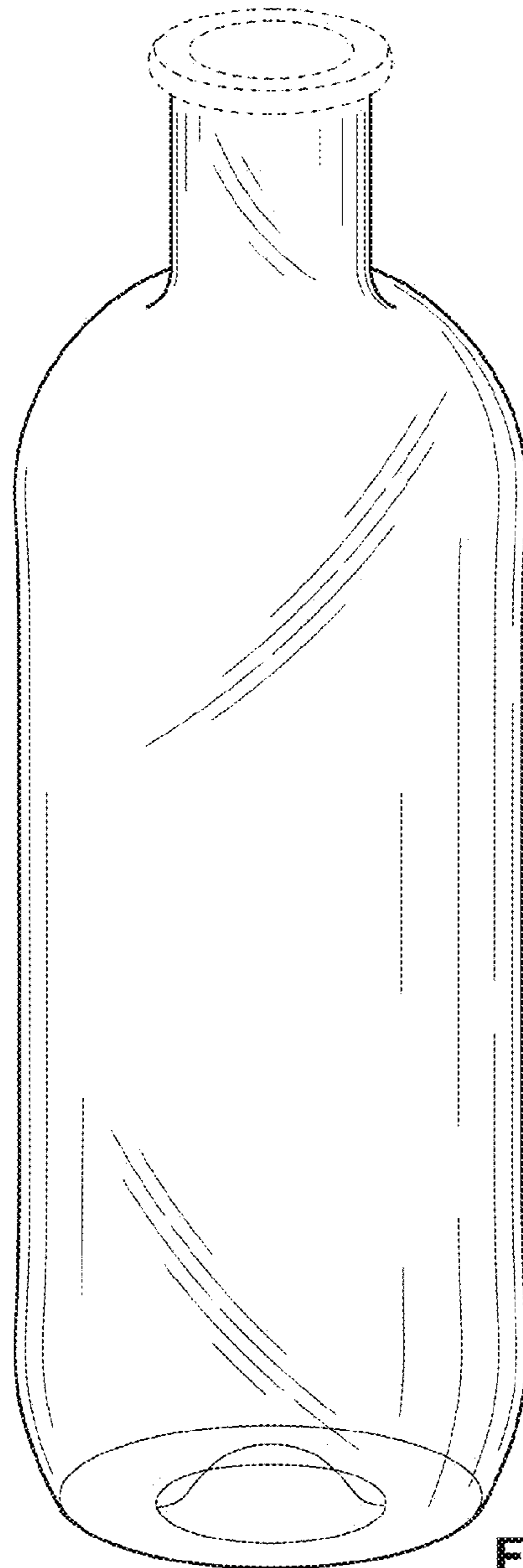
