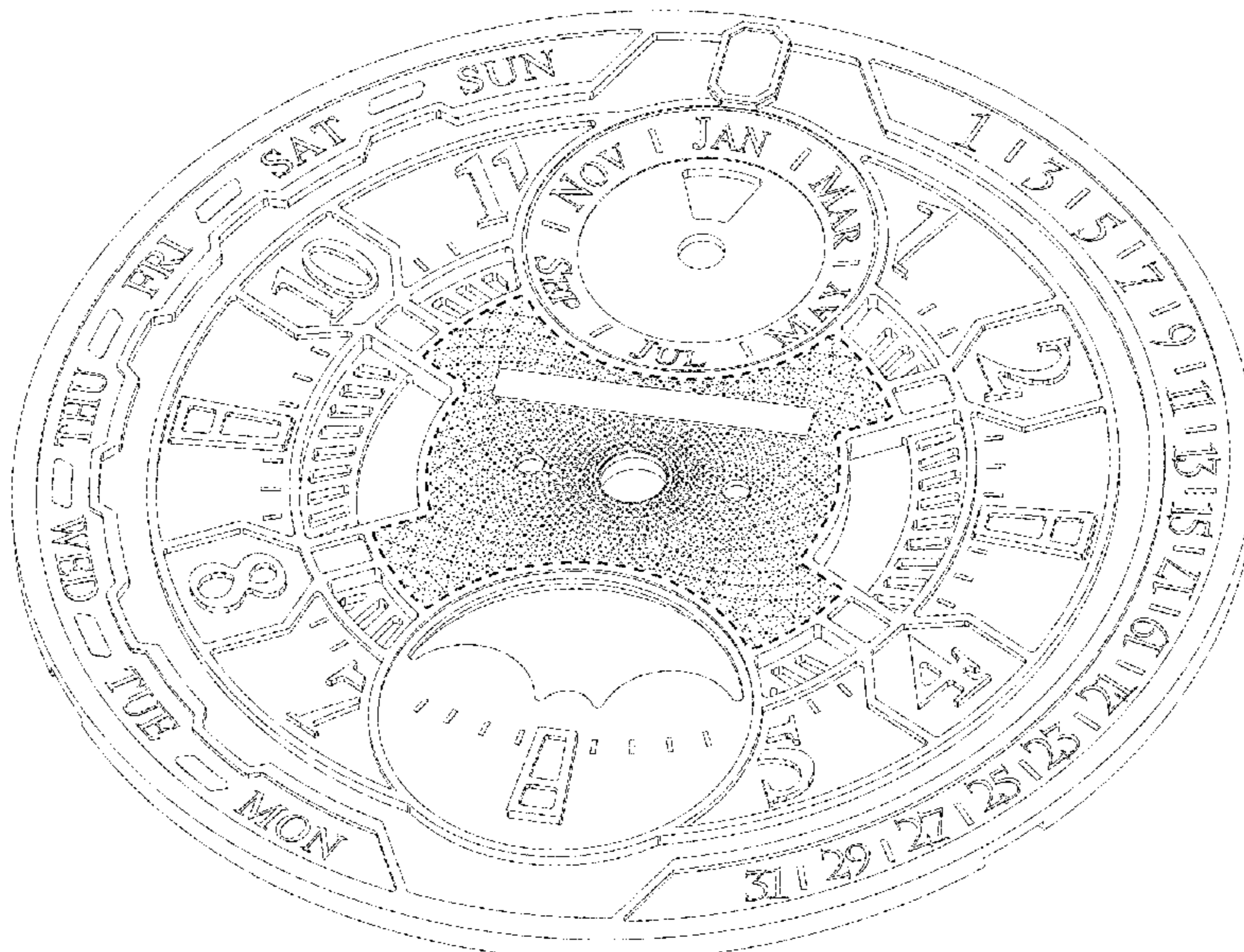
The ornamental design for a dial, as shown and described.

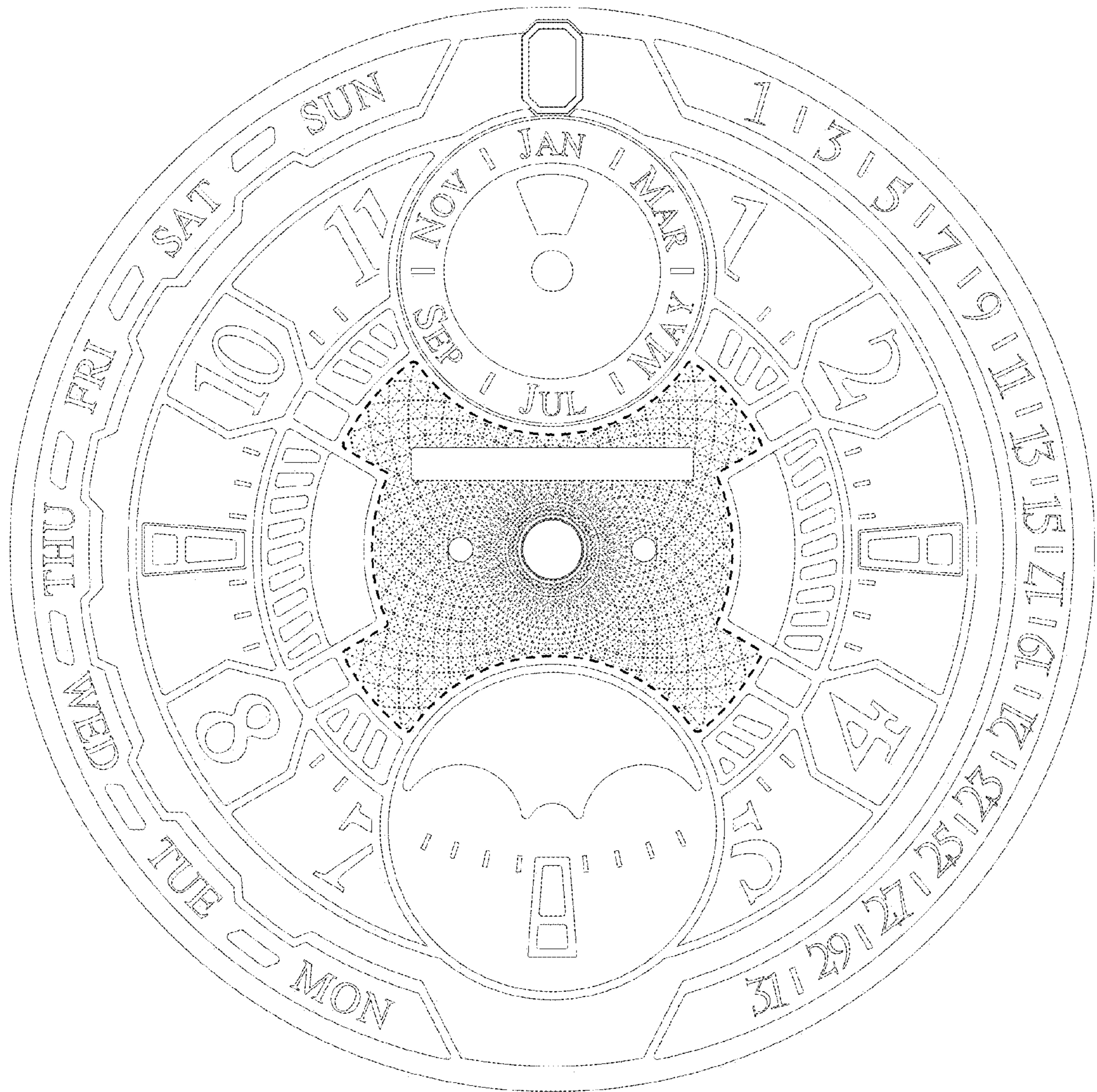
**DESCRIPTION**

Portions of the dial shown in broken lines form no part of the claimed design.

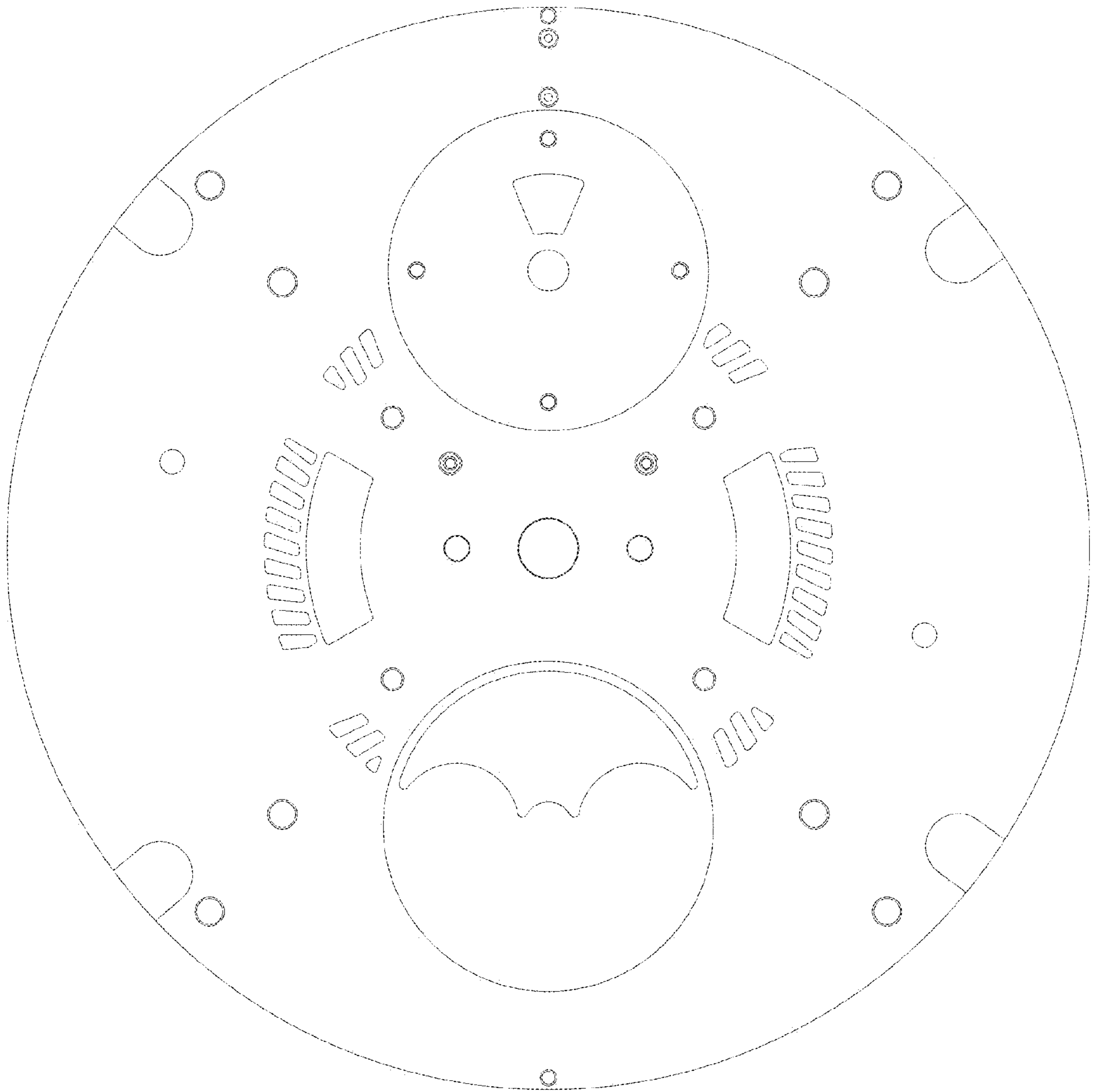

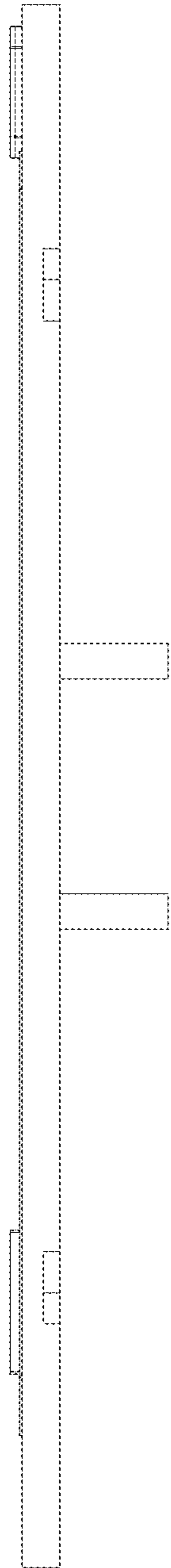




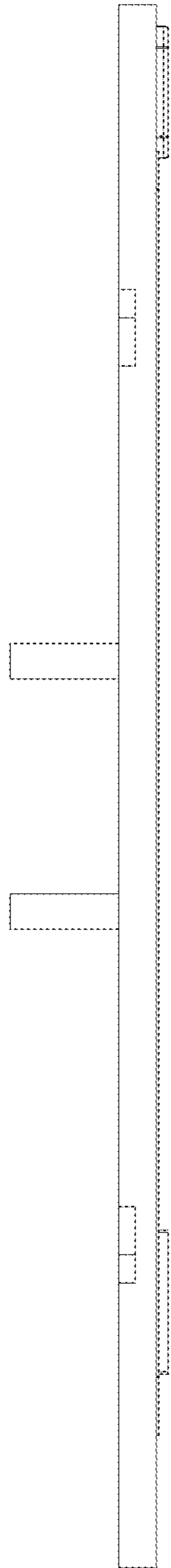

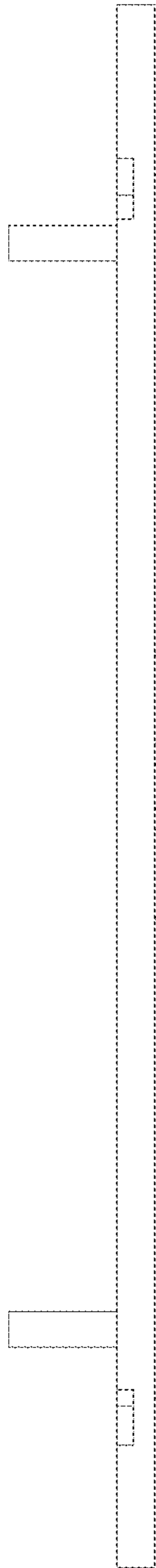

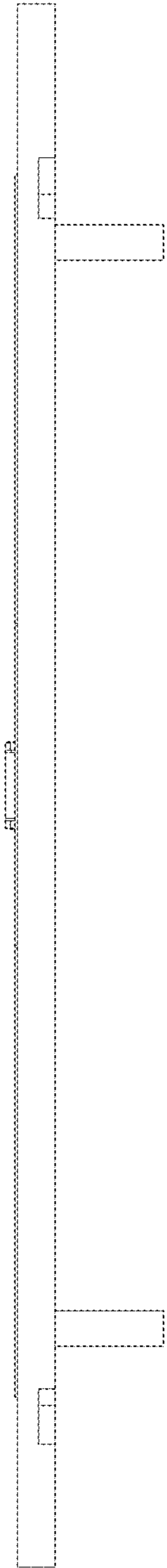

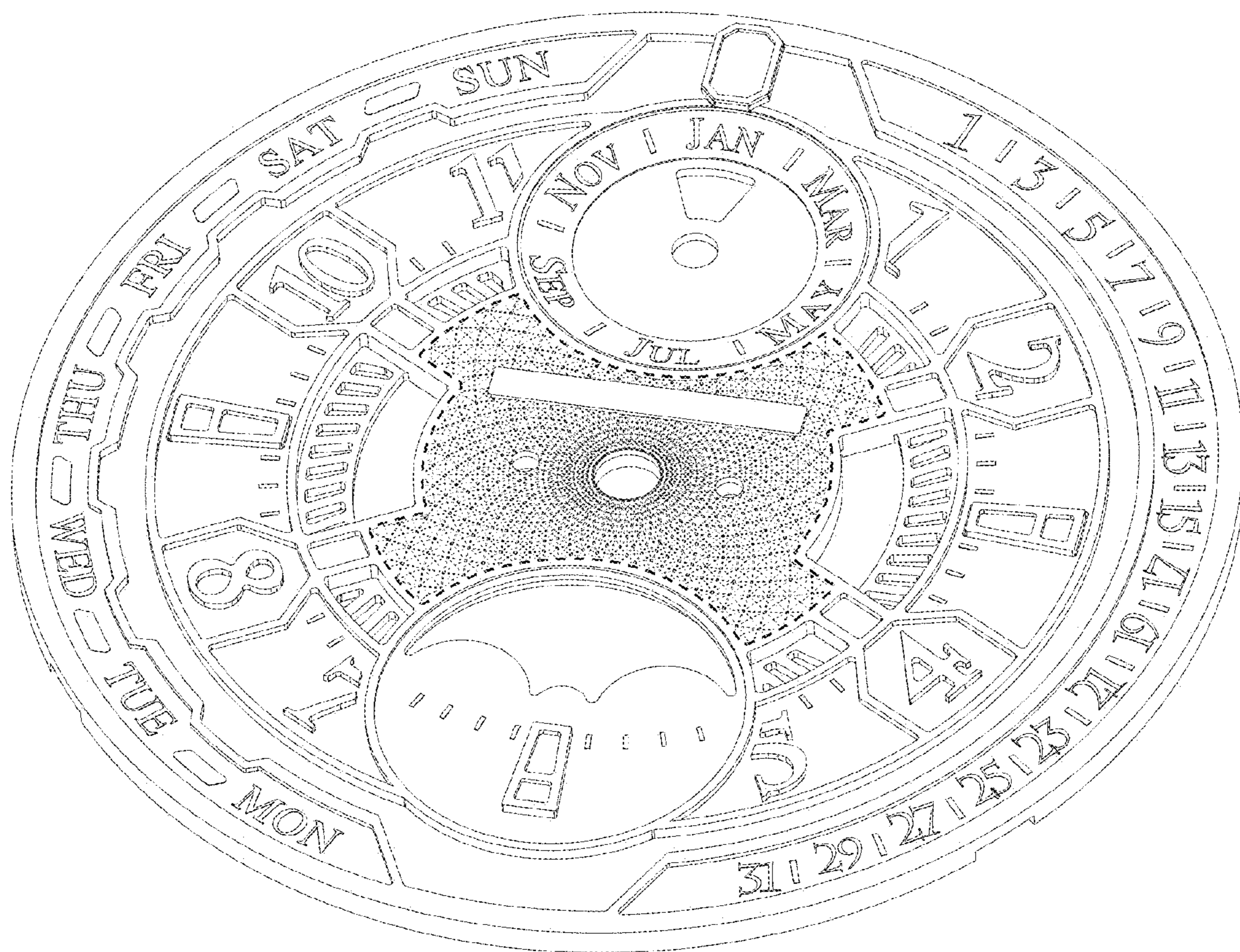

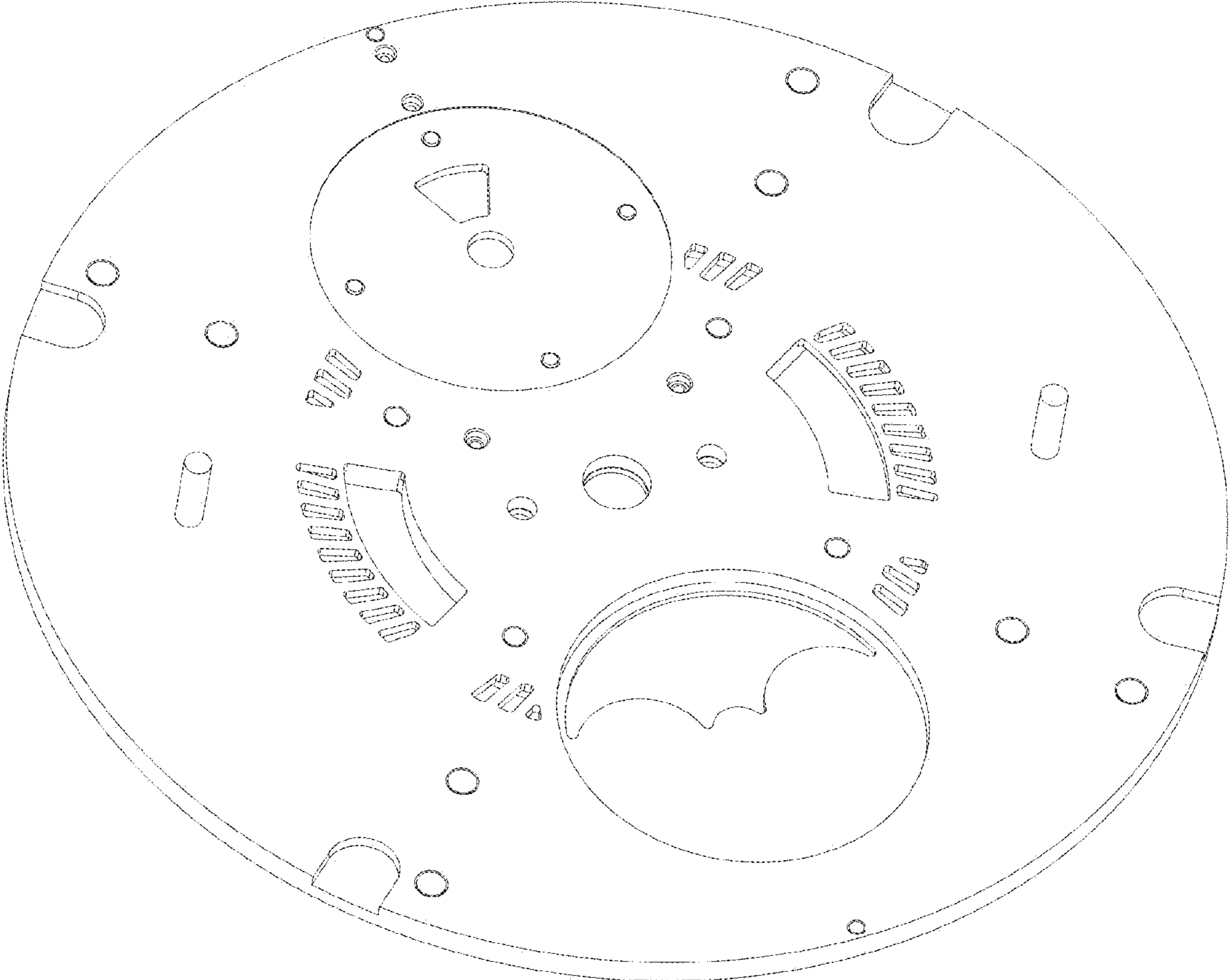
