(57) **CLAIM**

The ornamental design for a pendant, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the present invention shown in a position of use on an unclaimed linking ring and chain drawn in broken lines;
FIG. 2 is a front view of the pendant of FIG. 1 shown removed from the unclaimed linking ring and chain;
FIG. 3 is a back view thereof;
FIG. 4 is a right-side view thereof;
FIG. 5 is a left-side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines illustrating a linking ring and chain depict environment and form no part of the claimed design.

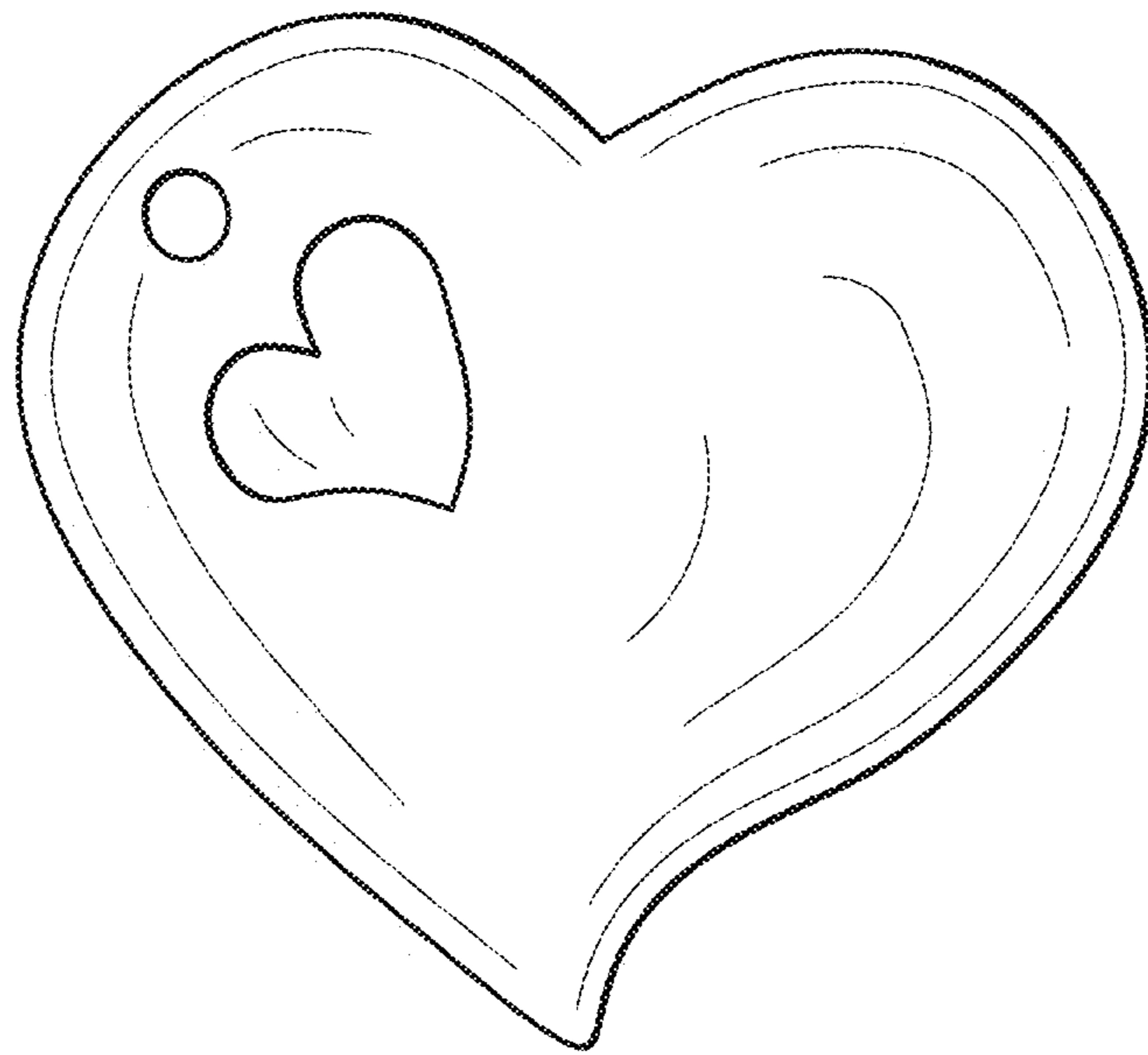

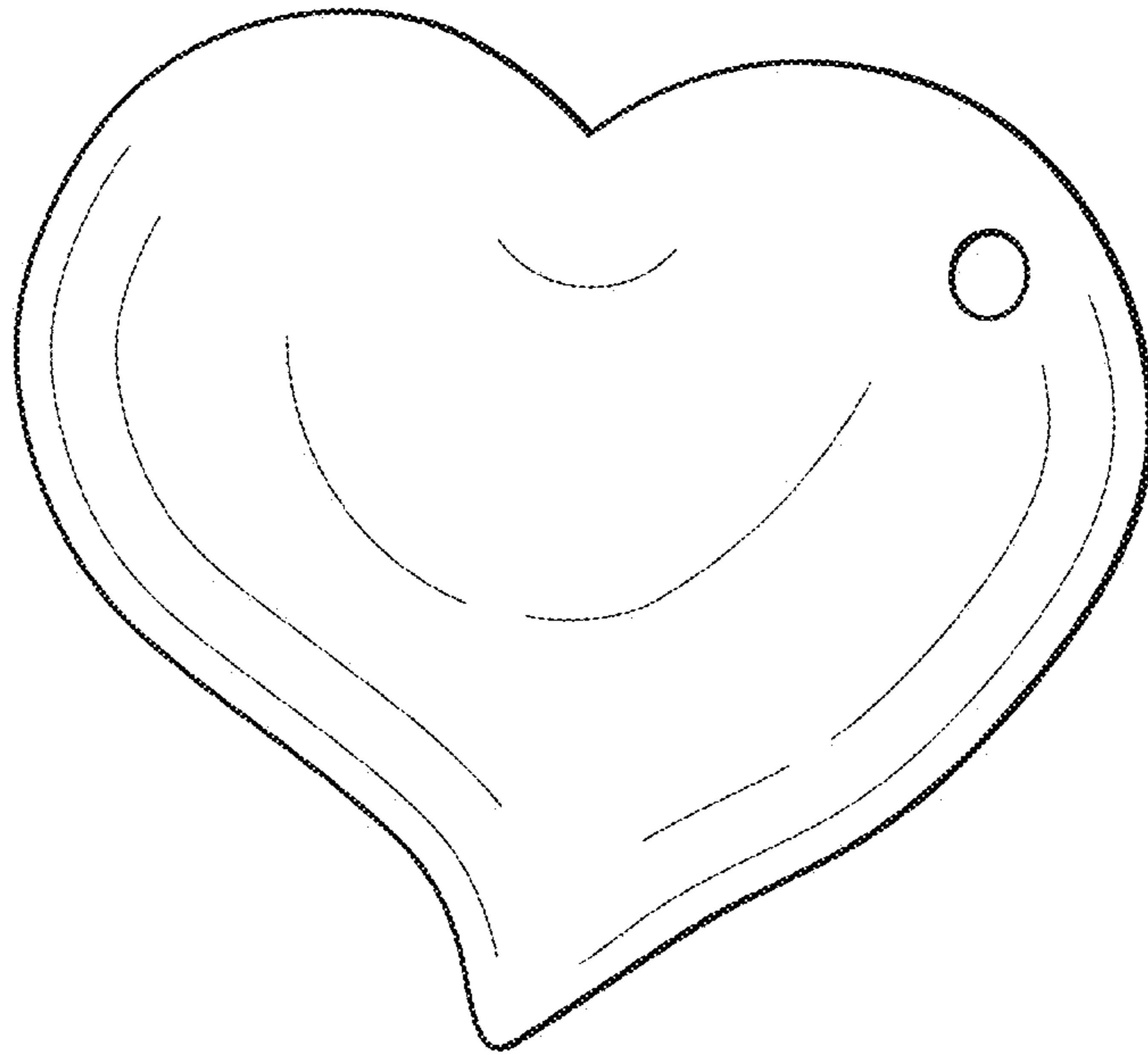

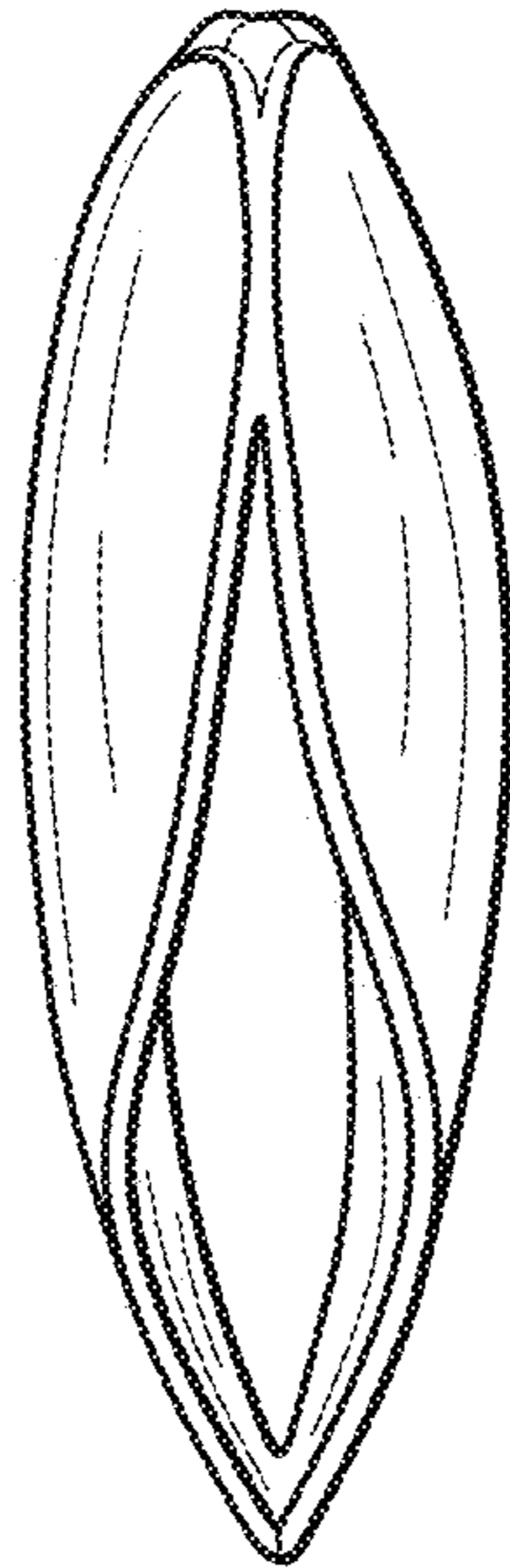

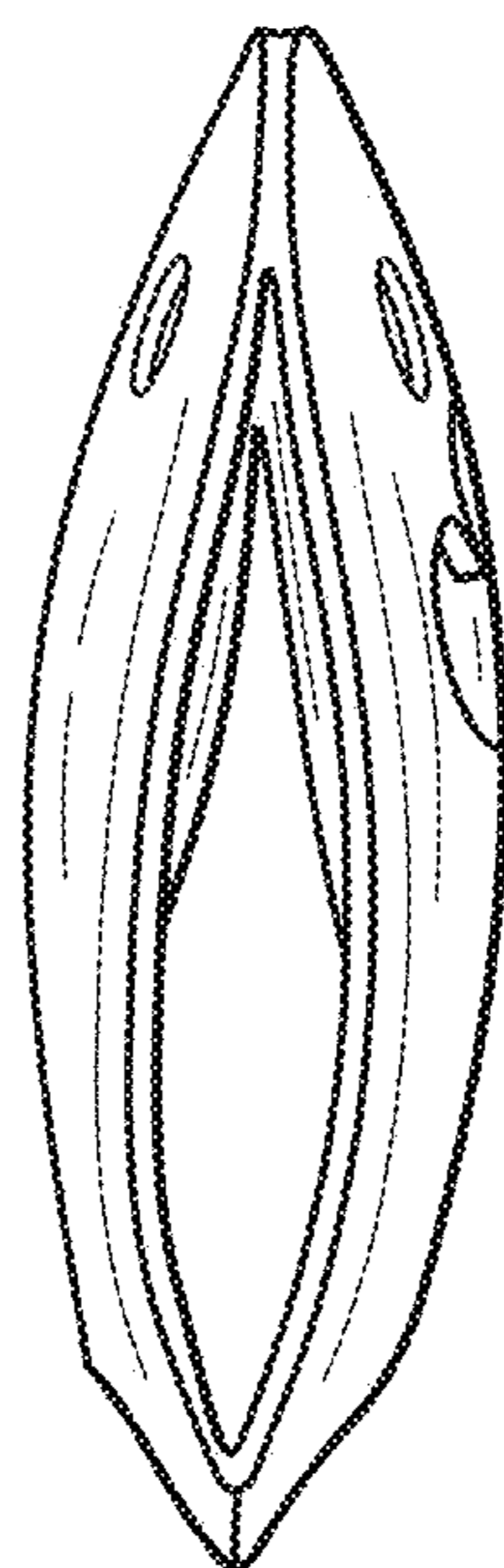

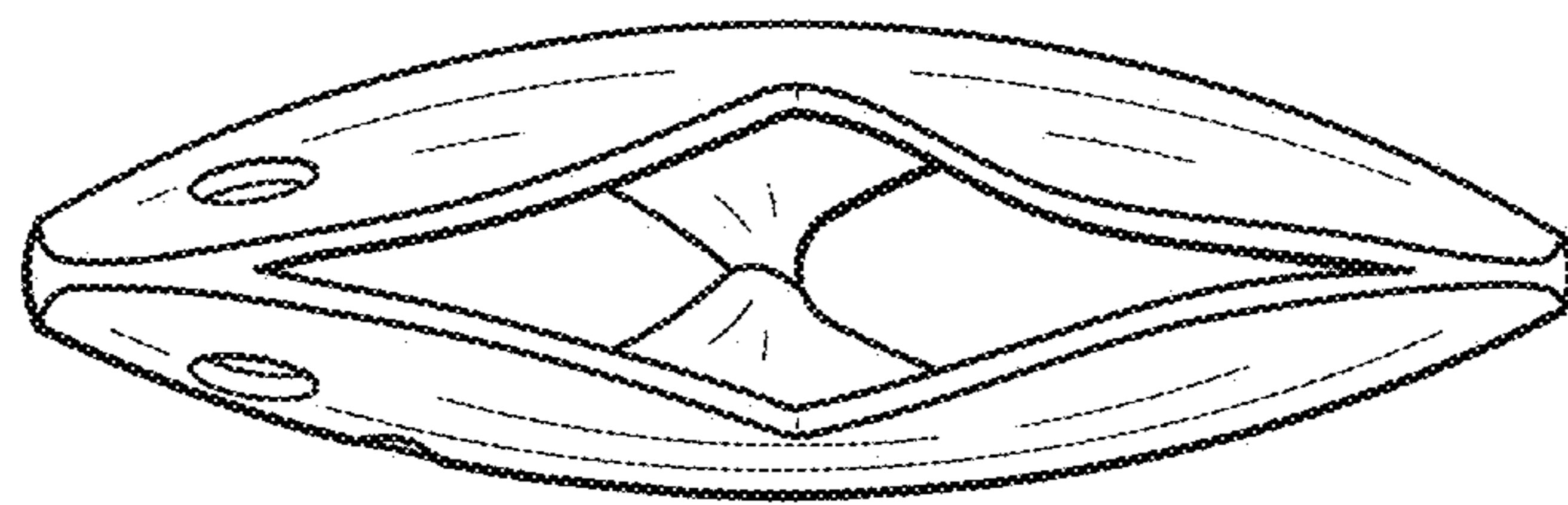
