The ornamental design for a motor vehicle, toy and/or replicas thereof, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a motor vehicle, toy and/or replicas thereof showing my new design; FIG. 2 is a rear and left side perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; and, FIG. 7 is a top view thereof.

The wheels and lights of the motor vehicle shown throughout the drawings views in a de-emphasized and faded out half tone manner are for environmental and illustrative purposes and form no part of the claimed design.

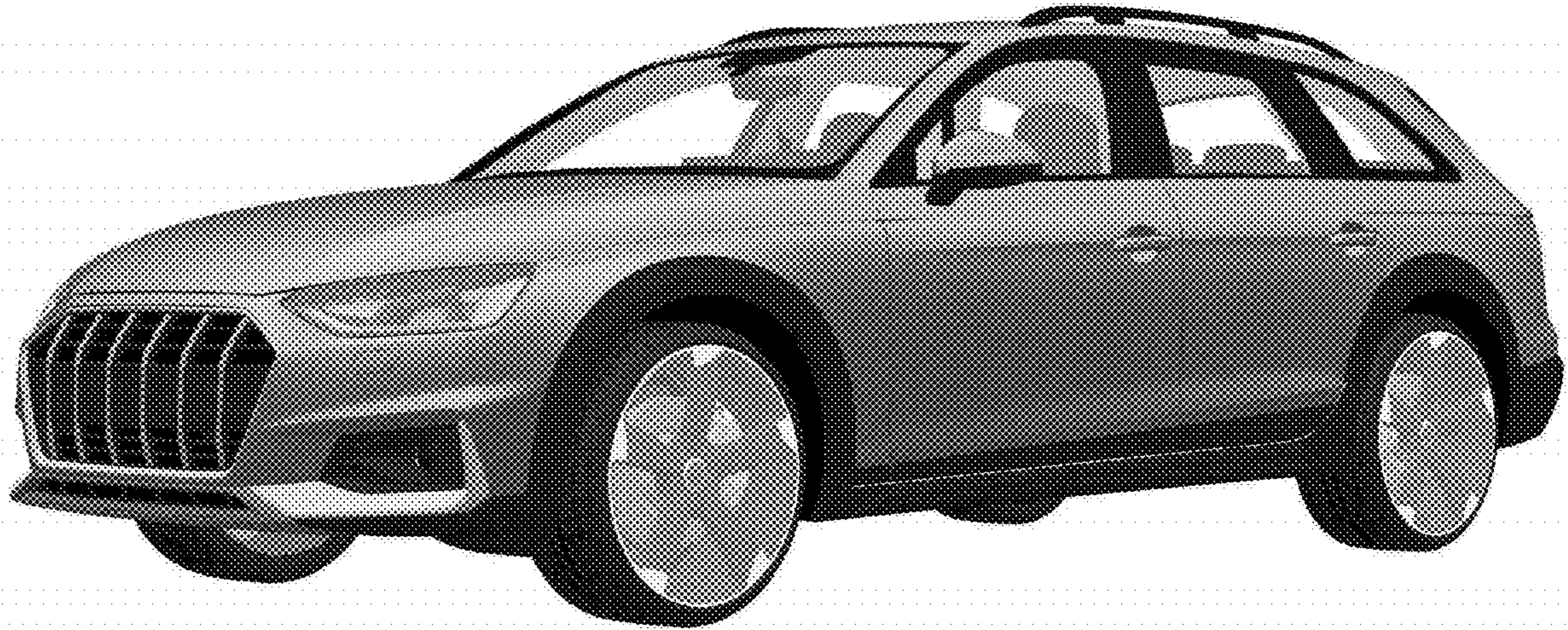

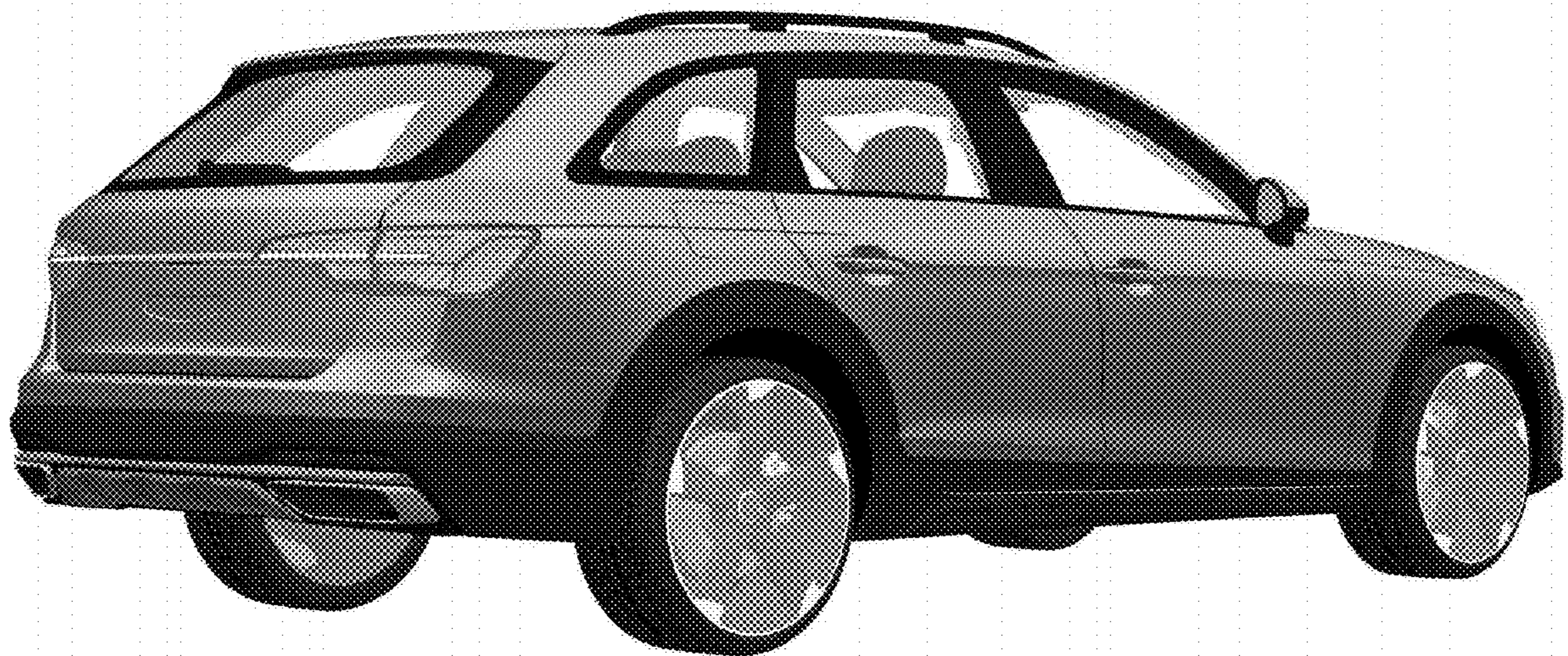

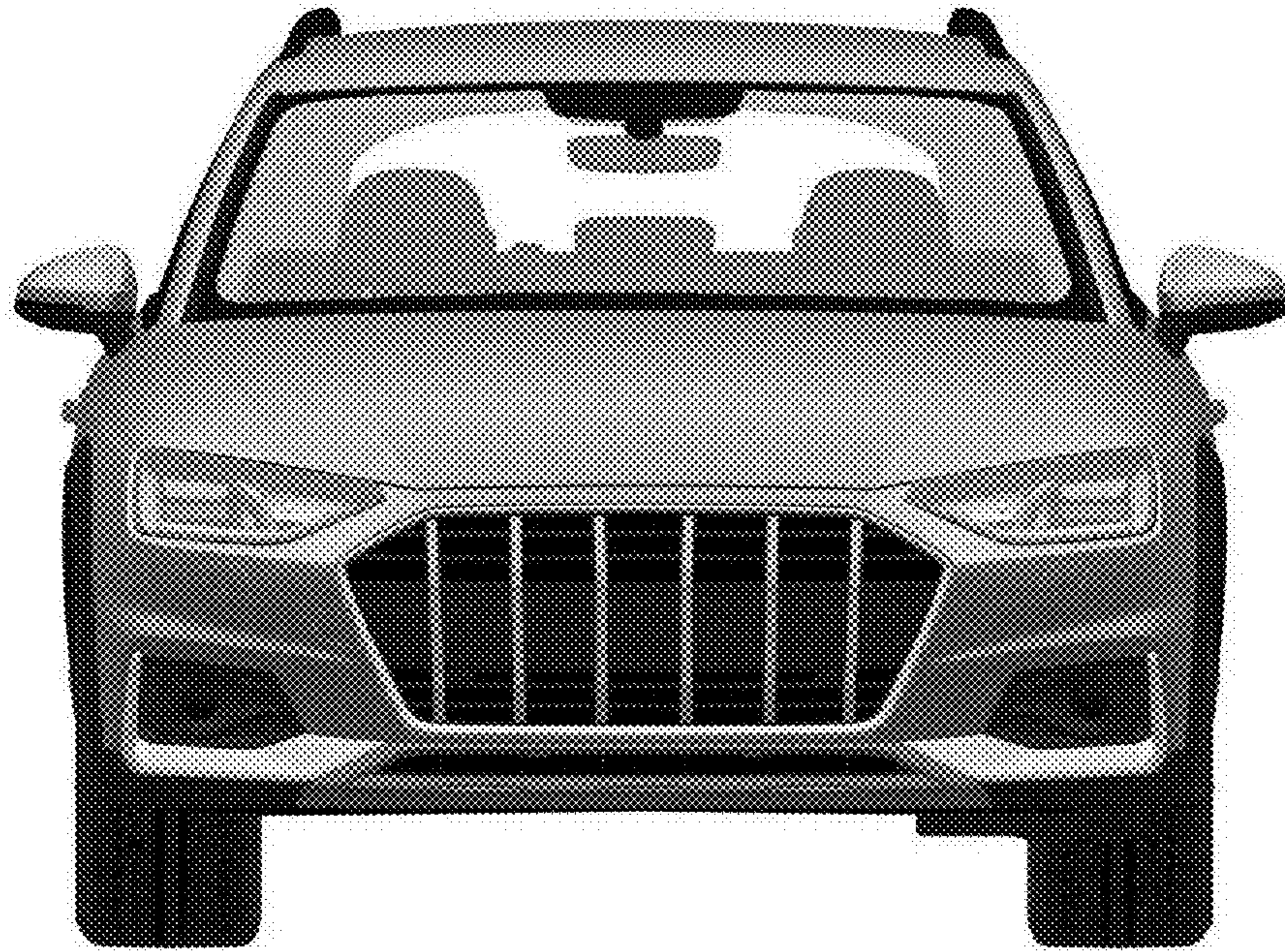

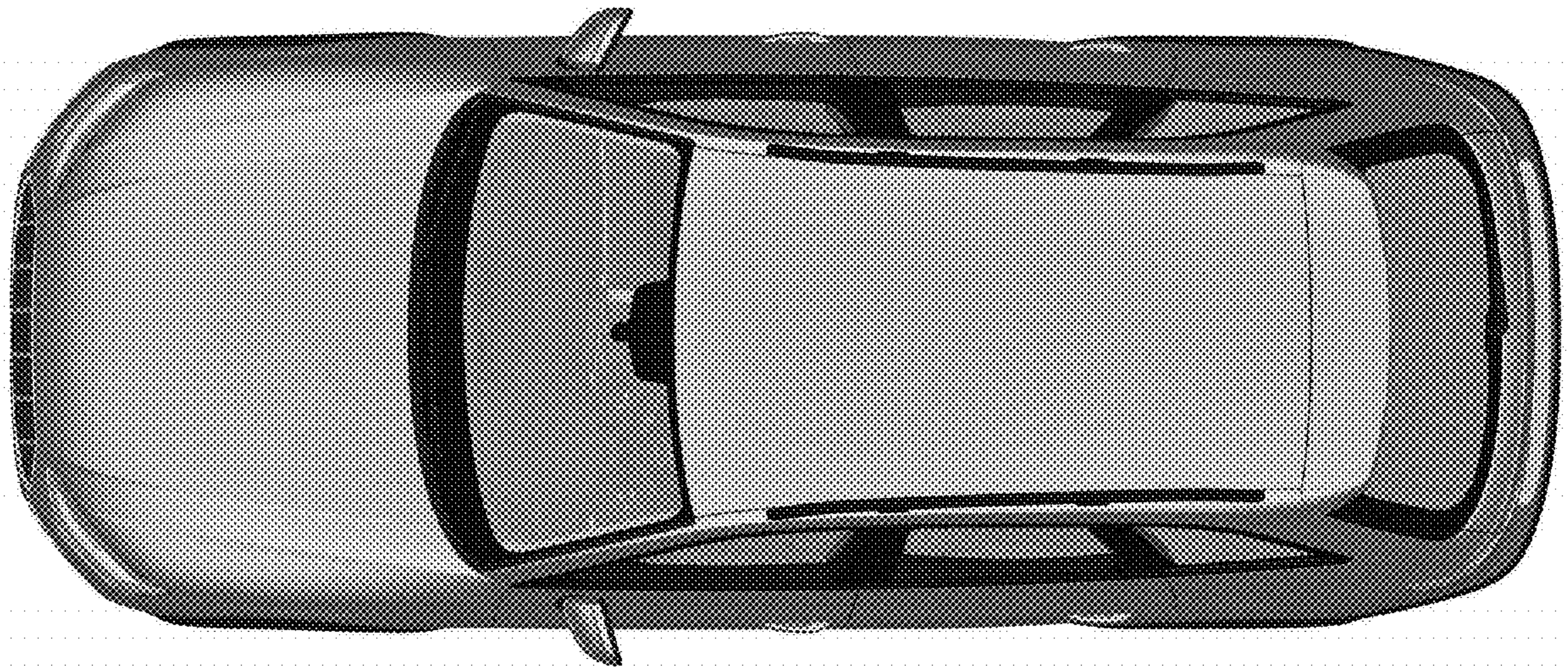
