(57) **CLAIM**

The ornamental design for a radiator grille for a vehicle, as shown and described.

DESCRIPTION

FIG. 3 is a left, bottom perspective view thereof;

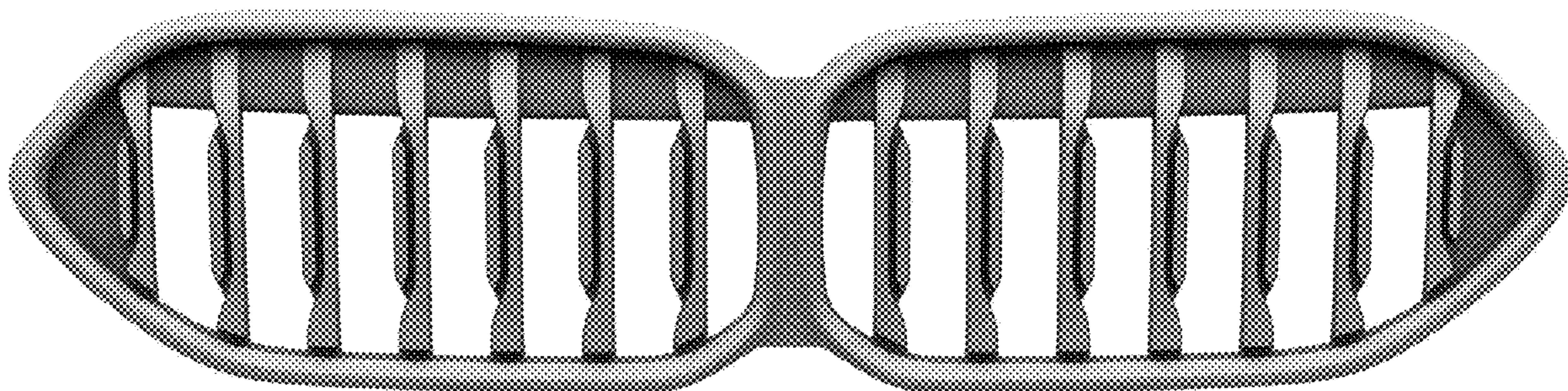
FIG. 4 is a right side view thereof;

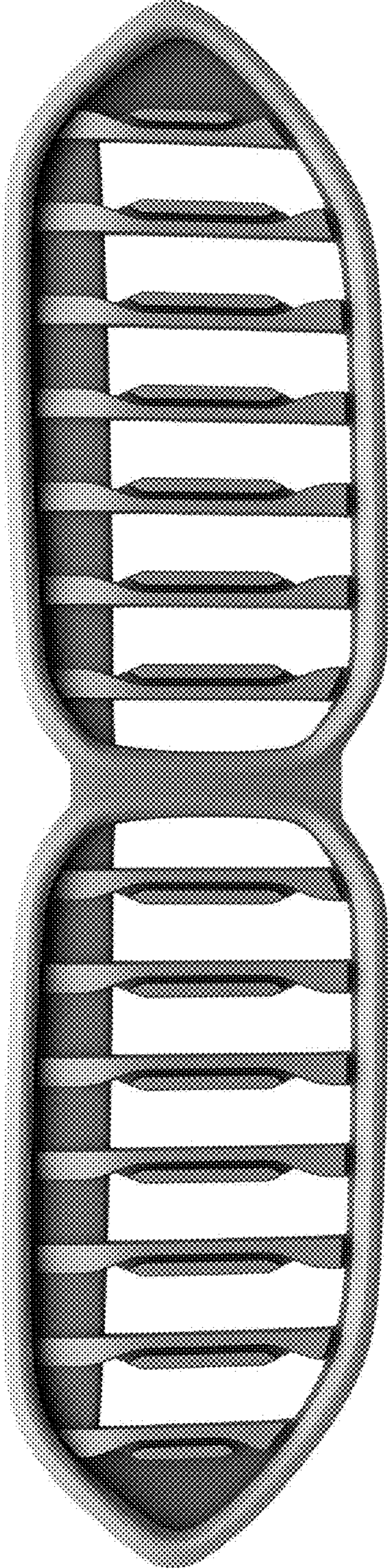

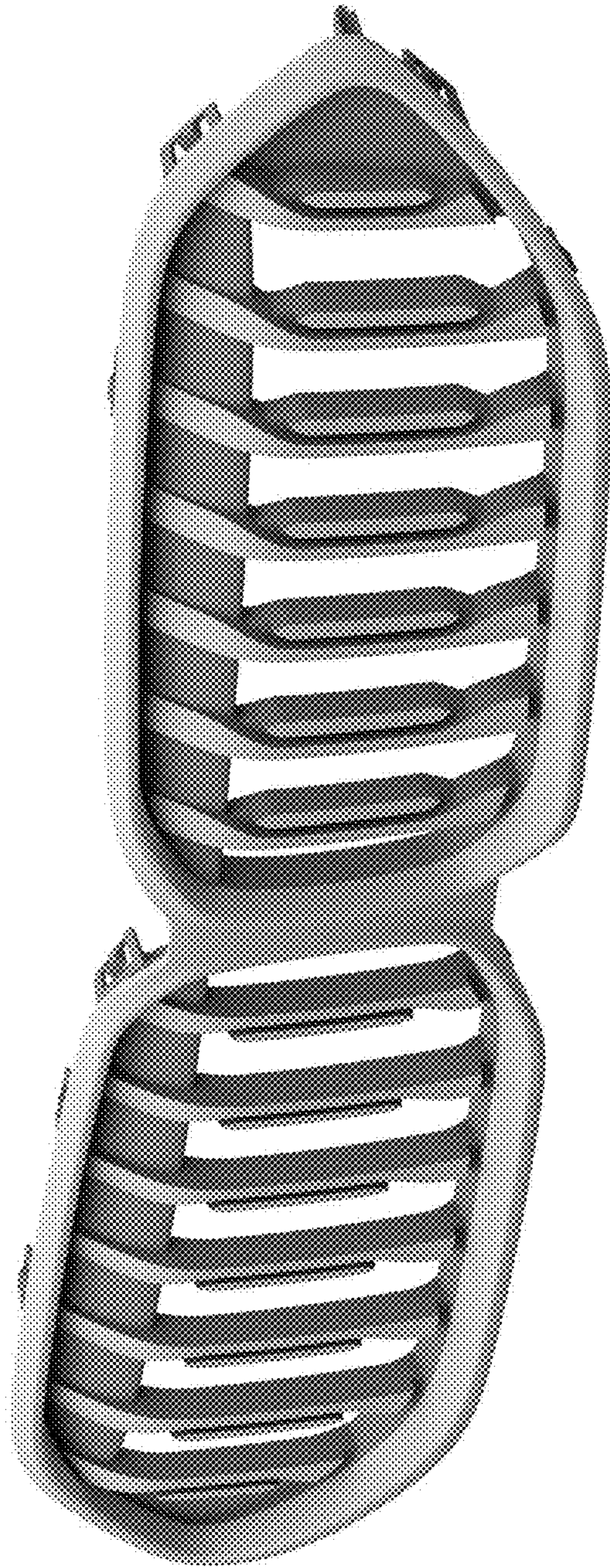

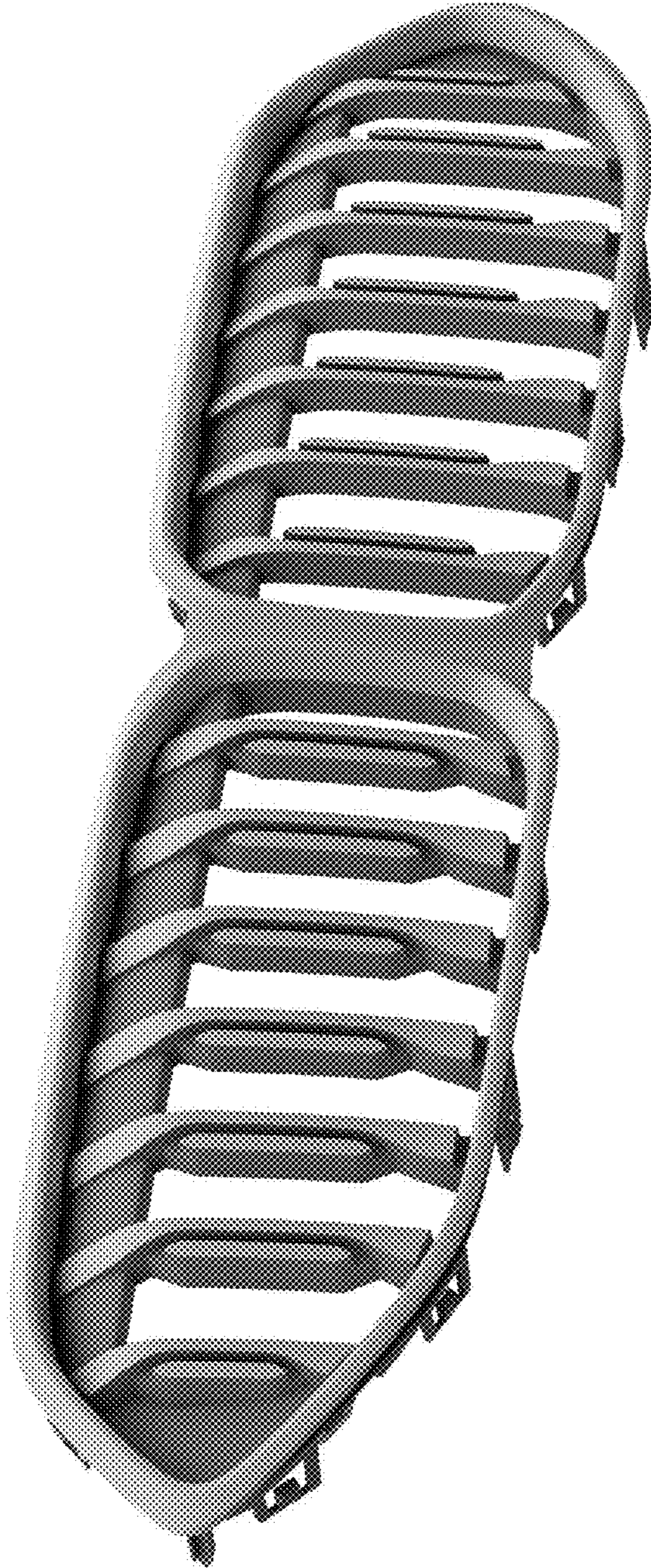

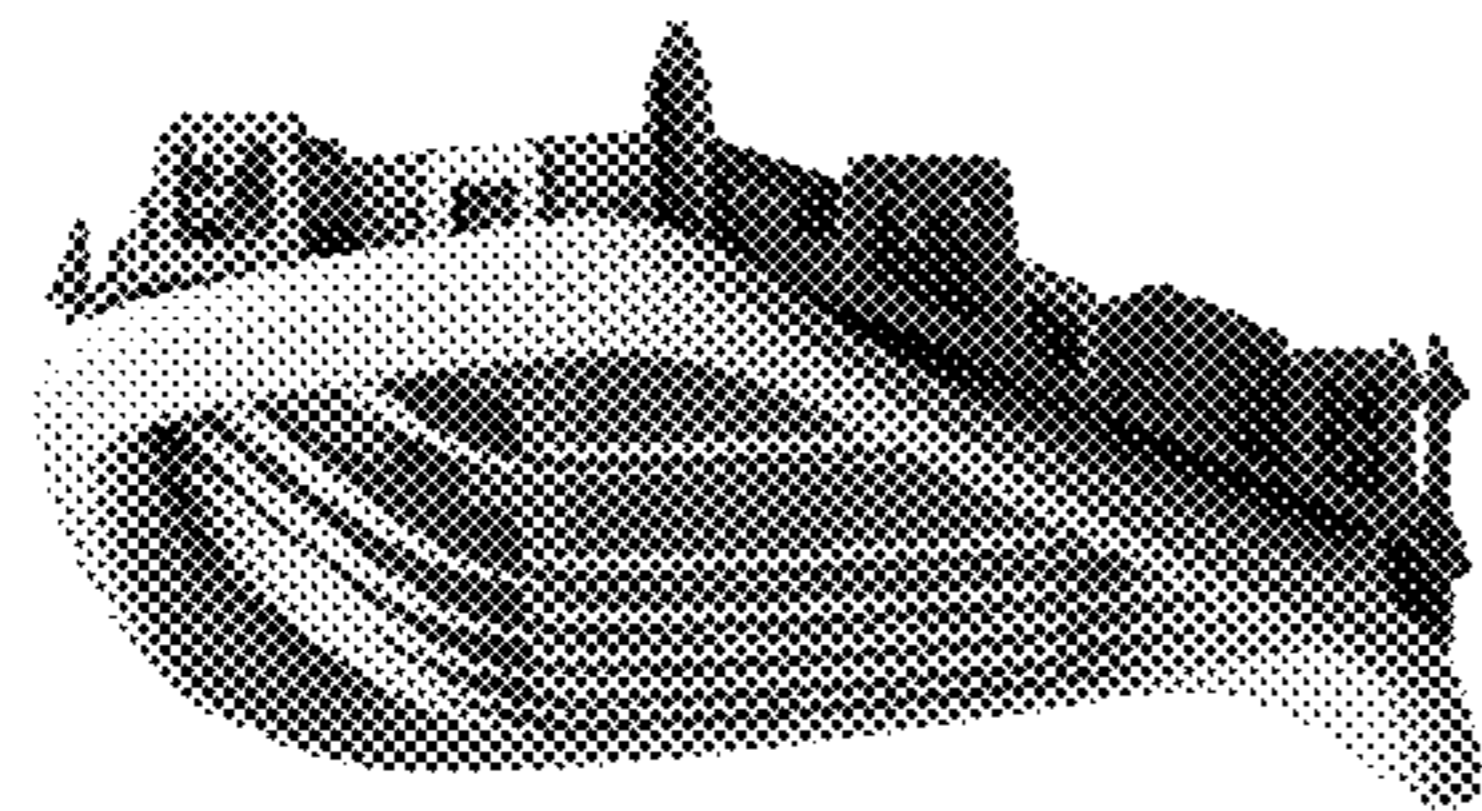

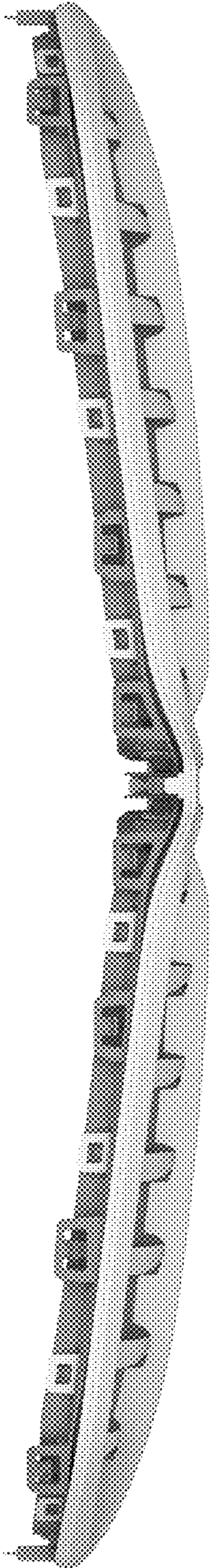

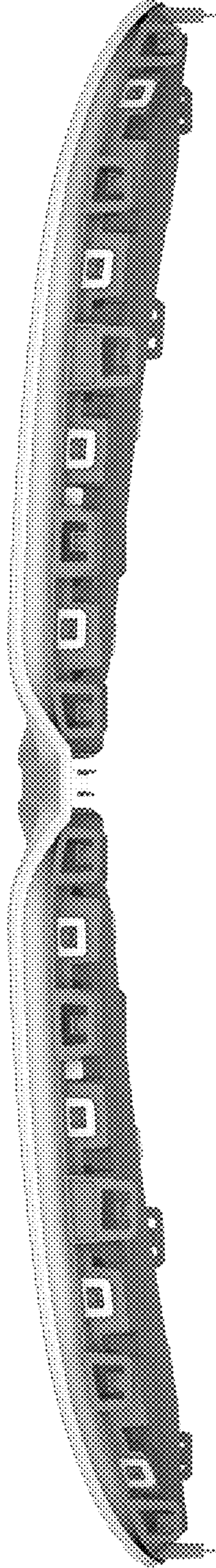
