The ornamental design for a shift cable bushing, as shown and described.

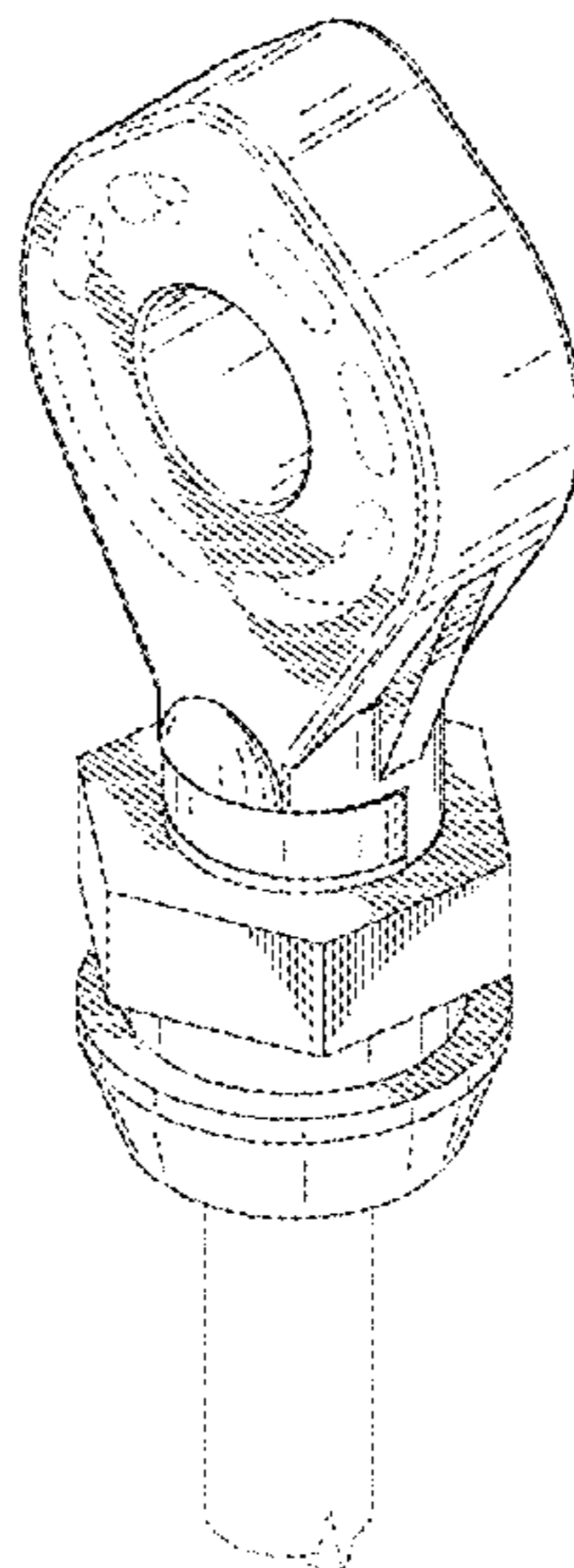
**DESCRIPTION**

FIG. 1 is a perspective view of our shift cable bushing; FIG. 2 is a front elevation of the shift cable bushing in FIG. 1; FIG. 3 is a rear elevation of the shift cable bushing in FIG. 1; FIG. 4 is a right side elevation of the shift cable bushing in FIG. 1; FIG. 5 is a left side elevation of the shift cable bushing in FIG. 1; FIG. 6 is a top plan view of the shift cable bushing in FIG. 1; and, FIG. 7 is a bottom plan view of the shift cable bushing in FIG. 1. The broken lines illustrate portions of the shift cable bushing that form no part of the claimed design.

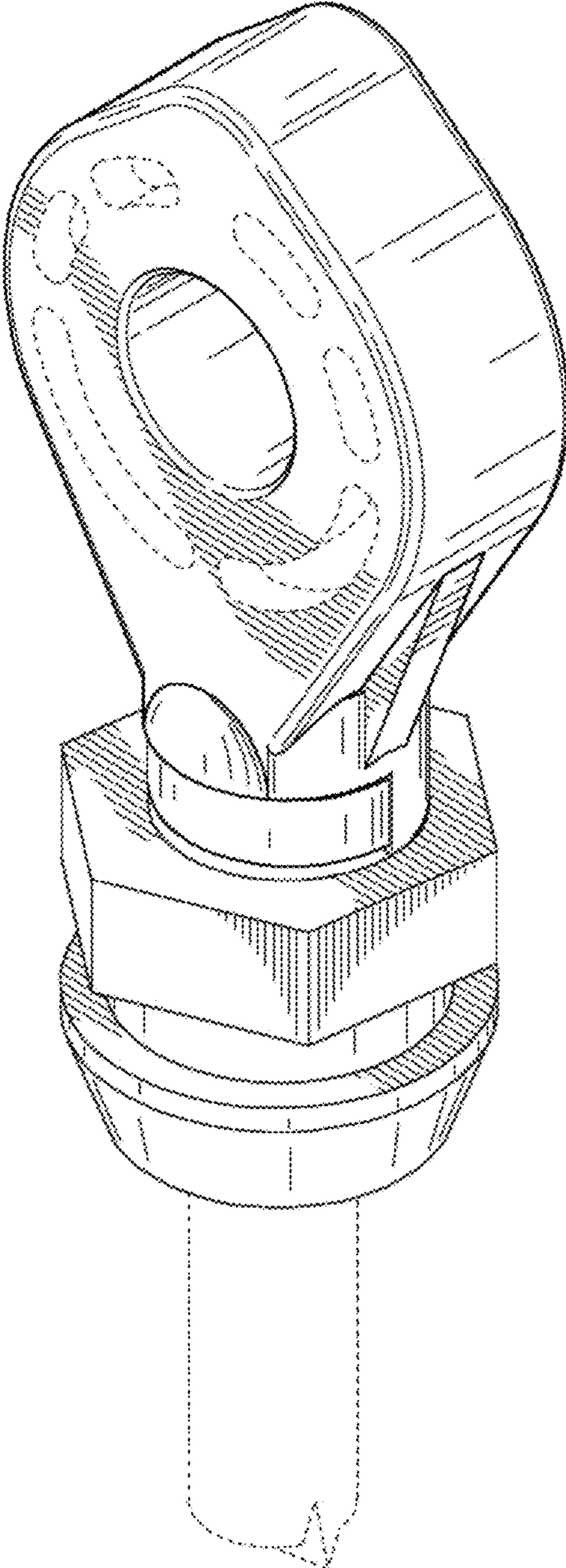

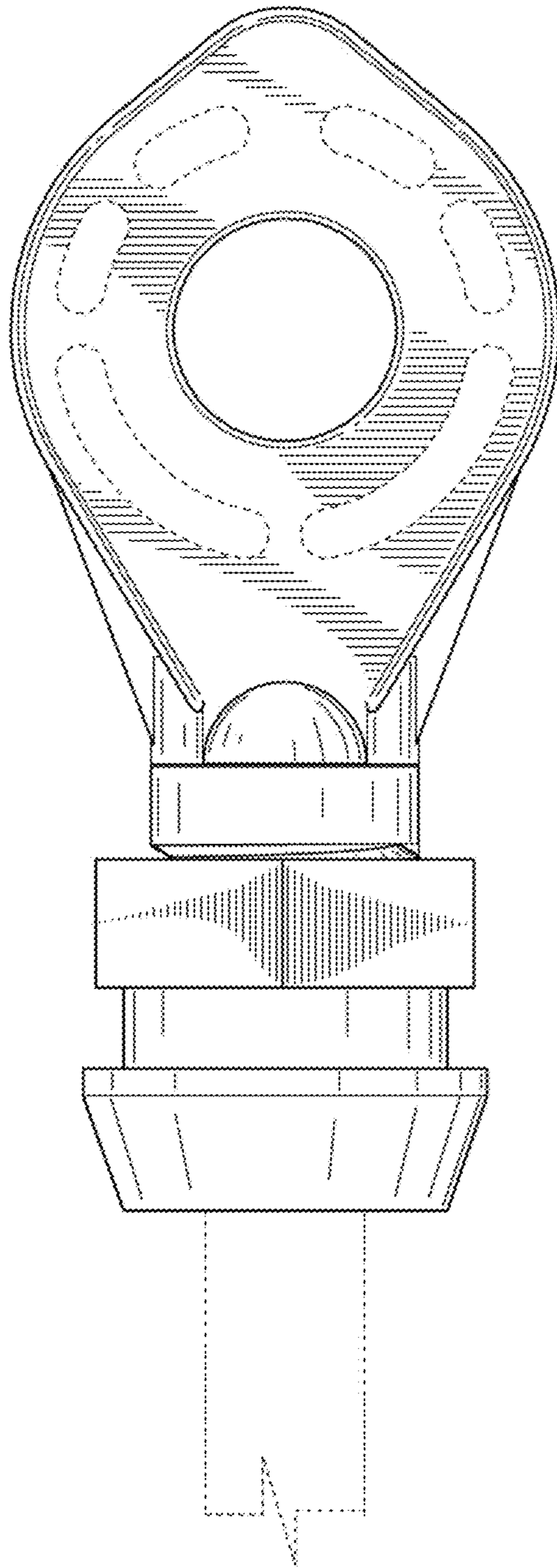

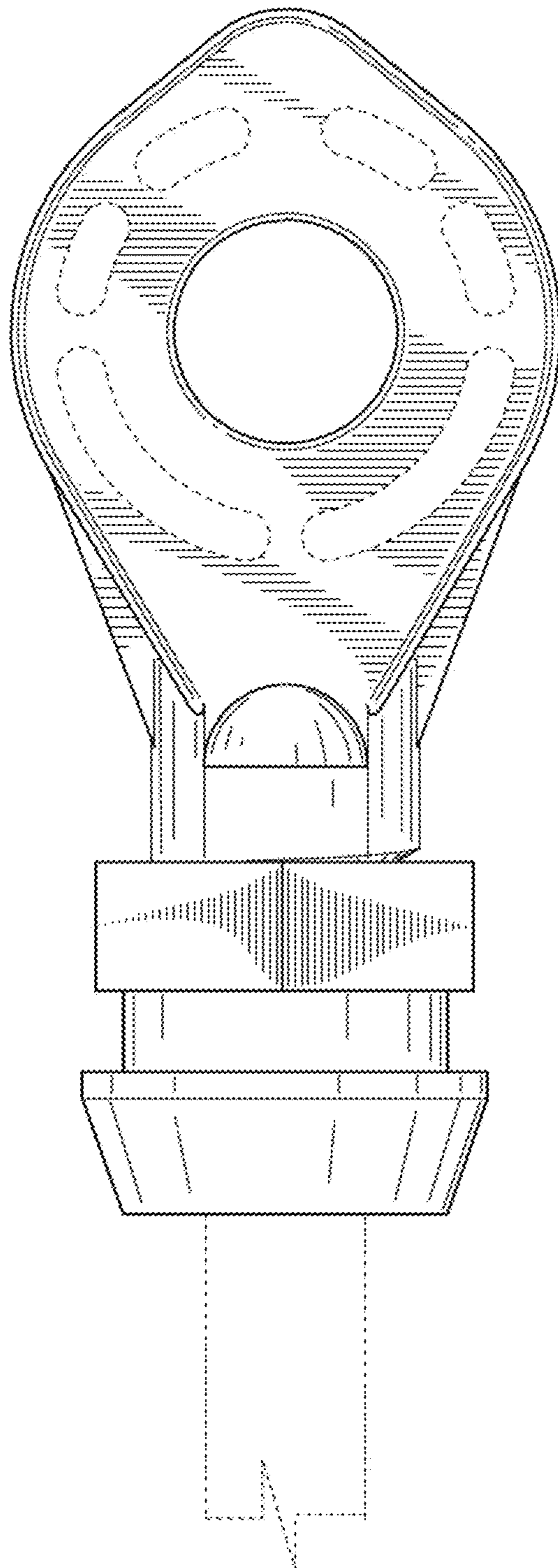

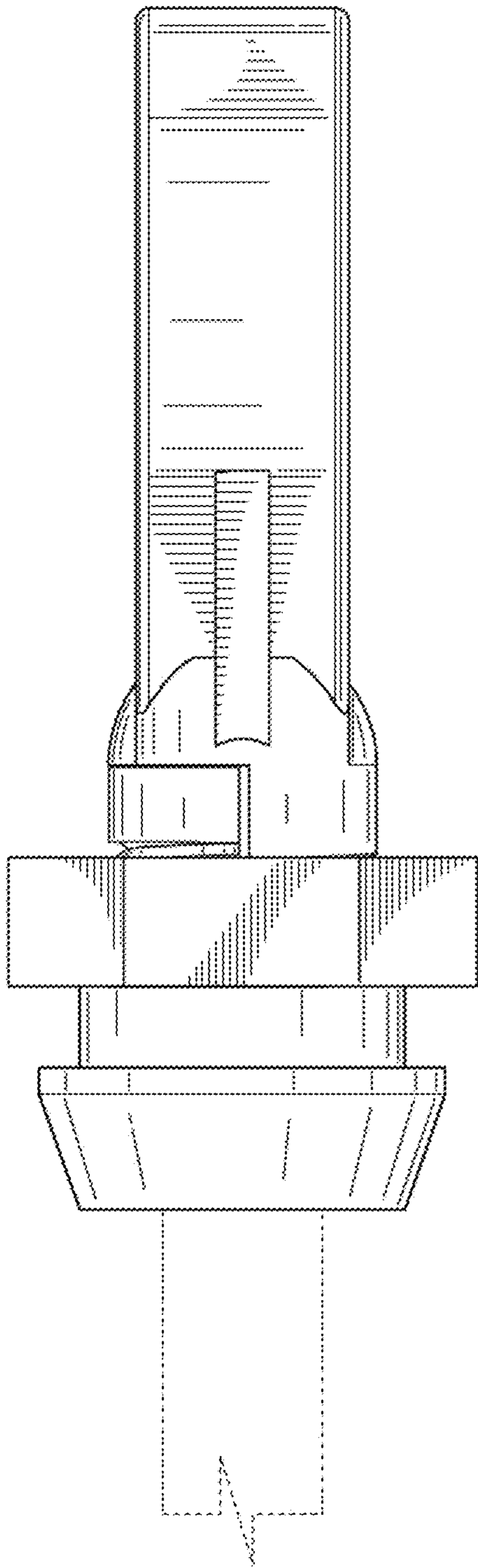

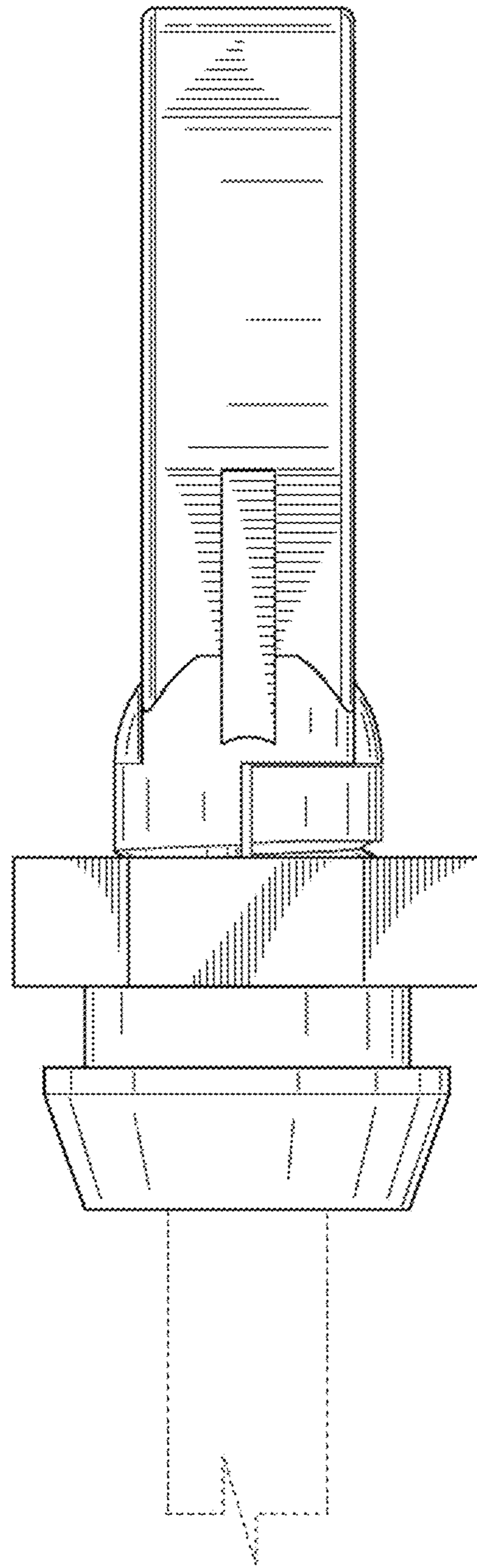

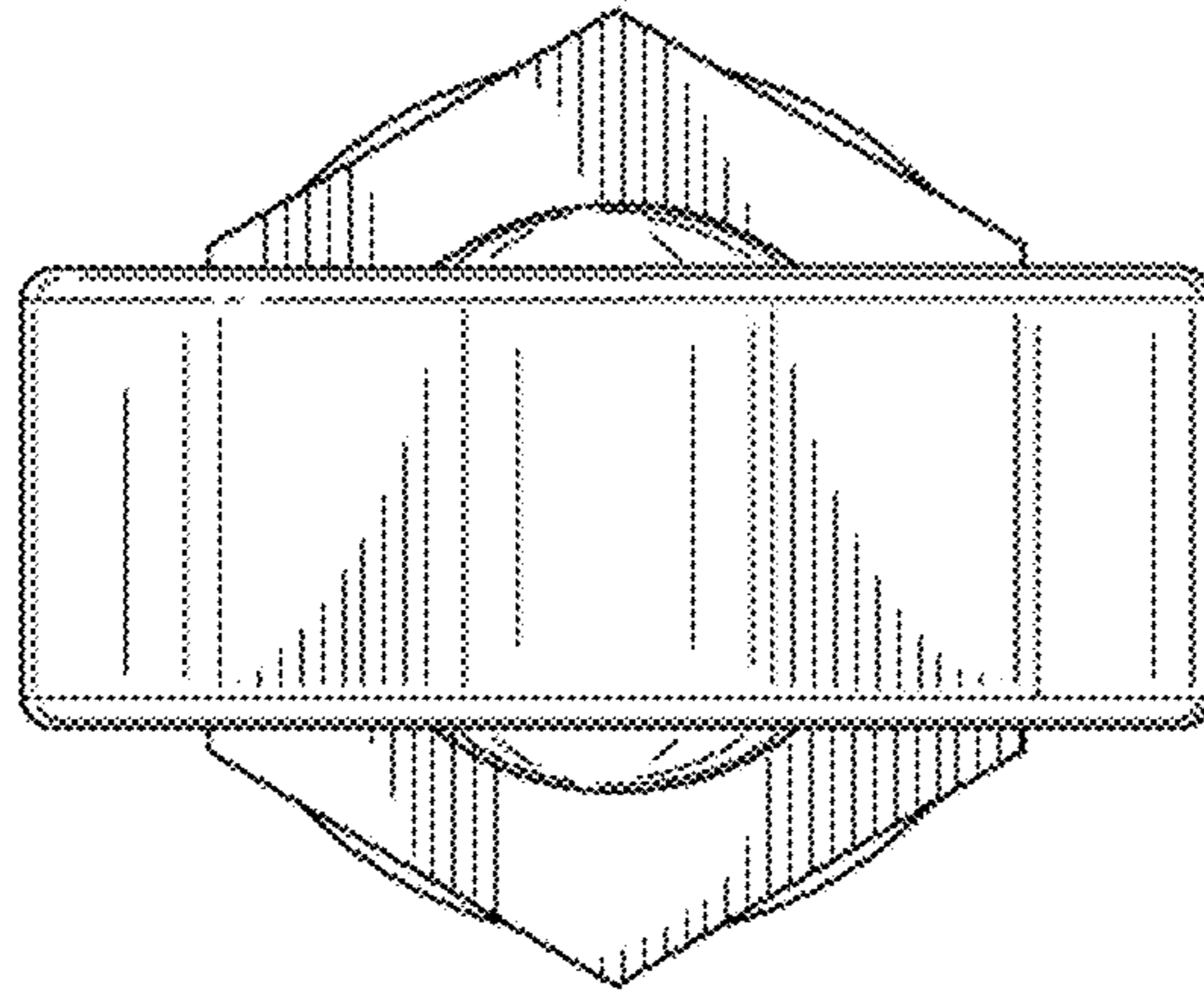

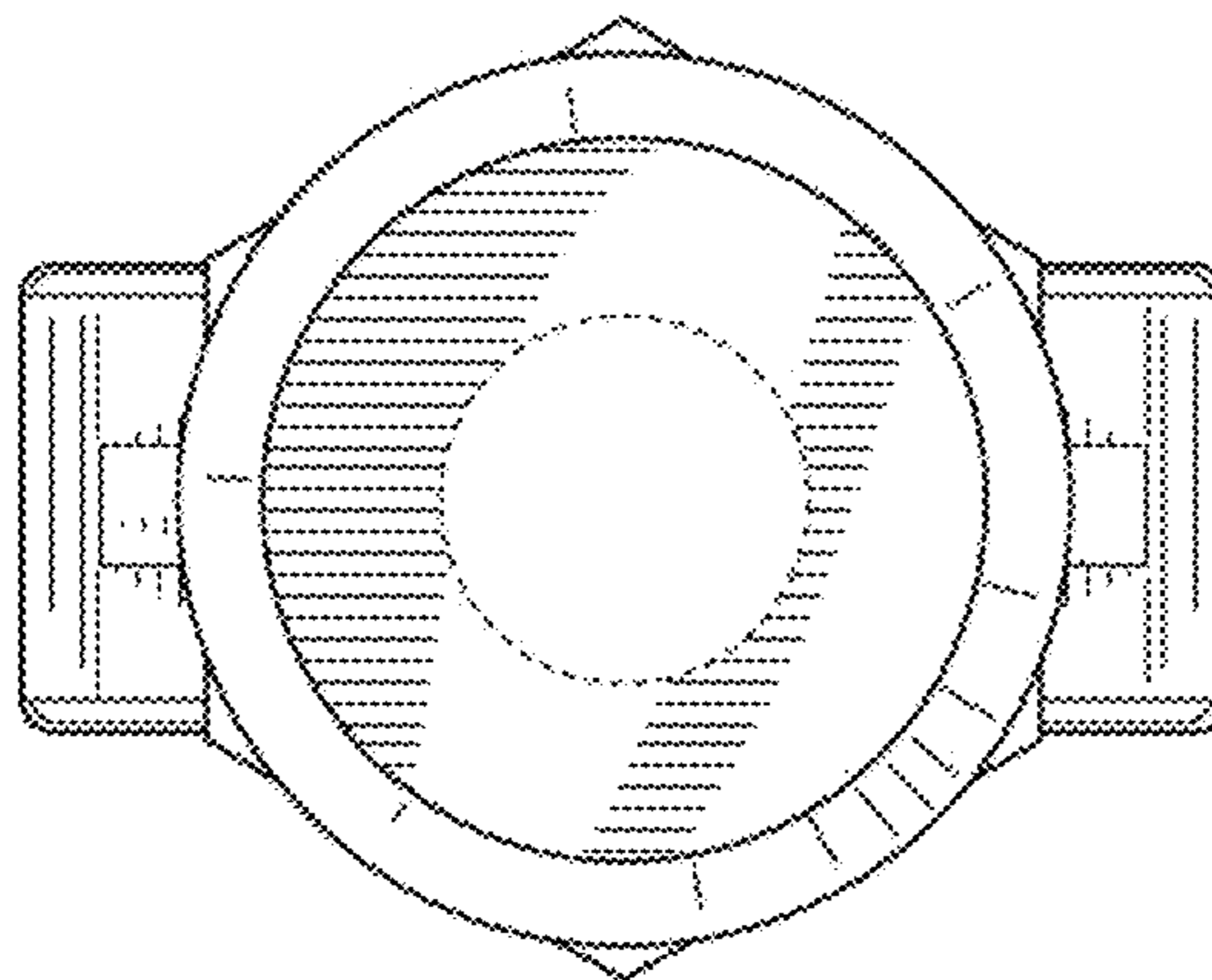
