DESCRIPTION

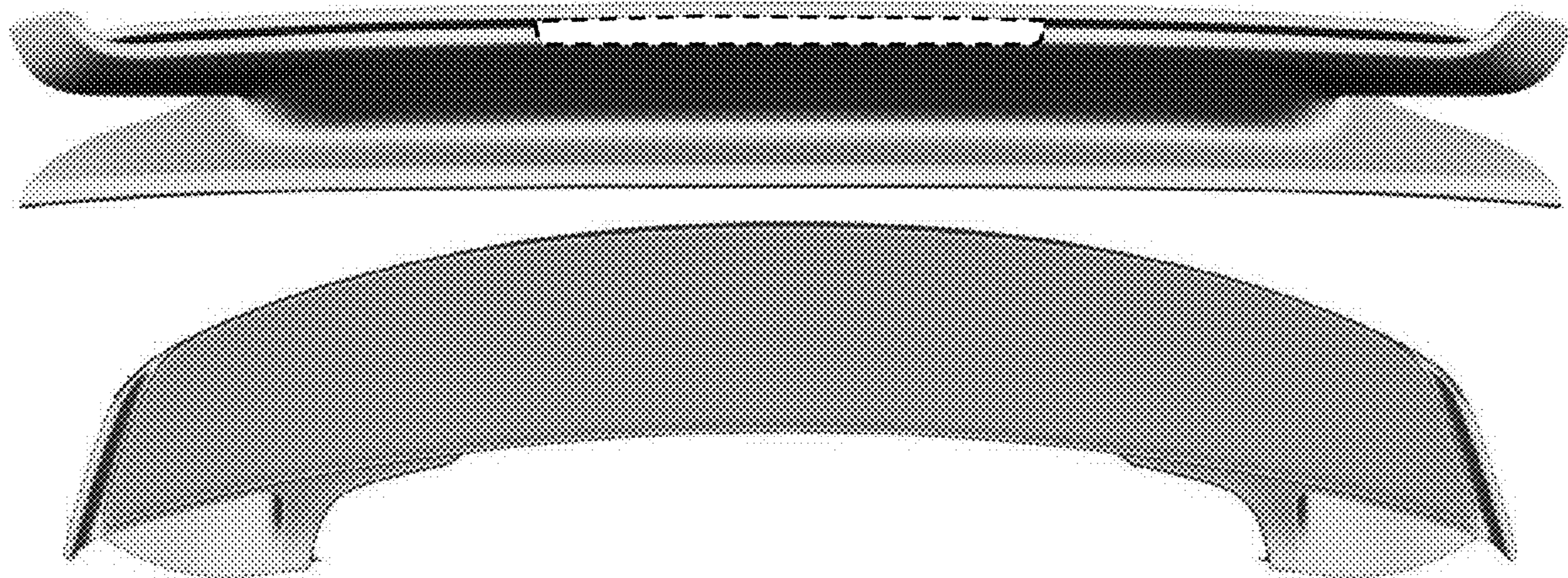
FIG. 1 is a front side perspective view of a spoiler for motor vehicle;

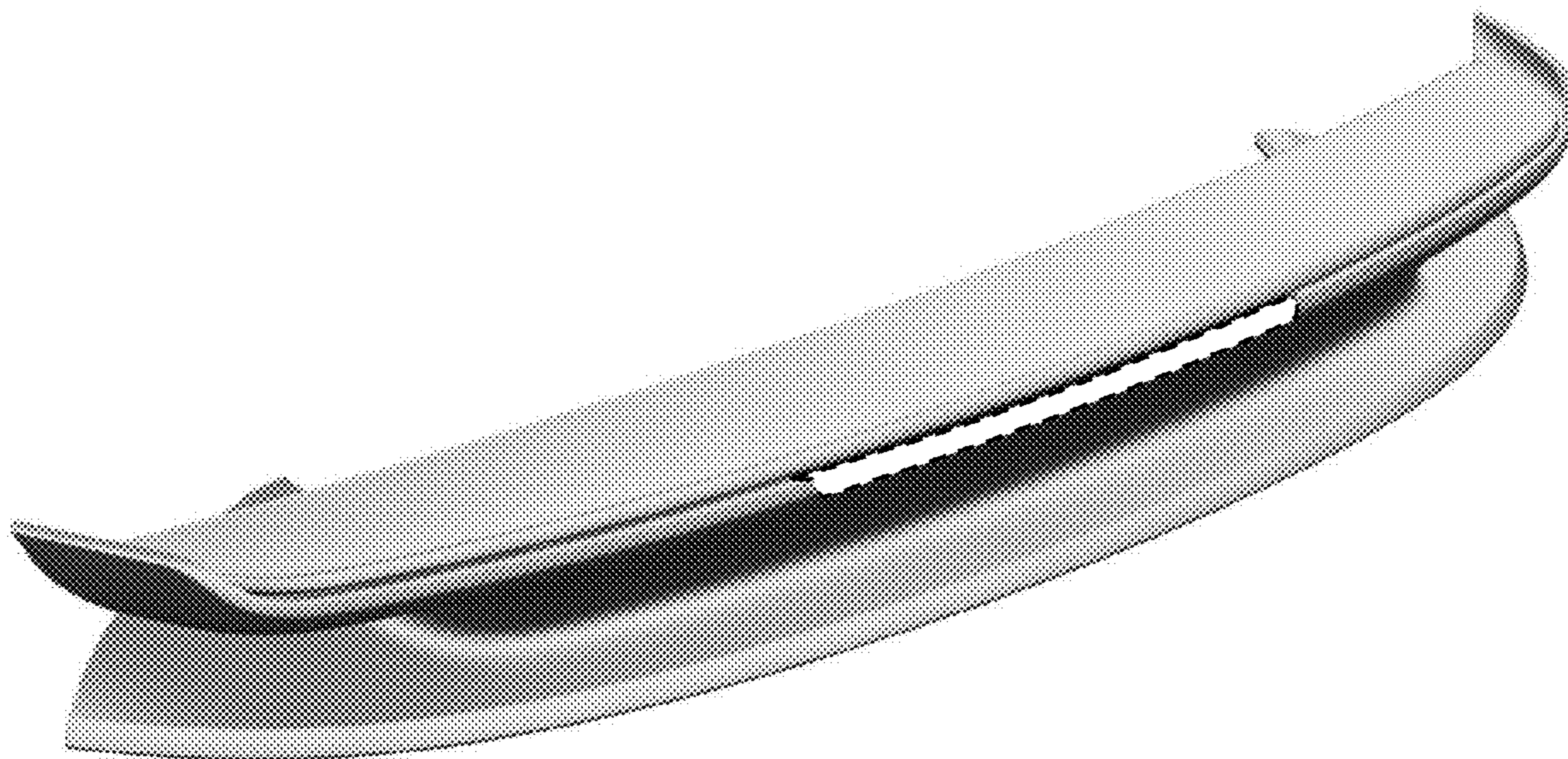

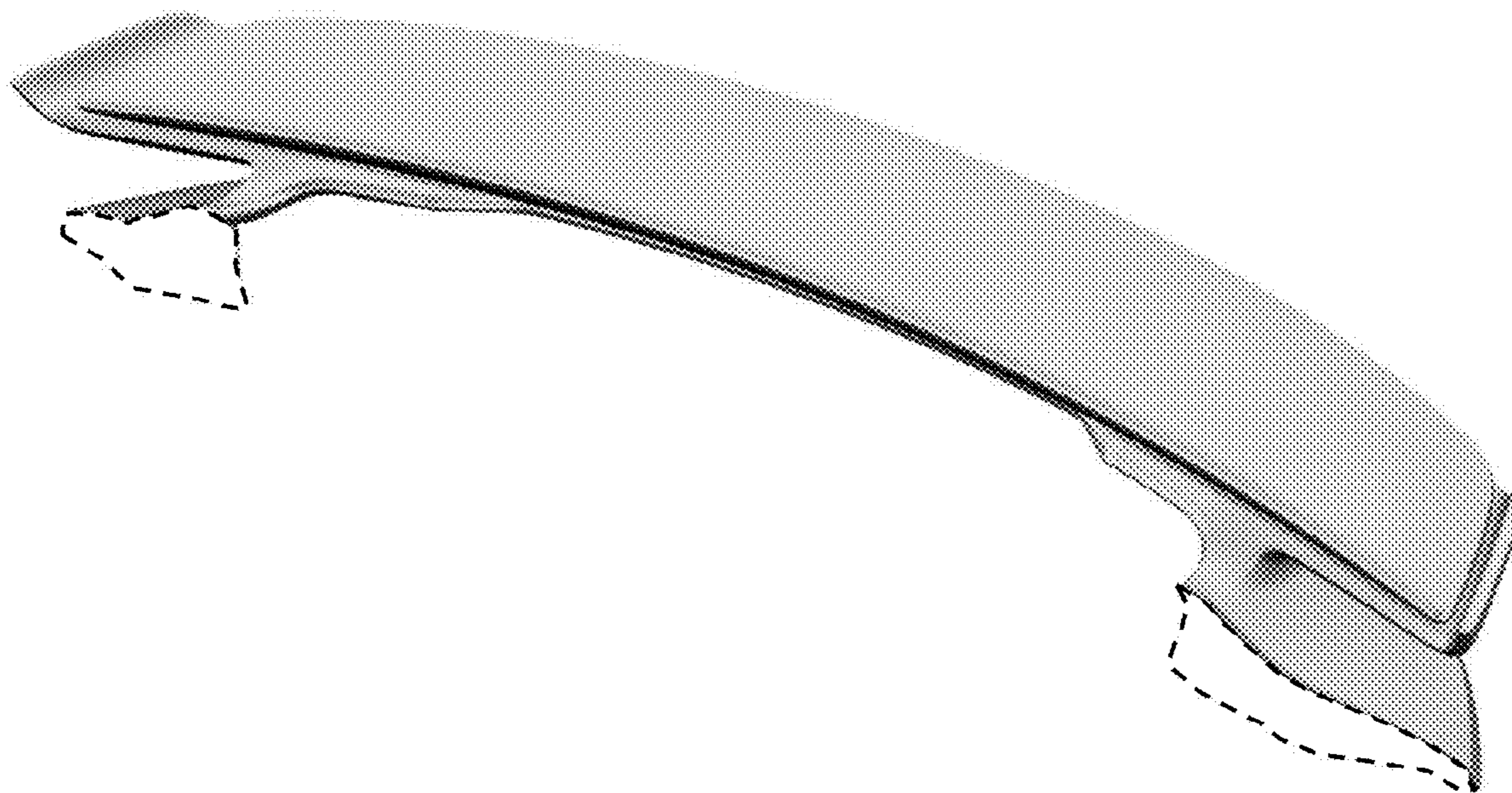

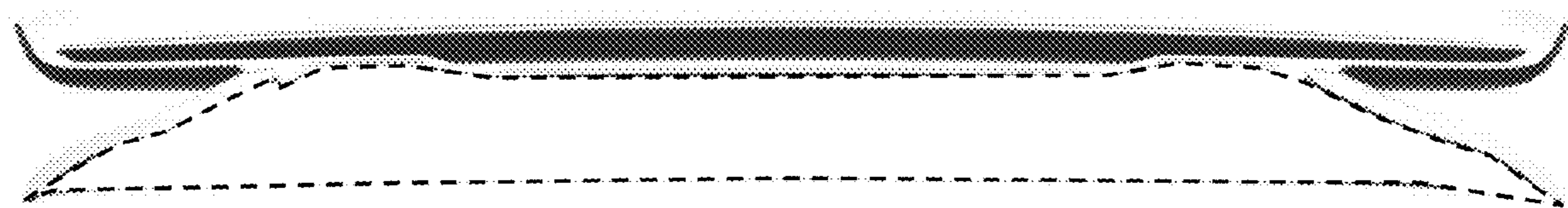

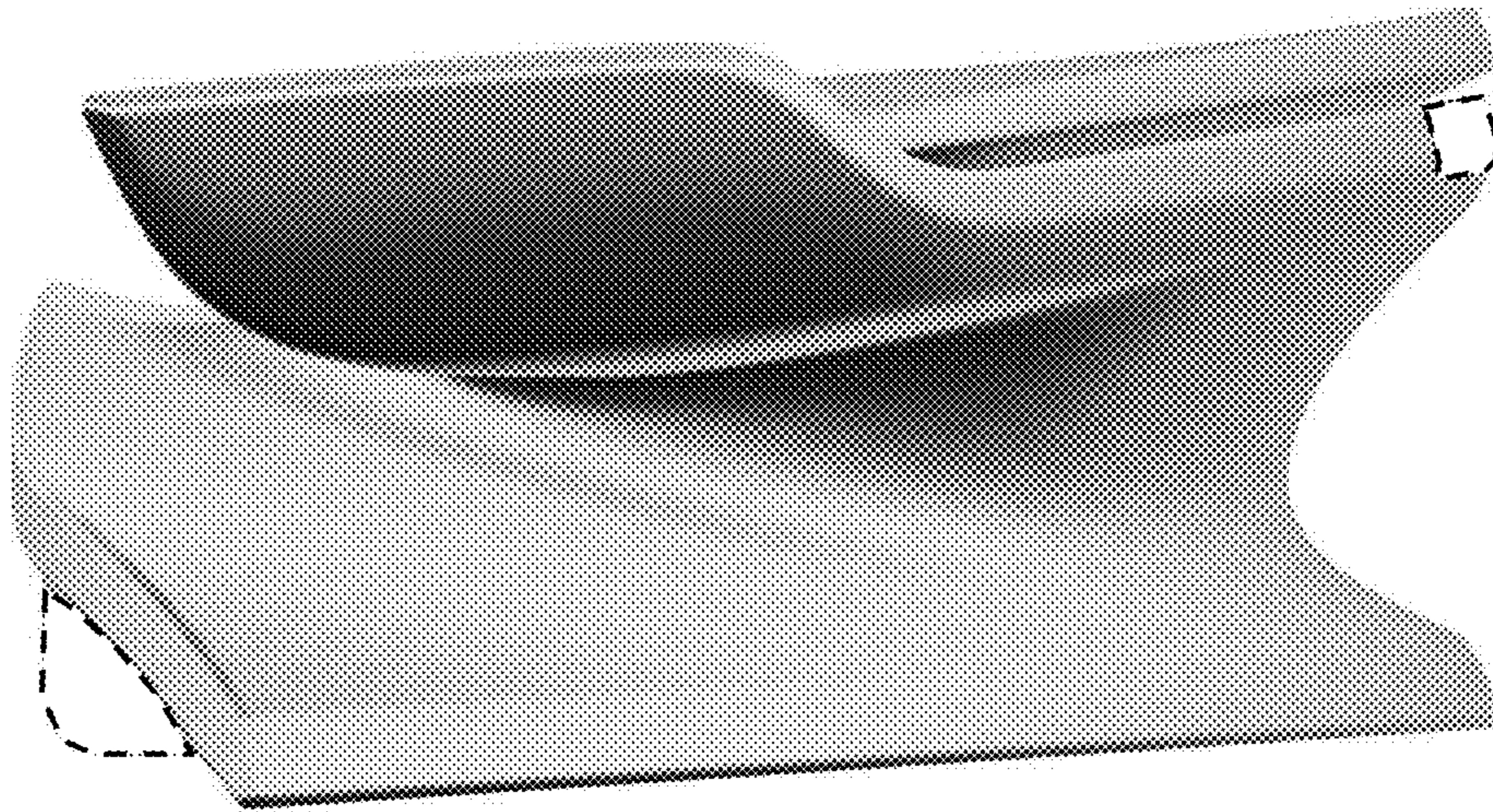

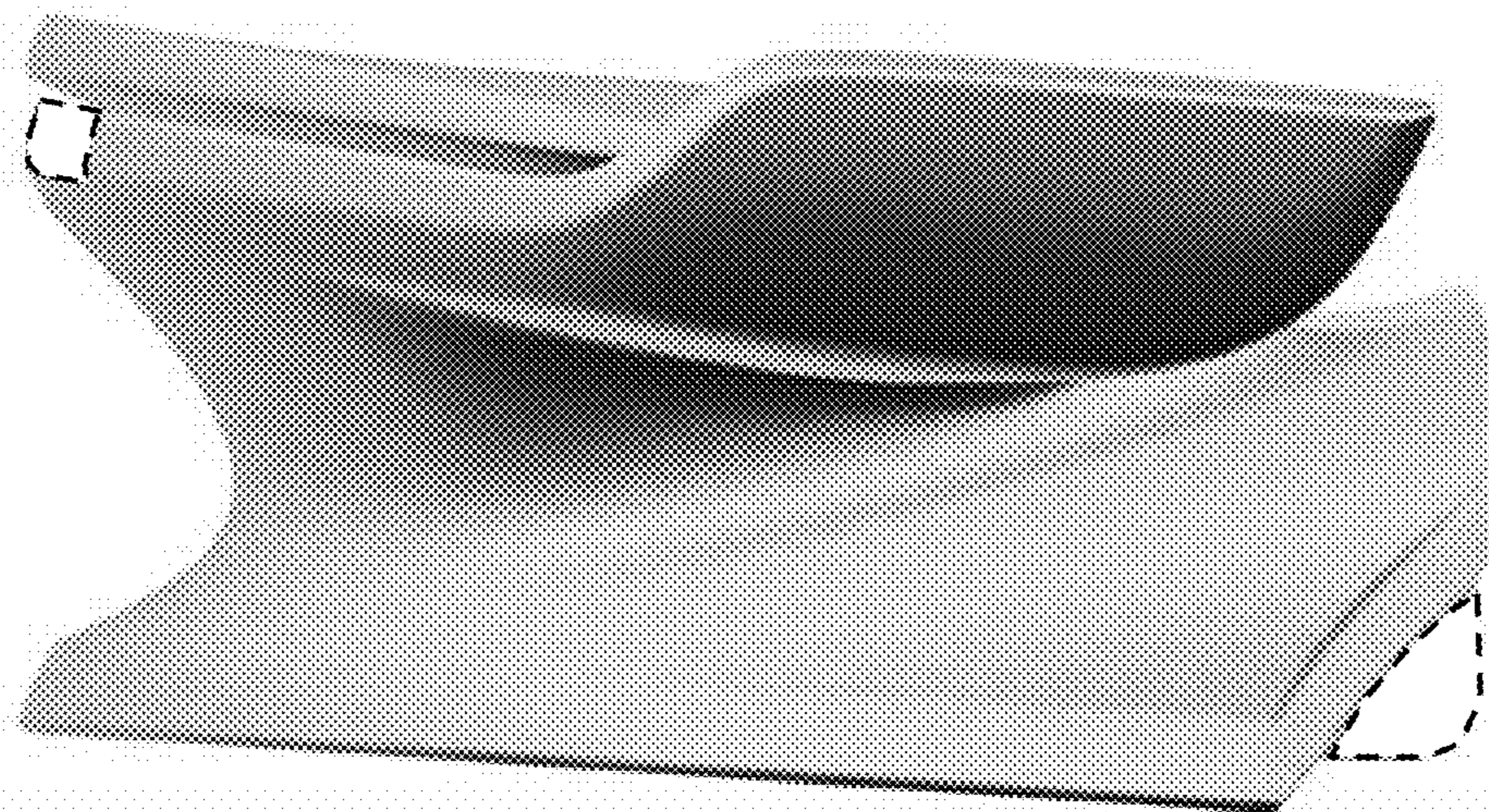

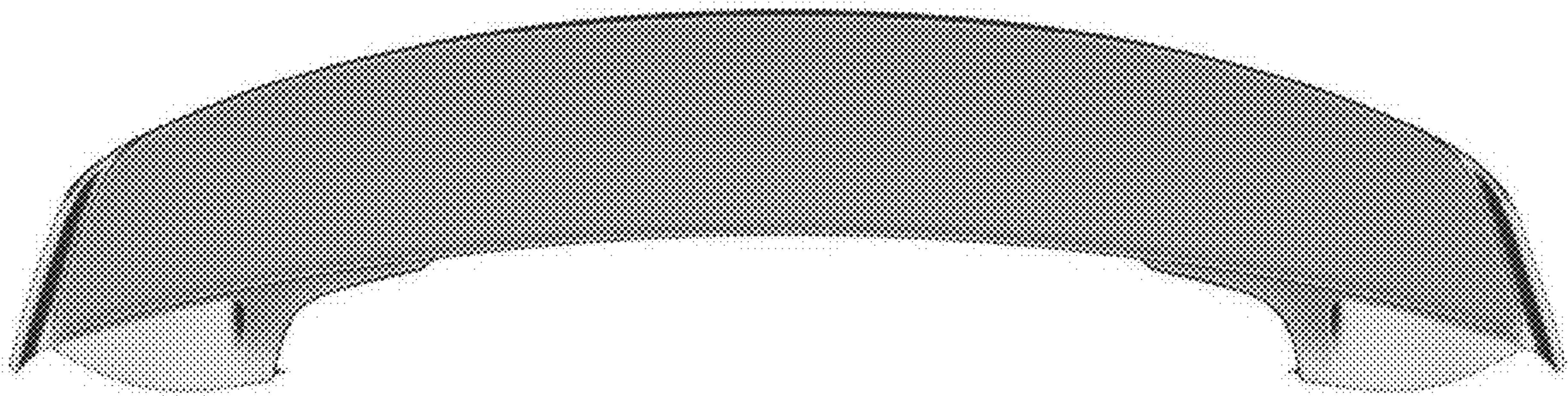

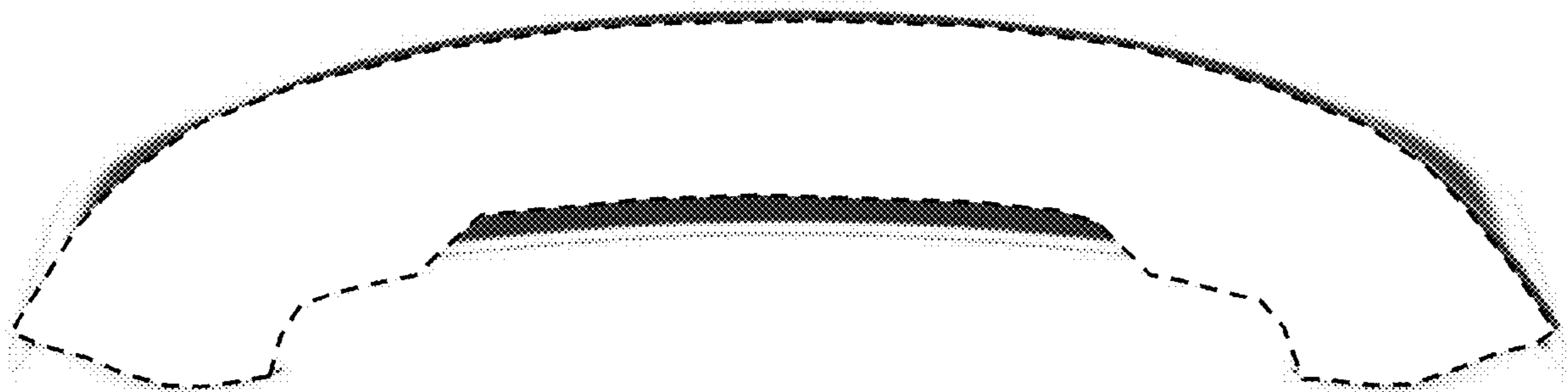
