(57) **CLAIM**

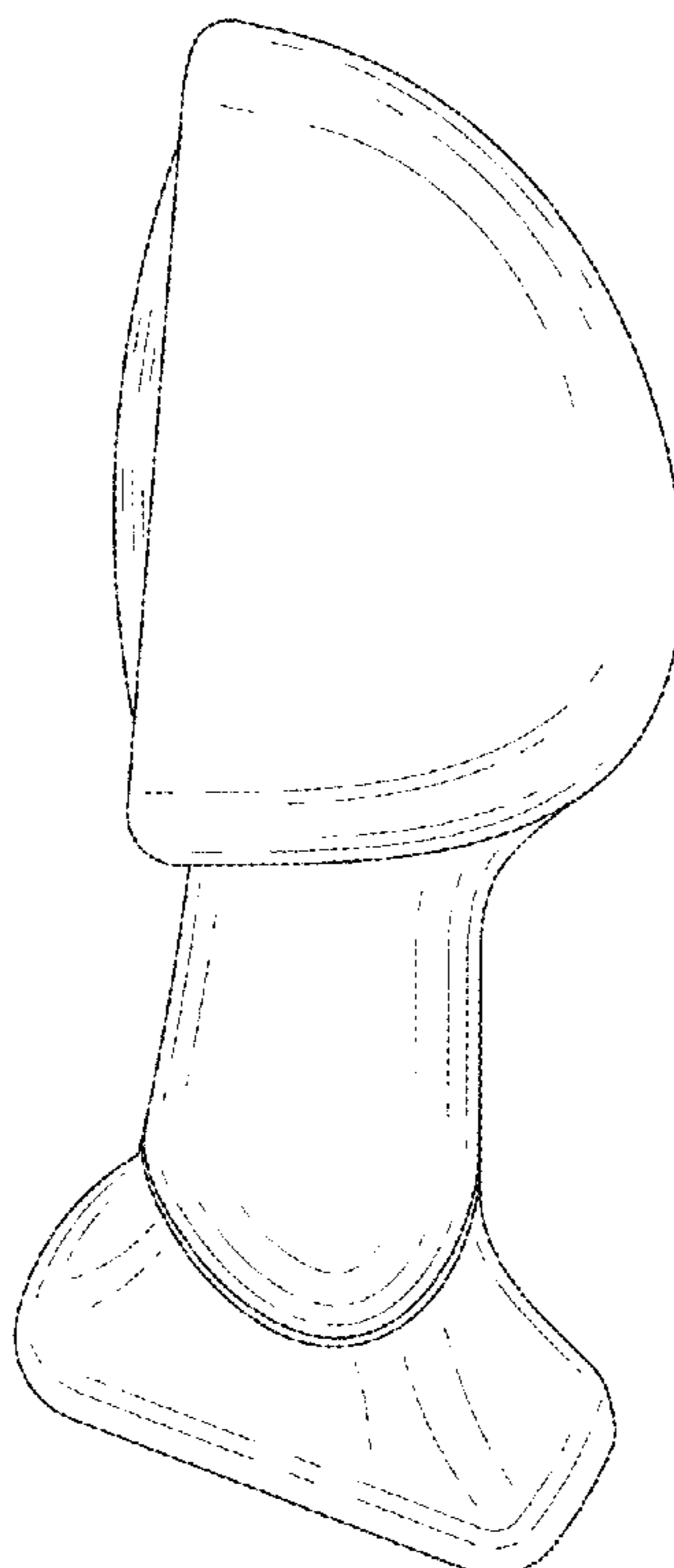
The ornamental design for mirror for a truck vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an embodiment of the mirror for a truck vehicle, showing our new design; FIG. 2 is a right view of the mirror of FIG. 1; FIG. 3 is a left view of the mirror of FIG. 1; FIG. 4 is a front view of the mirror of FIG. 1; FIG. 5 is a back view of the mirror of FIG. 1; and, FIG. 6 is a bottom perspective view of the mirror of FIG. 1. The broken lines illustrate portions of the mirror for truck vehicle that form no part of the claimed design.

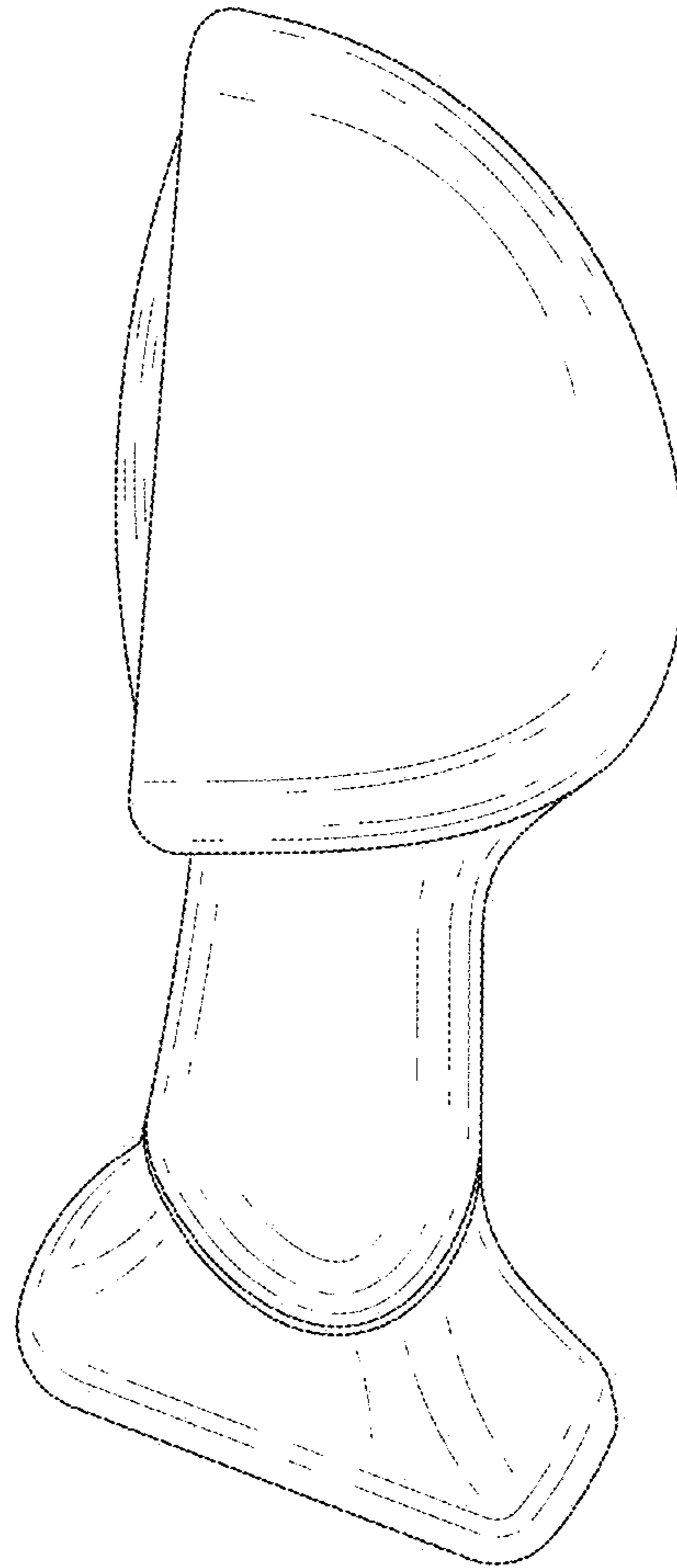

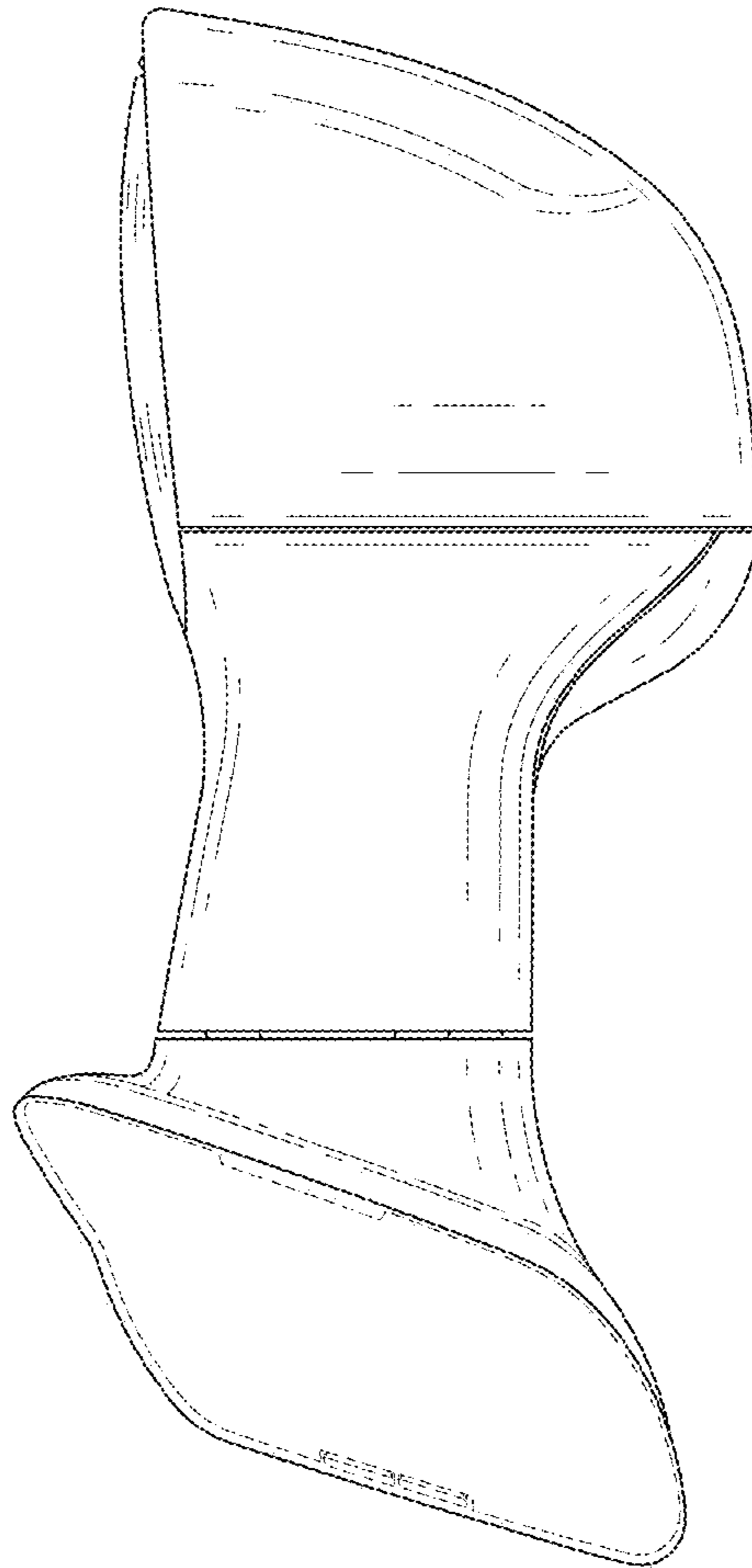

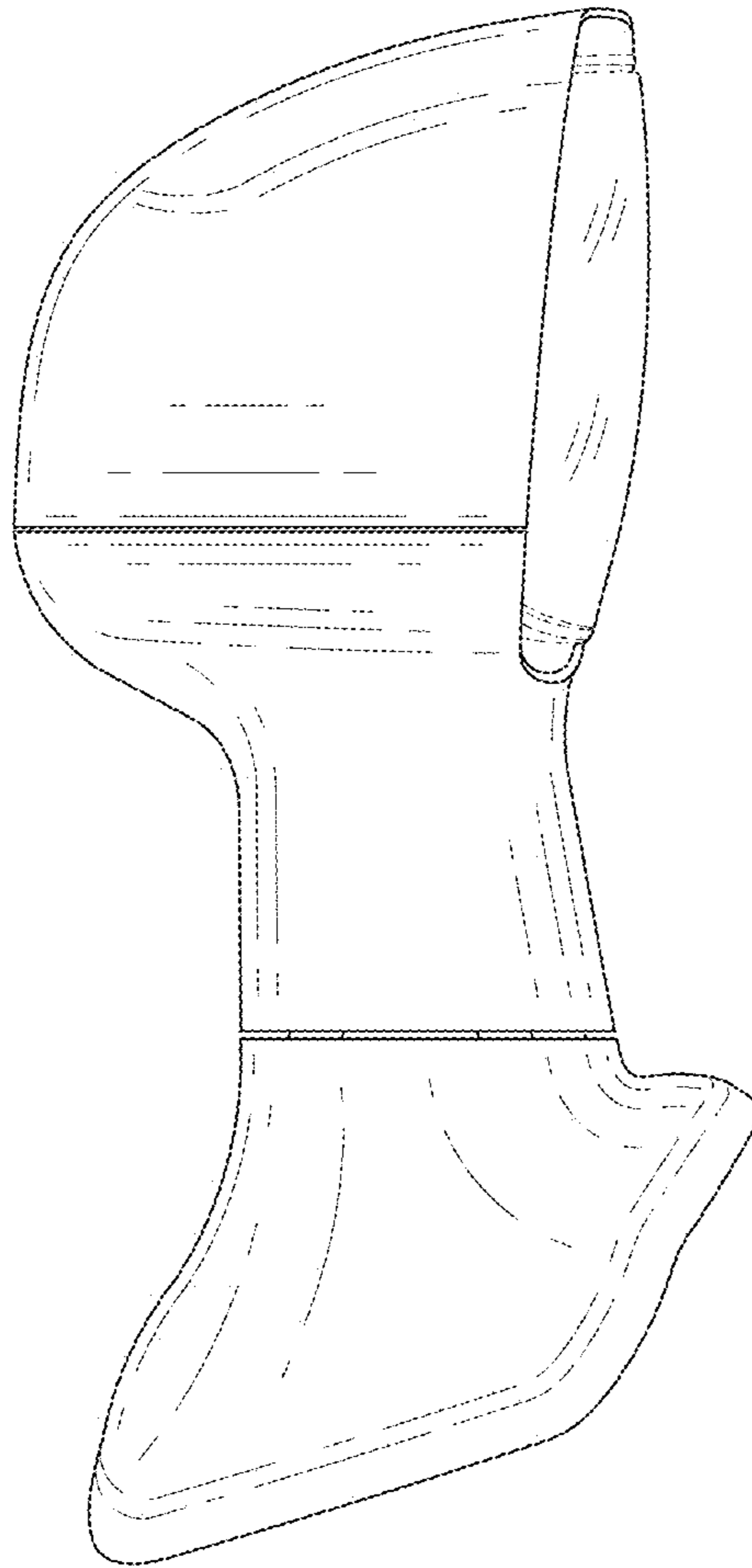

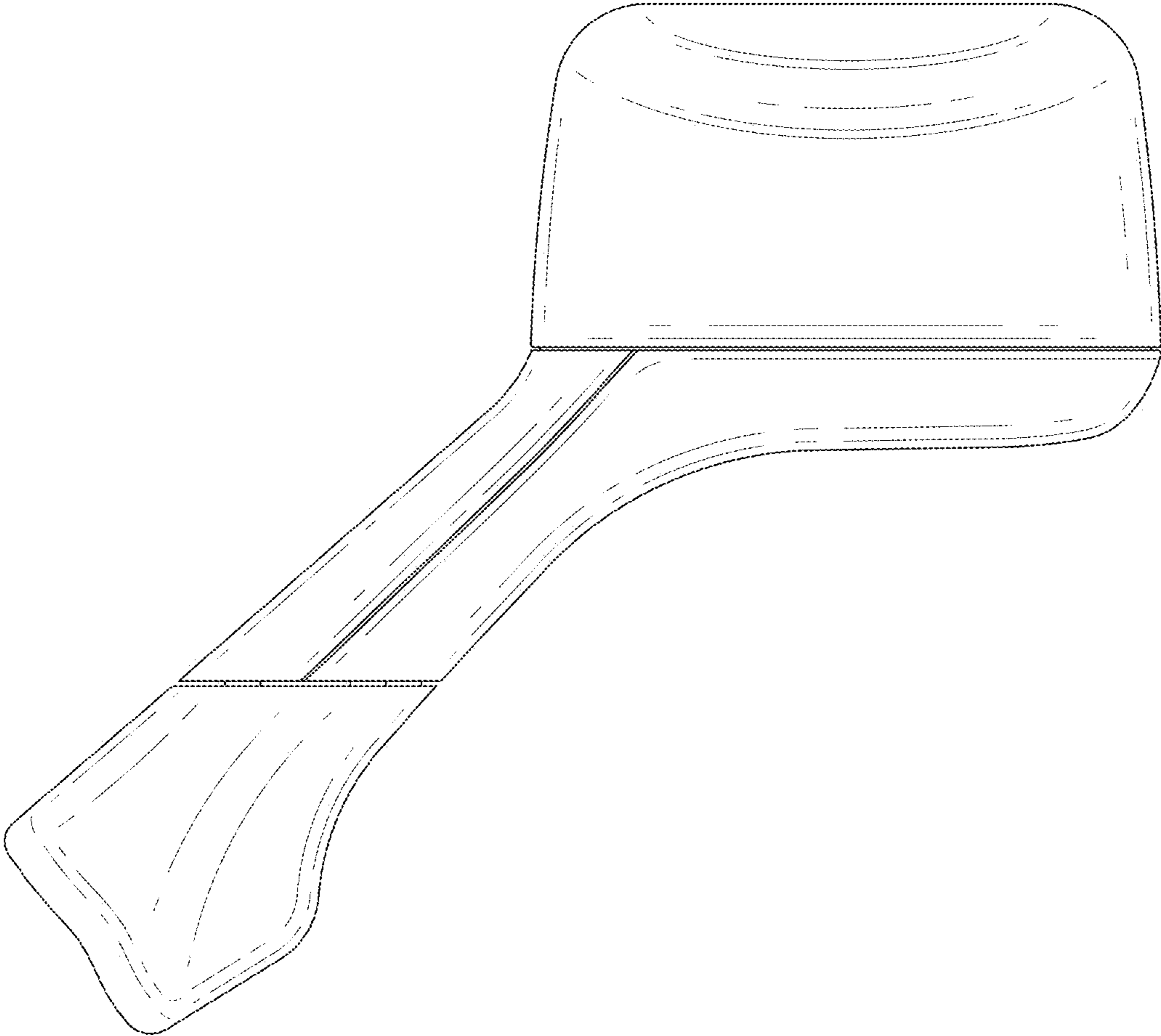

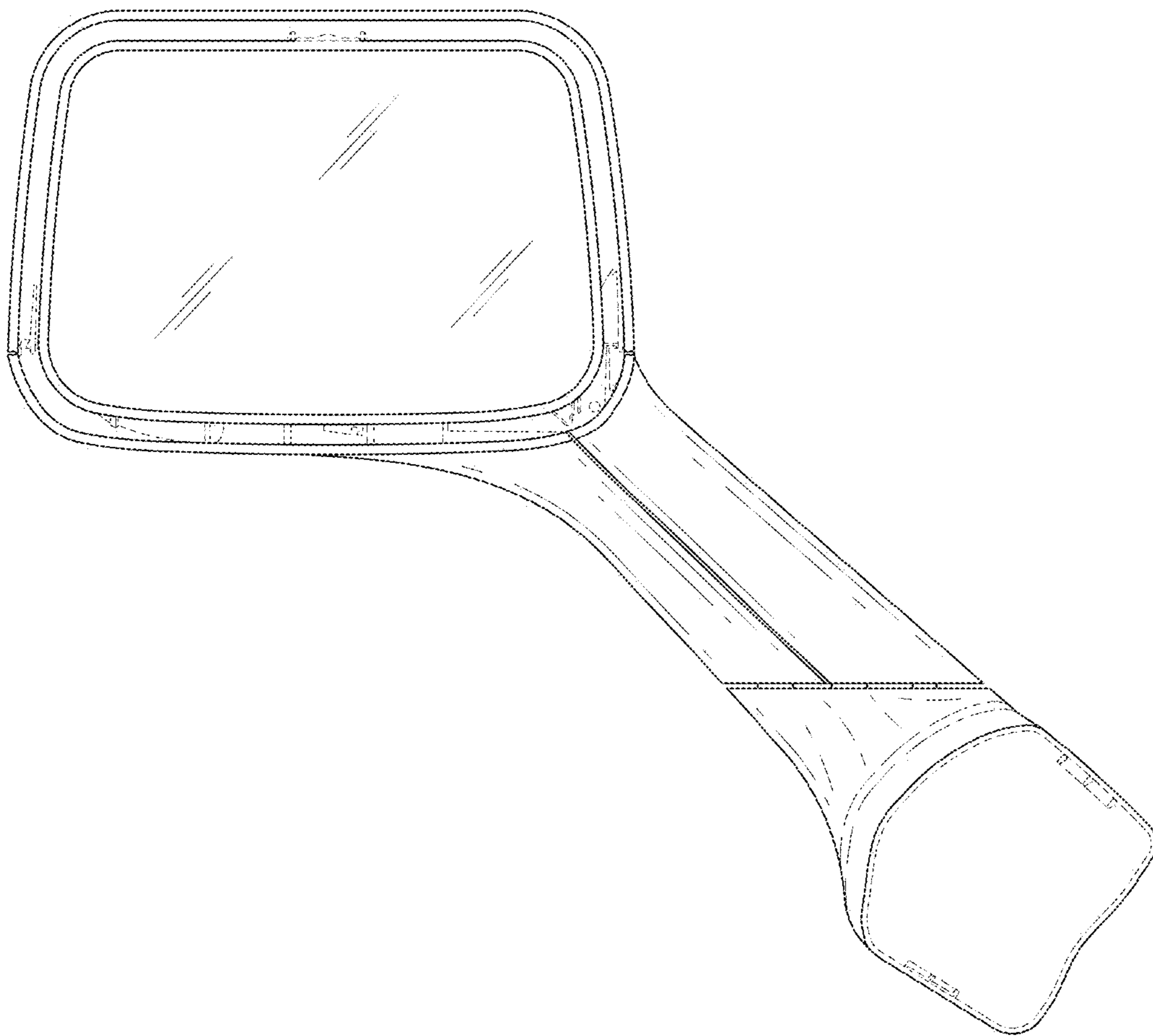

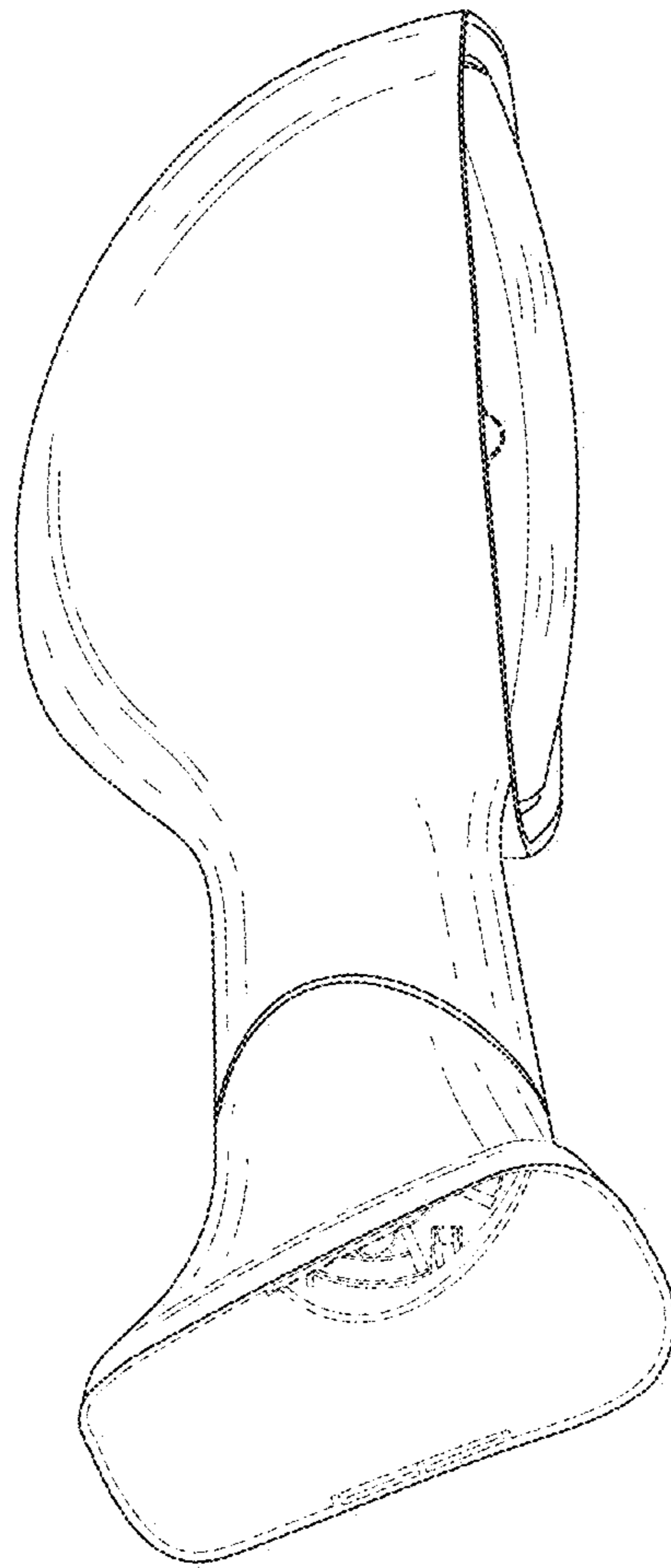
