(57) **CLAIM**

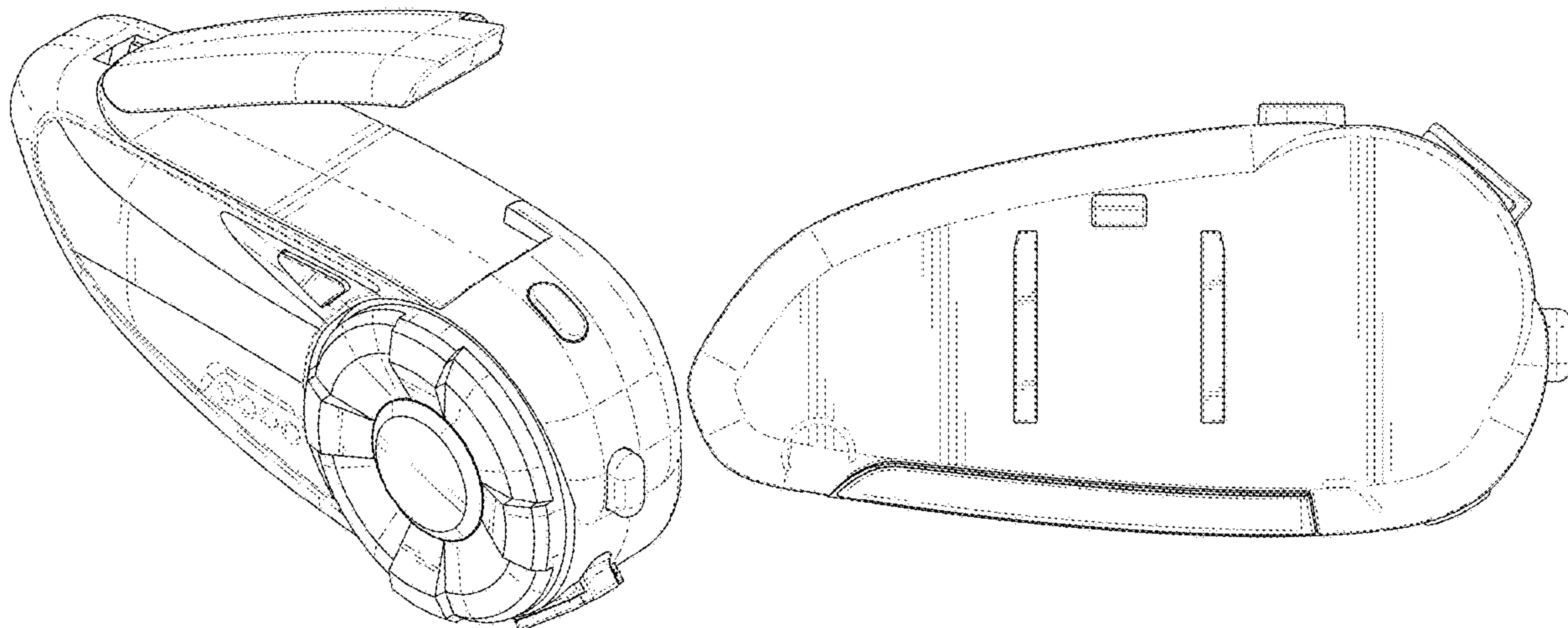
I claim the ornamental design for a wireless intercom headset, as shown and described.

DESCRIPTION

FIG. 1 is a Perspective view of a wireless intercom headset showing my new design;

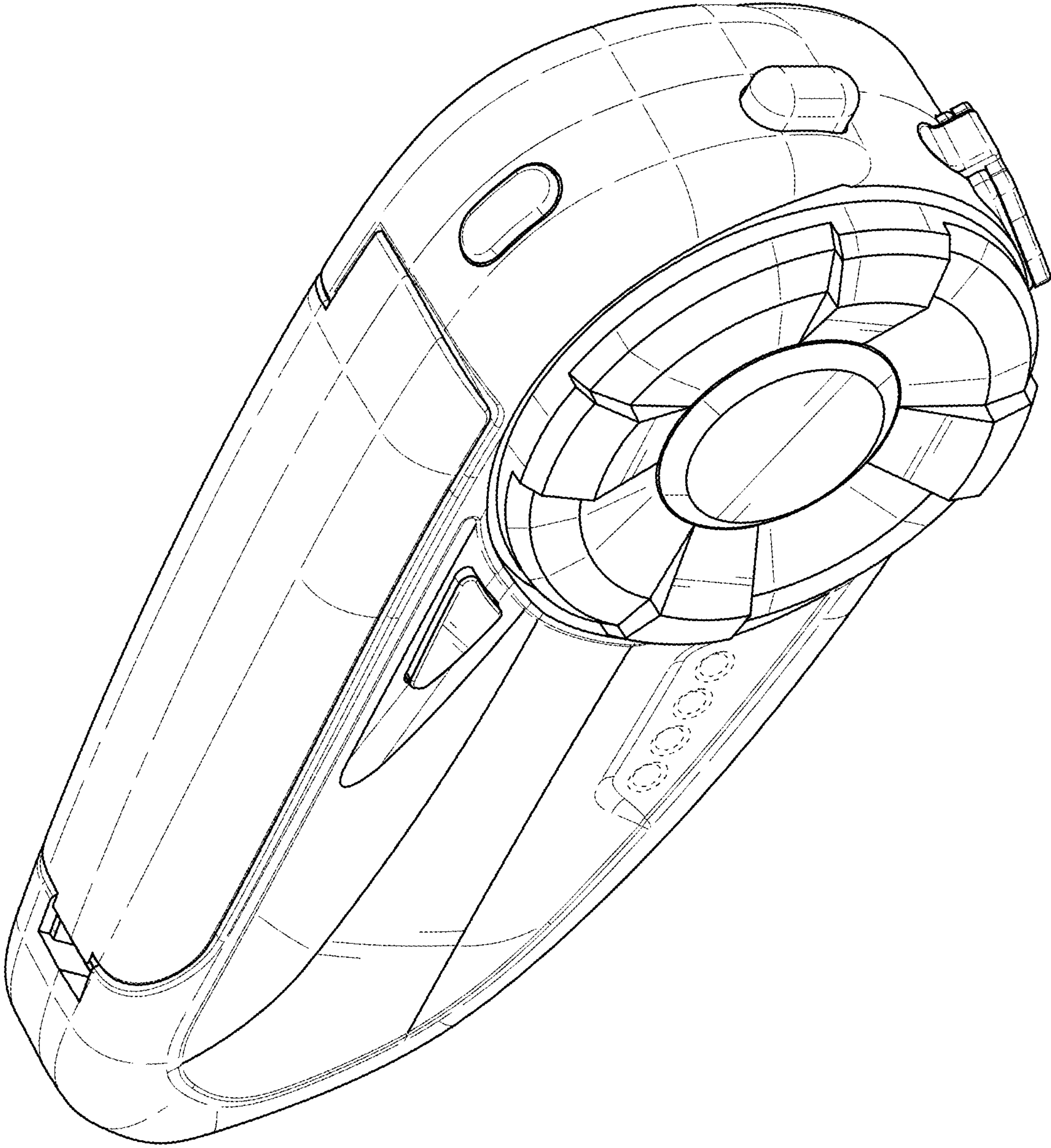

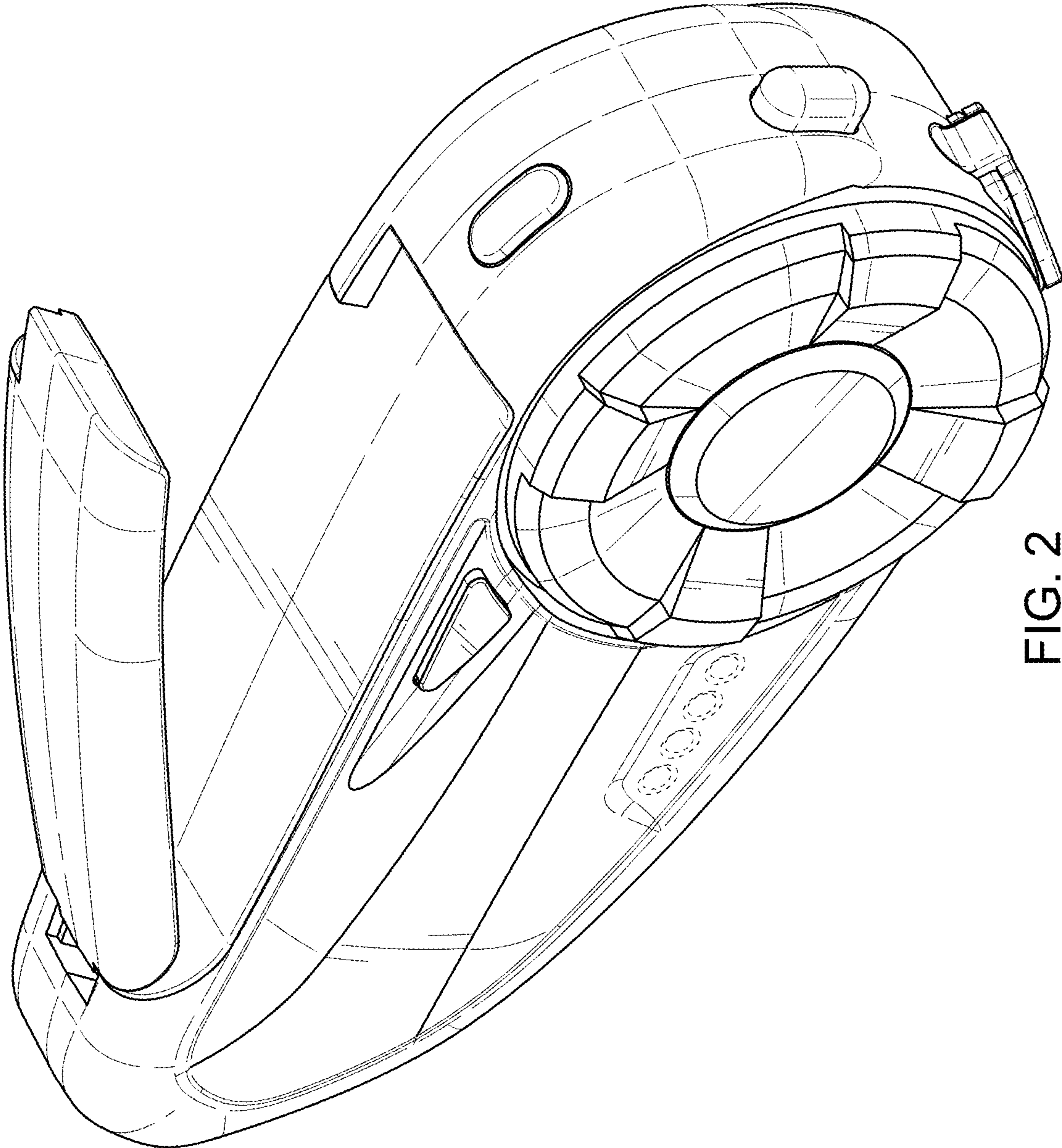

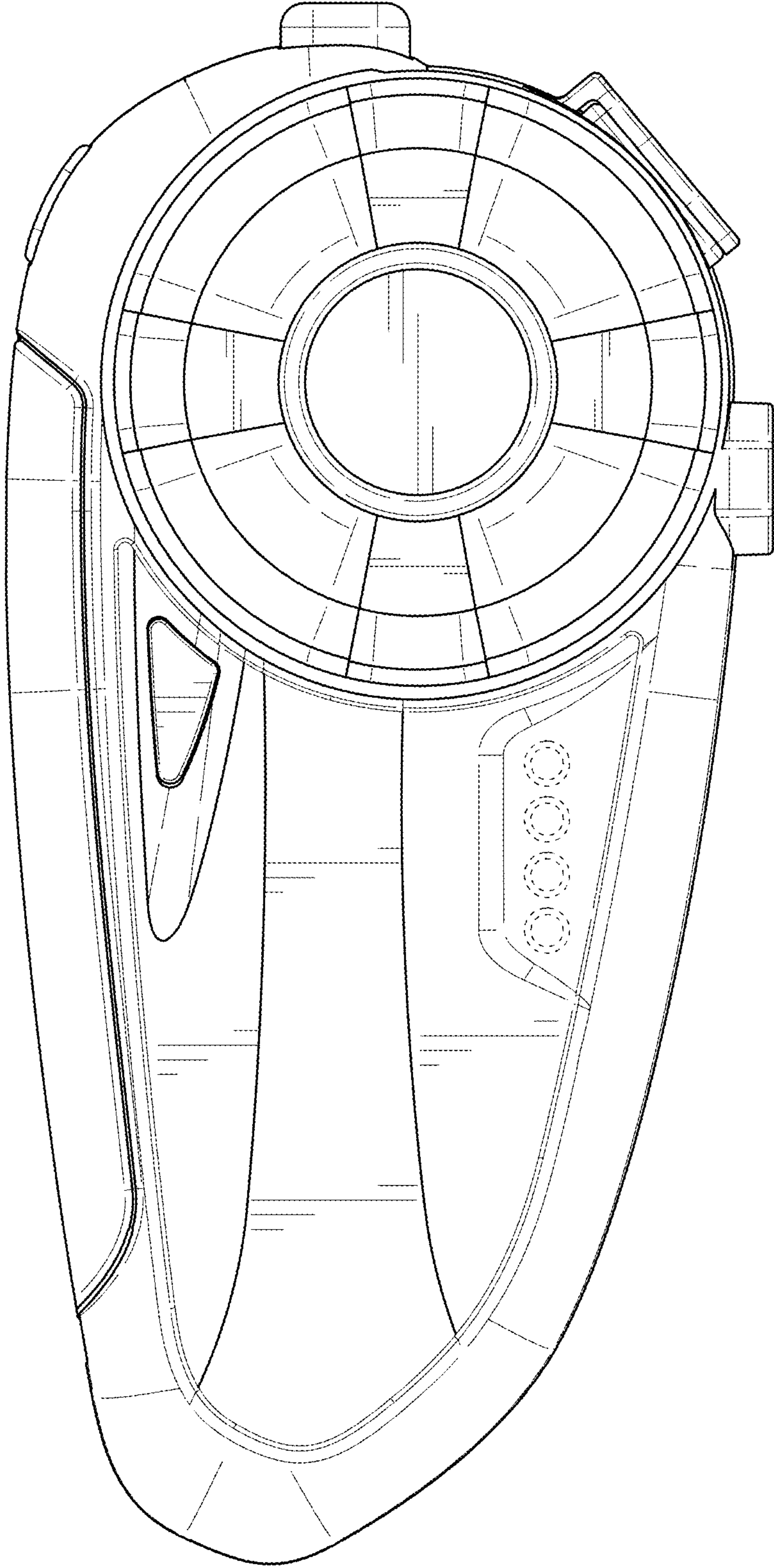

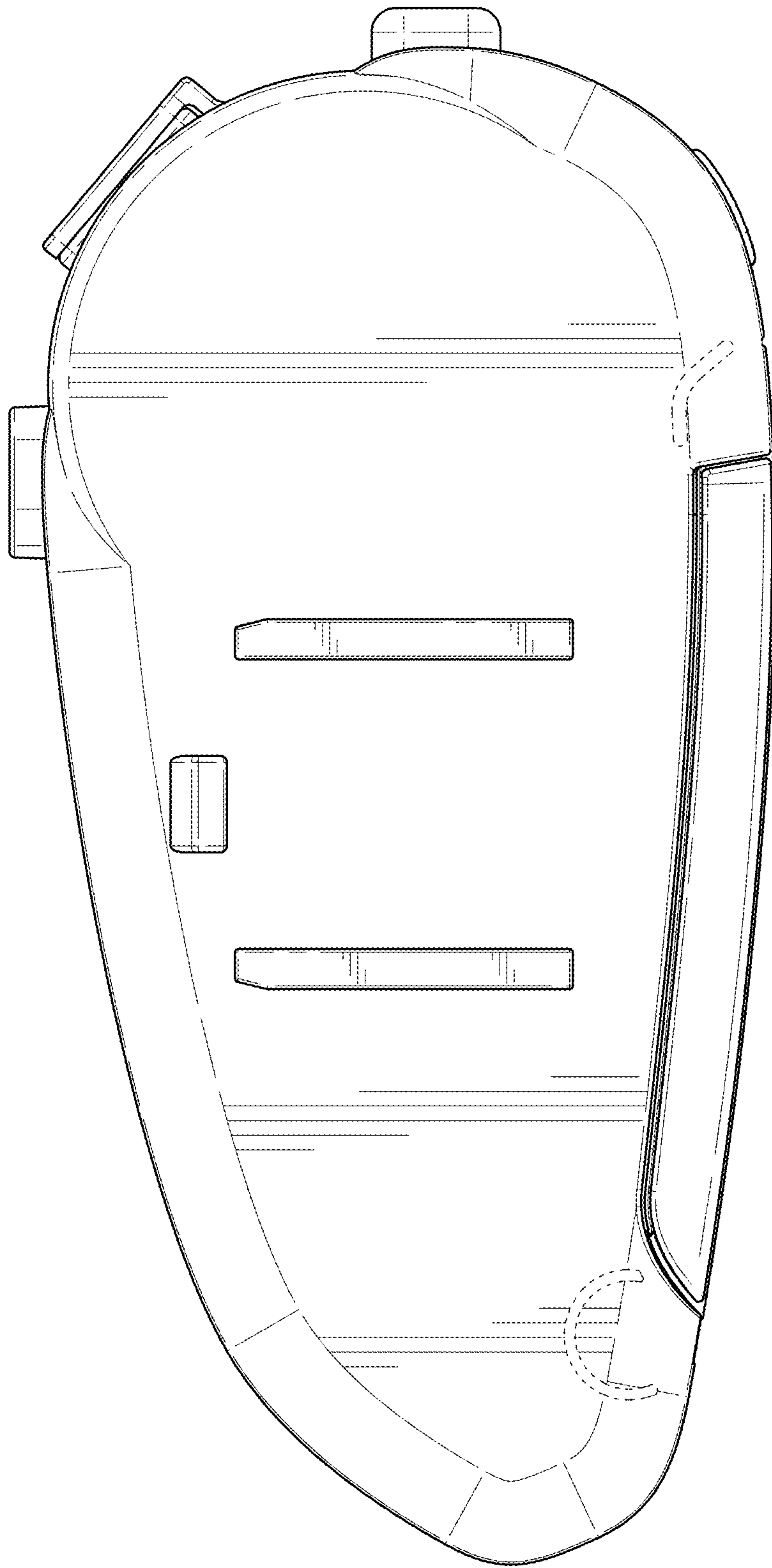

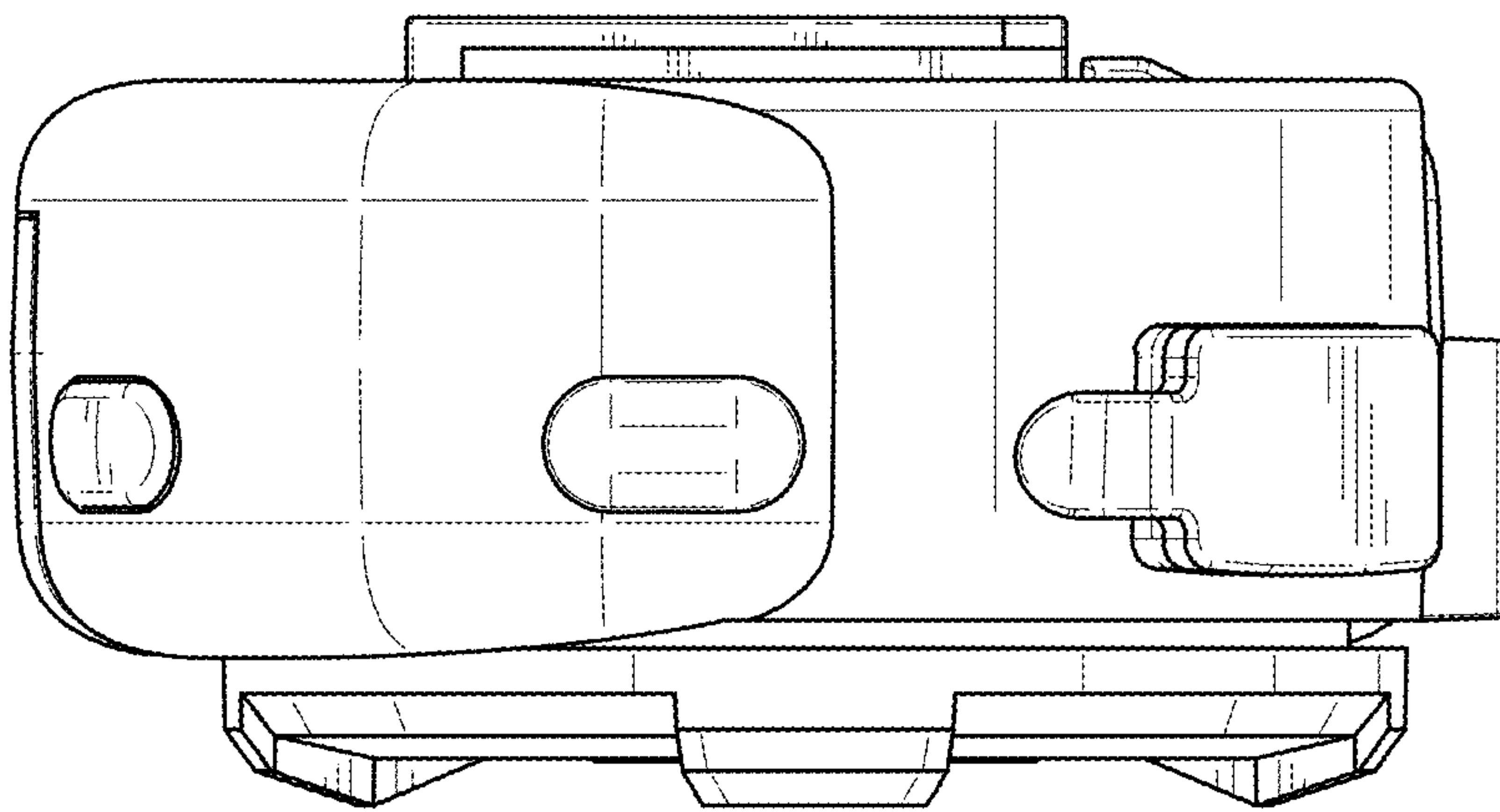

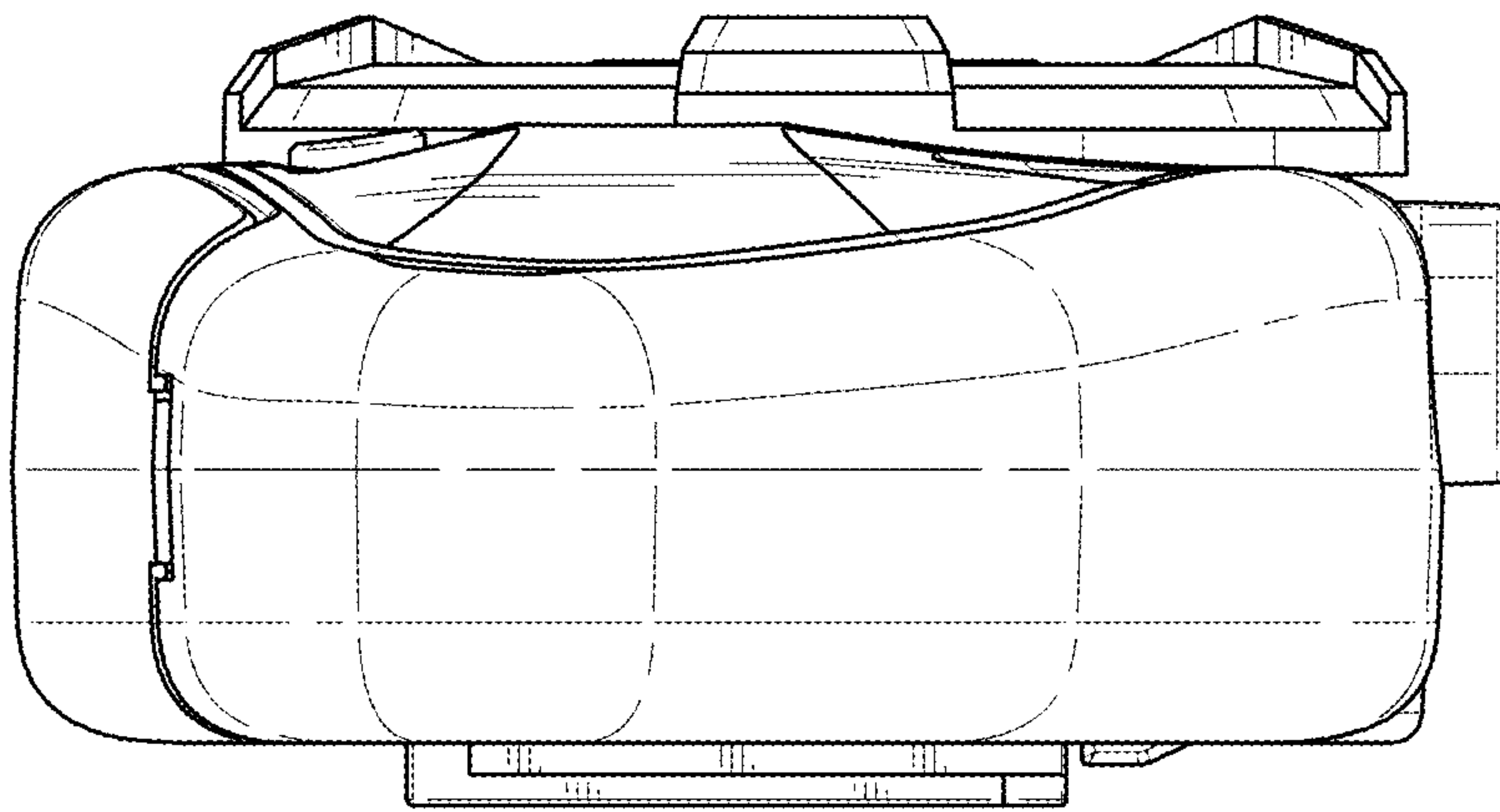

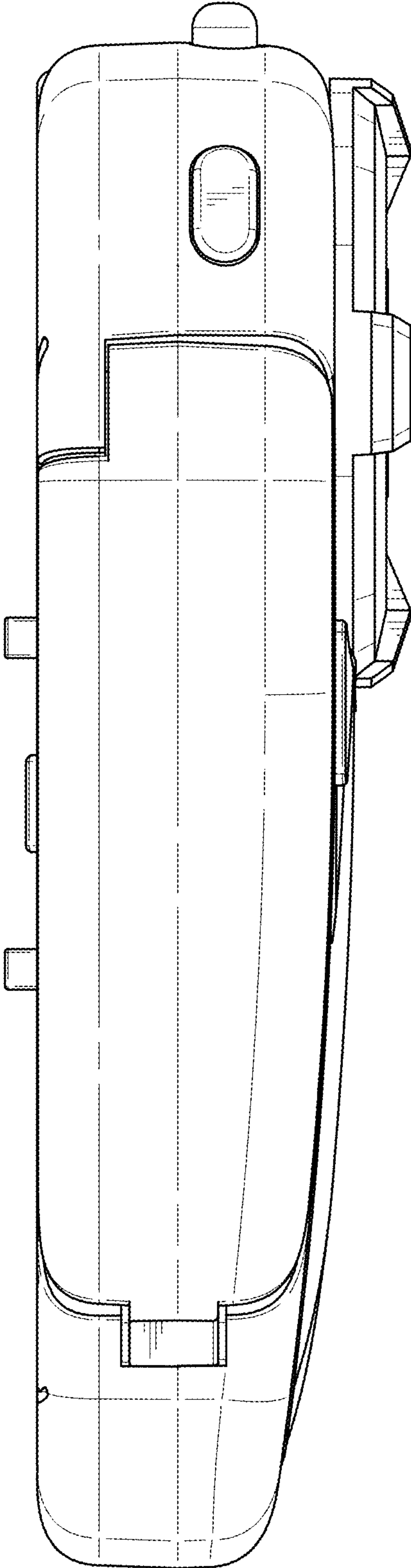

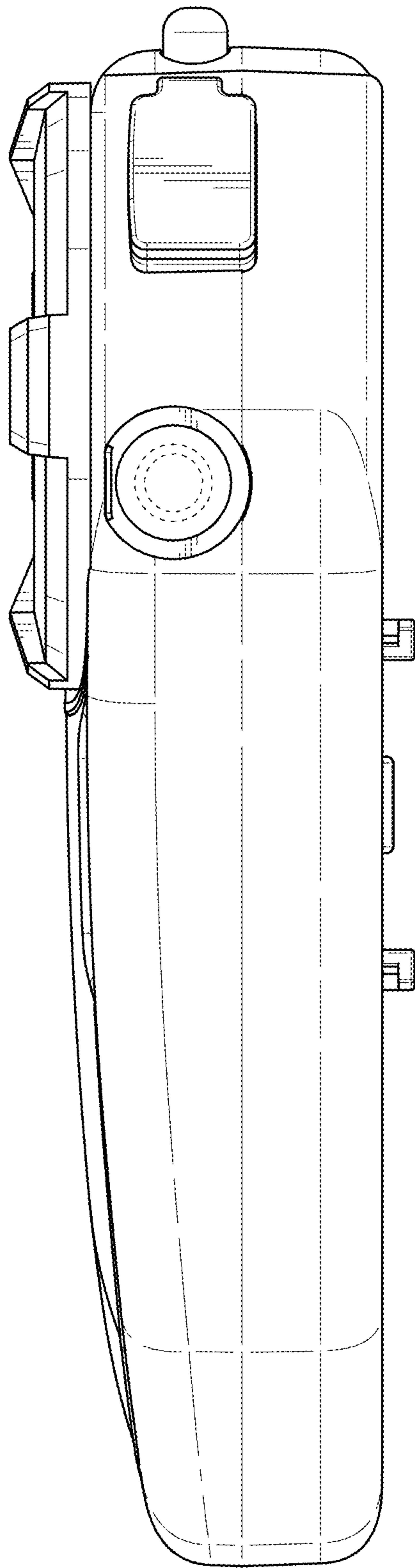
