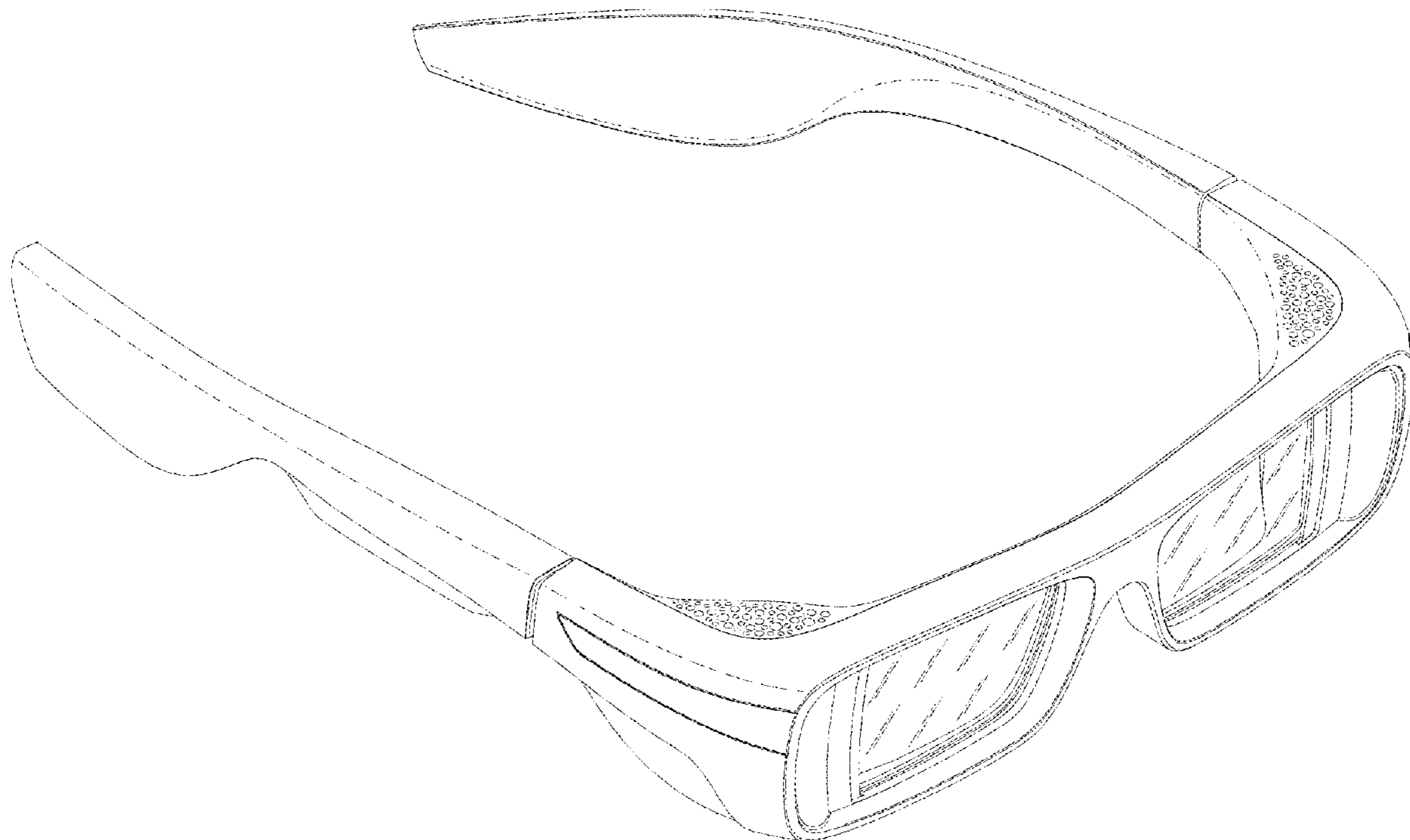
The ornamental design for augmented reality glasses, as shown.

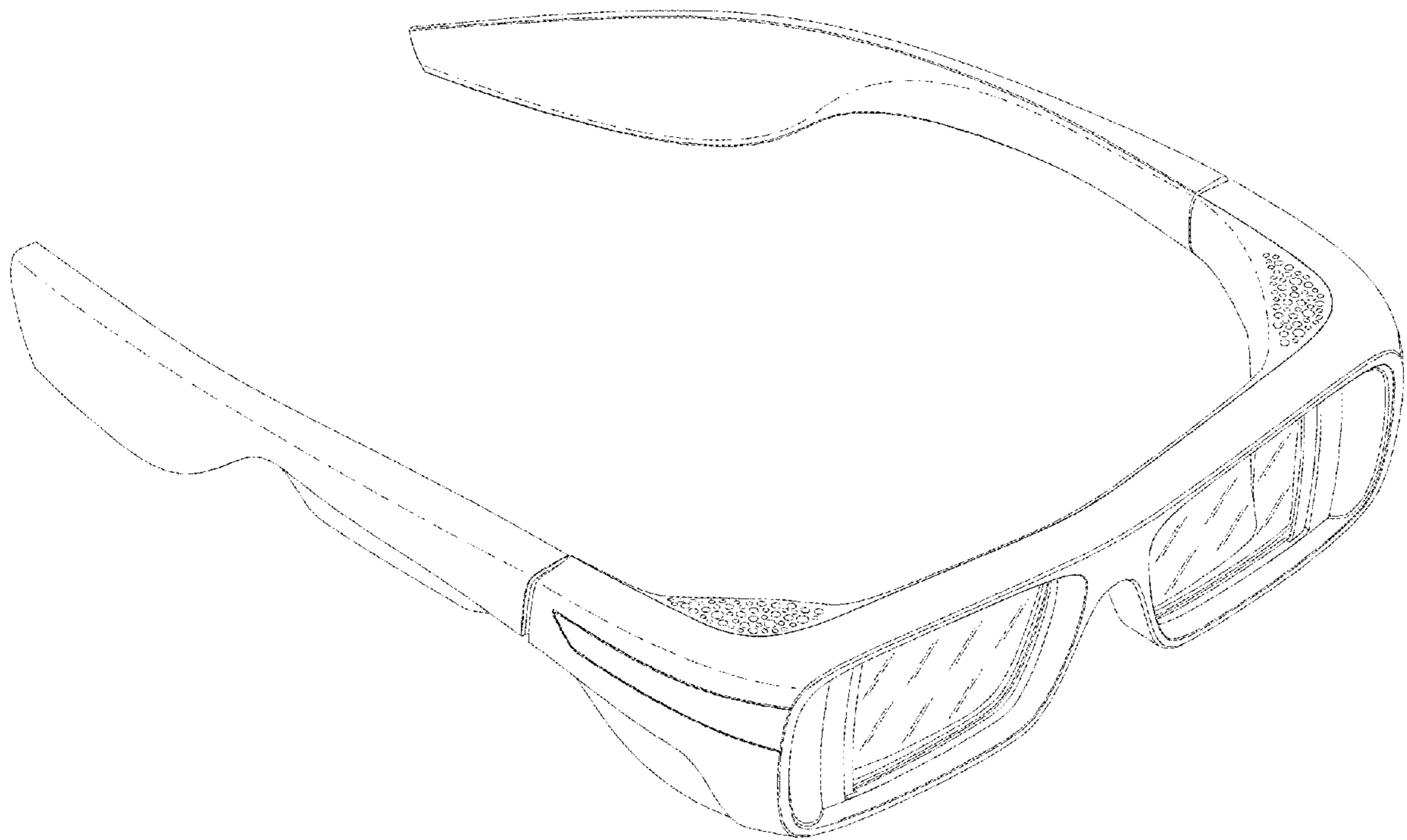

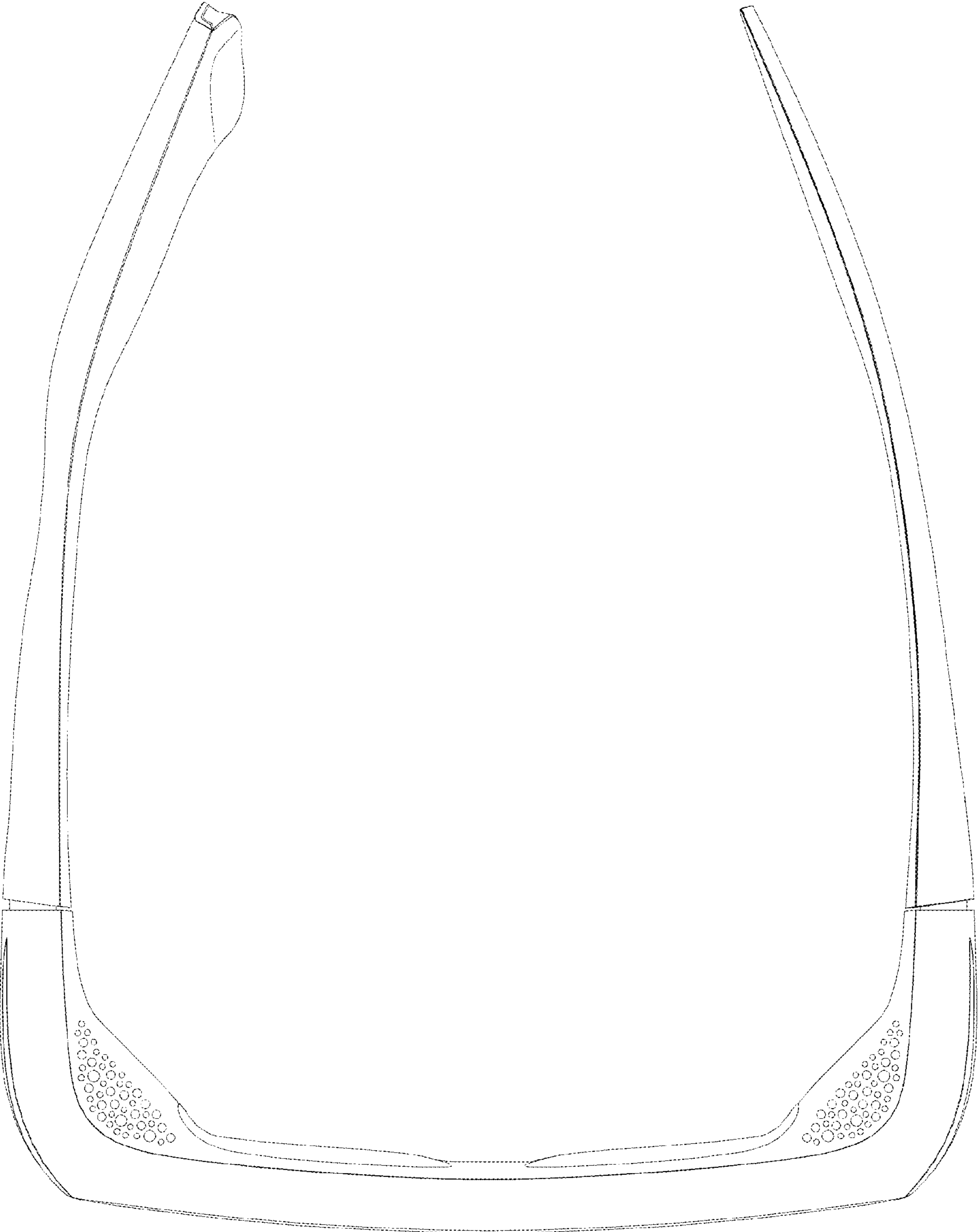

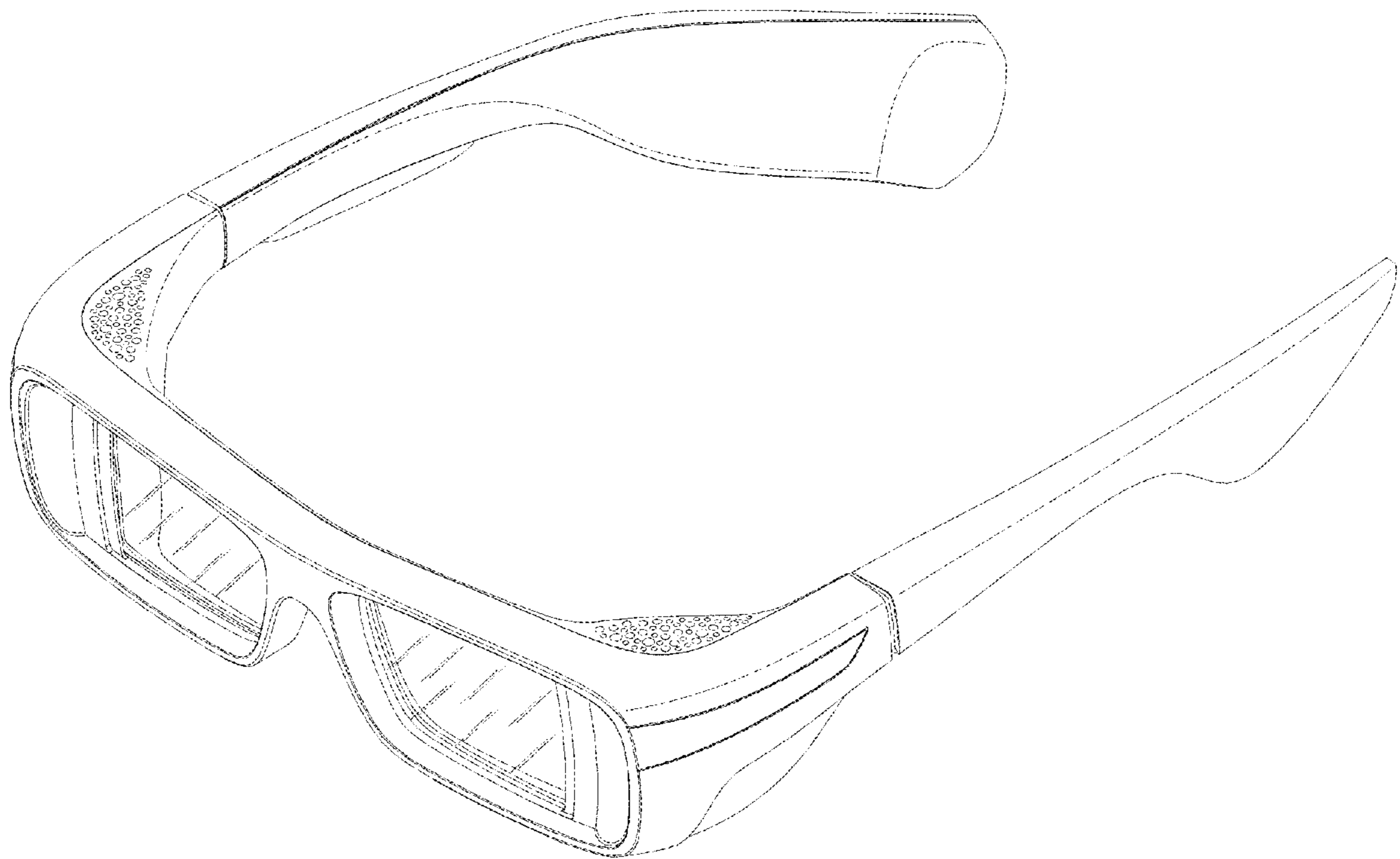

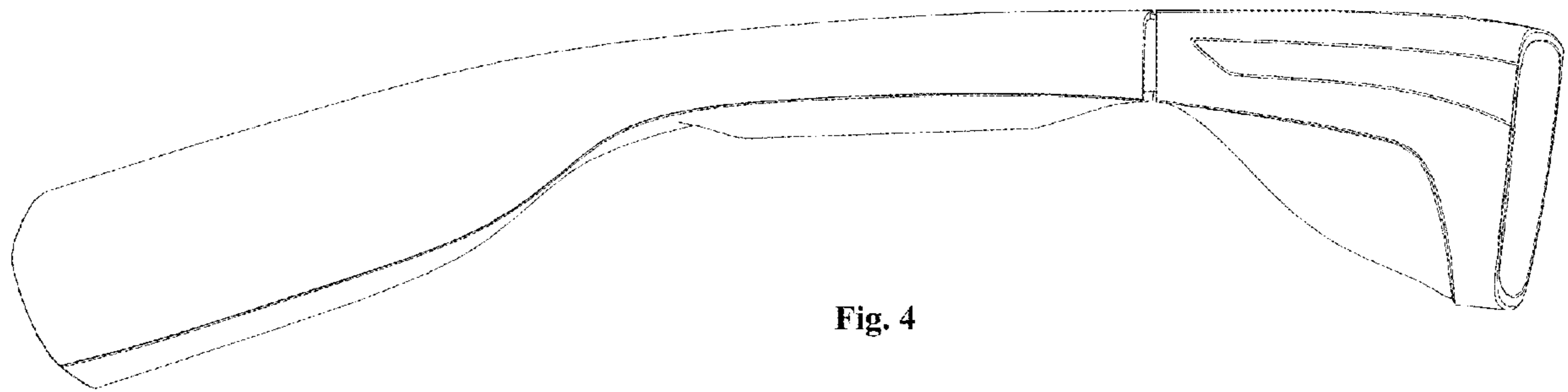

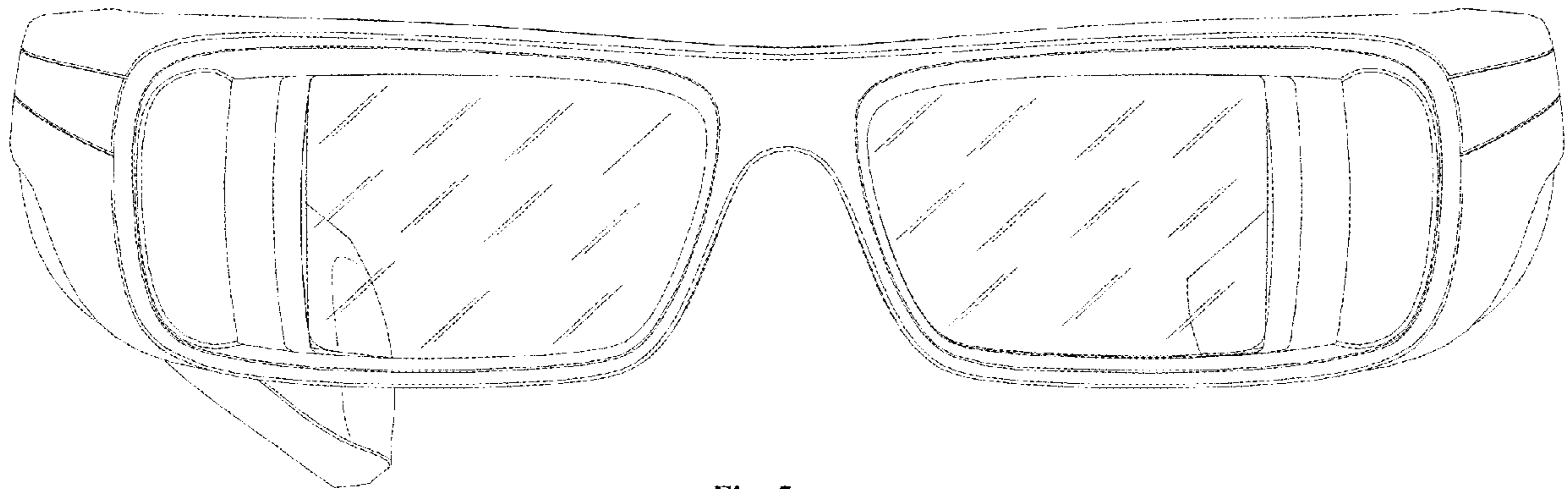

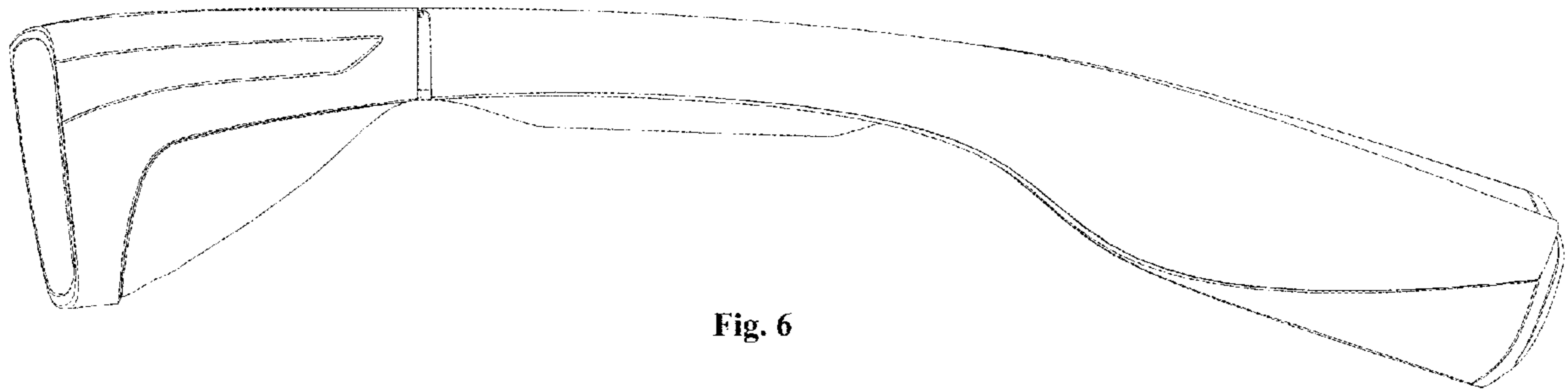

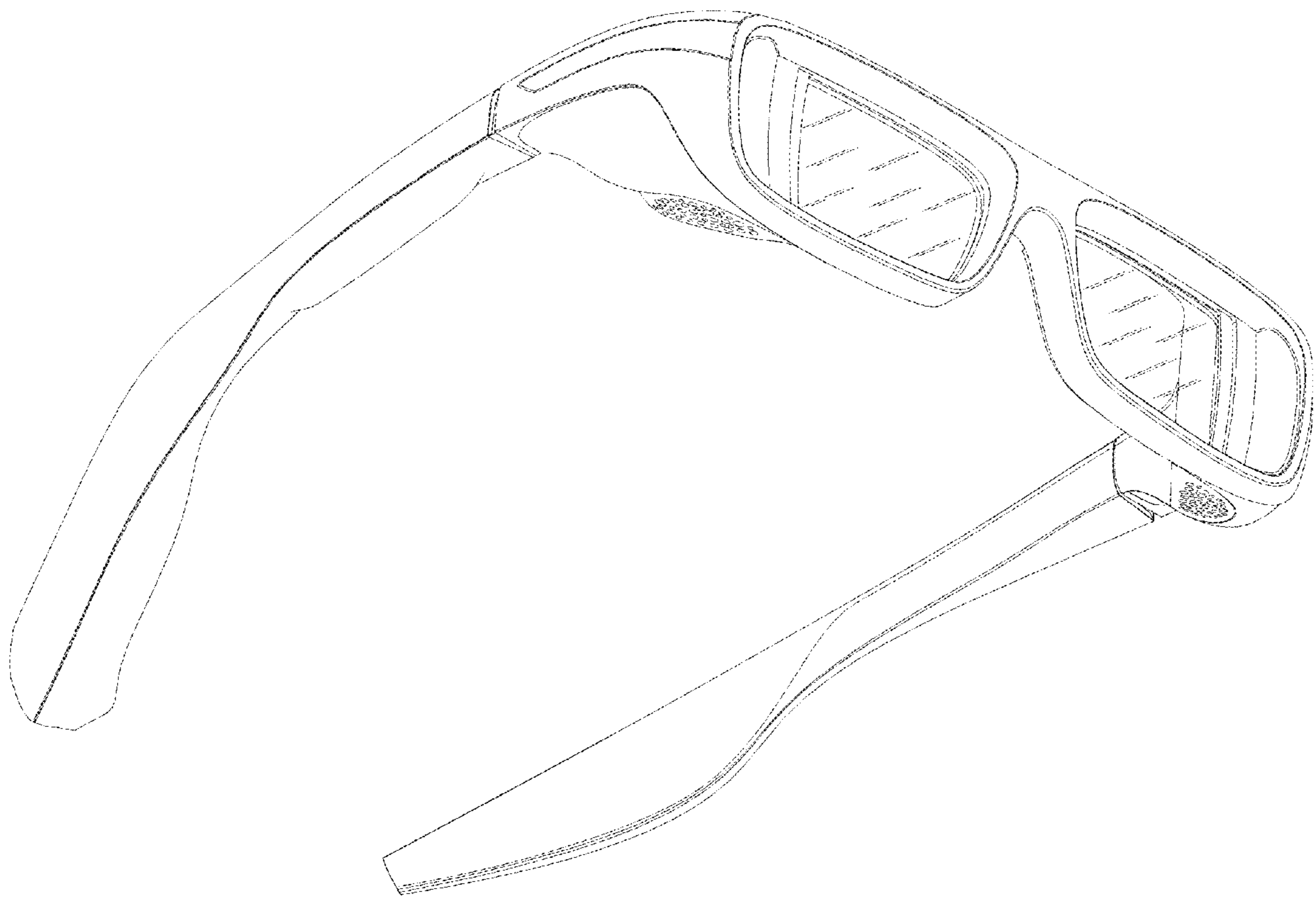

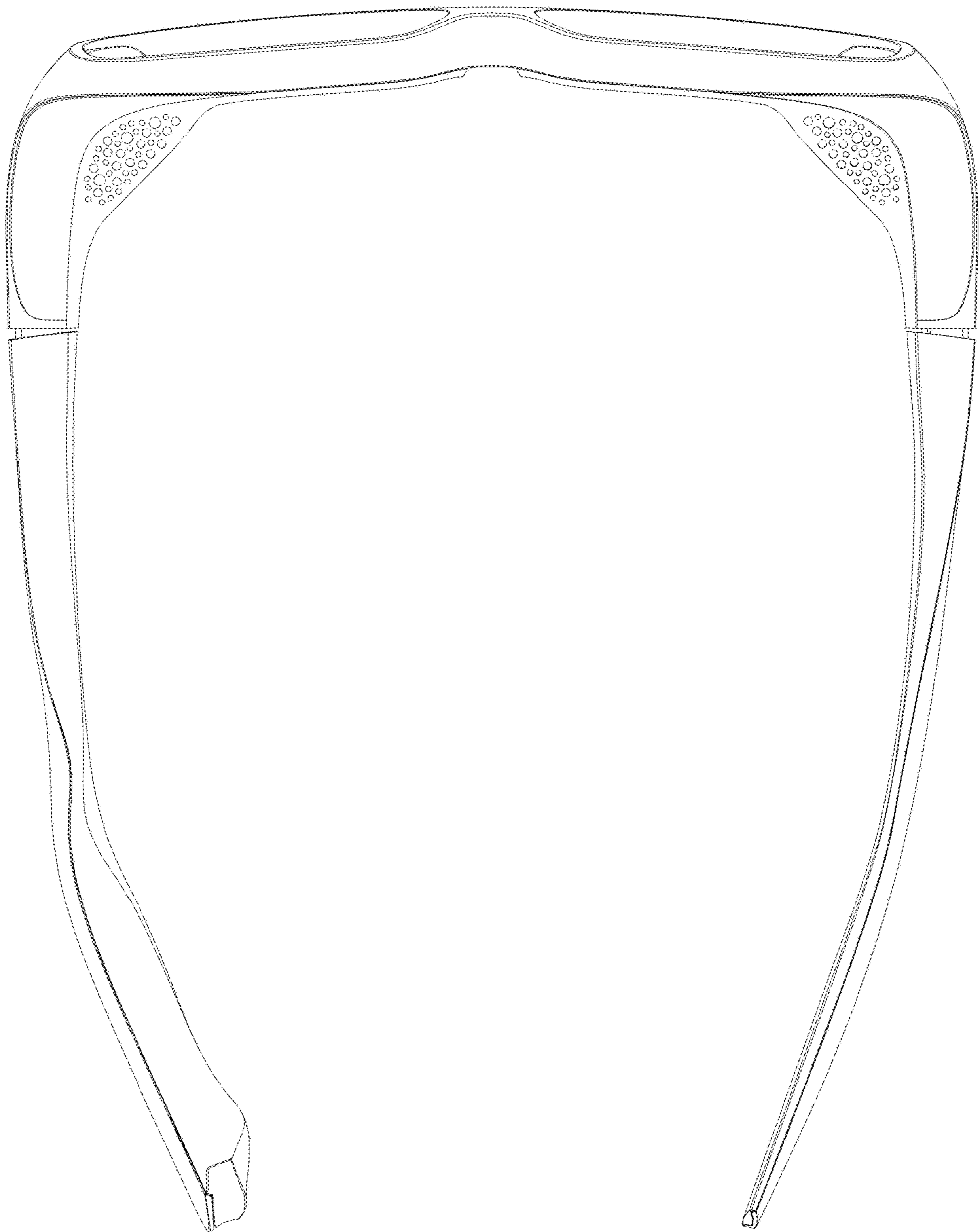

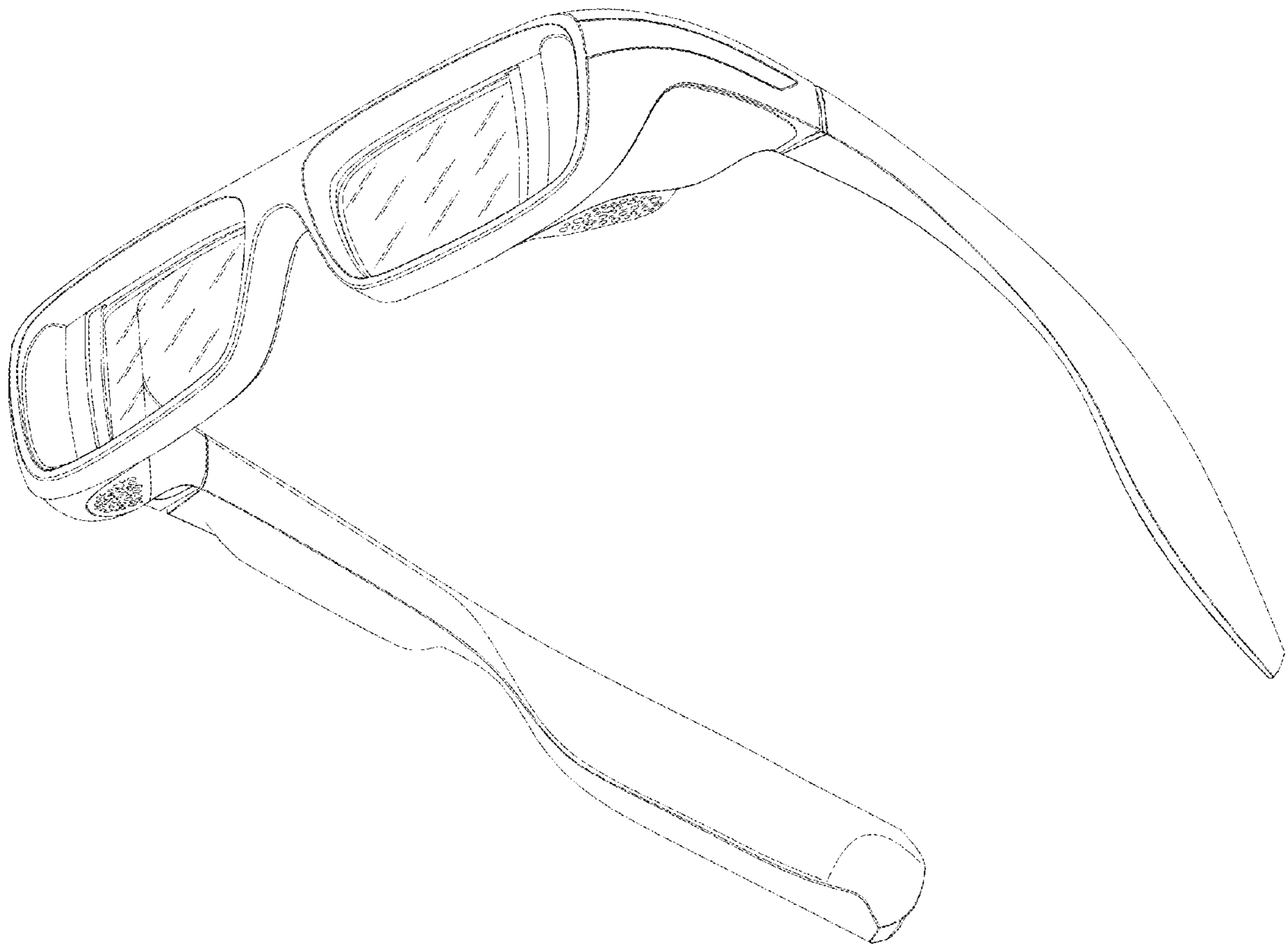

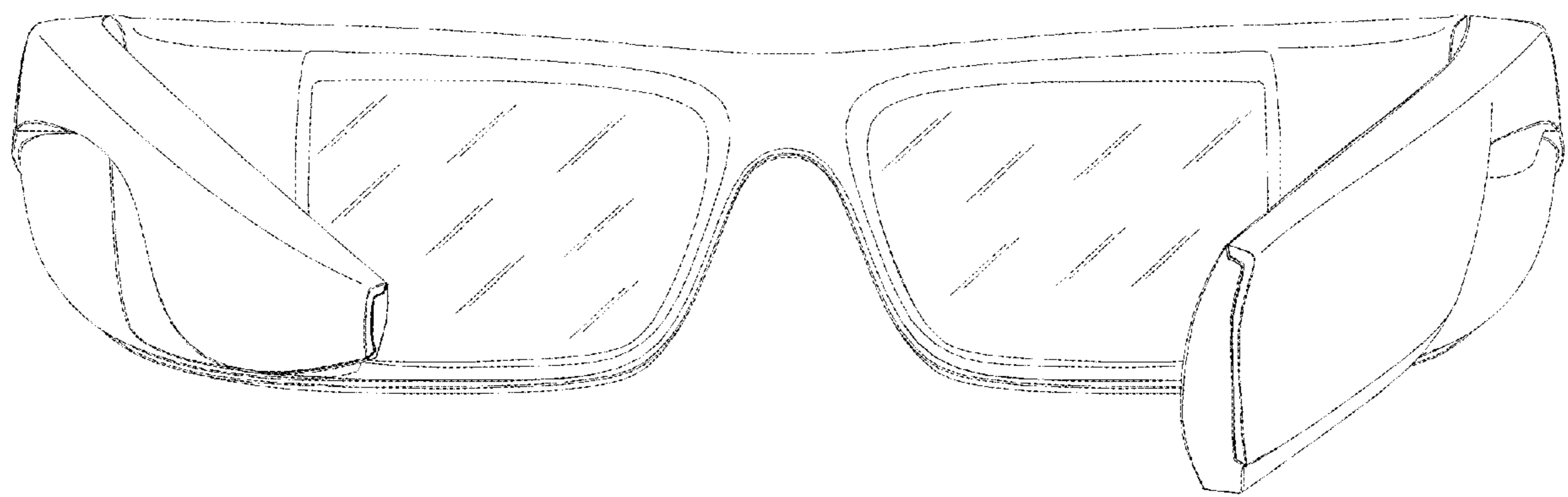
