FIG. 1 is a front view of a the a ring mount assembly showing our new design;

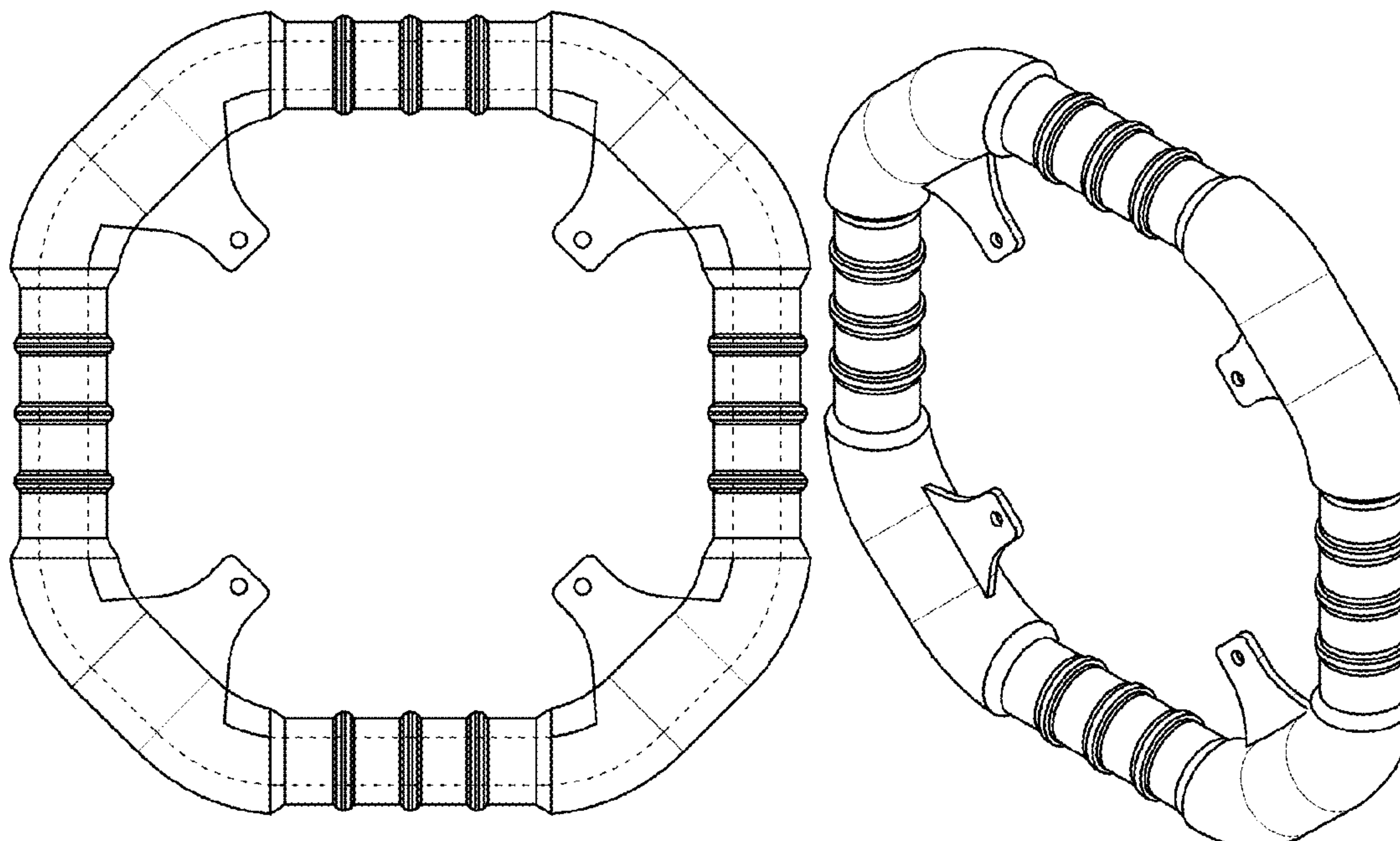
FIG. 2 is a side view thereof;

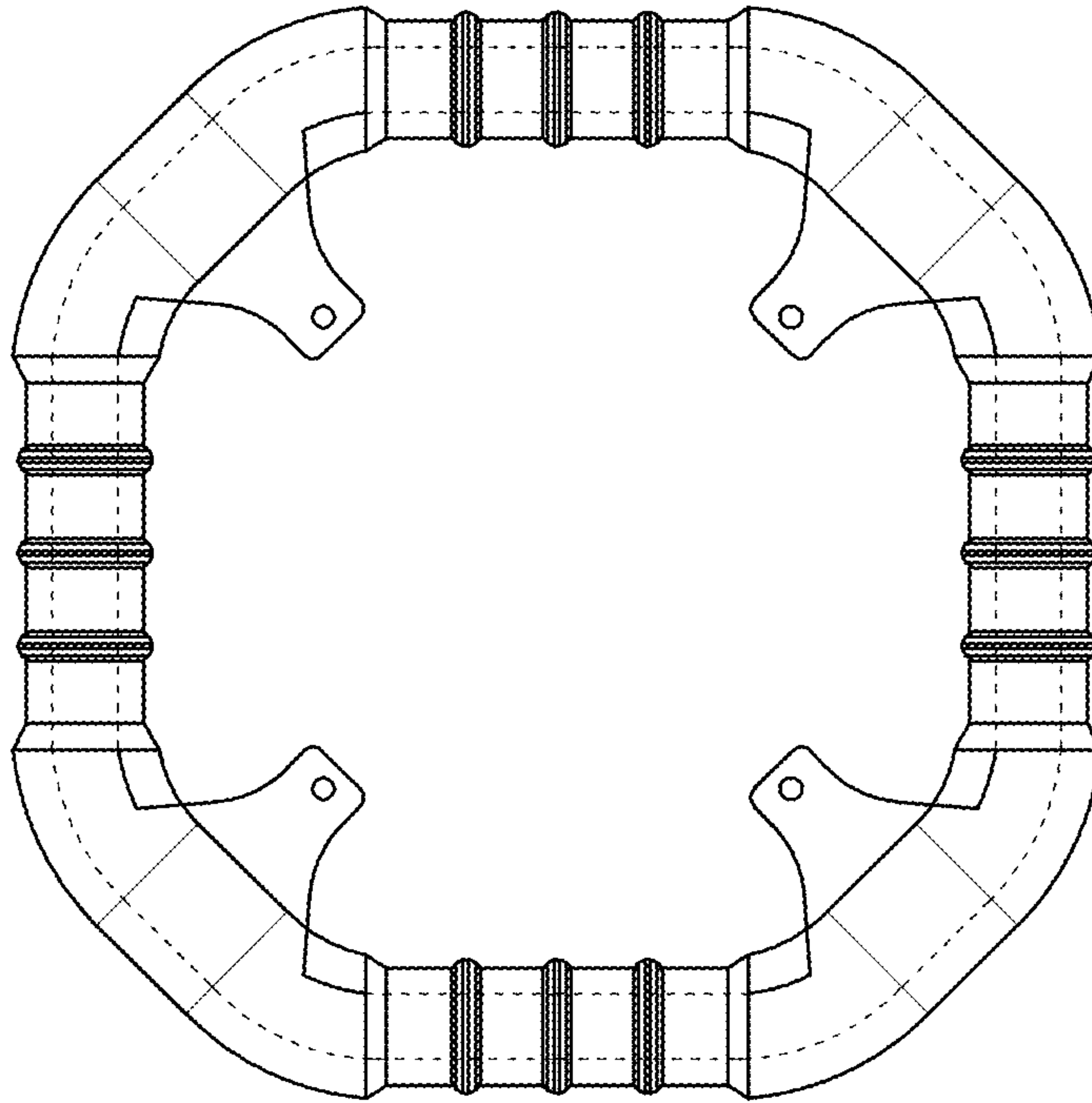

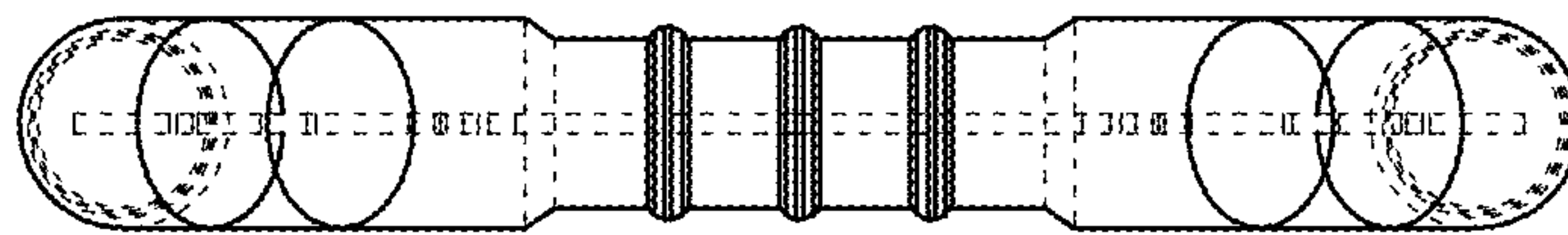

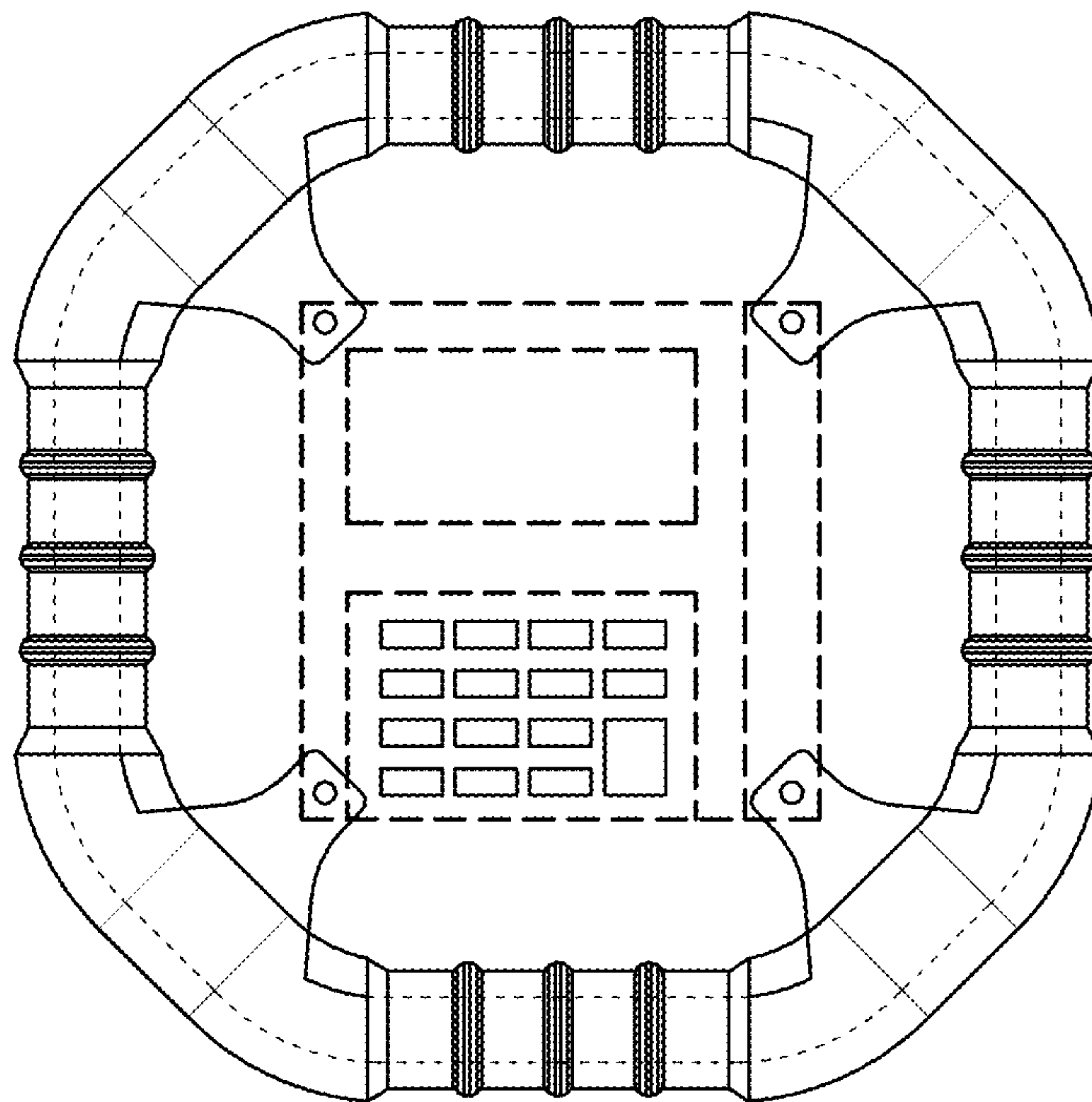

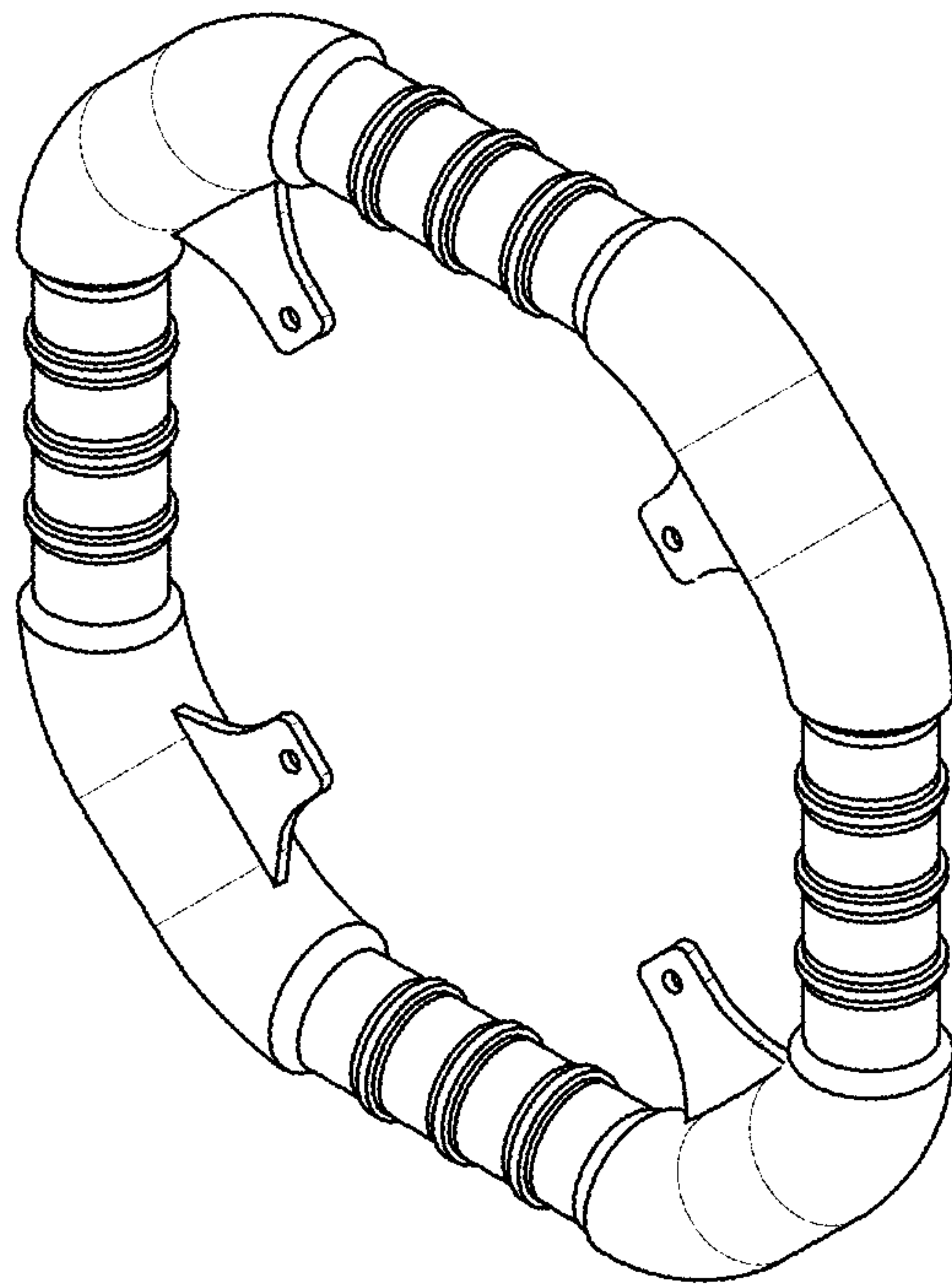
