The ornamental design for a display screen or portion thereof with graphical user interface for a boiler or water heater, as shown and described.

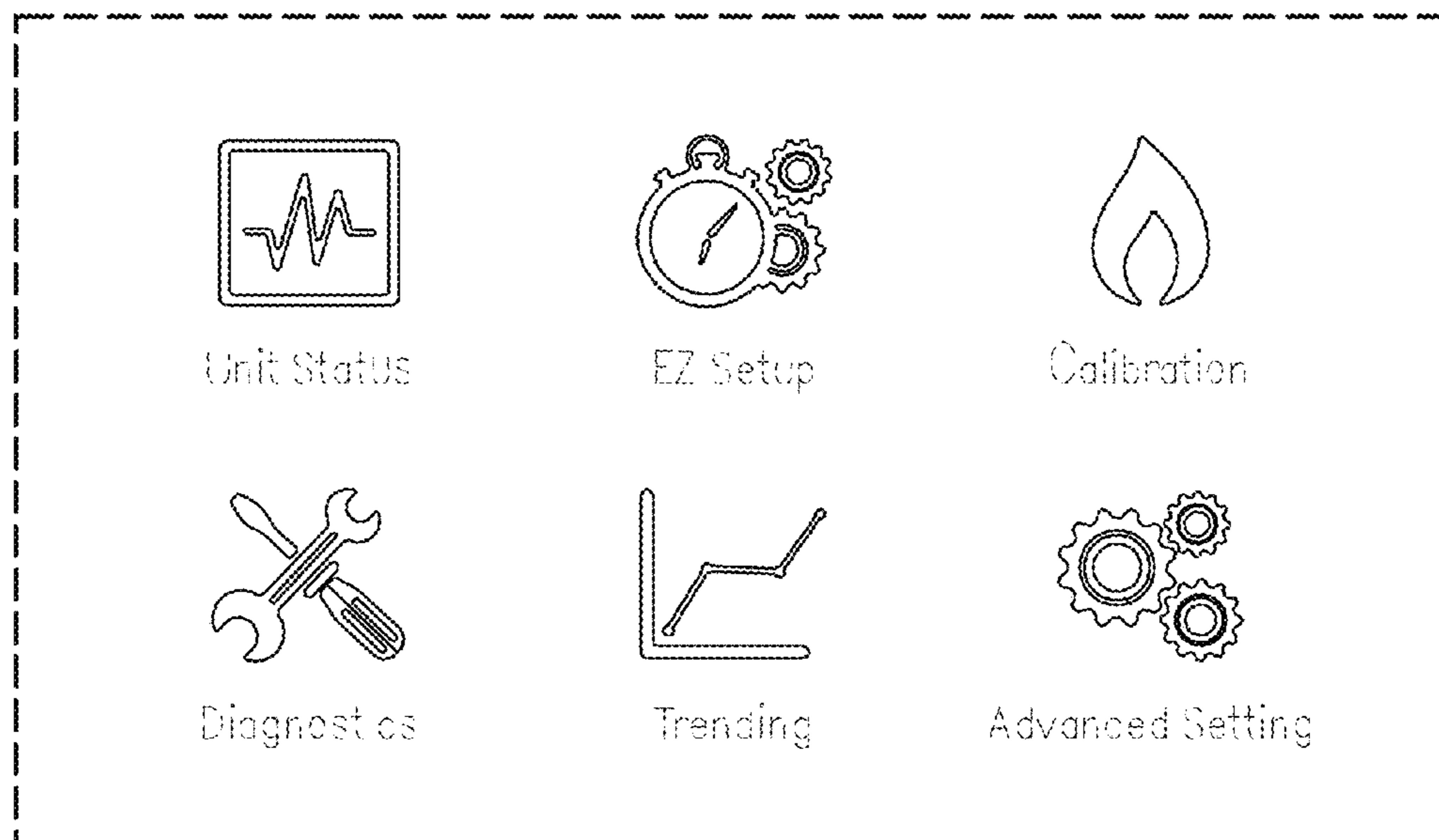
DESCRIPTION

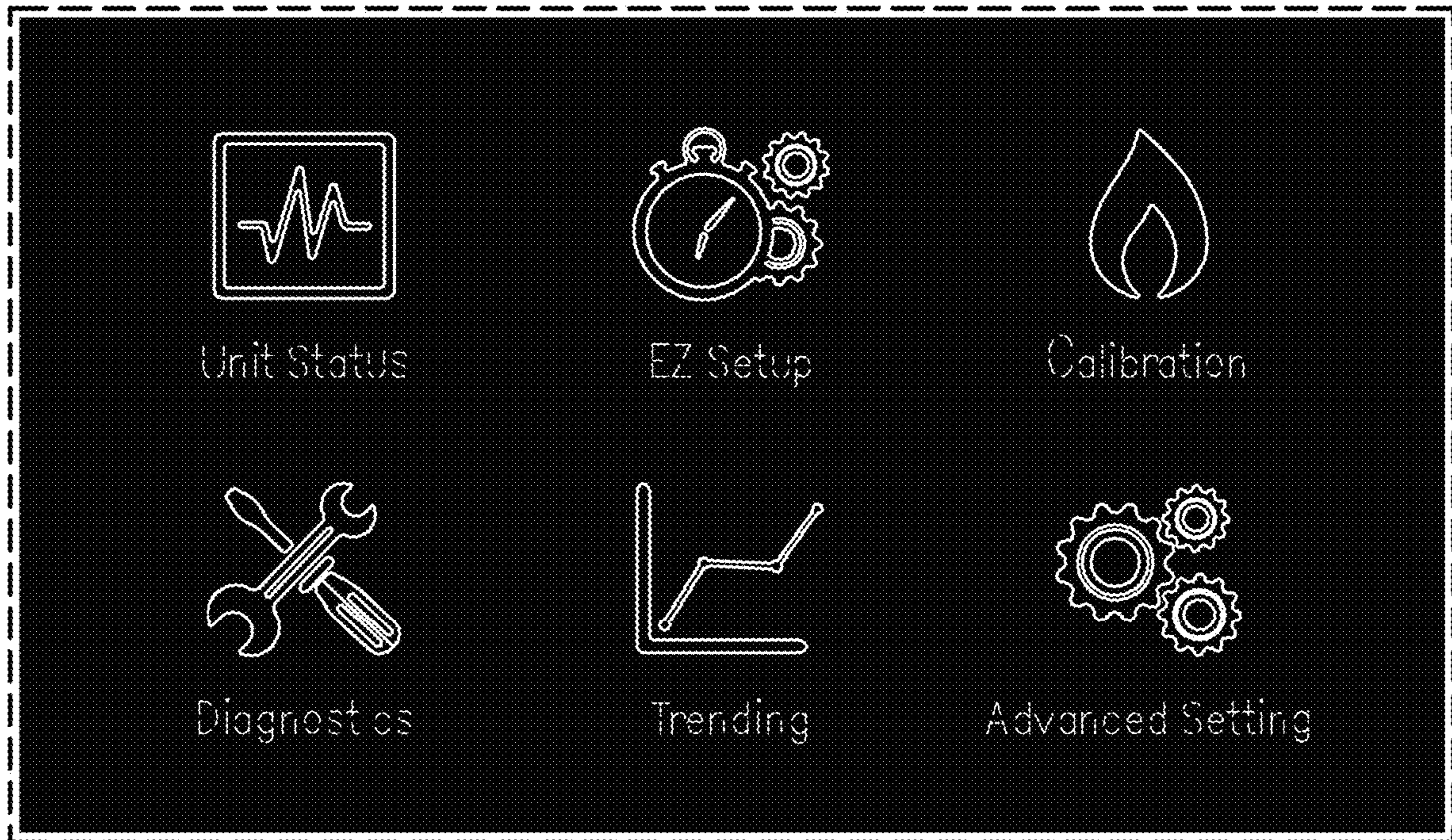
