DESCRIPTION

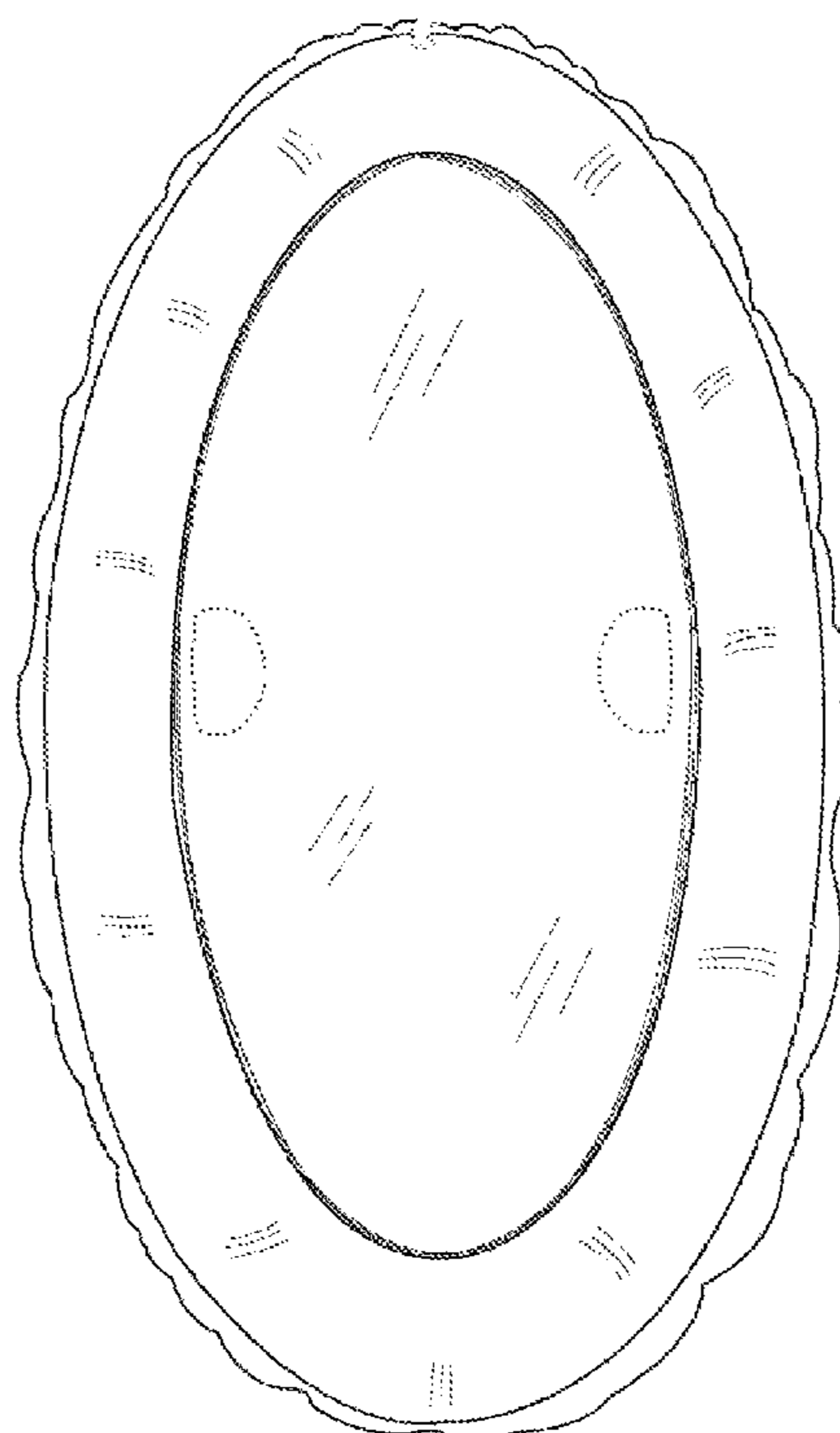
FIG. 1 is a prospective view of the pool float showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The shade lines in the Figures show contour and not surface ornamentation.
The broken lines in the Figures show portions of the pool float, which form no part of the claimed design.

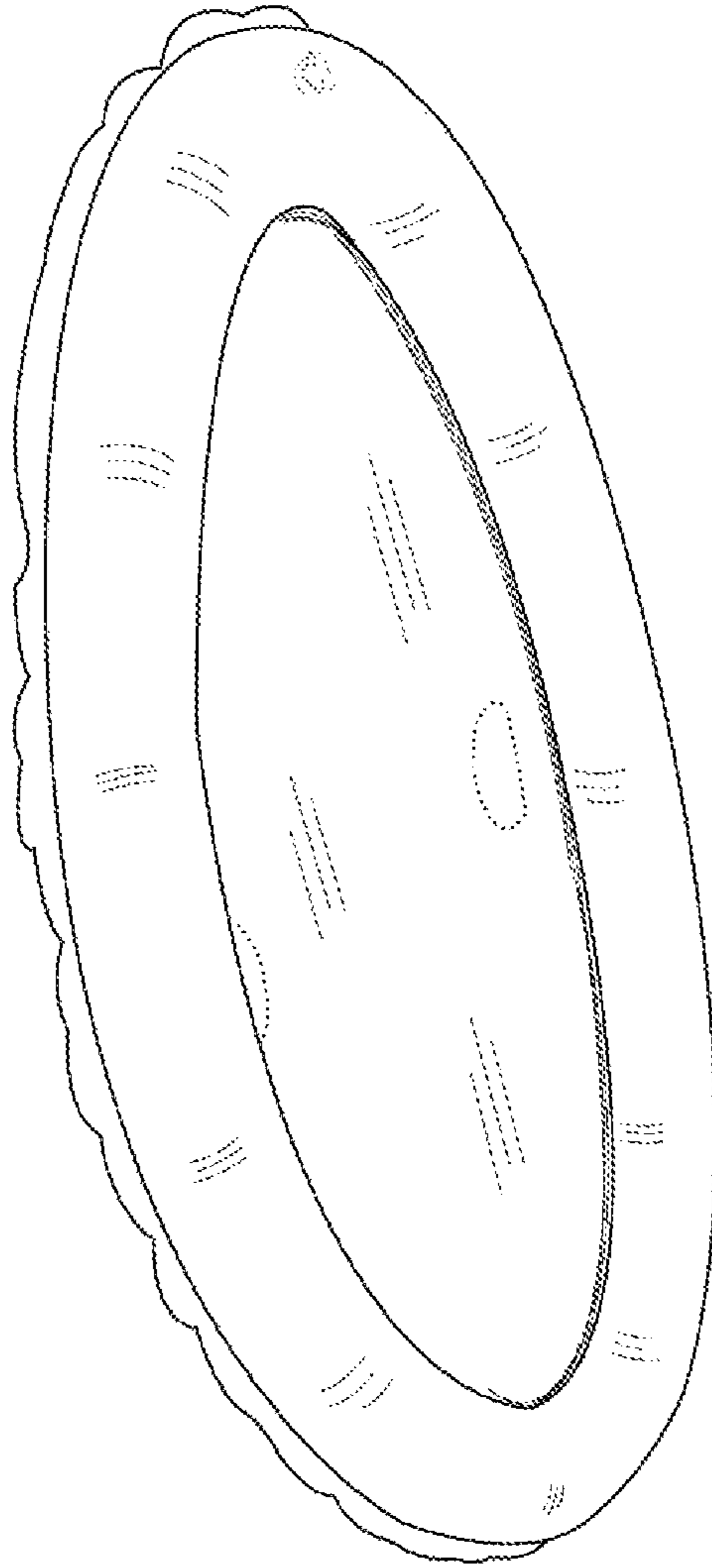

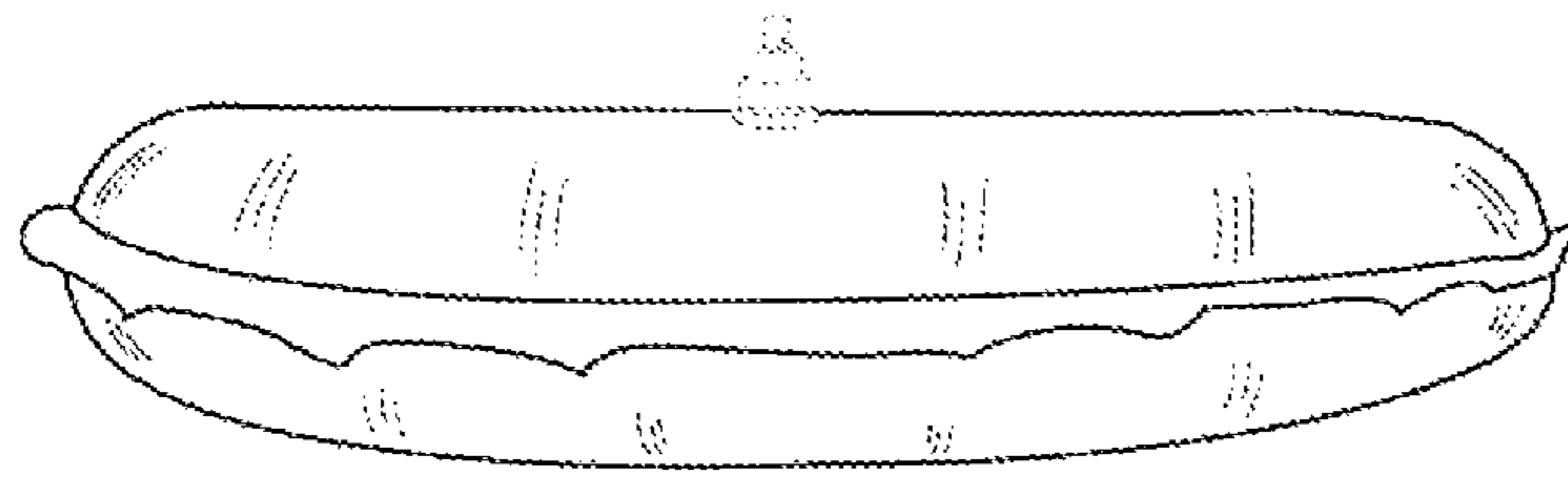

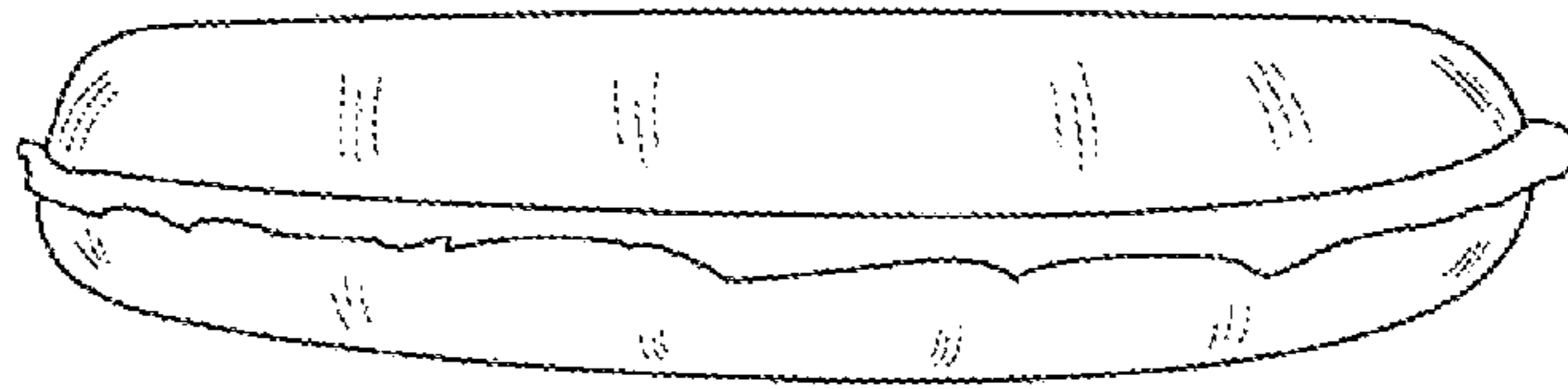

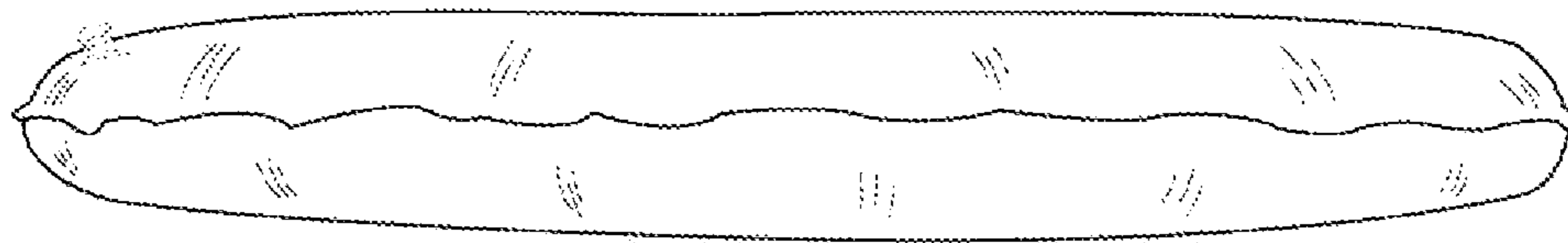

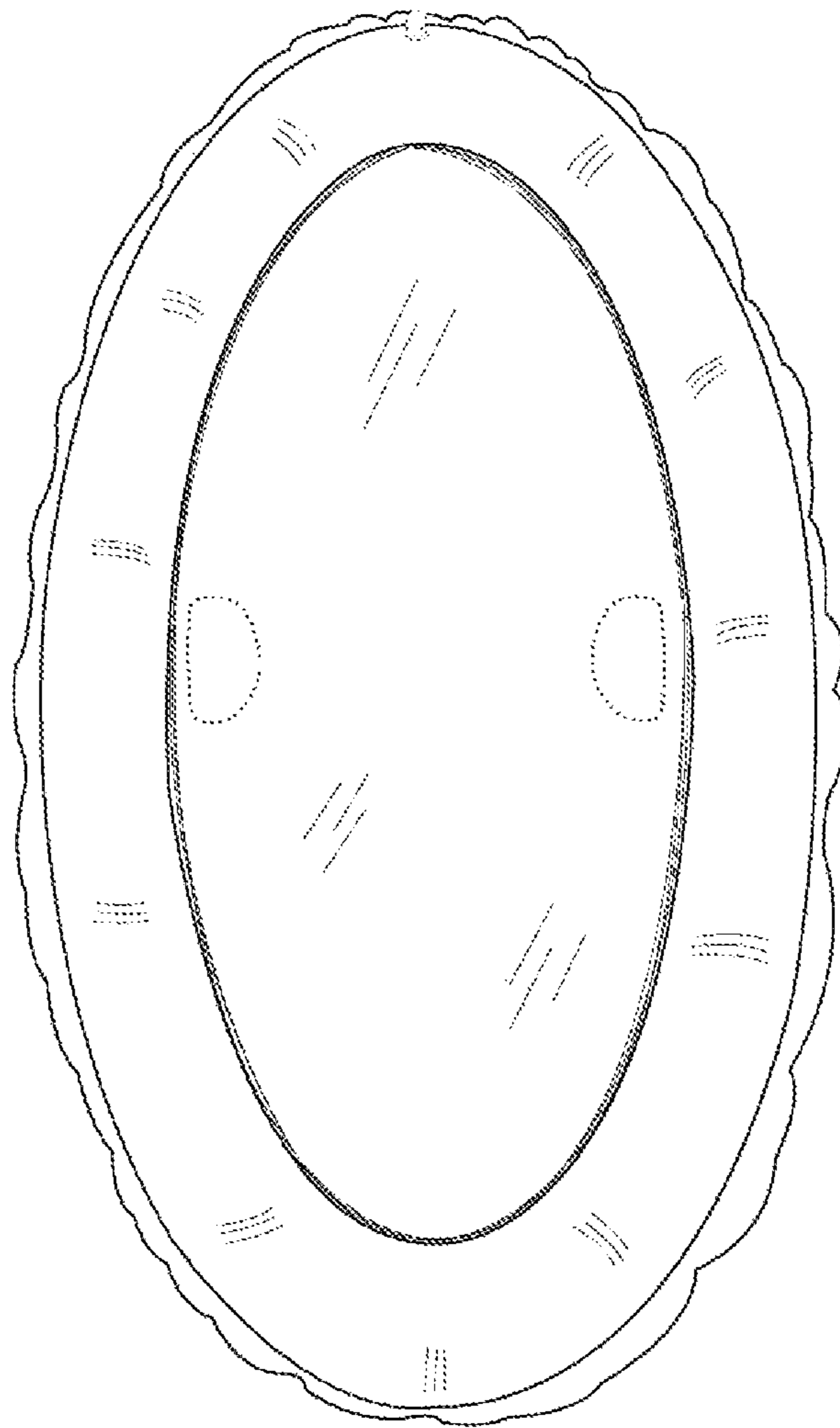

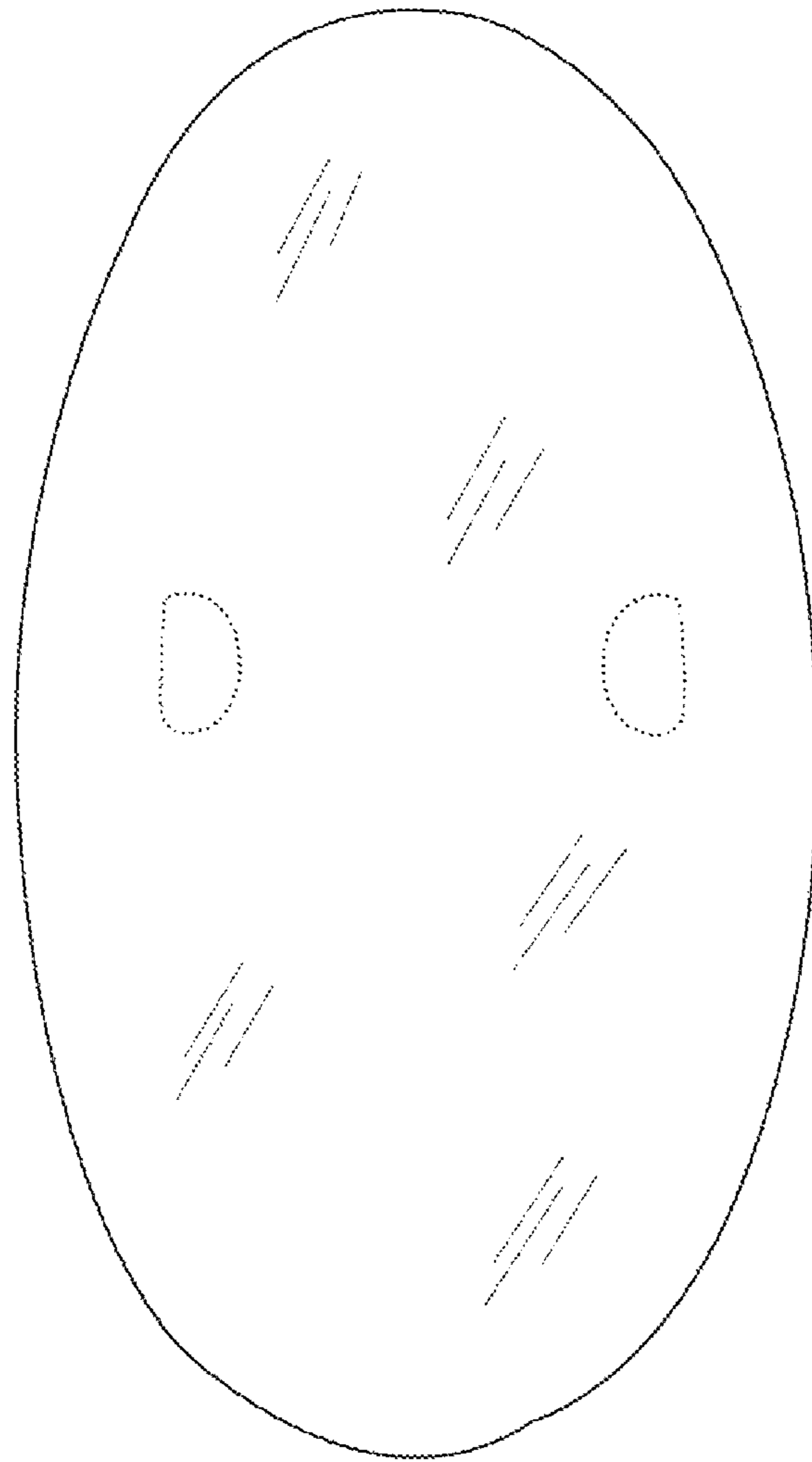
