The ornamental design for an aroma diffuser, as shown and described.

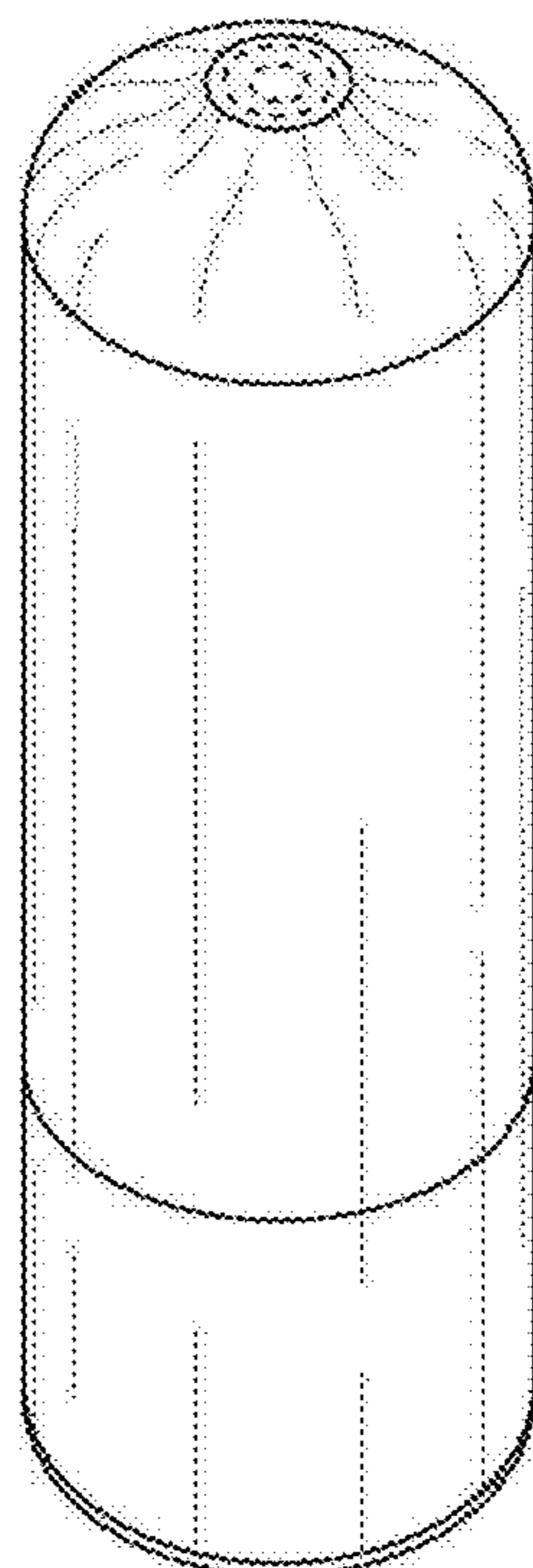
**DESCRIPTION**

FIG. 1 is a front elevational view of an aroma diffuser showing my new design;

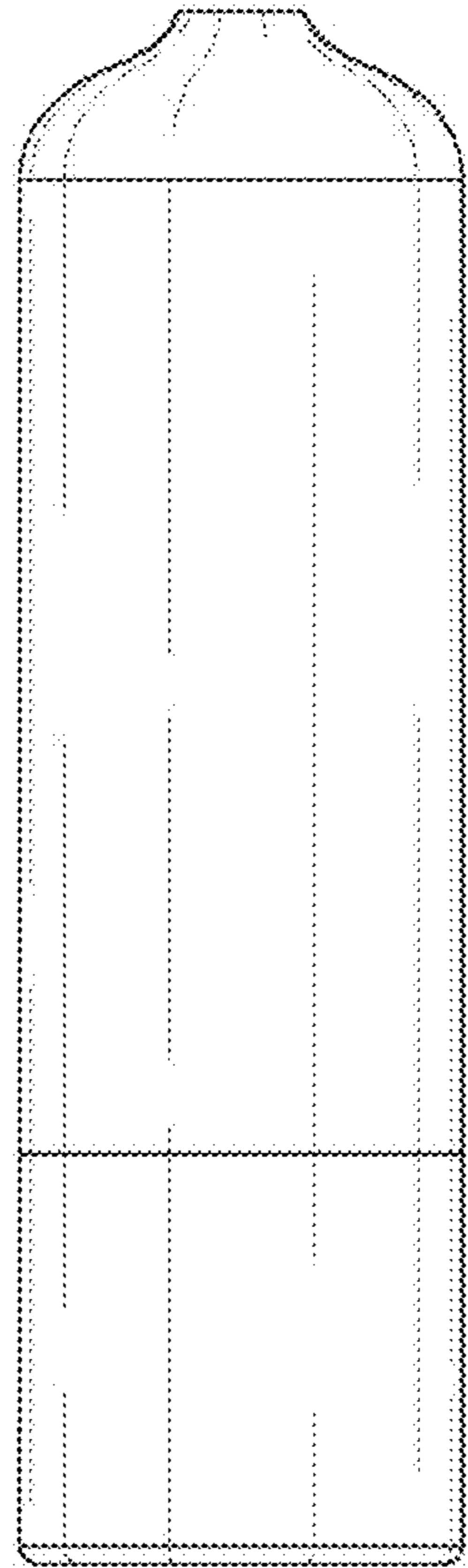

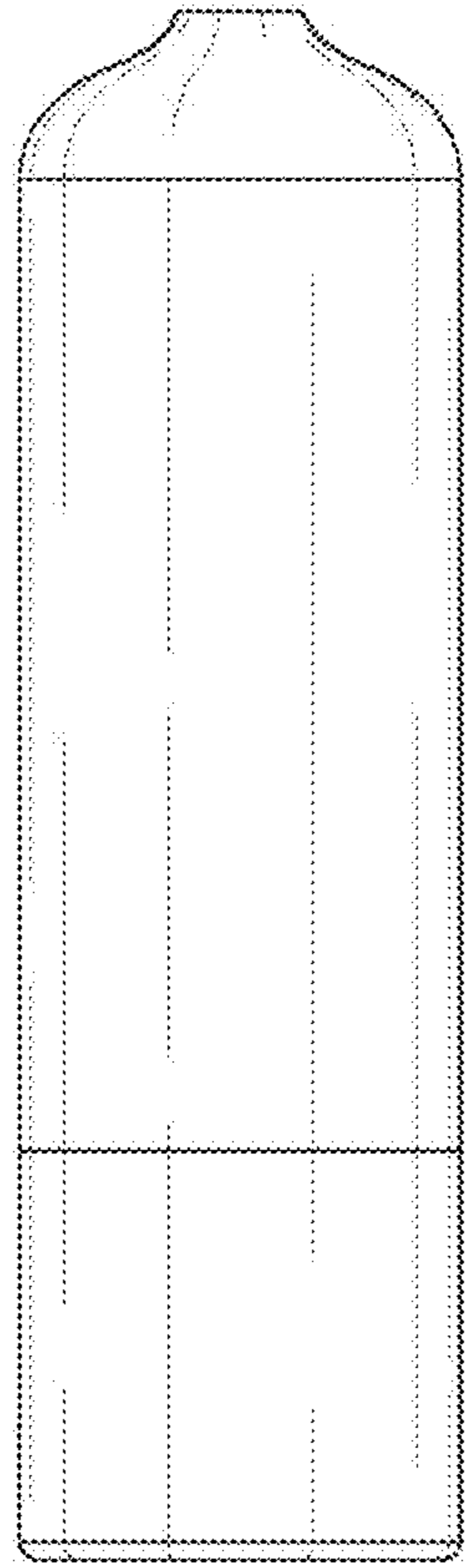

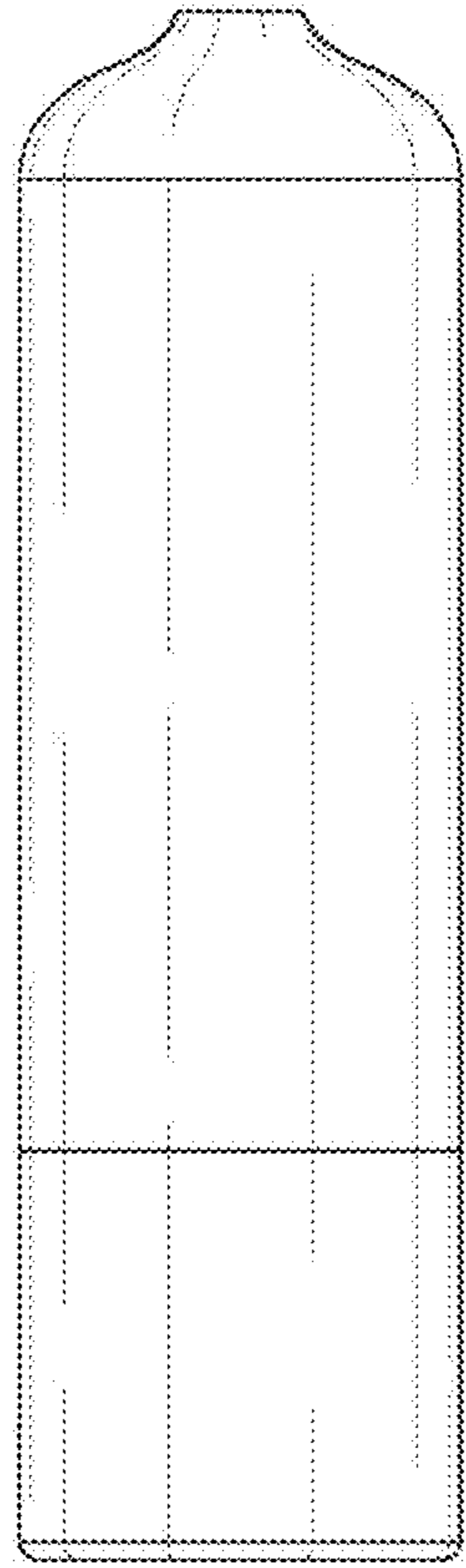

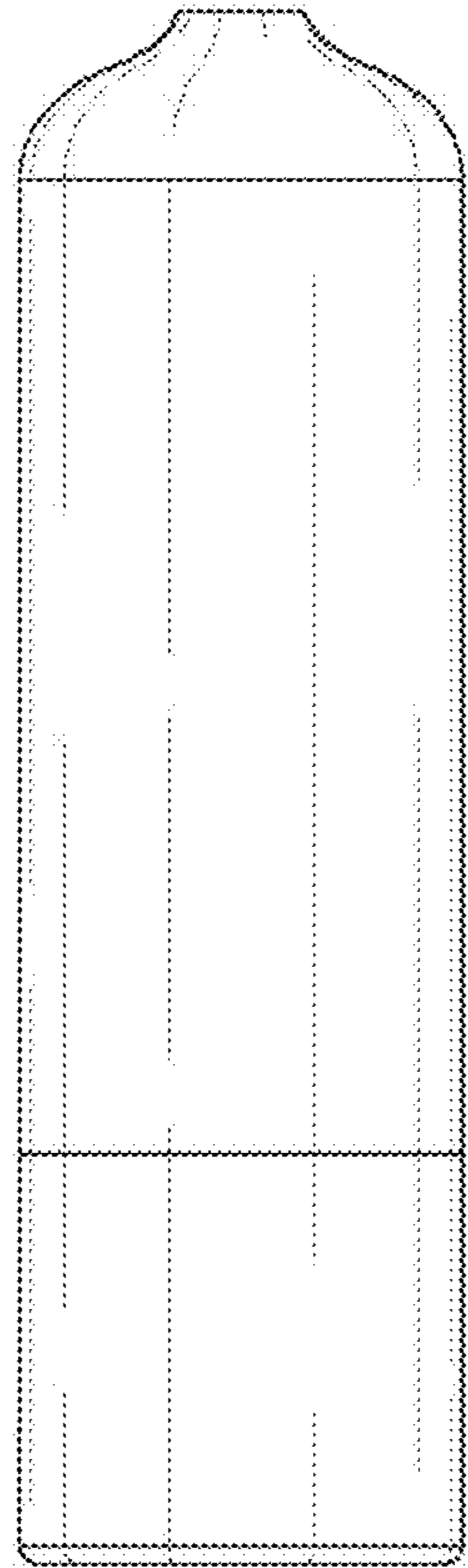

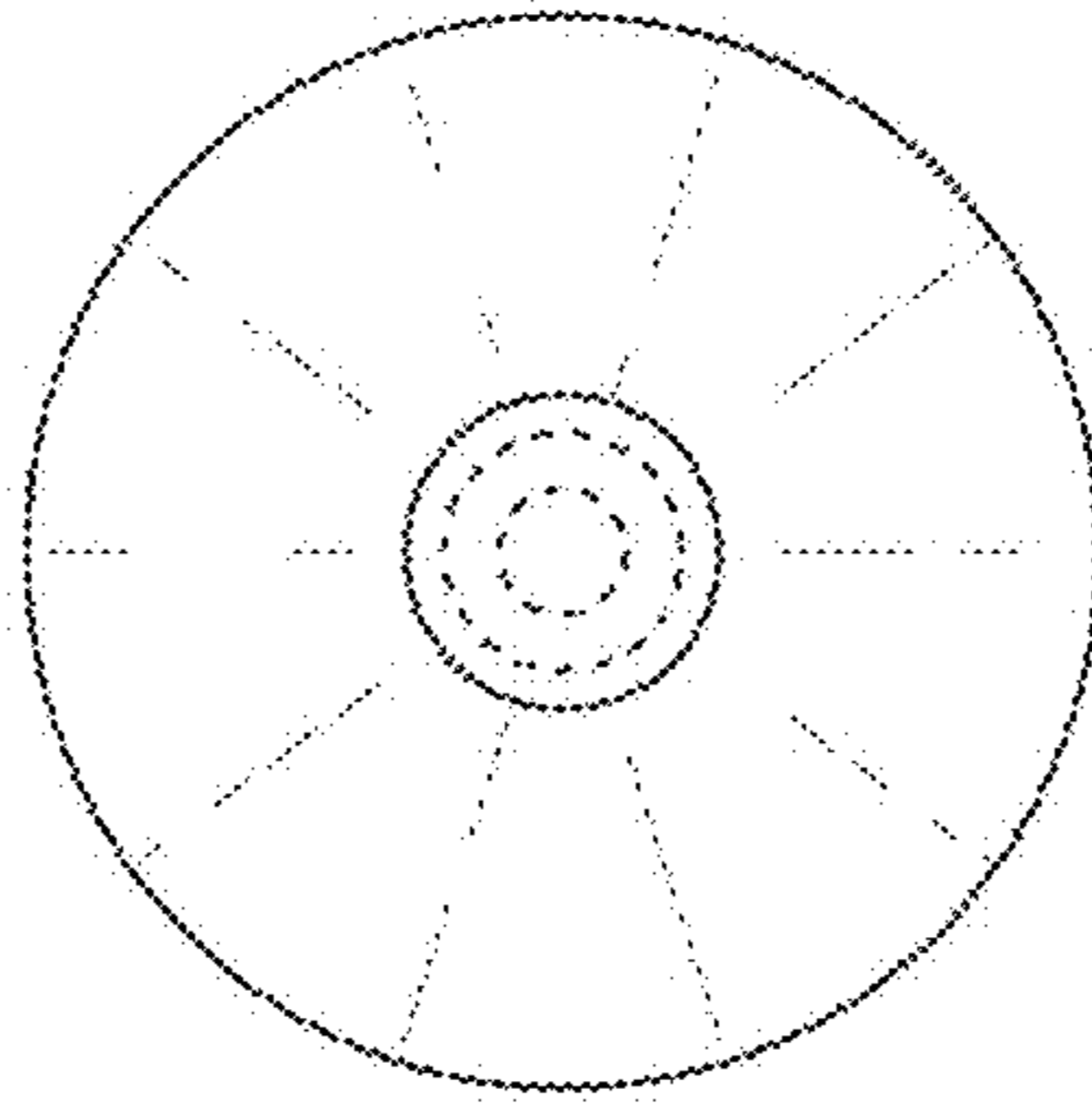

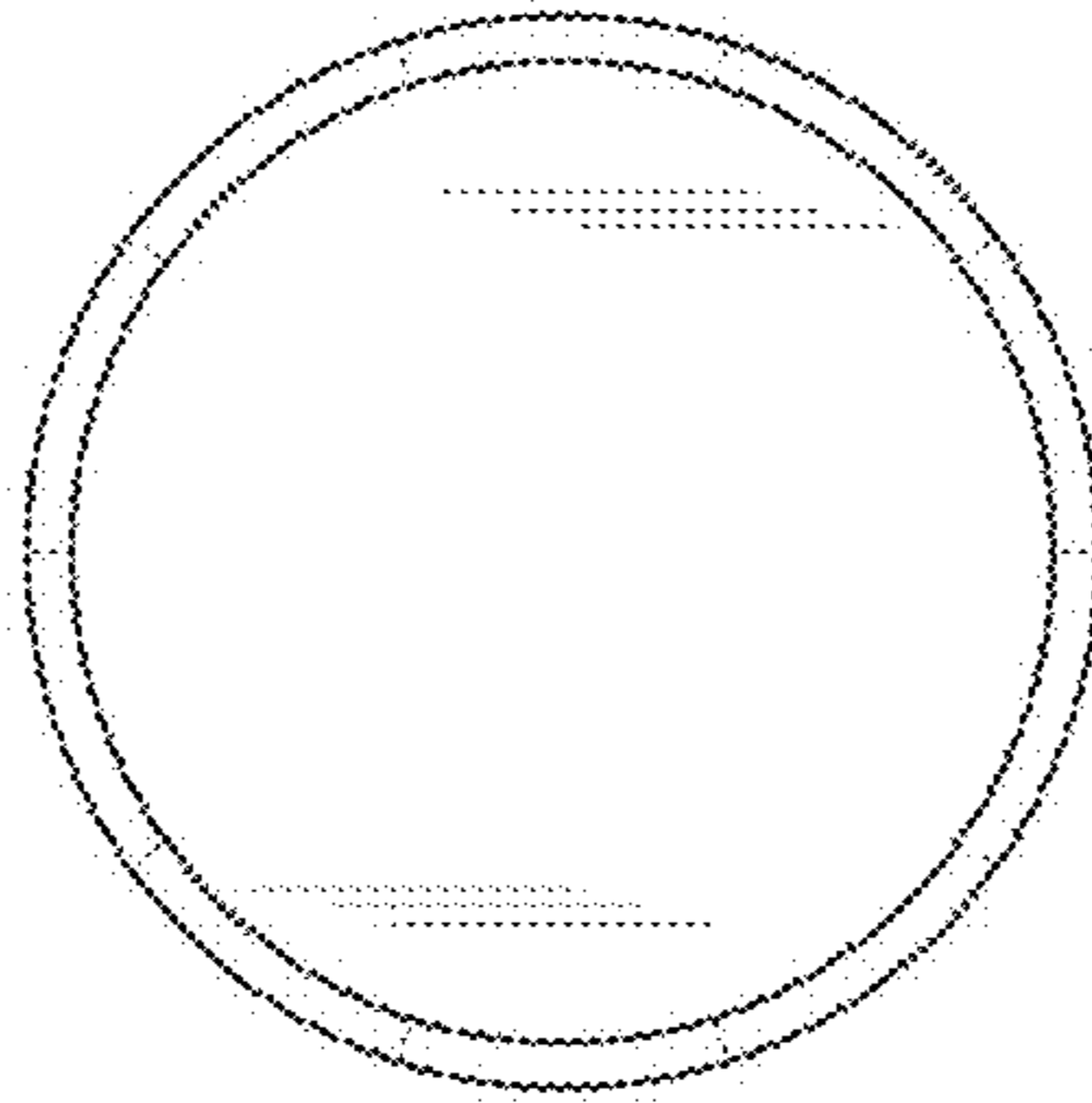

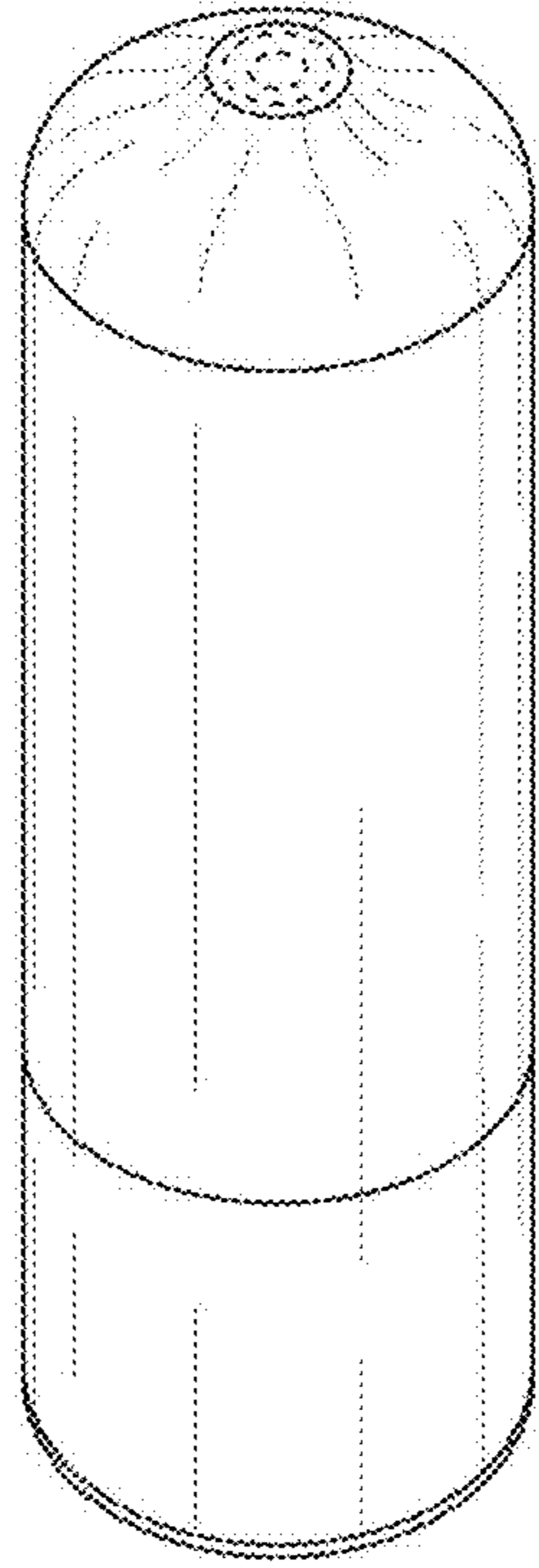

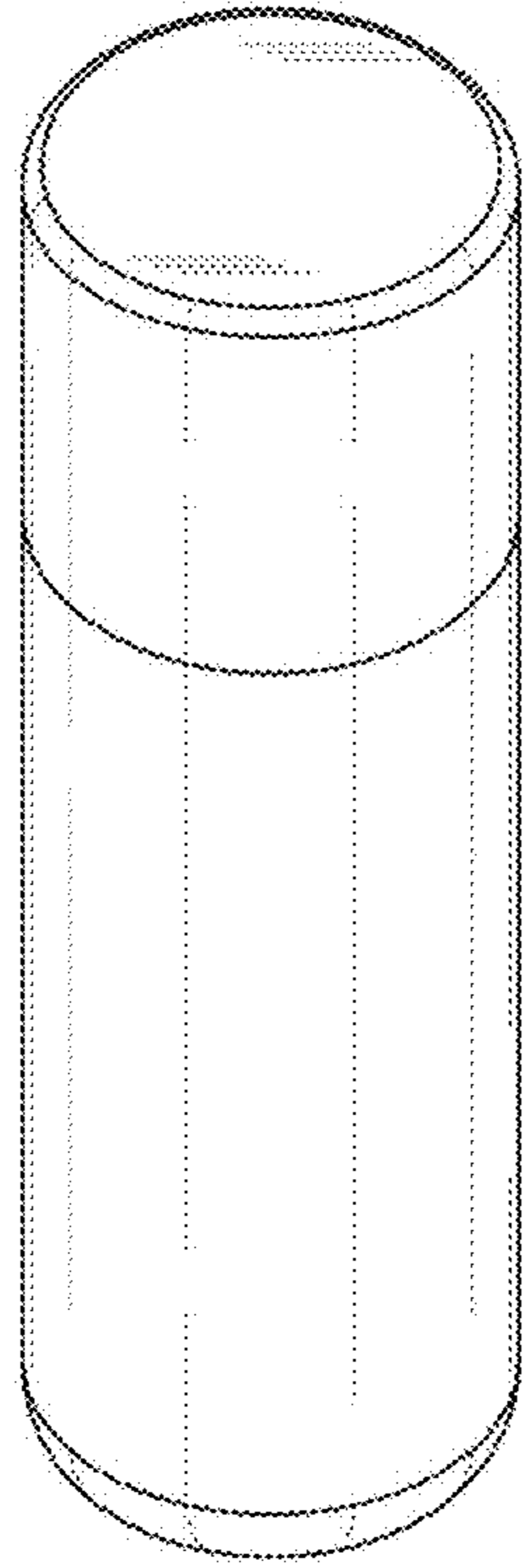
