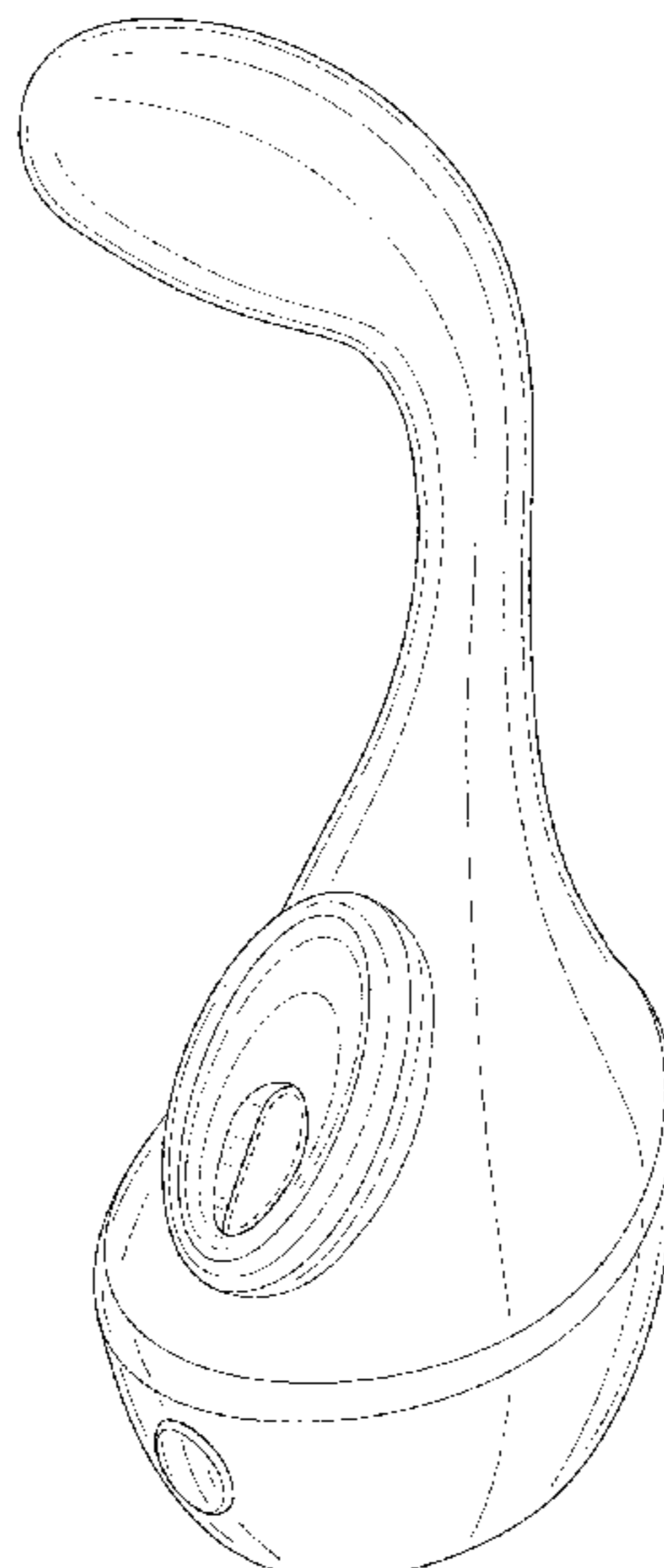
(57) **CLAIM**

The ornamental design for an electromechanical massager, as shown and described.

**DESCRIPTION**

FIG. 1 is a front top right side perspective view of an electromechanical massager showing our new design; FIG. 2 is a rear bottom right-side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left-side elevational view thereof; FIG. 6 is a right-side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines shown in the figures are for the purpose of illustrating portions of the electromechanical massager, which form no part of the claimed design.

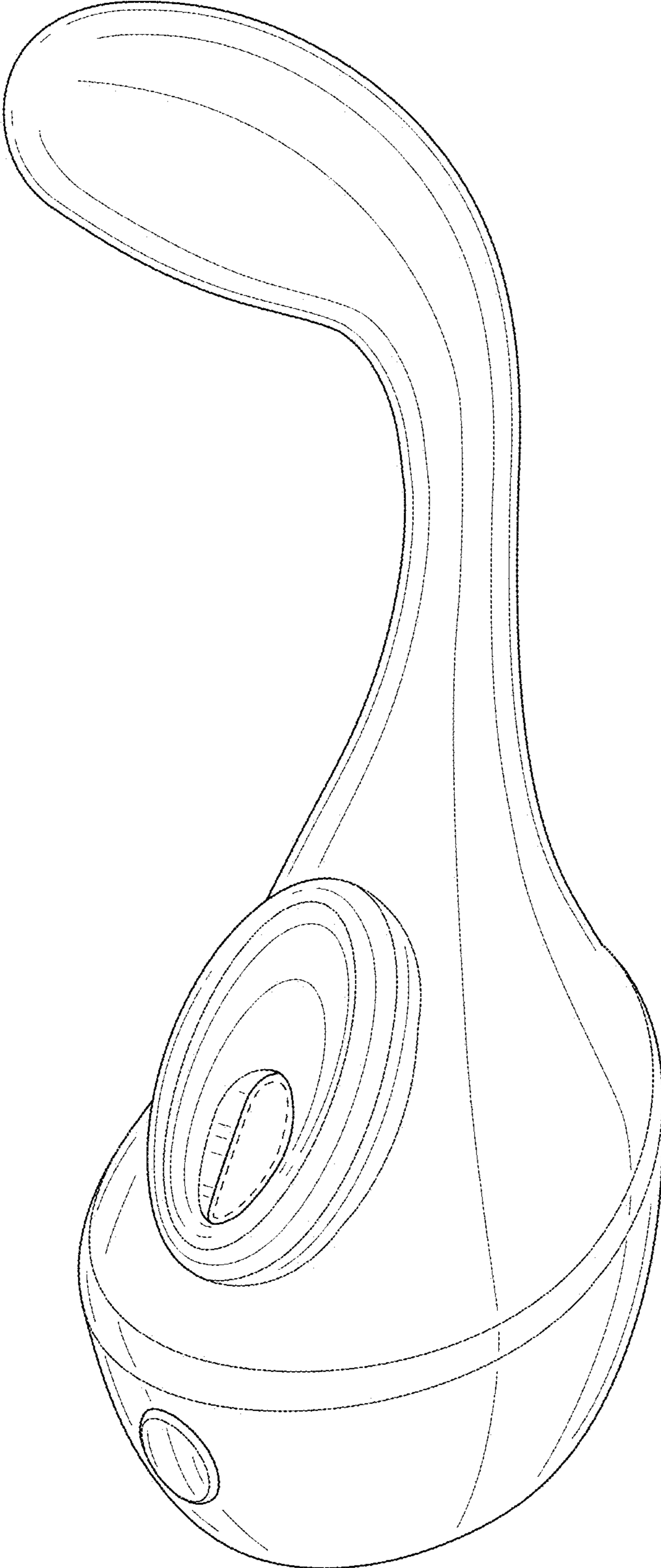

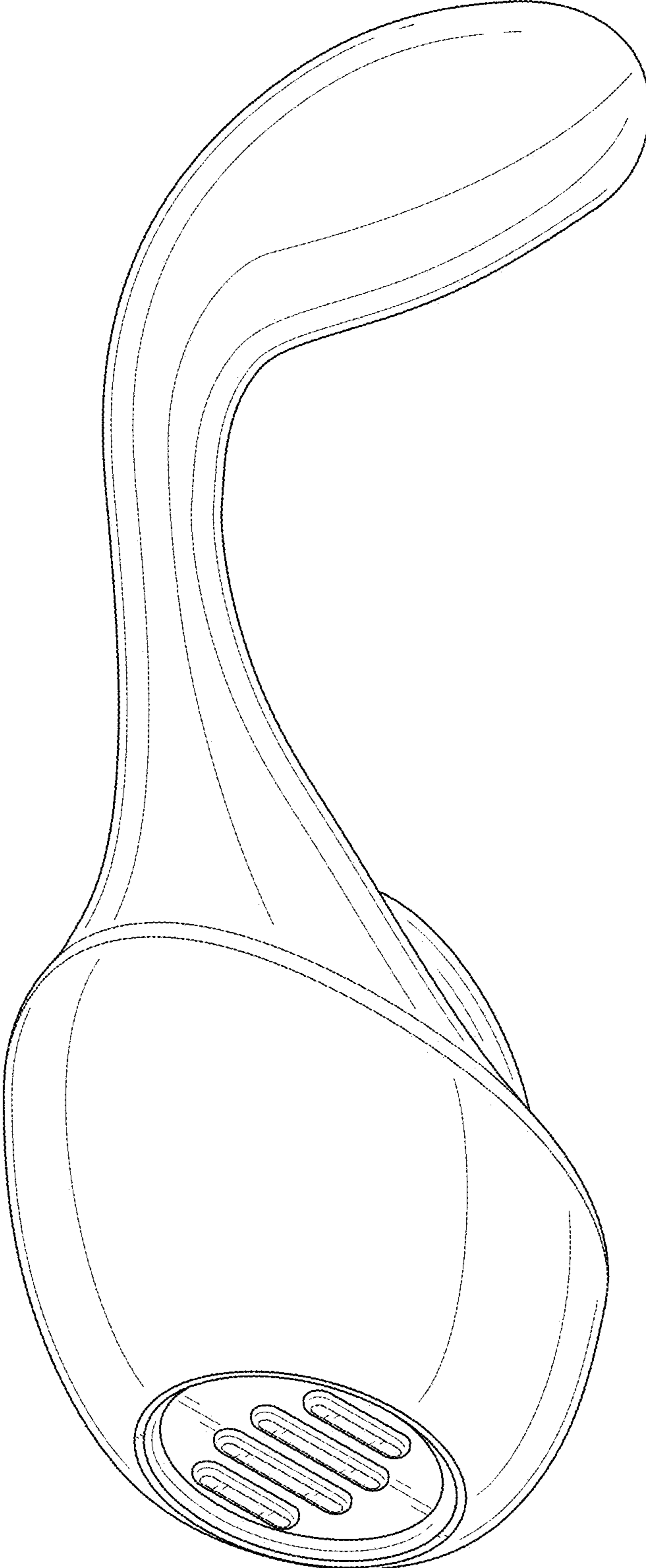

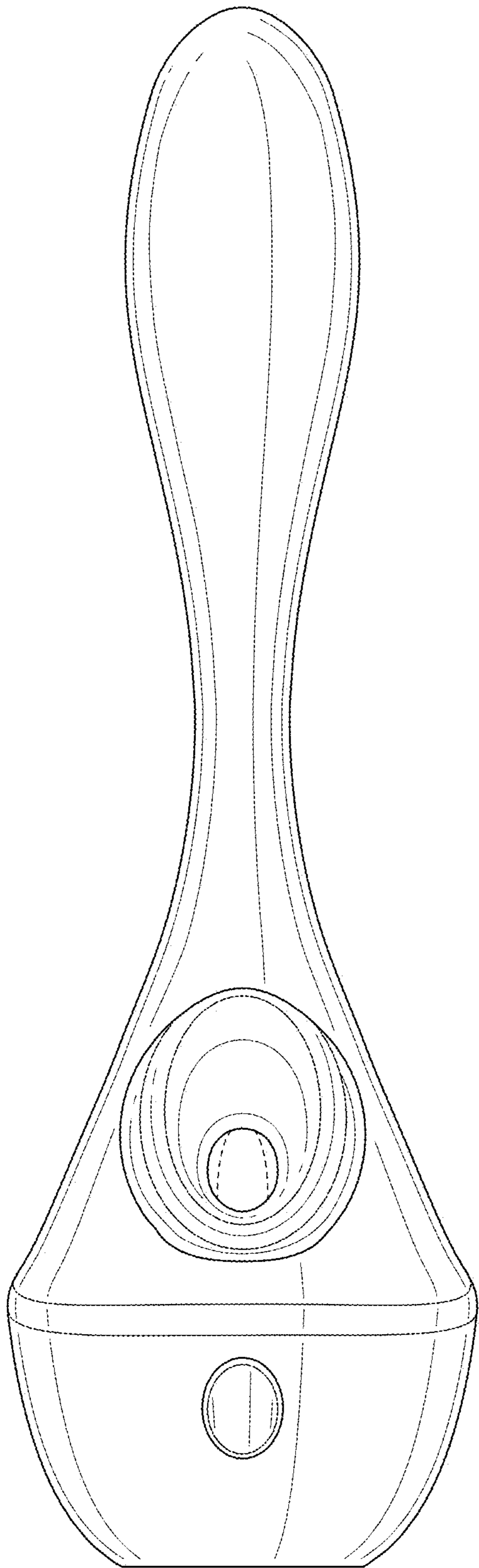

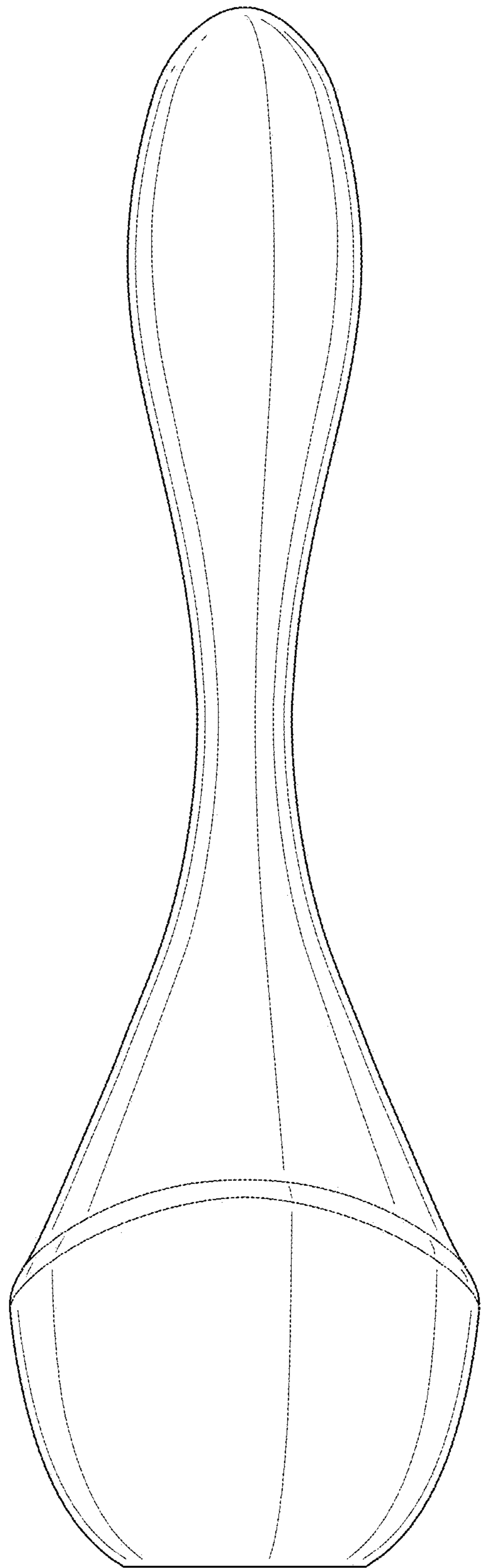

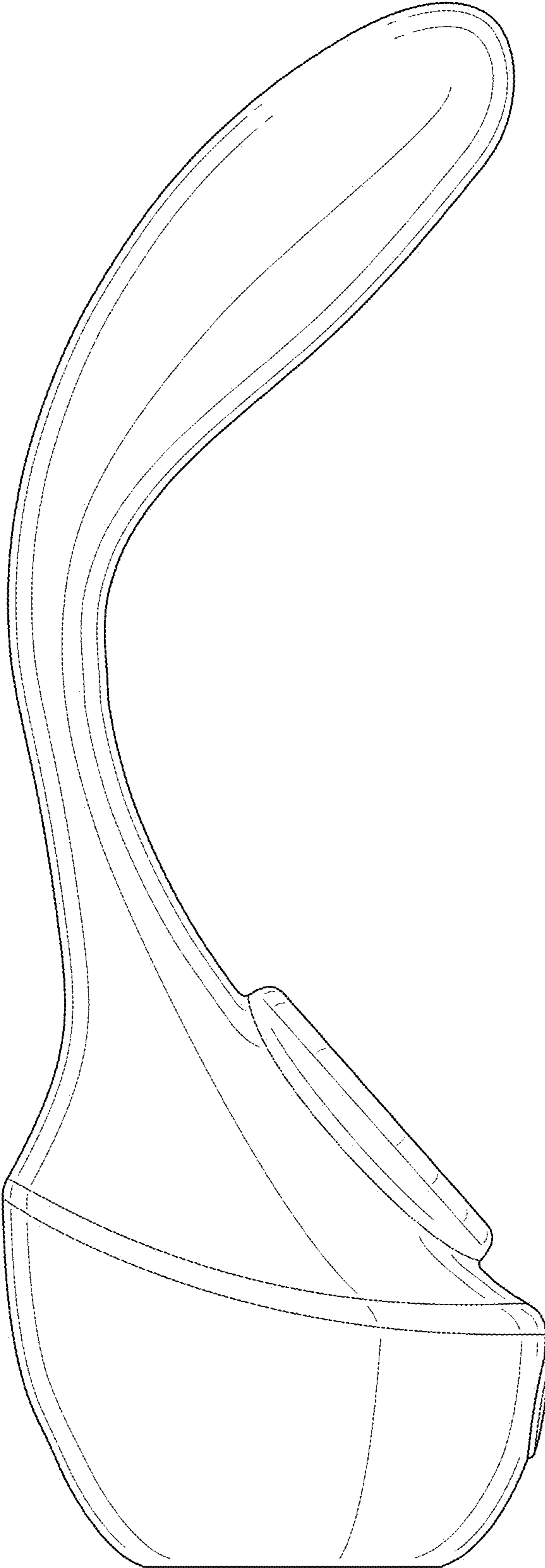

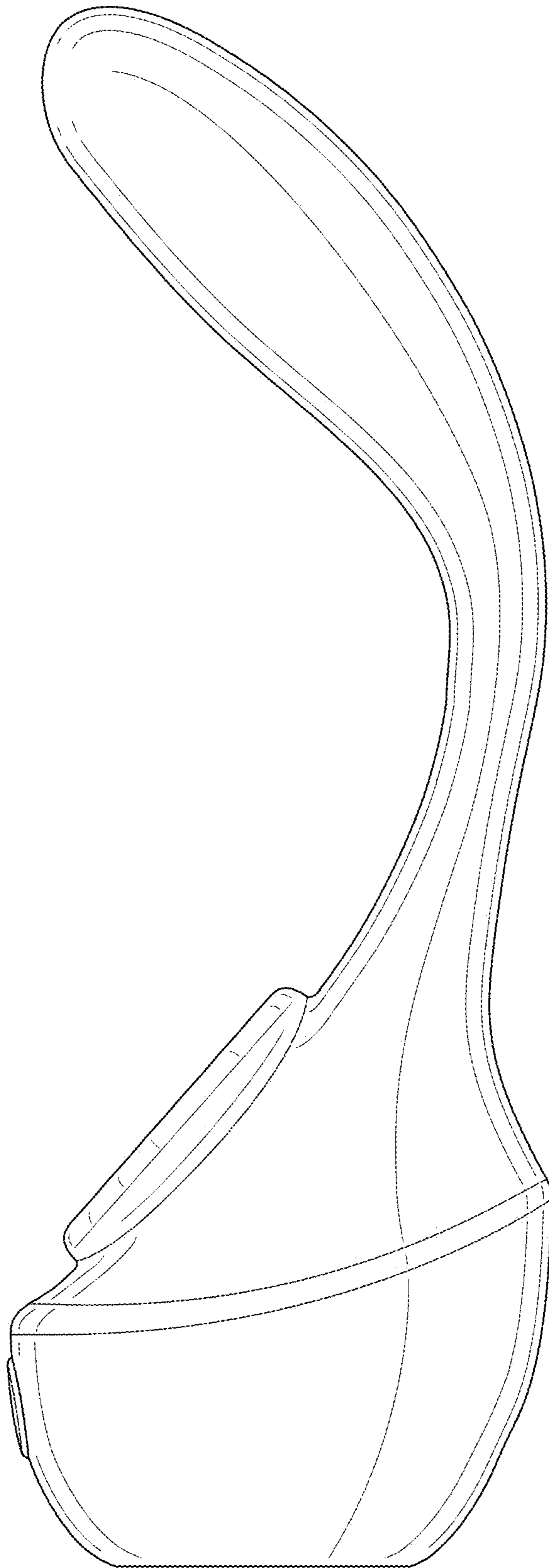

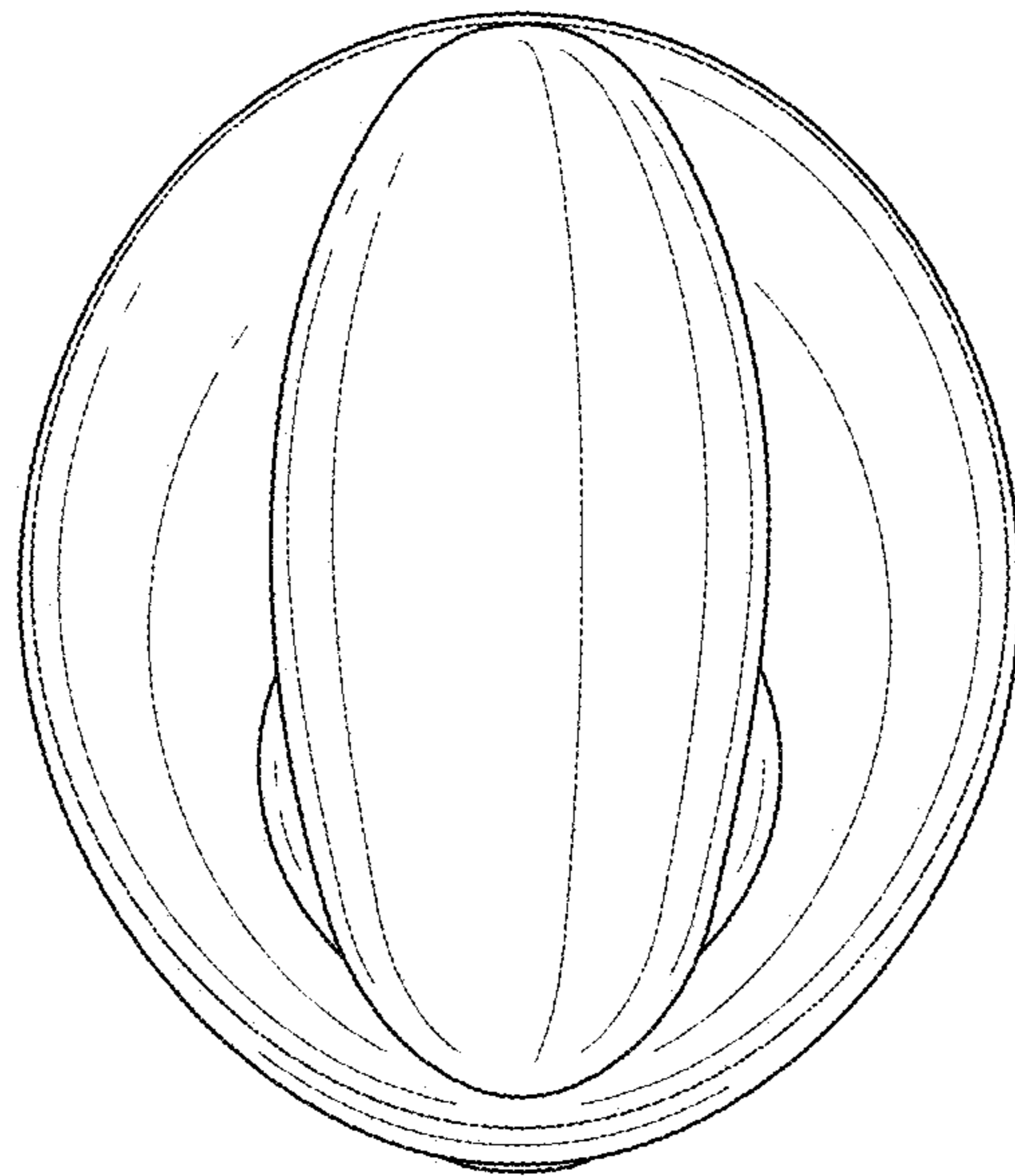

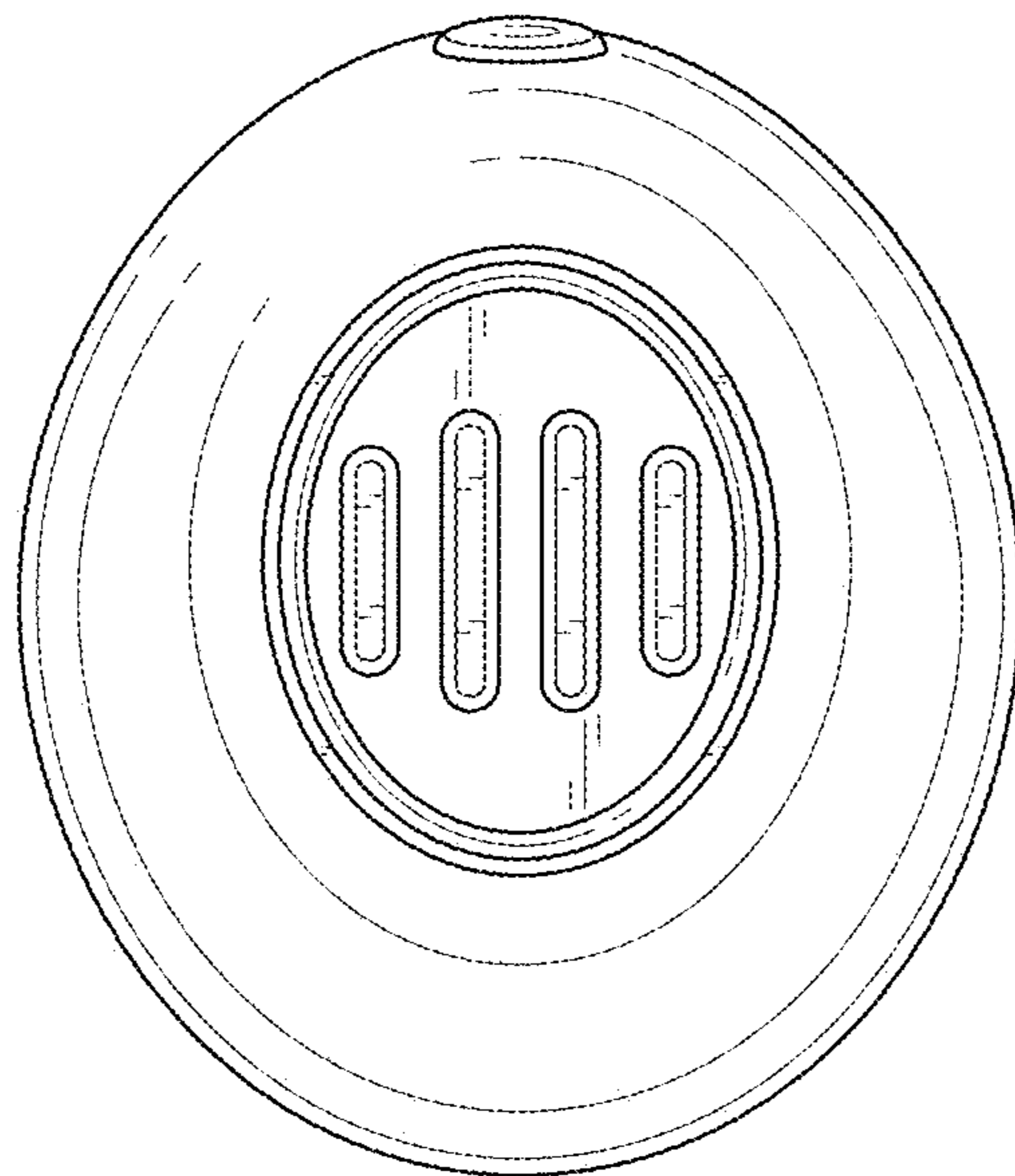
