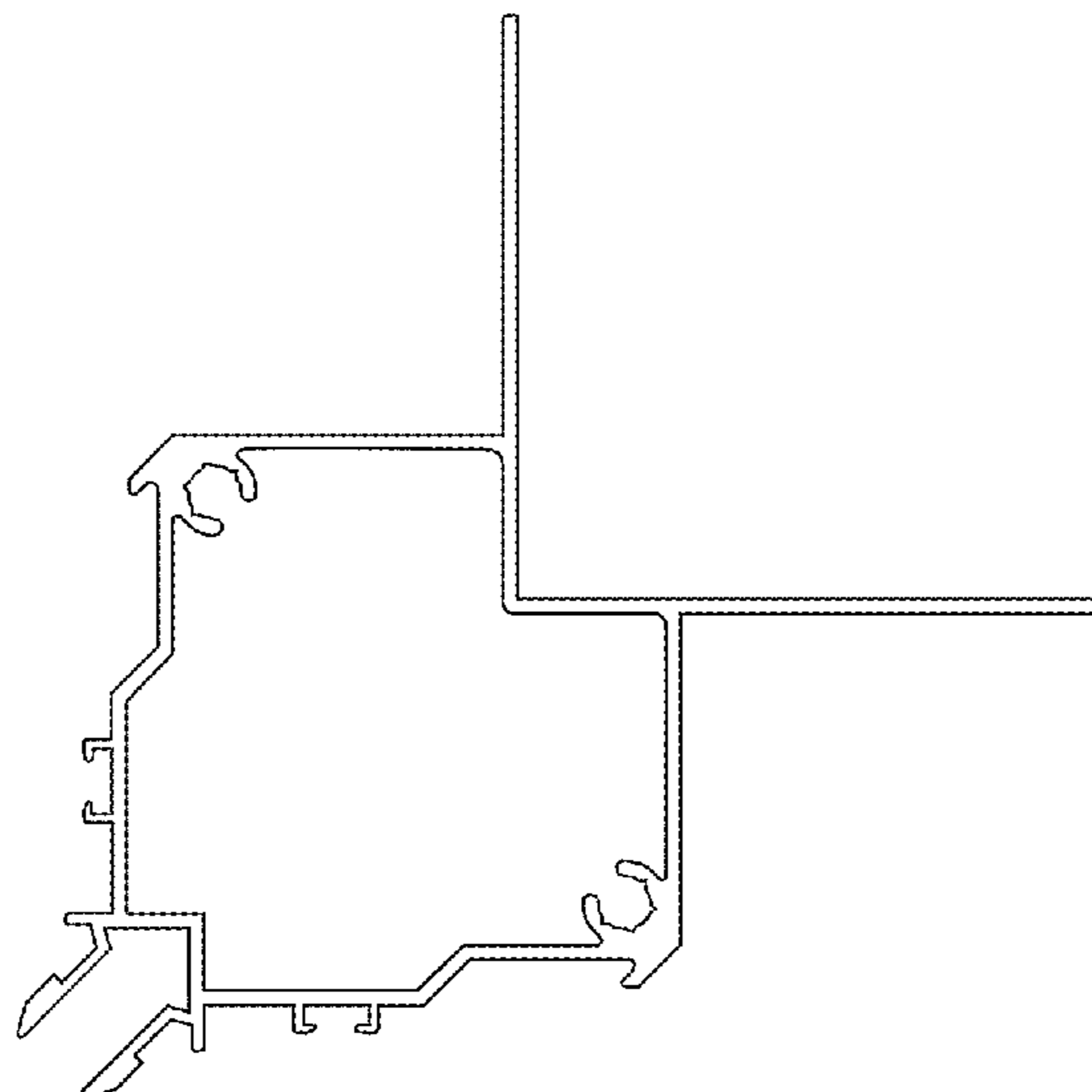
(57) **CLAIM**

The ornamental design for a building extrusion, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a front end view of a building extrusion, showing  
our new design;  
FIG. 2 is a back end view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a front, top and left side perspective view thereof.  
Broken lines are used in the drawings to illustrate features of  
the building extrusion that form no part of the claimed  
design. The building extrusion is shown with a symbolic  
break in its length. The appearance of any portion of the  
building extrusion between the break lines forms no part of  
the claimed design.

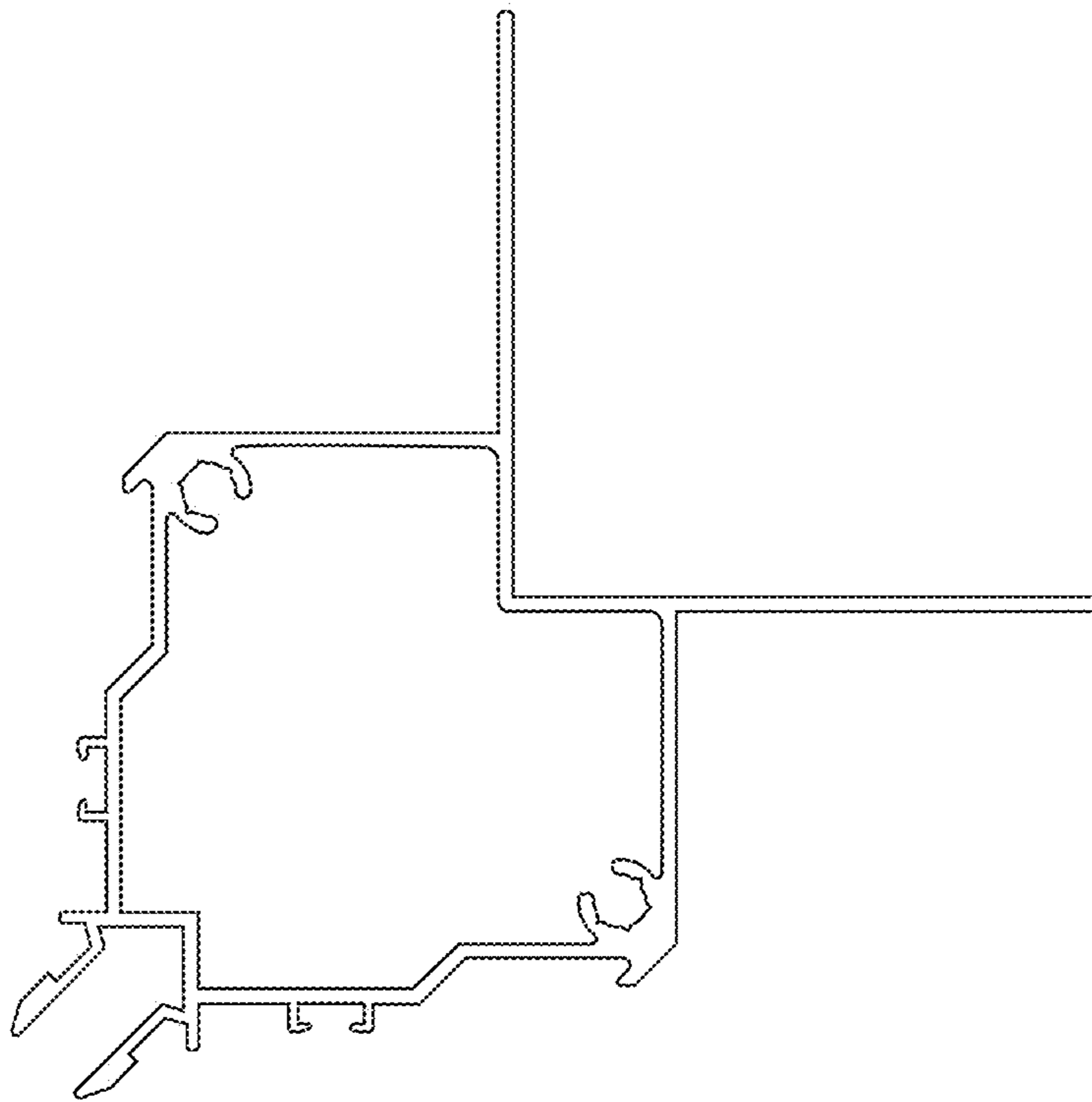

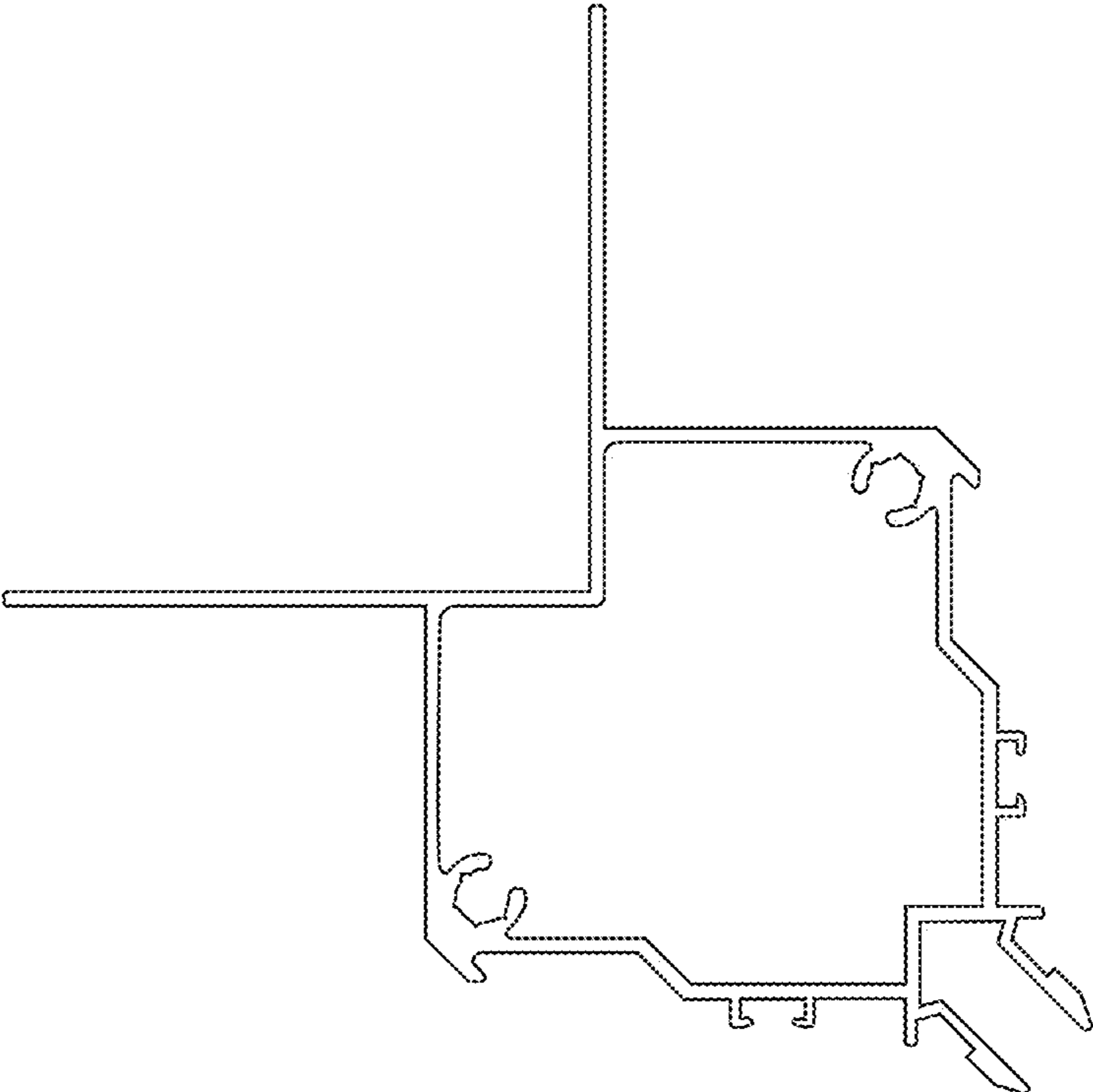

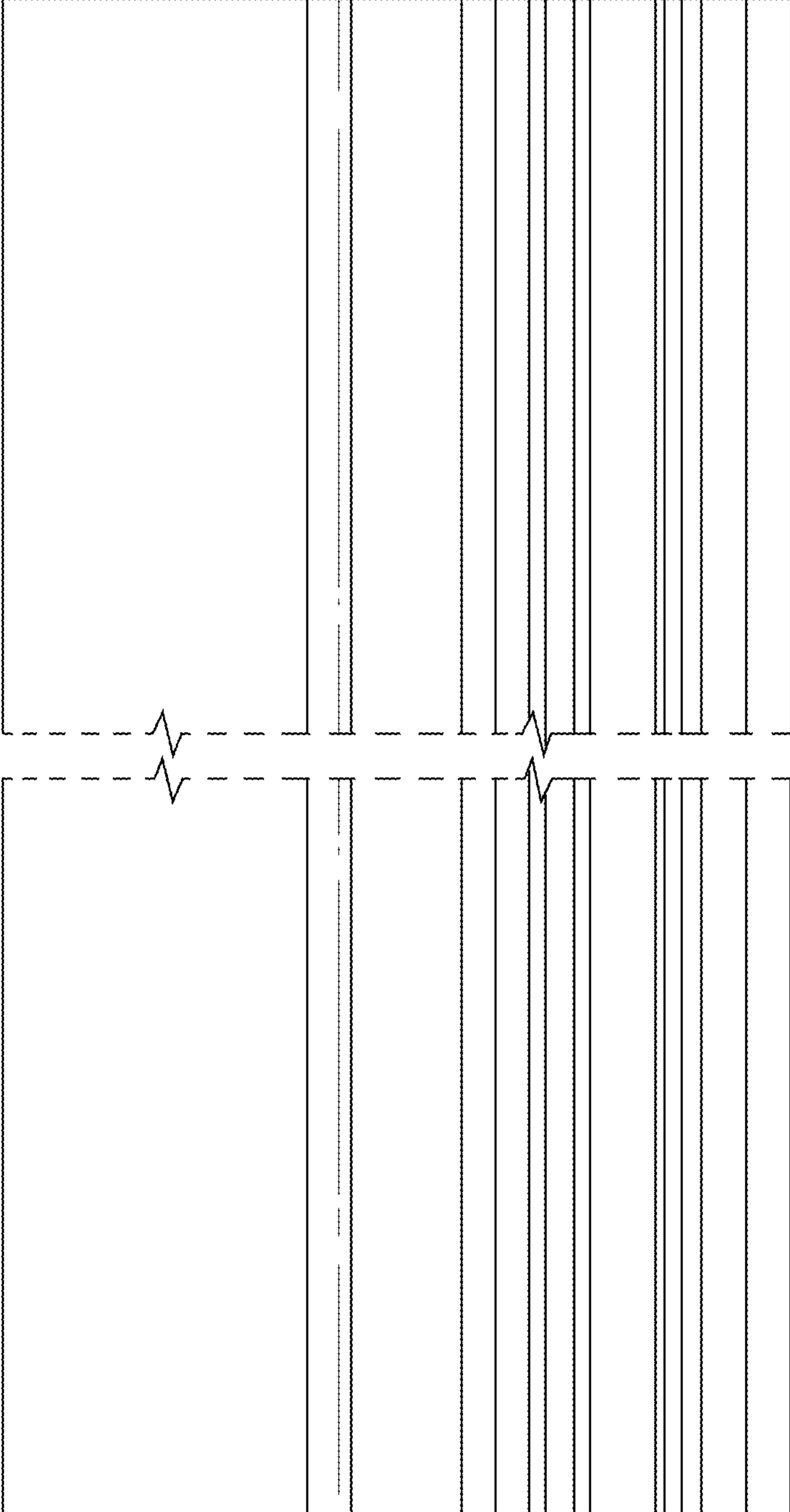

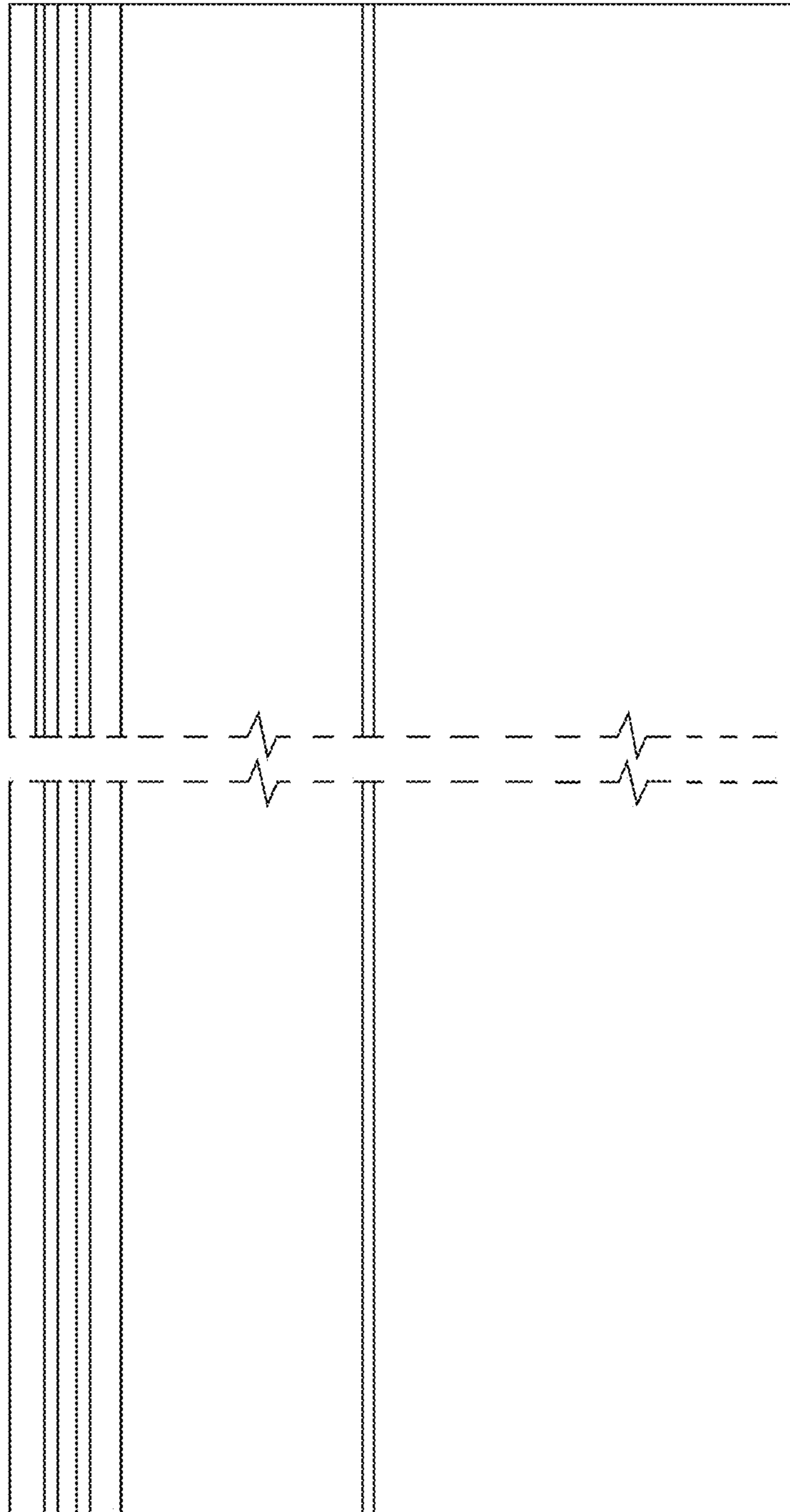

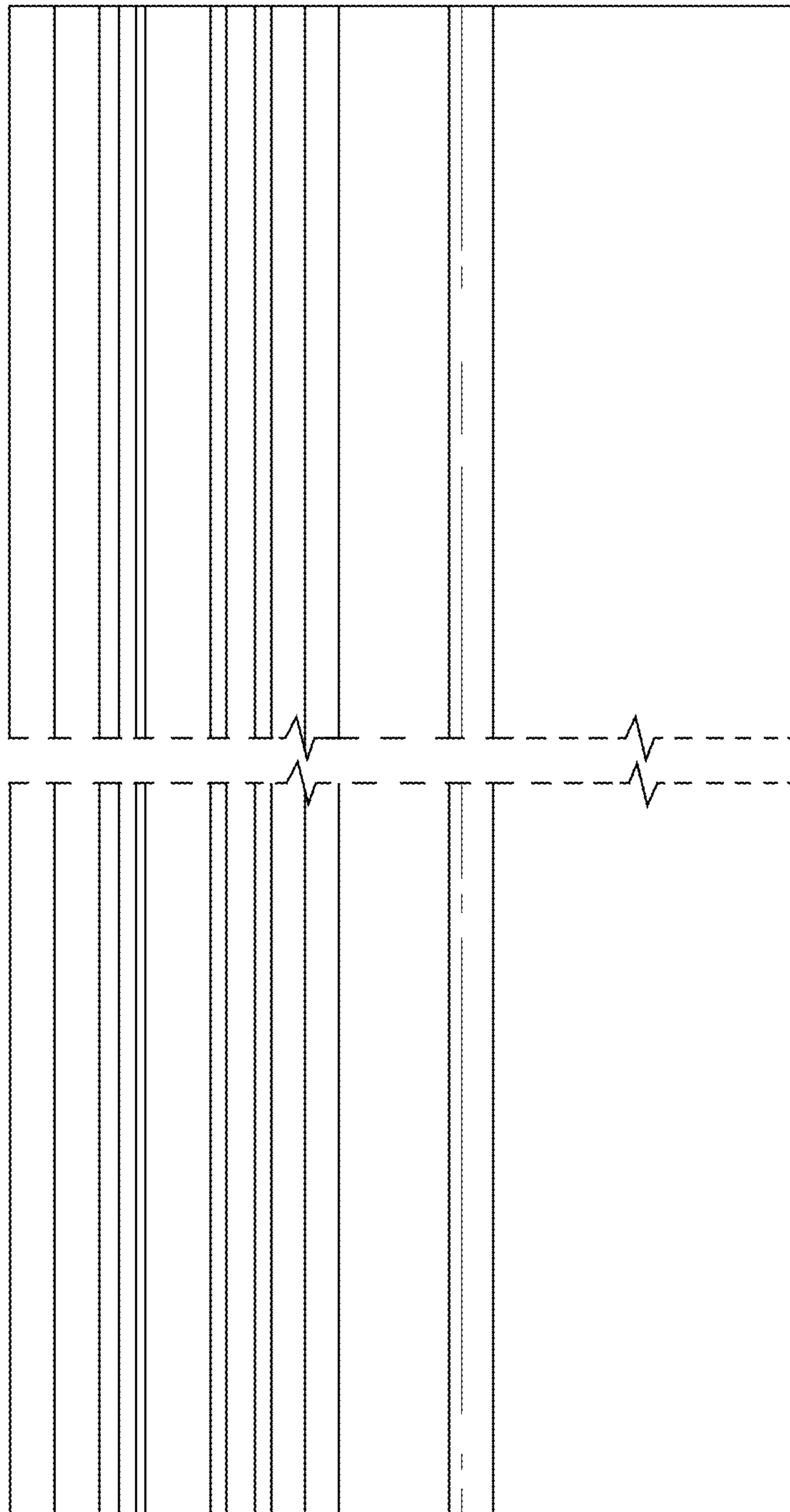

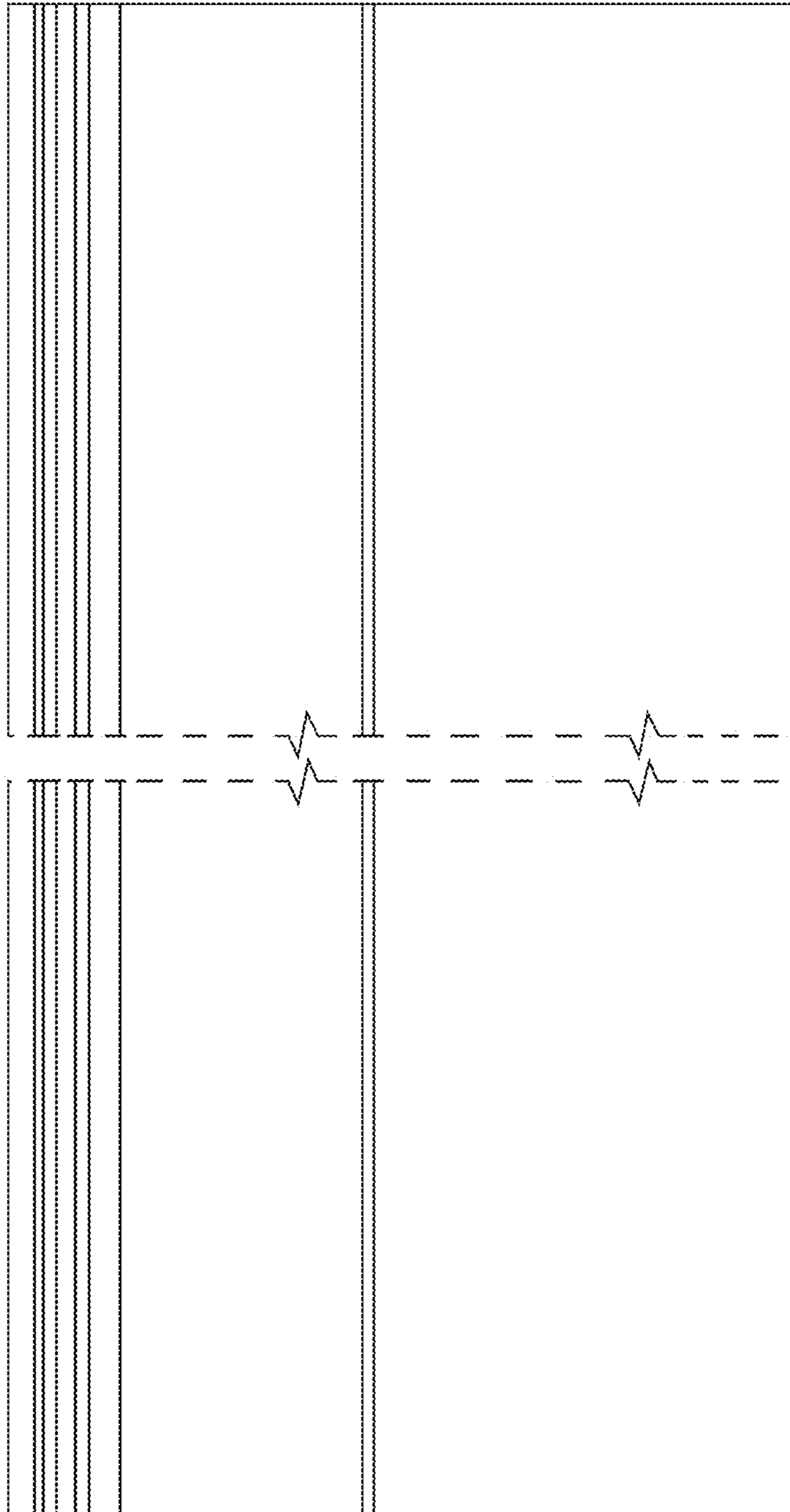

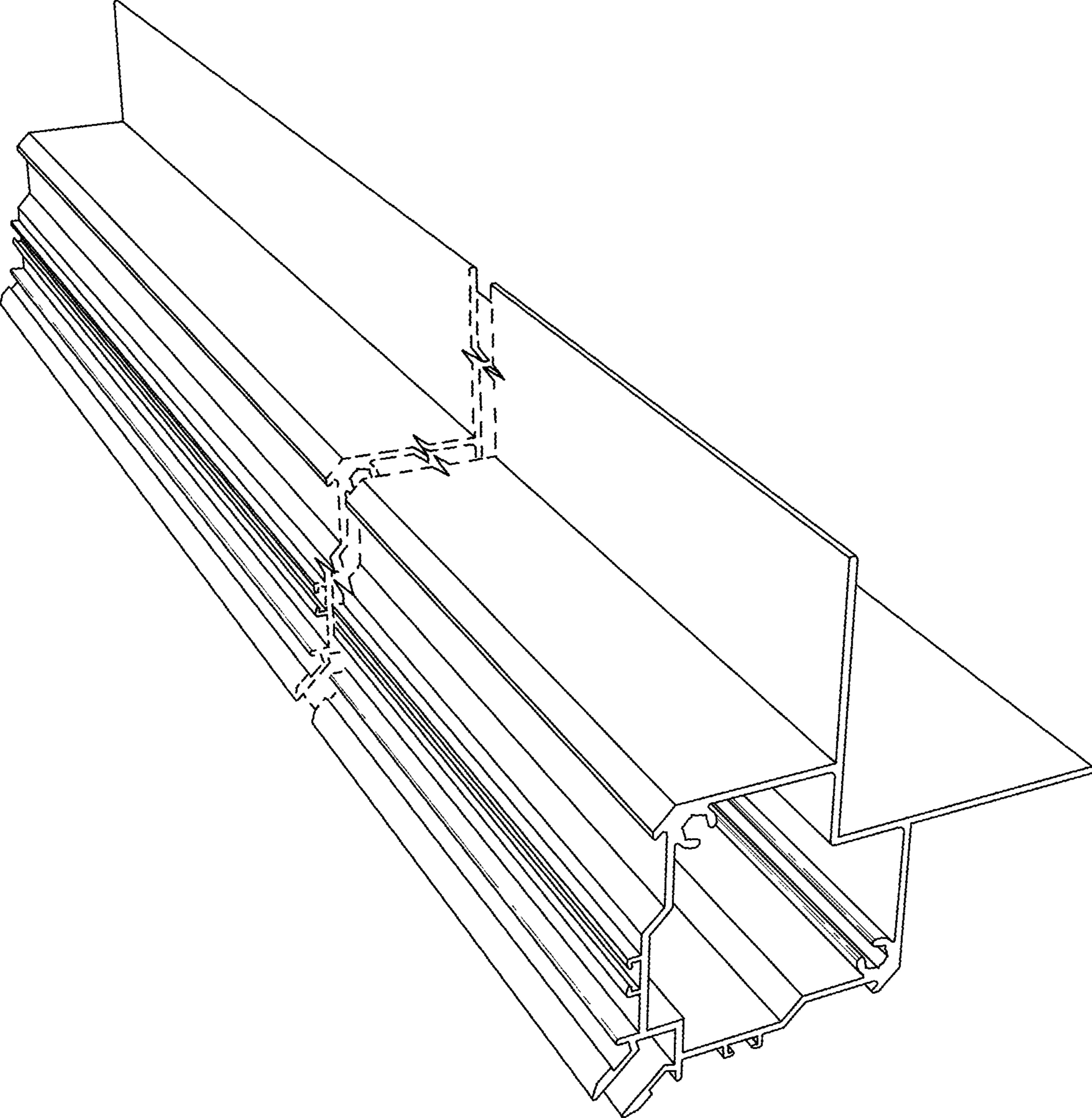
