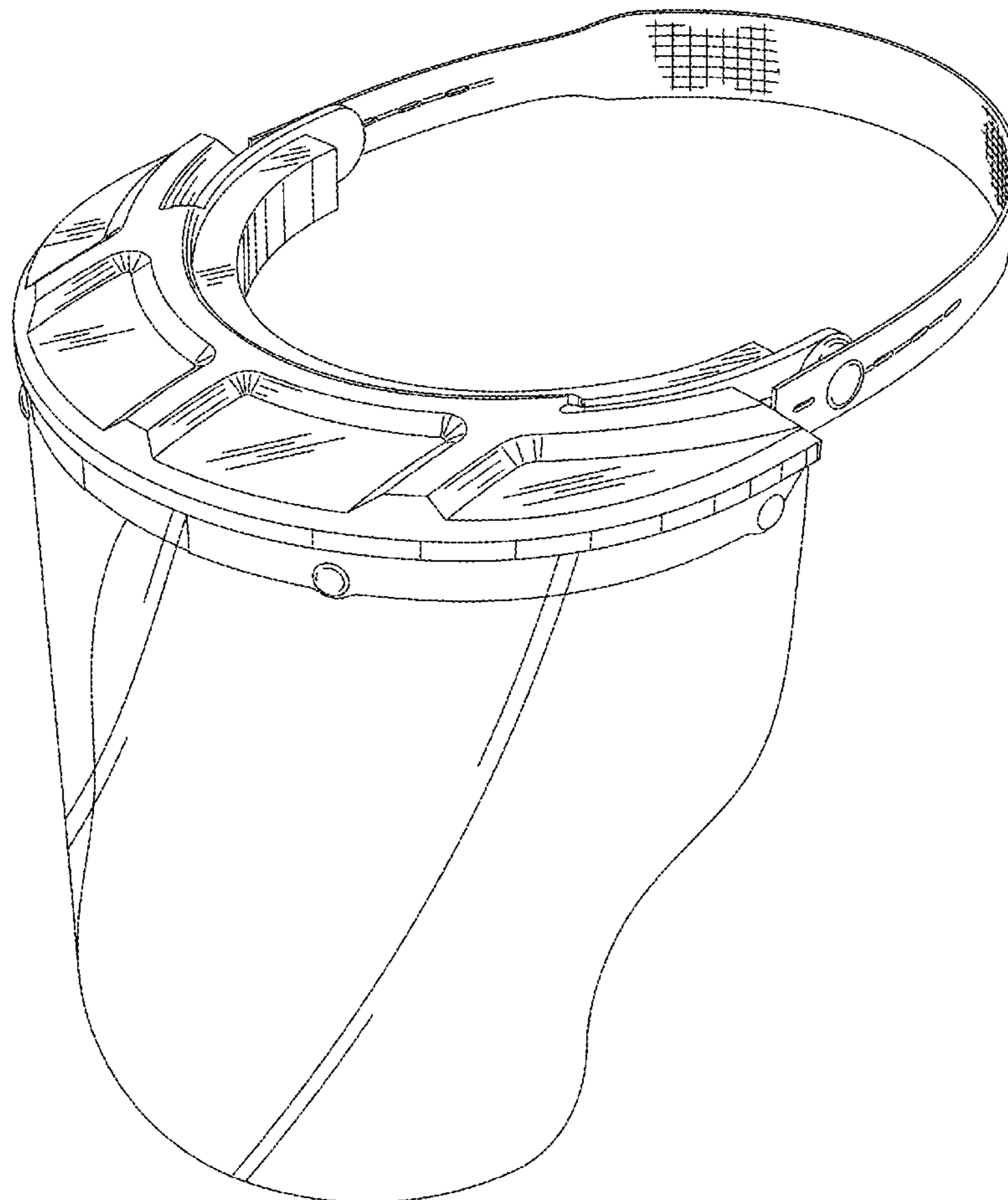

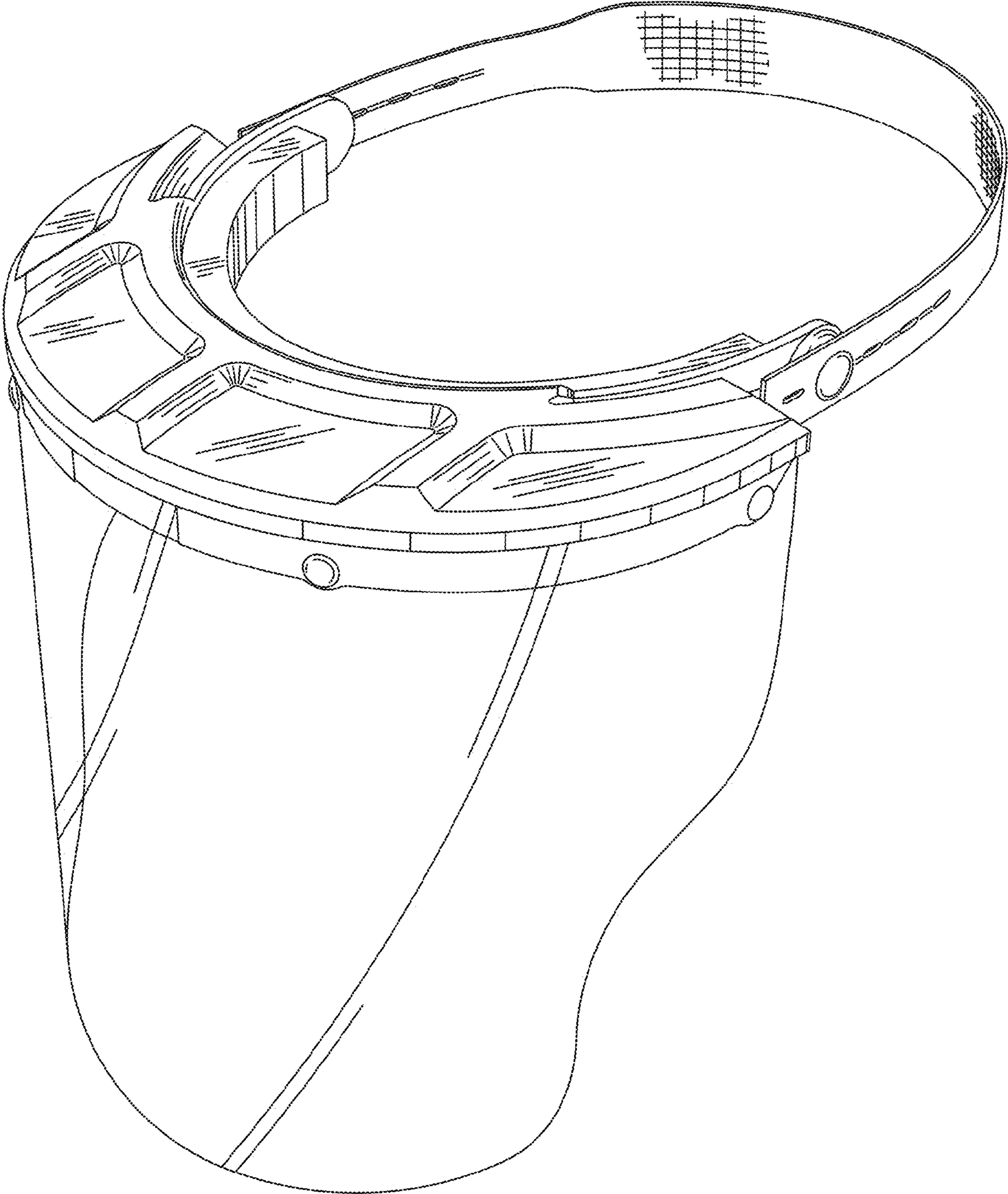
I claim the ornamental design for a face shield, as shown and described.

**DESCRIPTION**

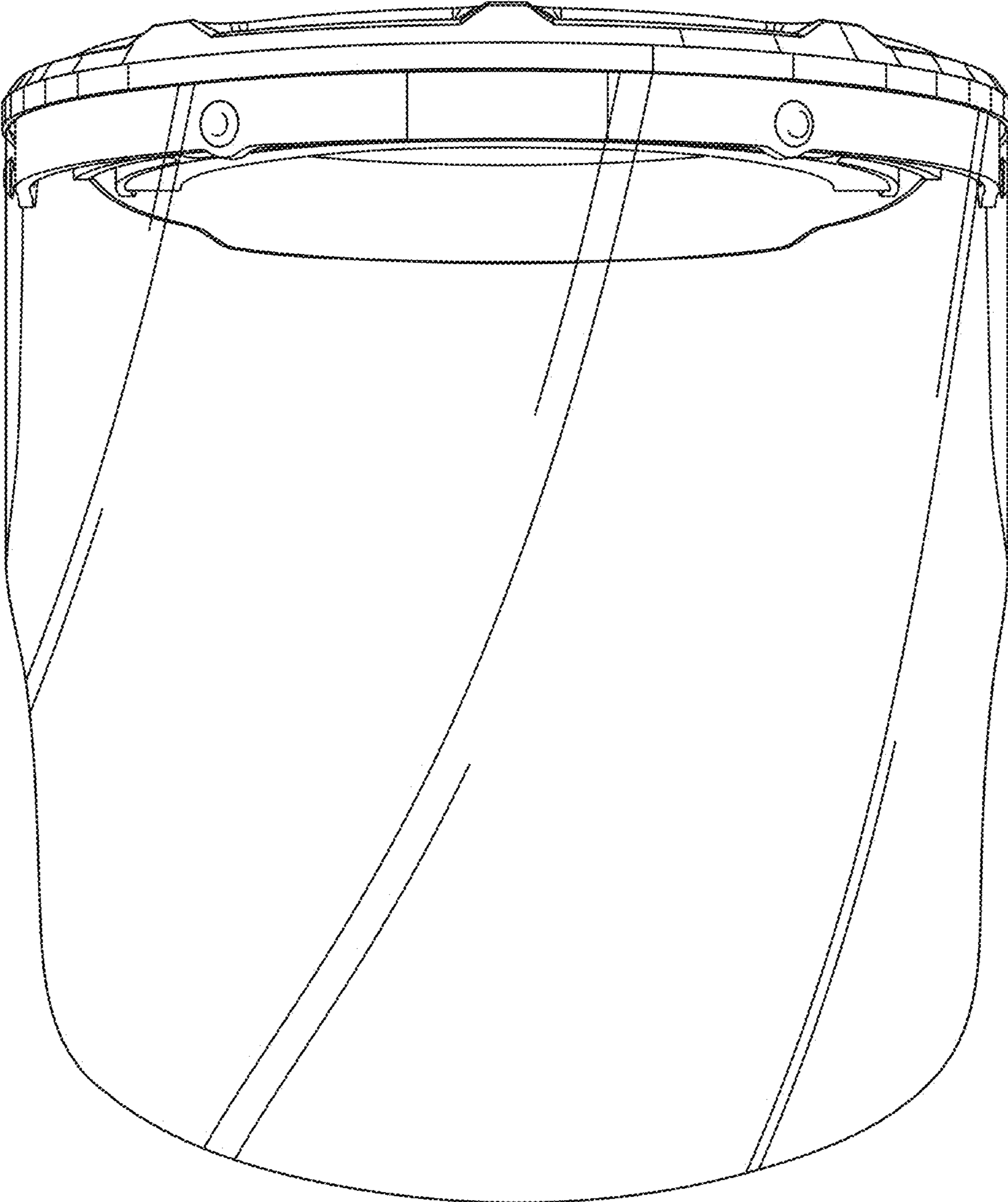
FIG. 1 is an isometric perspective view of a face shield;

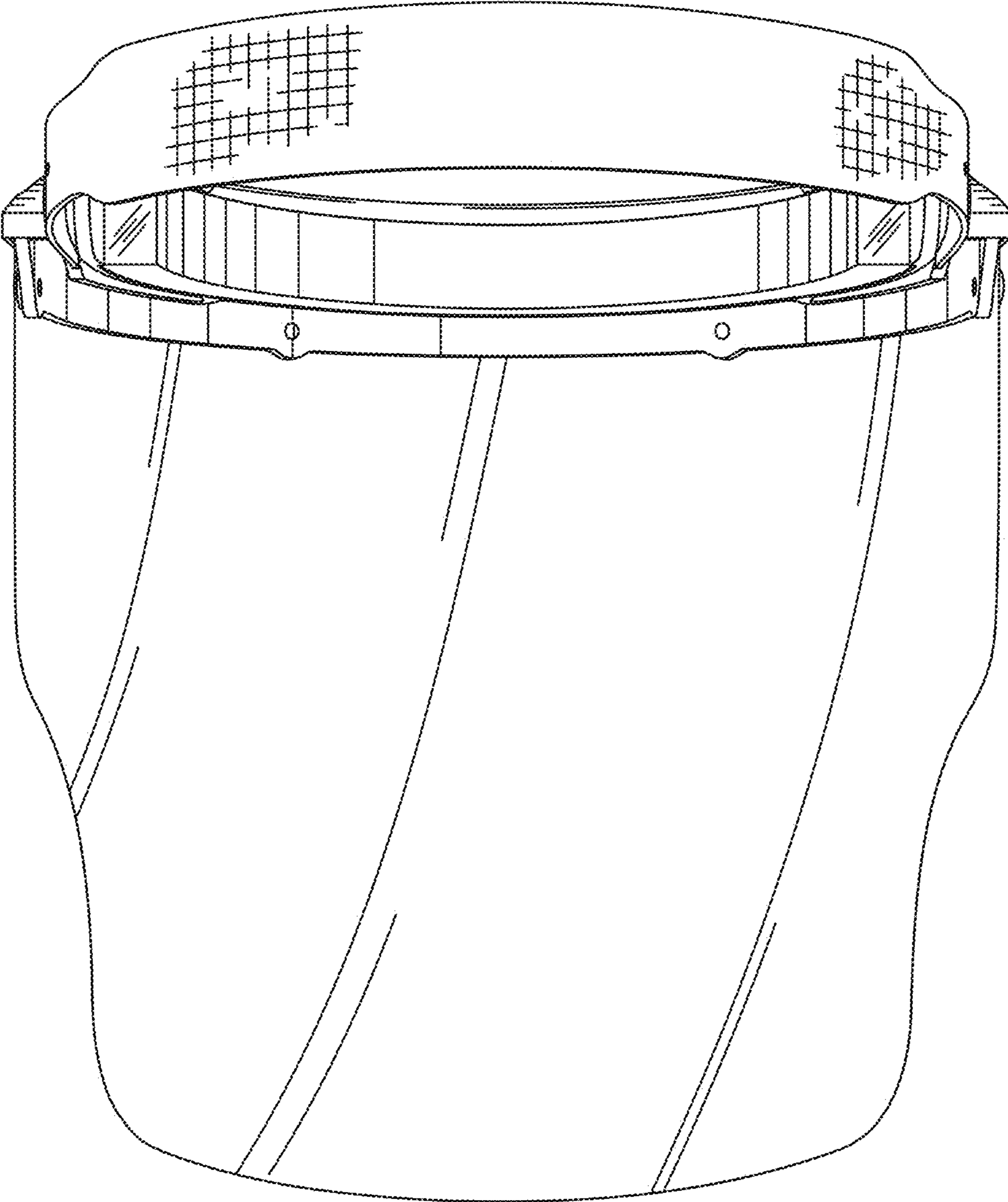




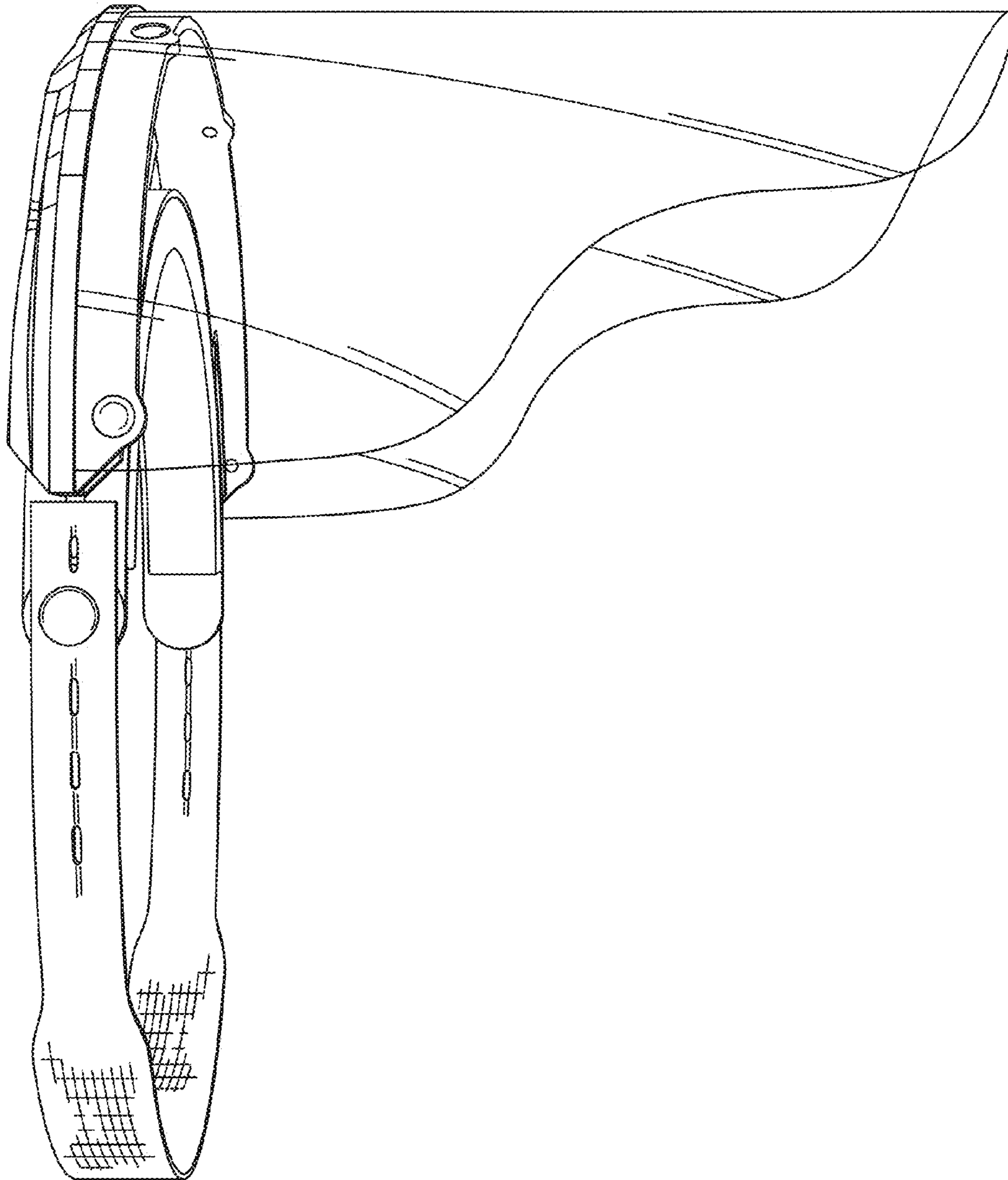

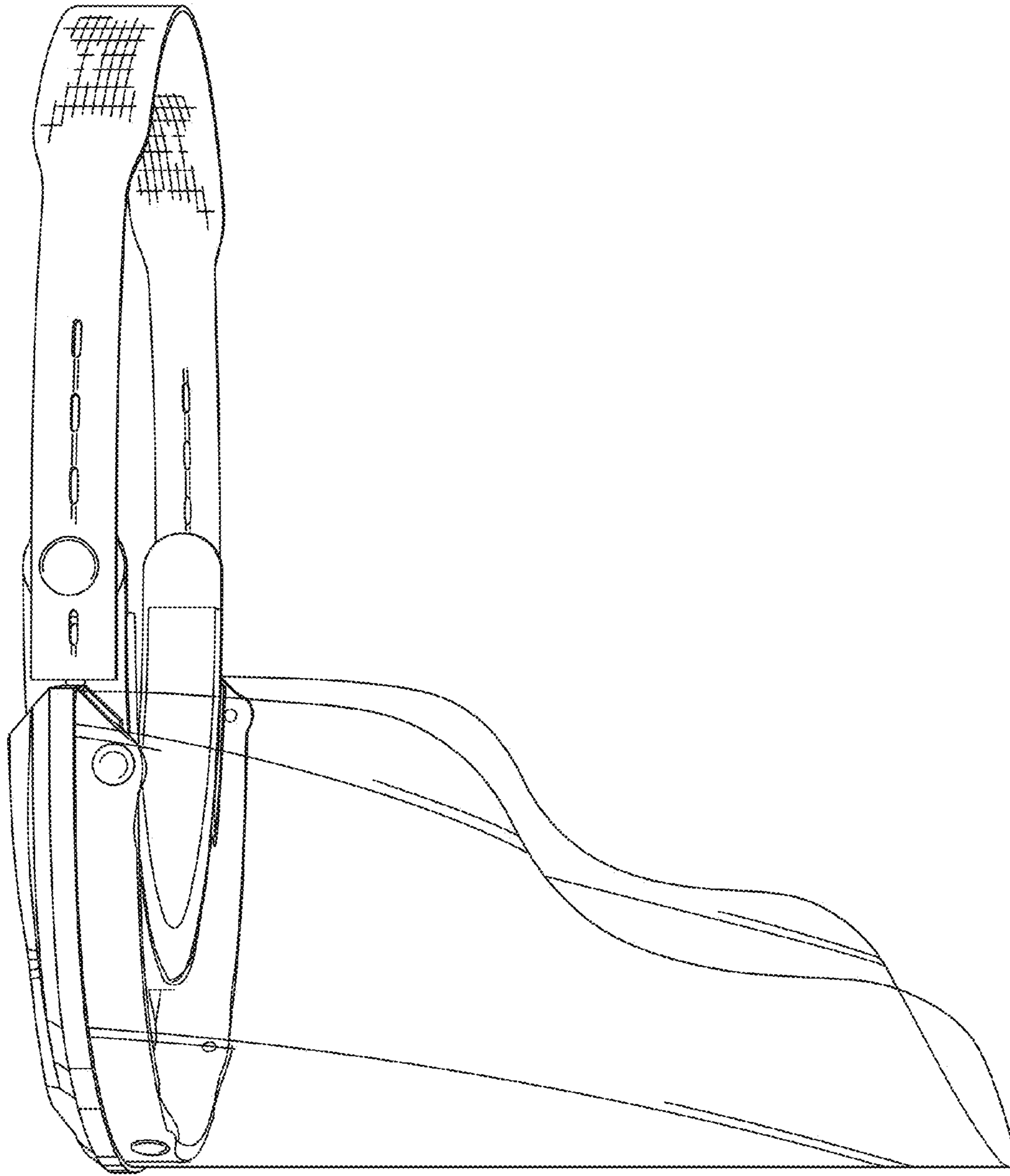

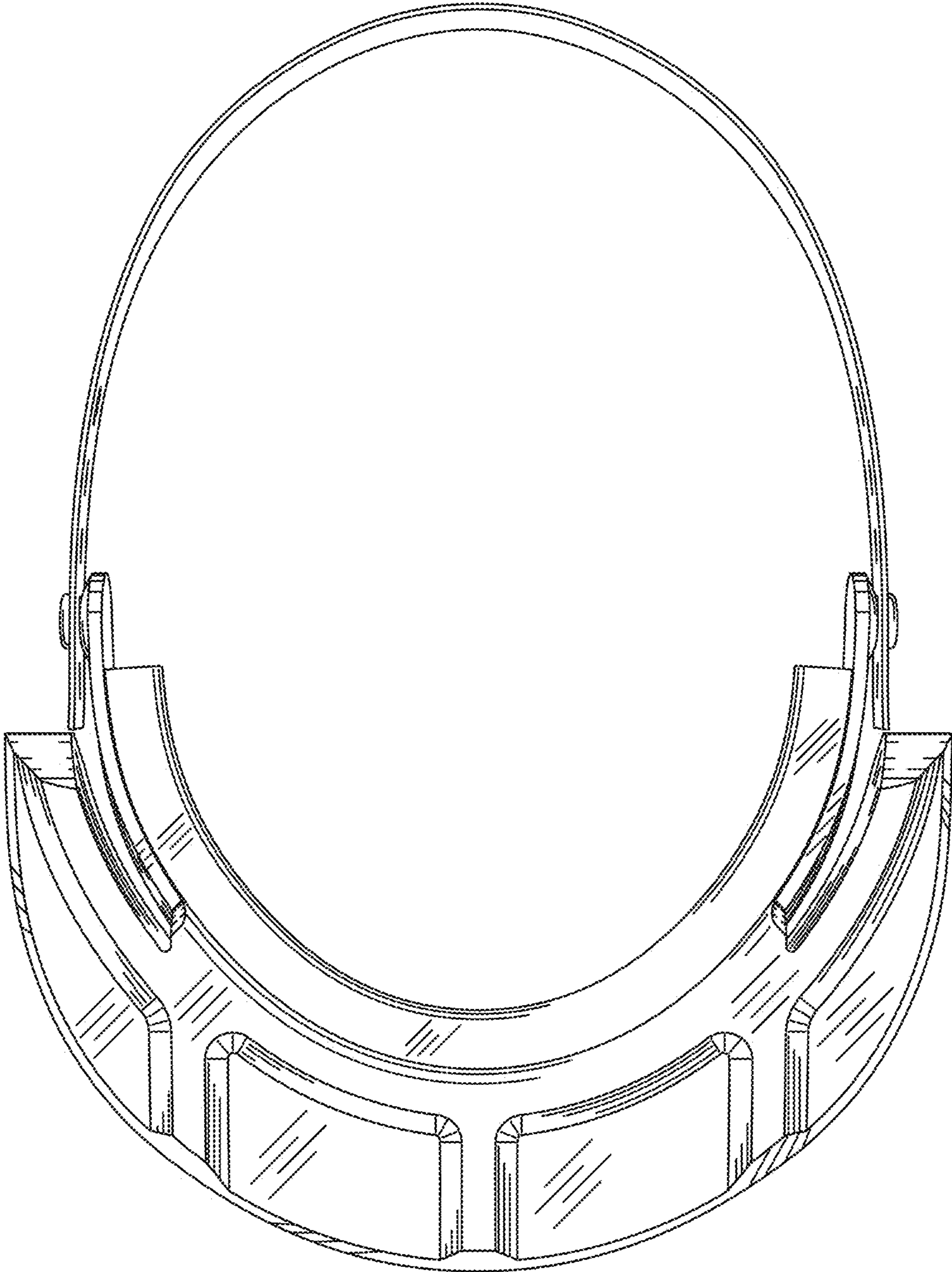

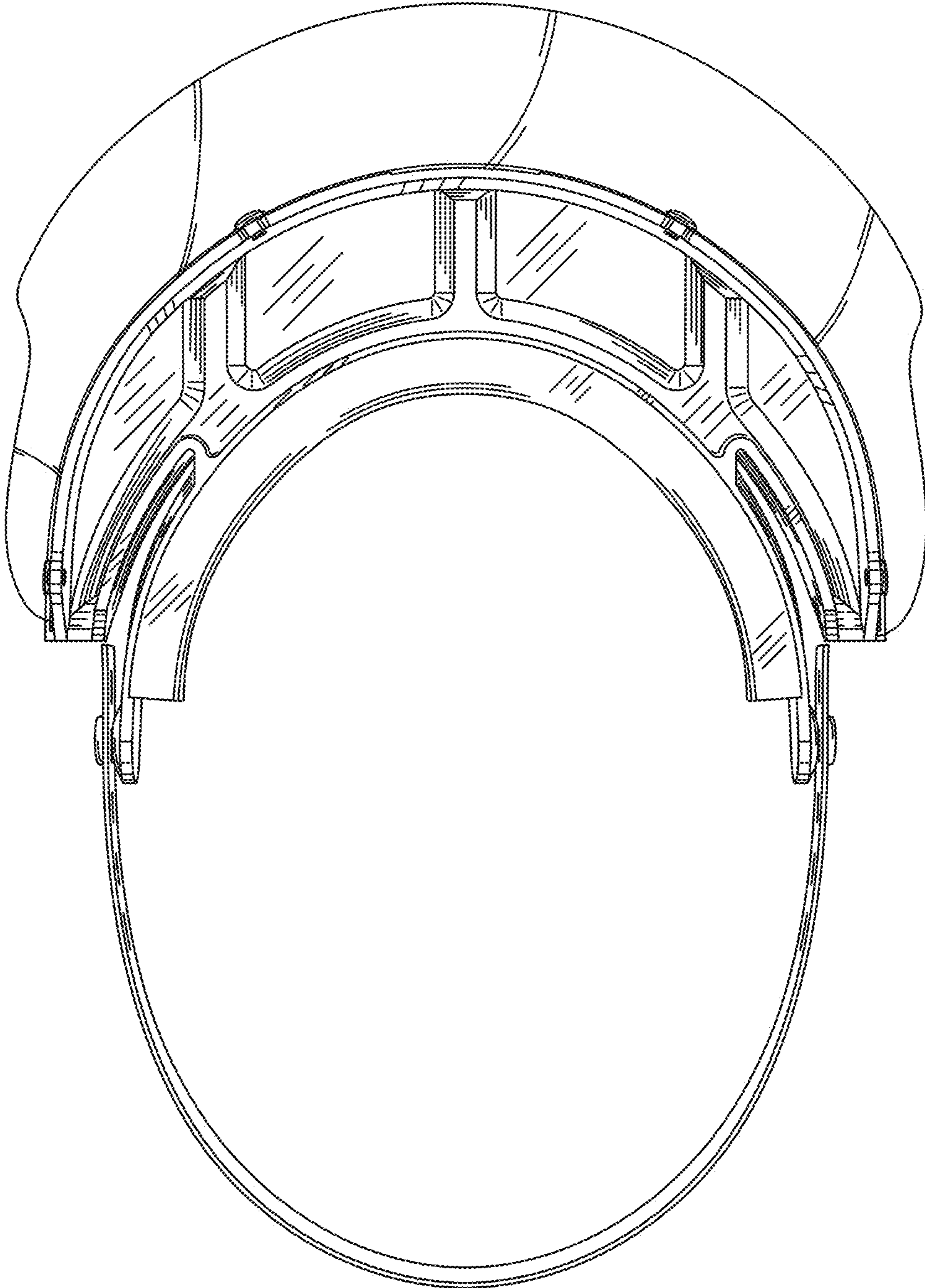
