(57) **CLAIM**

I claim the ornamental design for wrist grips for a baseball glove, as shown and described.

**DESCRIPTION**

FIG. 1 shows a top plan view of the wrist grips for a baseball glove according to the claimed design.

FIG. 2 shows a perspective view of the wrist grips.

FIG. 3 shows a top plan view of the wrist grips; the bottom plan view being a mirror image thereof.

FIG. 4 shows a left-side plan view of the left wrist grip; the right-side plan view of the right wrist grip is a mirror image thereof.

FIG. 5 shows a right-side plan view of the left wrist grip; the left-side plan view of the right wrist grip is a mirror image thereof; and,

FIG. 6 shows a front plan view of the wrist grips.

The broken lines illustrate portions of a baseball glove that form no part of the claimed design.

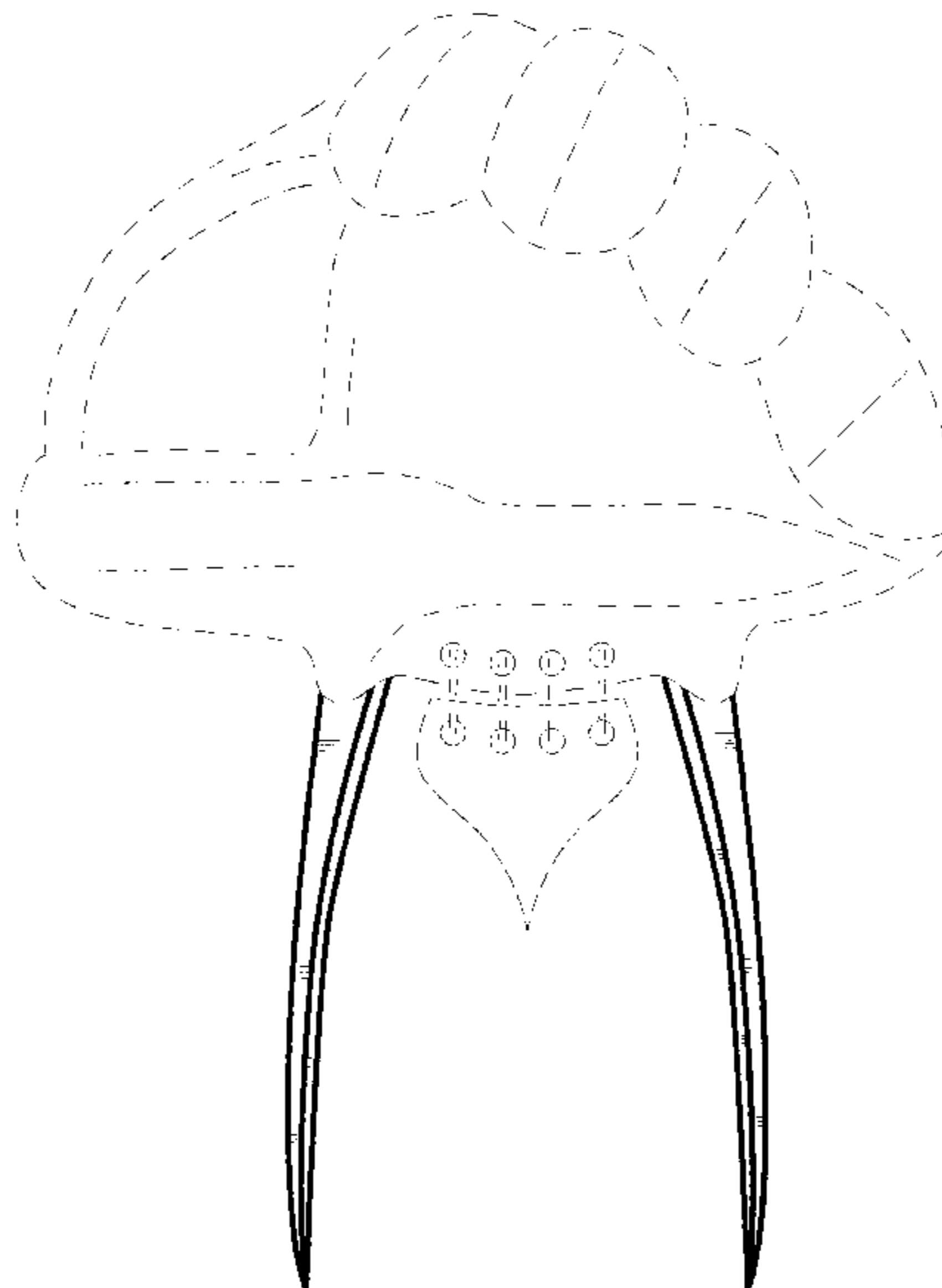

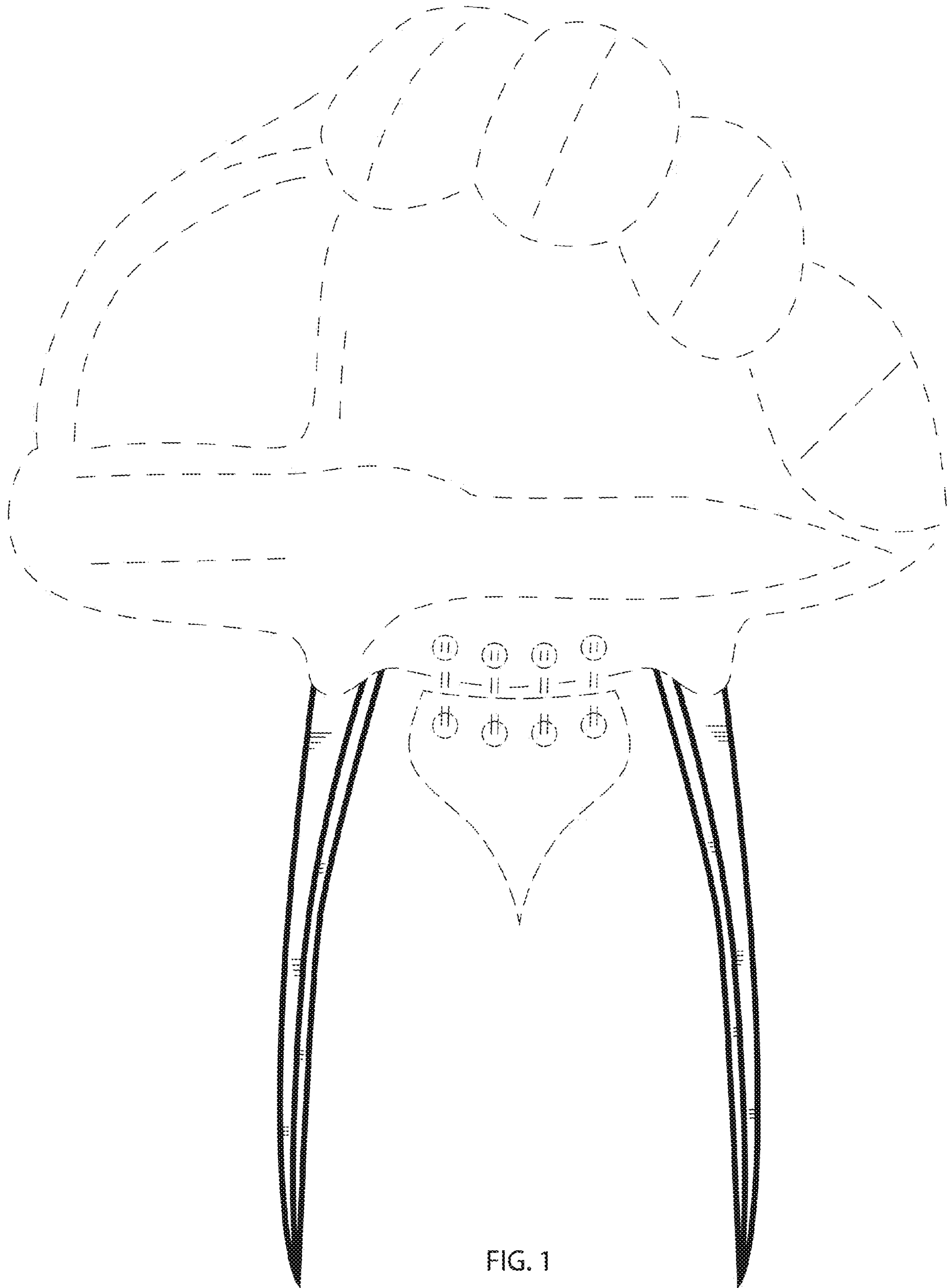

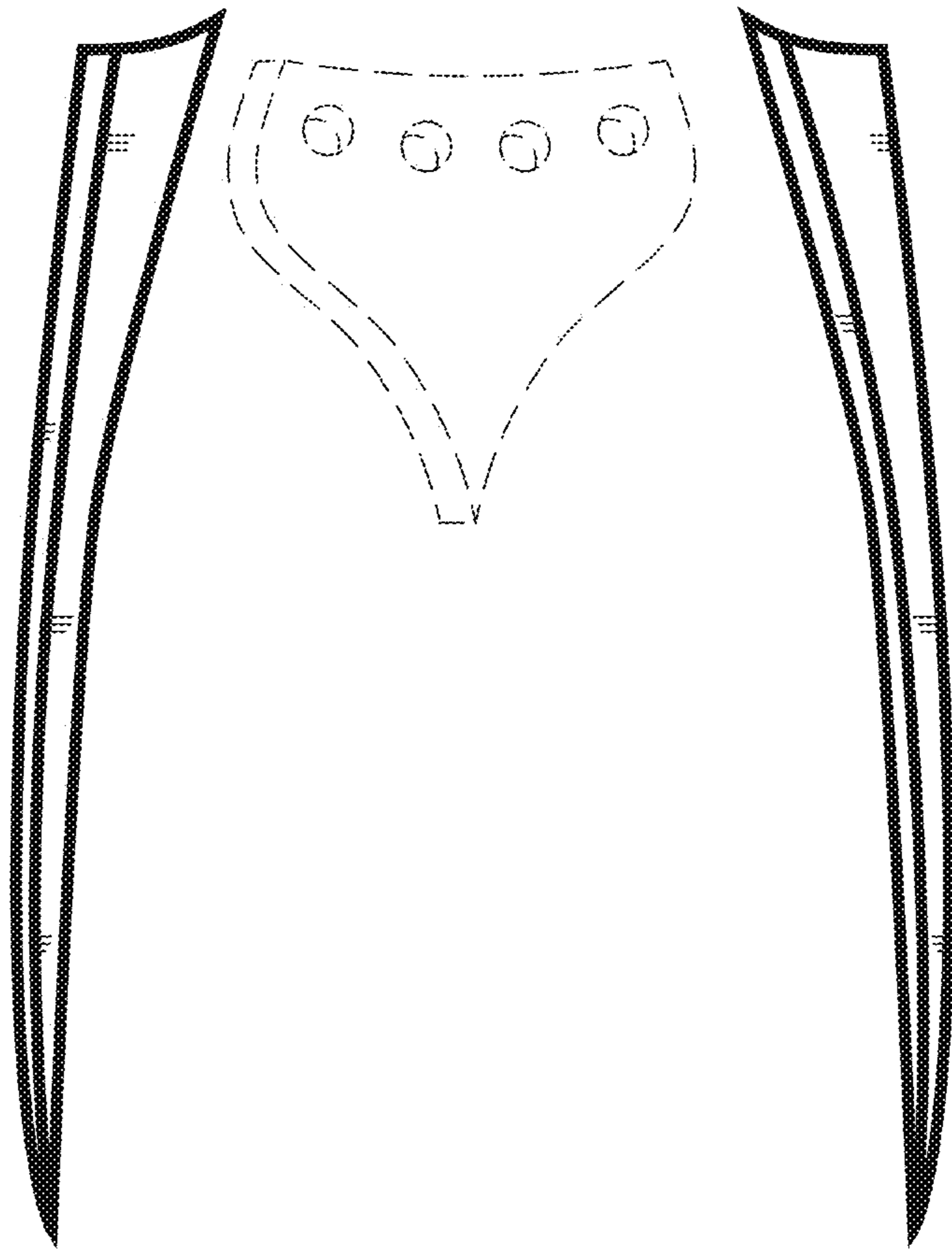

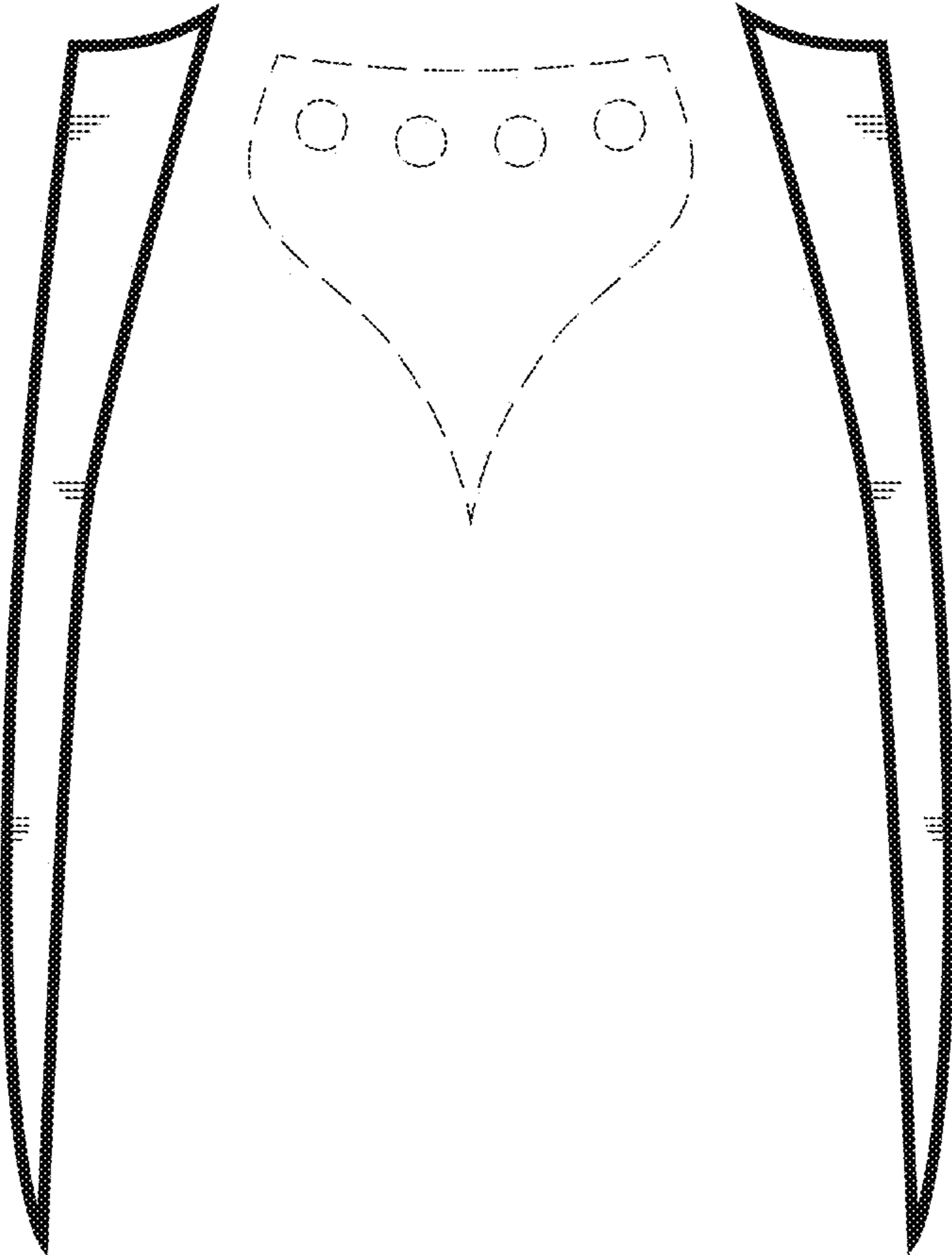

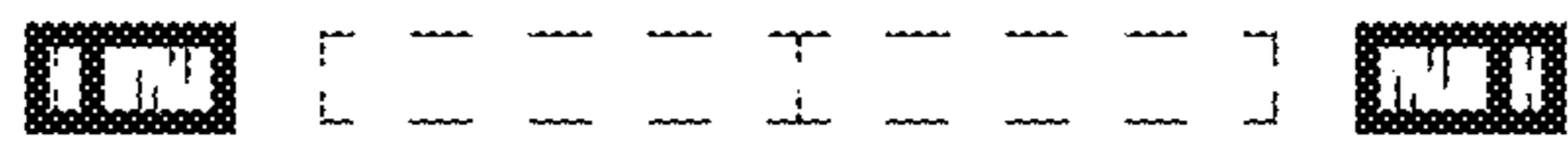
