(57) **CLAIM**

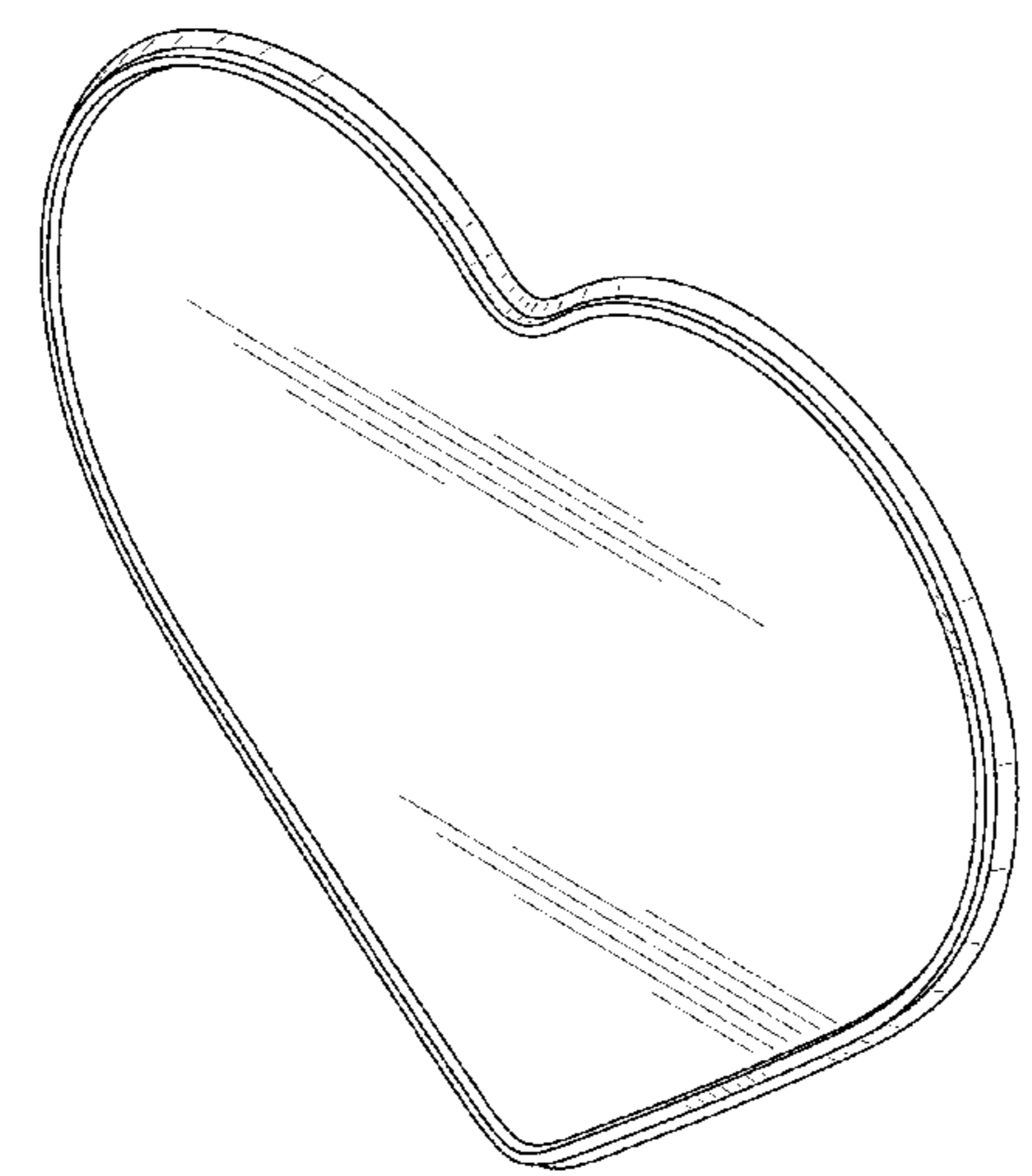
I claim the ornamental design for a dog bowl mat, as shown and described.

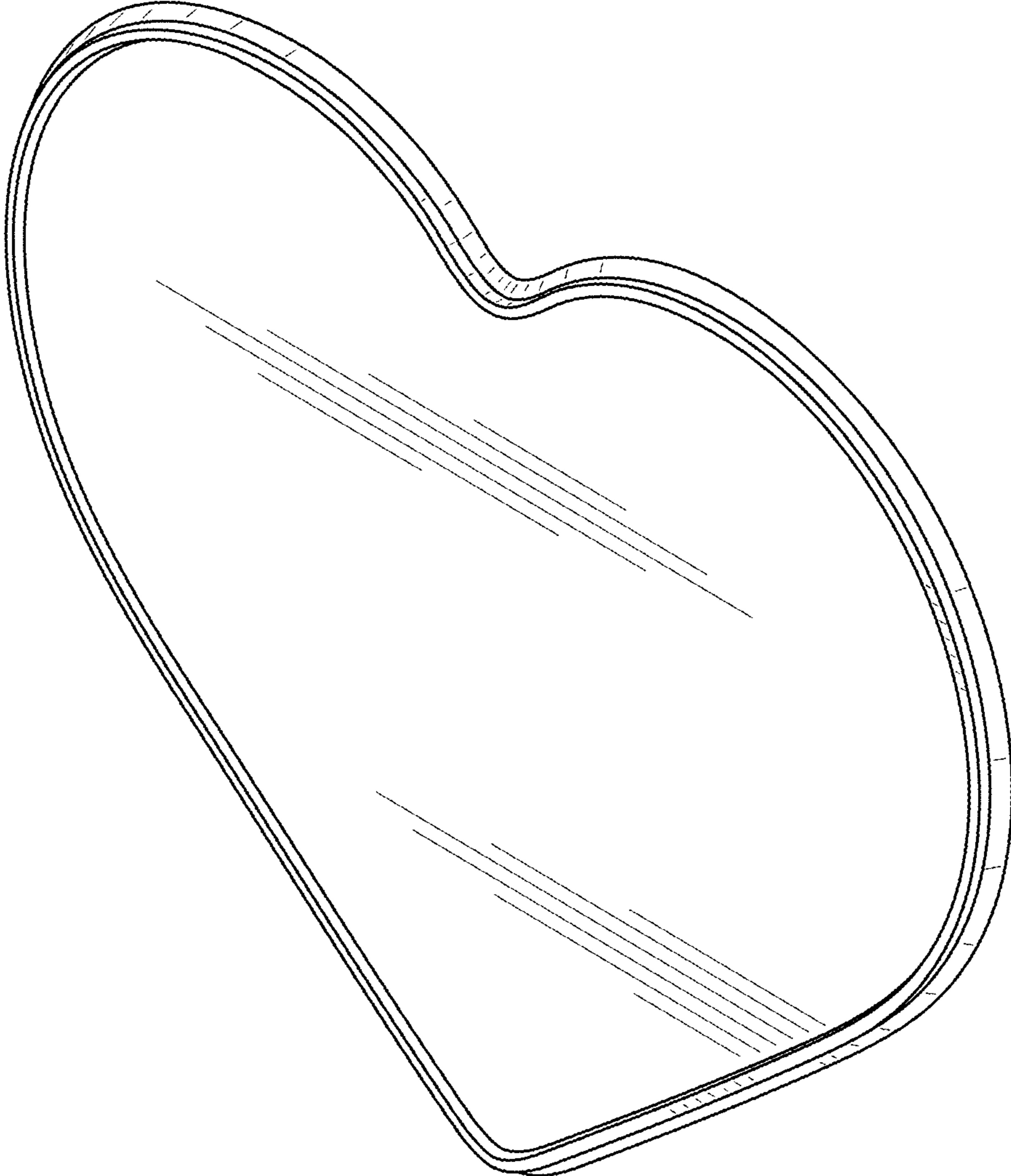

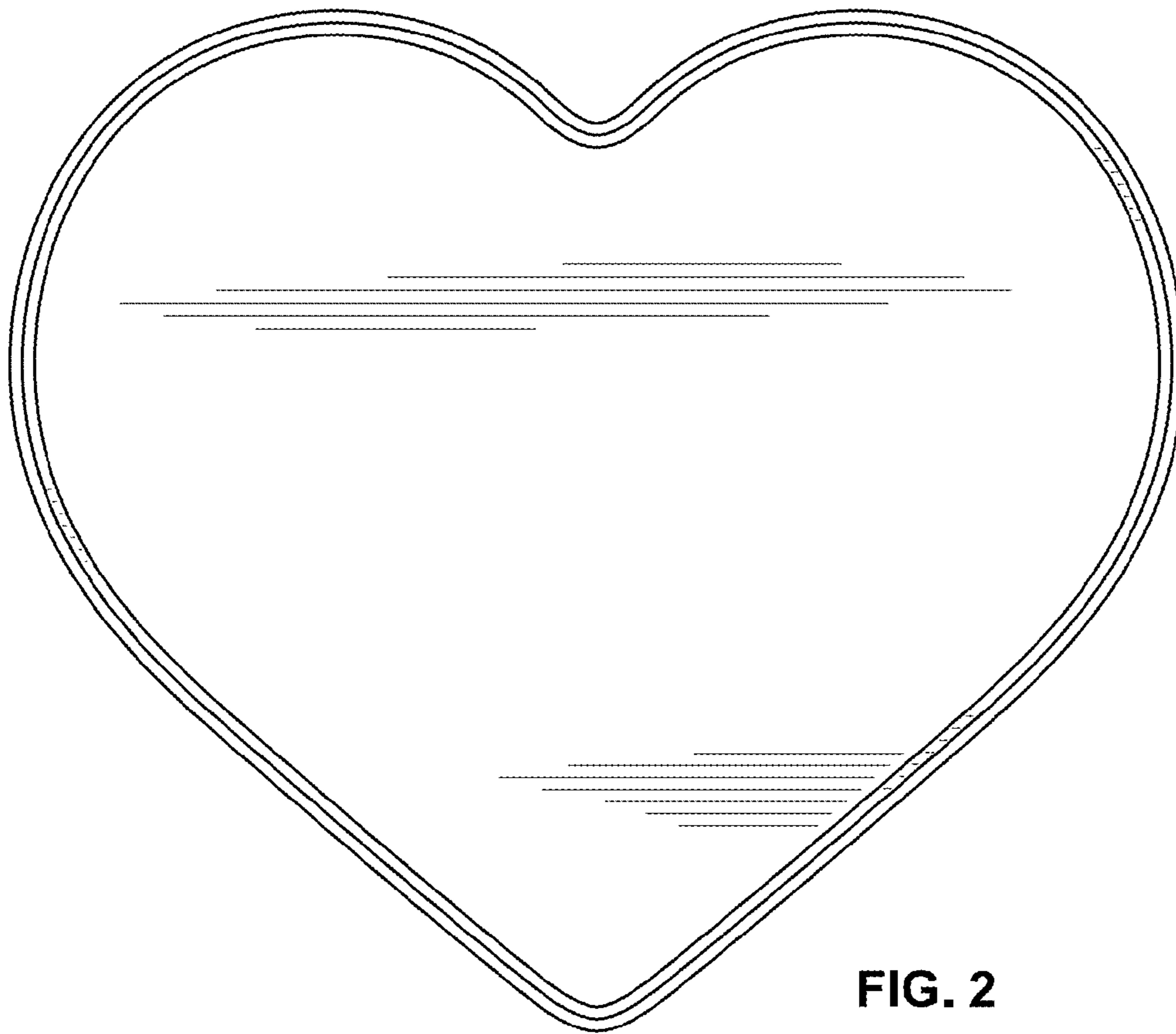

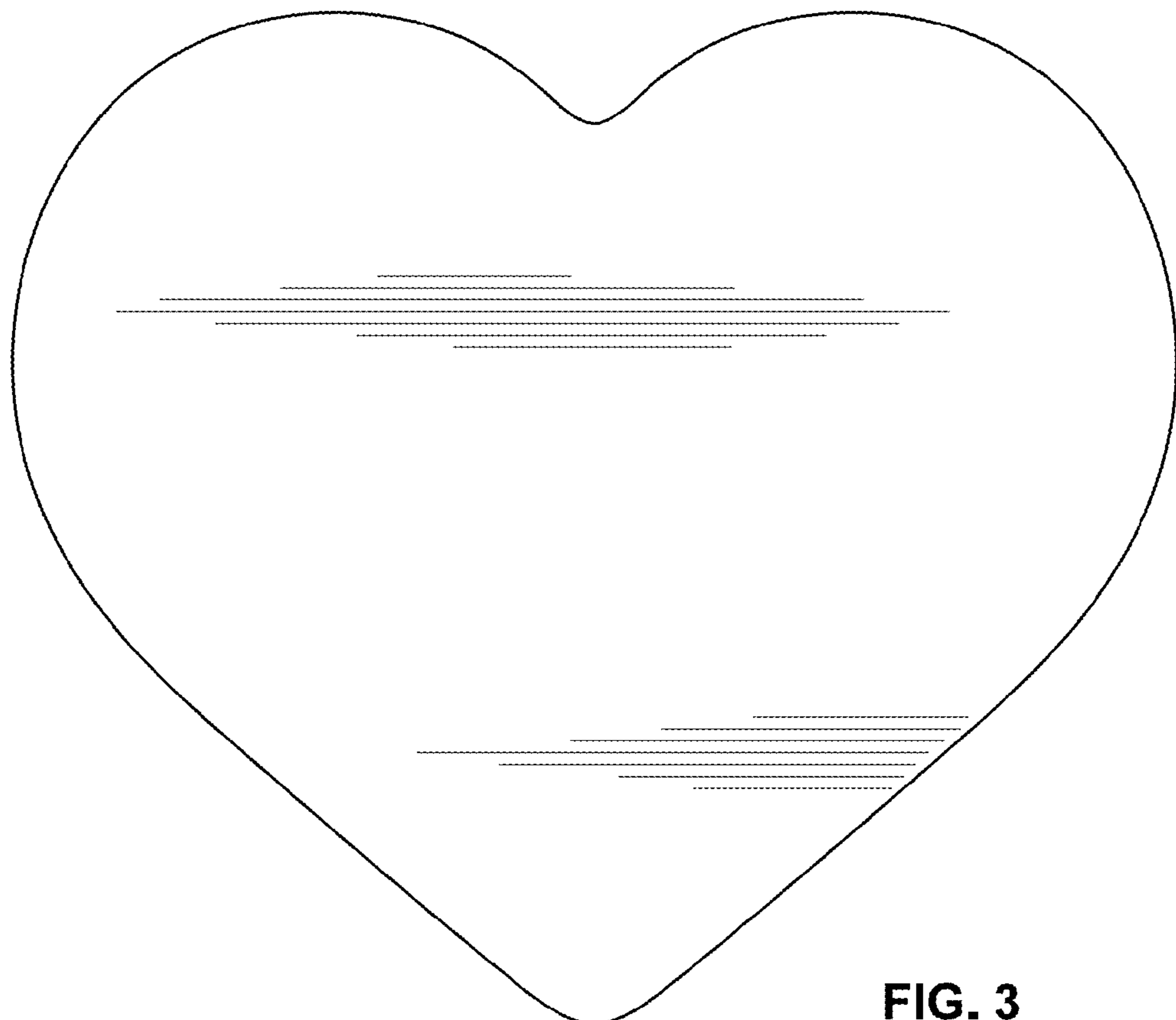

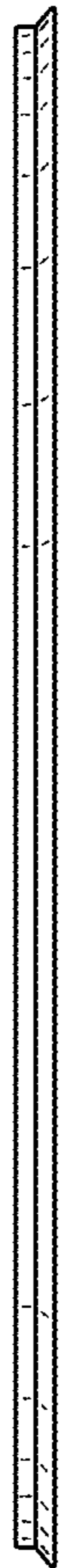

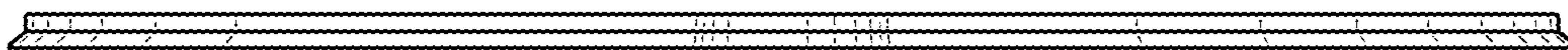
