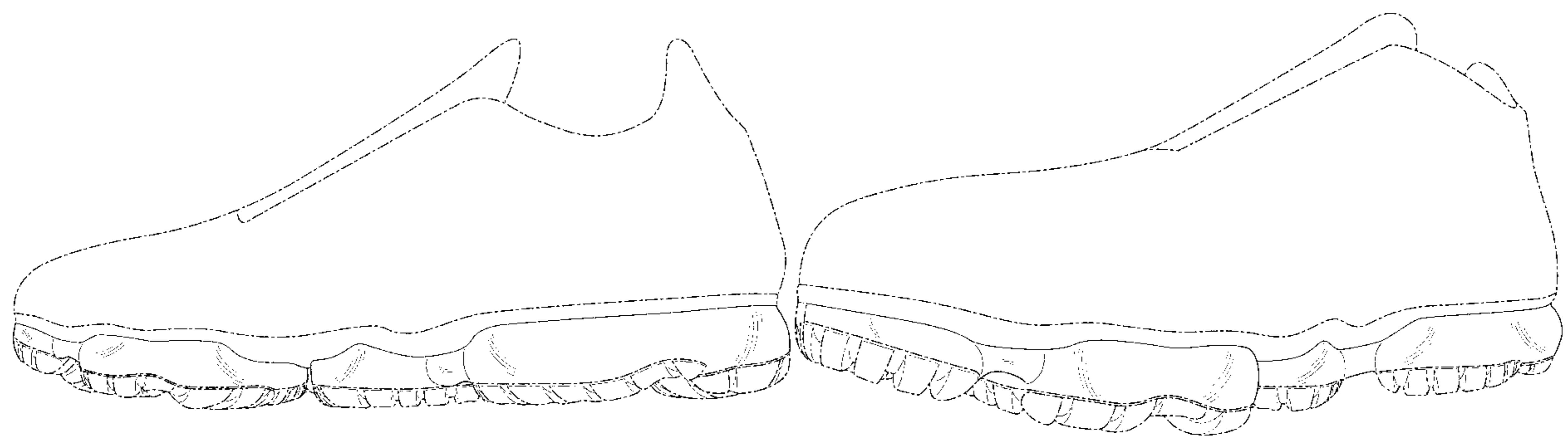

(57) **CLAIM**
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a front perspective view thereof; and, FIG. 3 is a rear perspective view thereof. The broken lines immediately adjacent to the front end, rear end, and bottom of the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

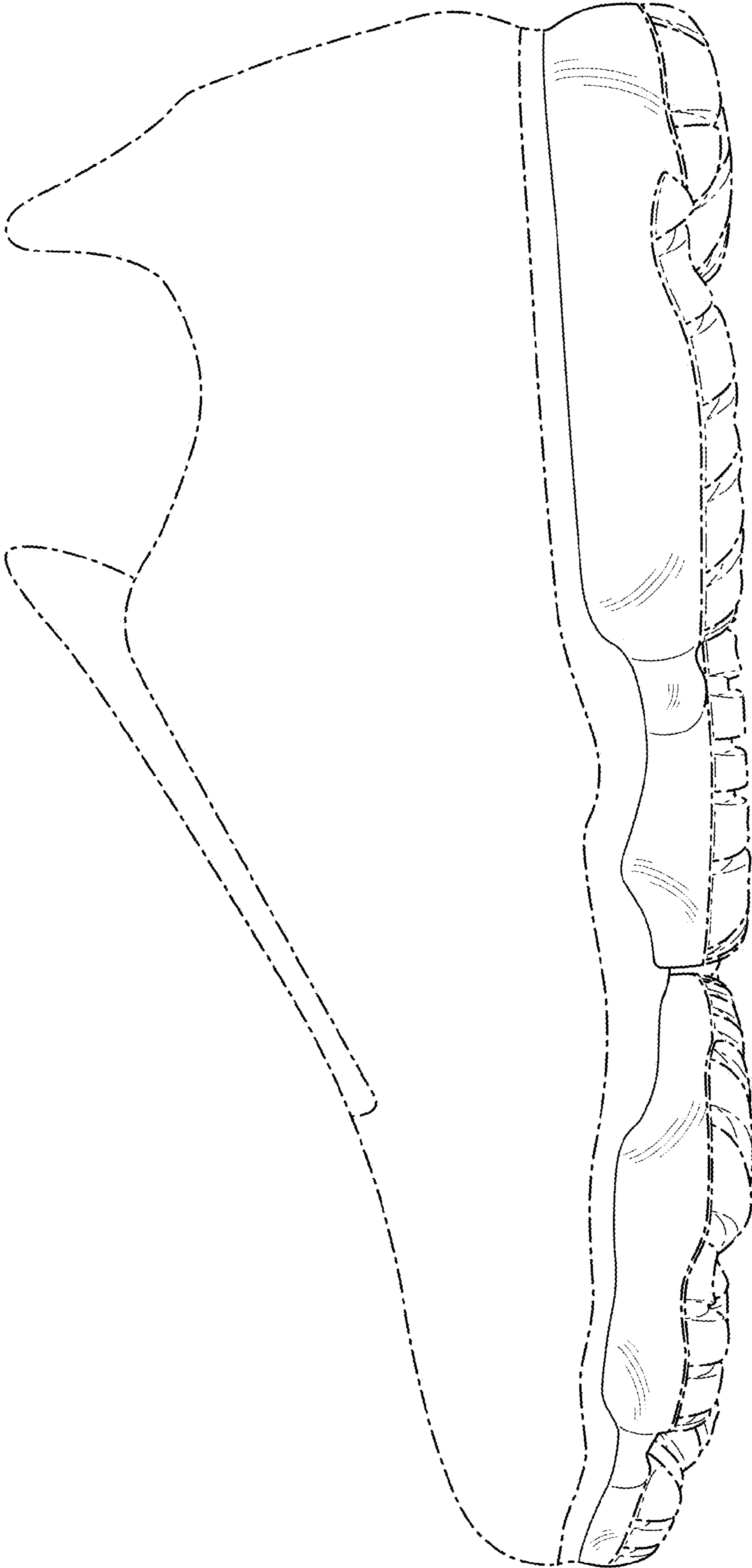

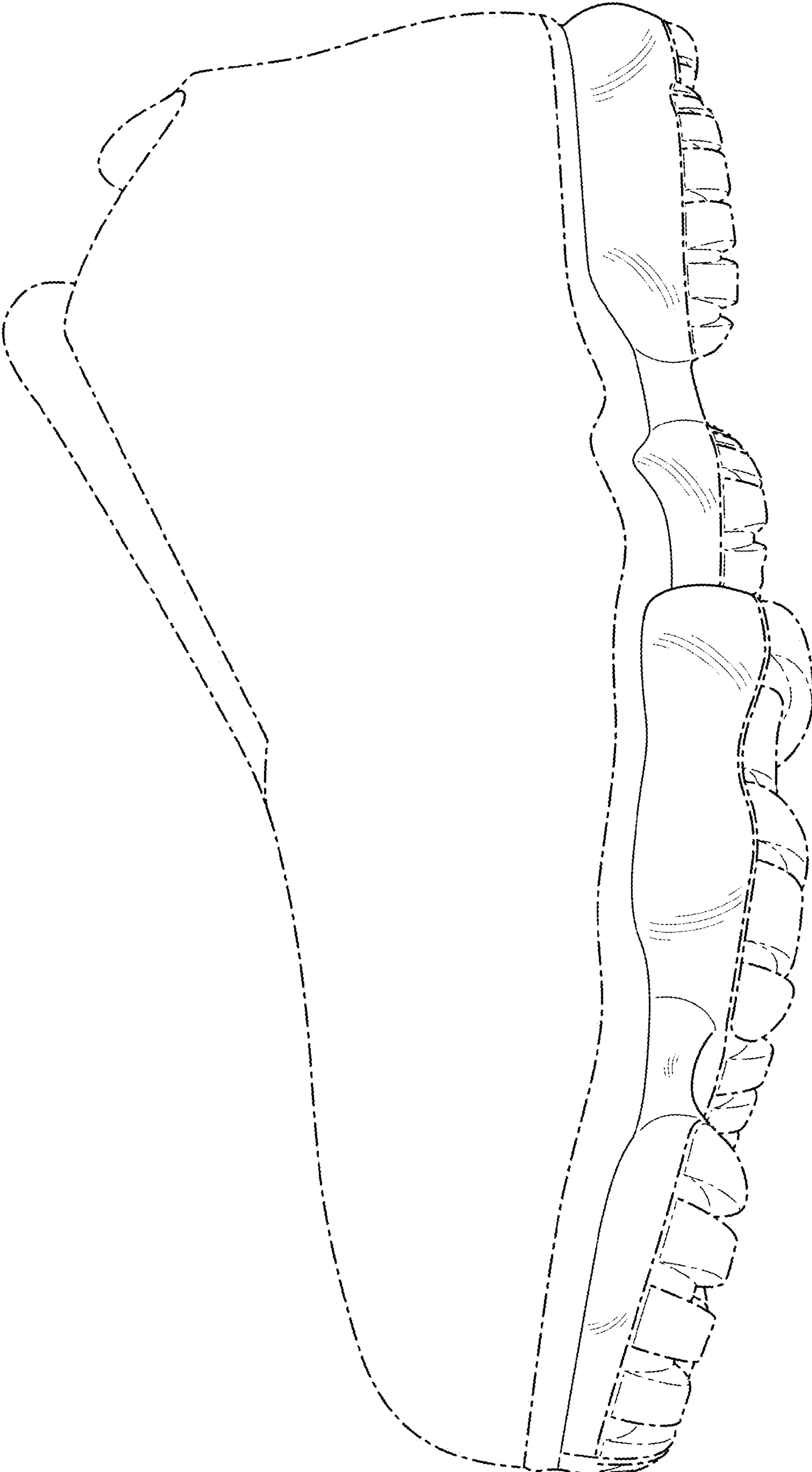

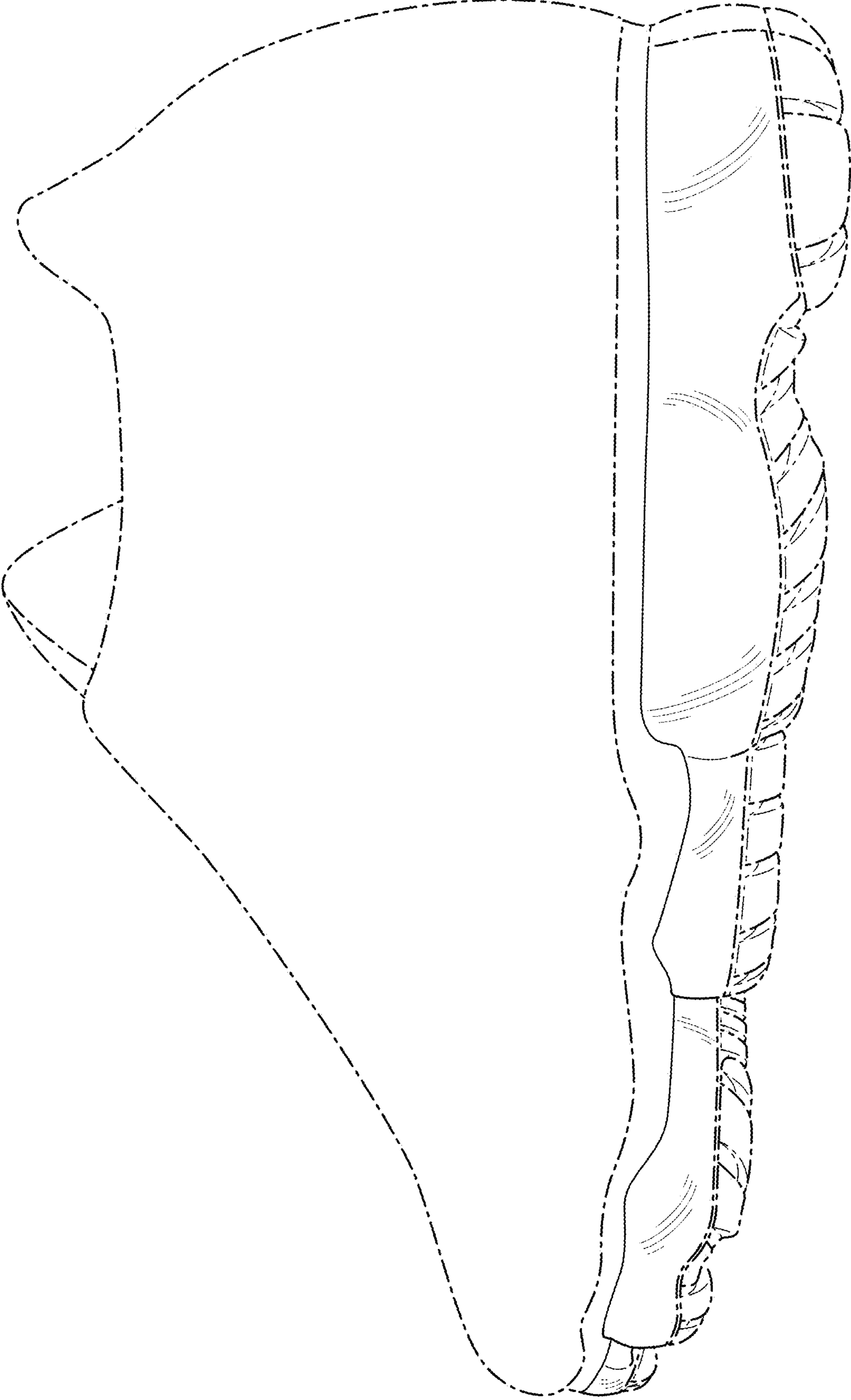
