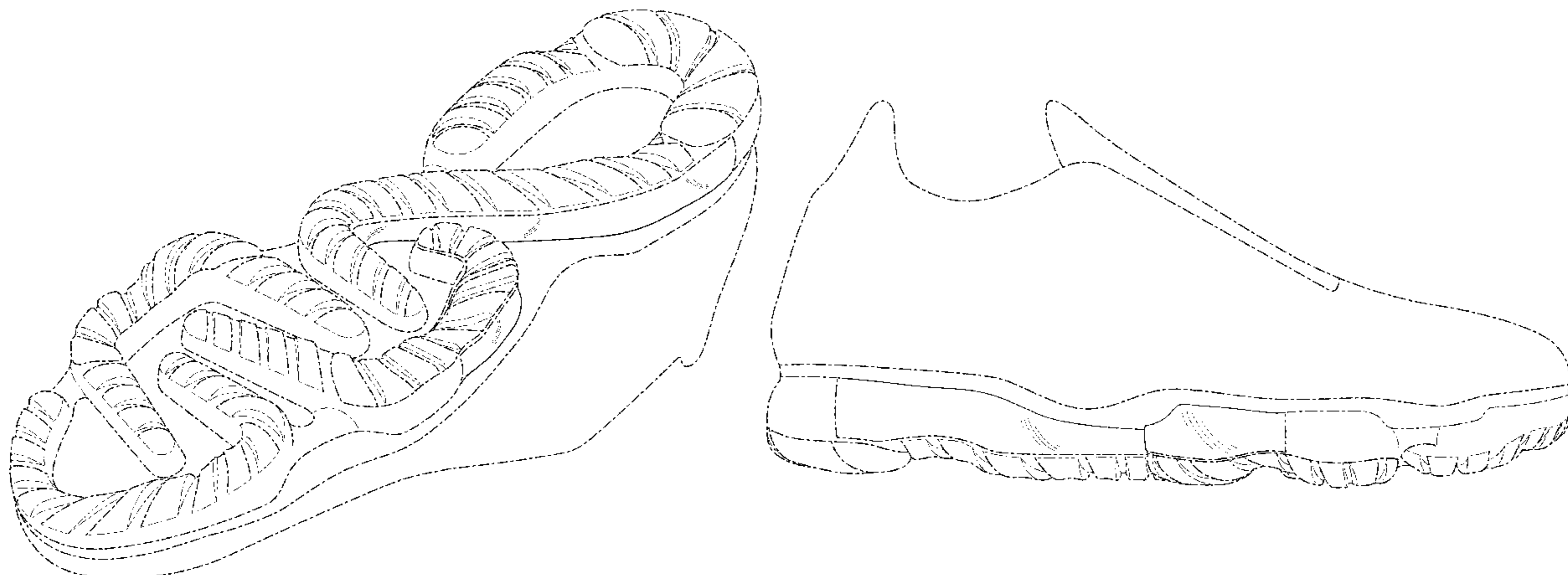
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom front perspective view of a shoe showing my new design;
FIG. 2 is a top rear perspective view thereof;
FIG. 3 is a side view thereof; and,
FIG. 4 is a bottom view thereof.
The broken line immediately adjacent to the shaded areas defines the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

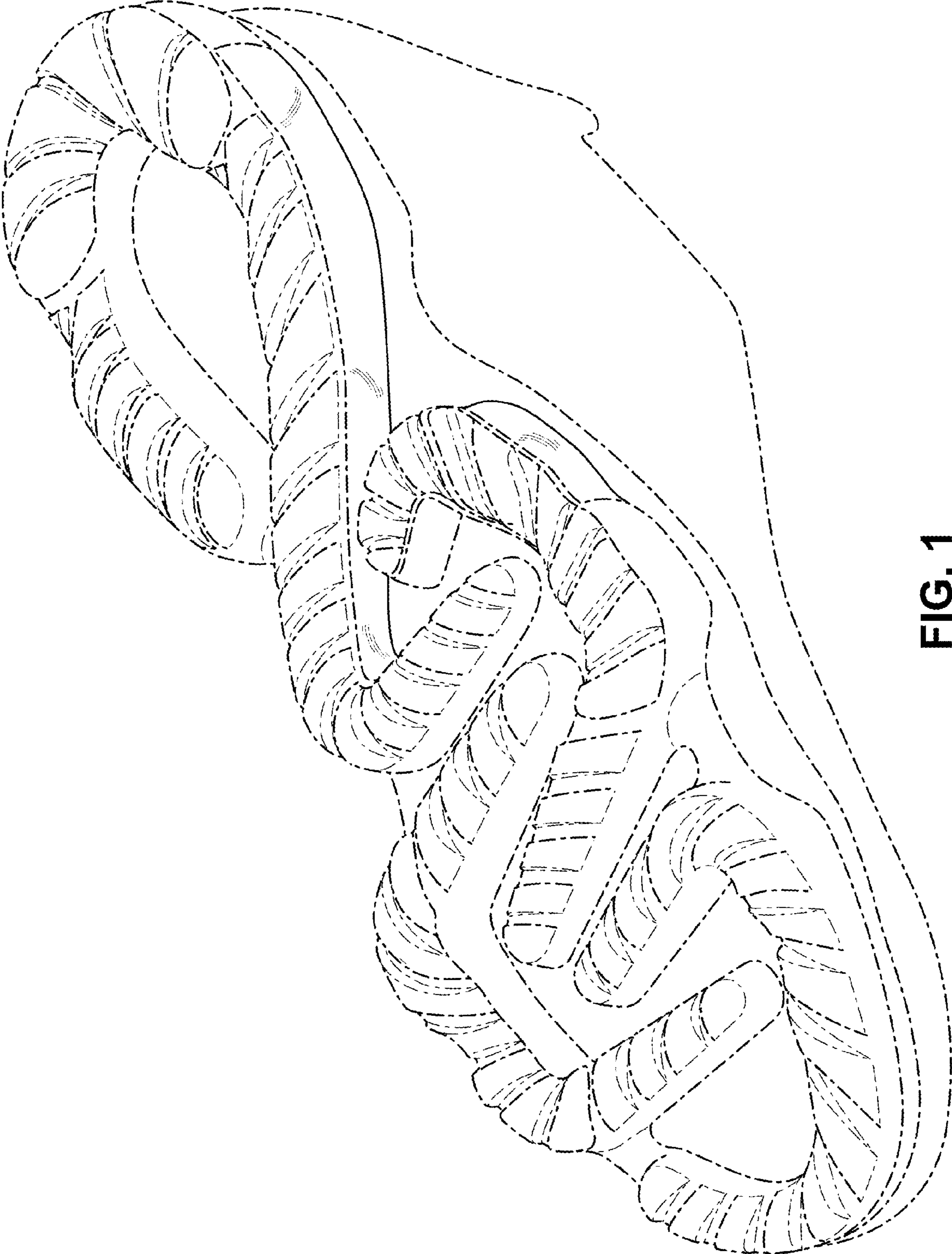

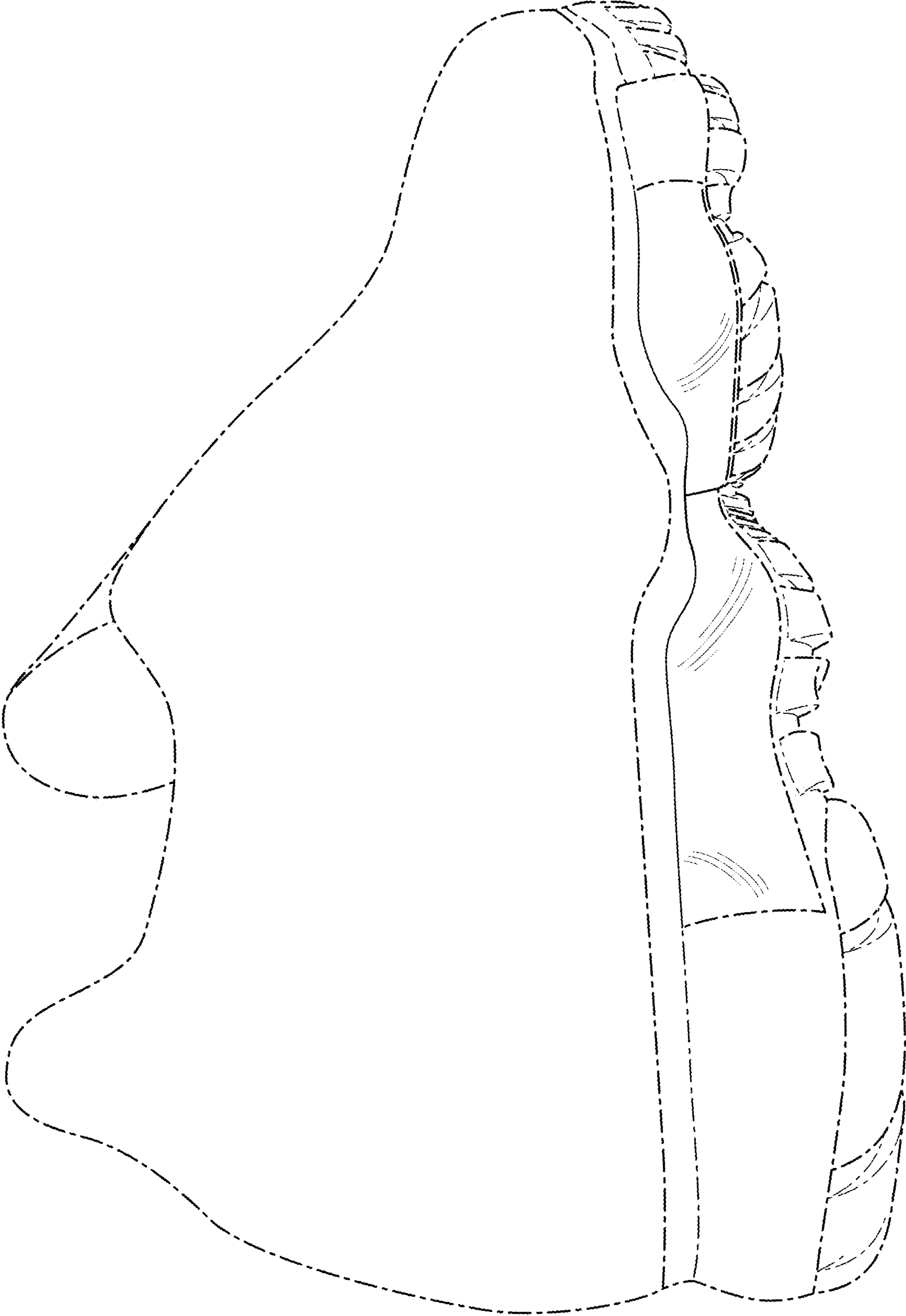

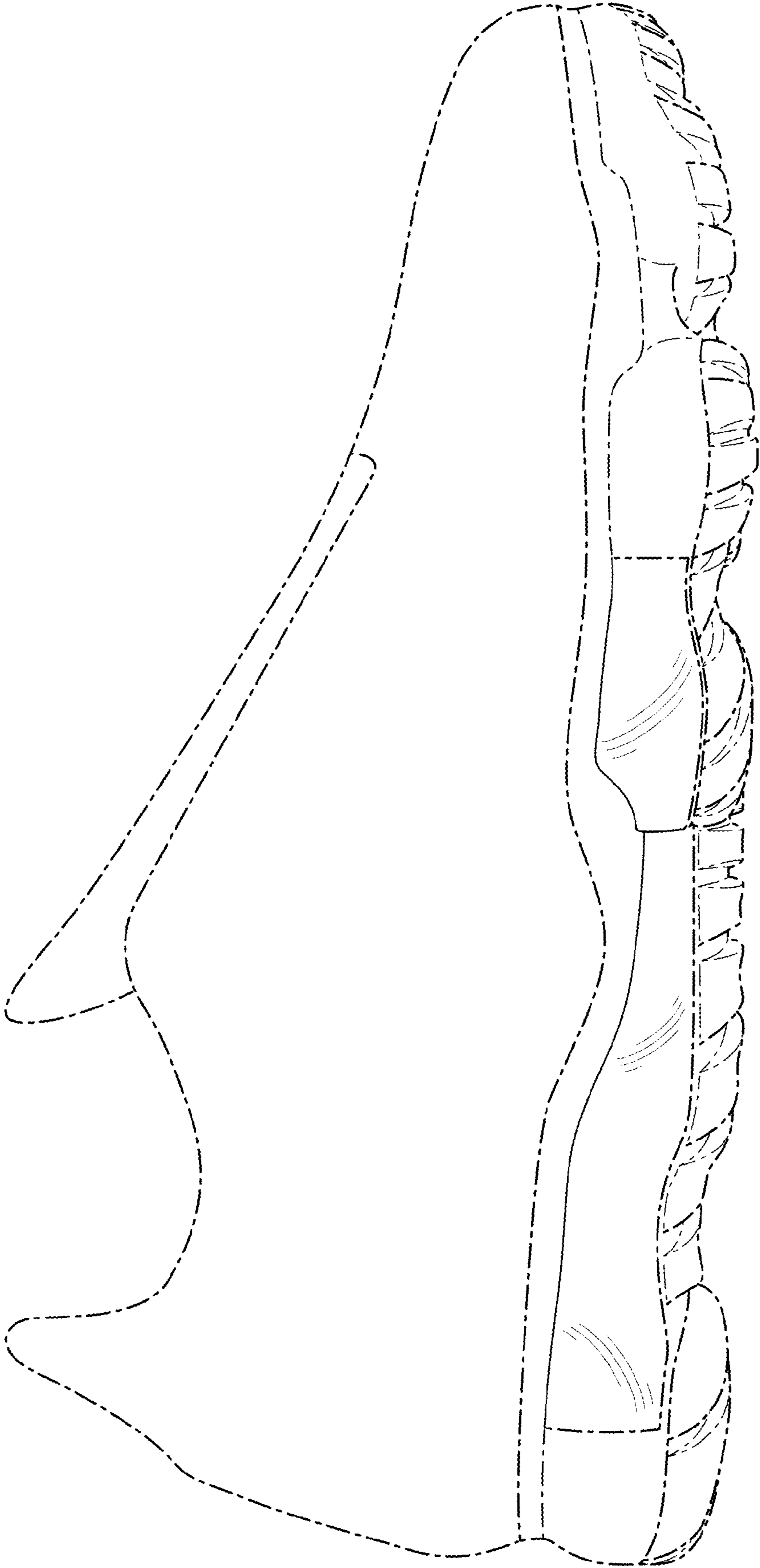

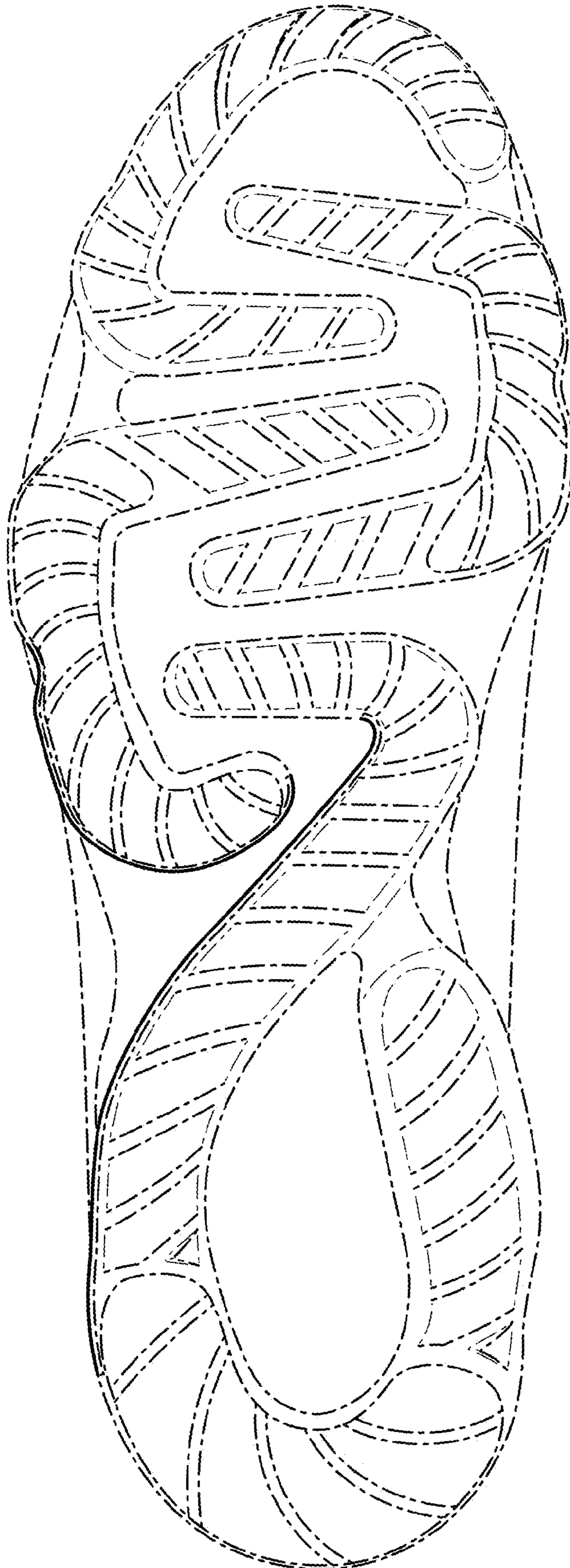
