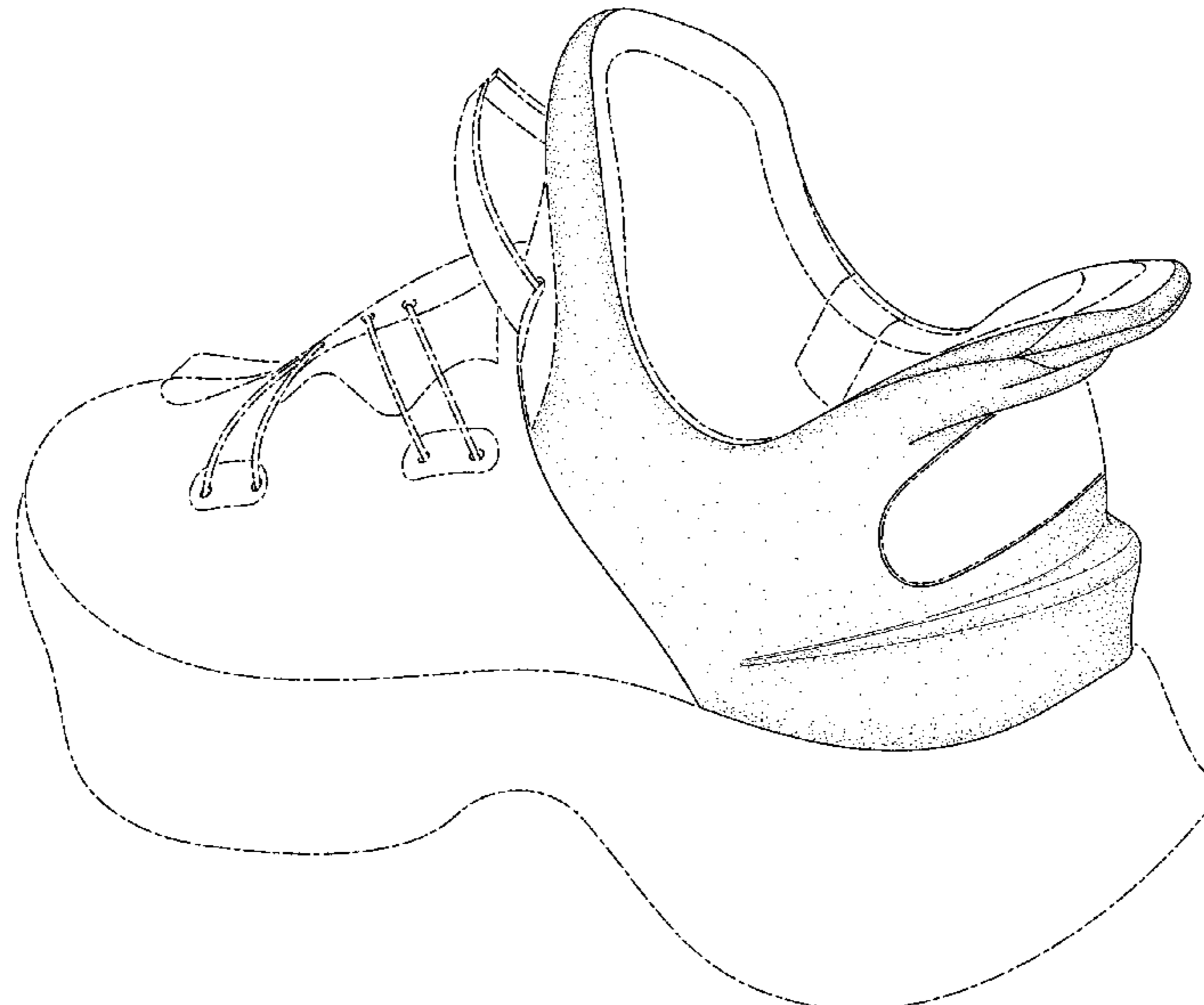
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a rear view thereof; FIG. 4 is an opposite side view thereof; and, FIG. 5 is an opposite side rear perspective view thereof. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The unshaded regions, including the unshaded regions on the heel, tongue, and ankle collar, form no part of the claimed design. The broken lines depicting the remainder of the shoe forms no part of the claimed design.

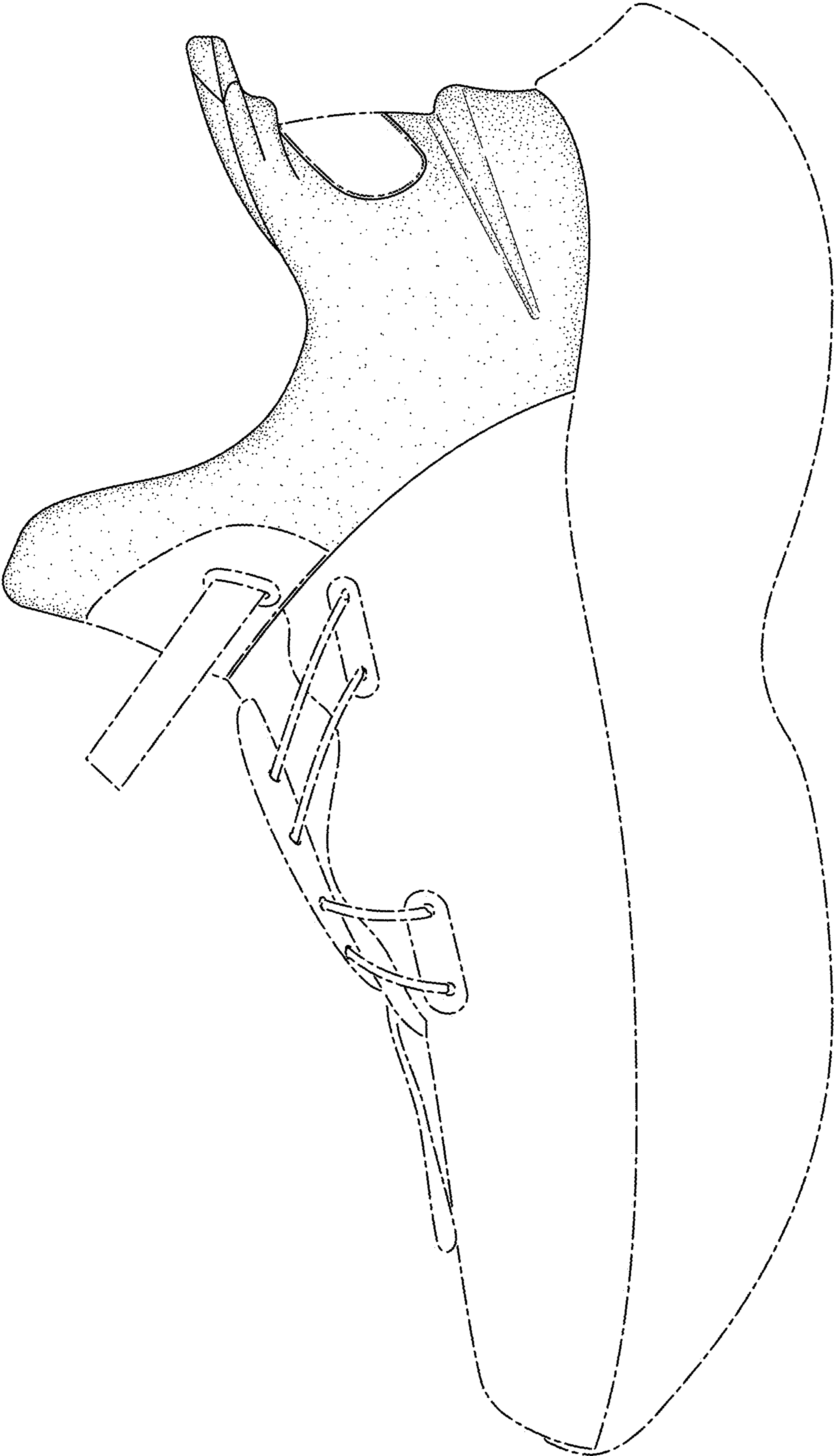

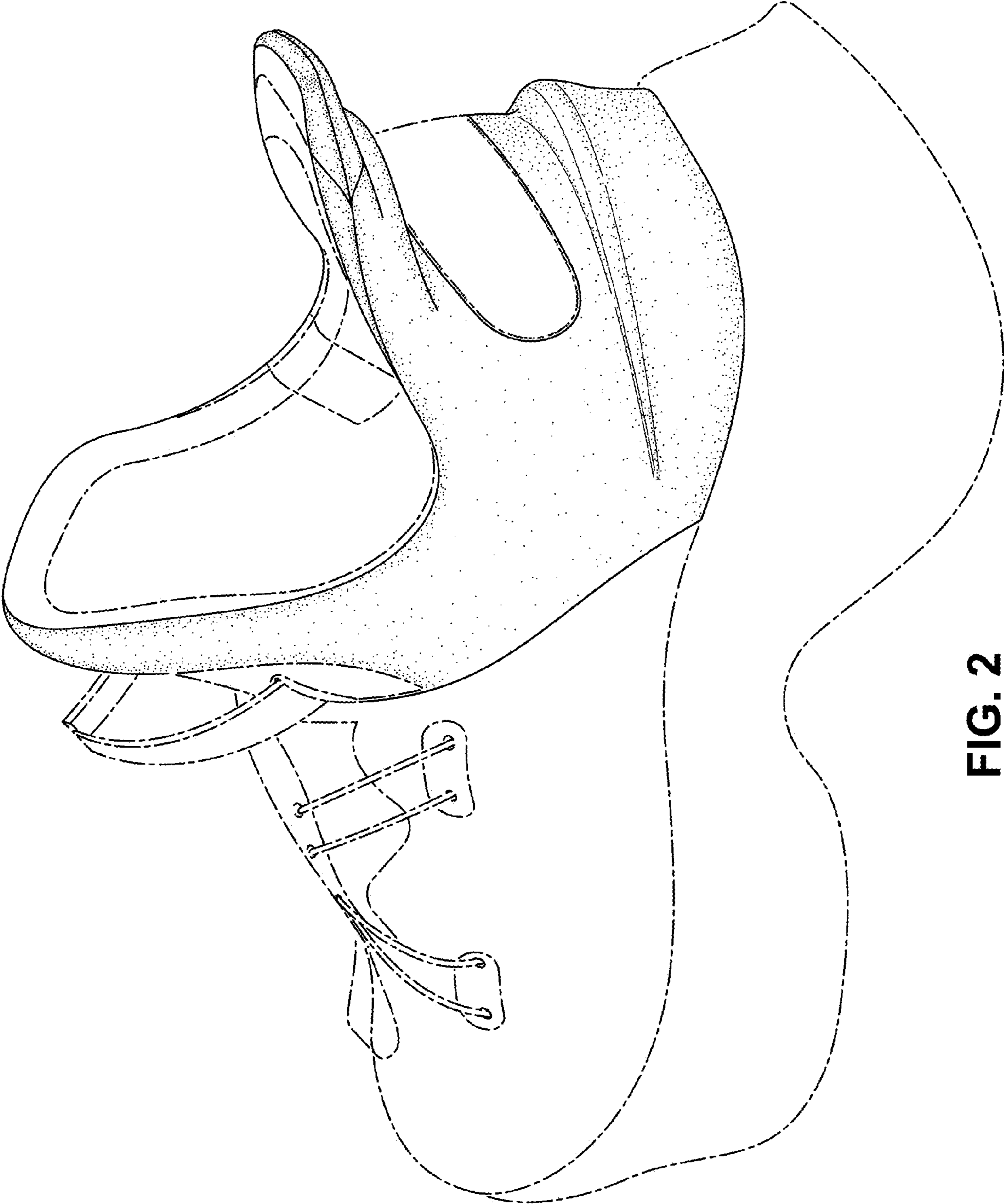

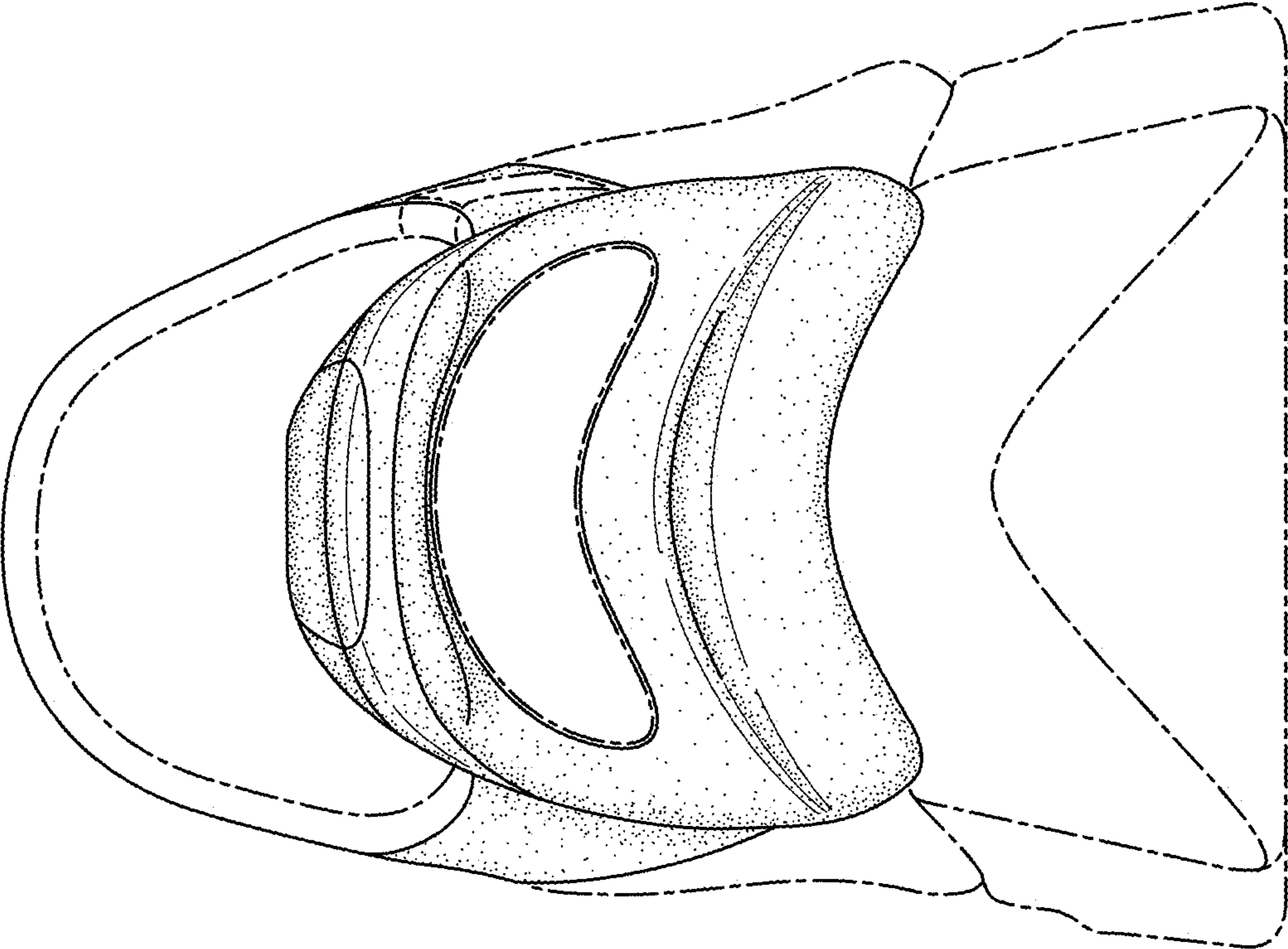

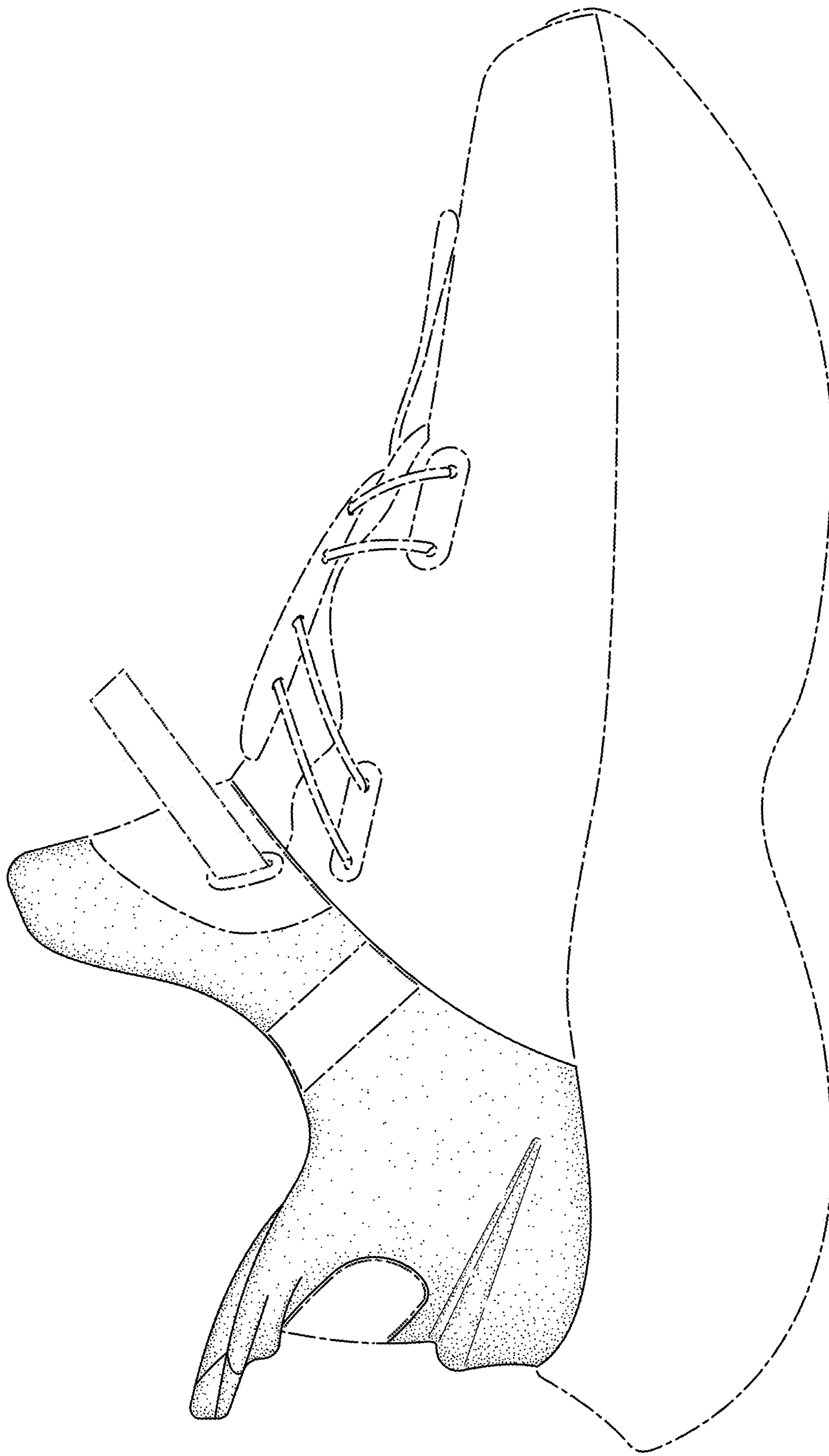

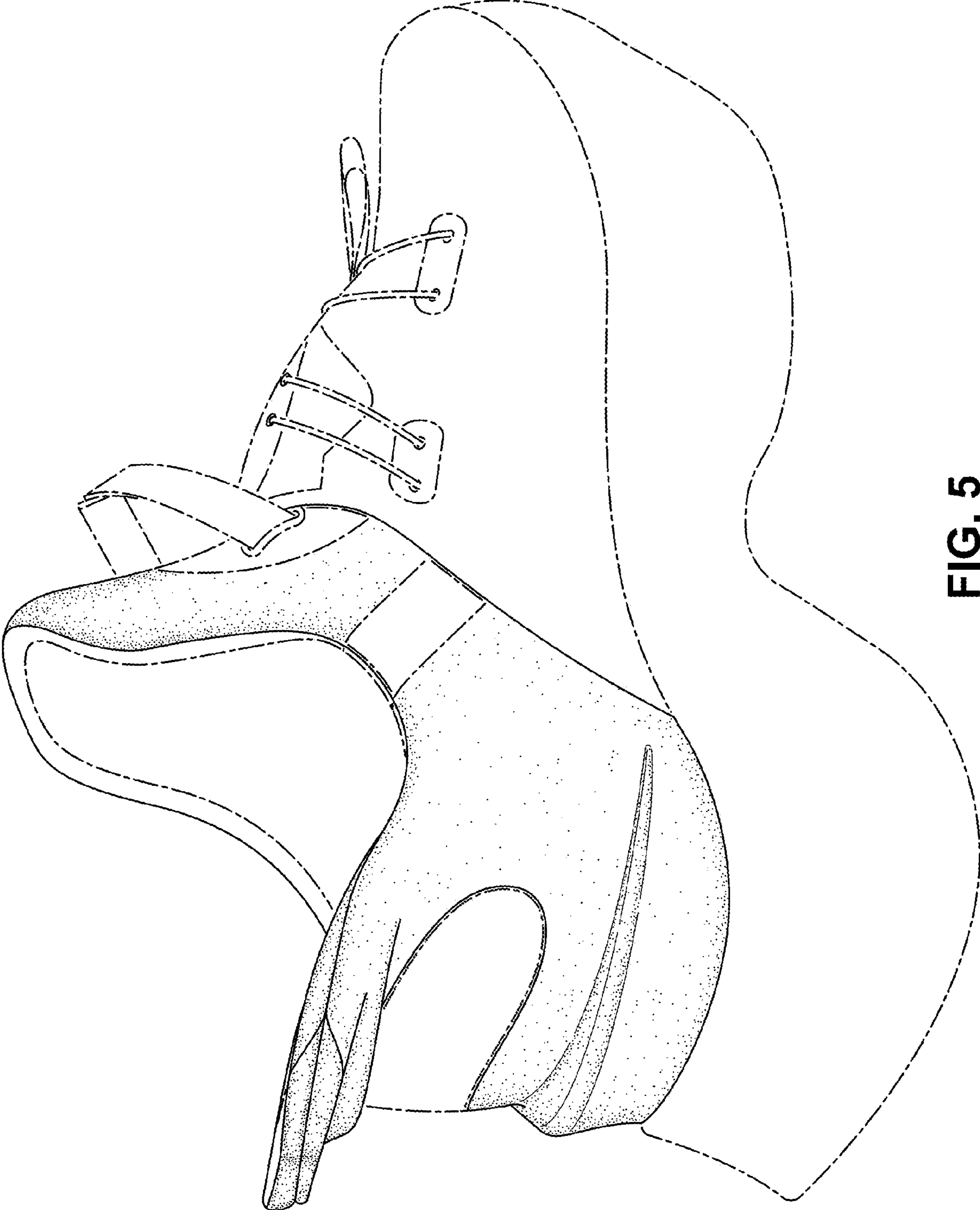
