The ornamental design for a headset carry case, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a headset carry case in a closed position.

FIG. 2 is a front view of the headset carry case shown in FIG. 1.

FIG. 3 is a back view of the headset carry case shown in FIG. 1.

FIG. 5 is right side view of the headset carry case shown in FIG. 1.

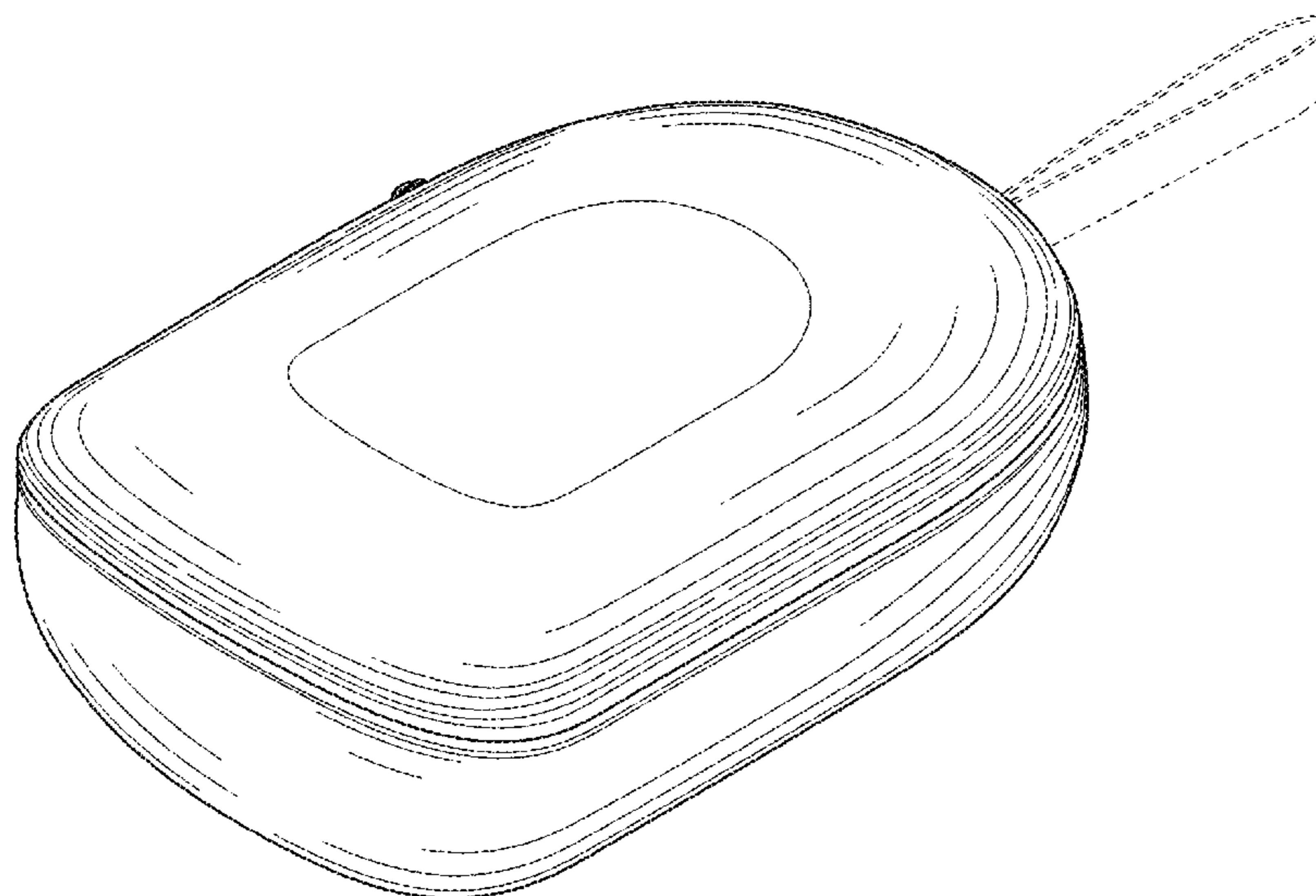
FIG. 6 is a top view of the headset carry case shown in FIG. 1.

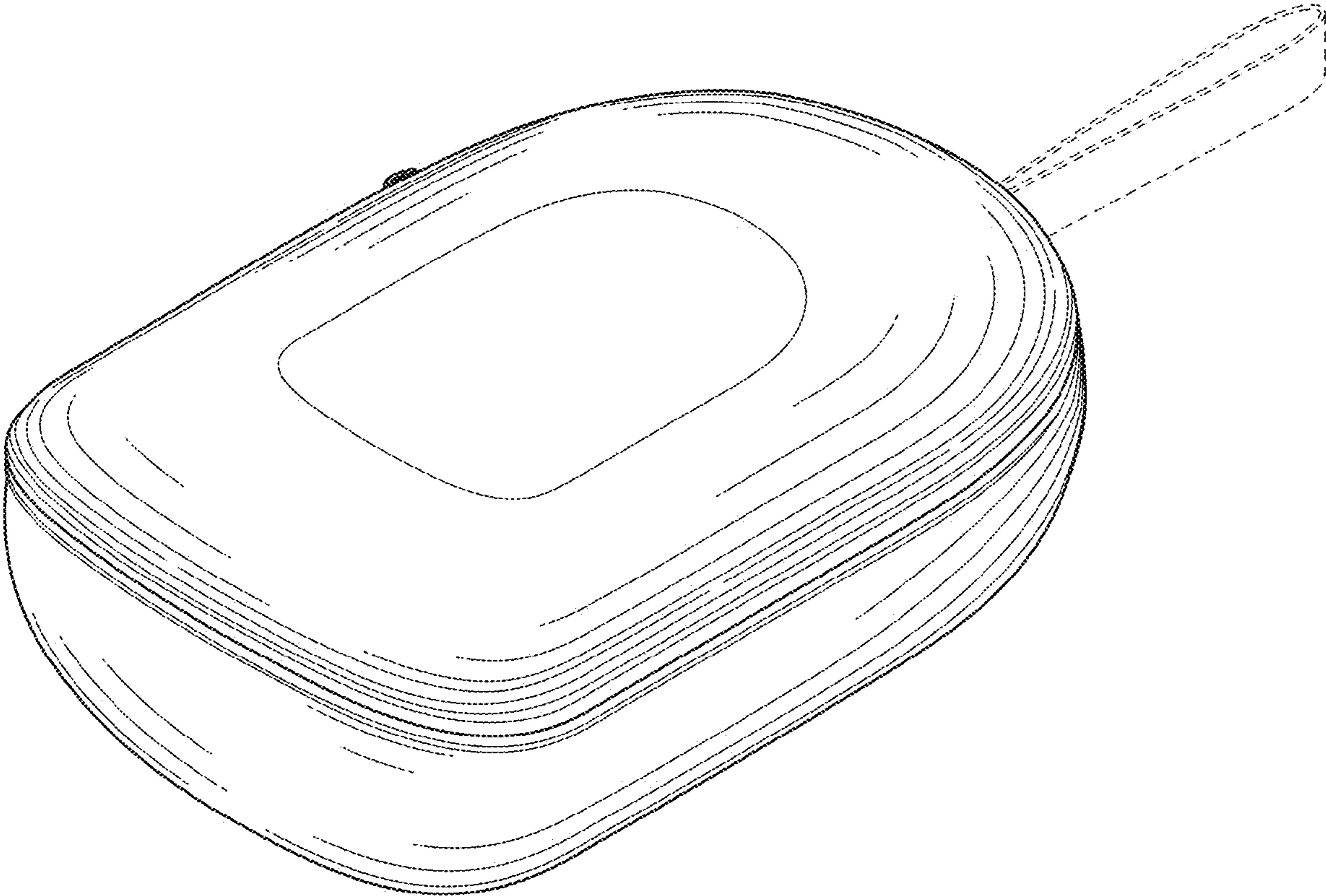

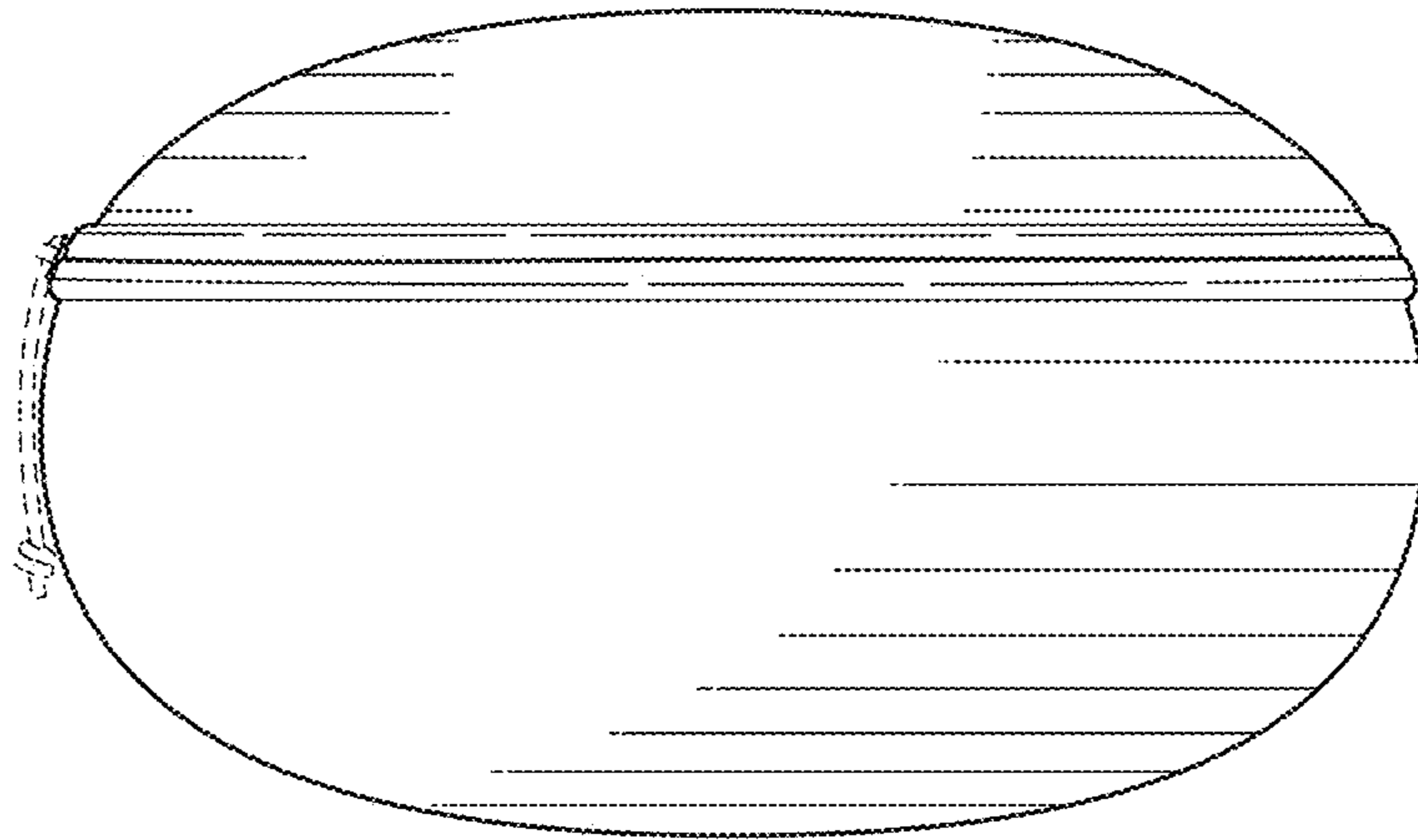

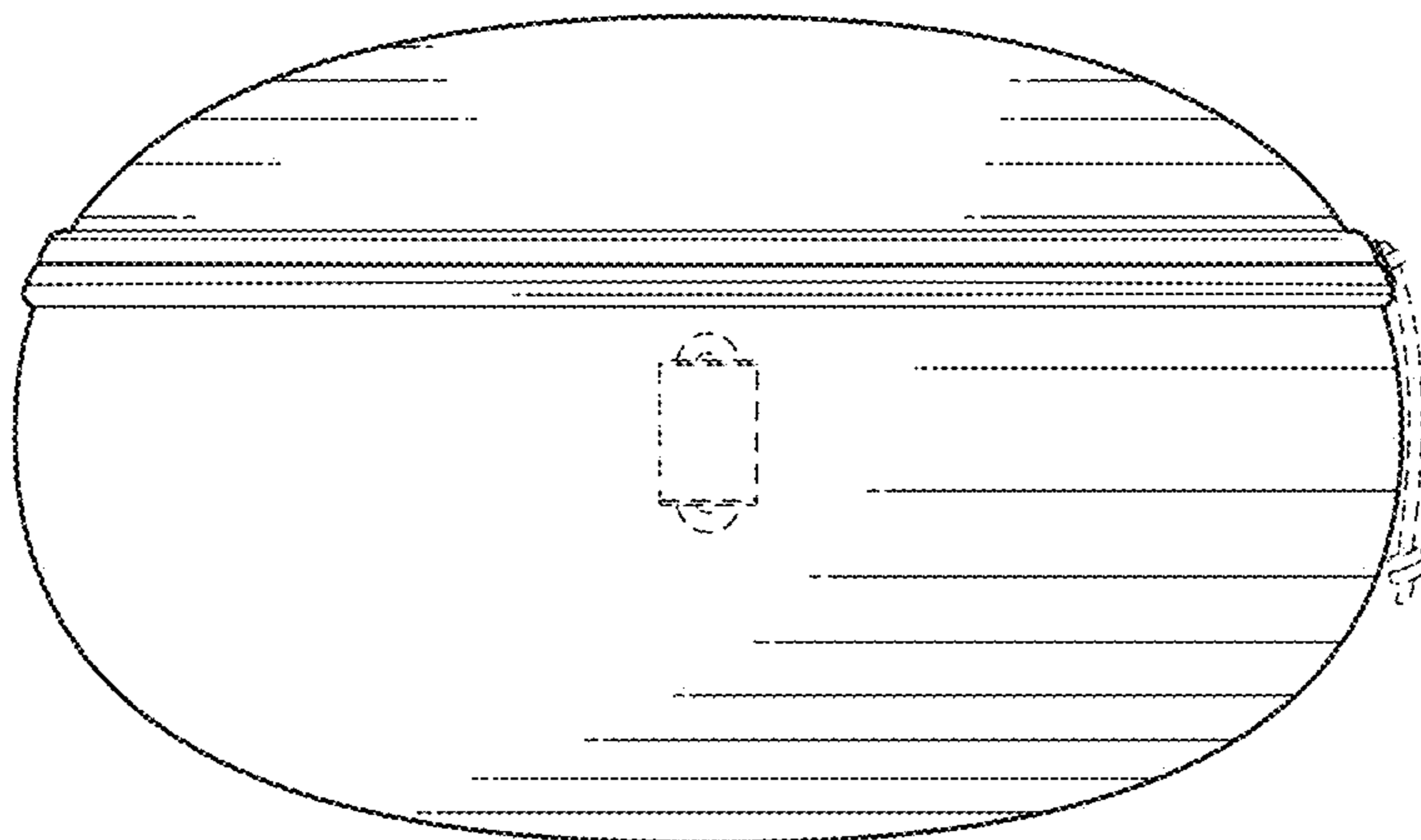

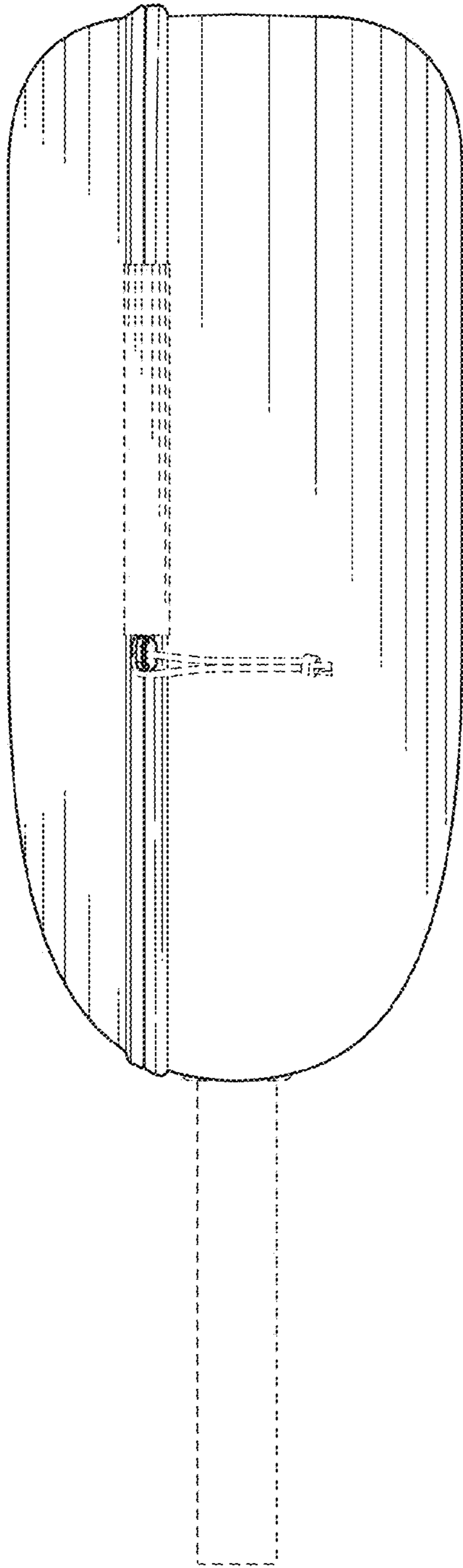

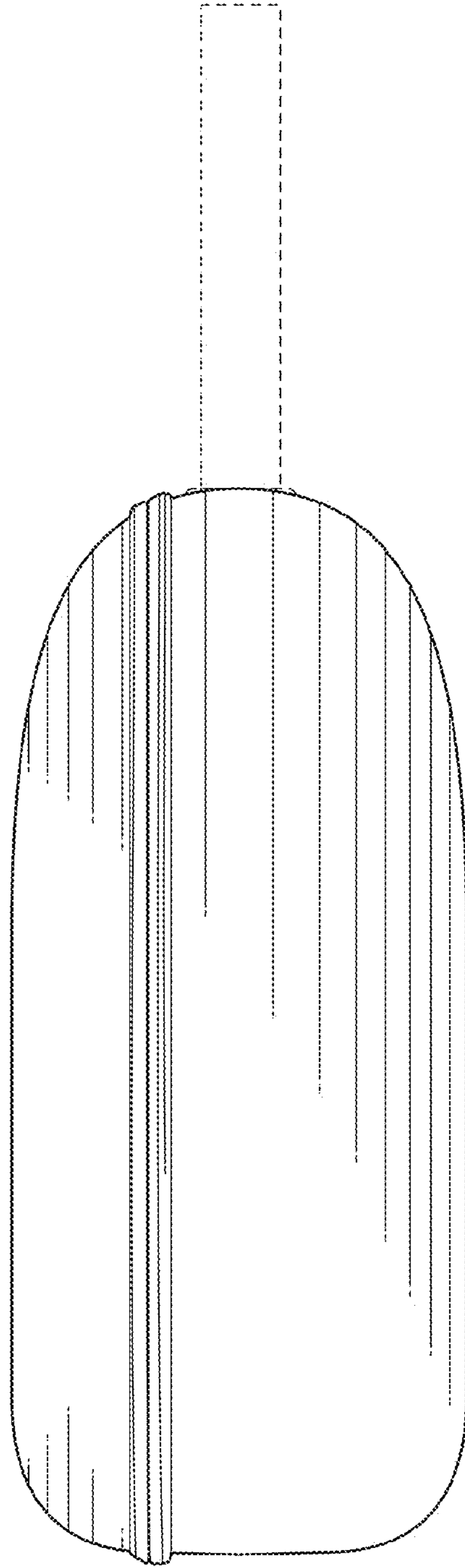

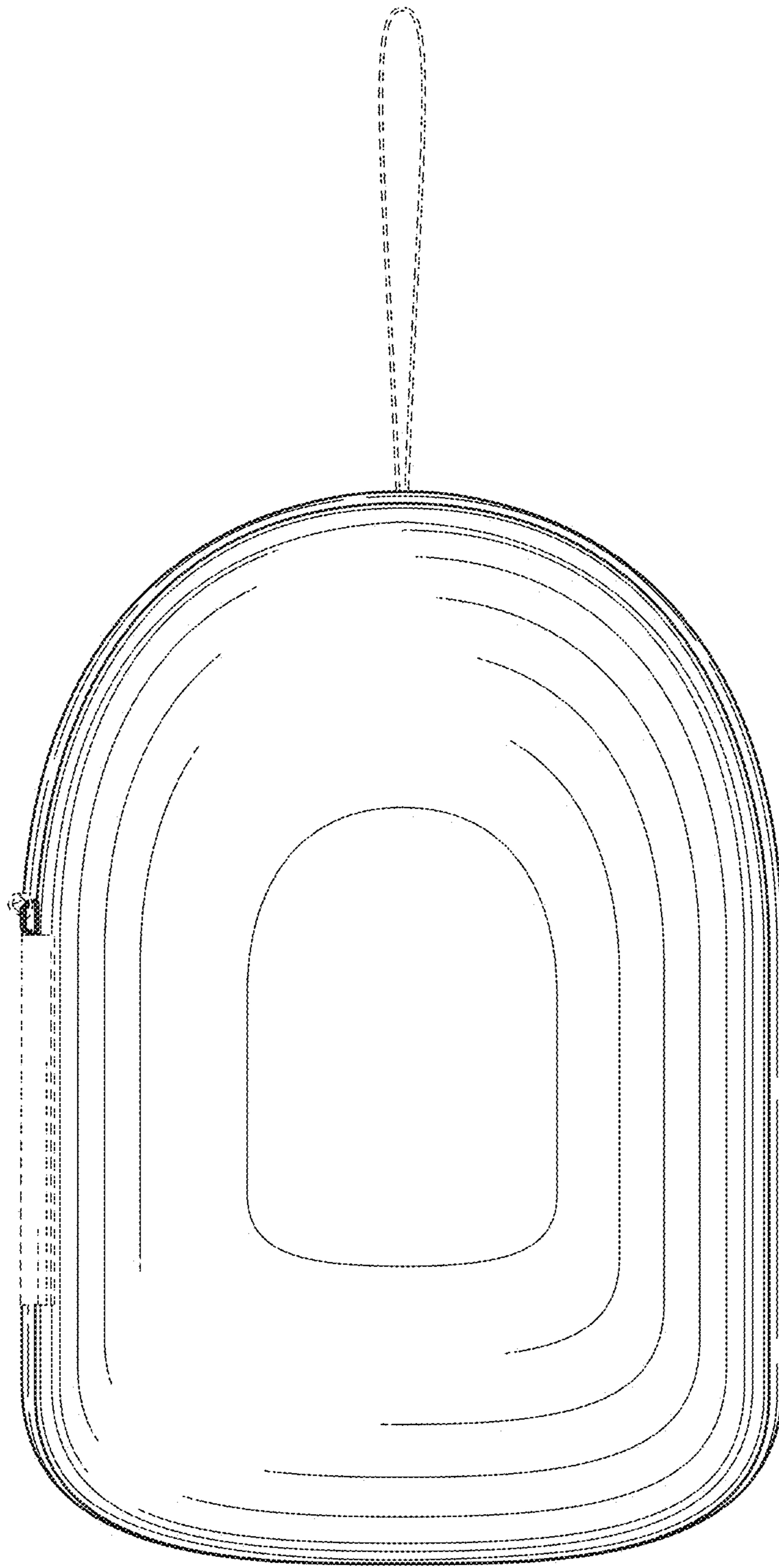

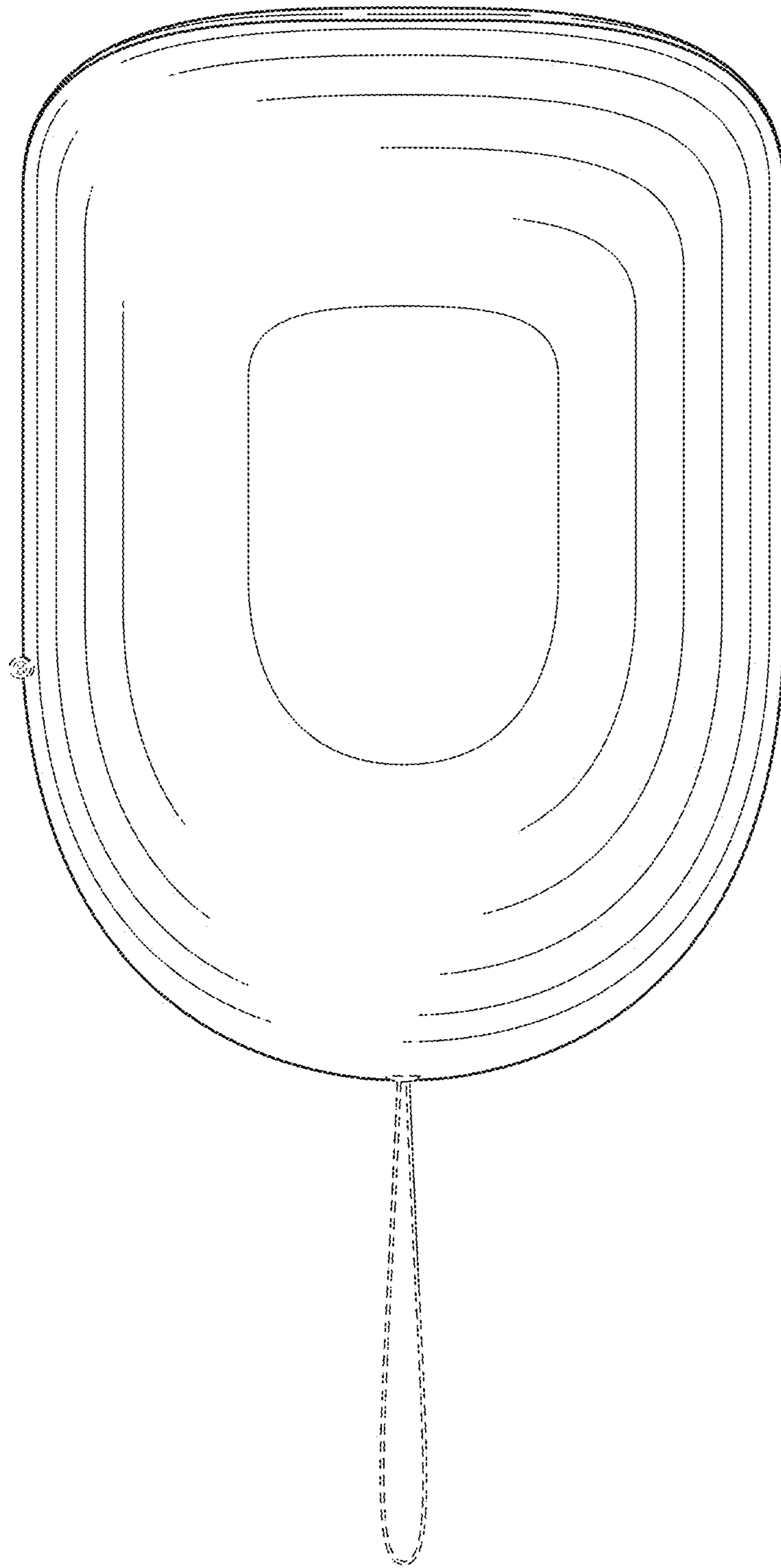

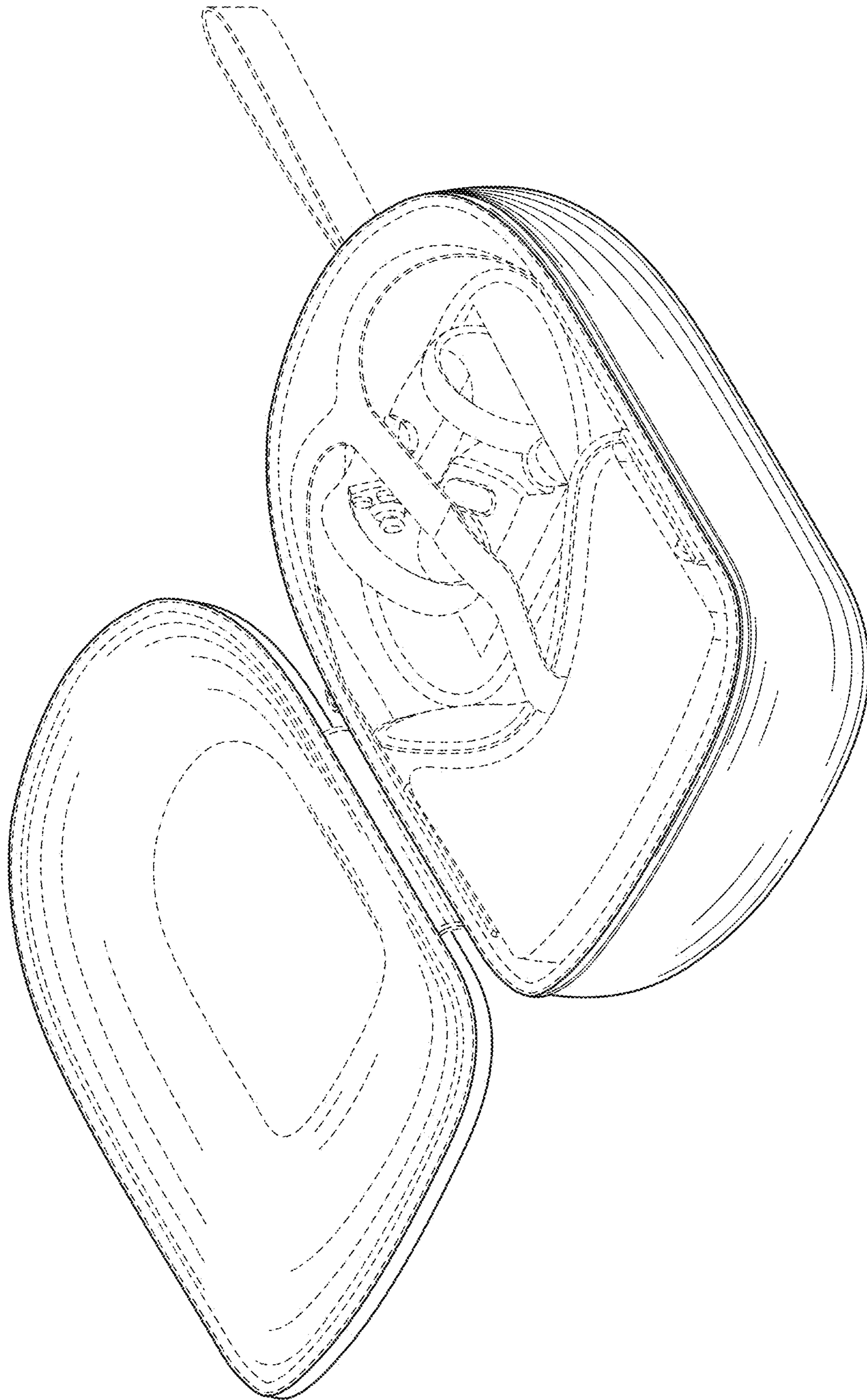
