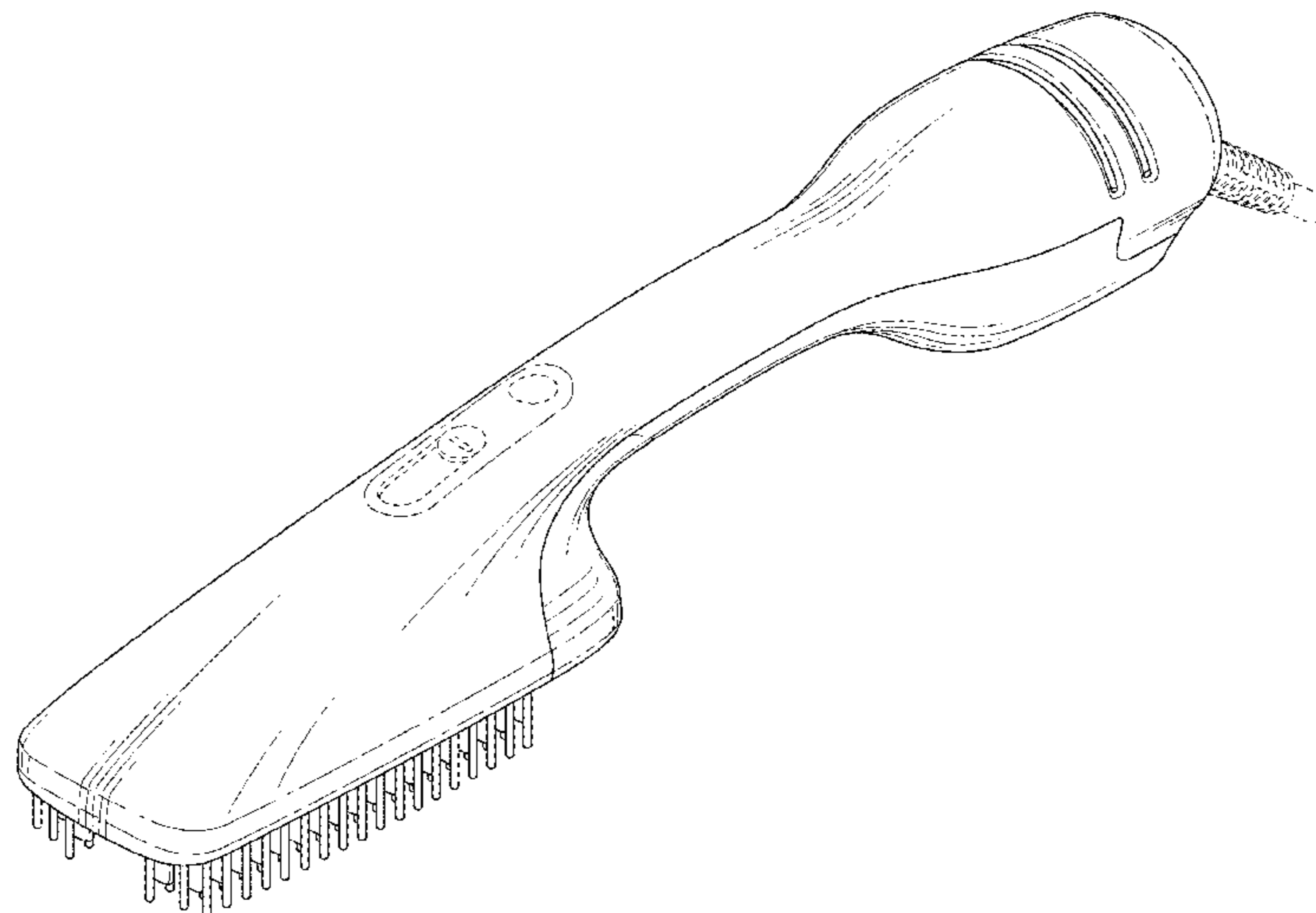
(57) **CLAIM**

The ornamental design for a hair dryer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hair dryer, showing the new, original and ornamental design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a right side elevation view thereof (the unshown left side elevation view being a mirror image thereof);
FIG. 5 is a front elevation view thereof; and,
FIG. 6 is a rear elevation view thereof.
The broken lines in the drawings illustrate features of the hair dryer that form no part of the claimed design.

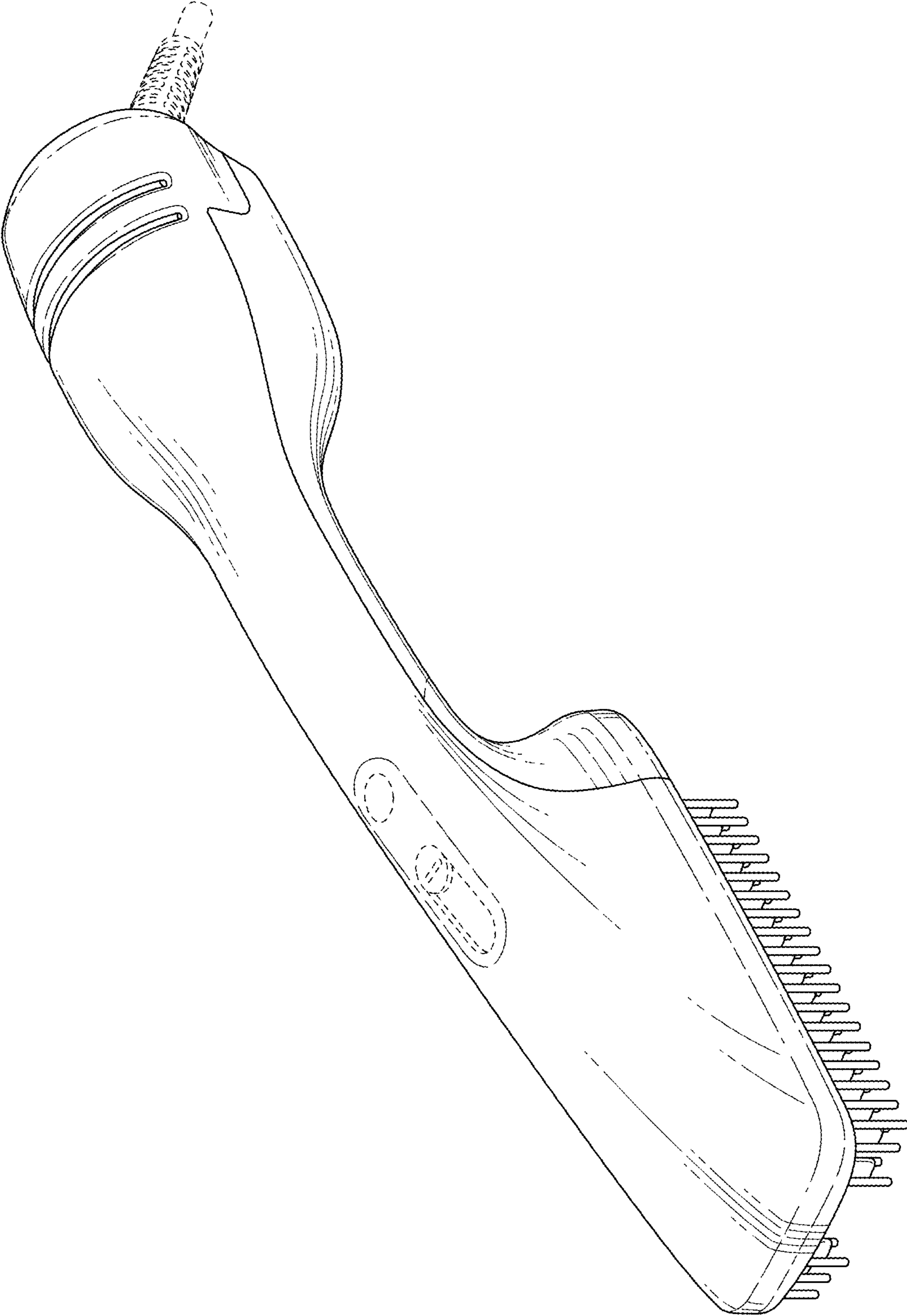

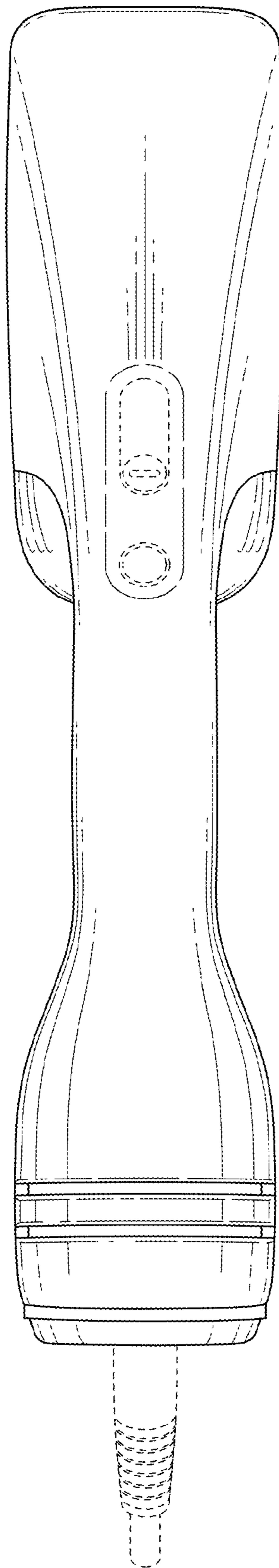

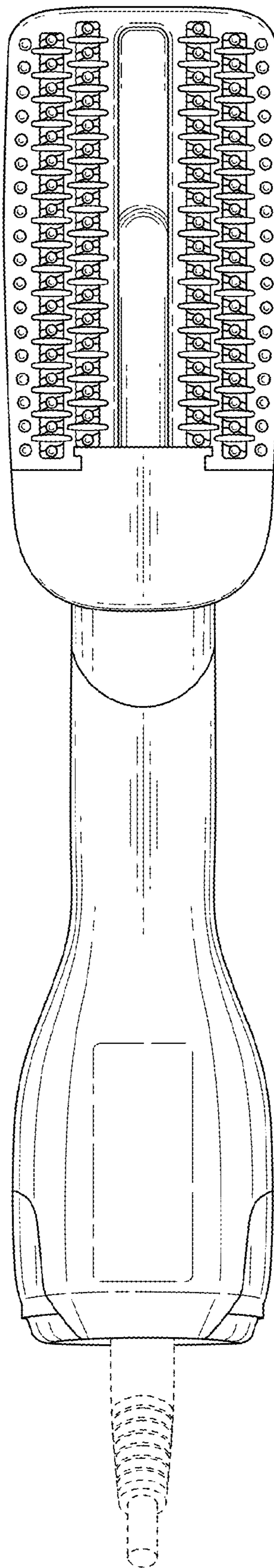

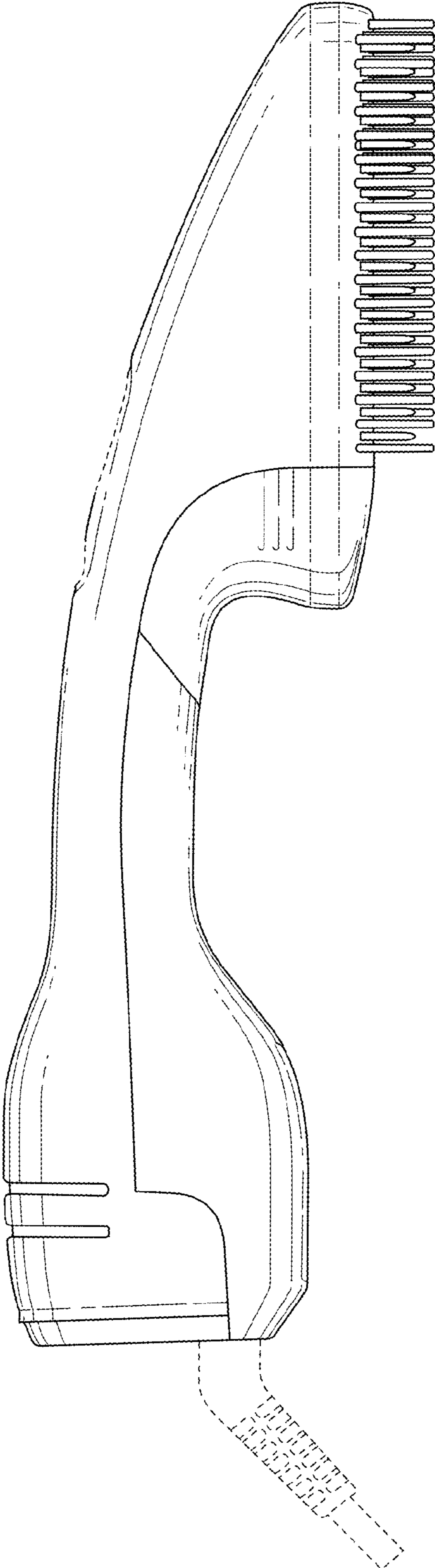

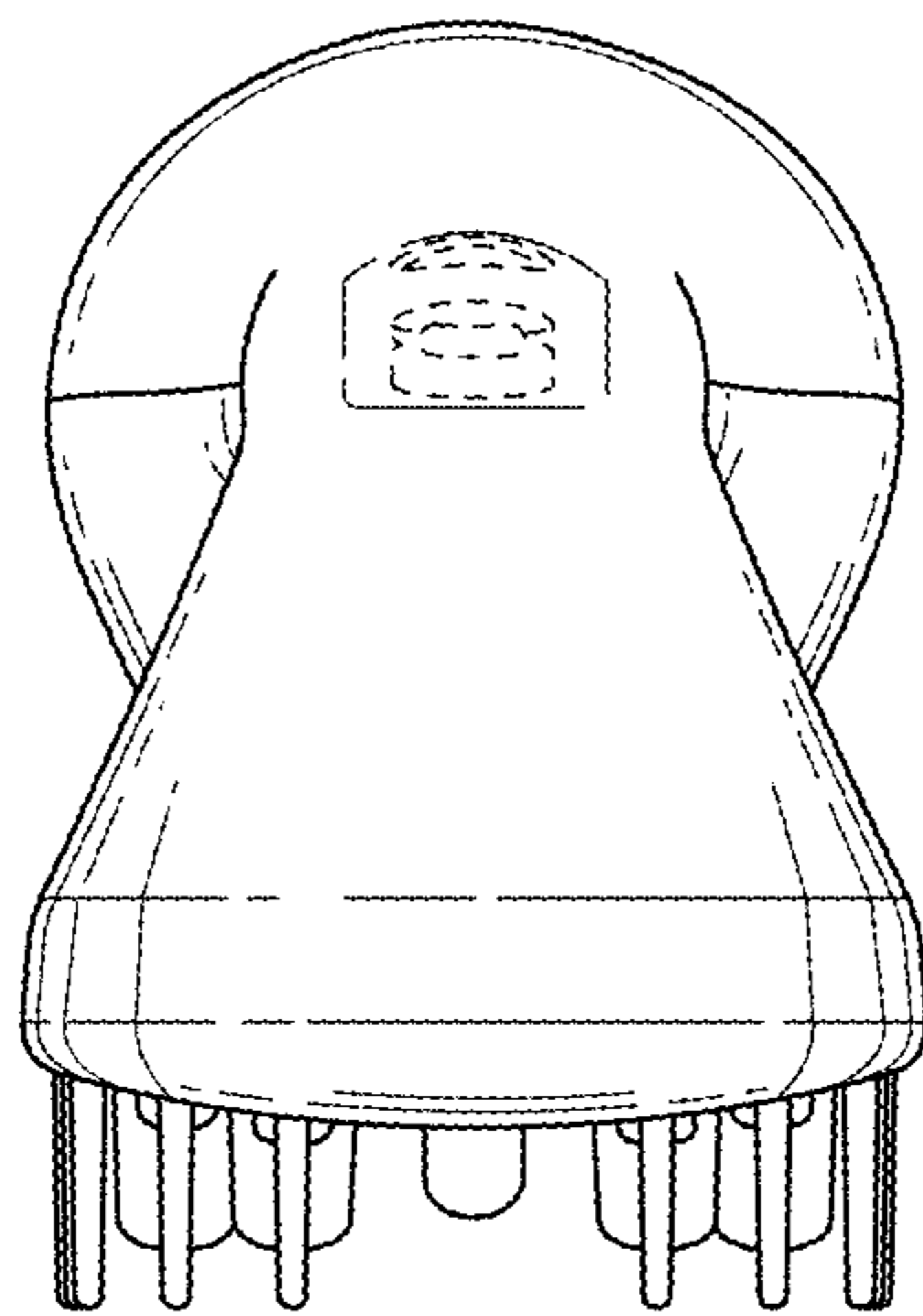

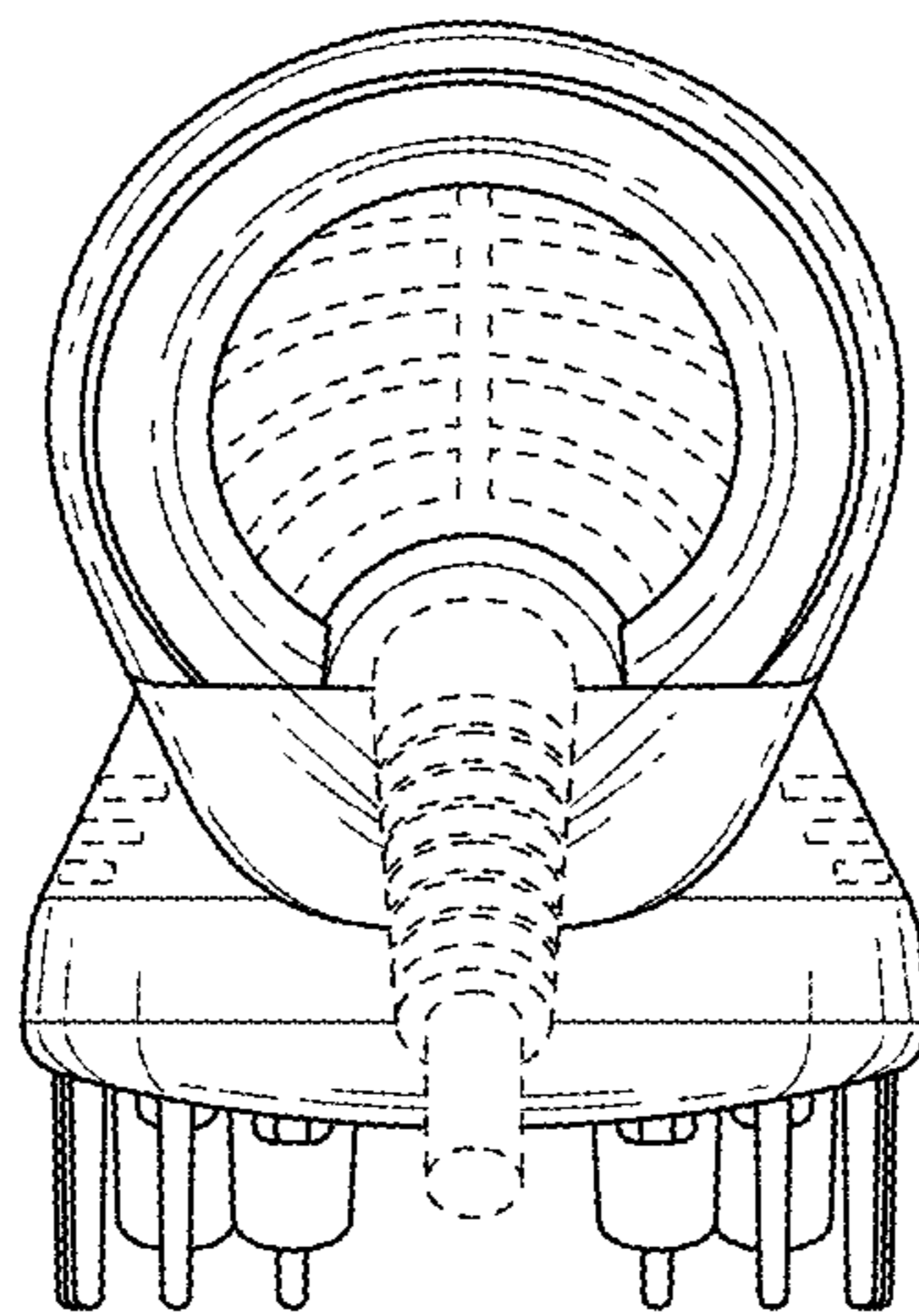
