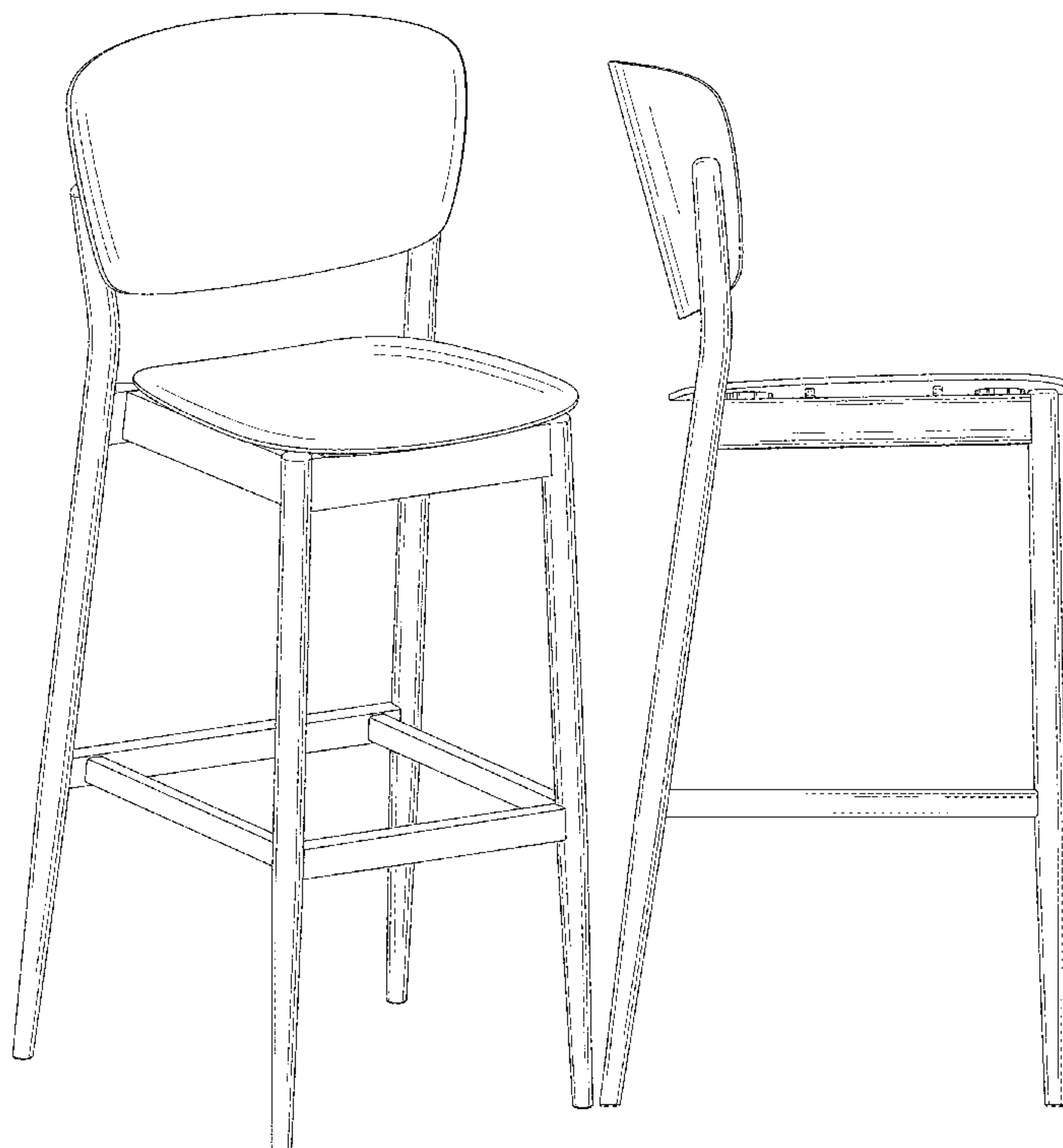
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a barstool showing our new design;
FIG. 2 is a left side view thereof; the right side view being a mirror image;
FIG. 3 is a back view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

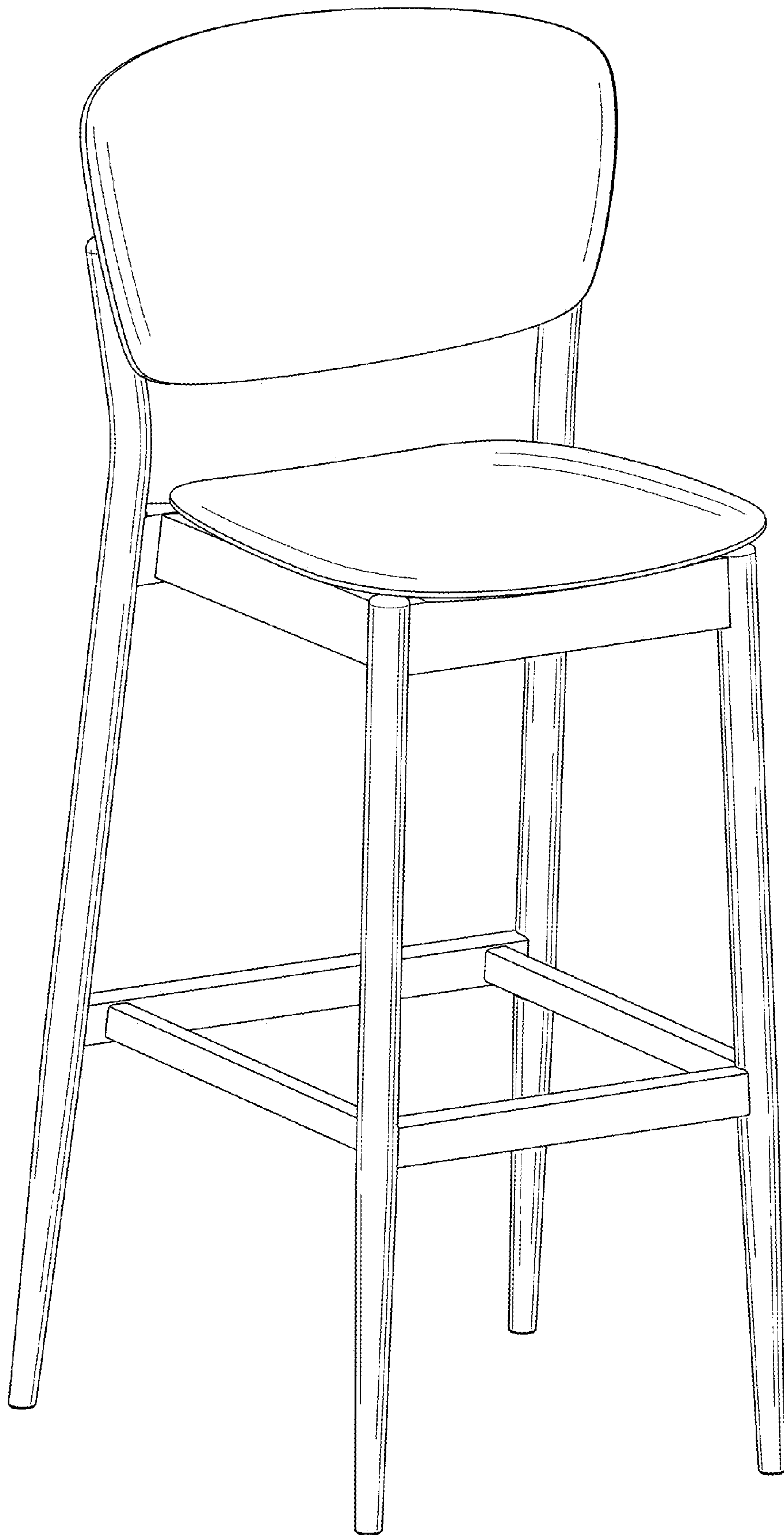

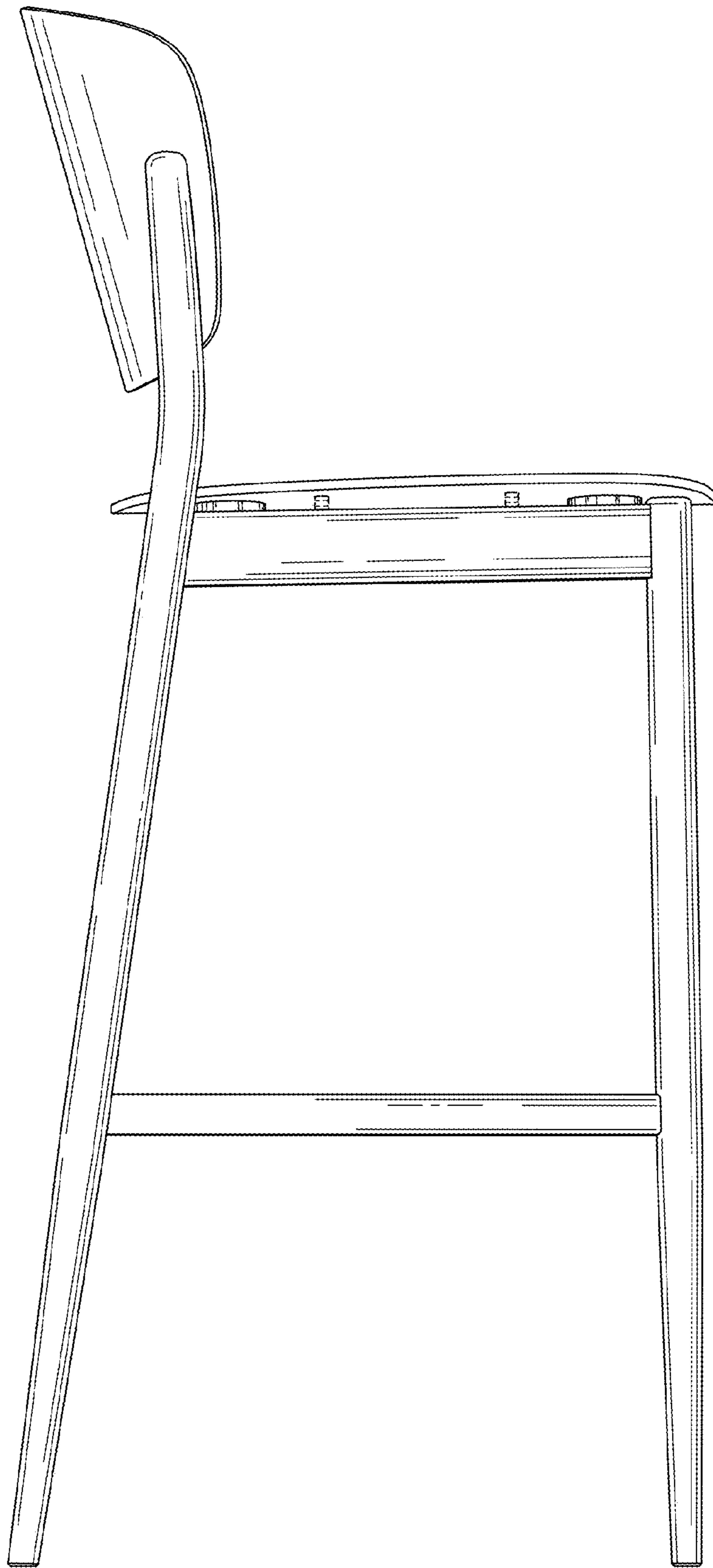

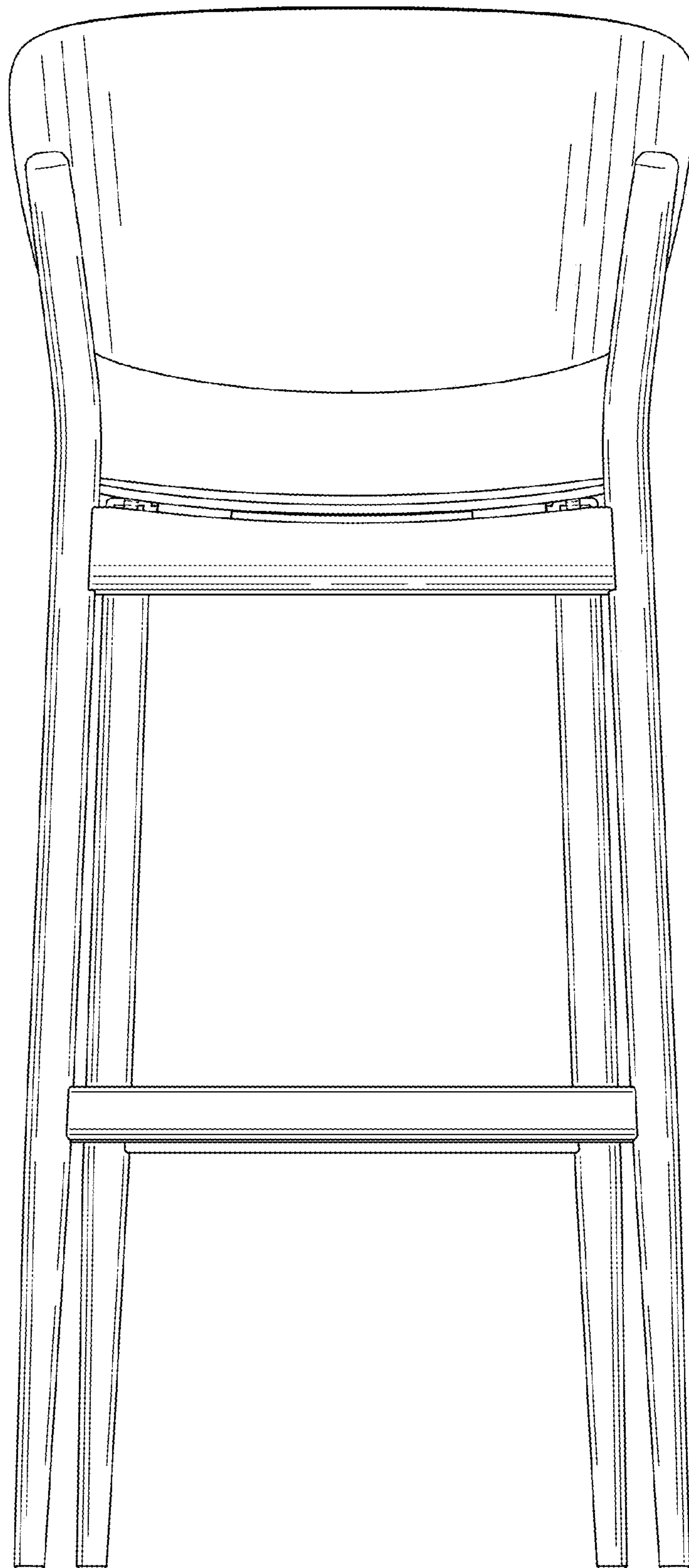

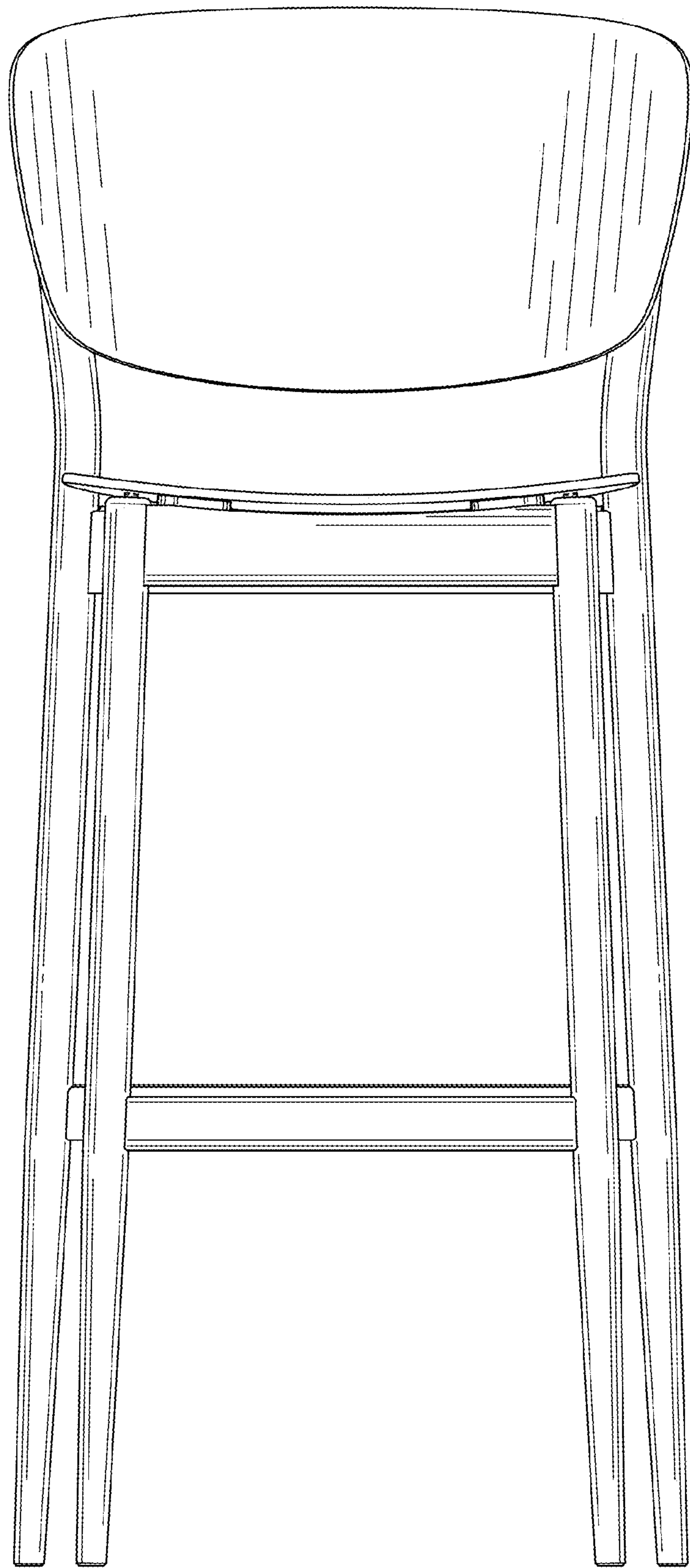

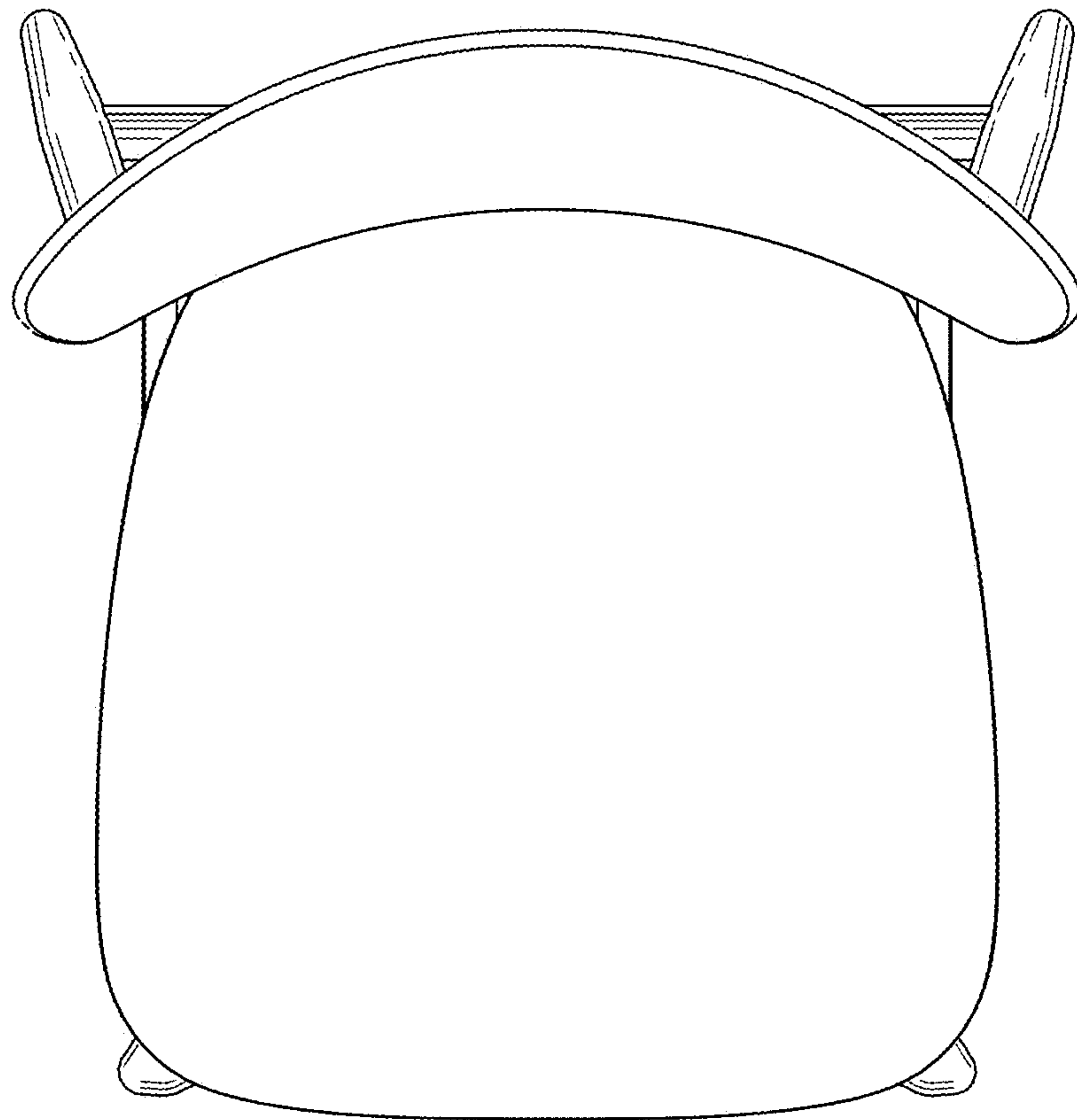

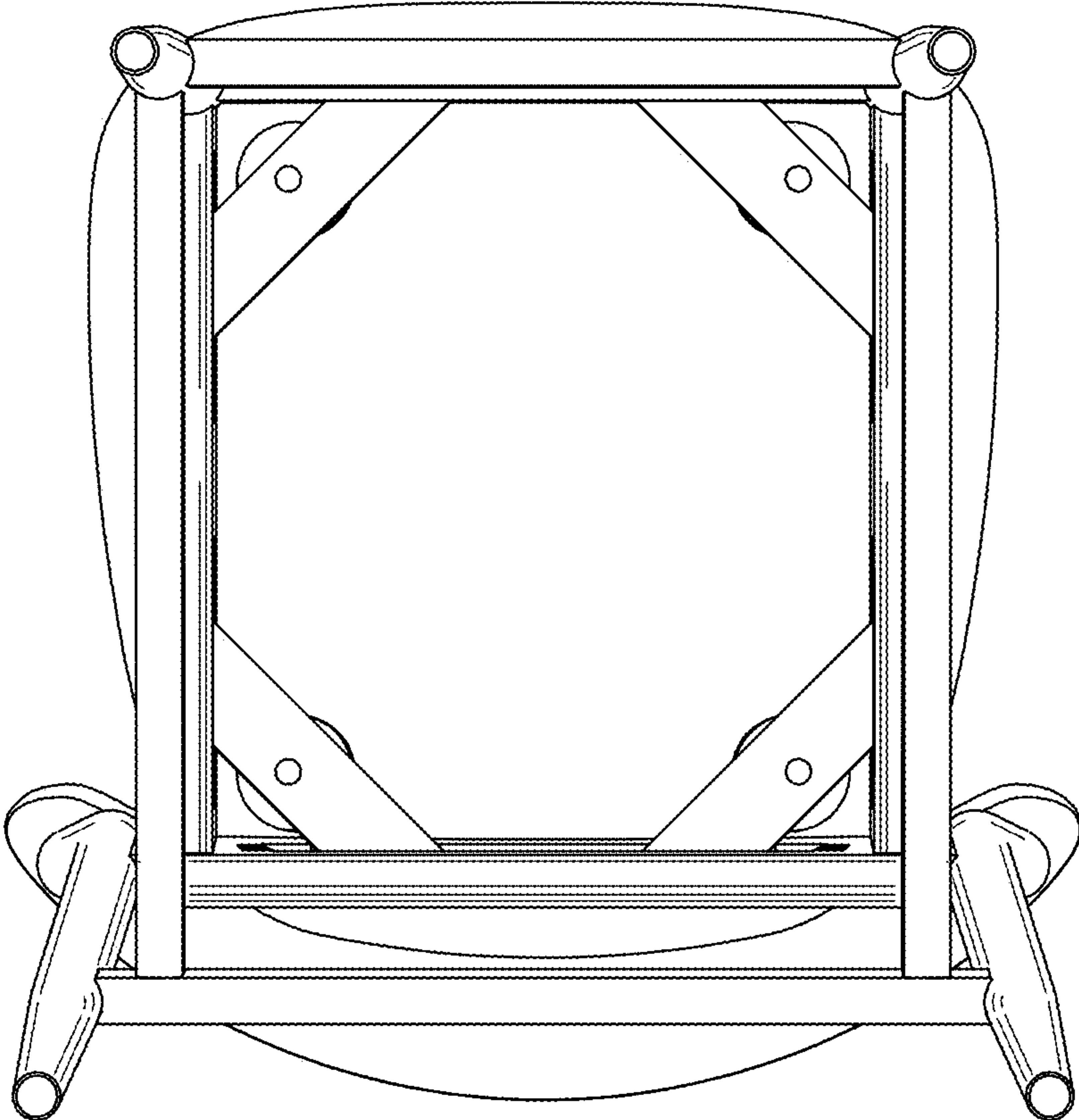
