**DESCRIPTION**

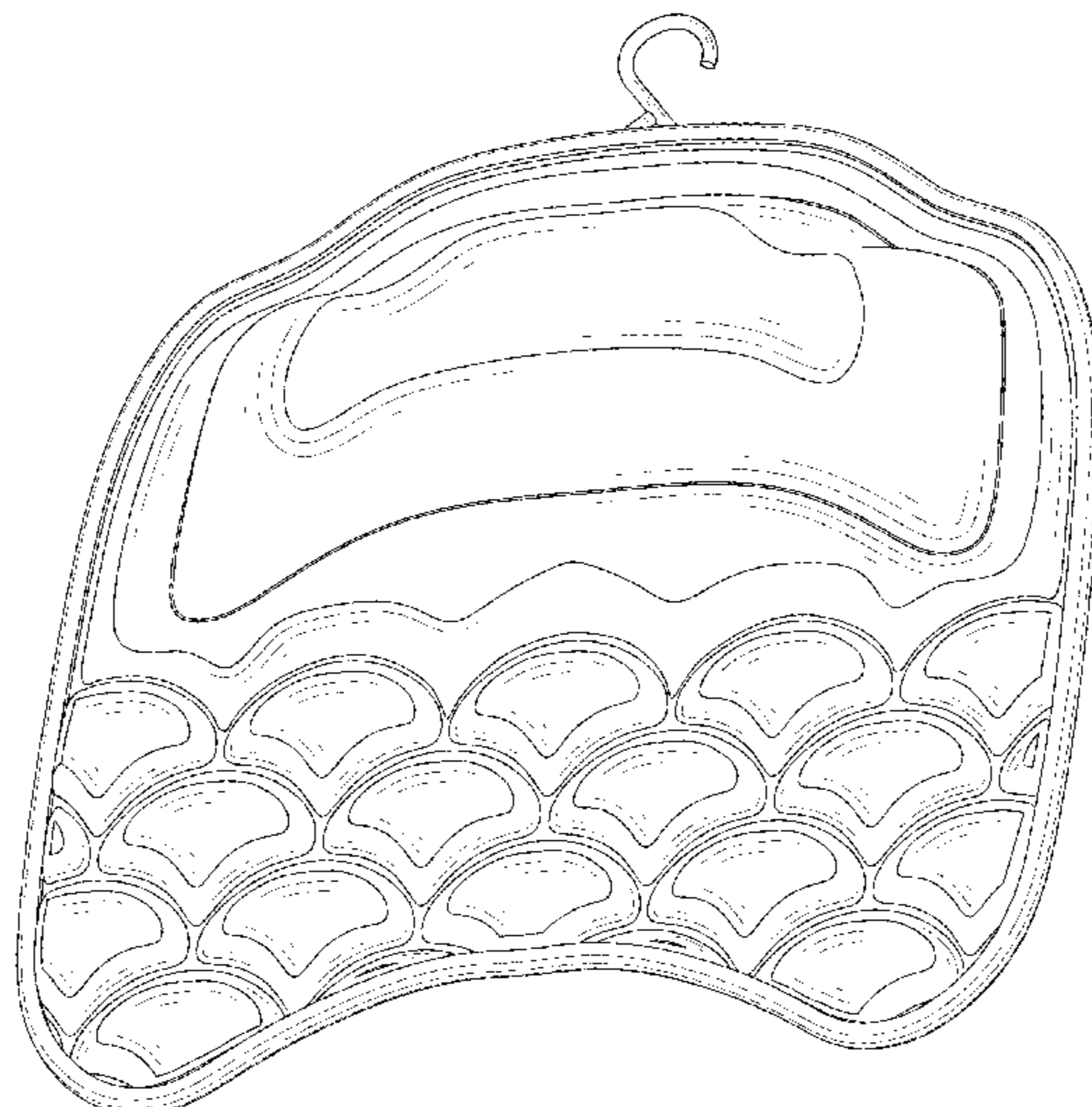
FIG. 1 is a perspective view of a bath pillow showing my new design;

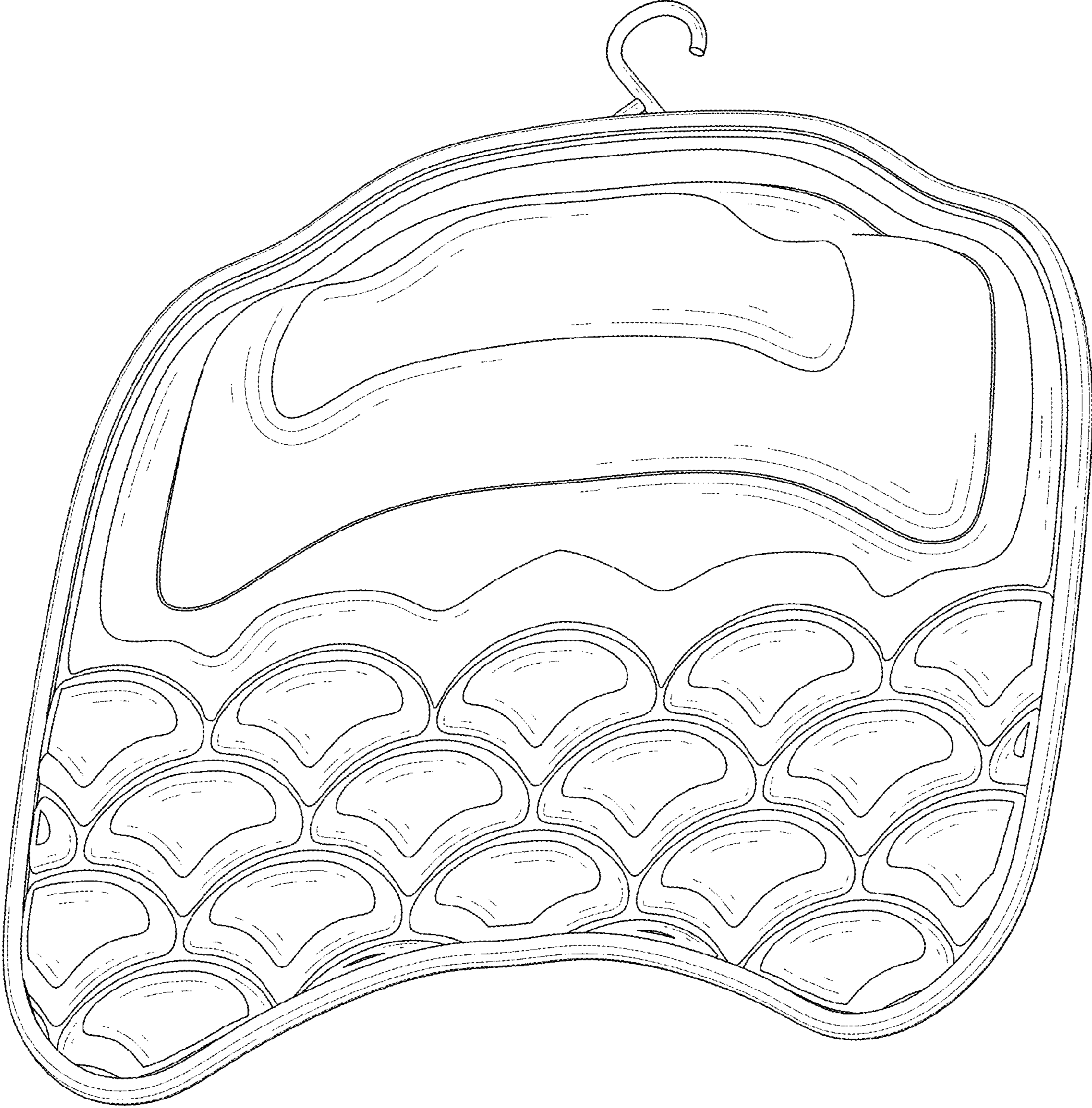

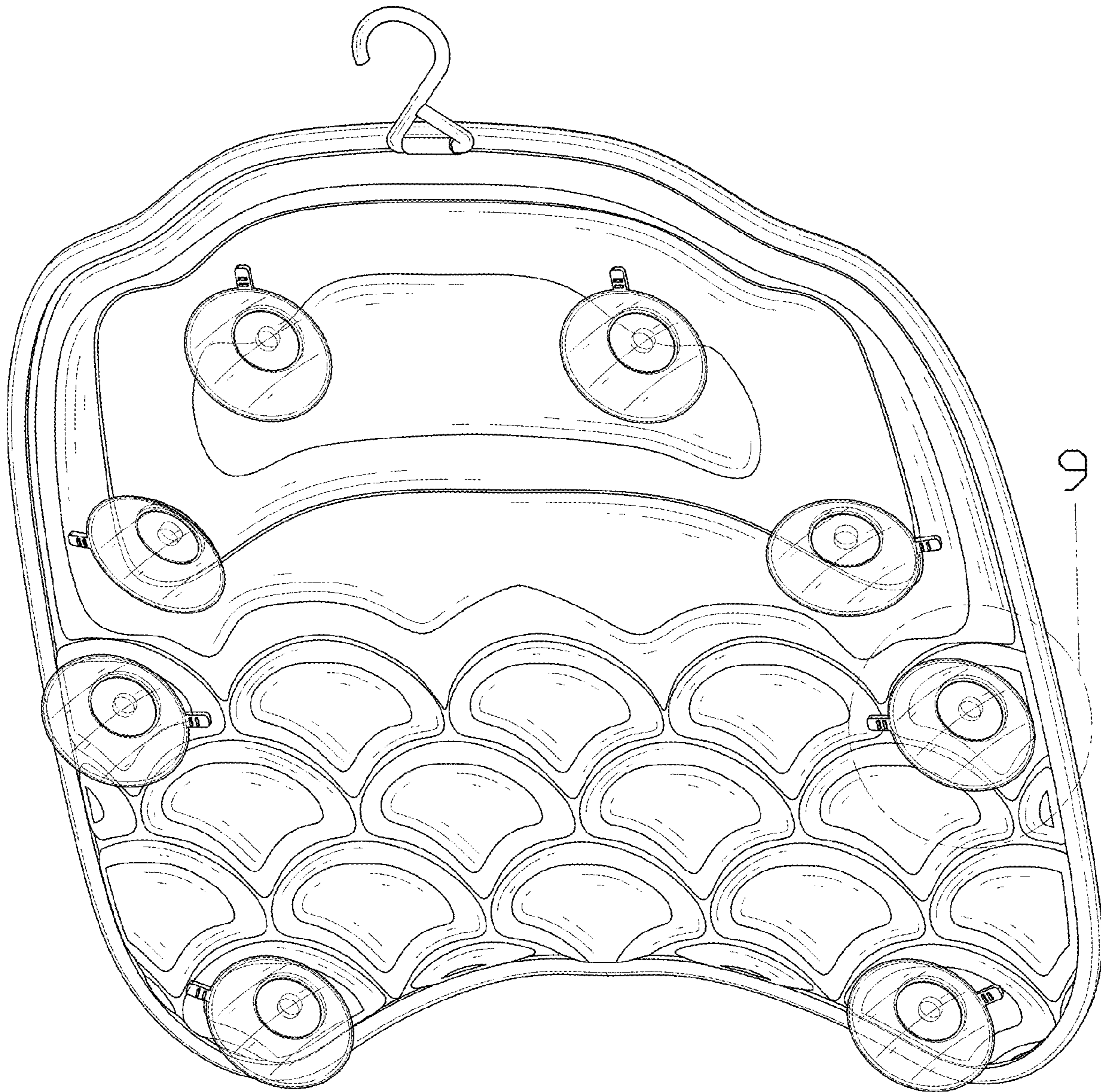

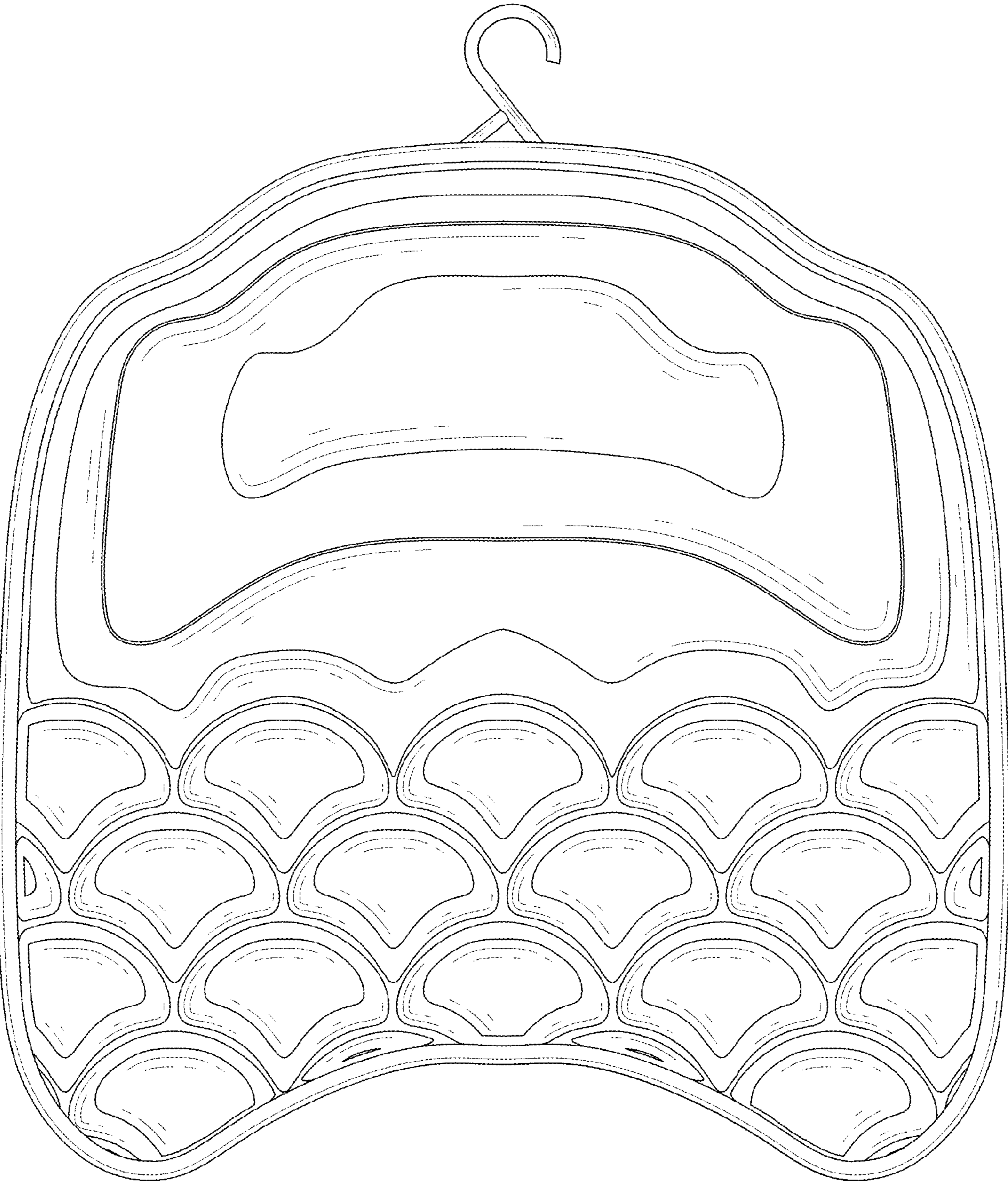

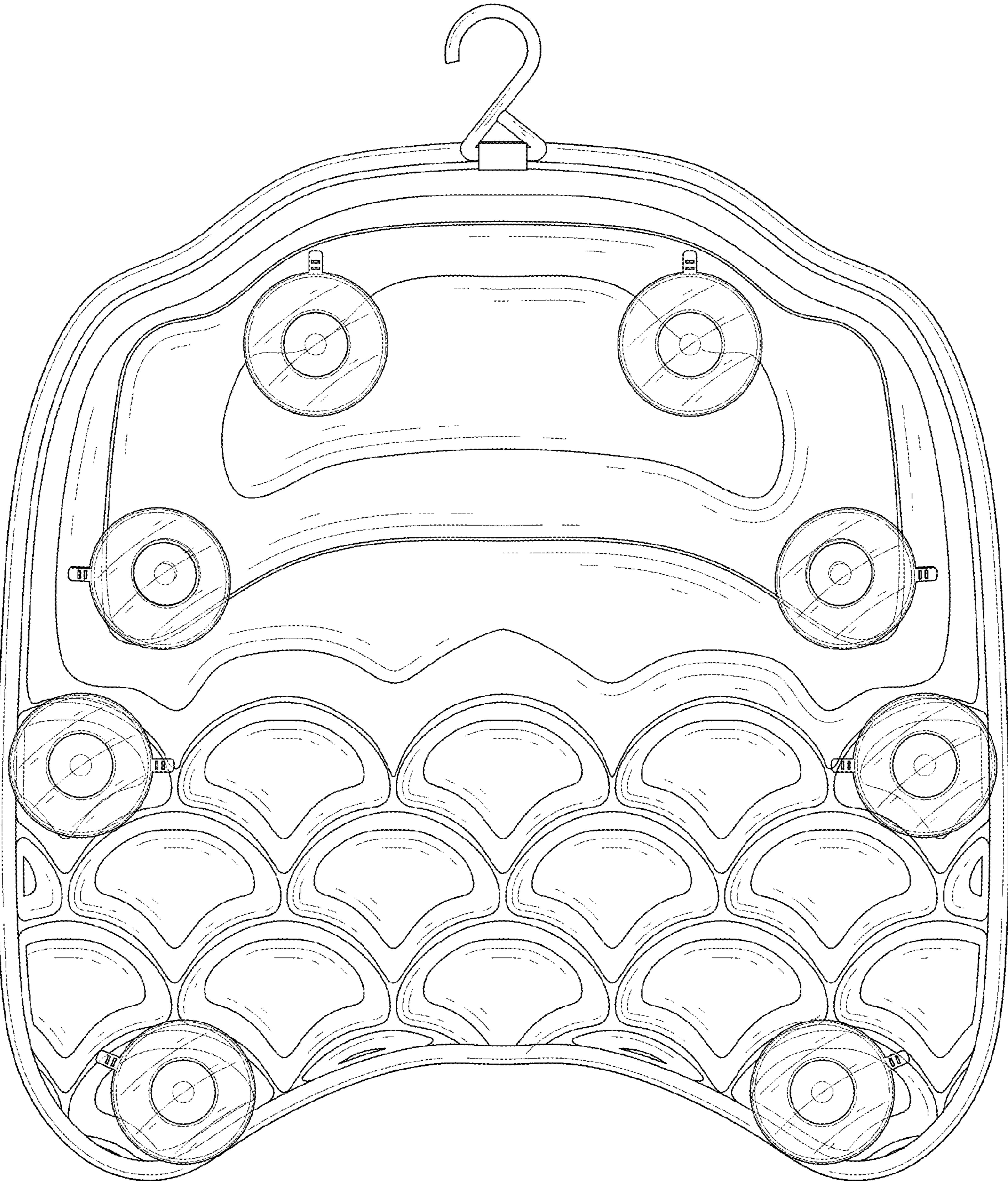

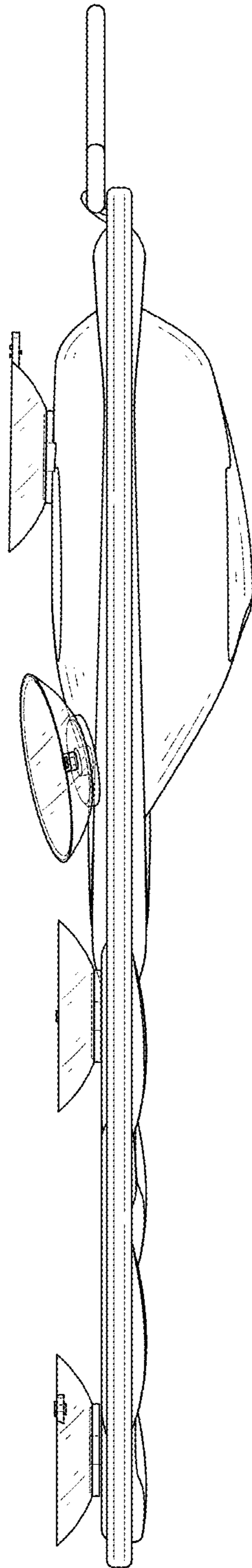

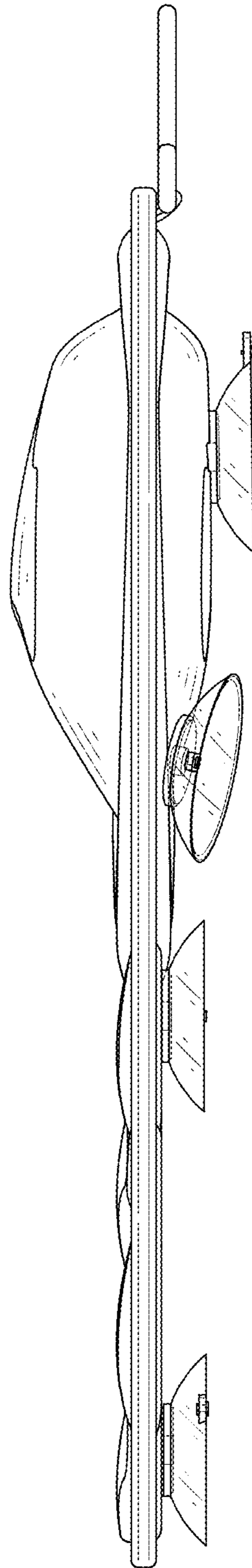

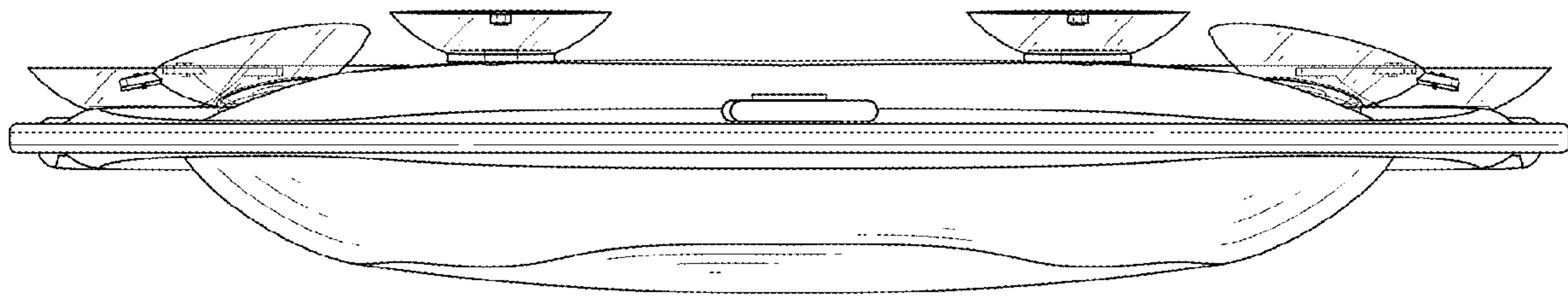

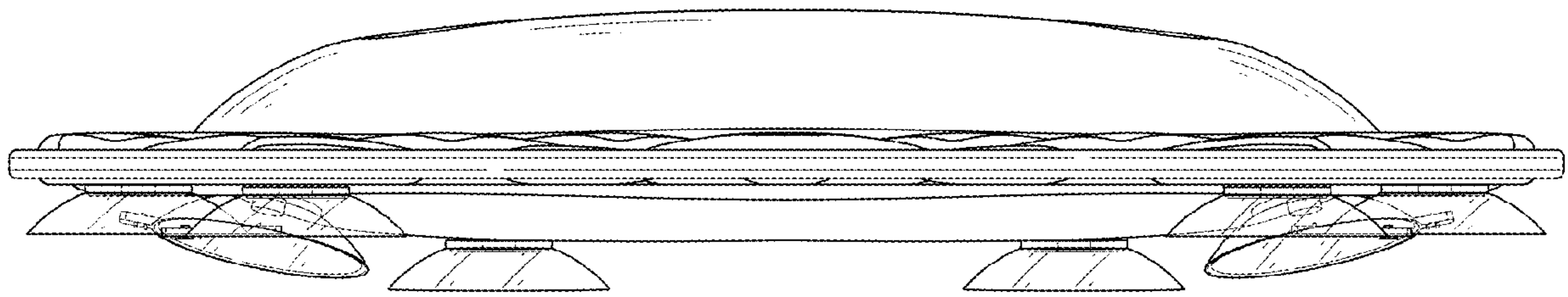

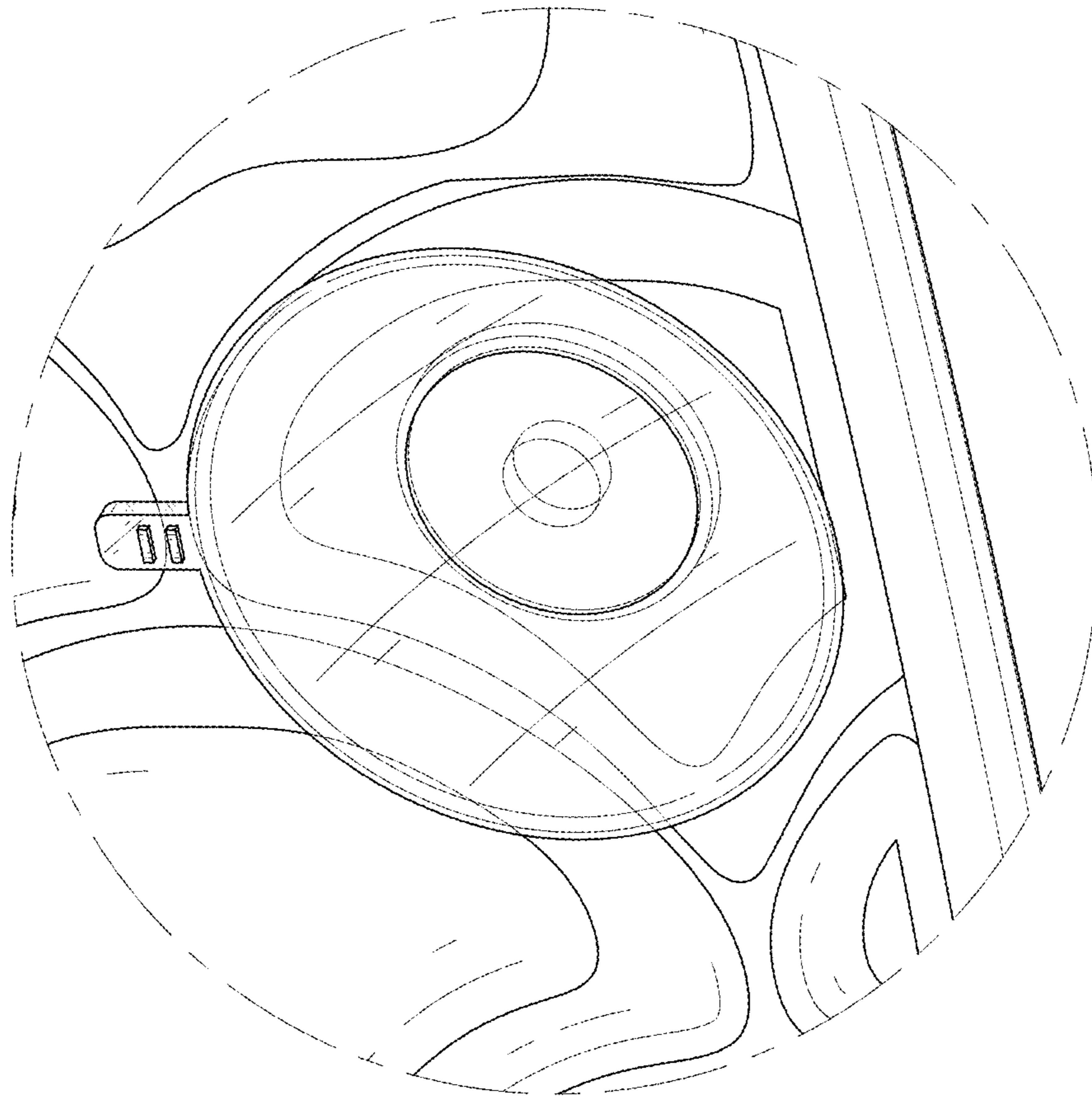
