The ornamental design for an attachment for power tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an attachment for power tool showing our new design;

FIG. 2 is a right side elevational view of the attachment for power tool of FIG. 1;

FIG. 3 is a left side elevational view of the attachment for power tool of FIG. 1;

FIG. 4 is a front side elevational view of the attachment for power tool of FIG. 1;

FIG. 5 is a rear side elevational view of the attachment for power tool of FIG. 1;

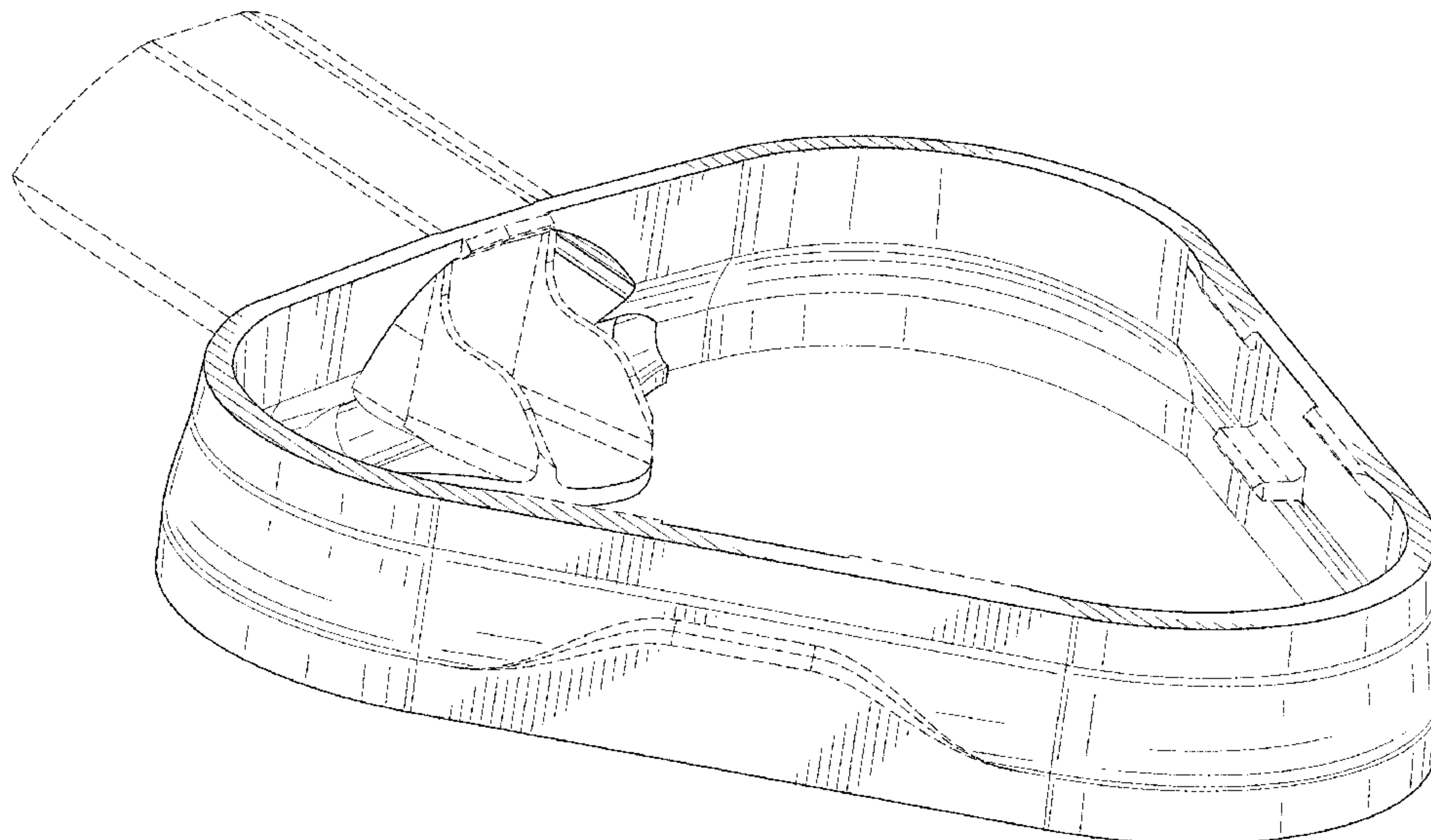
FIG. 6 is a top plan view of the attachment for power tool of FIG. 1; and,

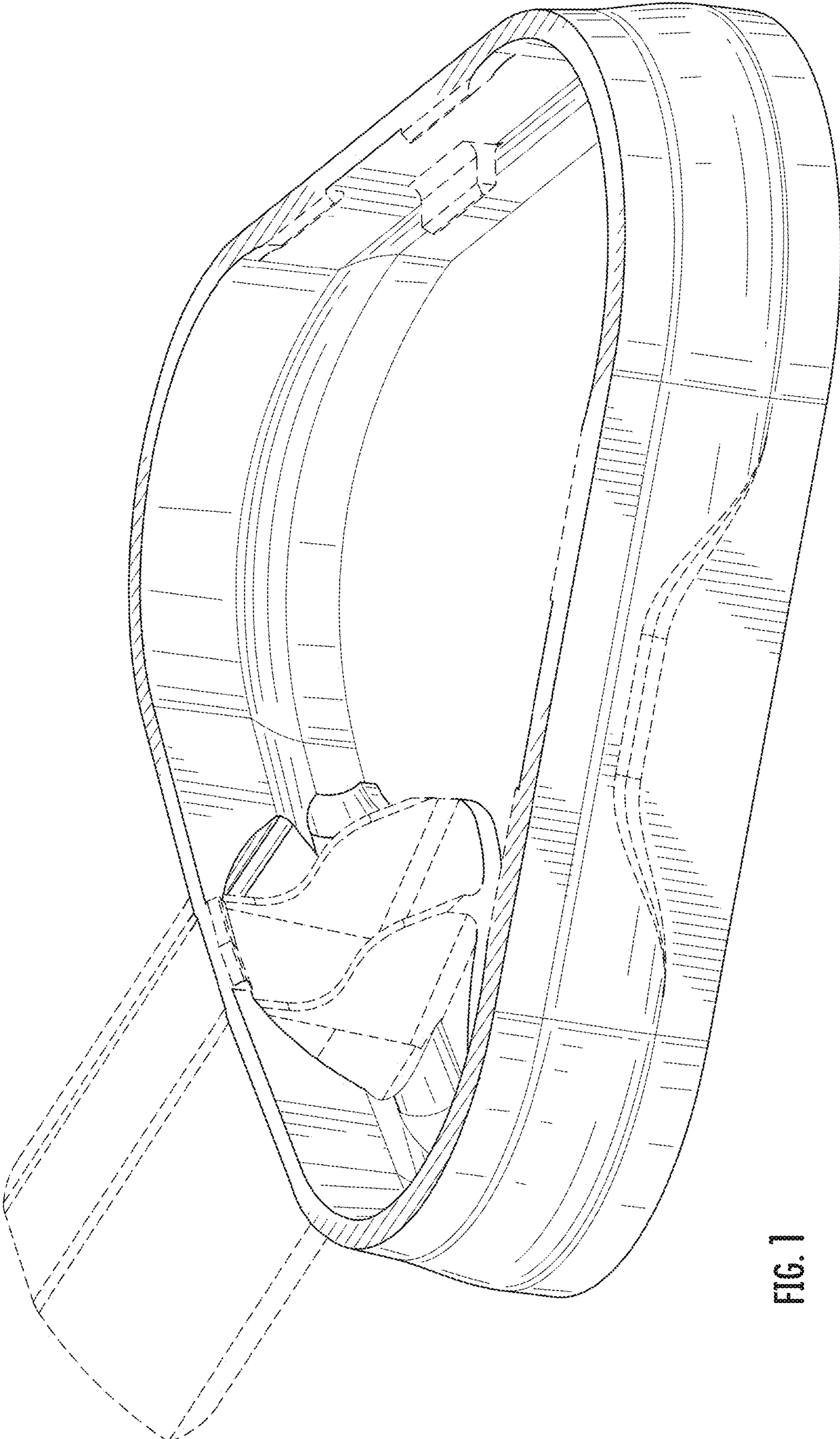

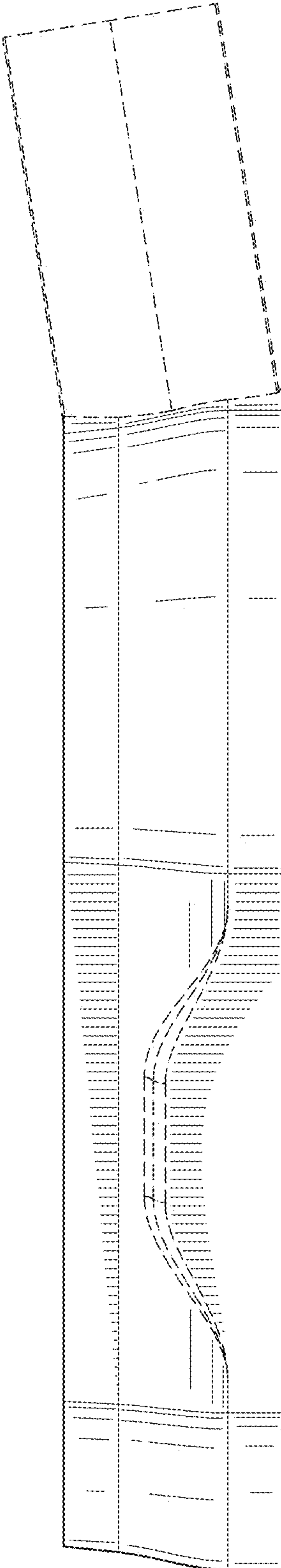

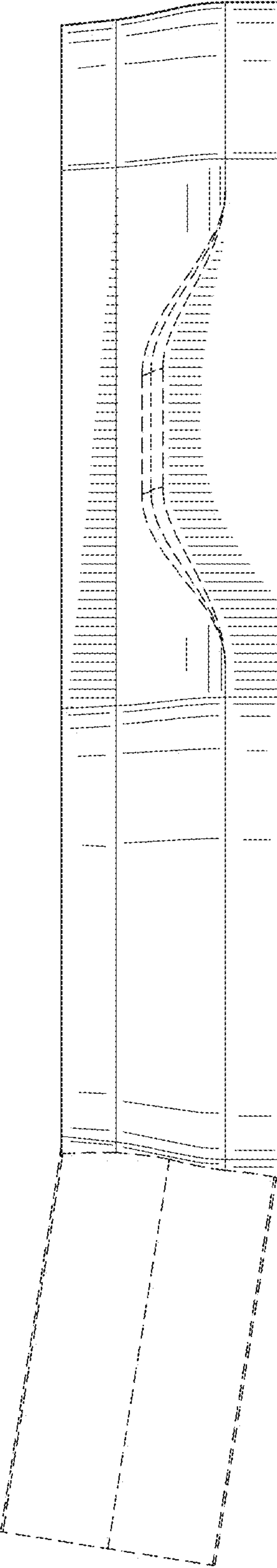

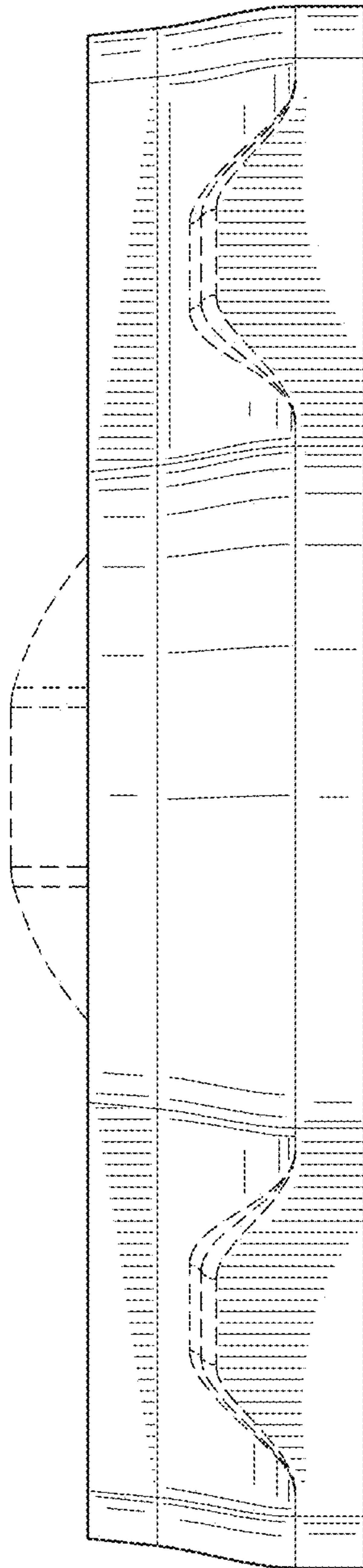

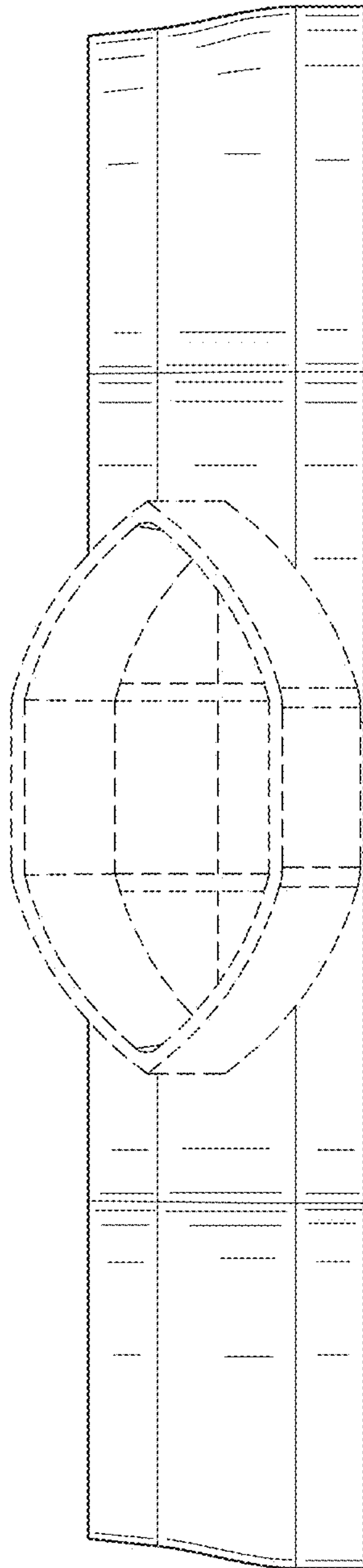

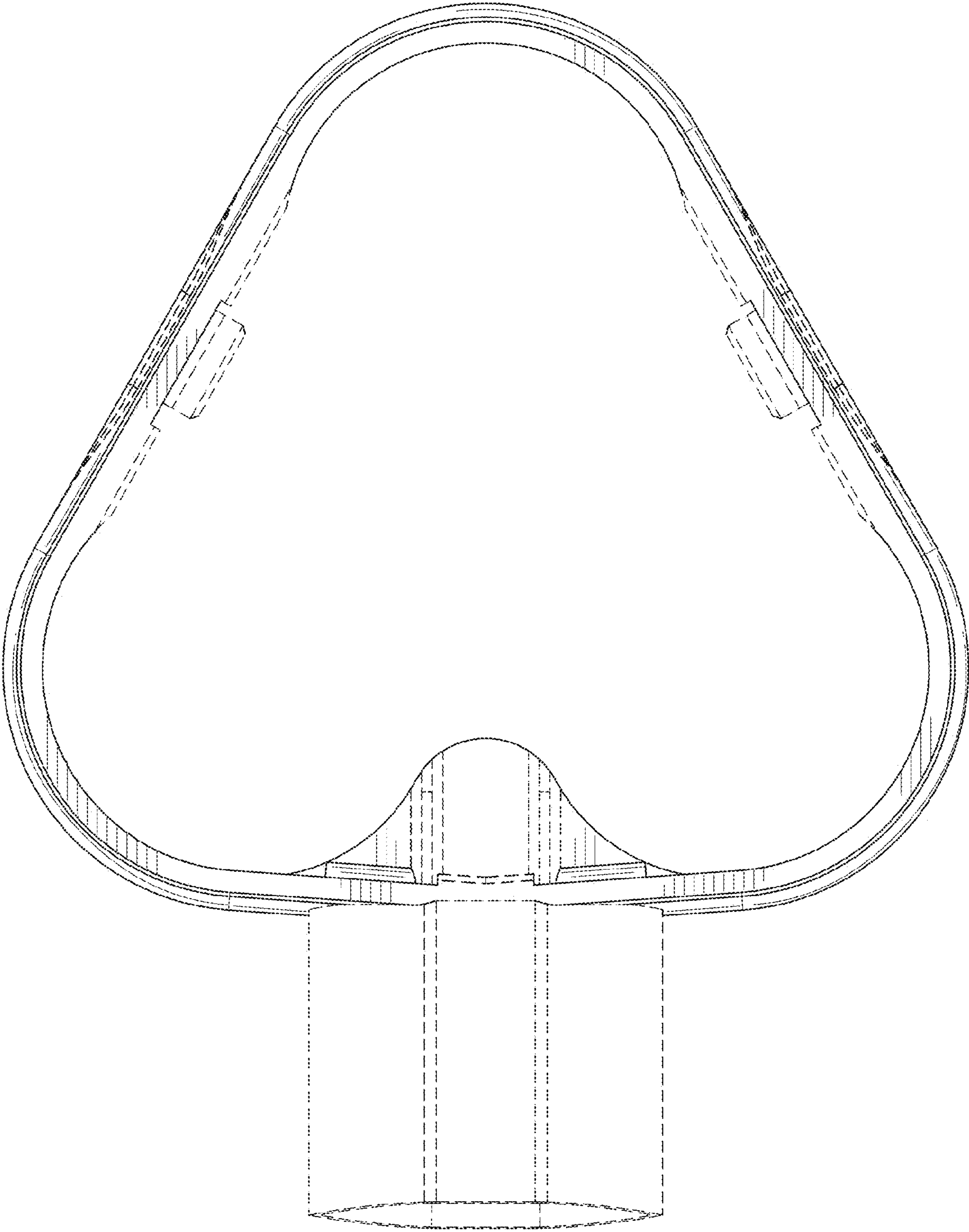

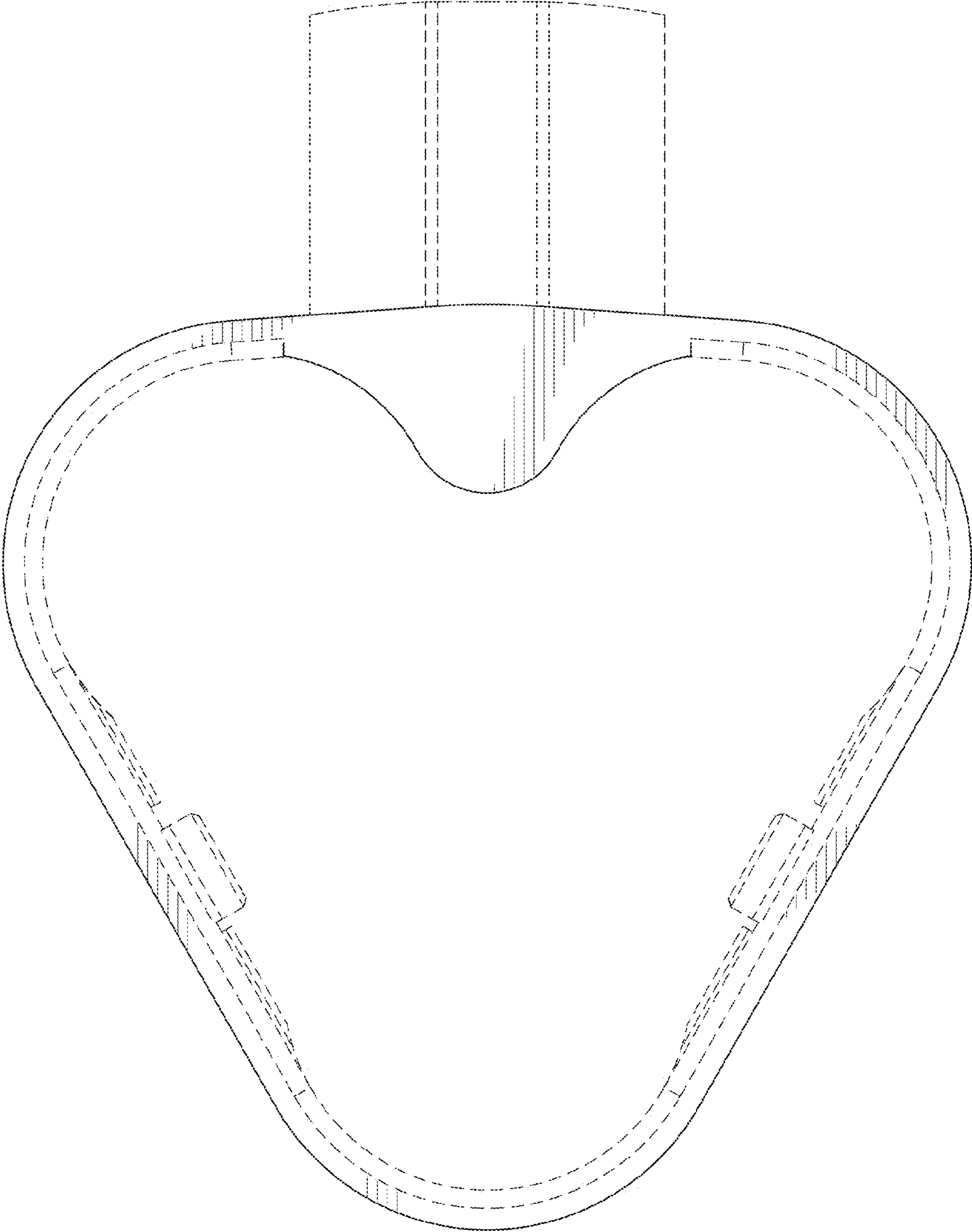
