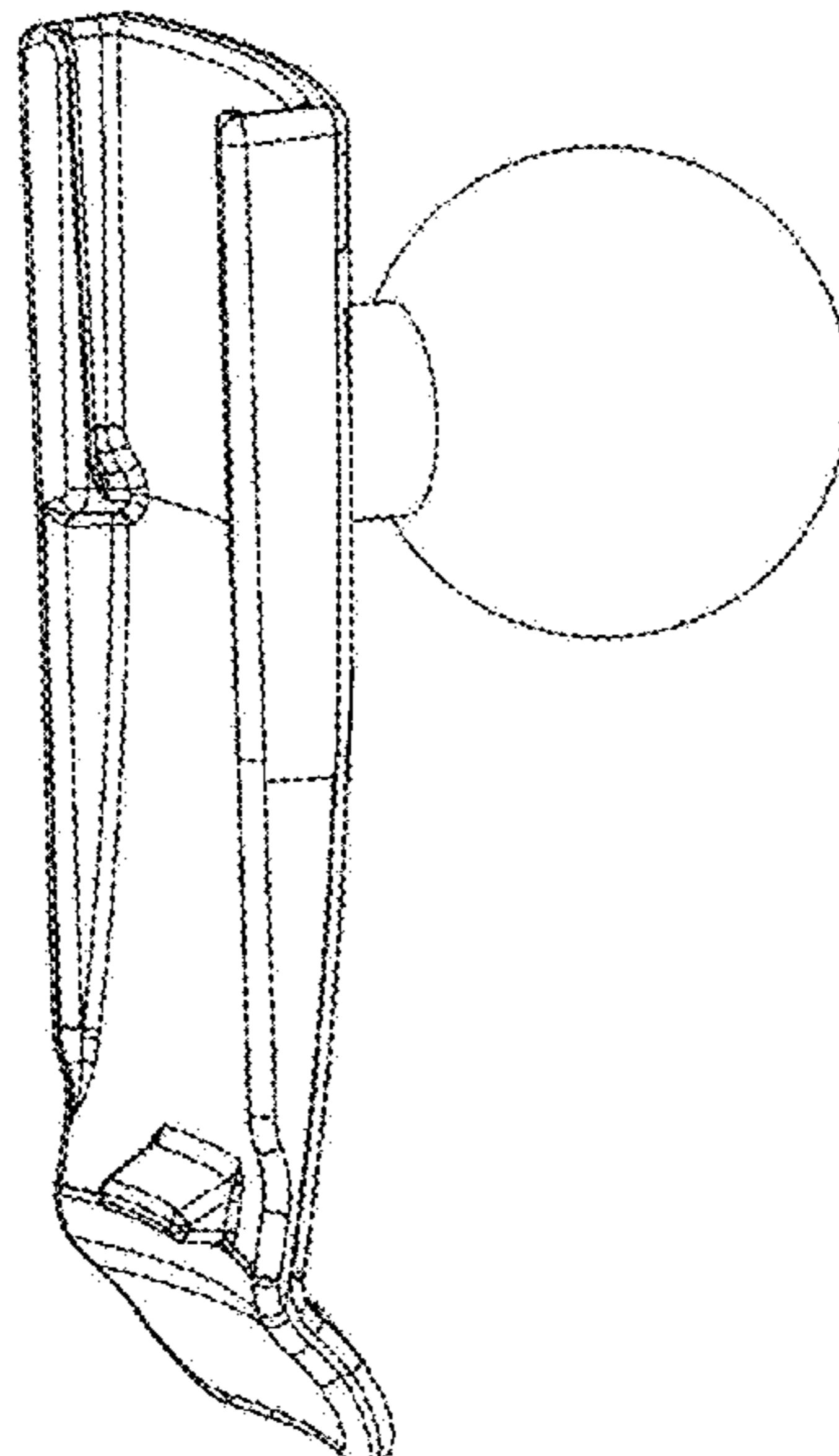
(57) **CLAIM**

The ornamental design for a mounting device with attached ball, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view showing a mounting device with attached ball according to the invention; FIG. 2 is a front right perspective view showing the mounting device with attached ball of FIG. 1; FIG. 3 is a back right perspective view showing the mounting device with attached ball of FIG. 1; FIG. 4 is a back left perspective view showing the mounting device with attached ball of FIG. 1; FIG. 5 is a front elevation view showing the mounting device with attached ball of FIG. 1; and, FIG. 6 is a back elevation view showing the mounting device with attached ball of FIG. 1.

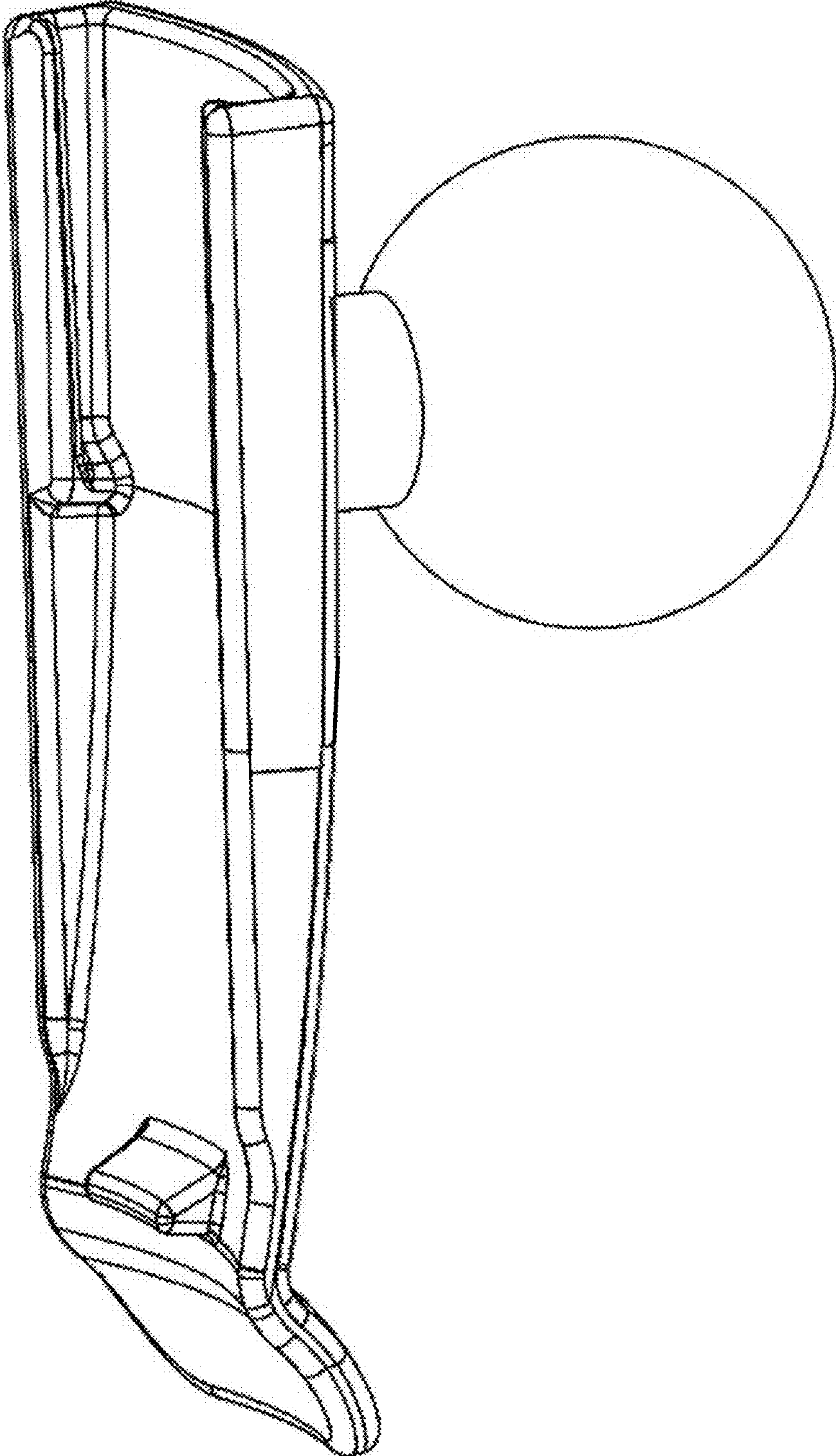

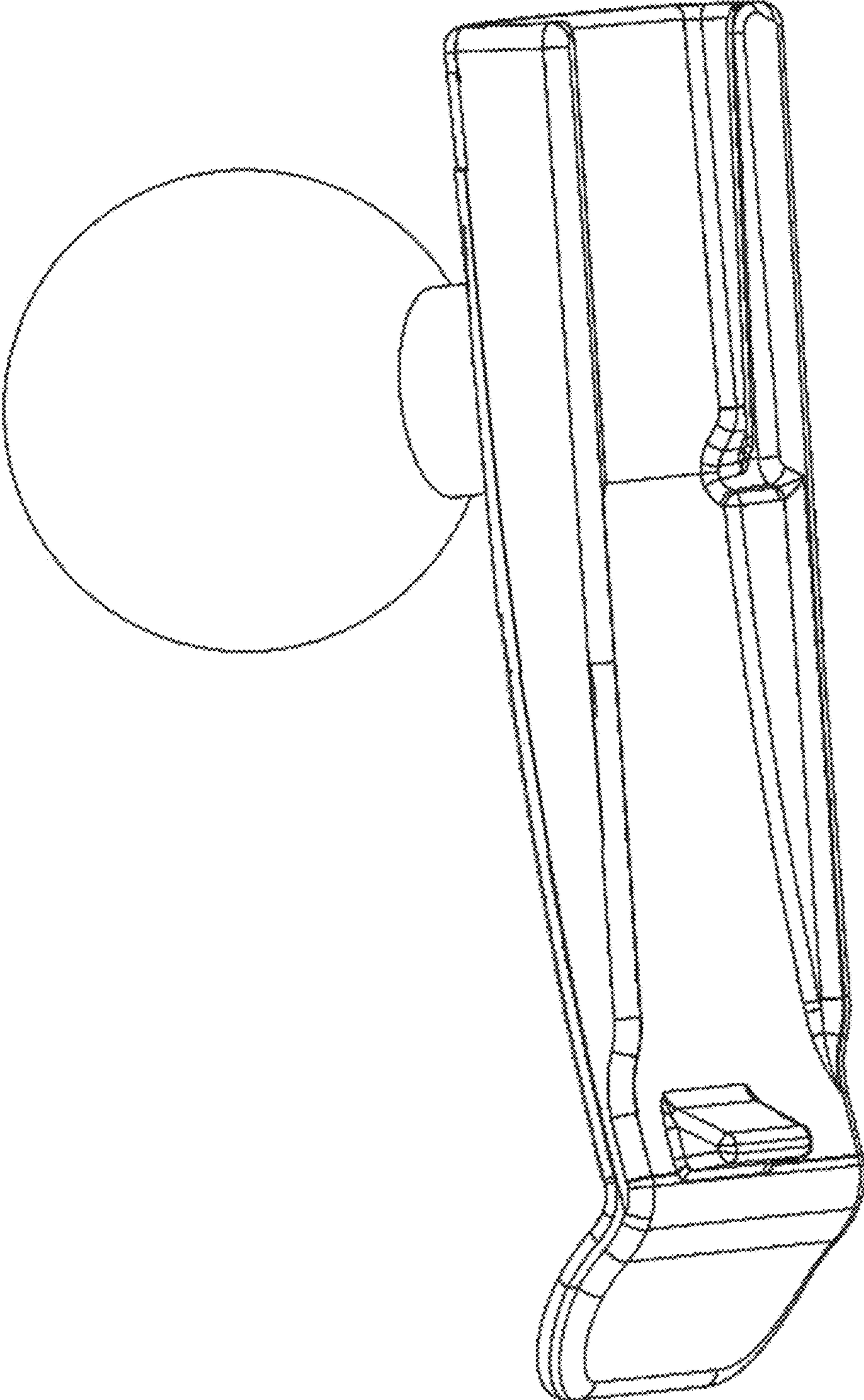

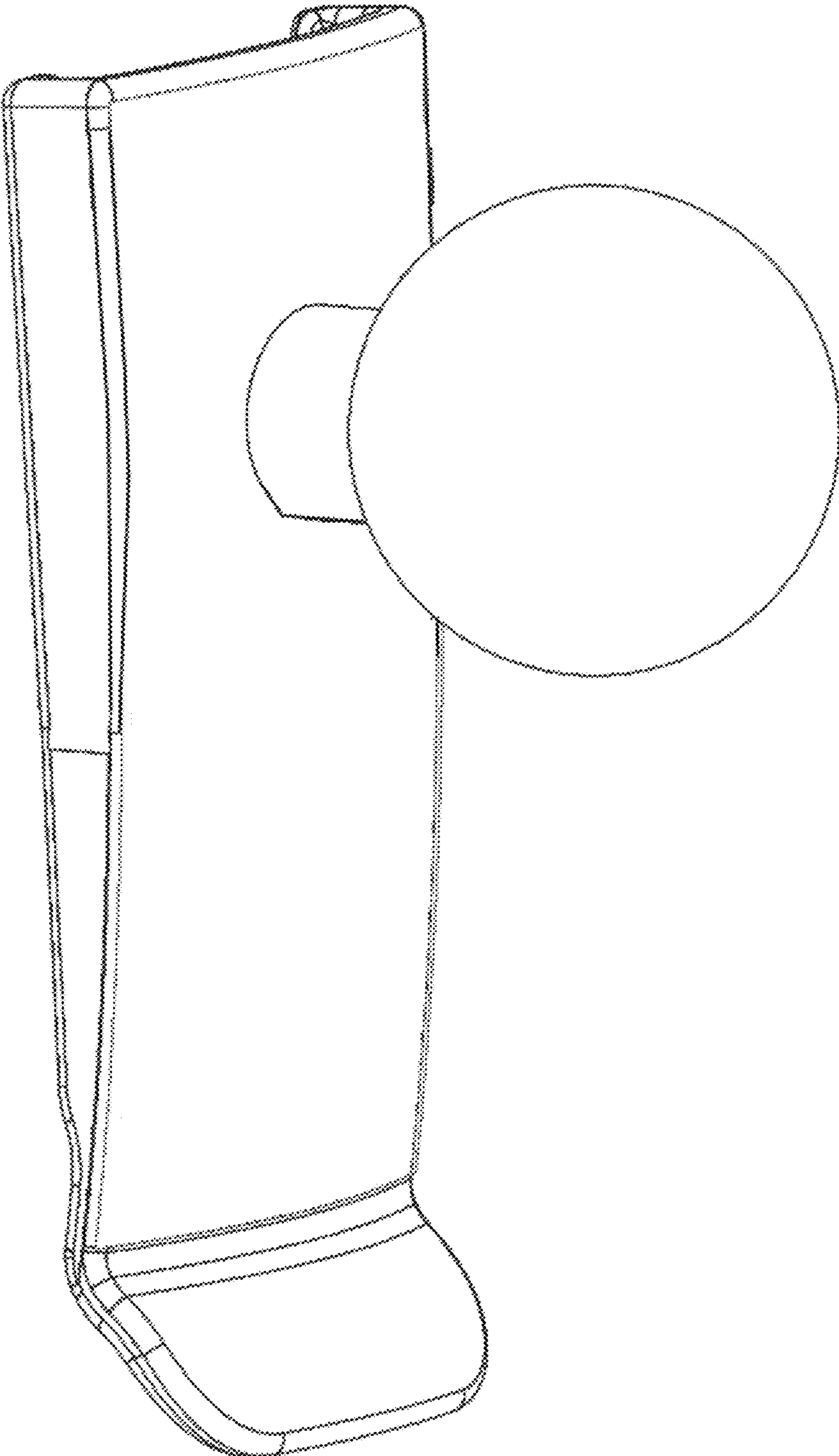

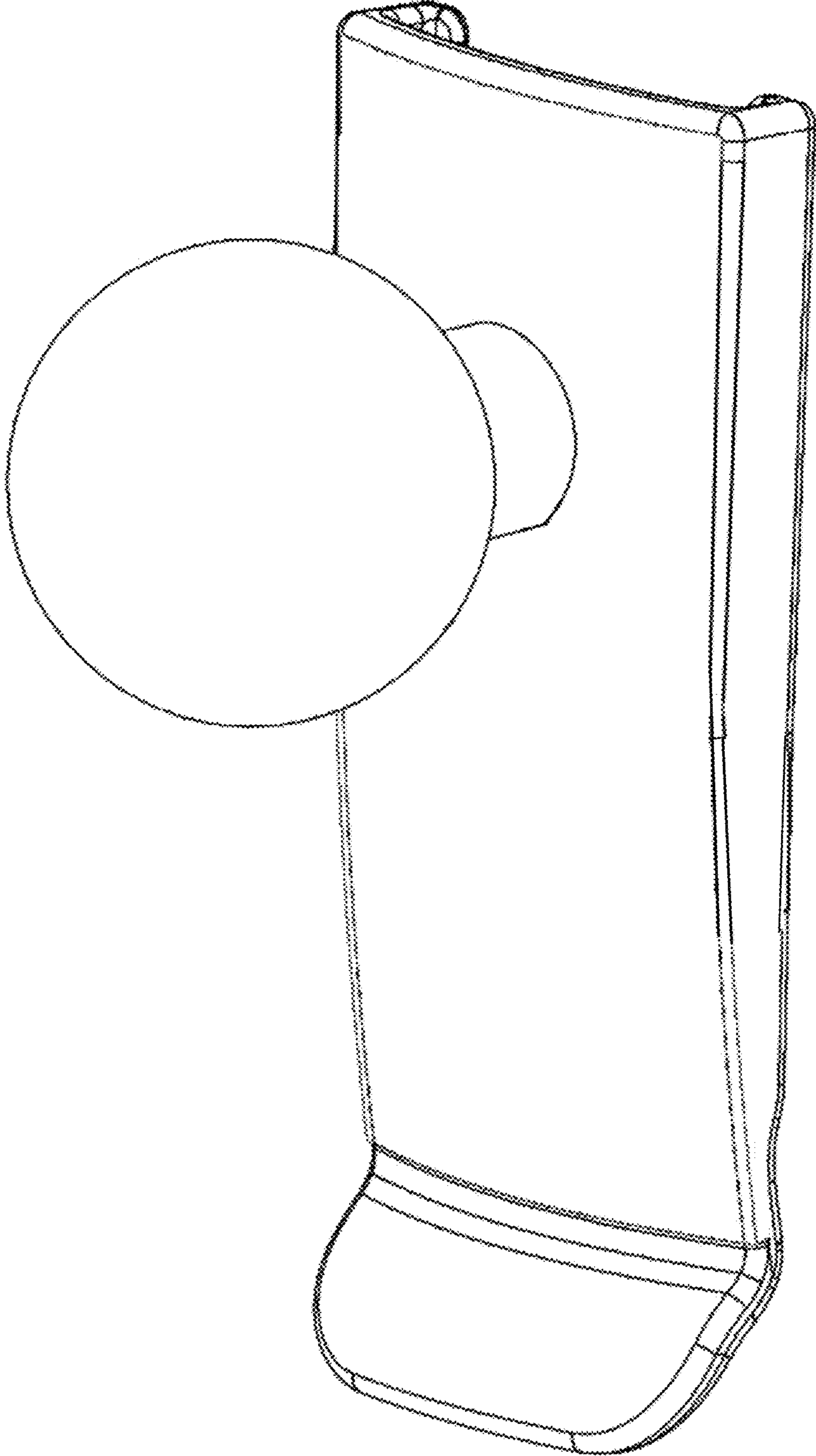

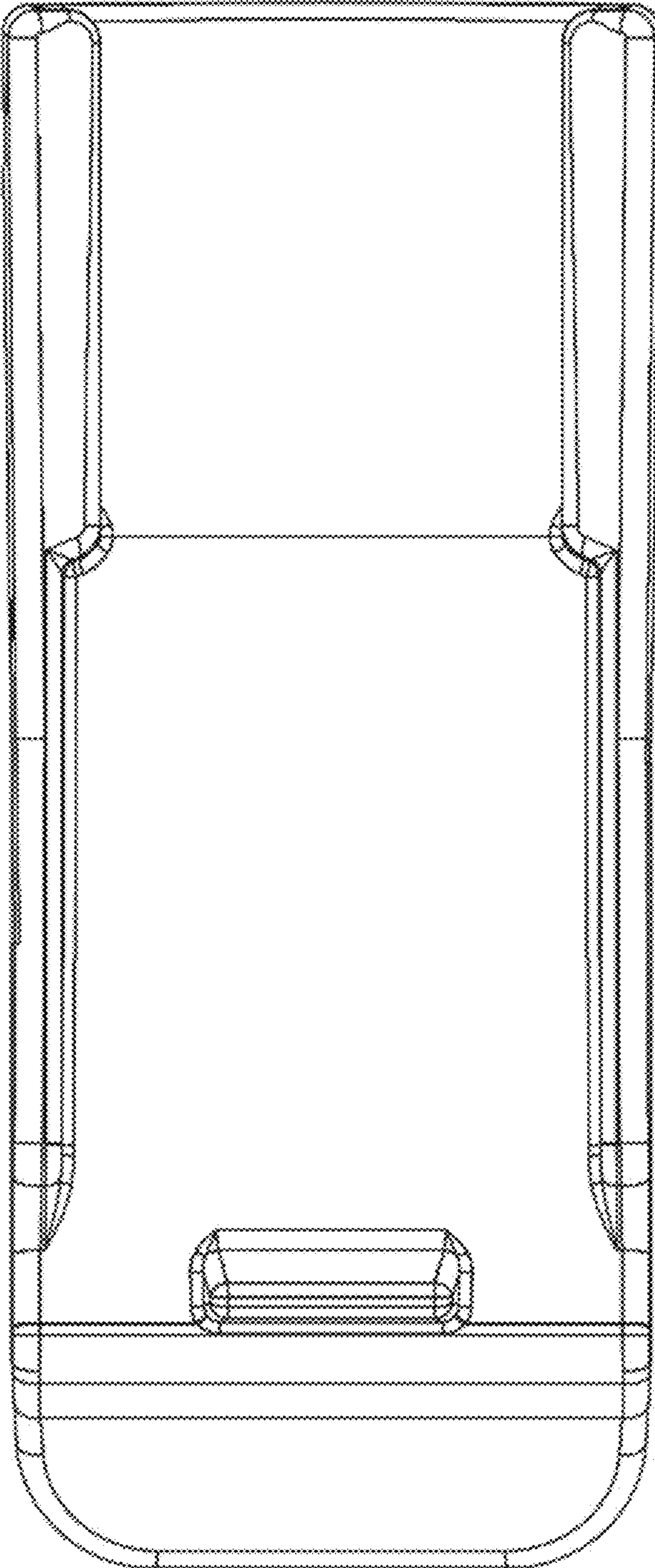

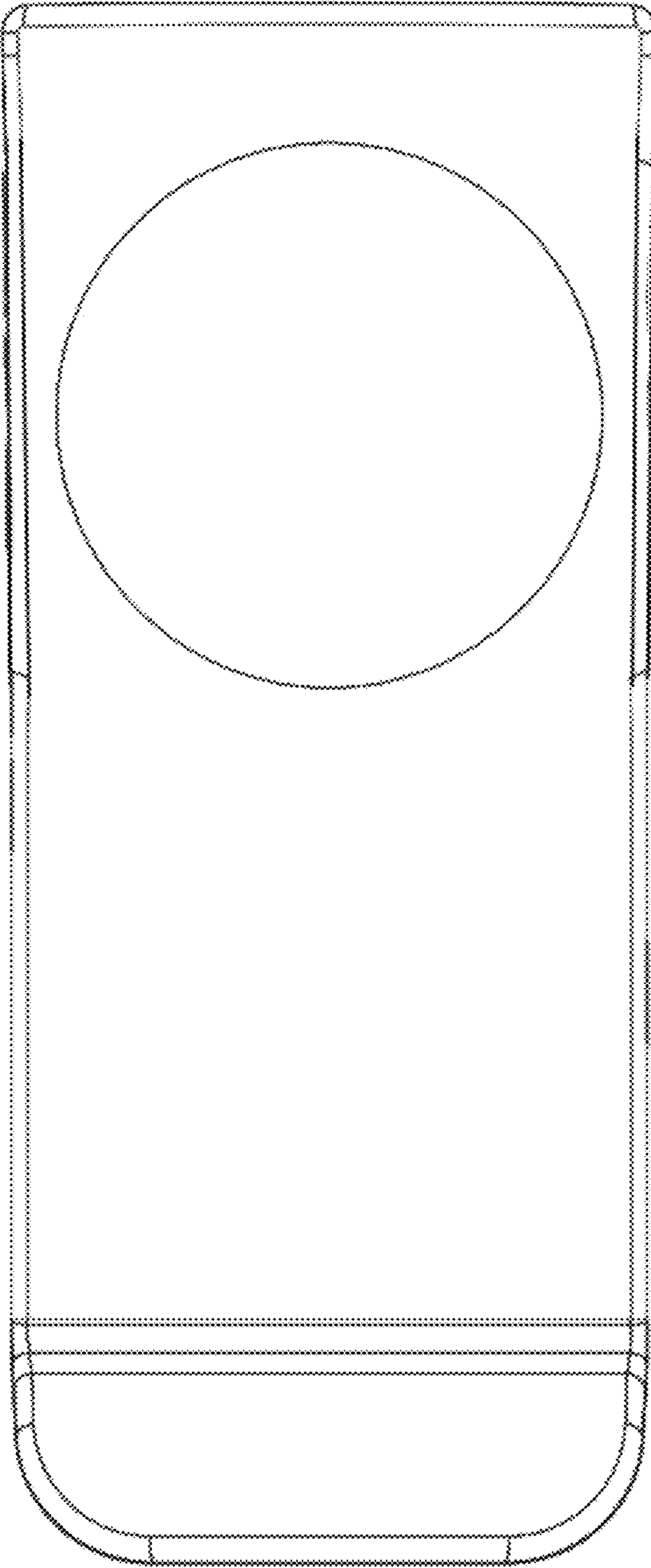
