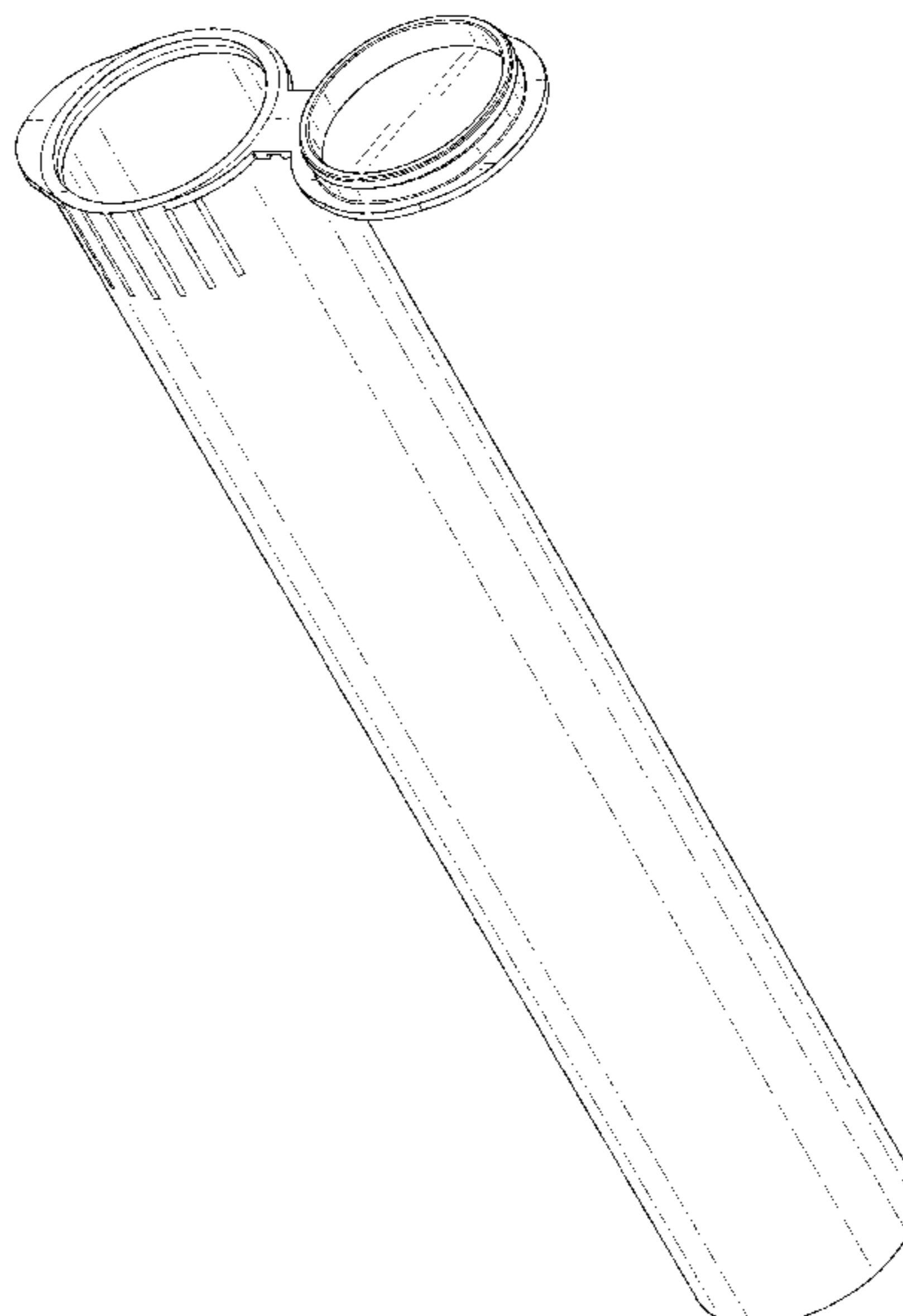
(57) **CLAIM**

I claim the ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the container showing my new design;  
FIG. 2 is a front elevation thereof;

FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top plan view thereof; and,

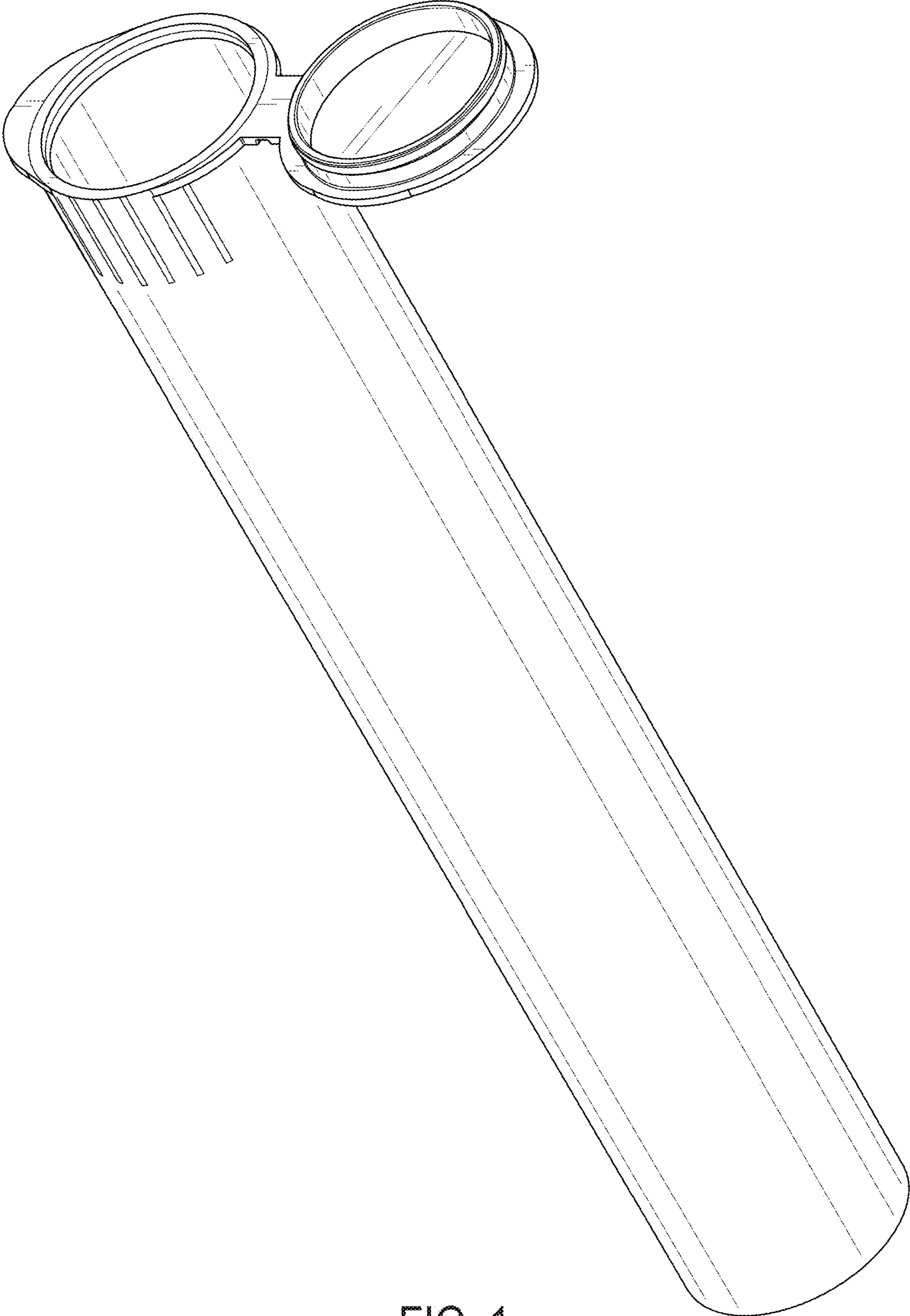

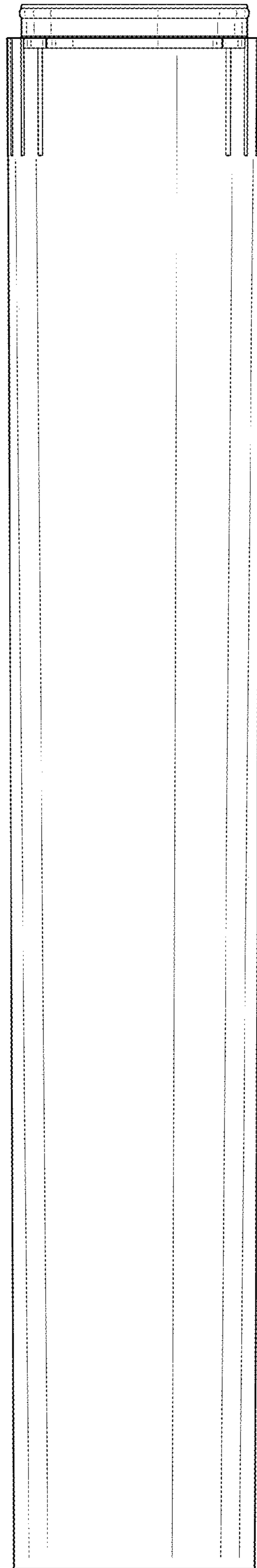

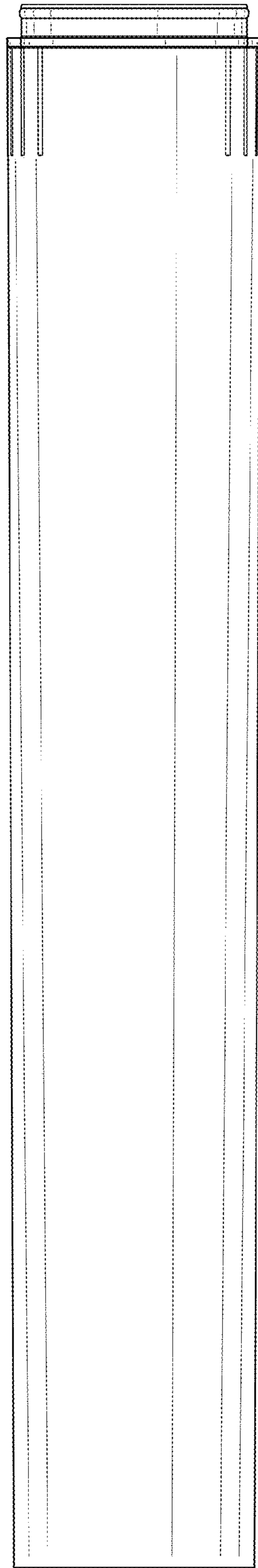

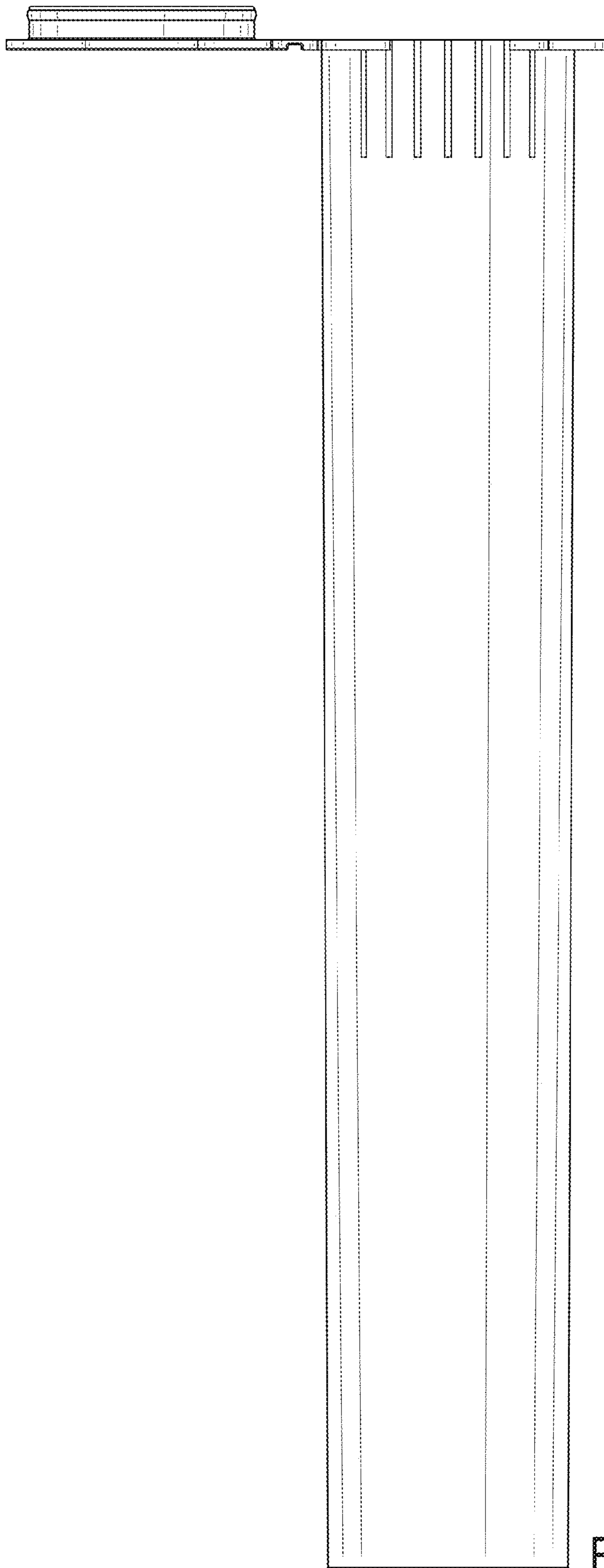

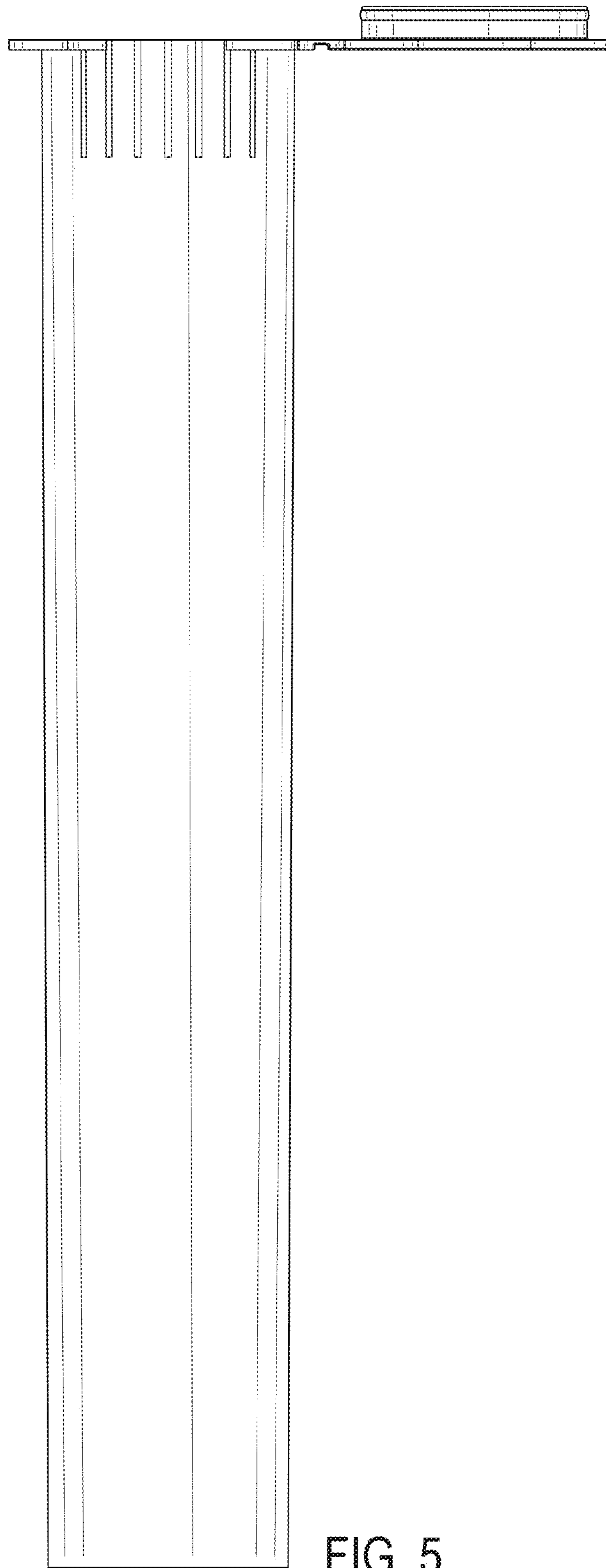

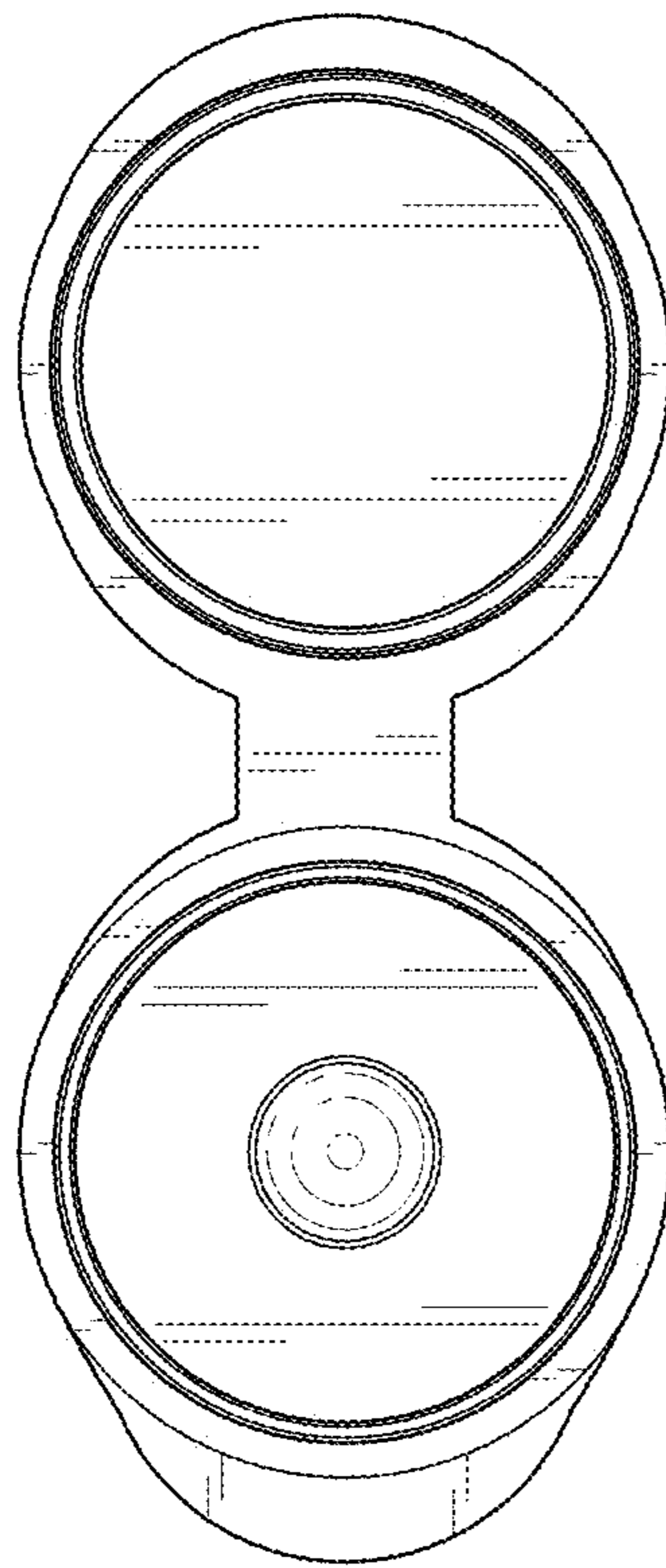

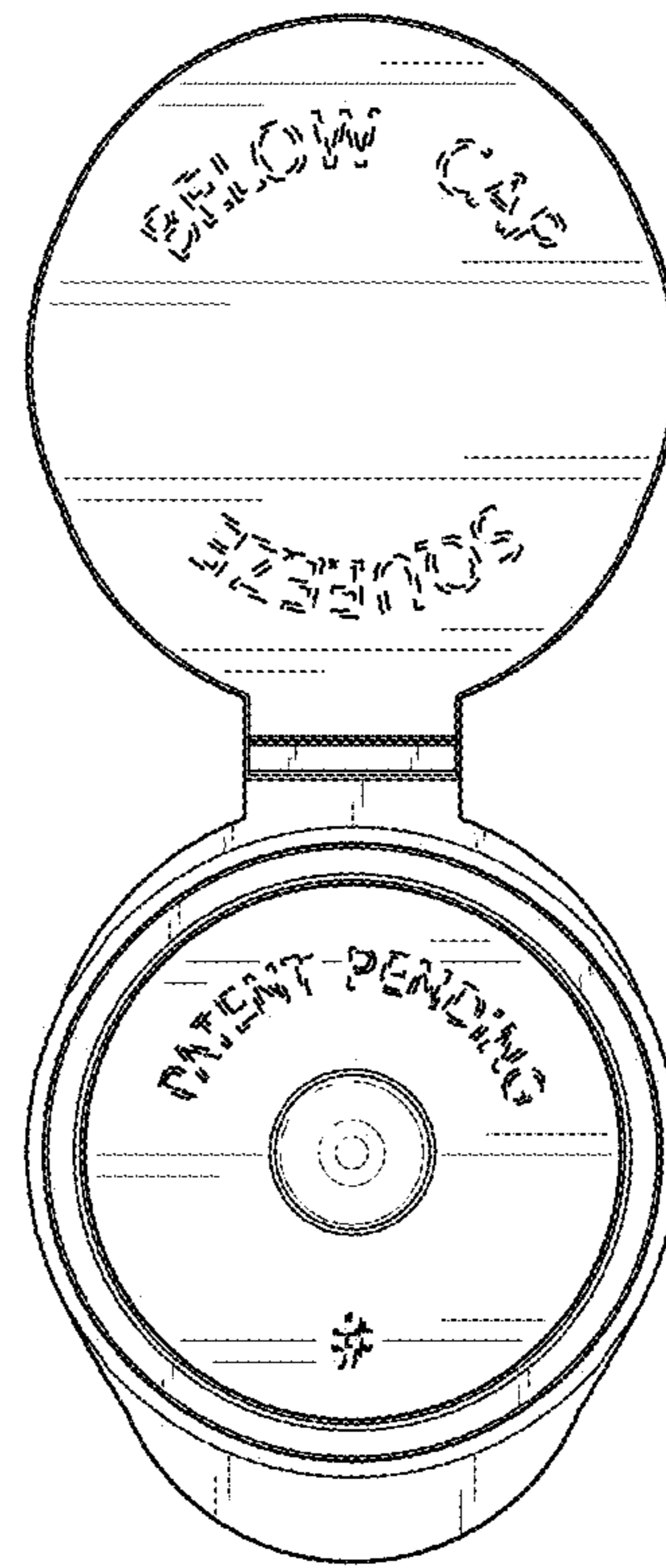
