(57) **CLAIM**

The ornamental design for an automotive interior receptacle, as shown and described.

DESCRIPTION

FIG. 1 is an environmental perspective view showing the front and left side of an automotive interior receptacle in an automobile door;

FIG. 2 is a front elevation view of the automotive interior receptacle;

FIG. 3 is a rear elevation view of the automotive interior receptacle;

FIG. 4 is a top plan view of the automotive interior receptacle;

FIG. 5 is a bottom plan view of the automotive interior receptacle;

FIG. 6 is a left side view of the automotive interior receptacle;

FIG. 7 is a right side view of the automotive interior receptacle;

FIG. 8 is an environmental perspective view showing the front and left side of a first alternate automotive interior receptacle in an automobile door;

FIG. 9 is a front elevation view of the first alternate automotive interior receptacle;

FIG. 10 is a rear elevation view of the first alternate automotive interior receptacle;

FIG. 11 is a top plan view of the first alternate automotive interior receptacle;

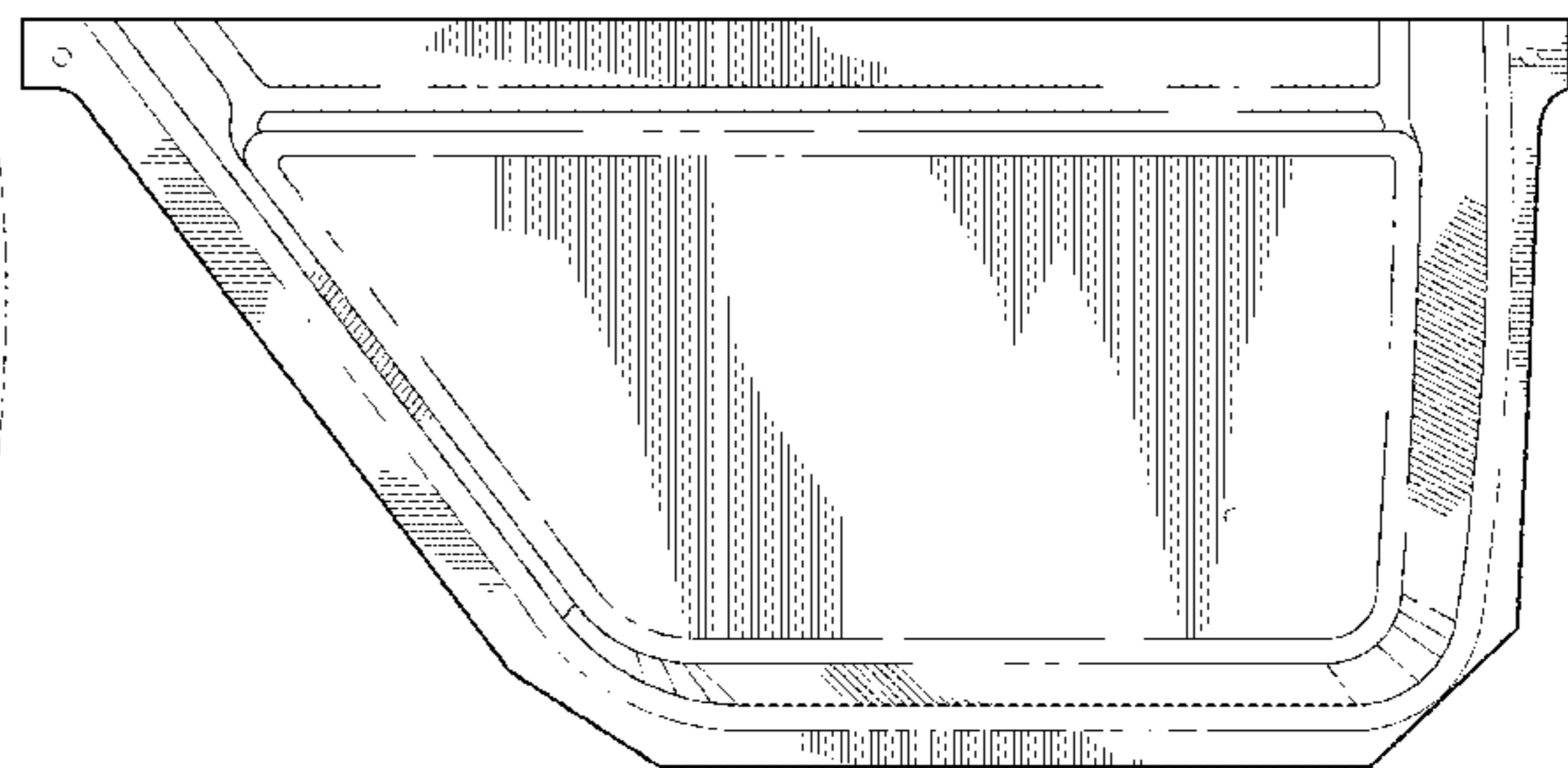
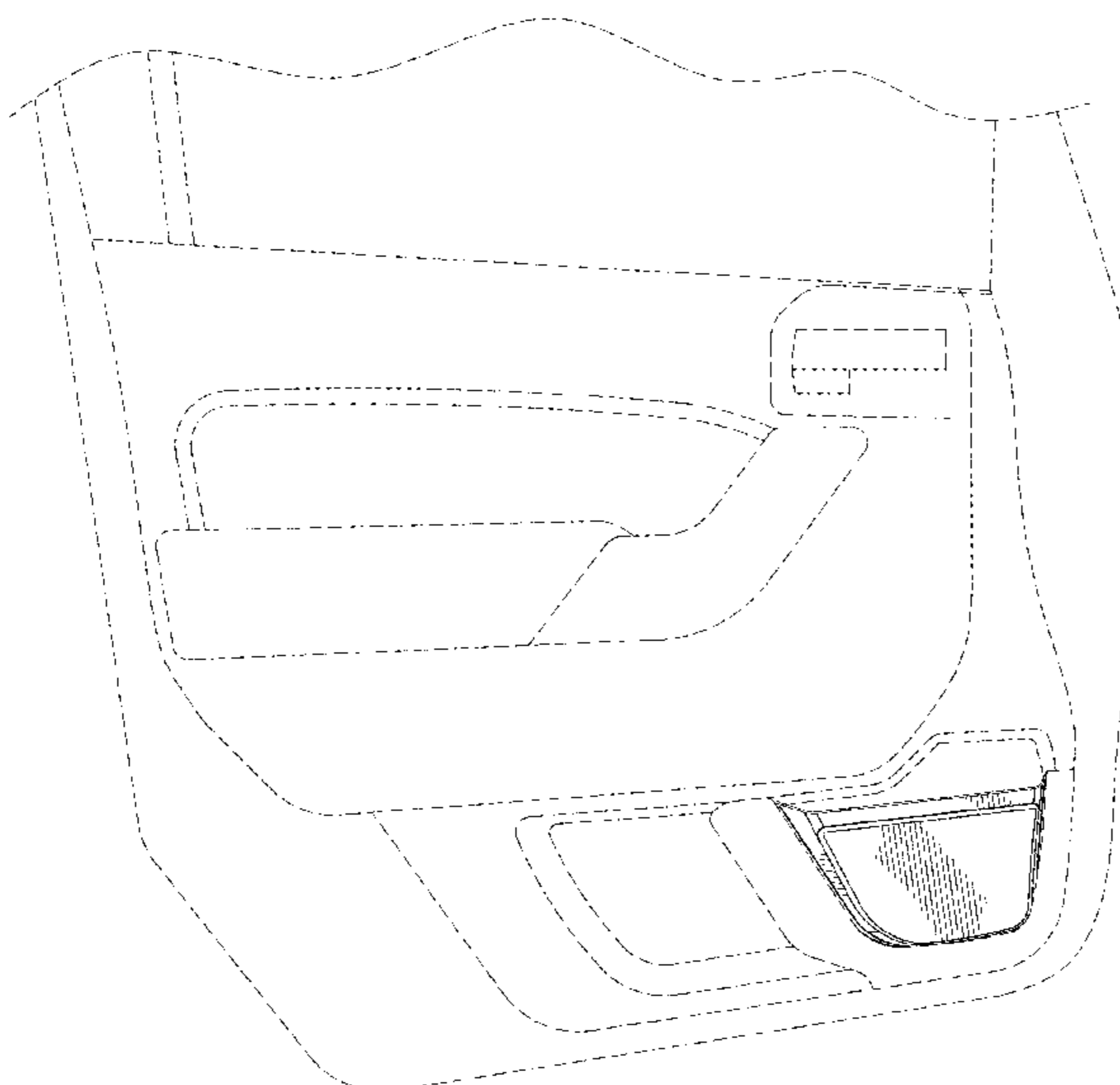
FIG. 12 is a bottom plan view of the first alternate automotive interior receptacle;

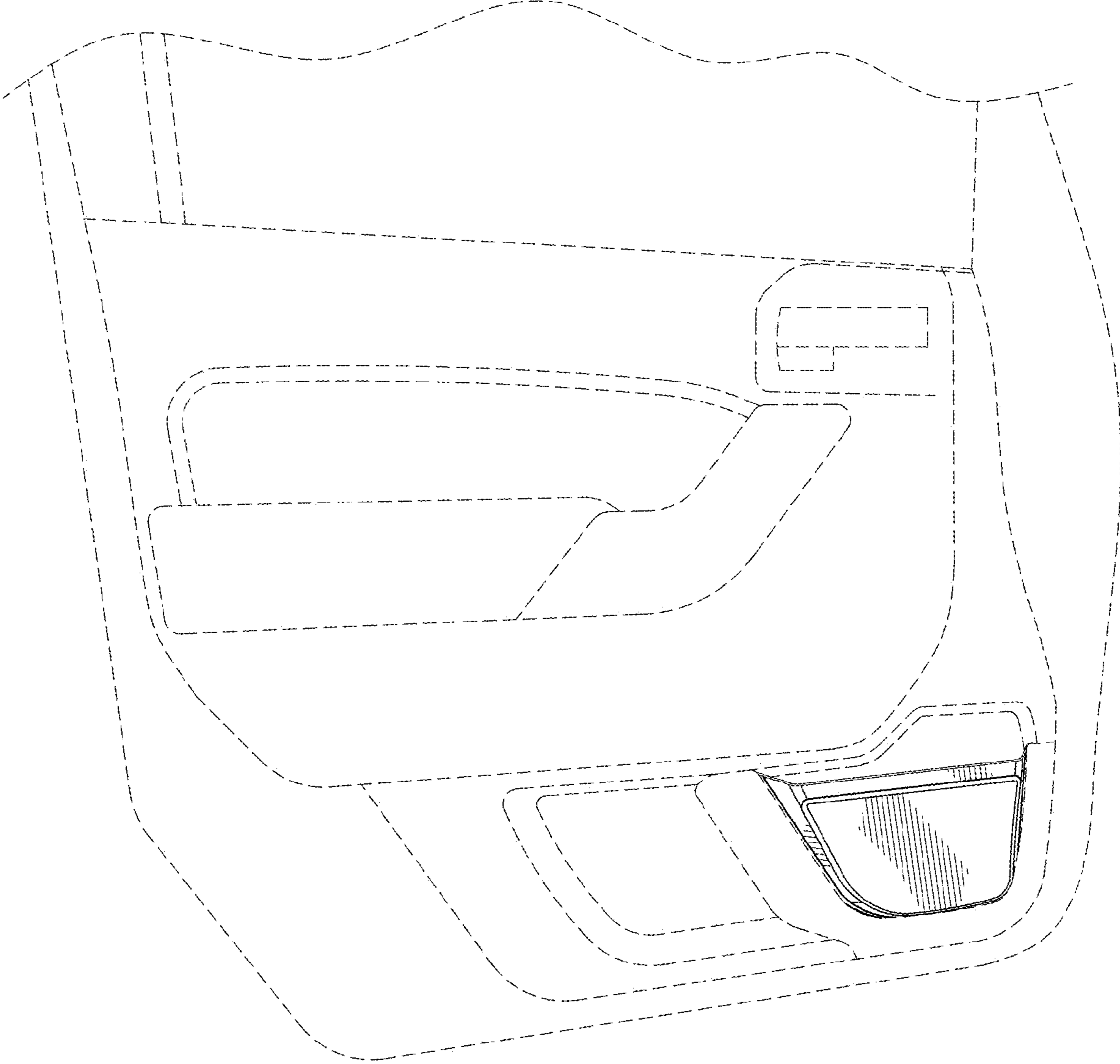

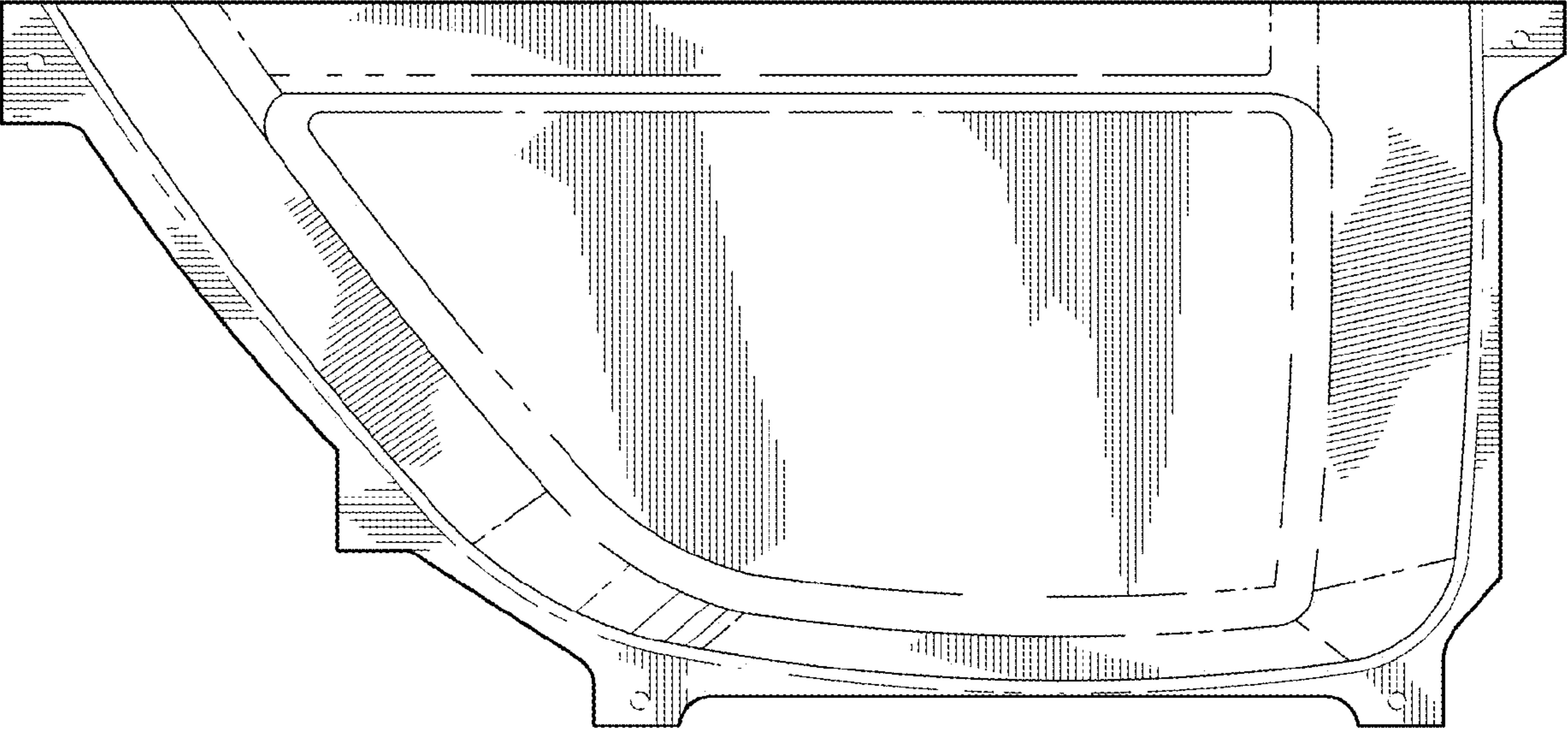

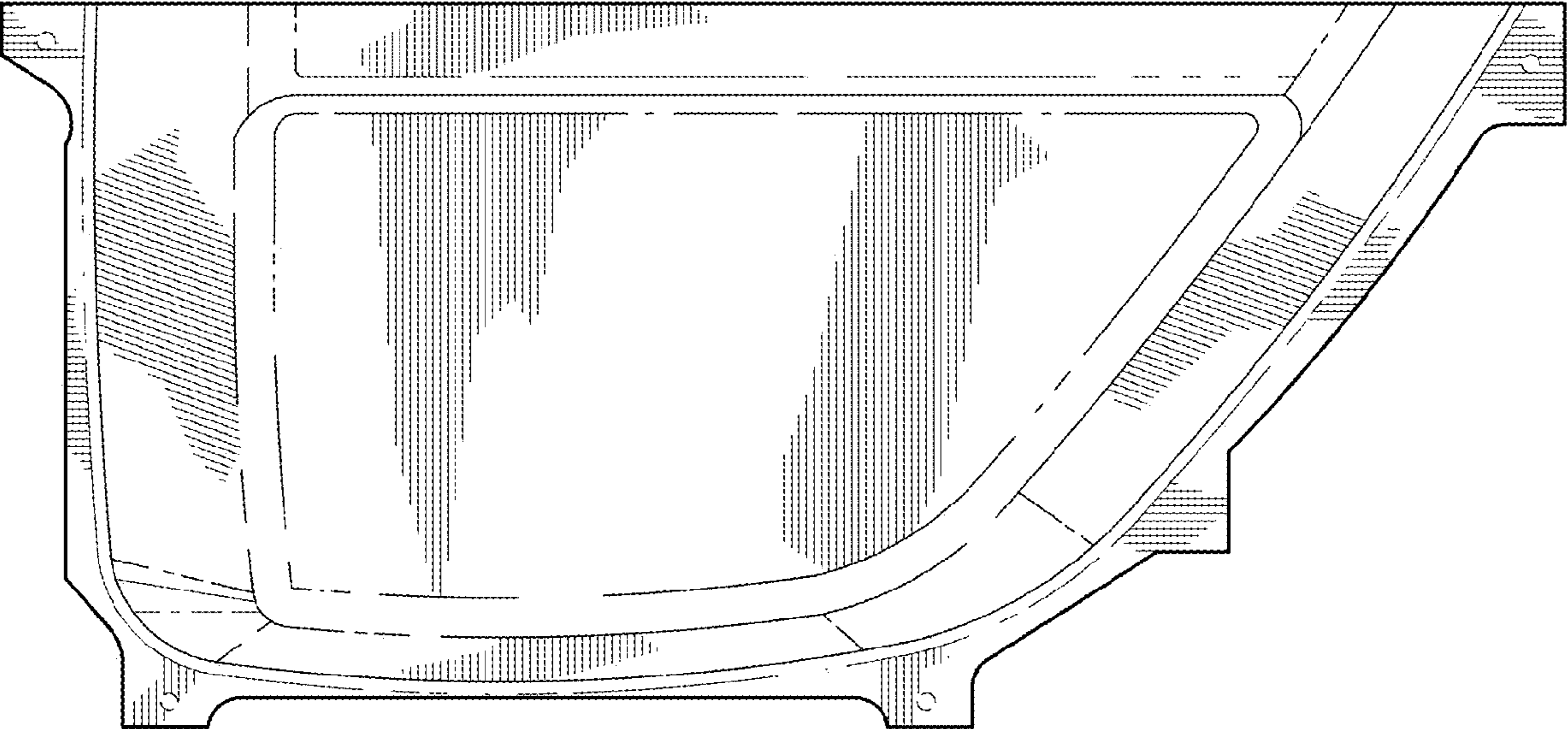

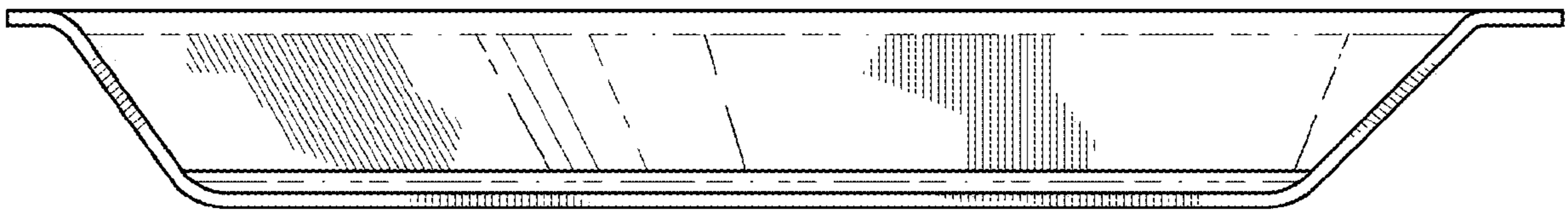

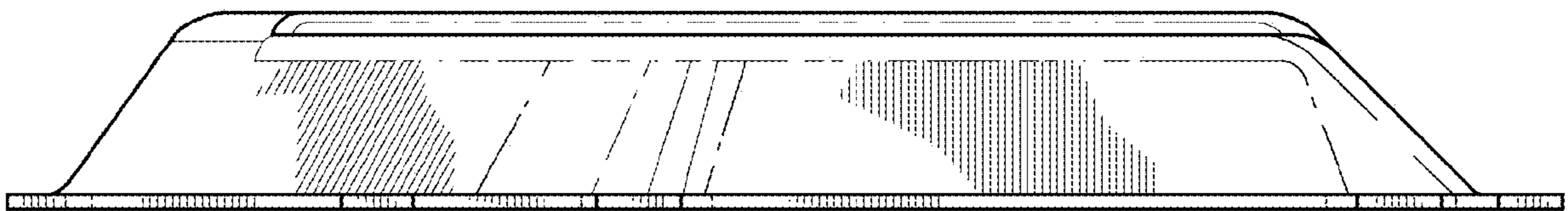

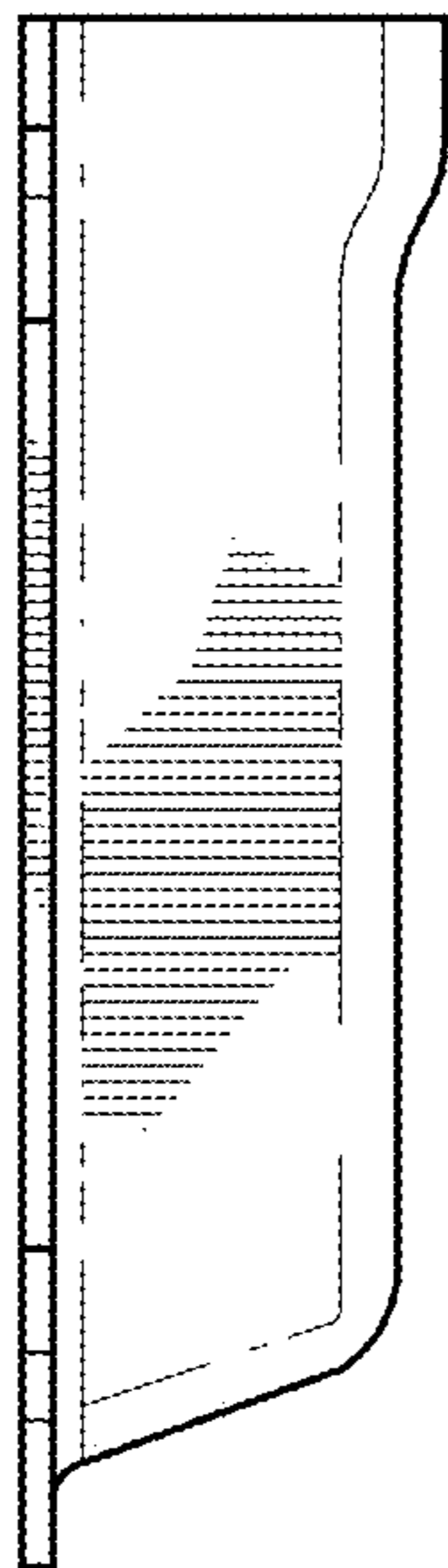

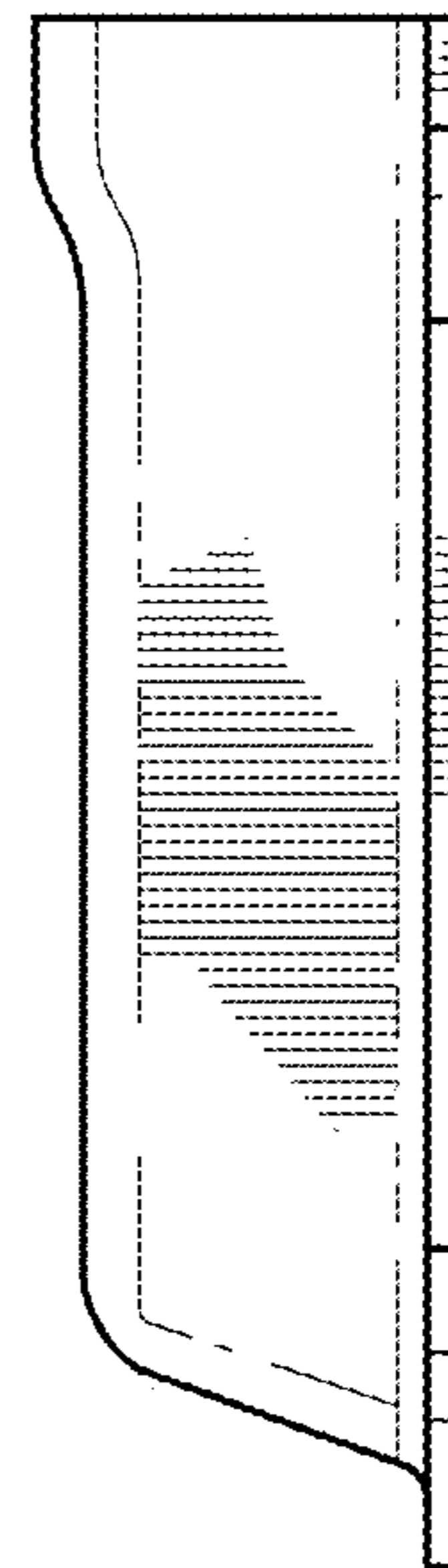

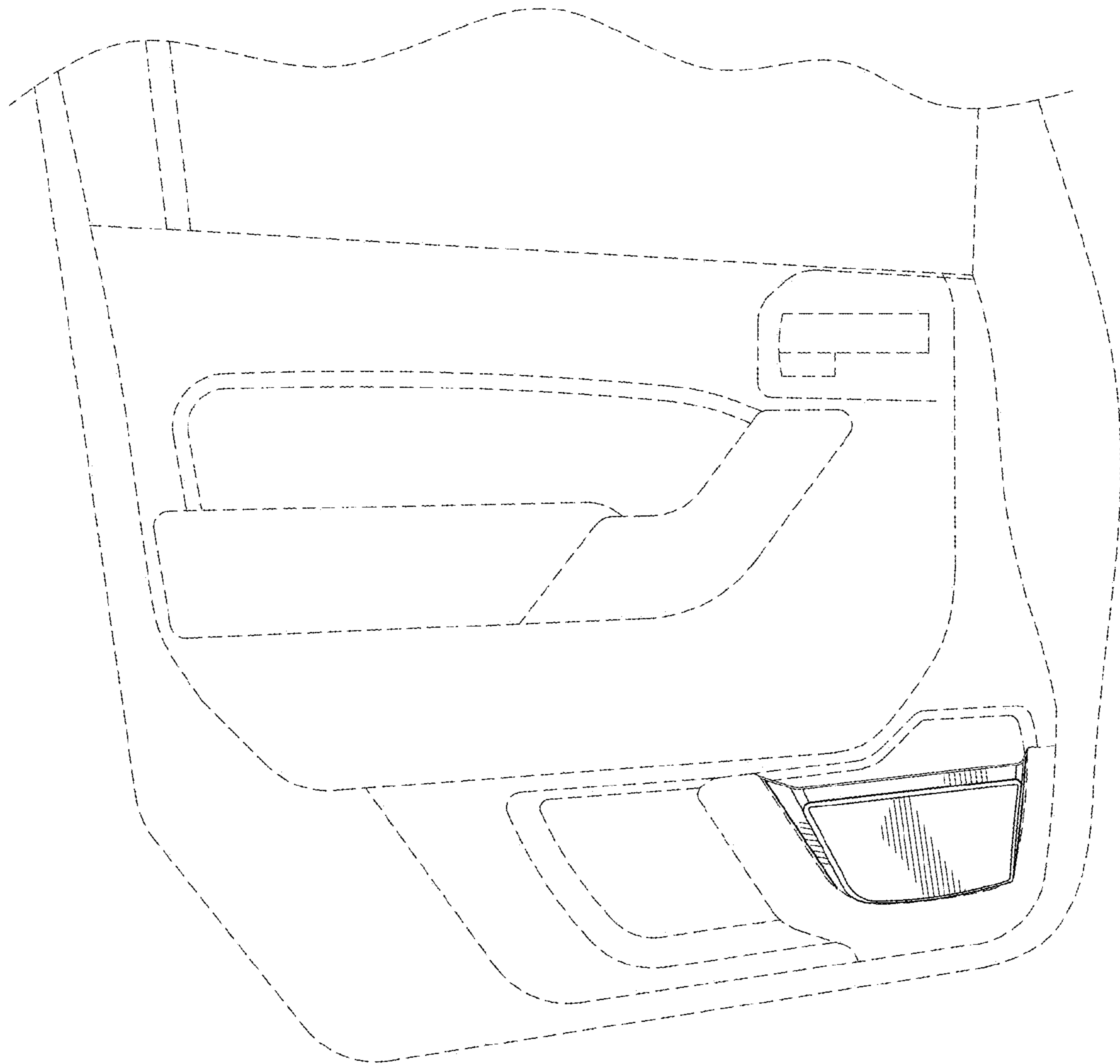

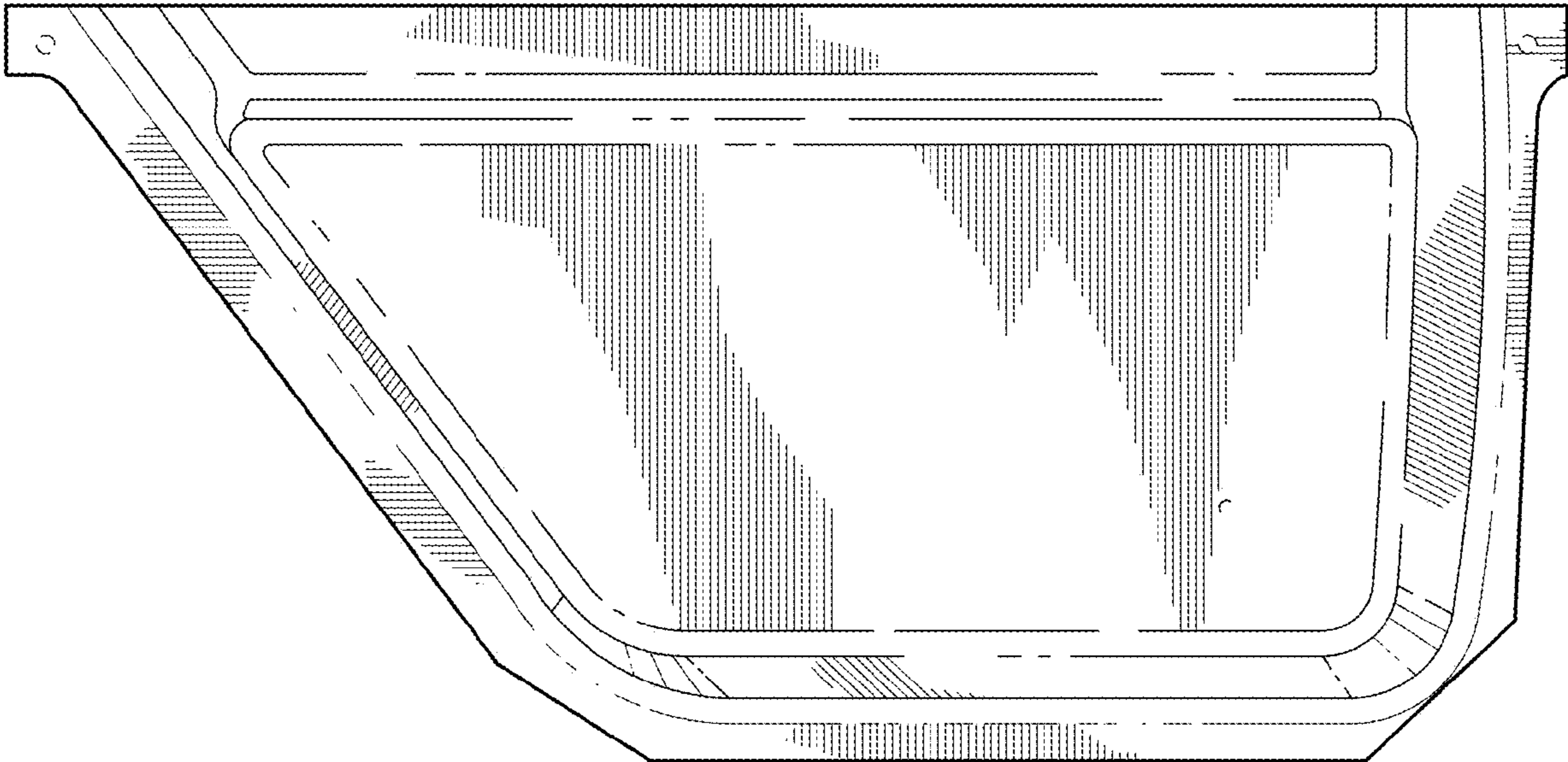

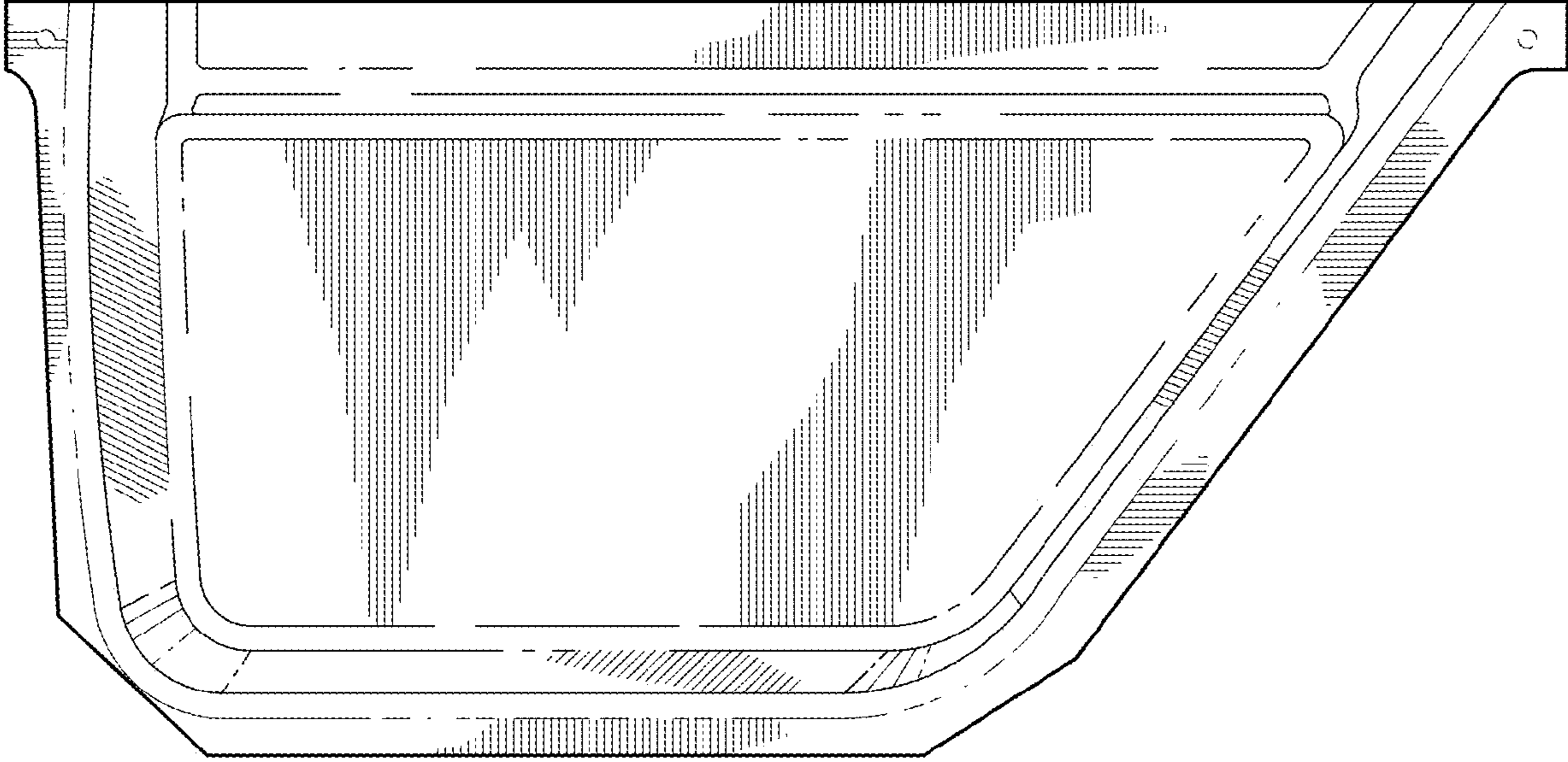

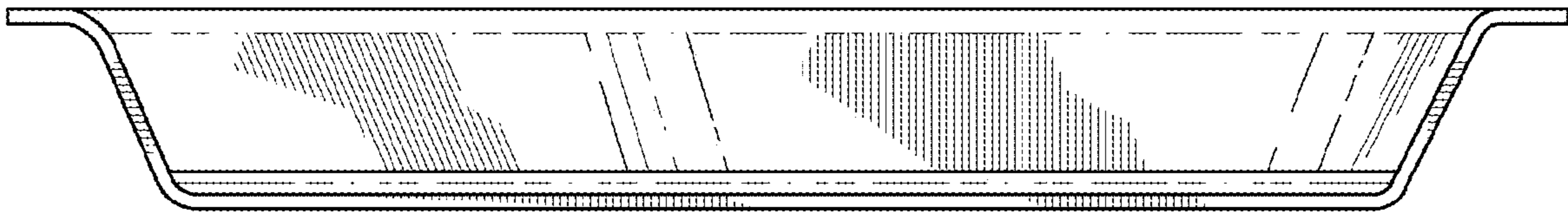

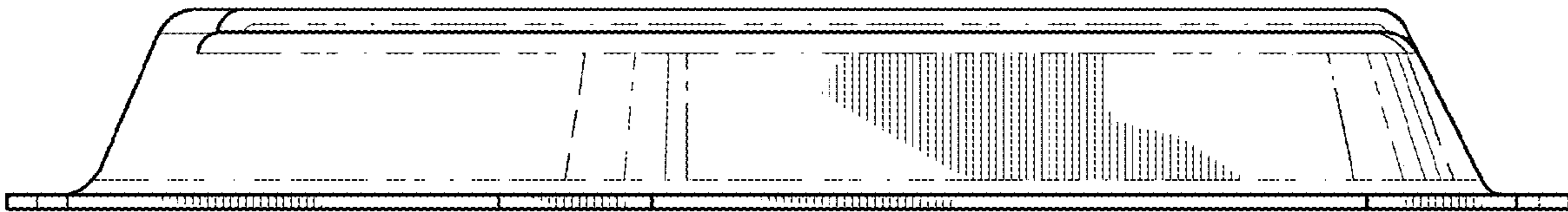

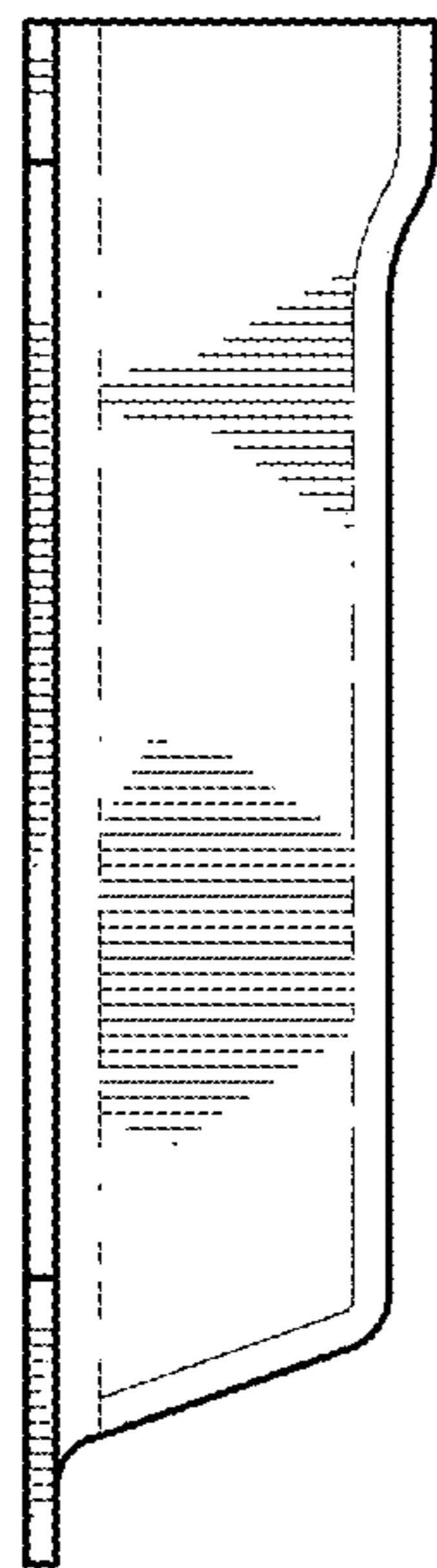
