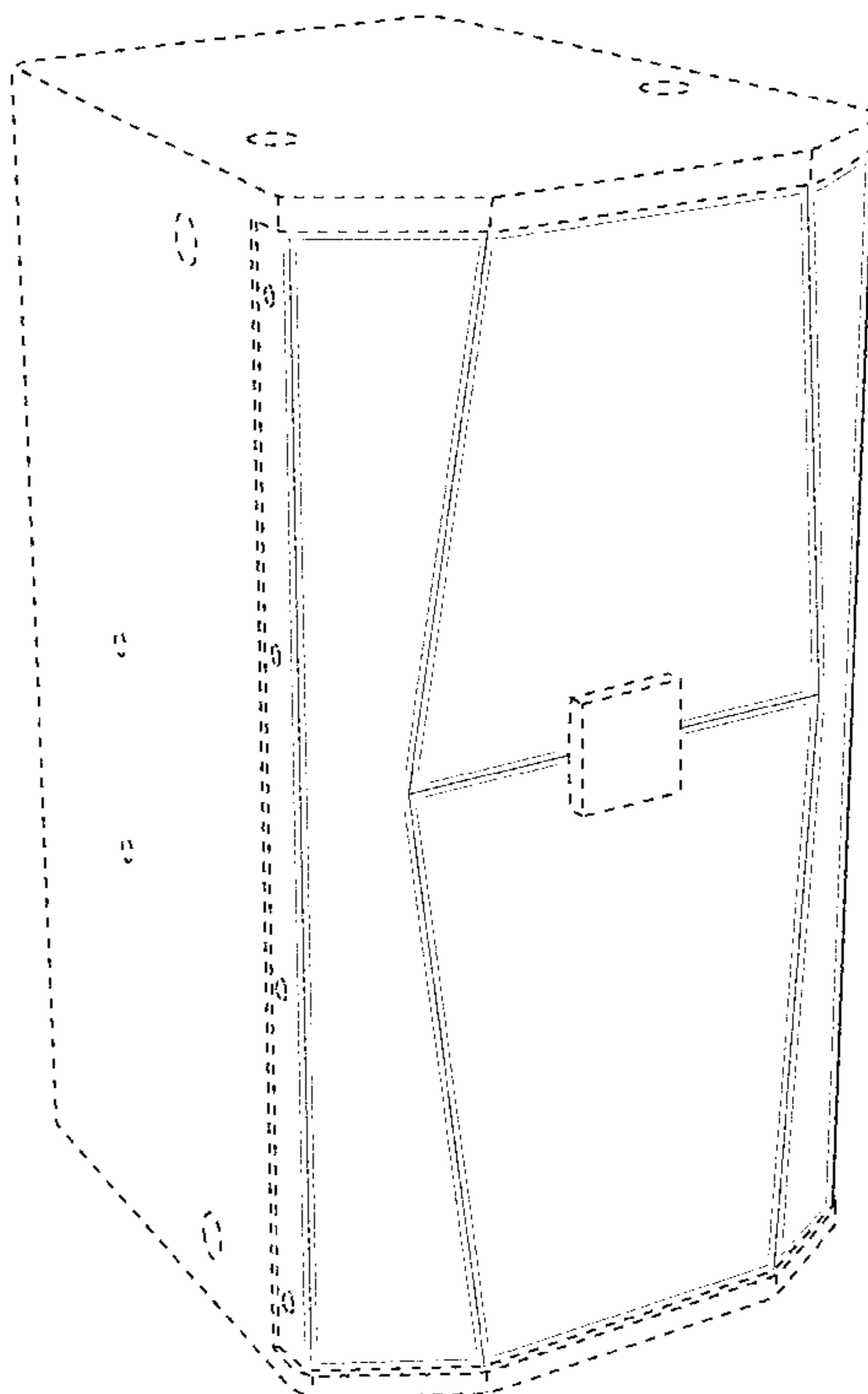

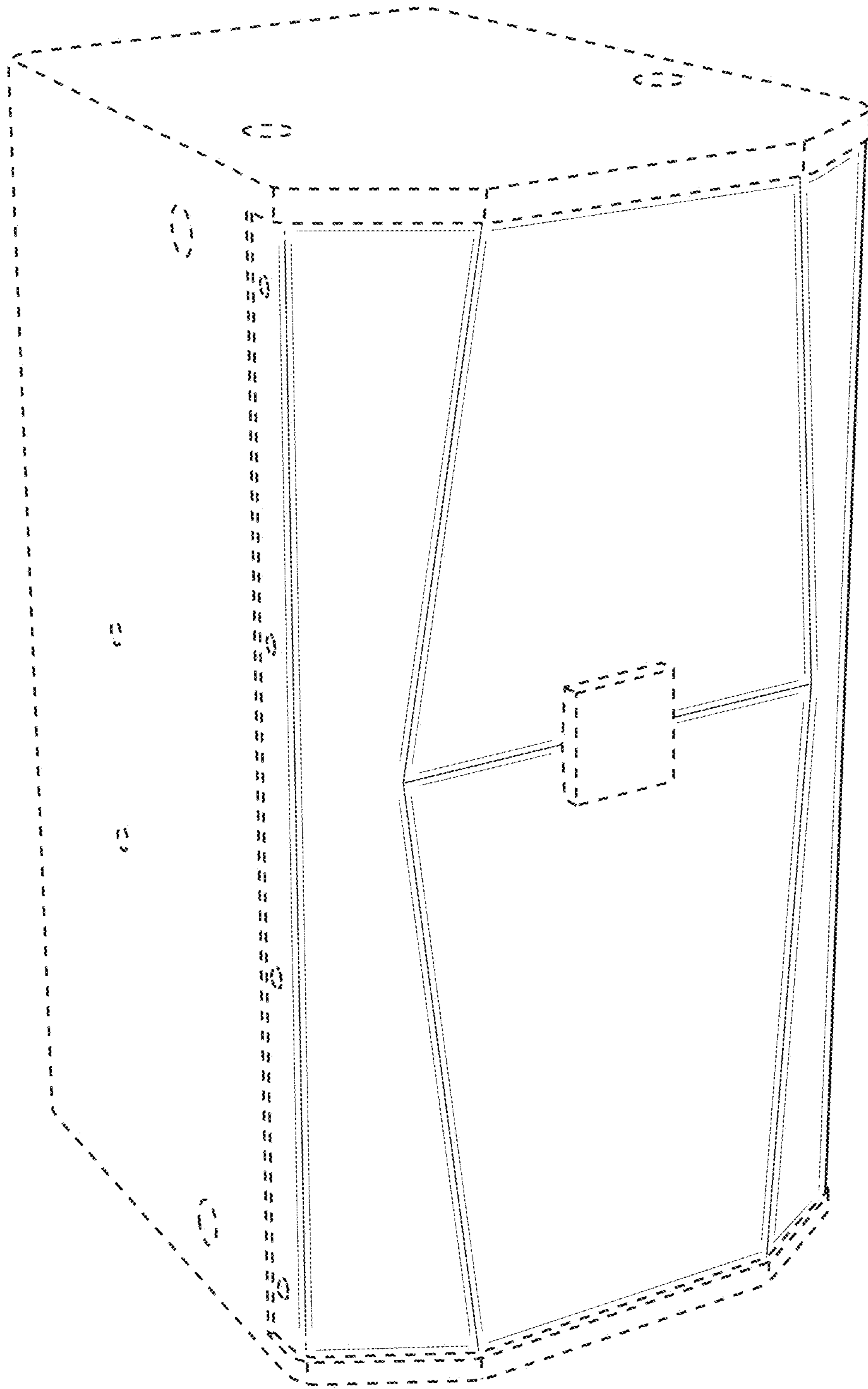
The ornamental design for a loudspeaker, as shown and described.

**DESCRIPTION**

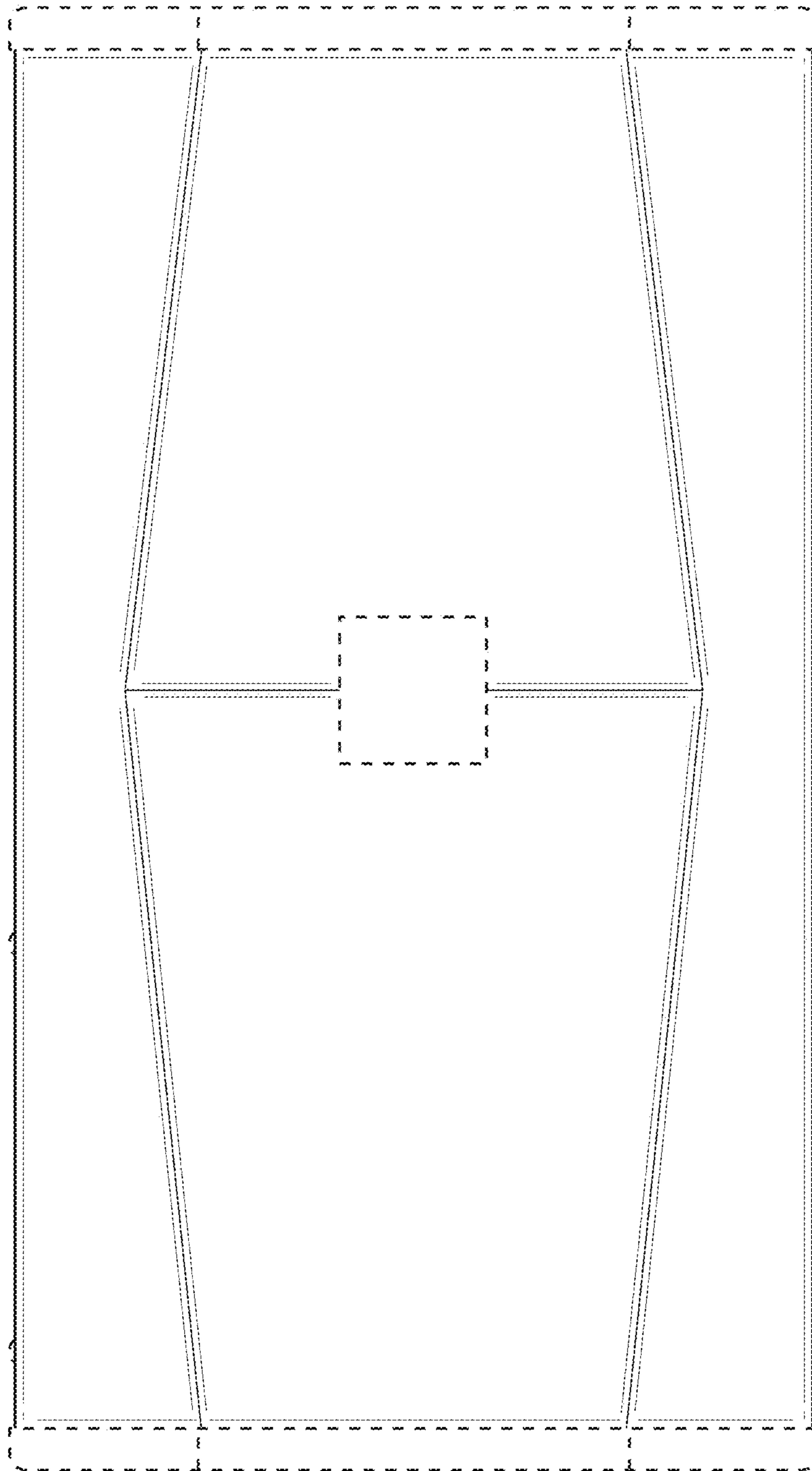
FIG. 1 is a front view of a loudspeaker showing my new design;

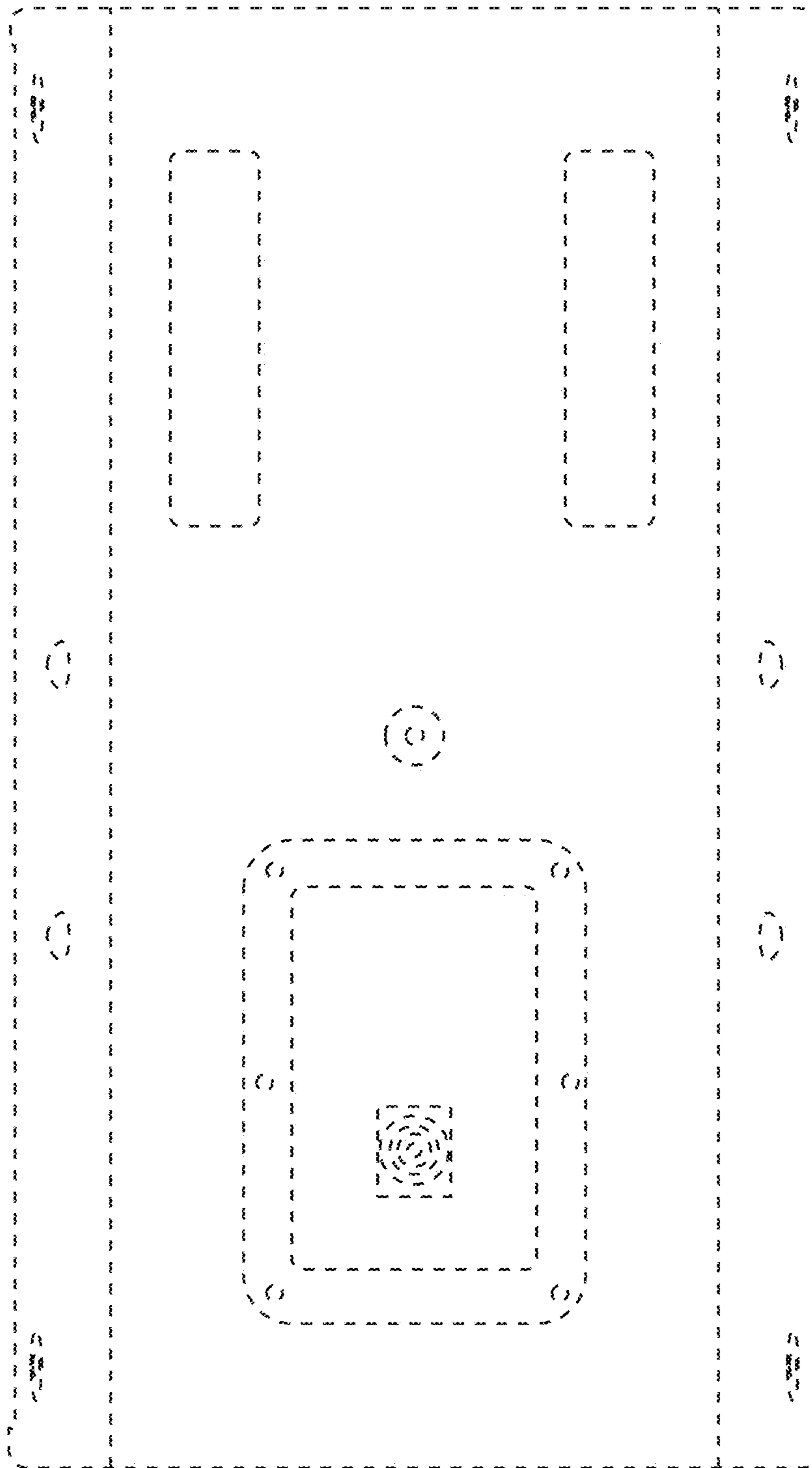




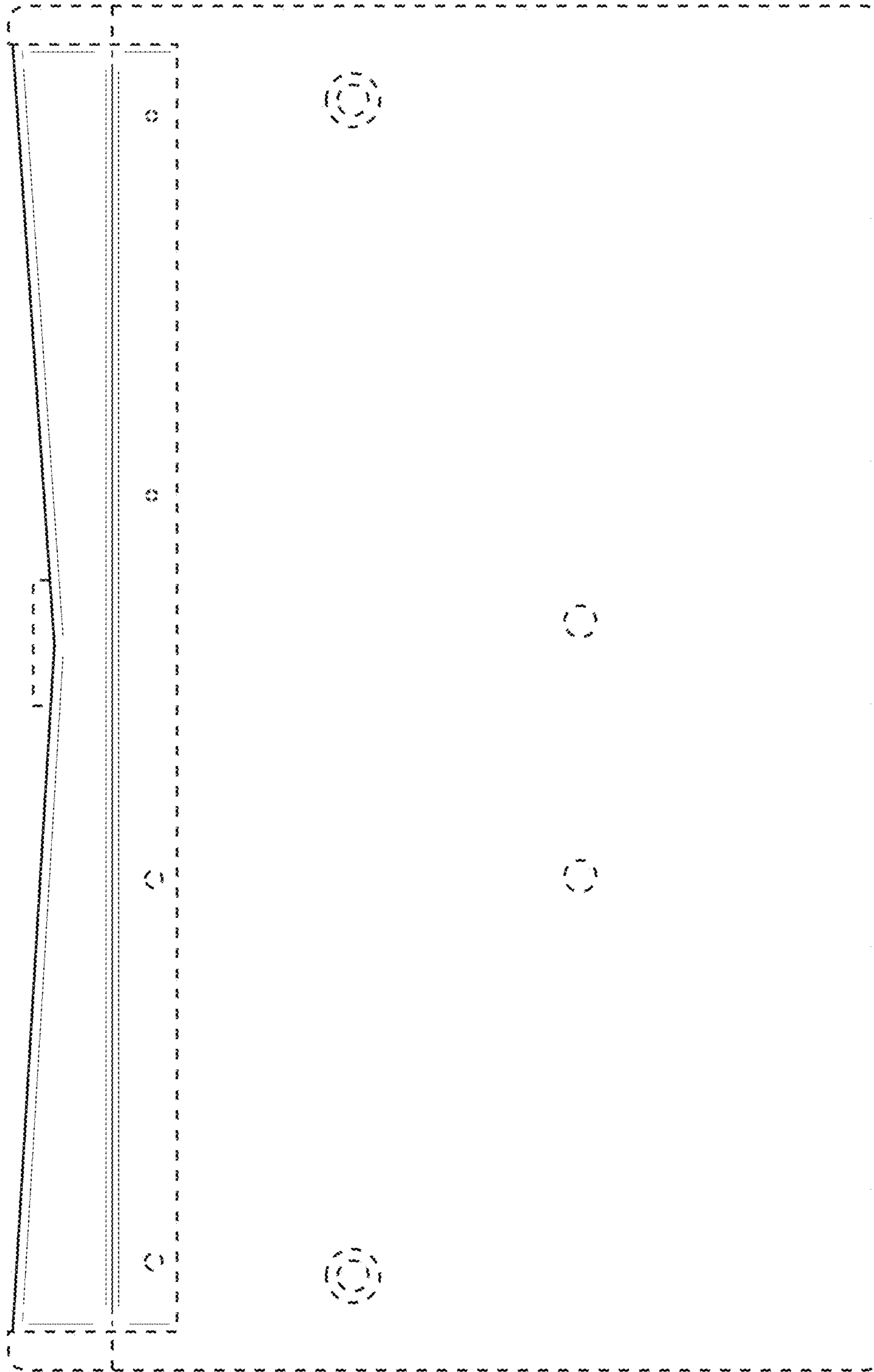

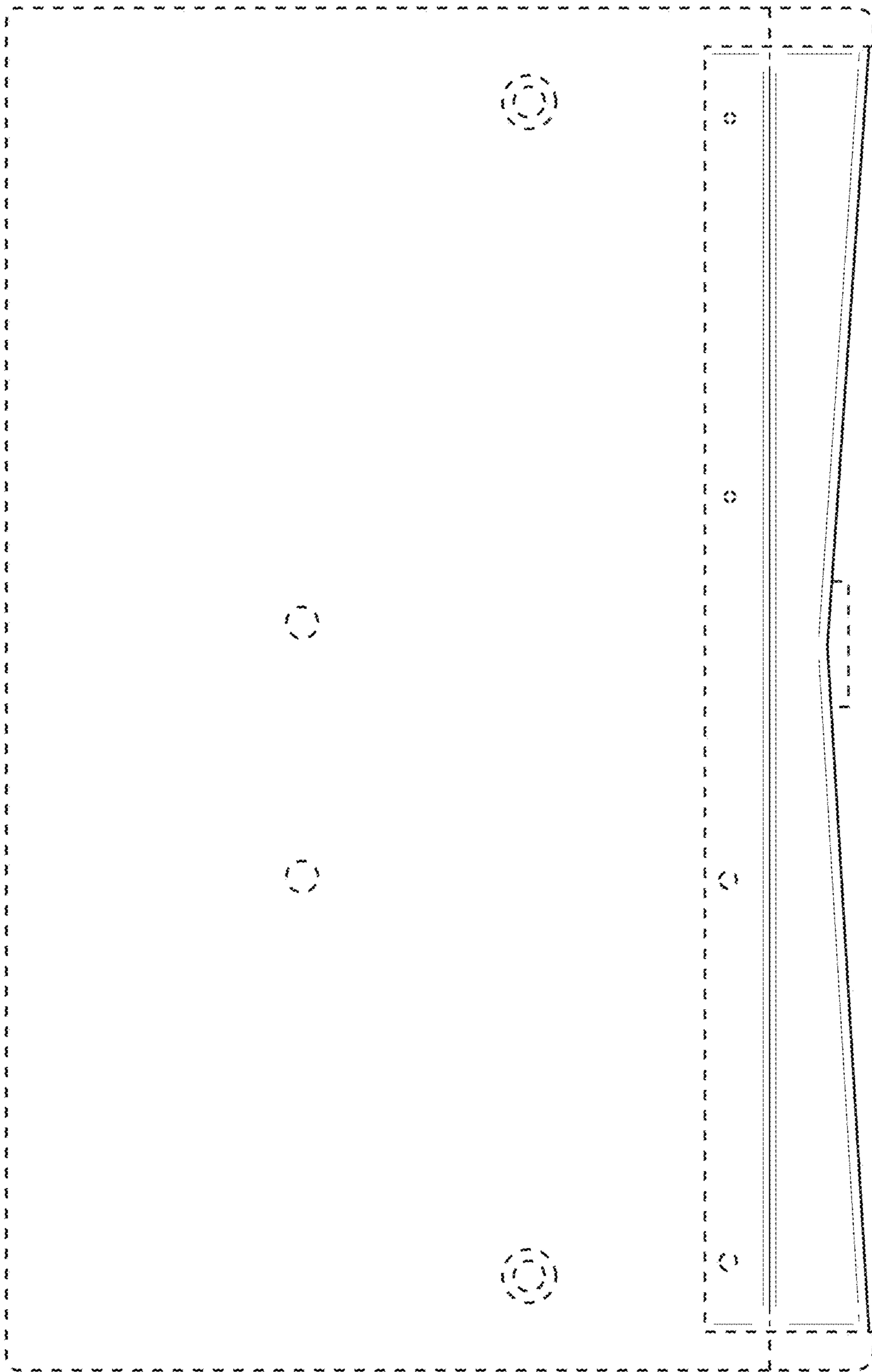

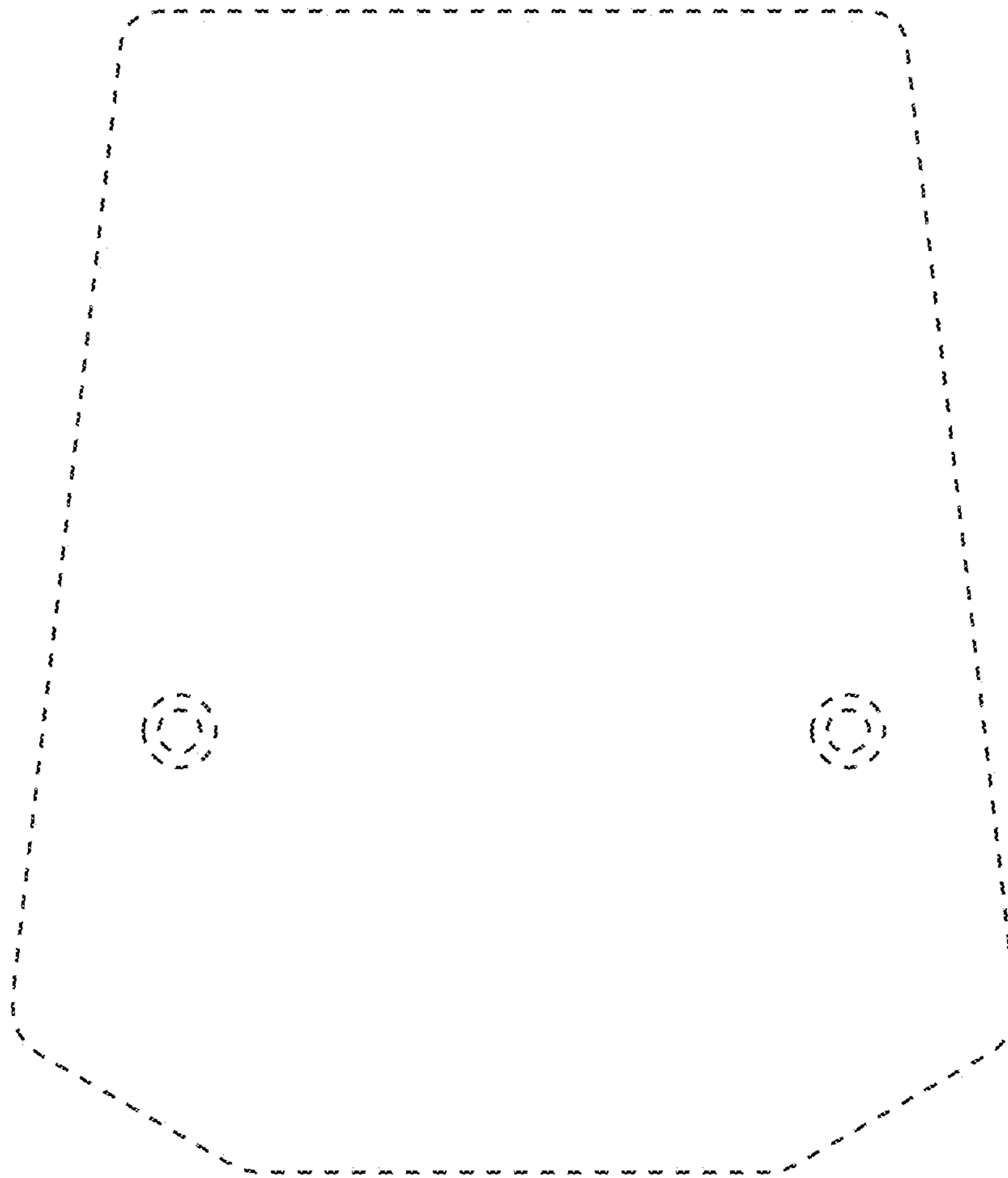

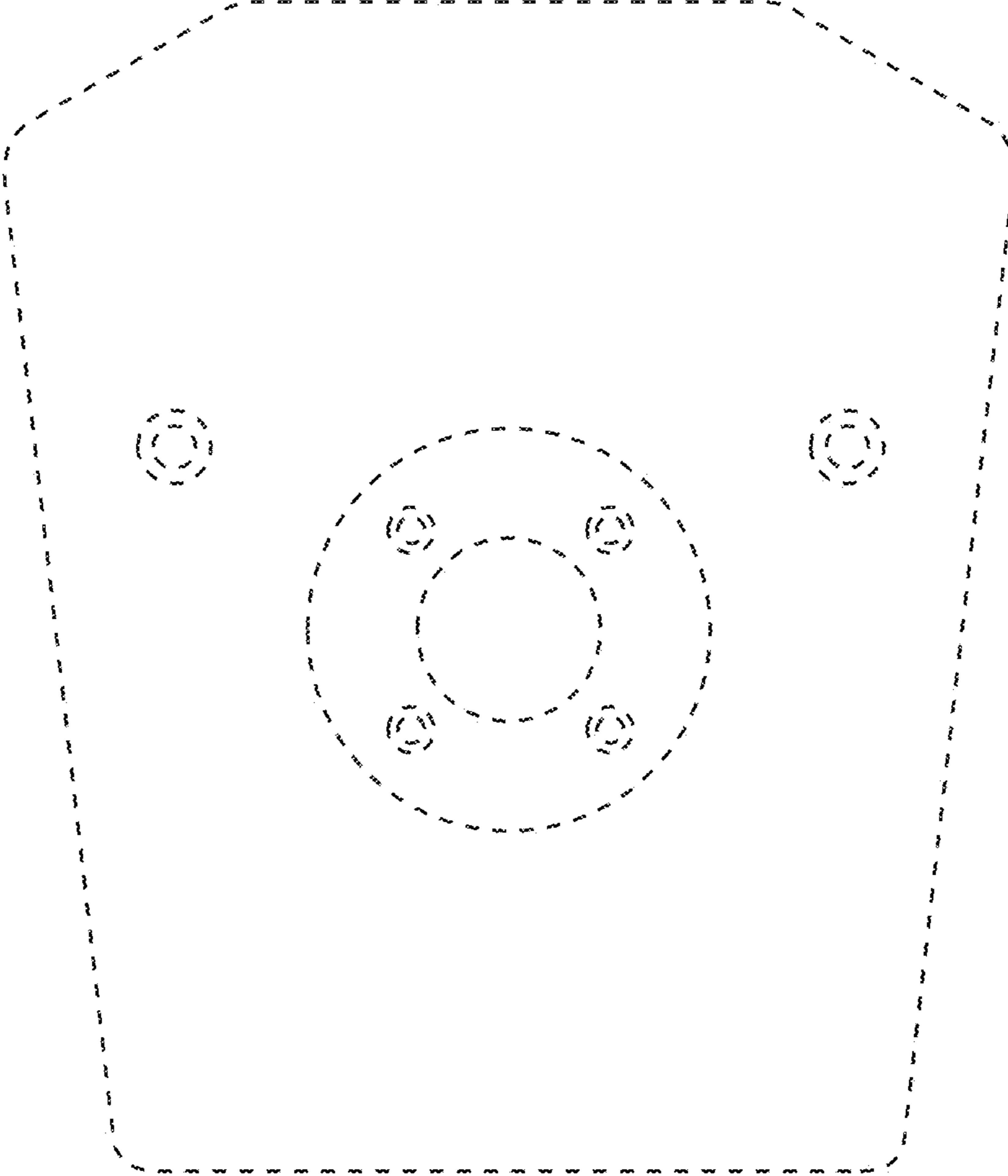
