FIG. 7 is a top view of the earbud headset shown in FIG. 1 (with the right earbud shown on the left and the left earbud shown on the right);

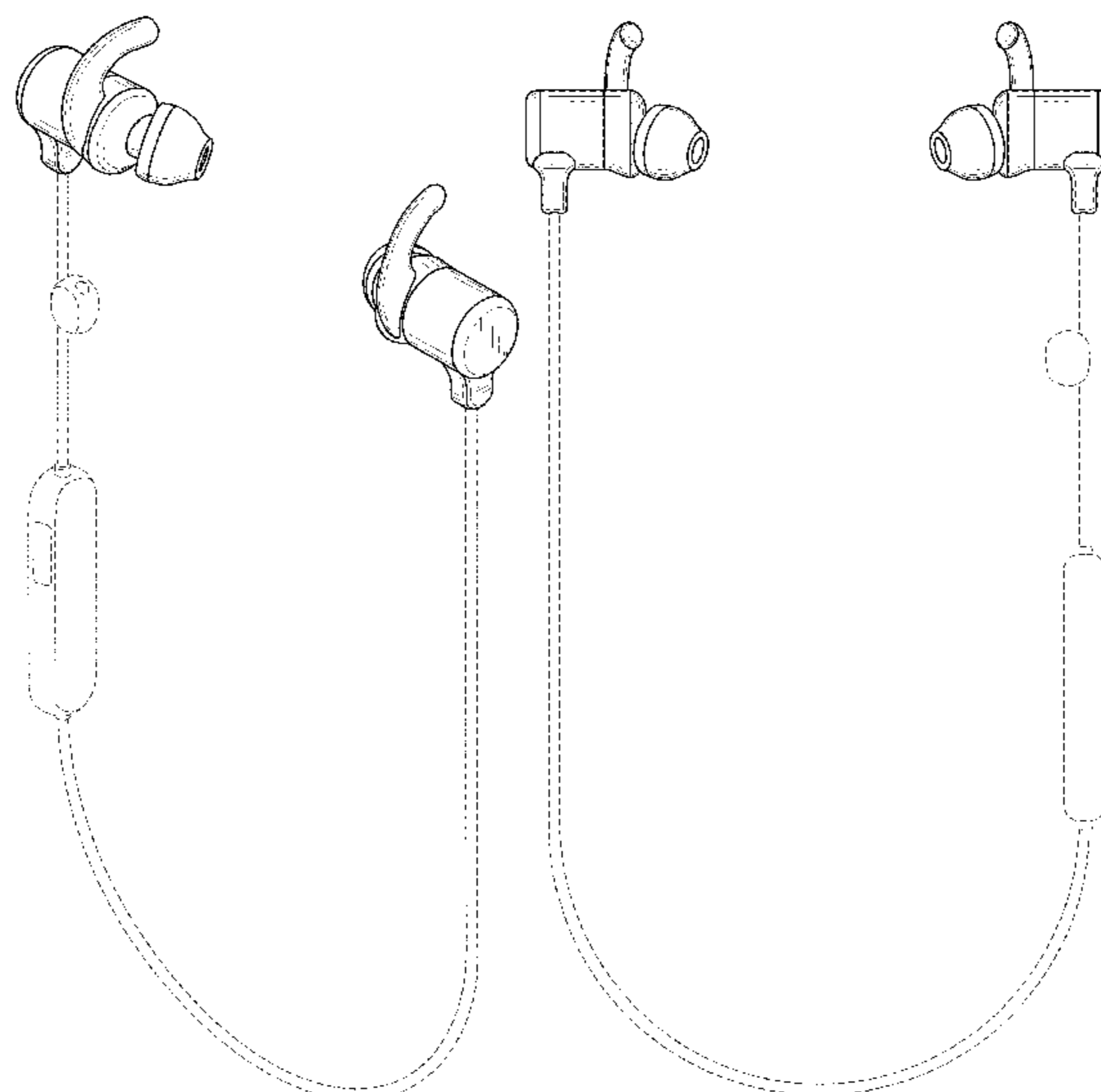
FIG. 8 is a bottom view of the earbud headset shown in FIG. 1 (with the right earbud shown on the right and the left earbud shown on the left); and,

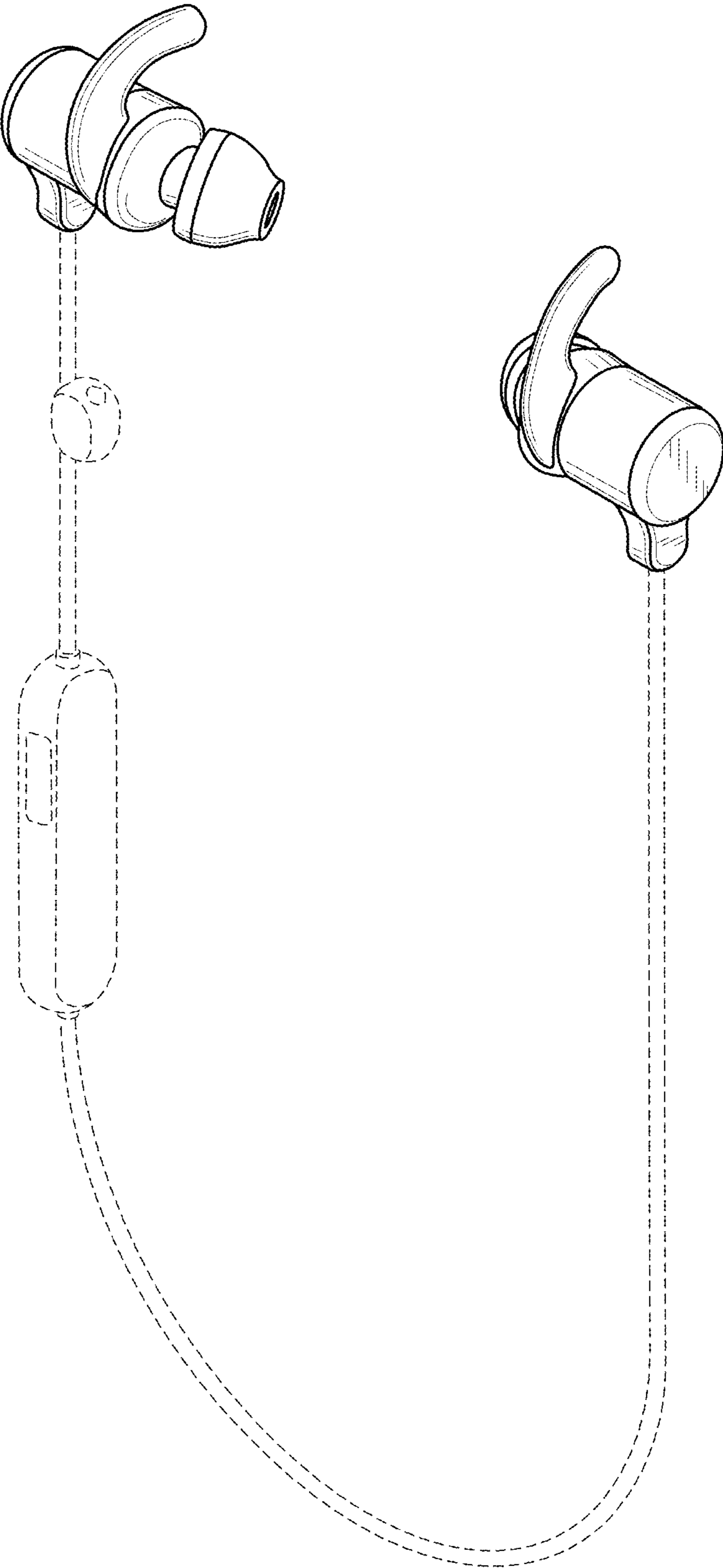

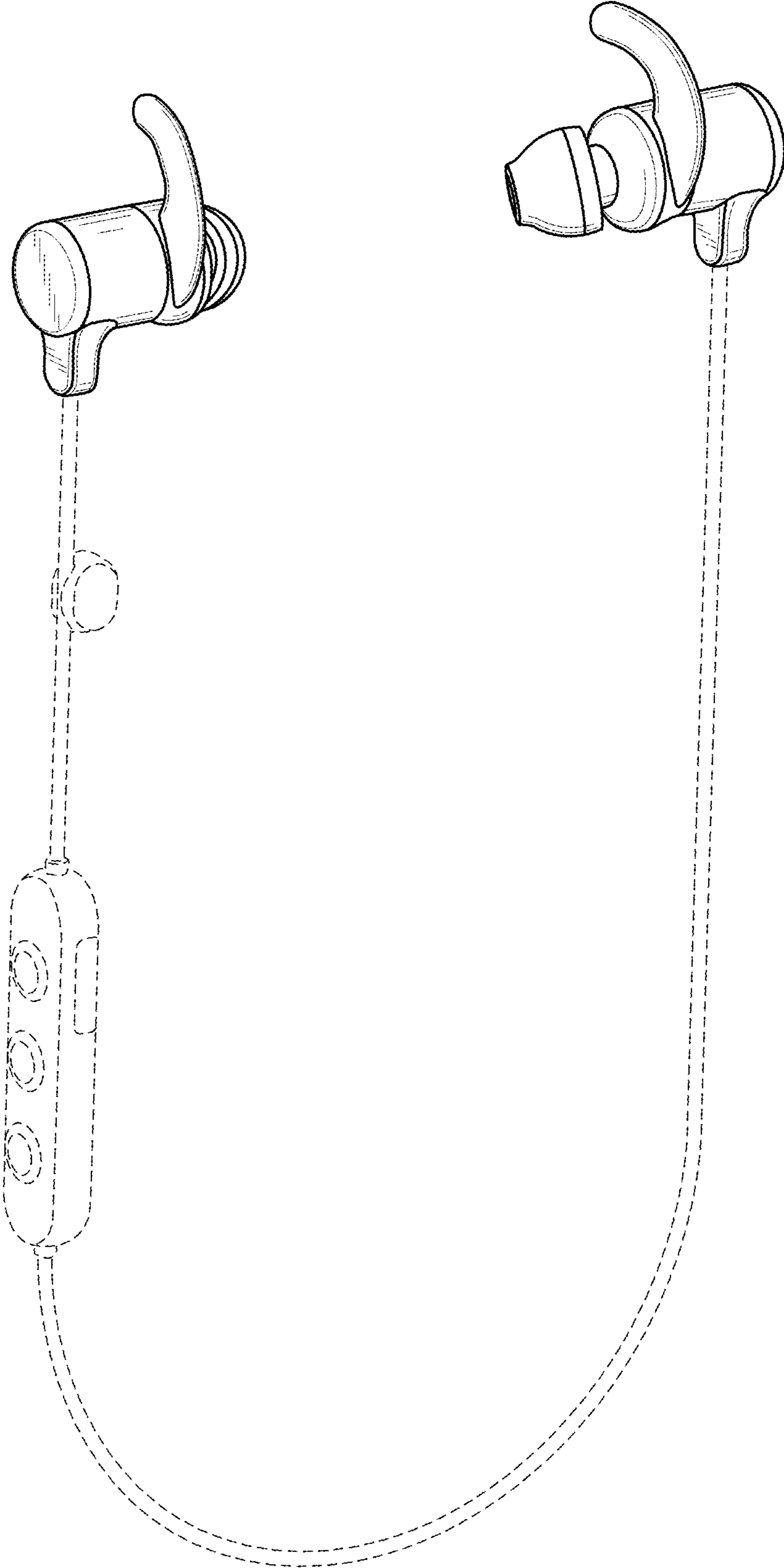

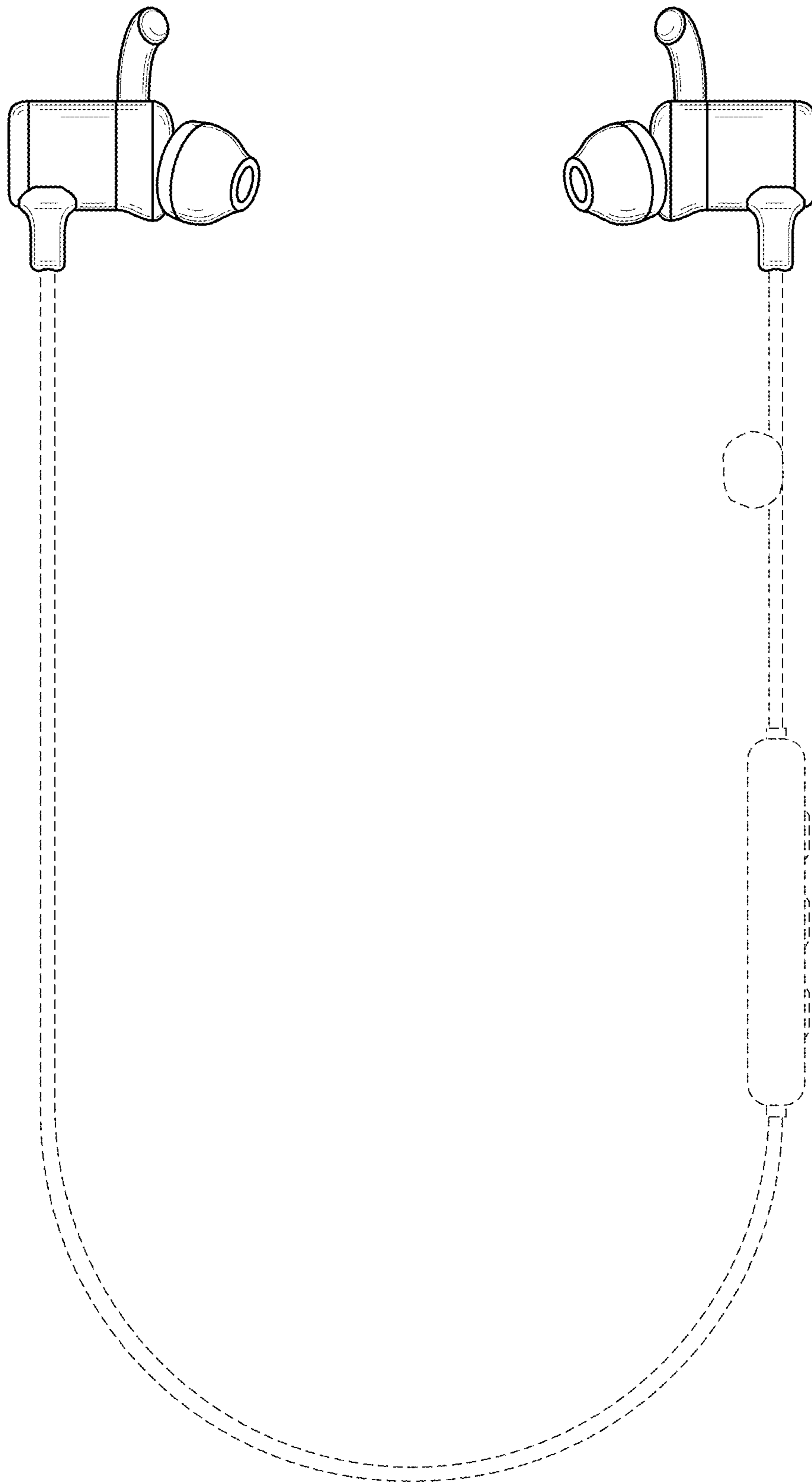

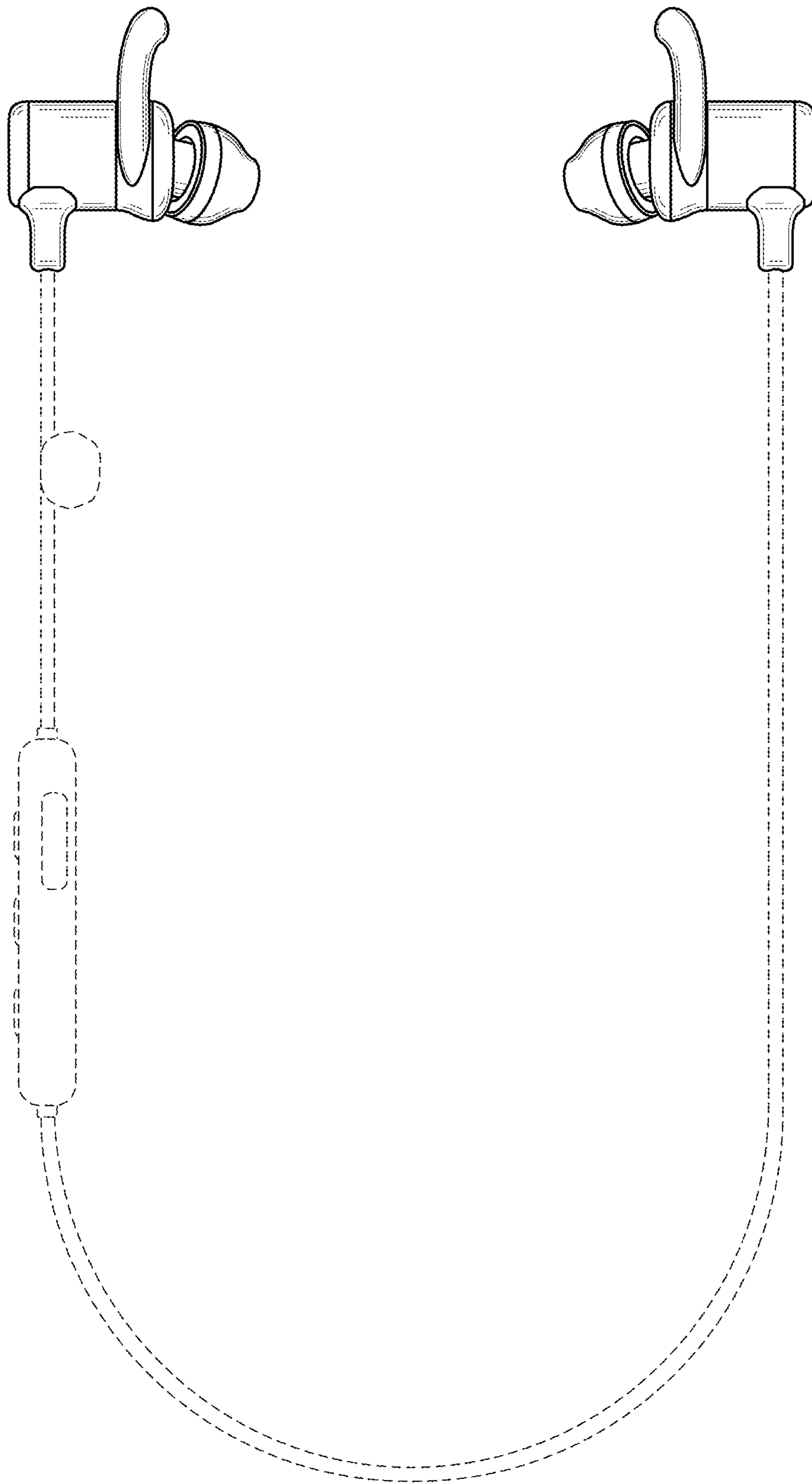

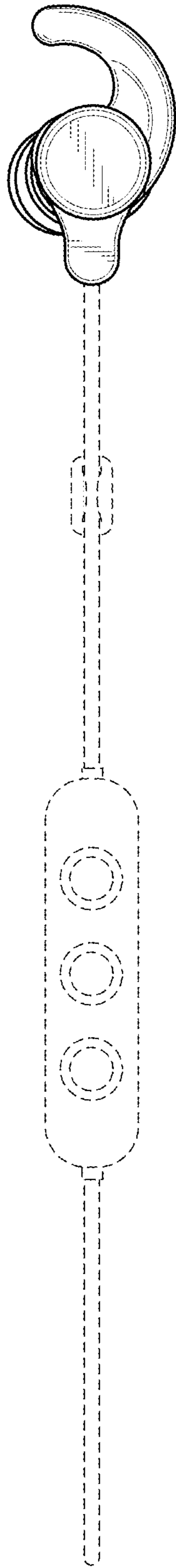

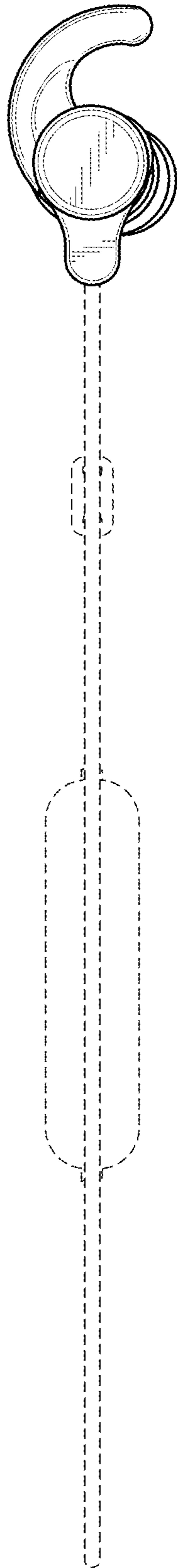

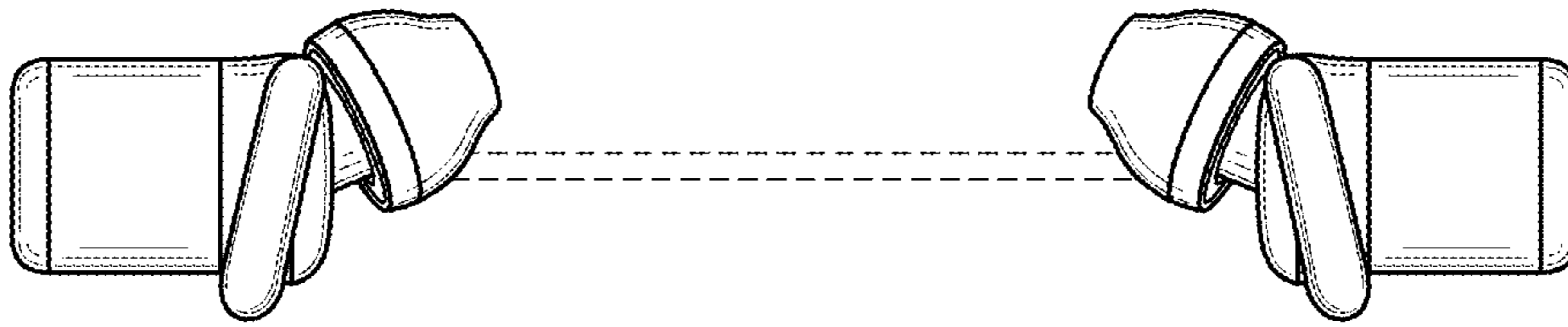

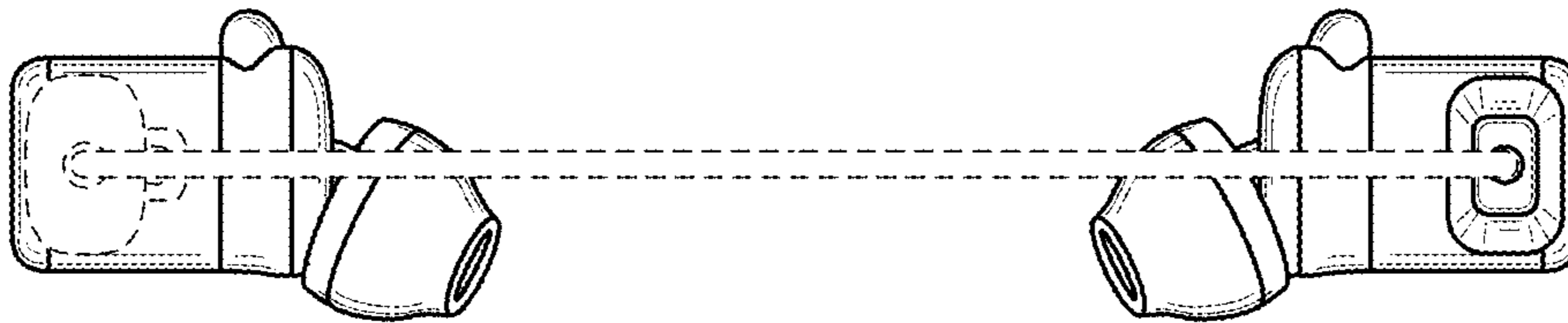
