(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is the first image in a sequence for a display screen or portion thereof with transitional graphical user interface showing our new design;

FIG. 2 is the second image thereof;

FIG. 3 is the third image thereof; and,

FIG. 4 is the fourth image thereof.

The outer perimeter shown by a pair of dashed broken lines in the drawings represents a display screen or portion thereof and forms no part of the claimed design. The remaining broken lines in the drawings illustrate portions of the transitional graphical user interface that form no part of the claimed design.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-4. The process or period in which one image transitions to another image forms no part of the claimed design.

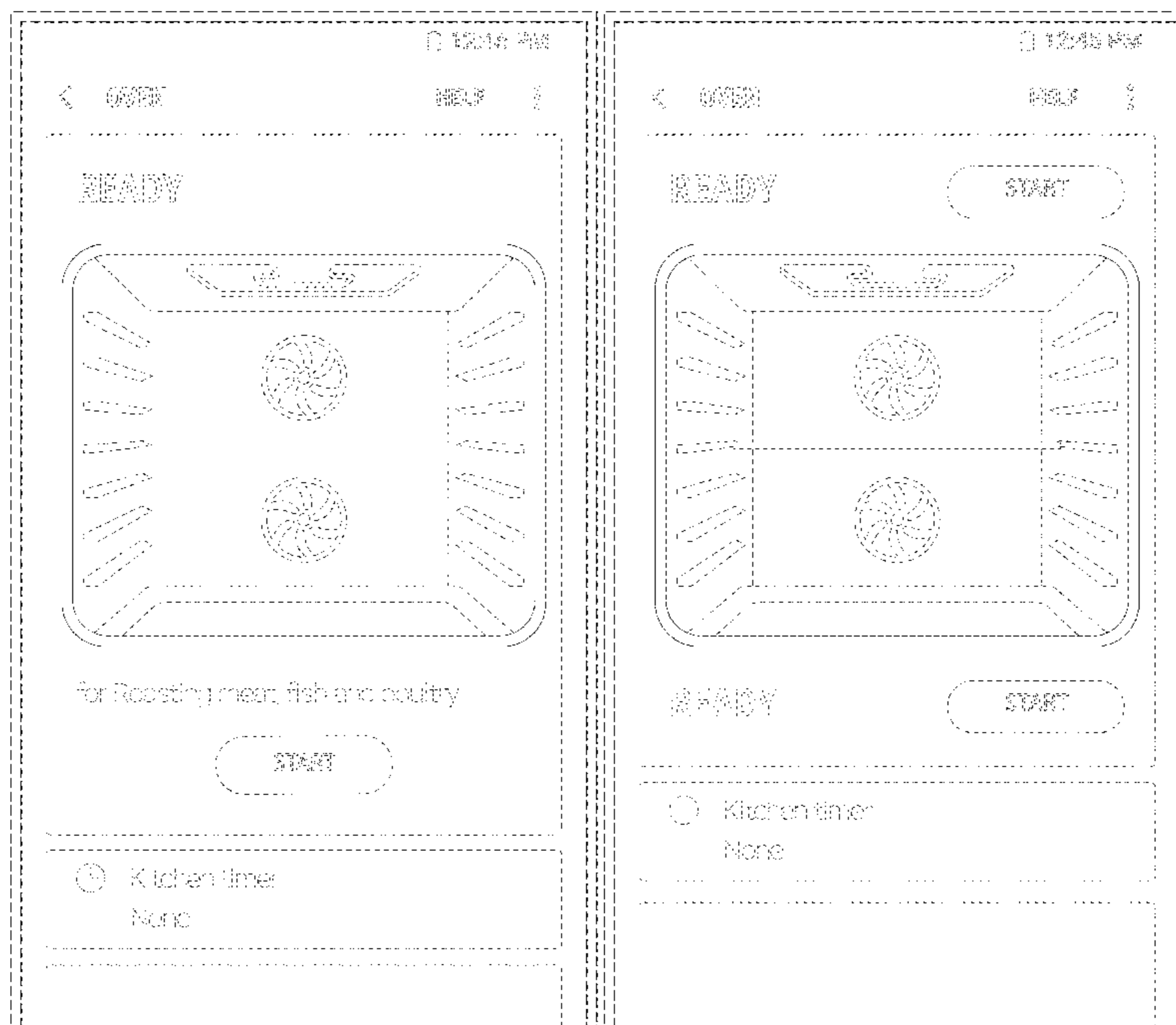

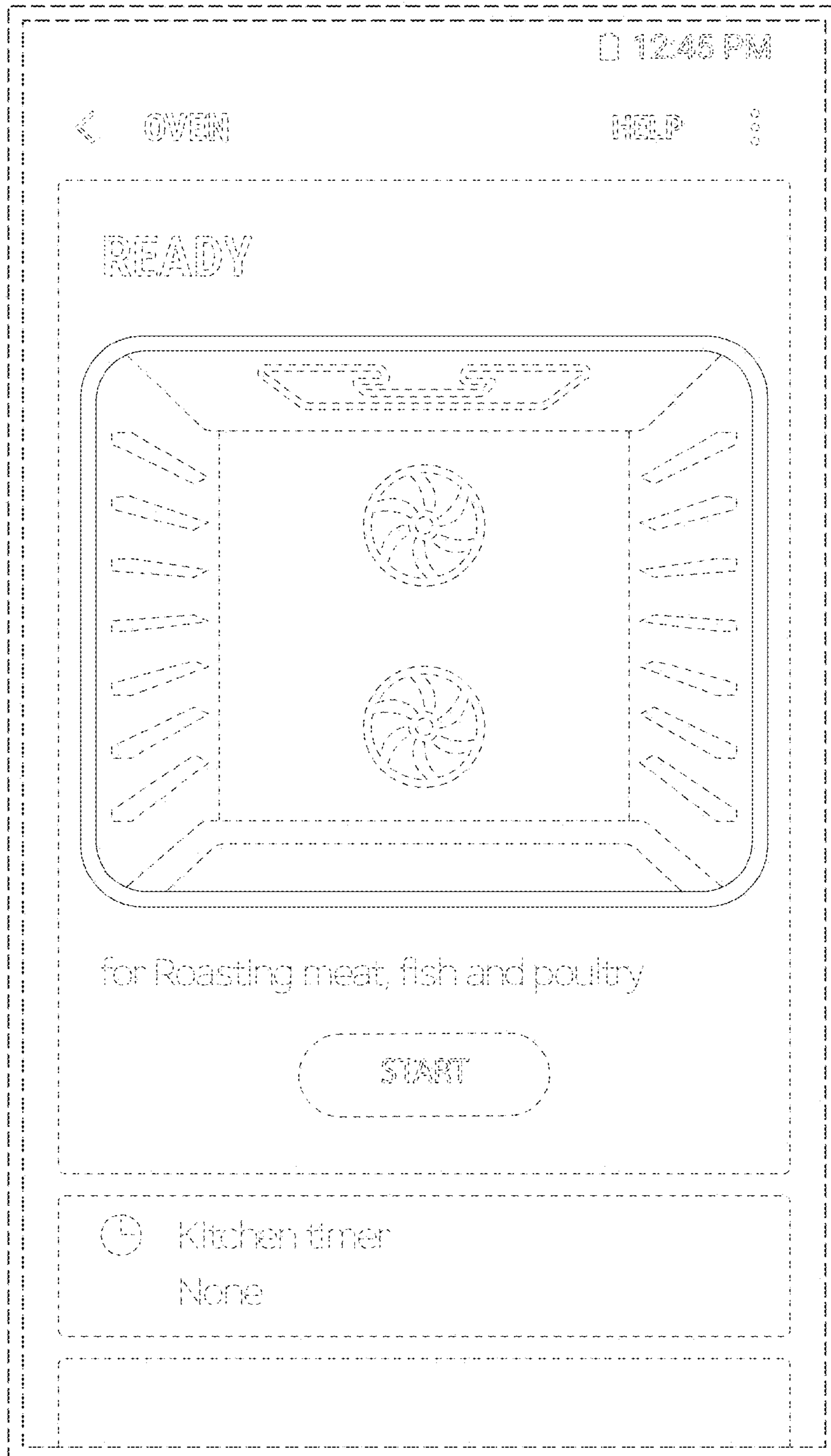

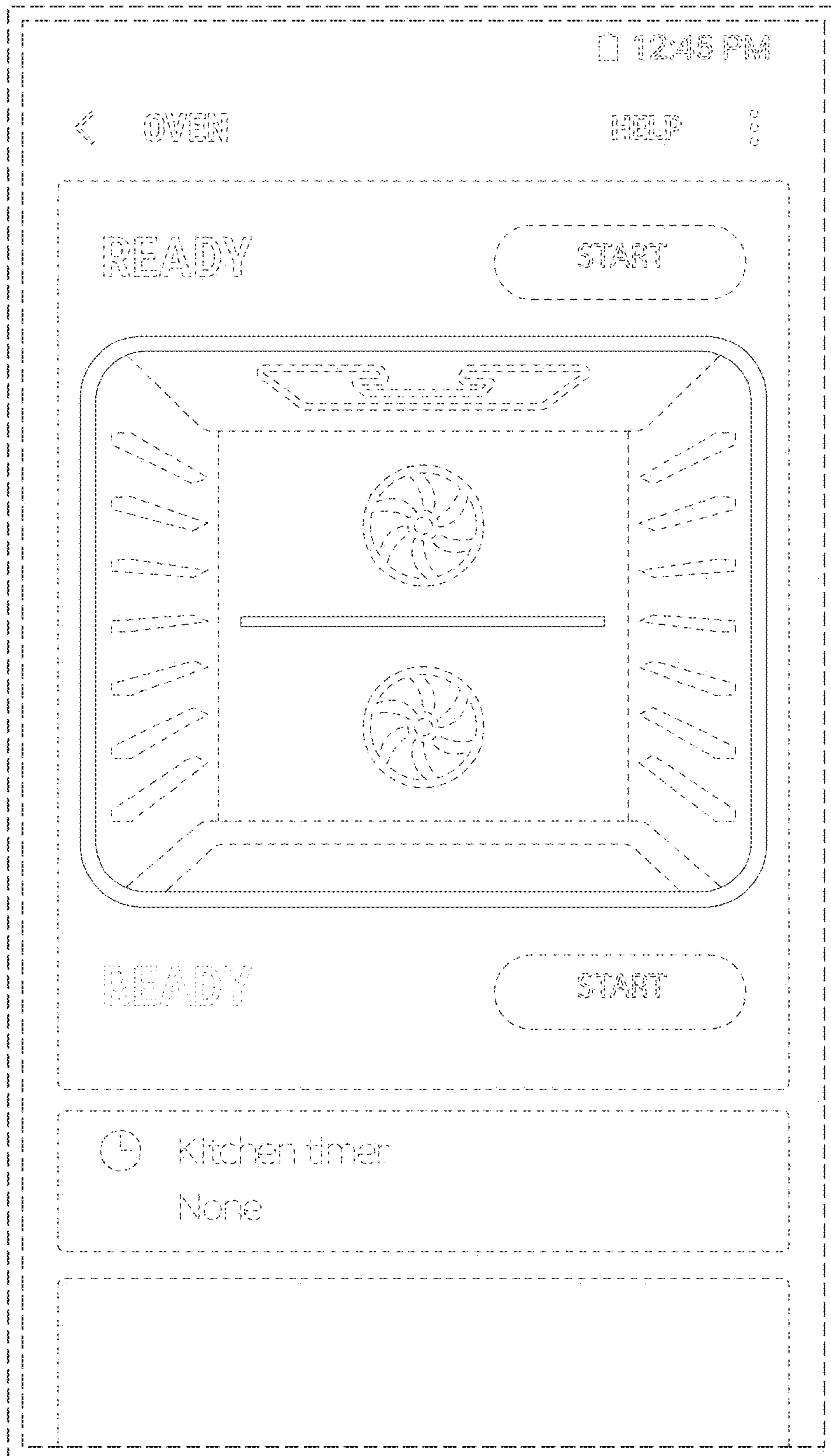

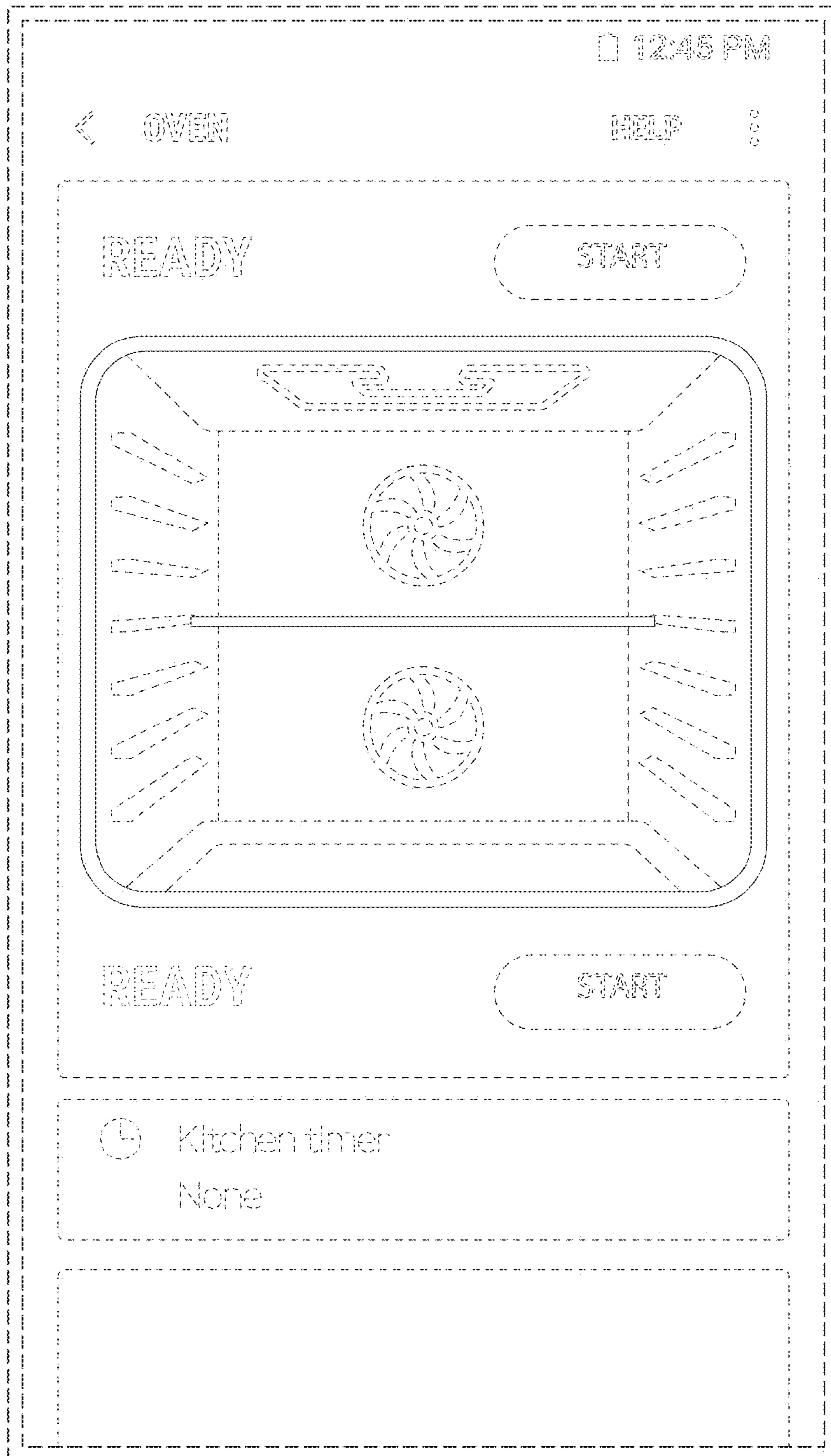
