The ornamental design for a non-axial turbomachine, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a non-axial turbomachine showing our new design;  
FIG. 2 is a right side elevational view of the non-axial turbomachine of FIG. 1;  
FIG. 3 is a left side elevational view of the non-axial turbomachine of FIG. 1;  
FIG. 4 is a front side elevational view of the non-axial turbomachine of FIG. 1;

FIG. 7 is a bottom plan view of the non-axial turbomachine of FIG. 1.

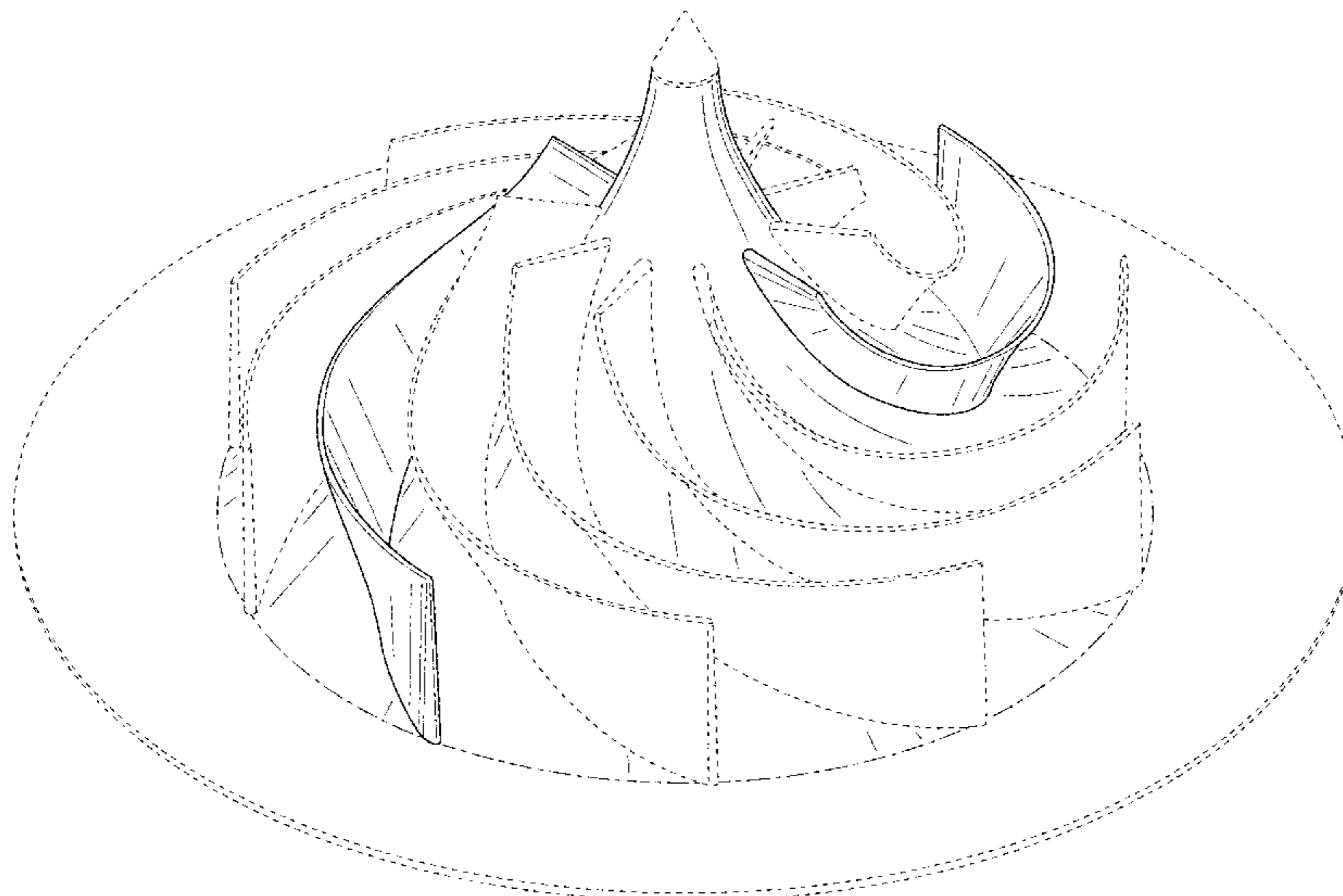

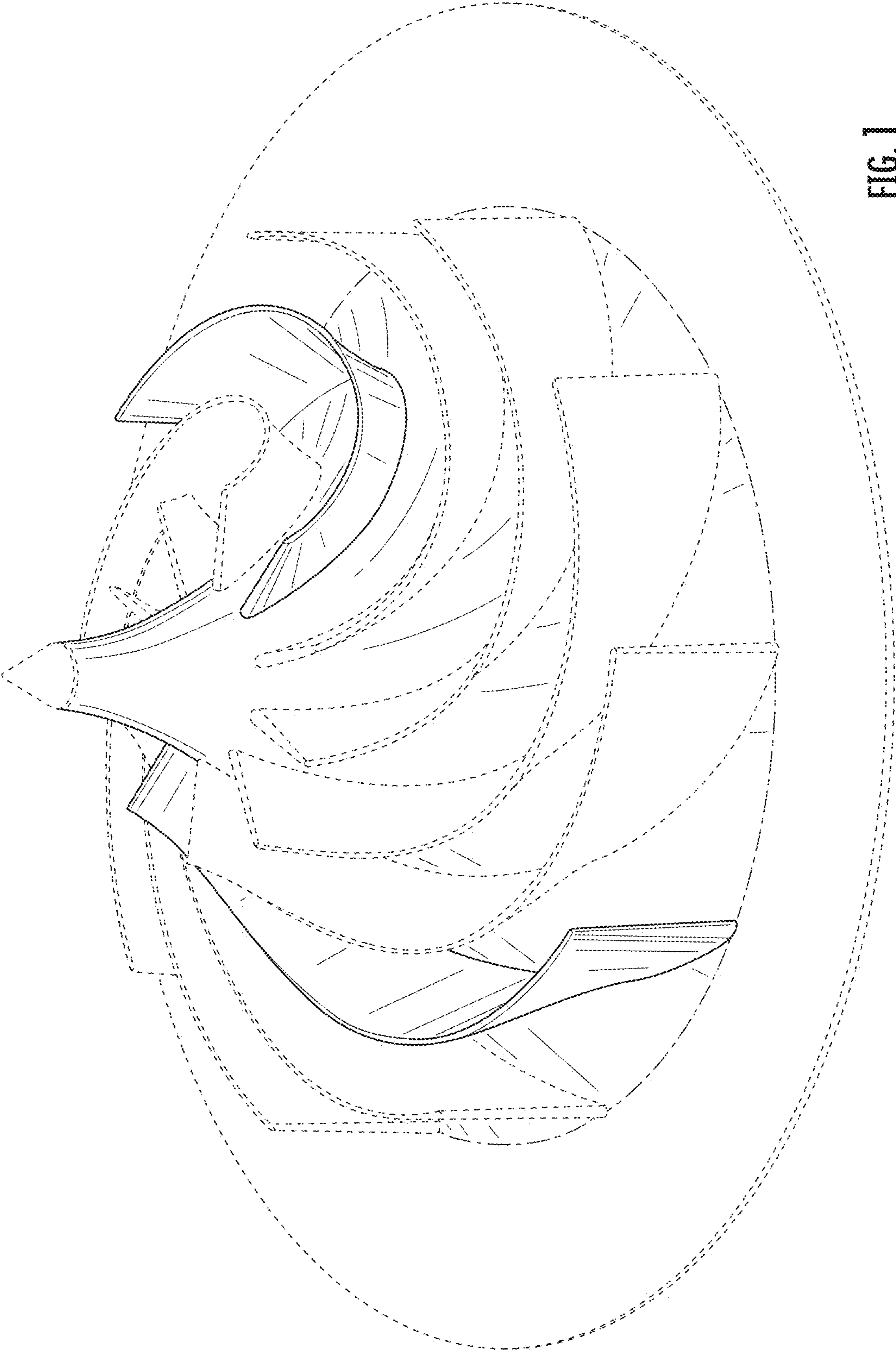

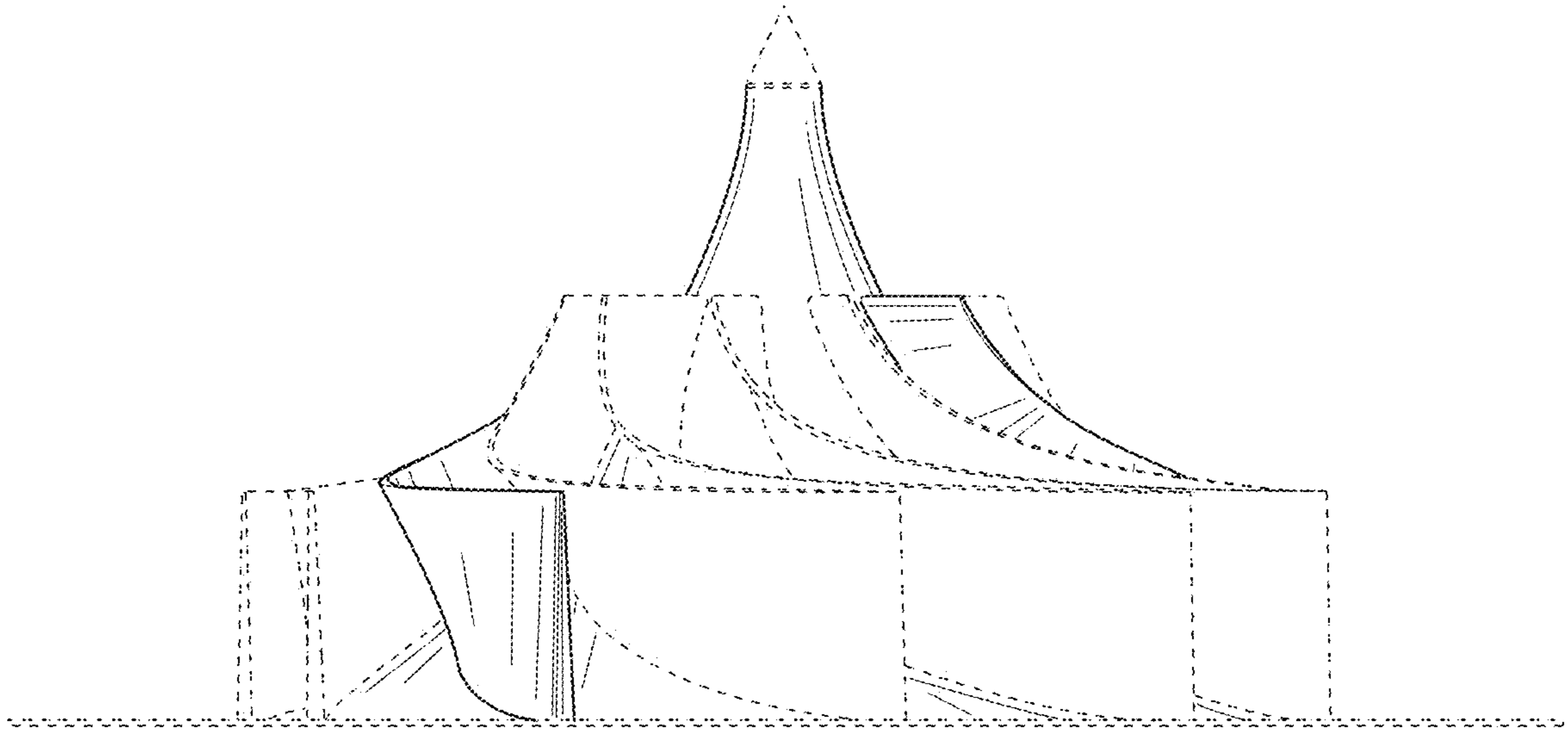

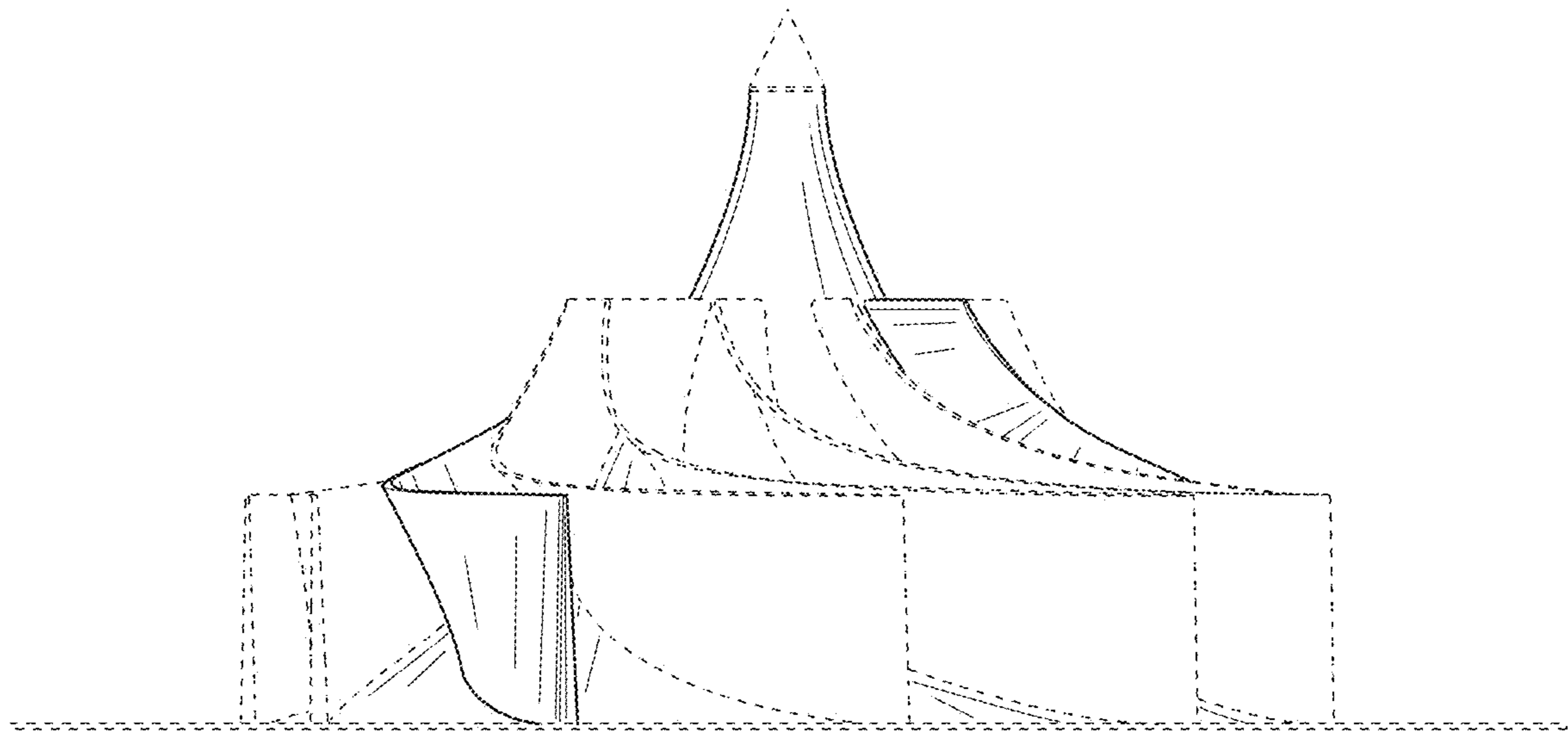

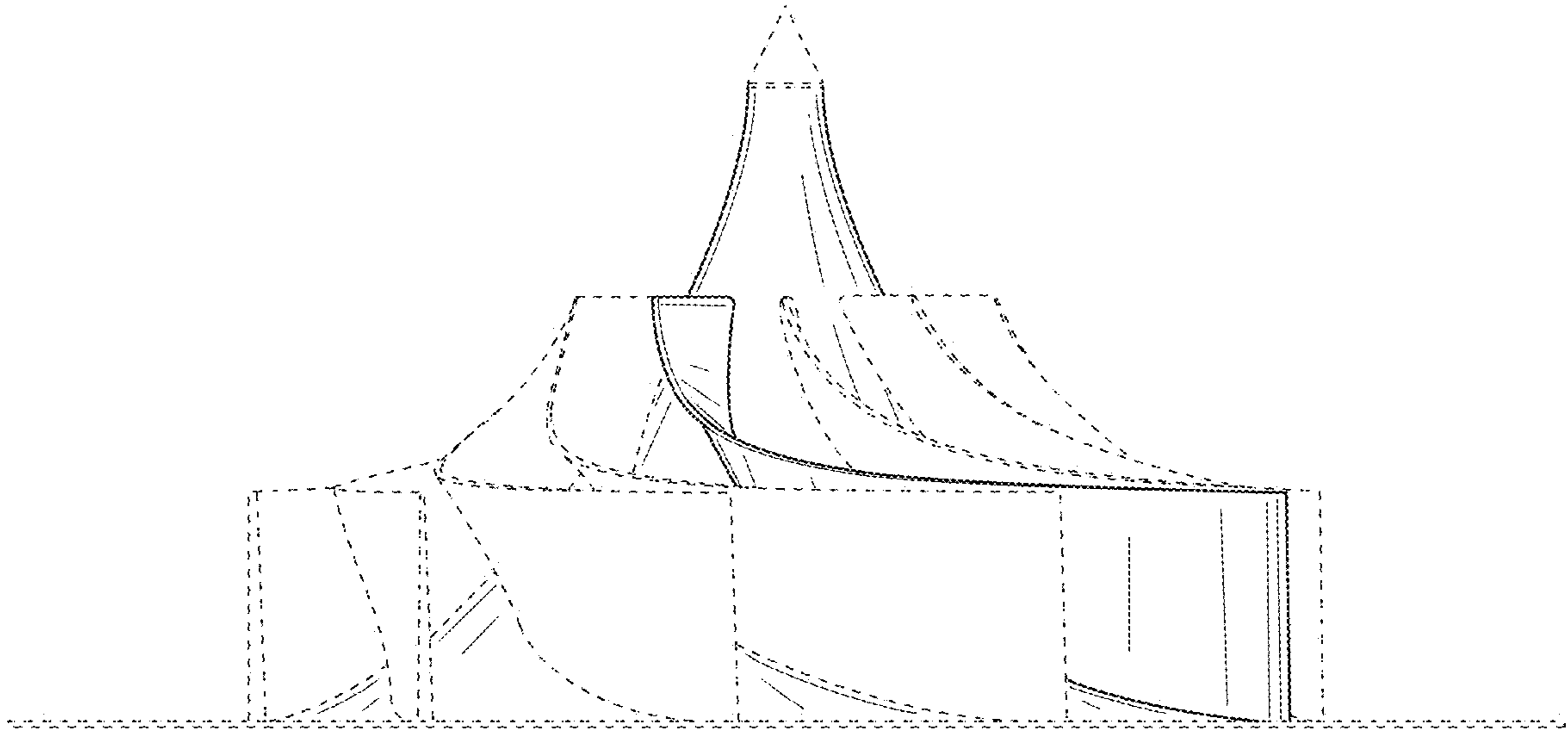

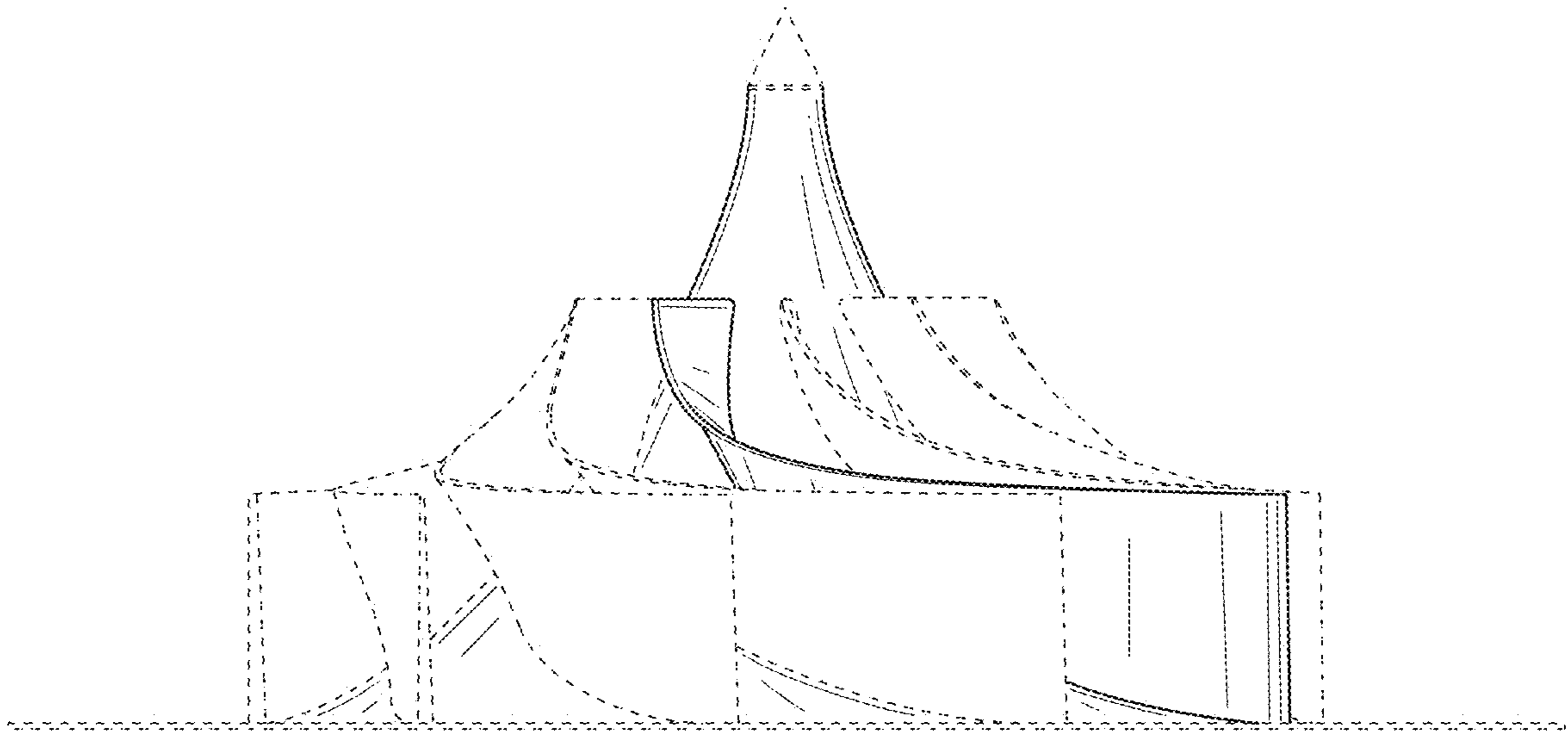

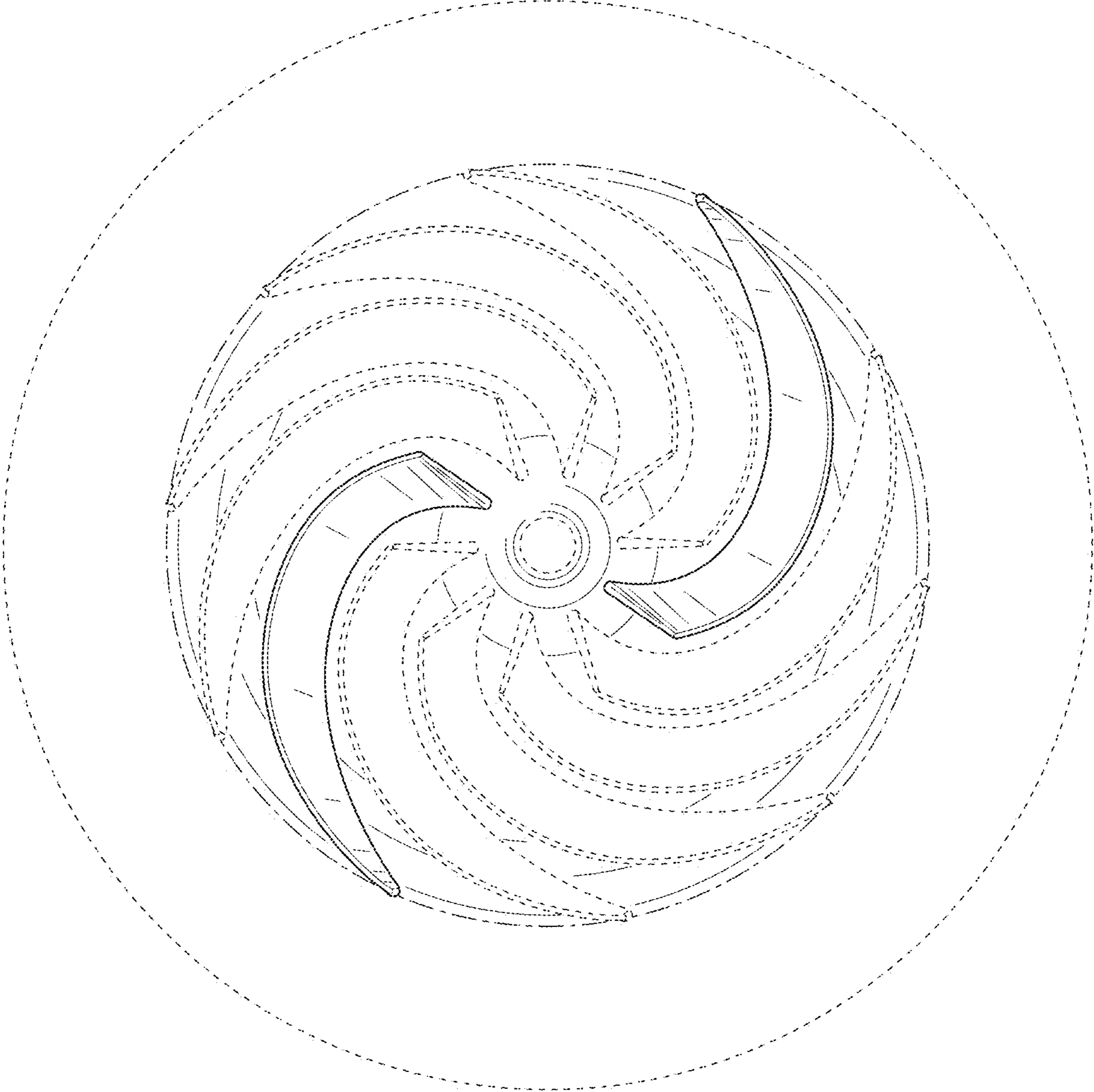

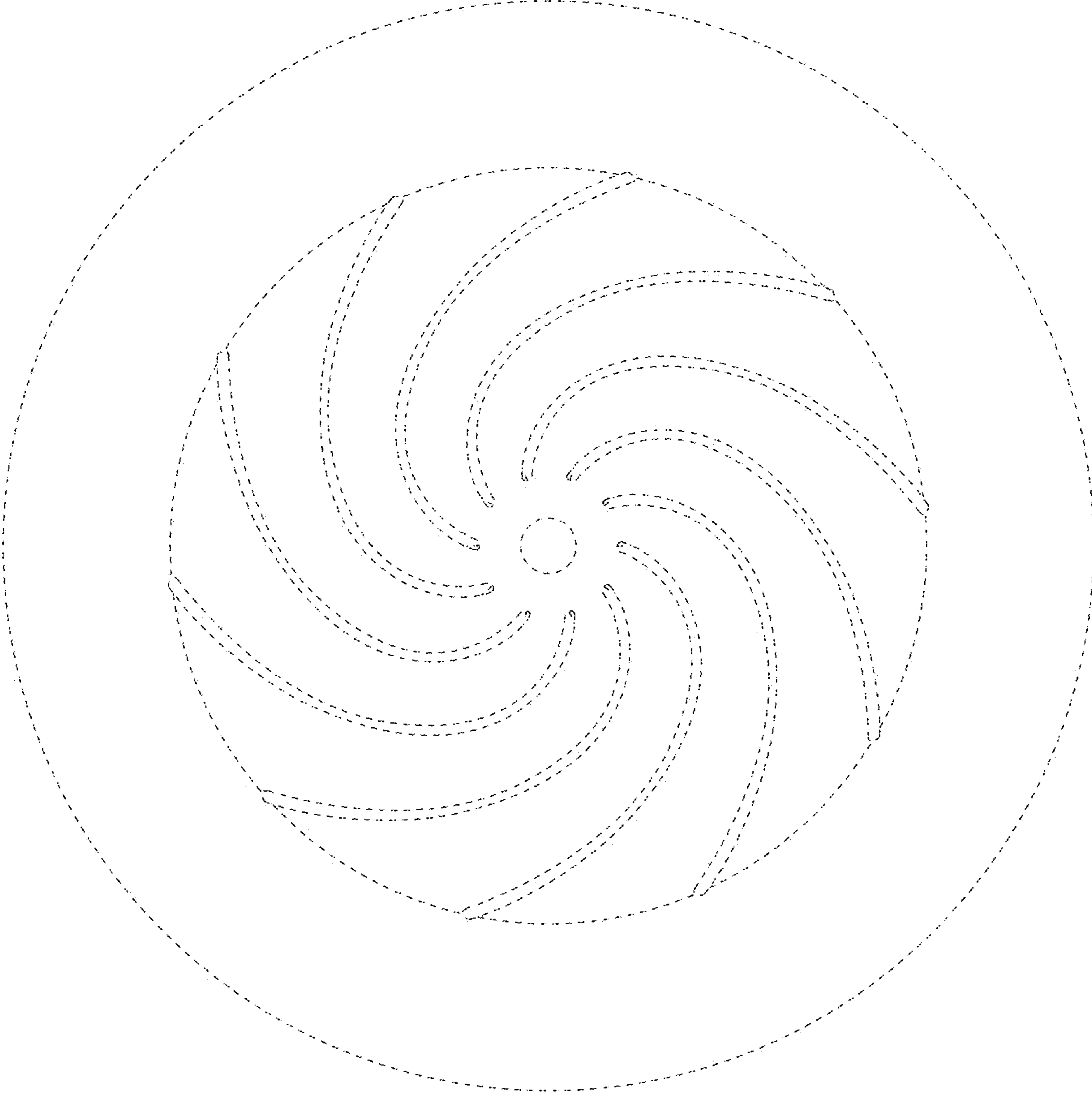
