The ornamental design for an oral appliance, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an oral appliance of a first embodiment of the design;

FIG. 13 is a right side view of the oral appliance as shown in FIG. 9;

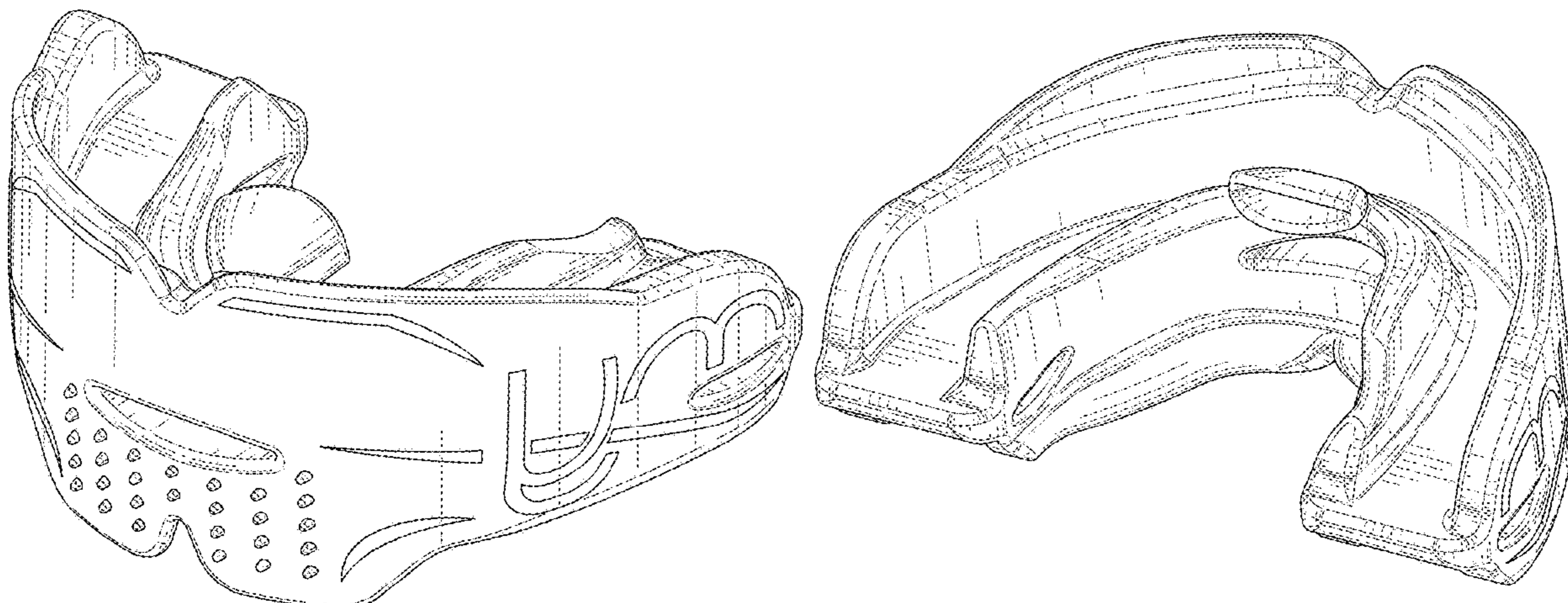
FIG. 14 is a left side view of the oral appliance as shown in FIG. 9;

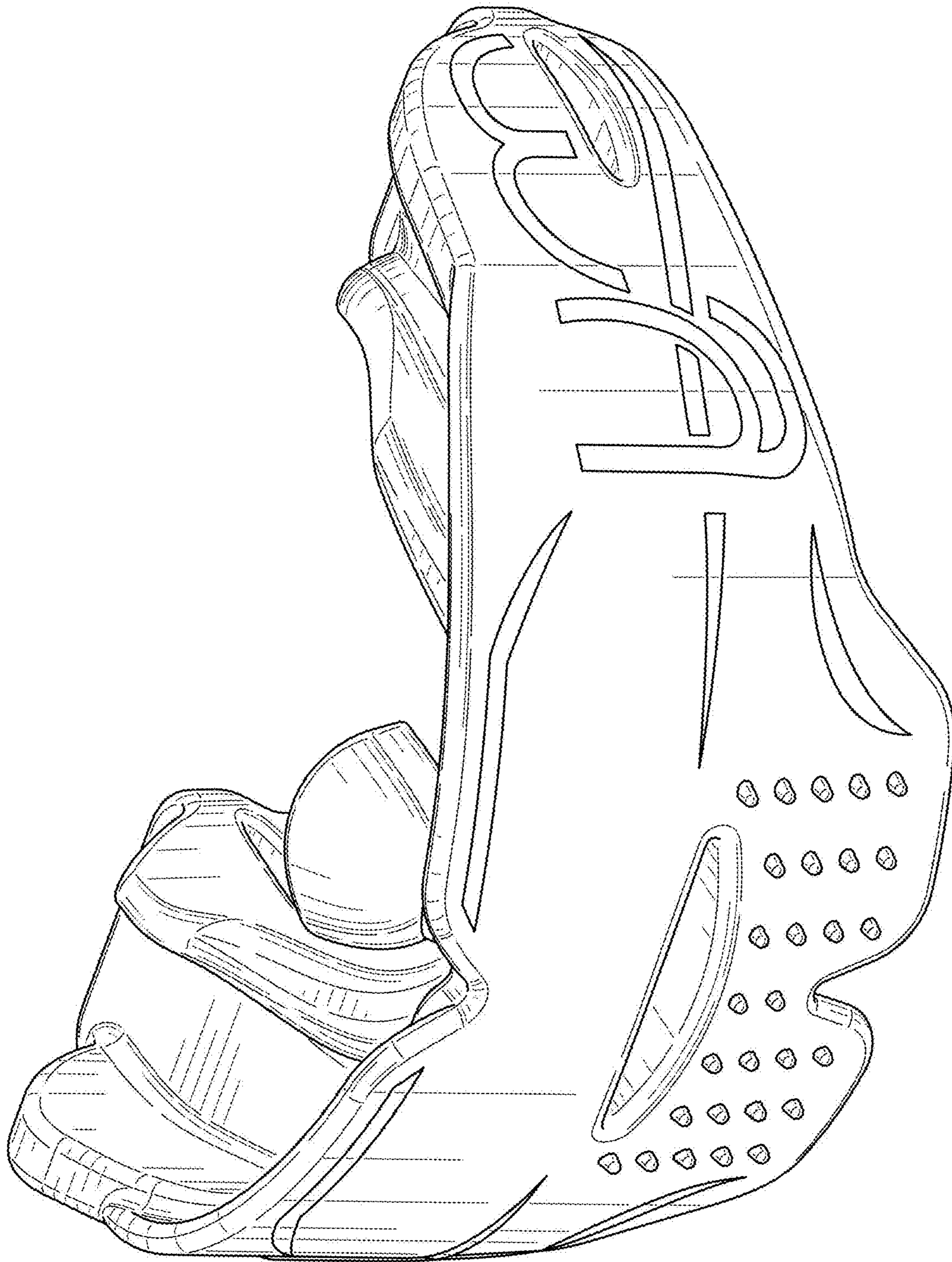

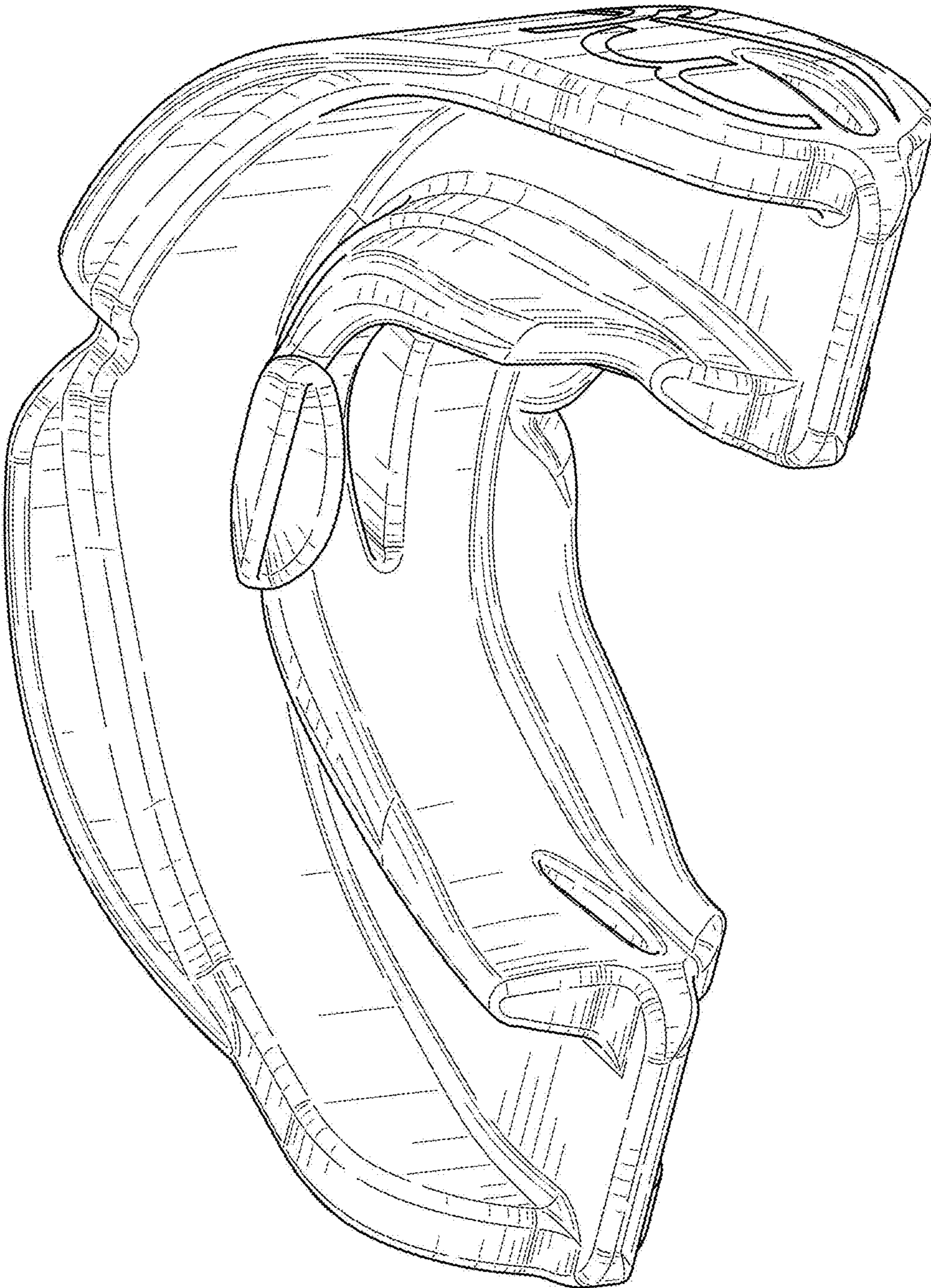

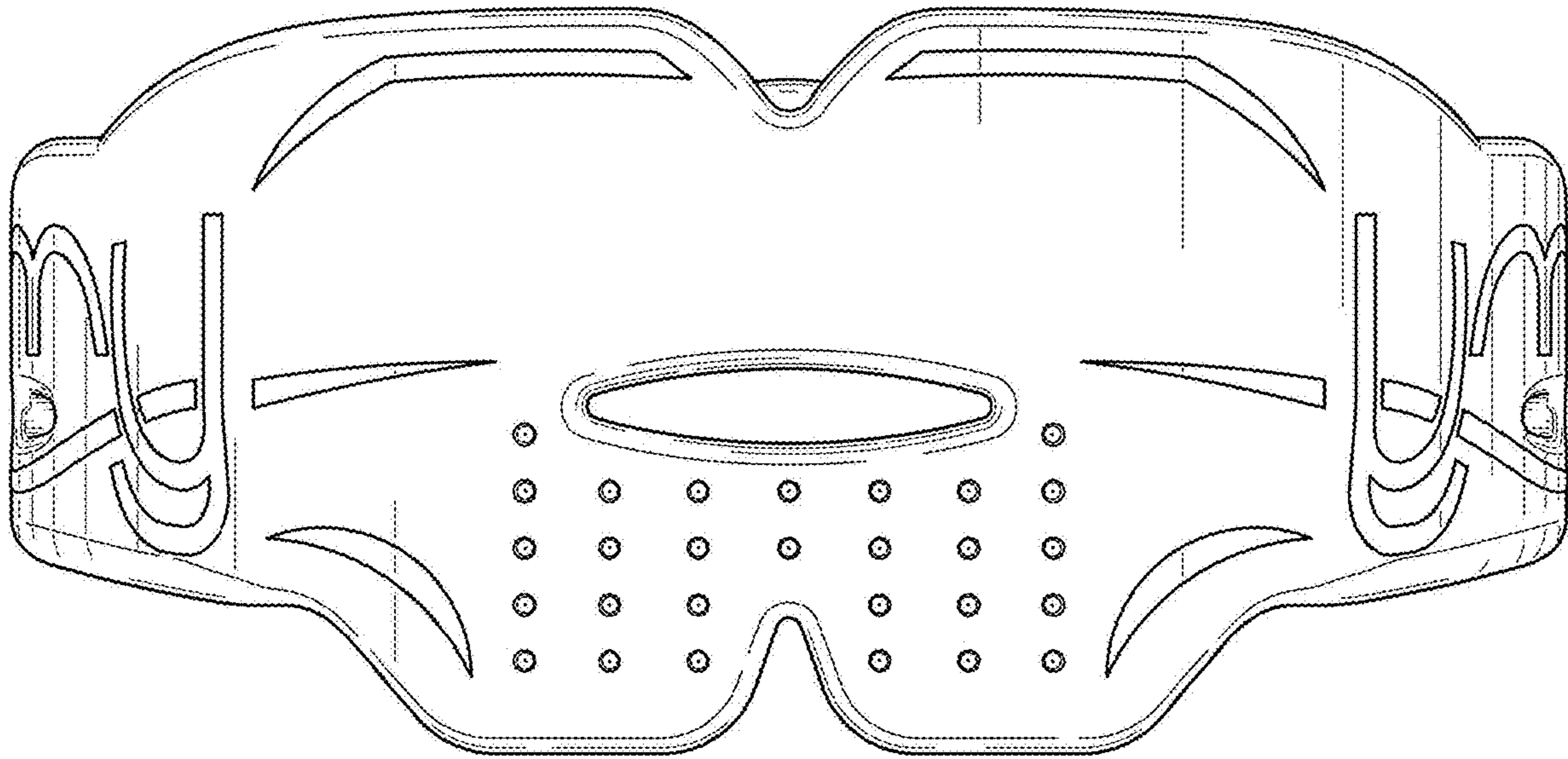

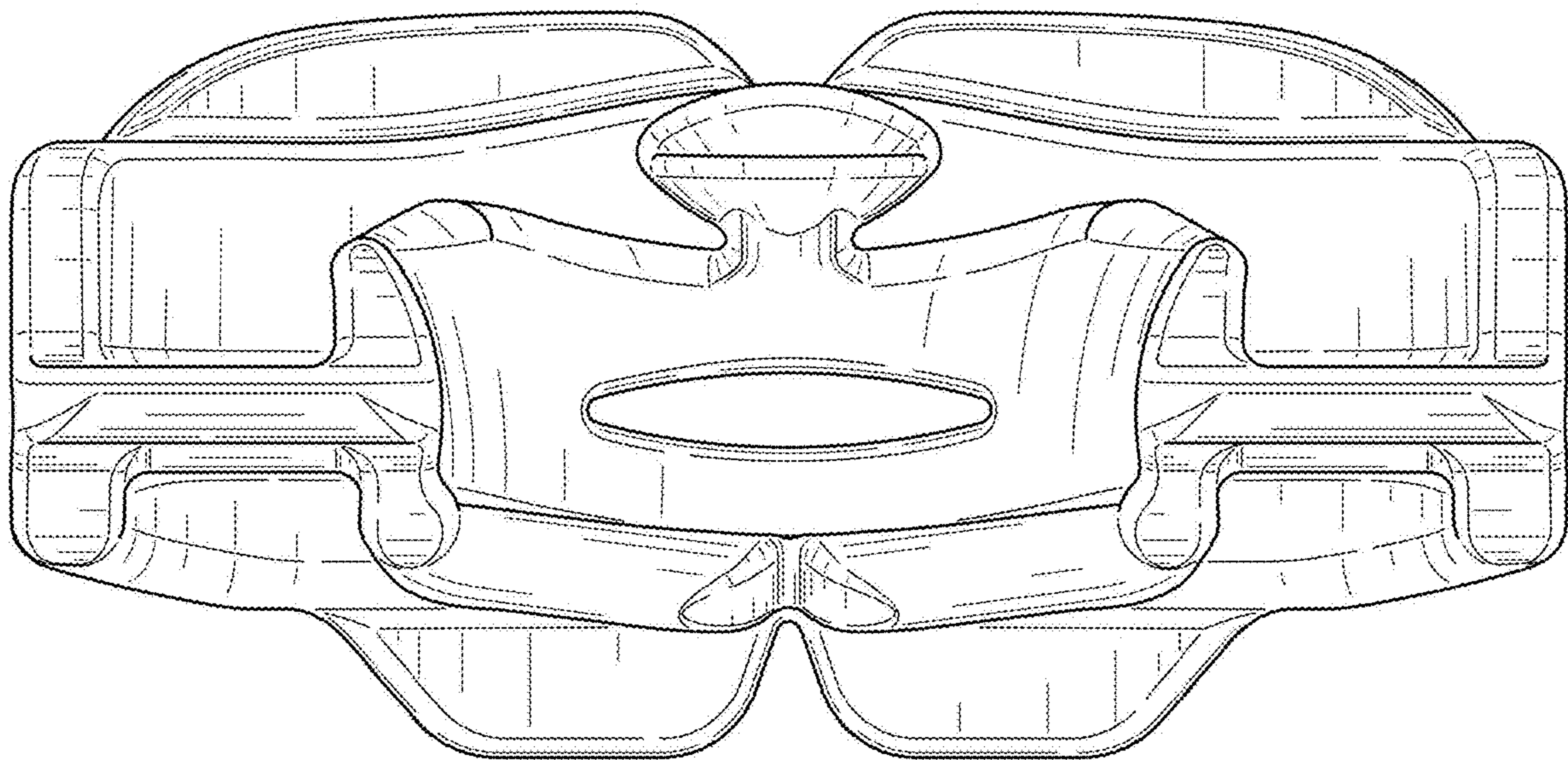

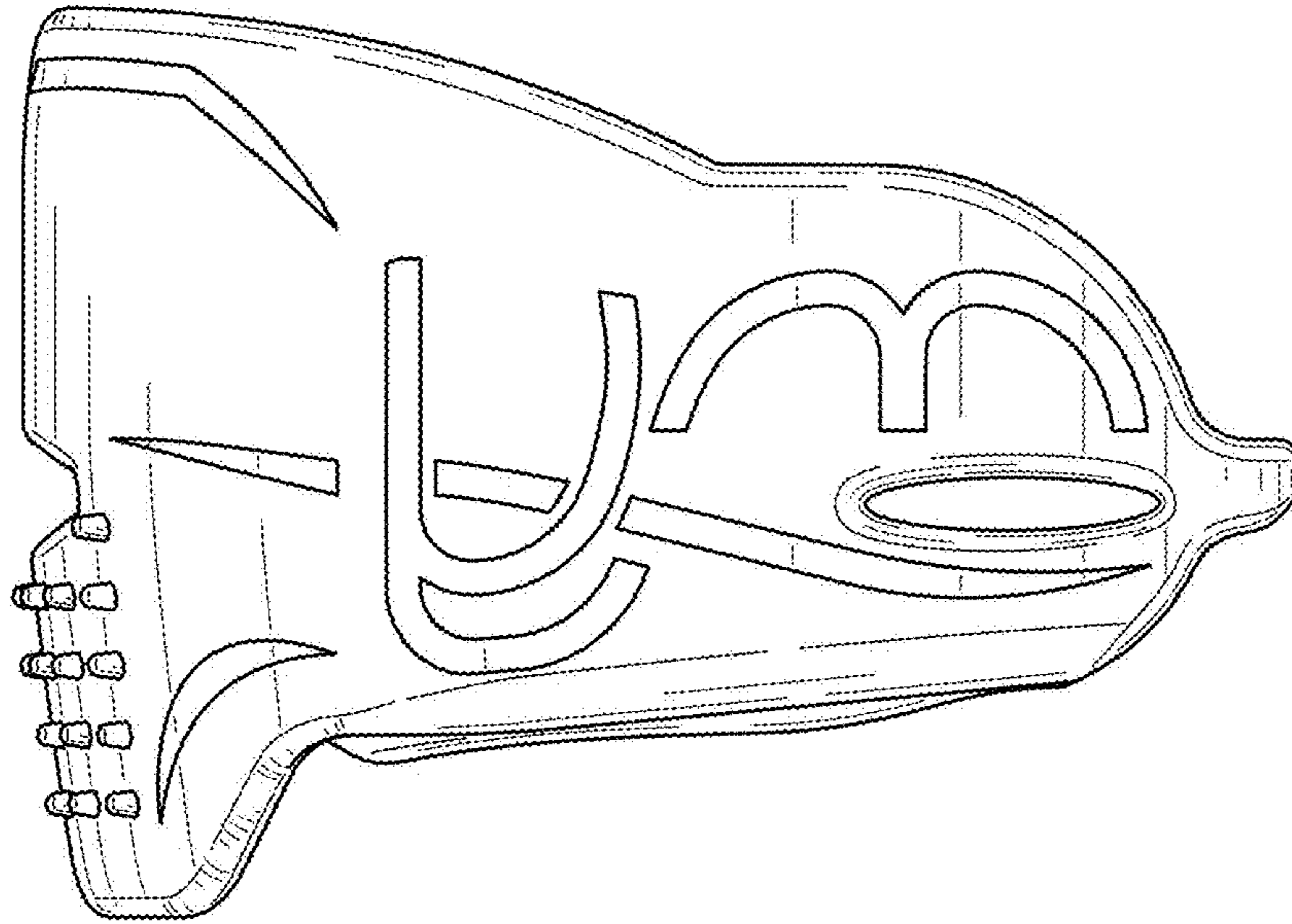

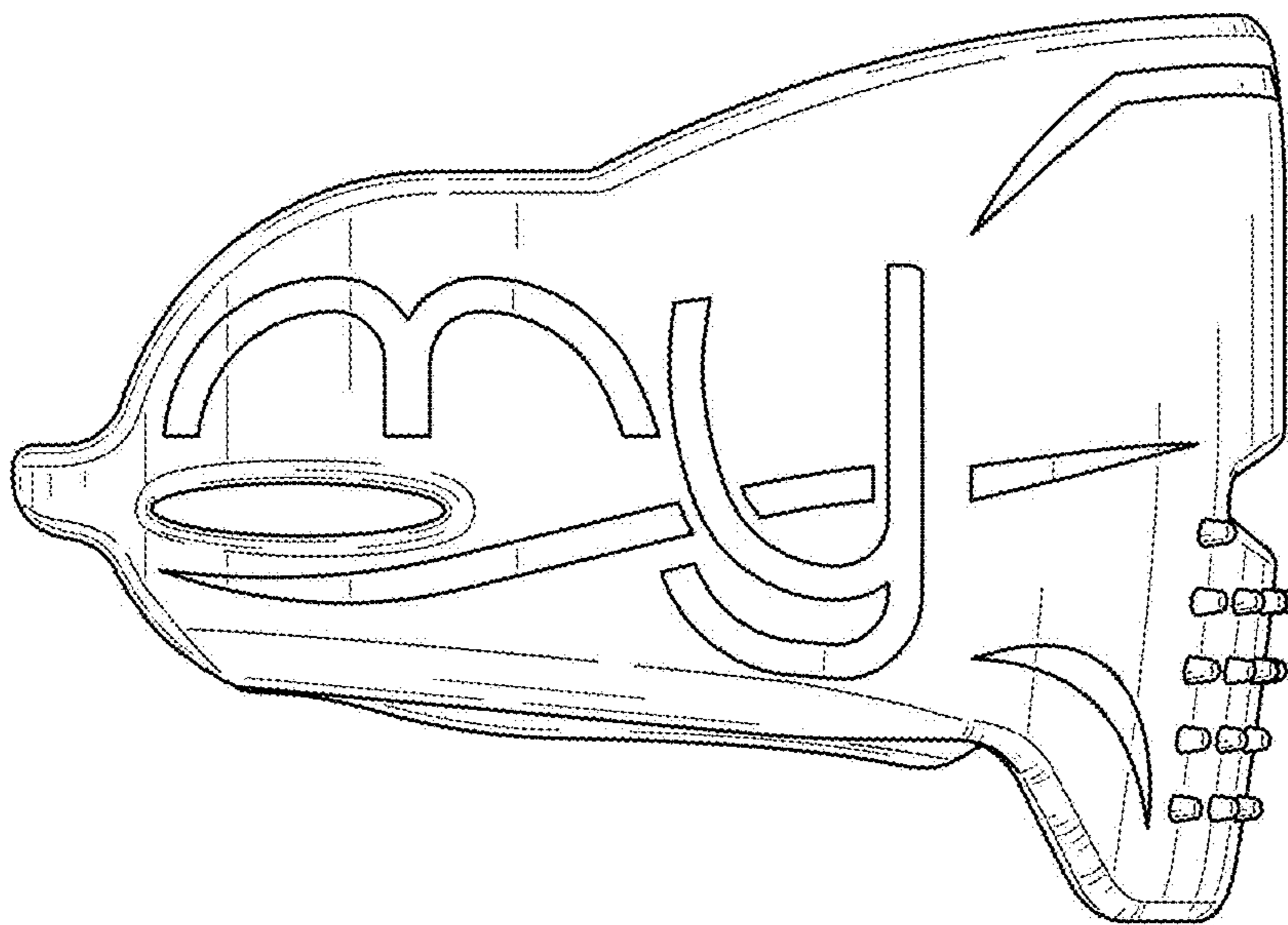

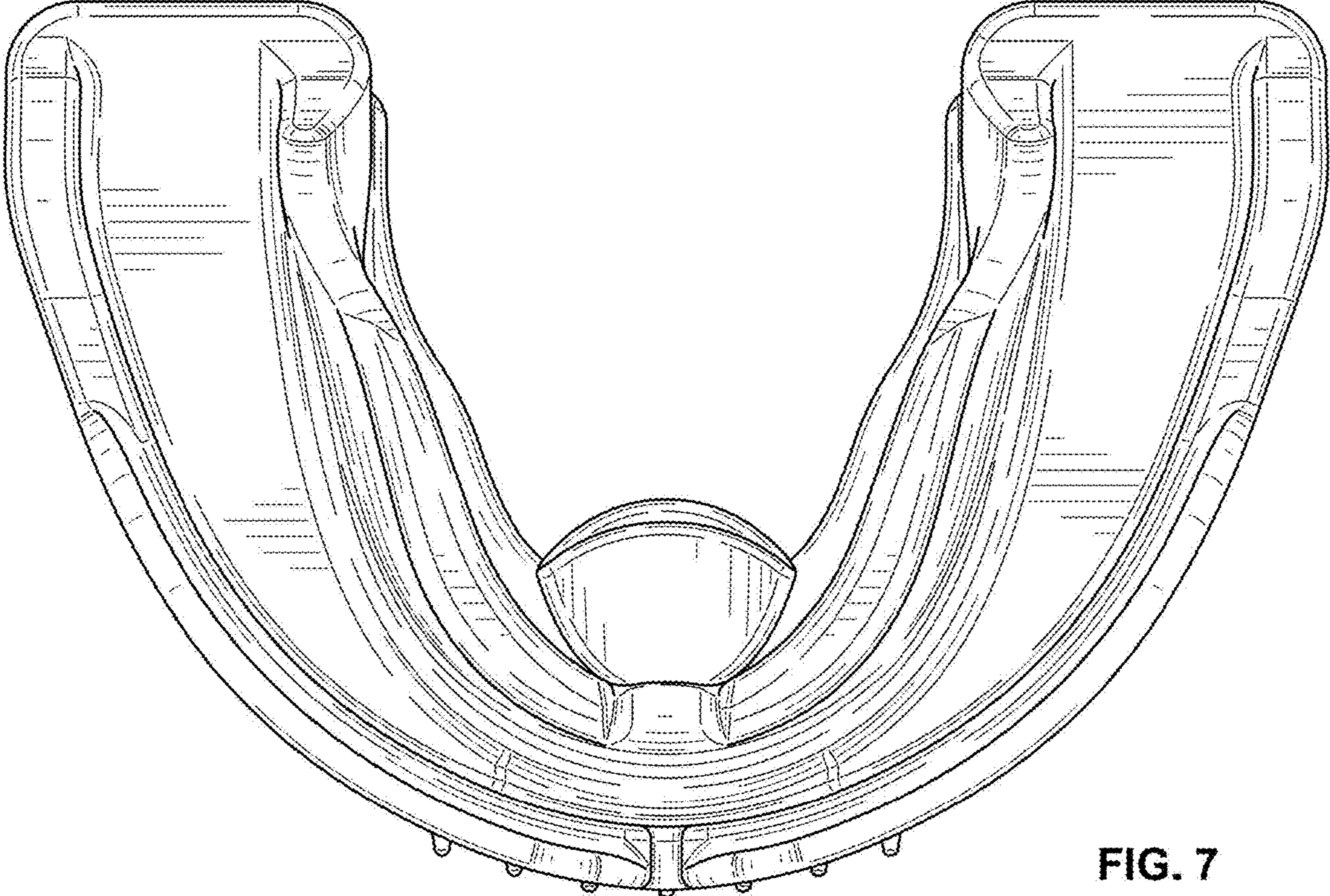

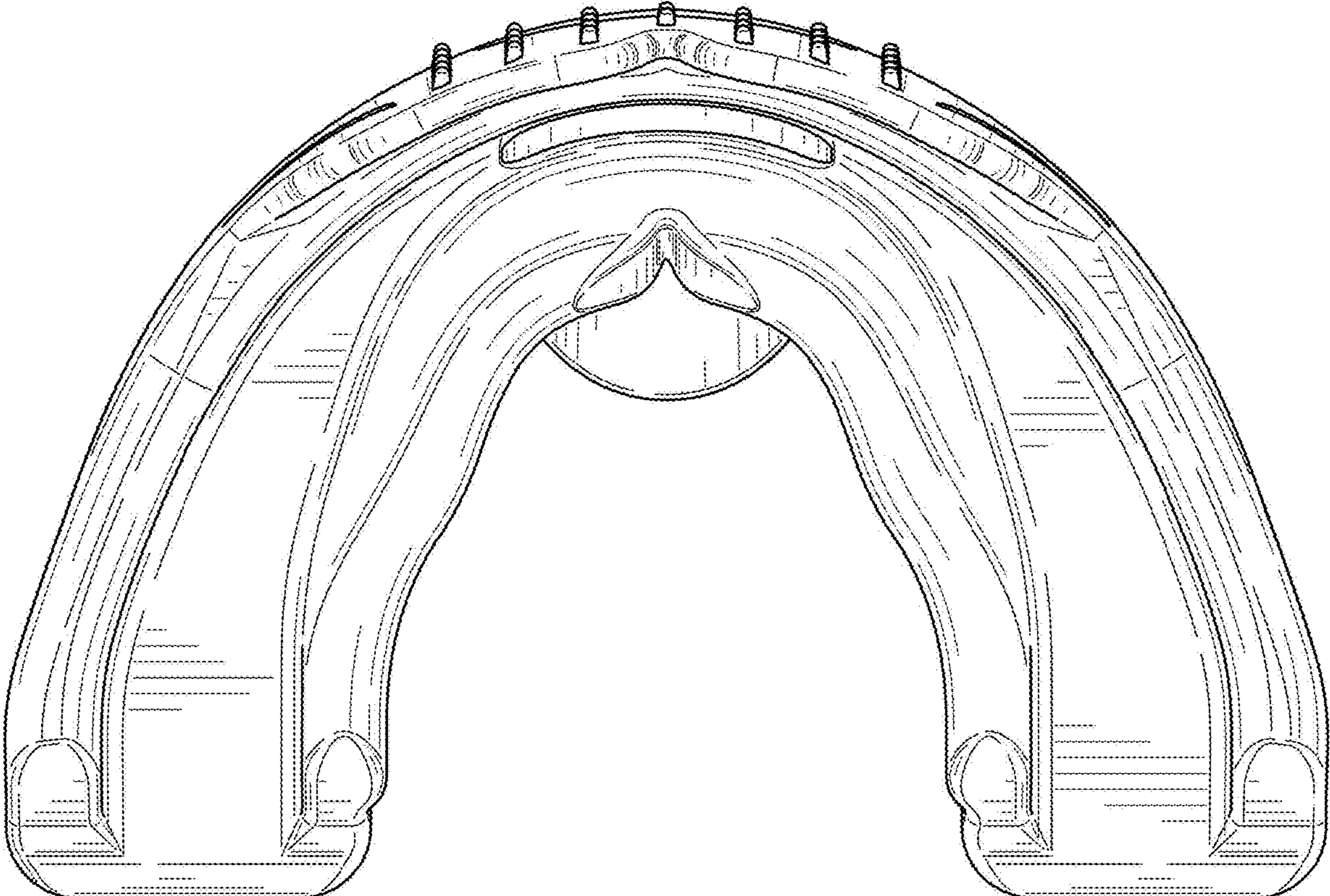

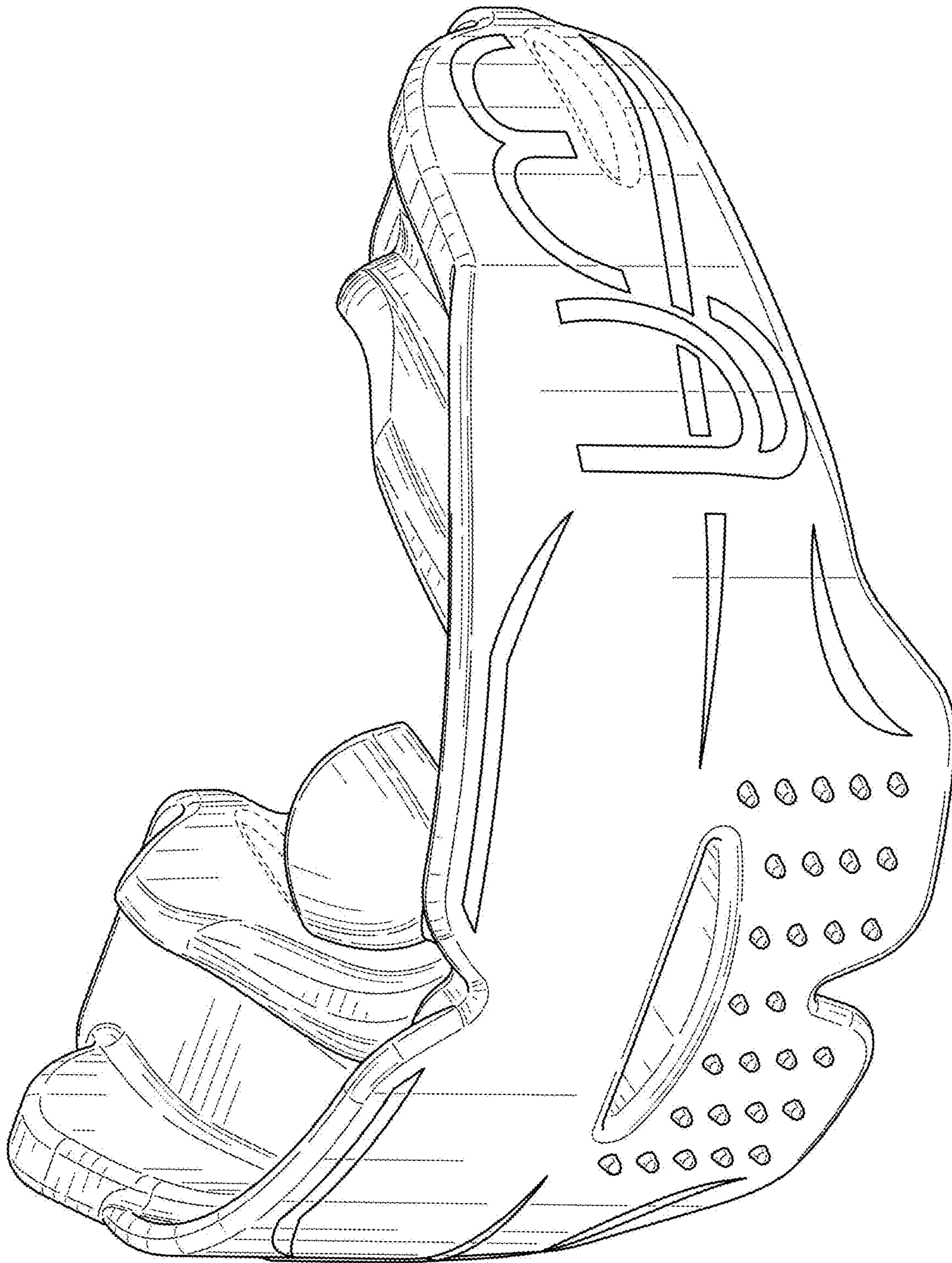

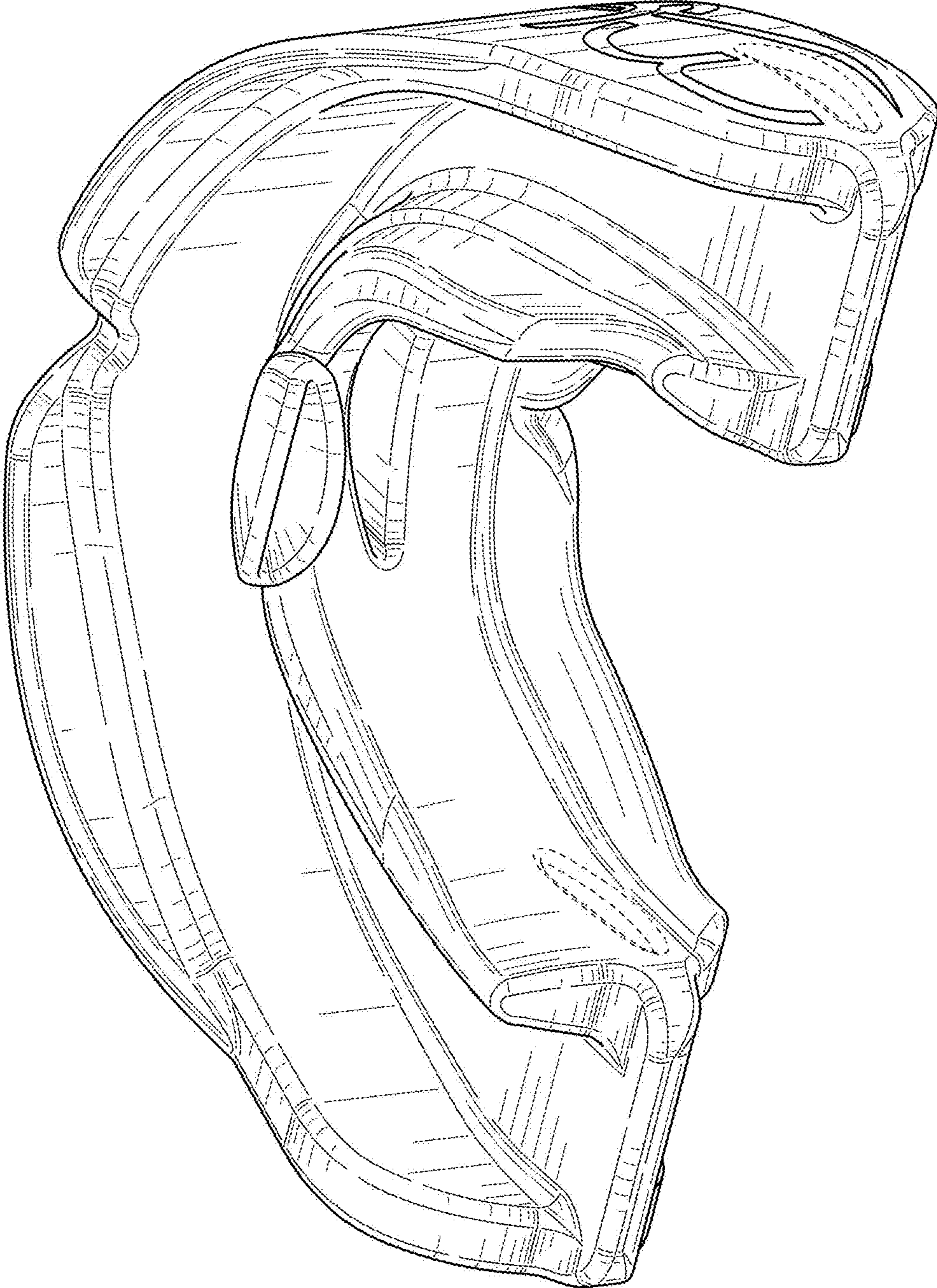

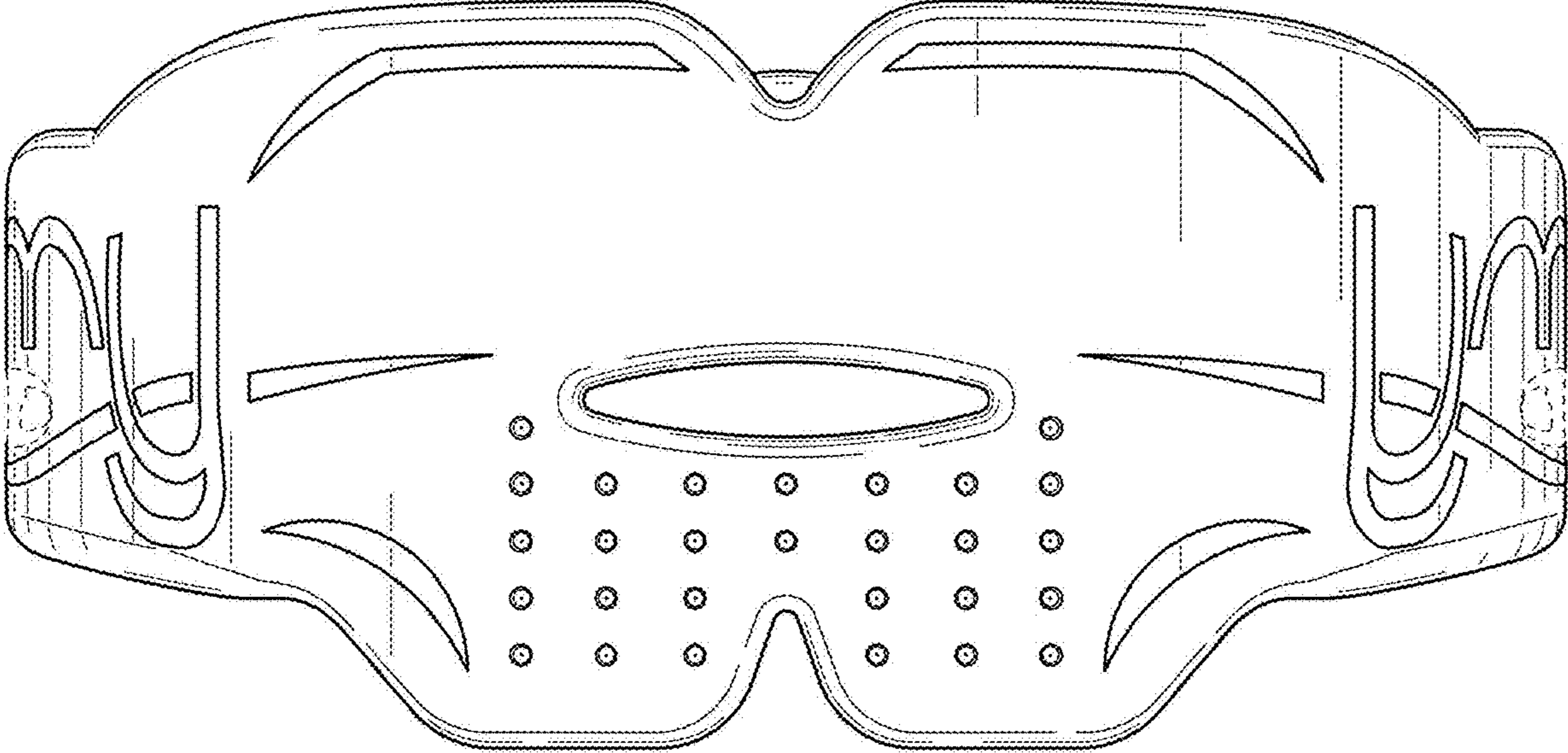

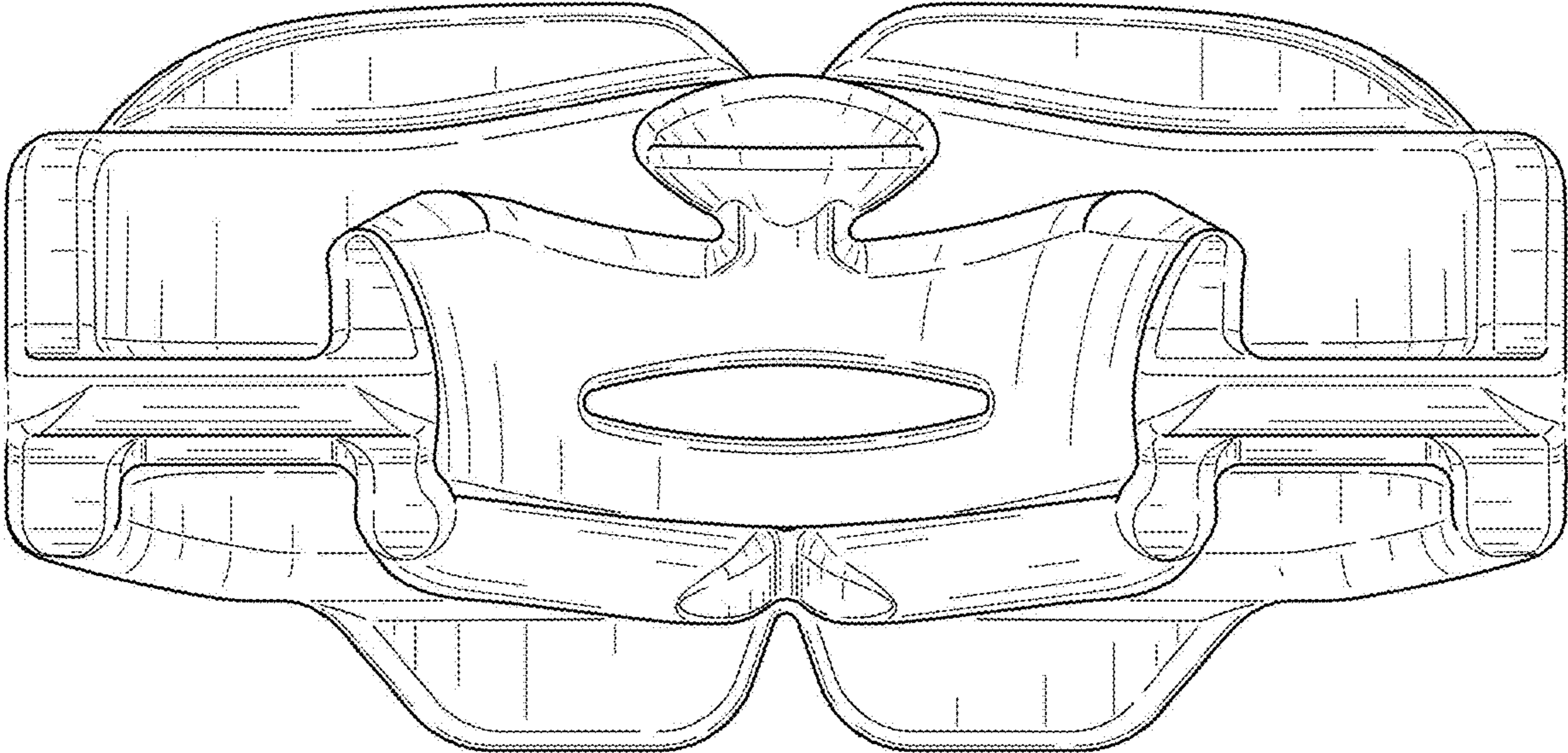

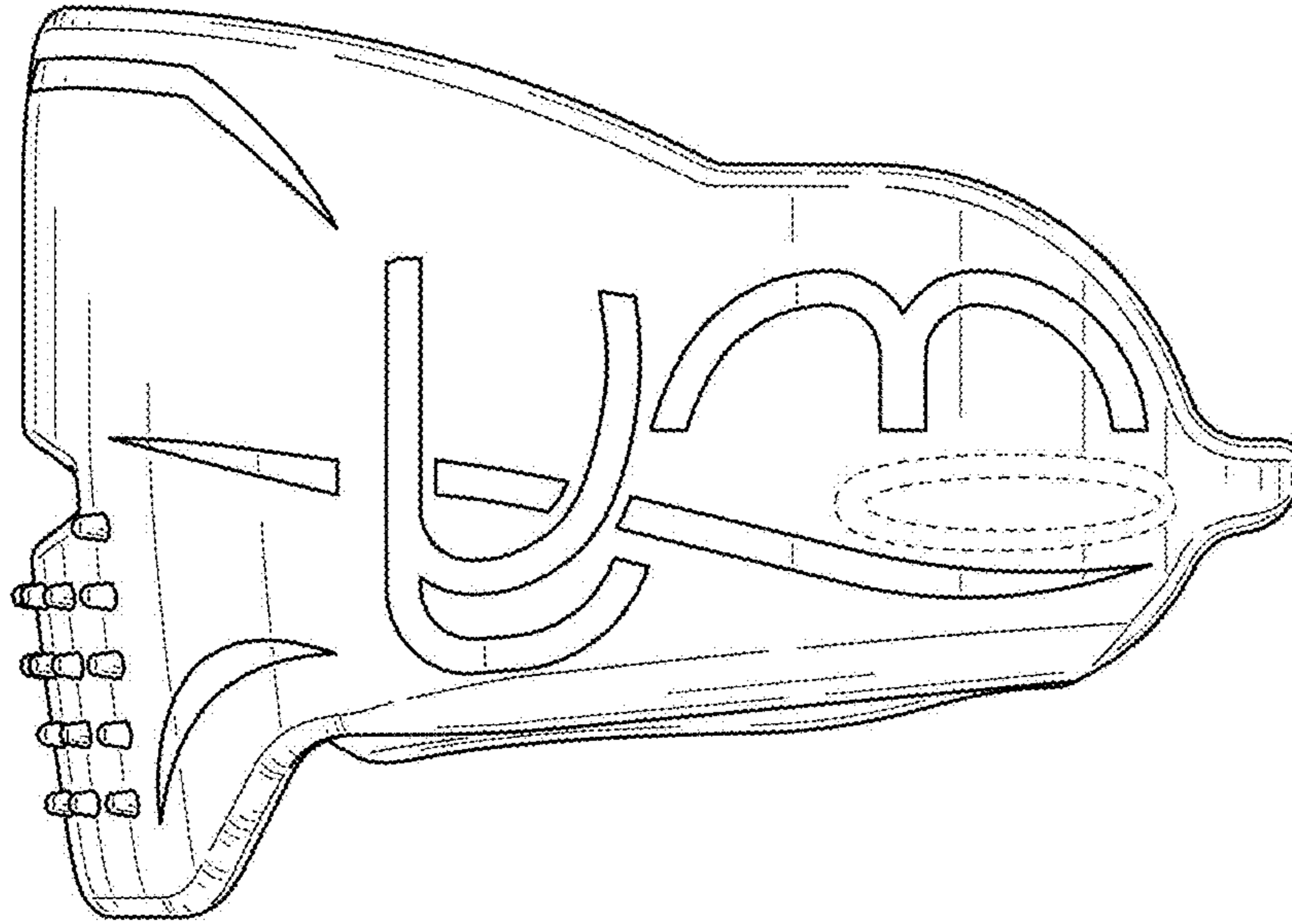

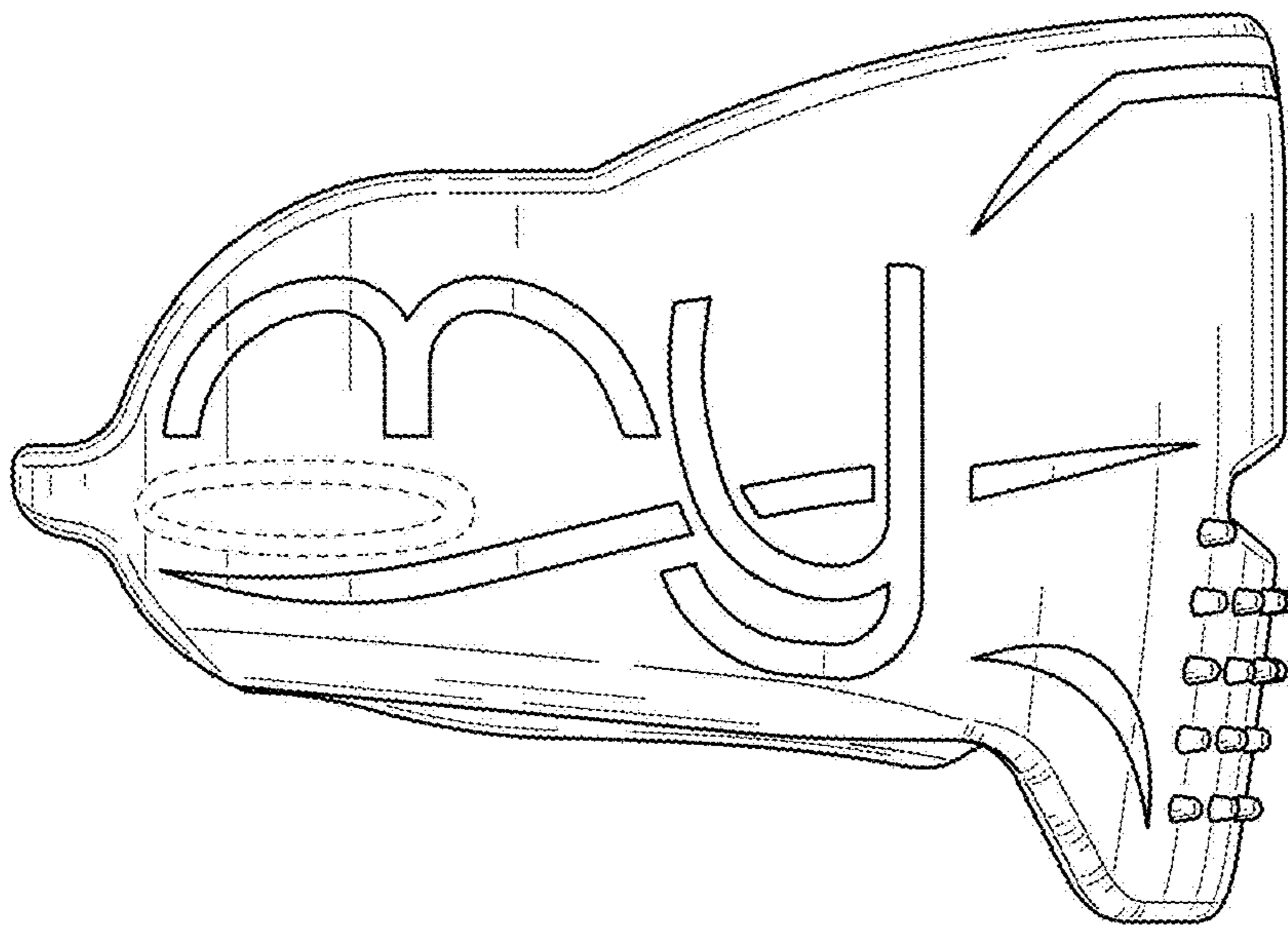

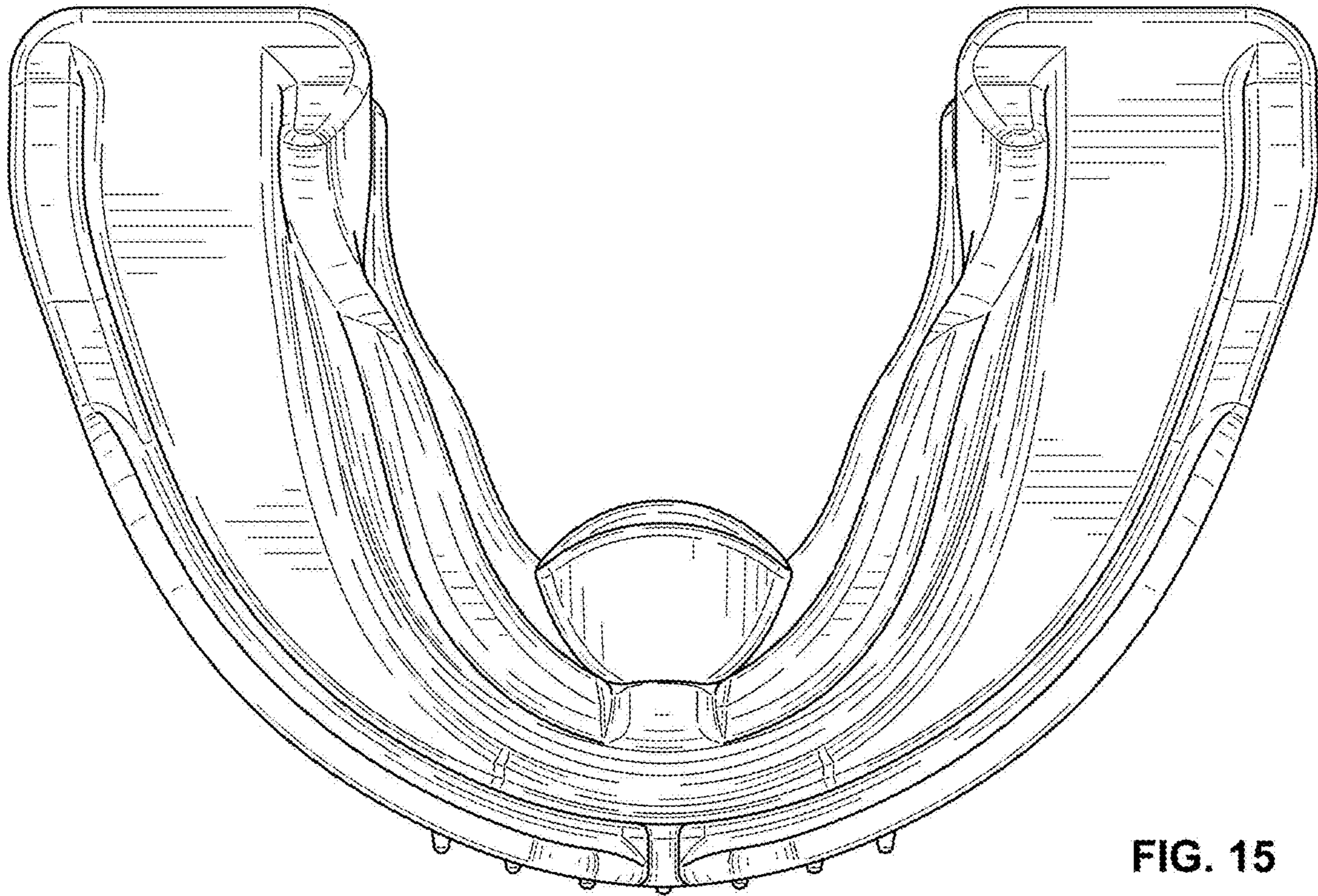

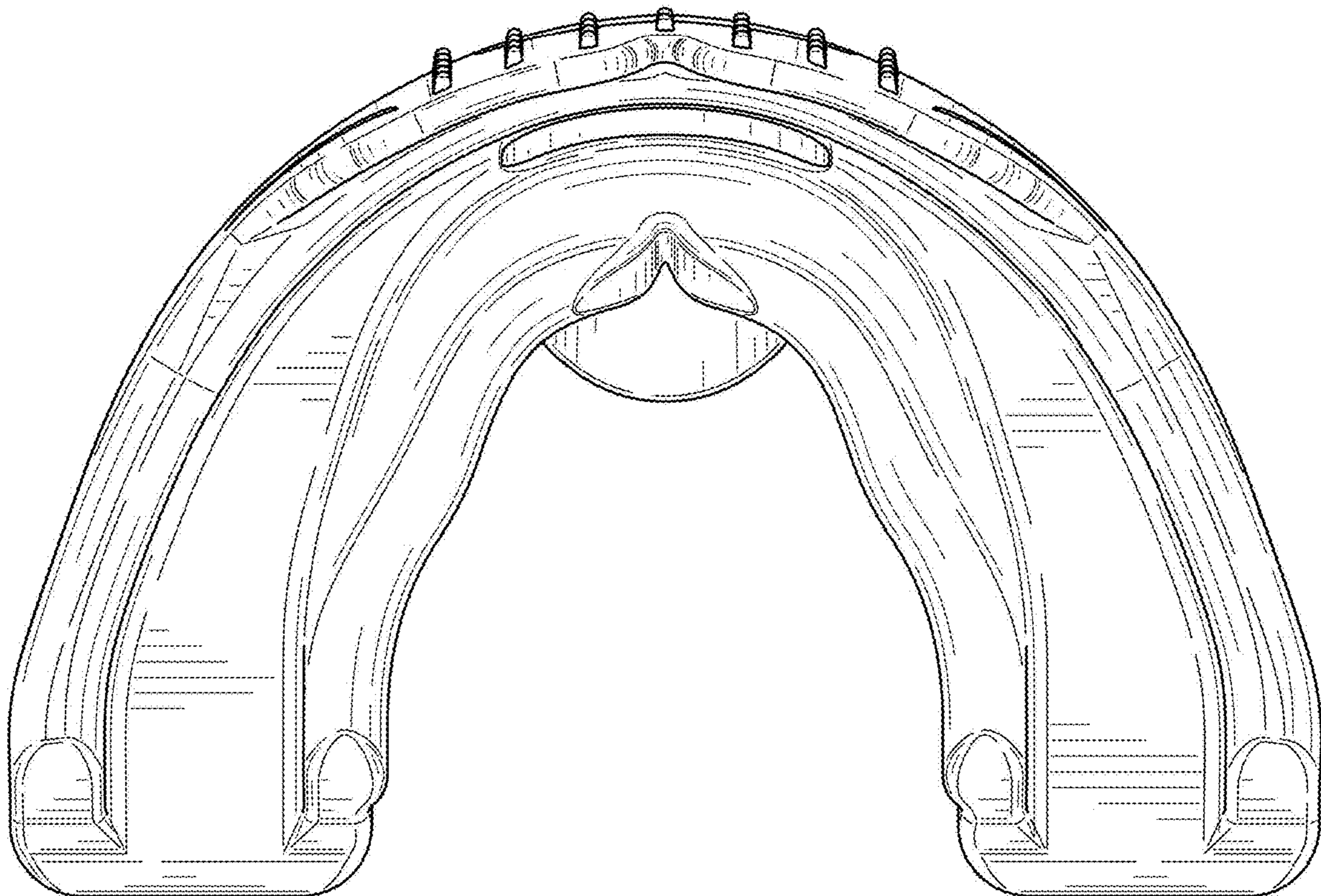
