FIG. 1.3 is another side elevation view thereof;

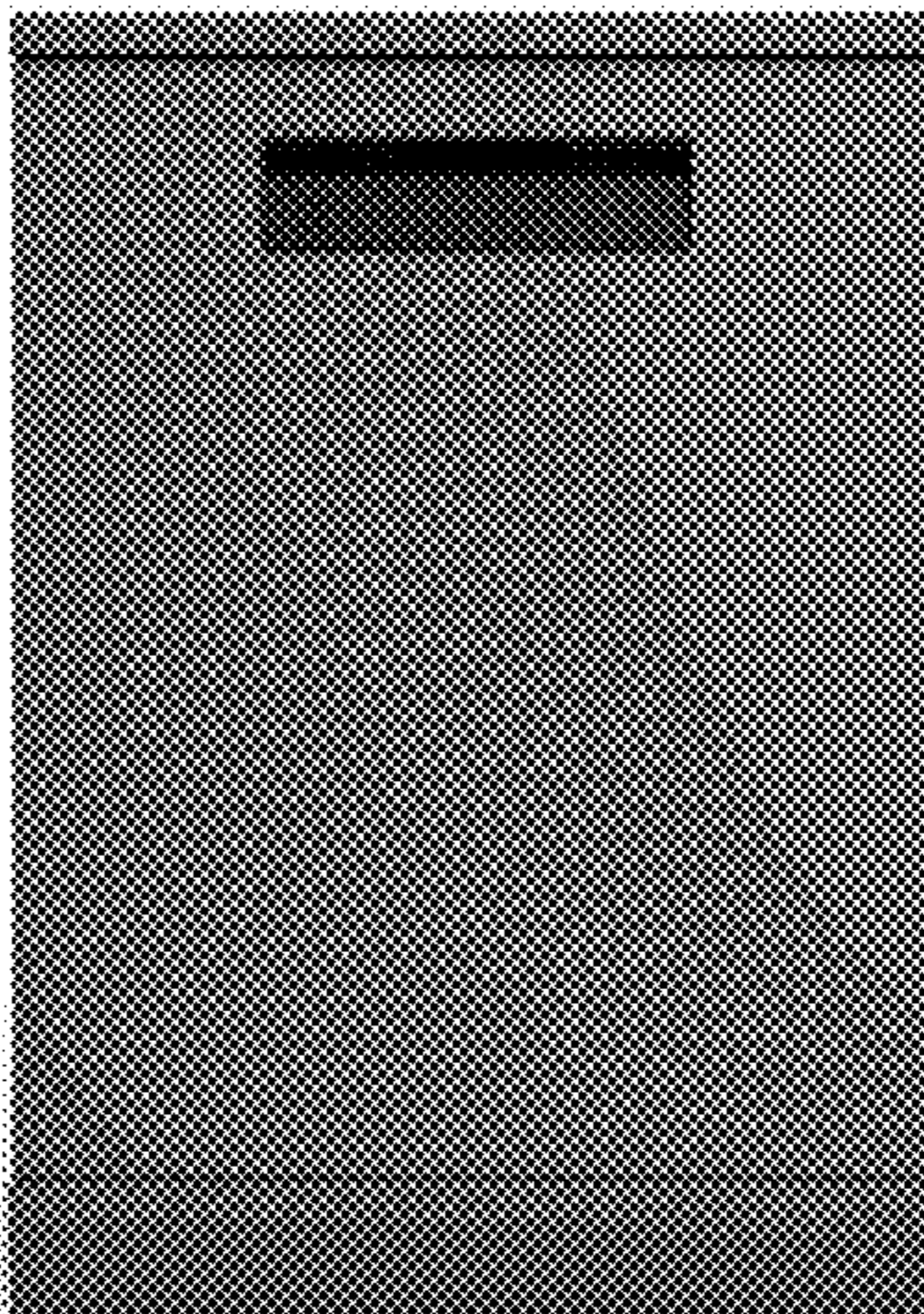
FIG. 1.4 is top plan view thereof; and

FIG. 1.5 is bottom plan view thereof;

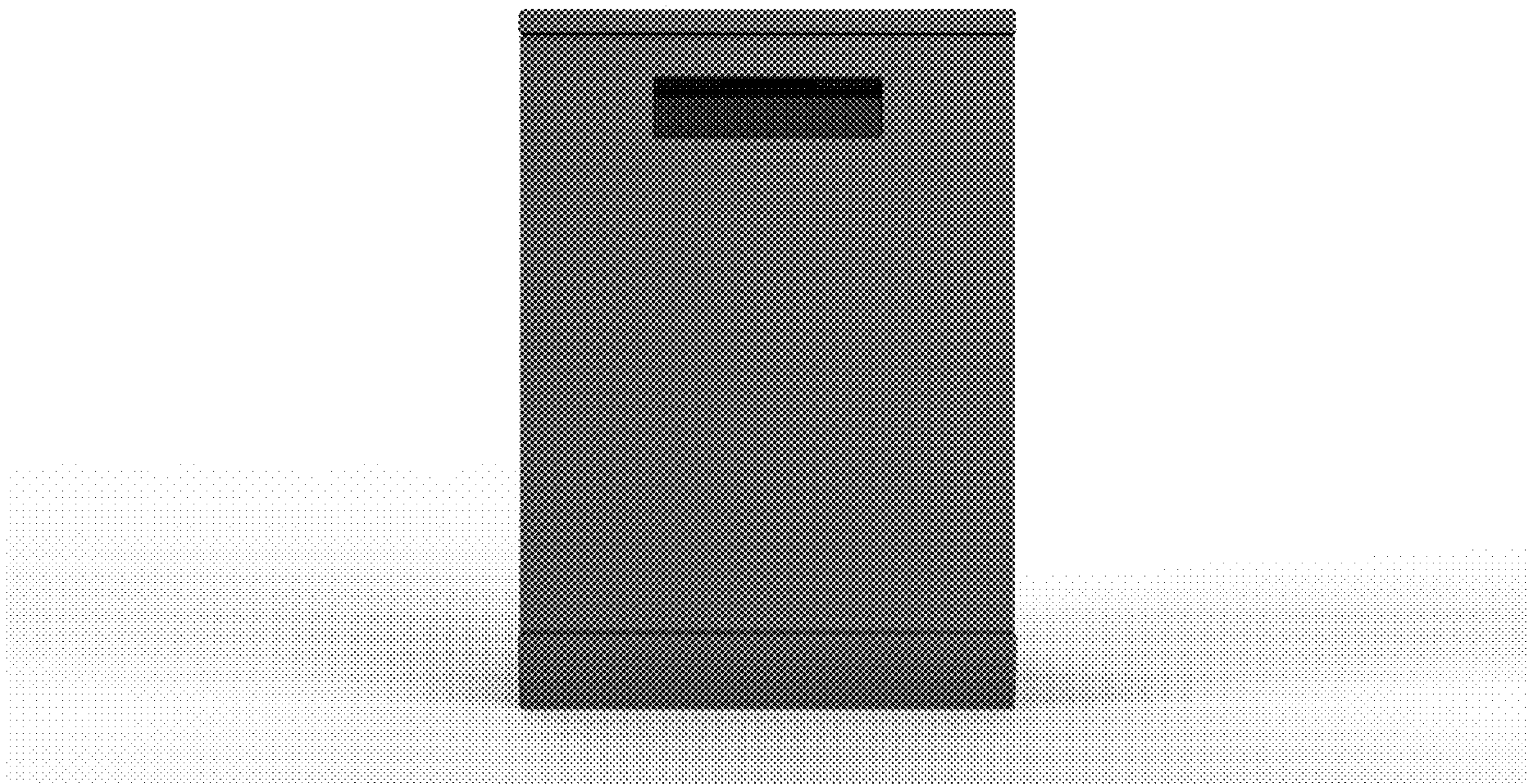
FIG. 1.6 is a perspective view thereof;

FIG. 1.7 is another perspective view thereof.

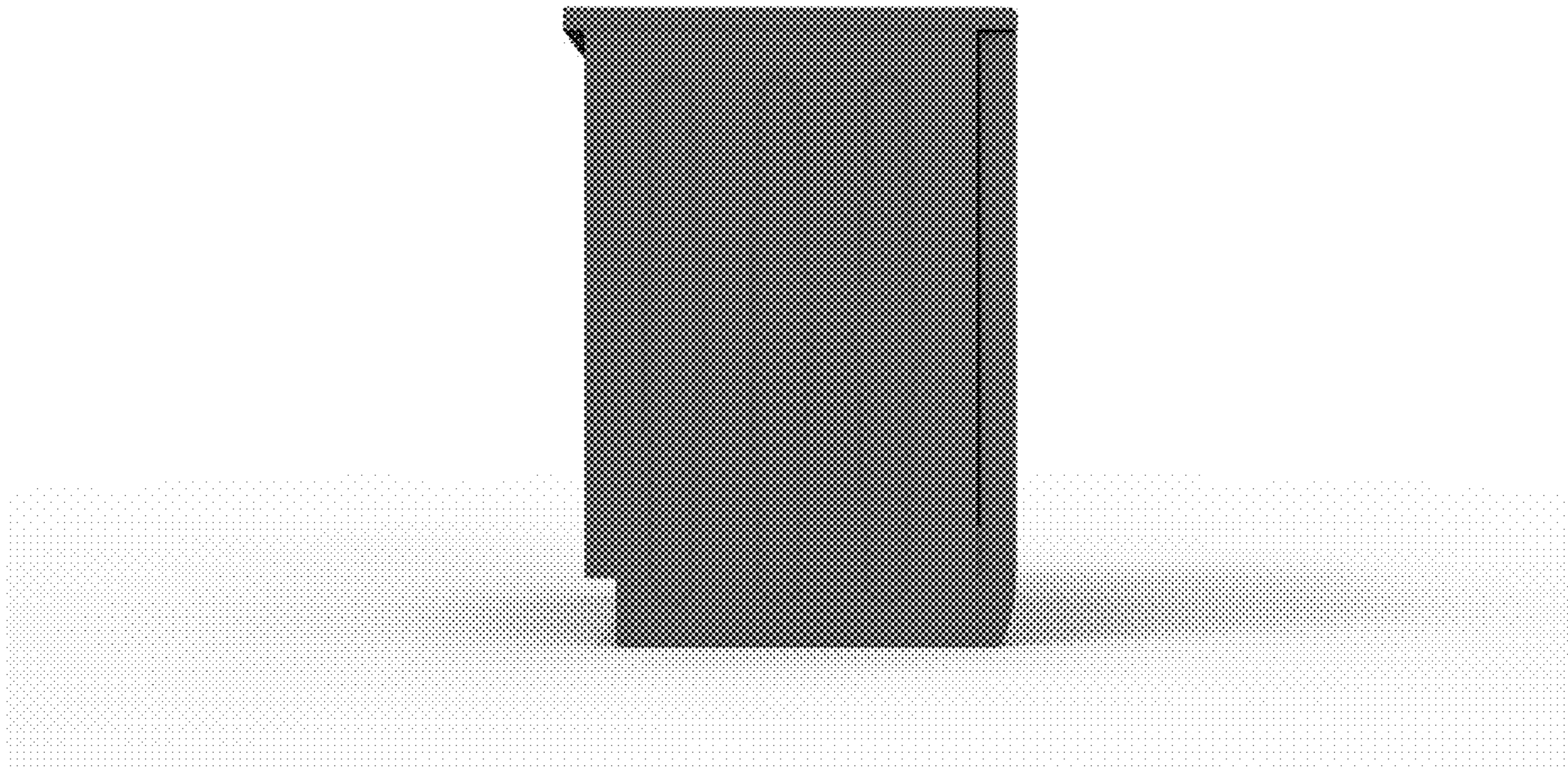

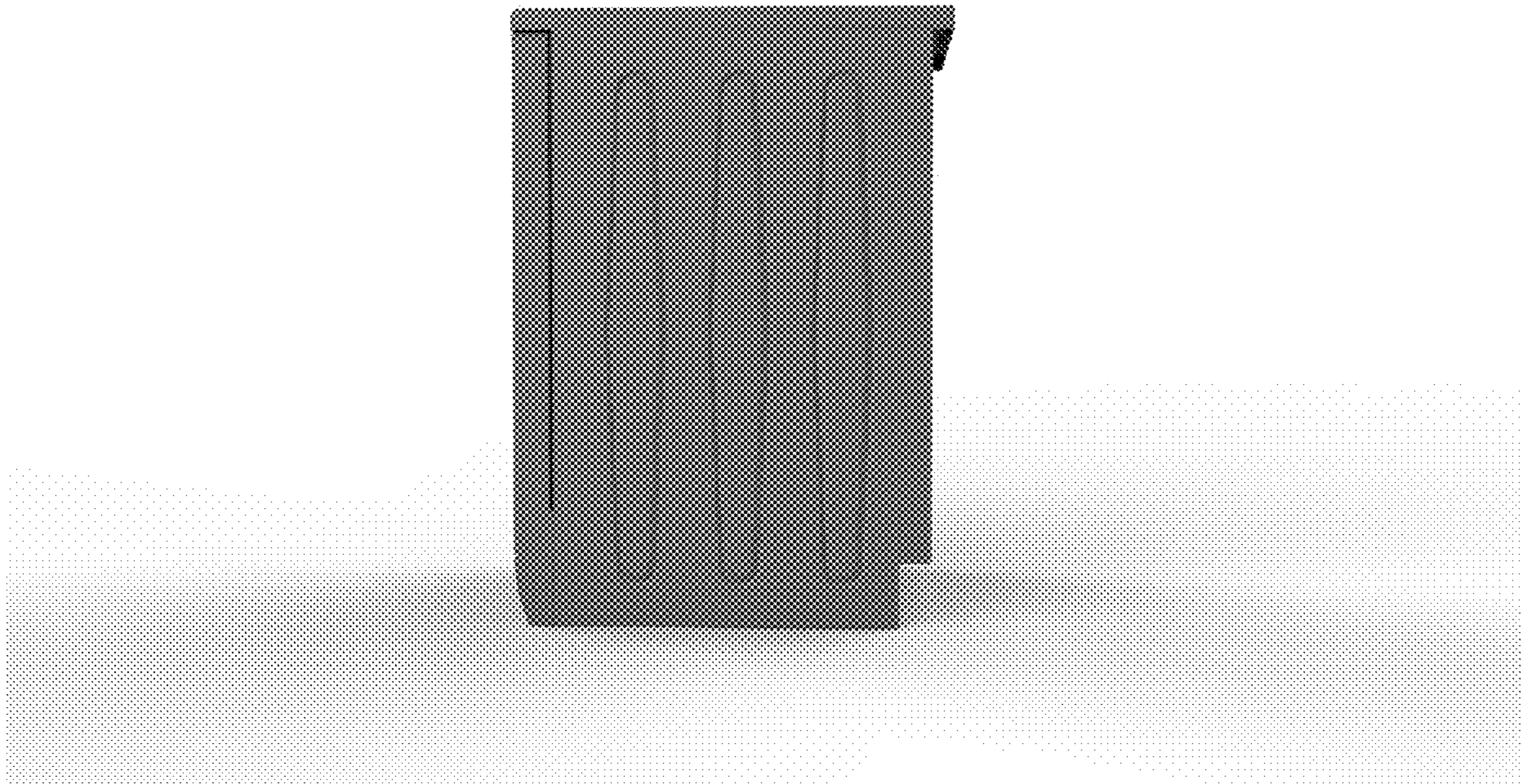

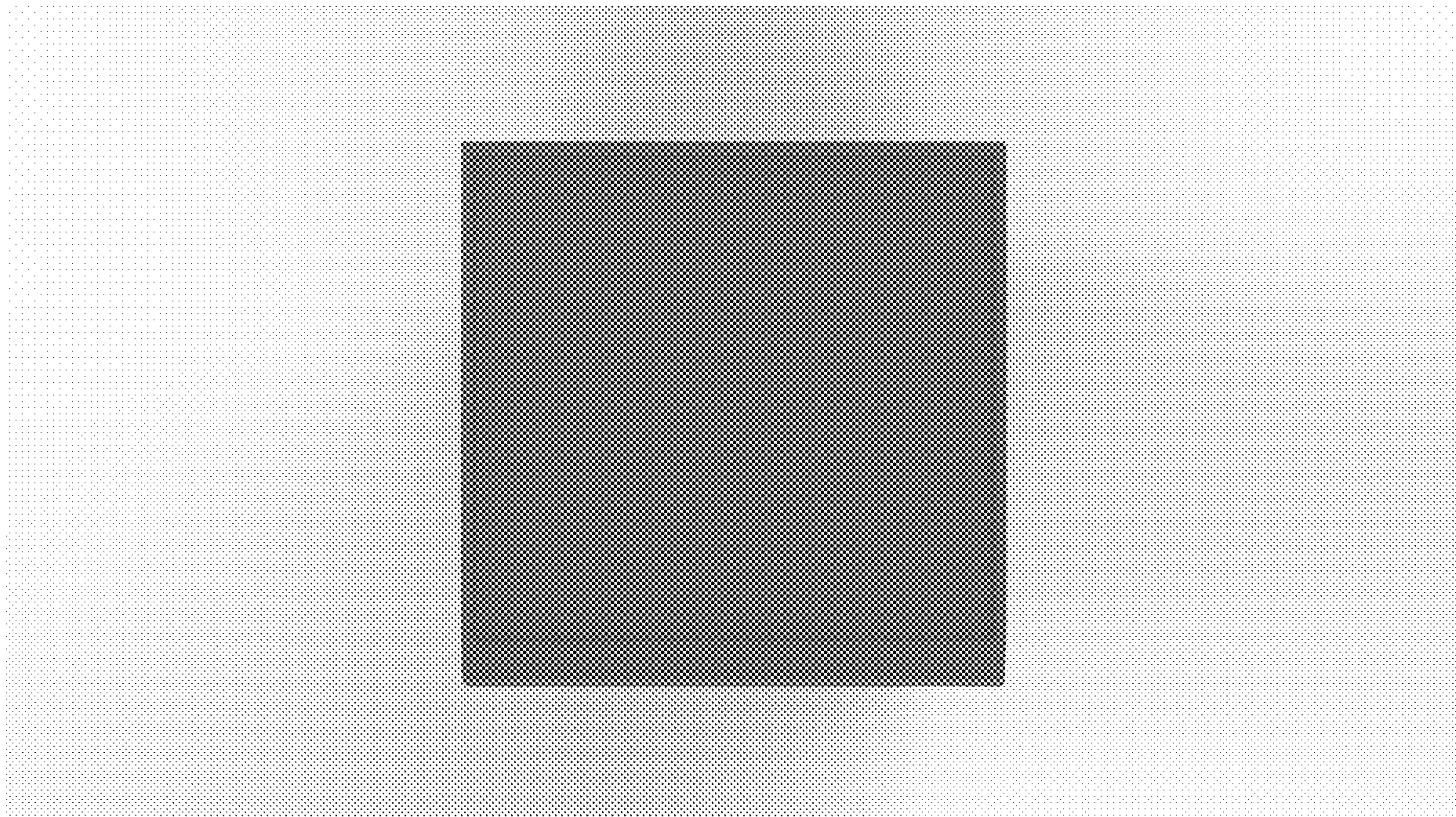

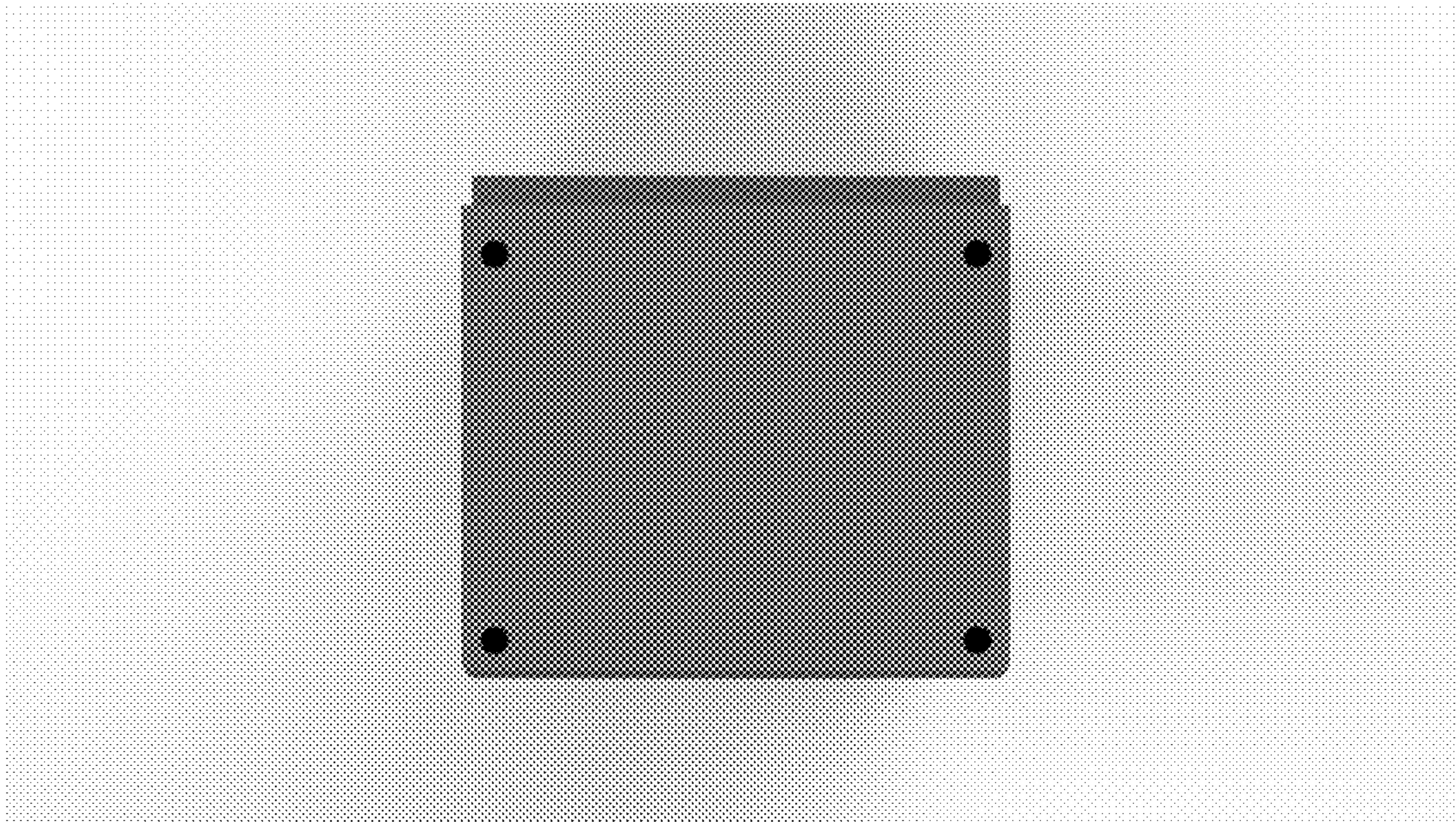

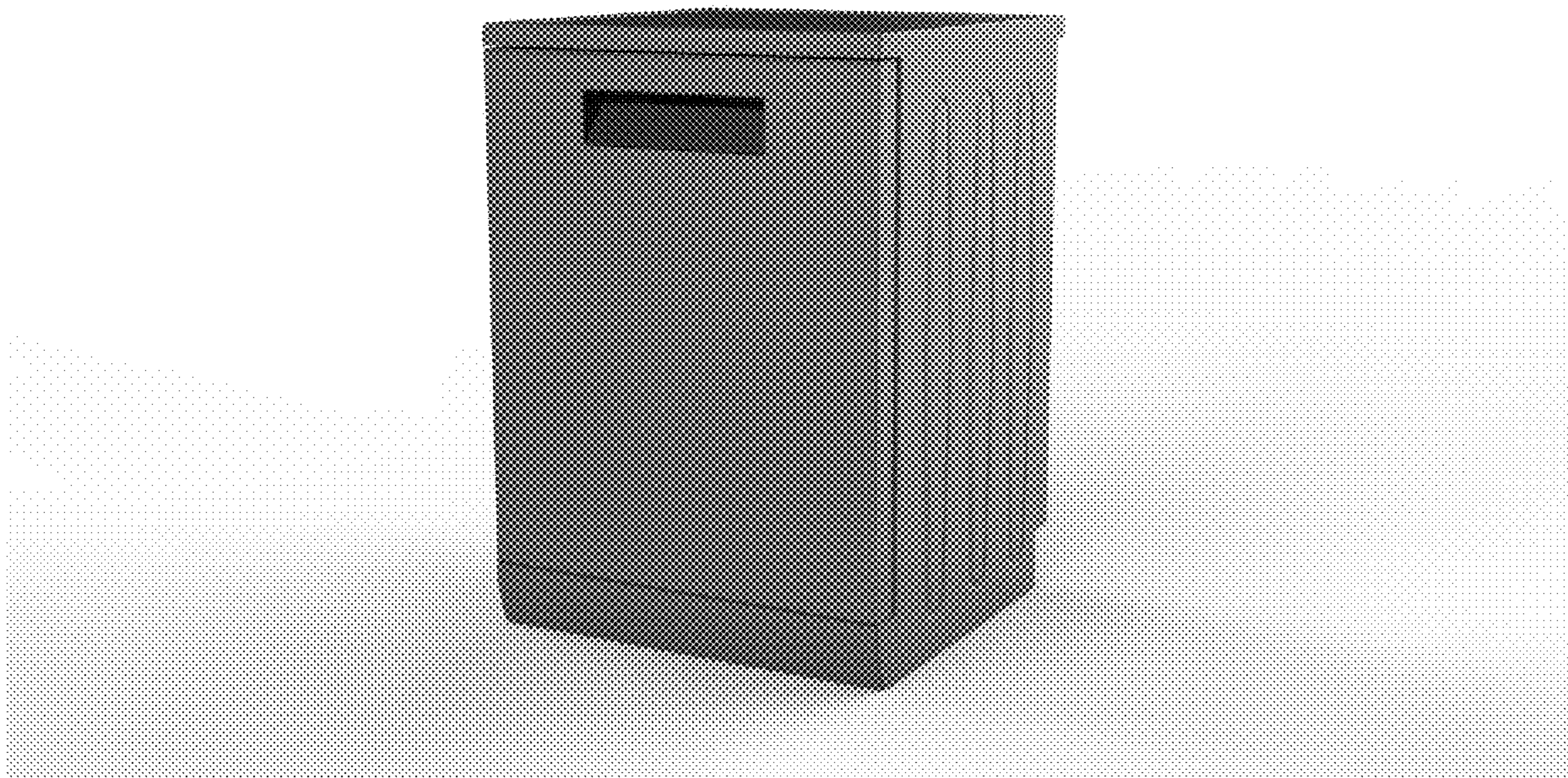
