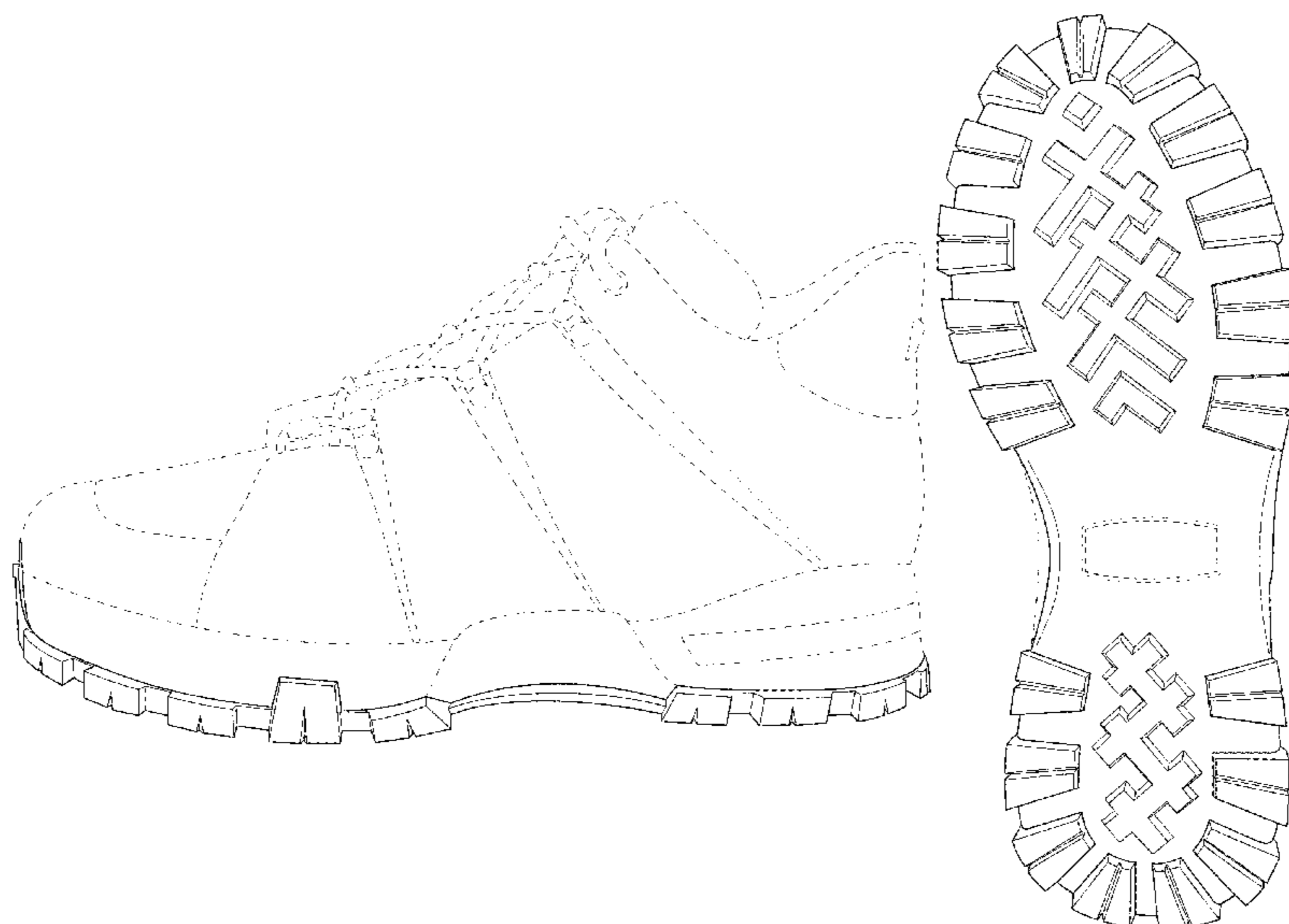
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right-side perspective view of a shoe in accordance with my new design;
 FIG. 2 is a front view of the shoe shown in FIG. 1;
 FIG. 3 is a rear view of the shoe shown in FIG. 1;
 FIG. 4 is a right-side view of the shoe shown in FIG. 1;
 FIG. 5 is a left-side view of the shoe shown in FIG. 1;
 FIG. 6 is a top view of the shoe shown in FIG. 1; and,
 FIG. 7 is a bottom view of the shoe shown in FIG. 1.

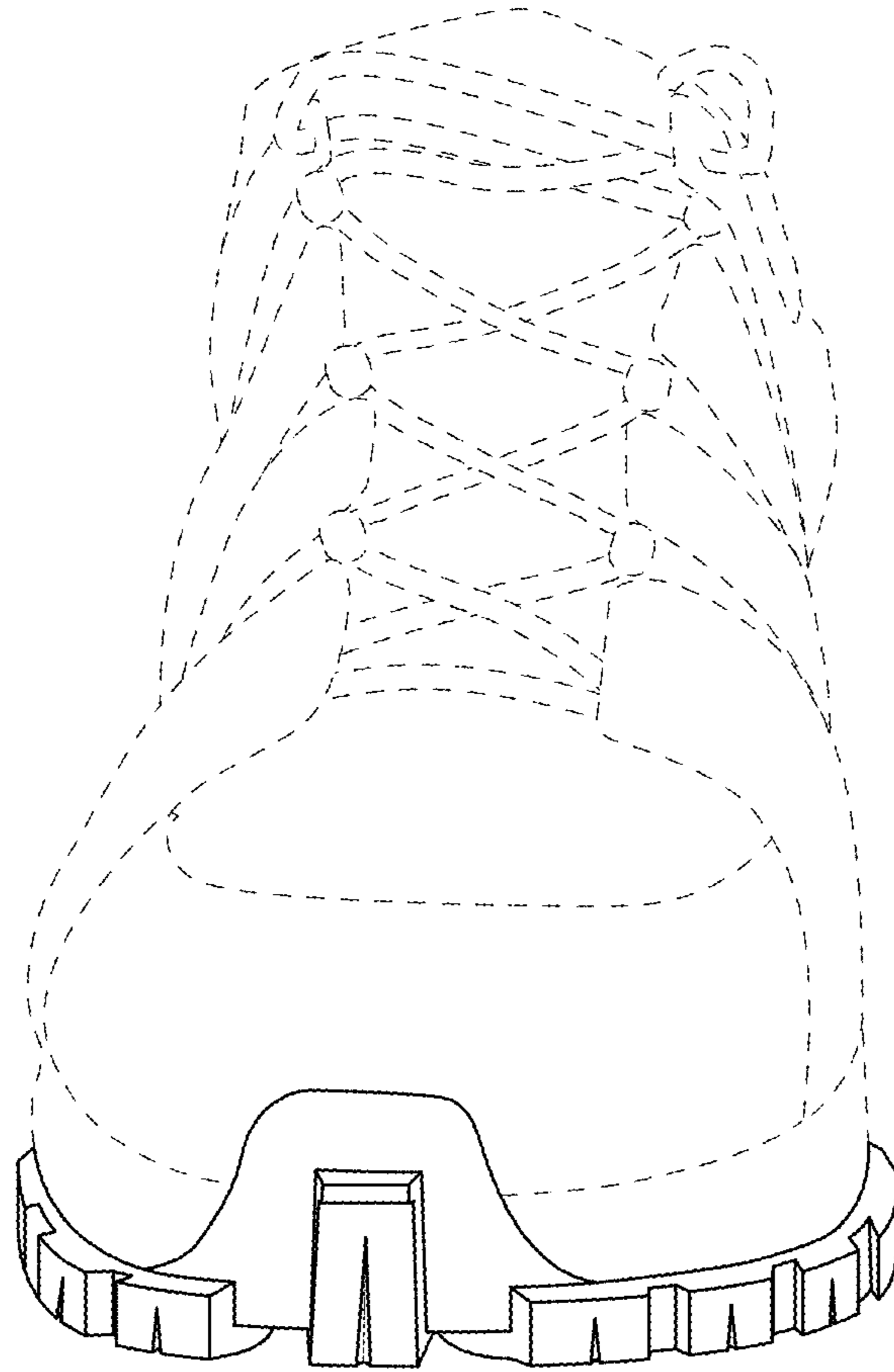

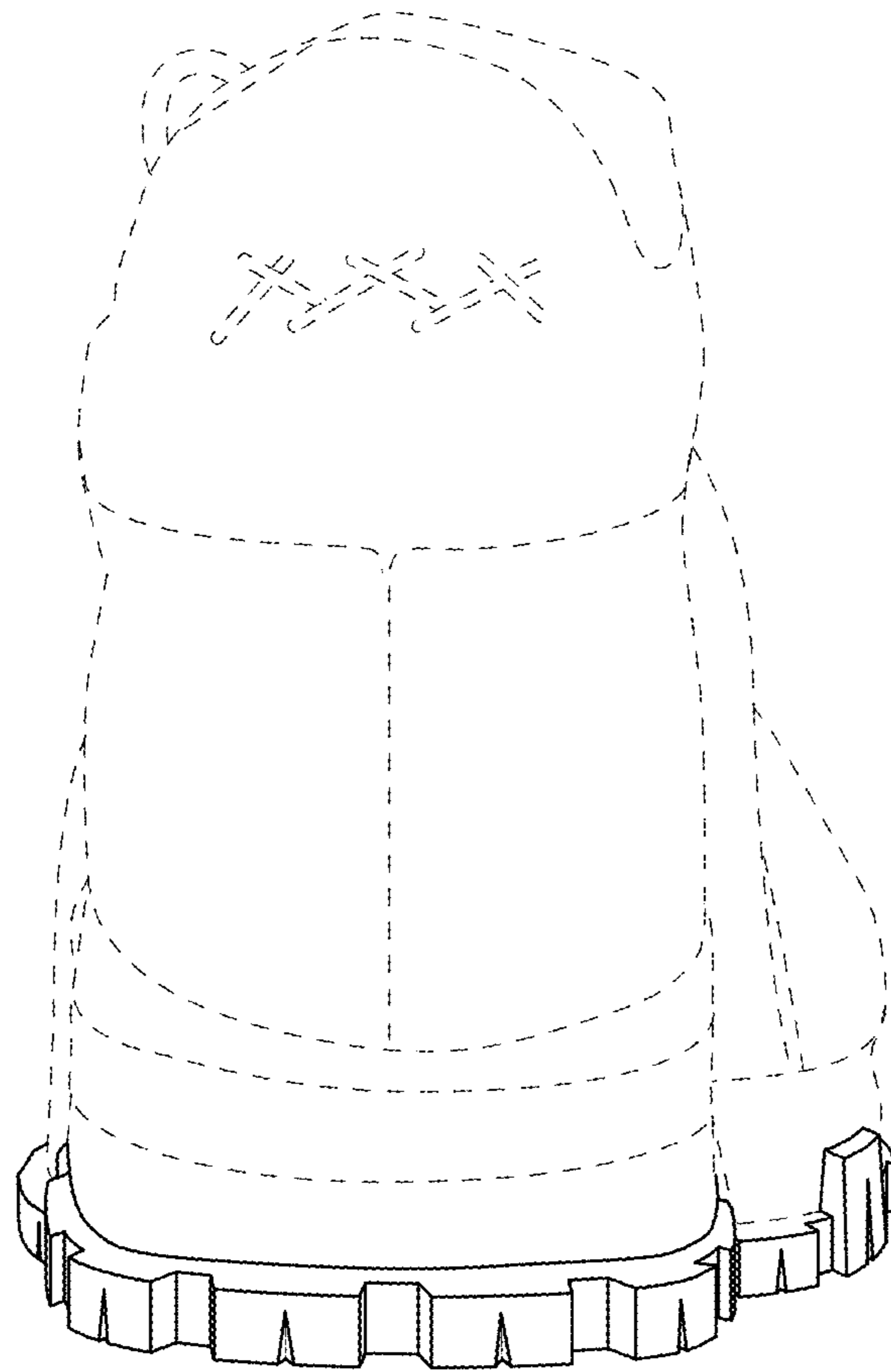

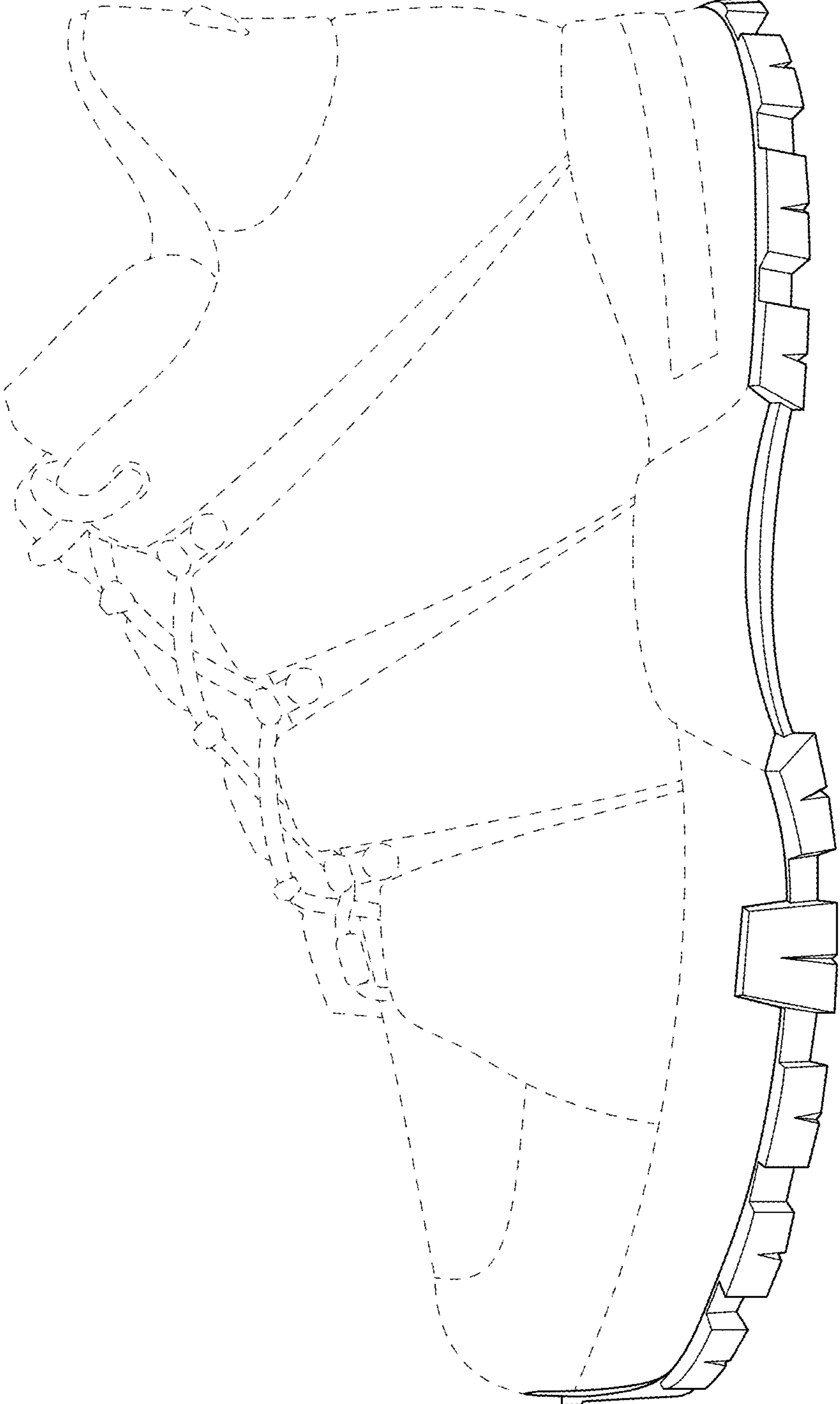

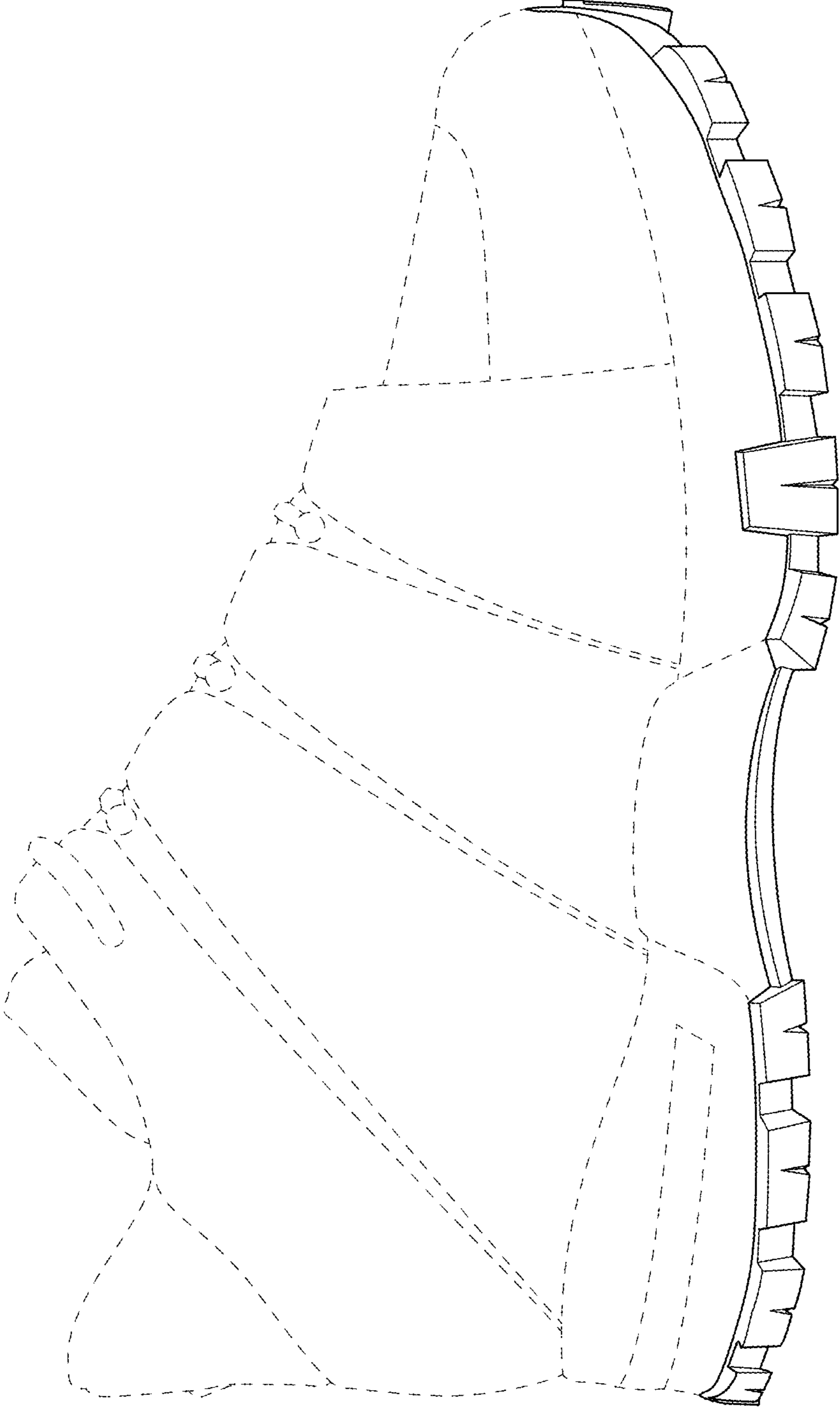

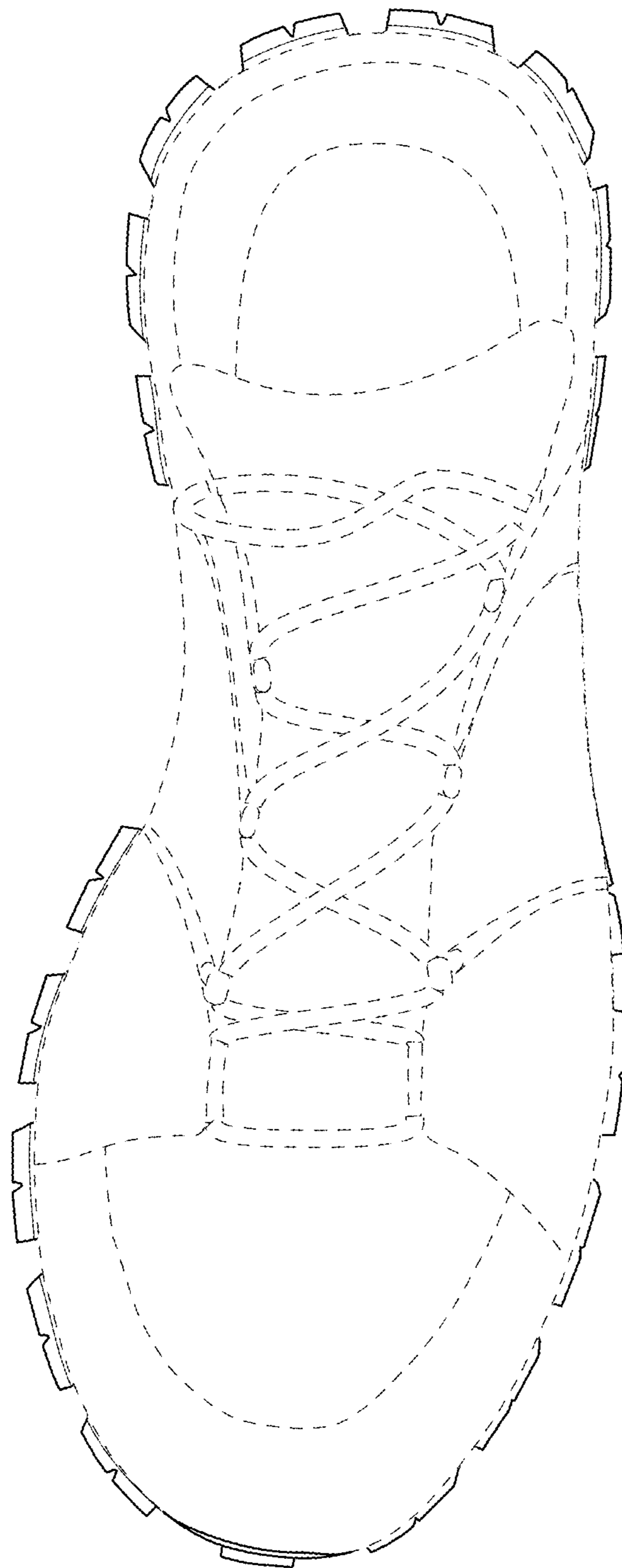

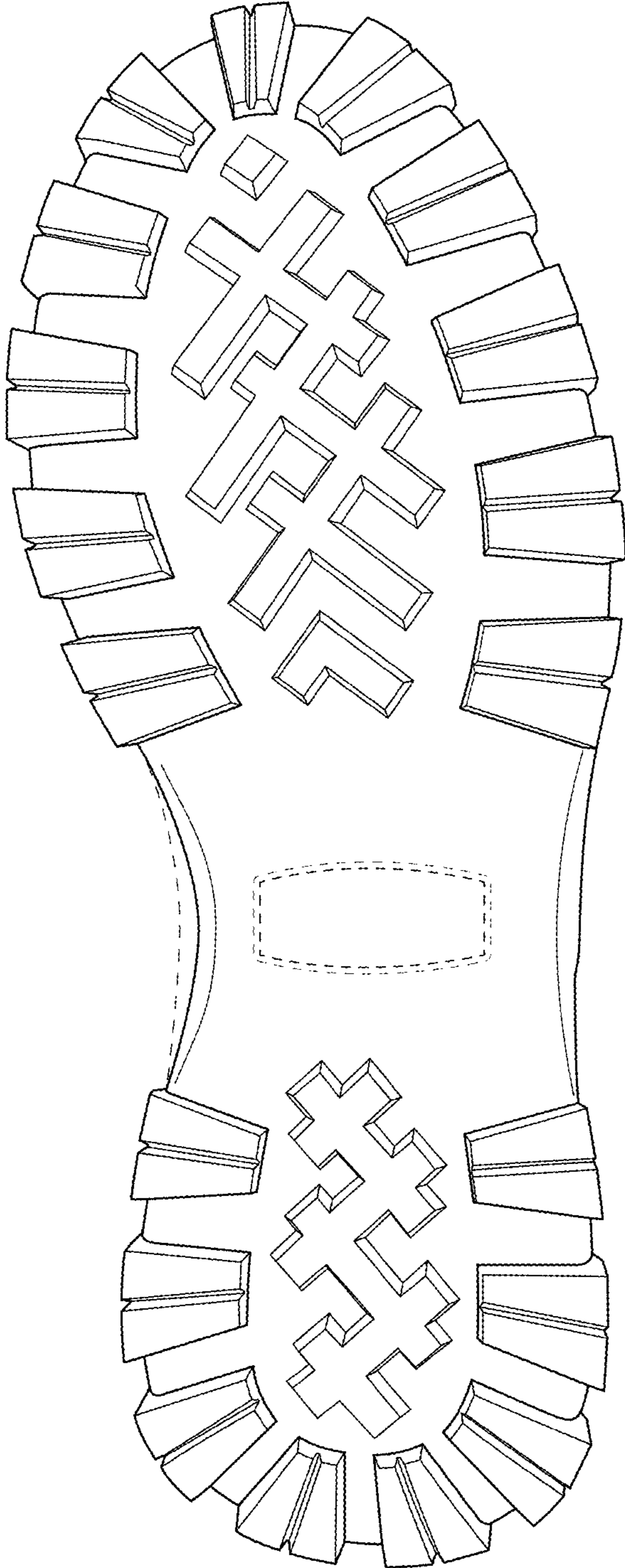
