(57) **CLAIM**

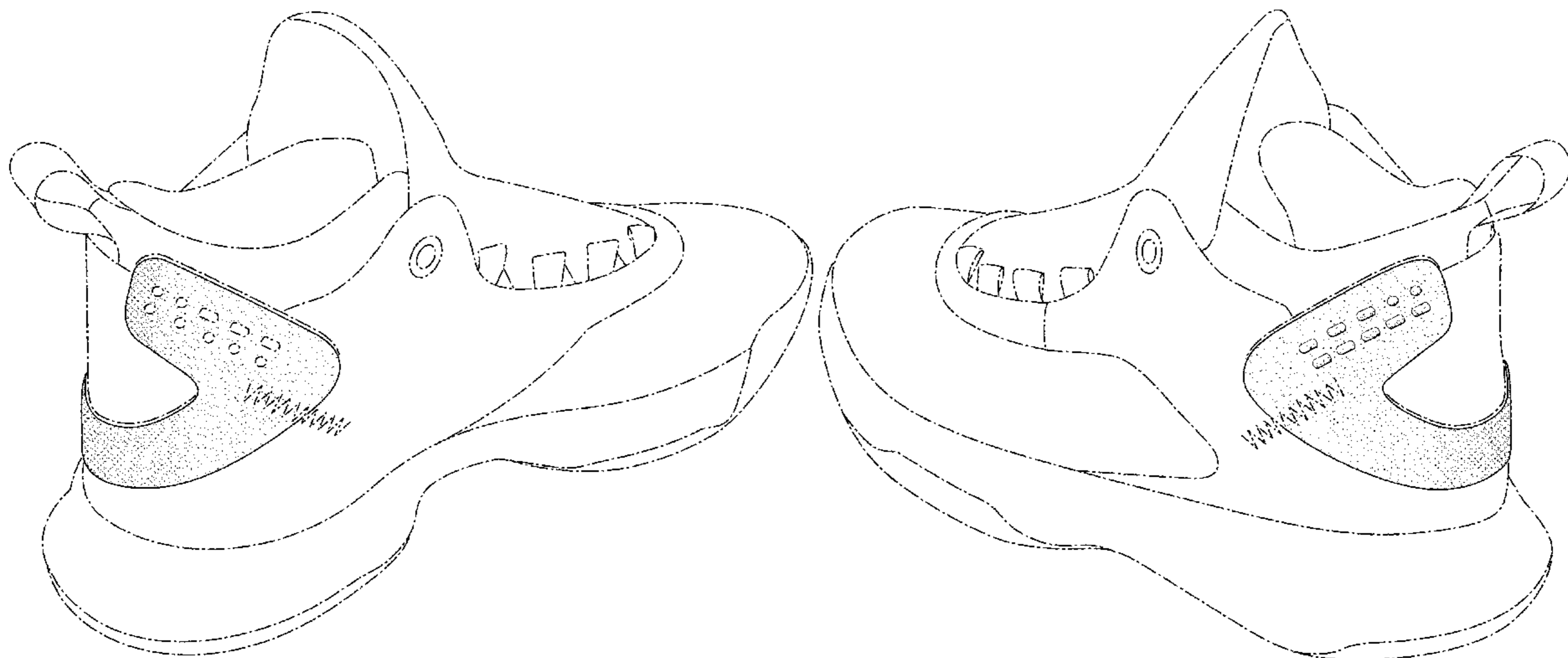
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a shoe showing my new design;
 FIG. 2 is a side view thereof;
 FIG. 3 is an opposite side rear perspective view thereof;
 FIG. 4 is an opposite side view thereof;
 FIG. 5 is a rear view thereof;
 FIG. 6 is a rear perspective view of the shoe of FIGS. 1-5 with disclaimed regions;
 FIG. 7 is a side view thereof;
 FIG. 8 is an opposite side rear perspective view thereof;
 FIG. 9 is an opposite side view thereof; and,
 FIG. 10 is a rear view thereof.

The zig-zag broken lines within the shaded area represent stitching which forms no part of the claimed design. The unshaded broken line regions within the shaded area in FIGS. 6-10 form no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

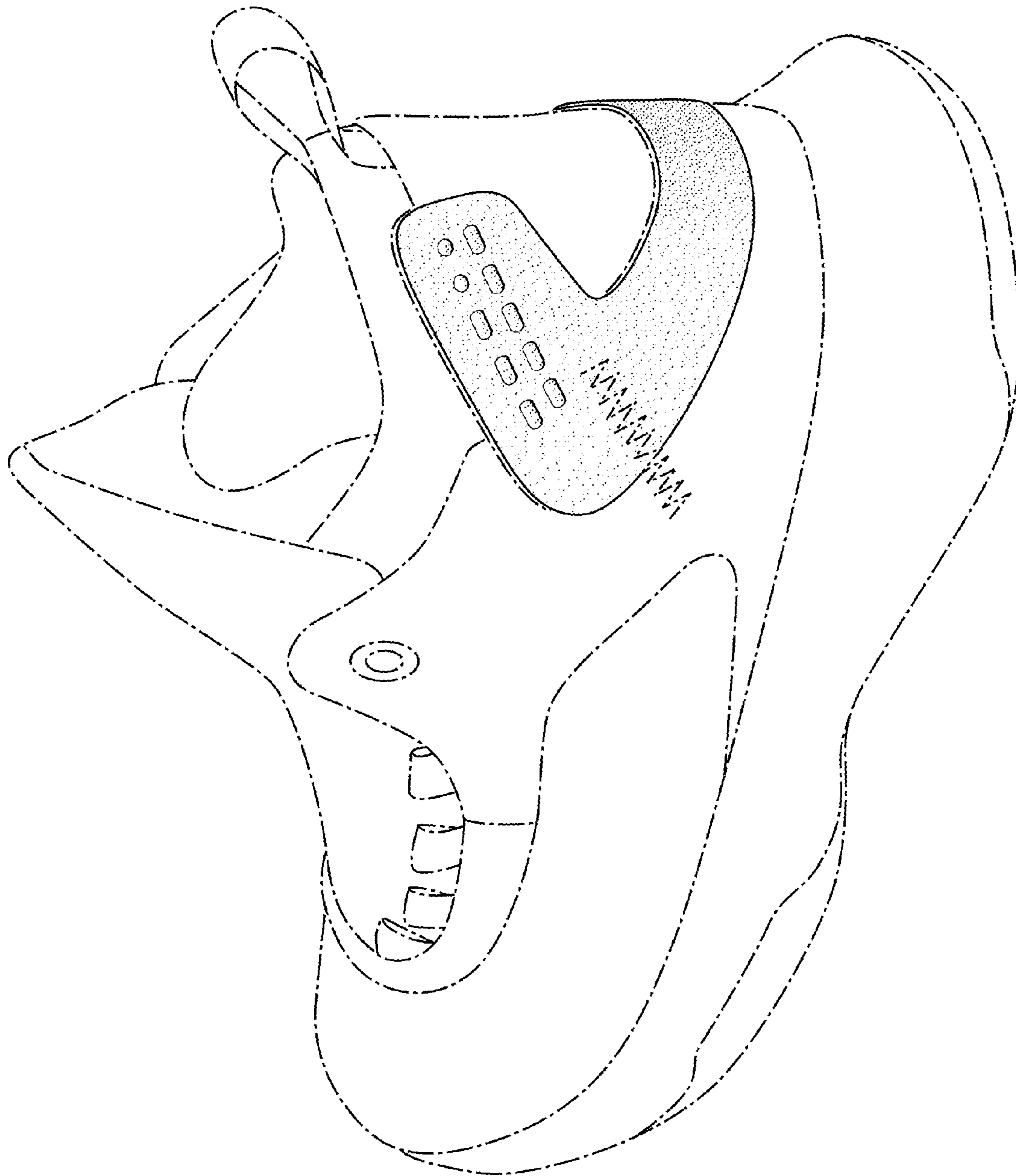

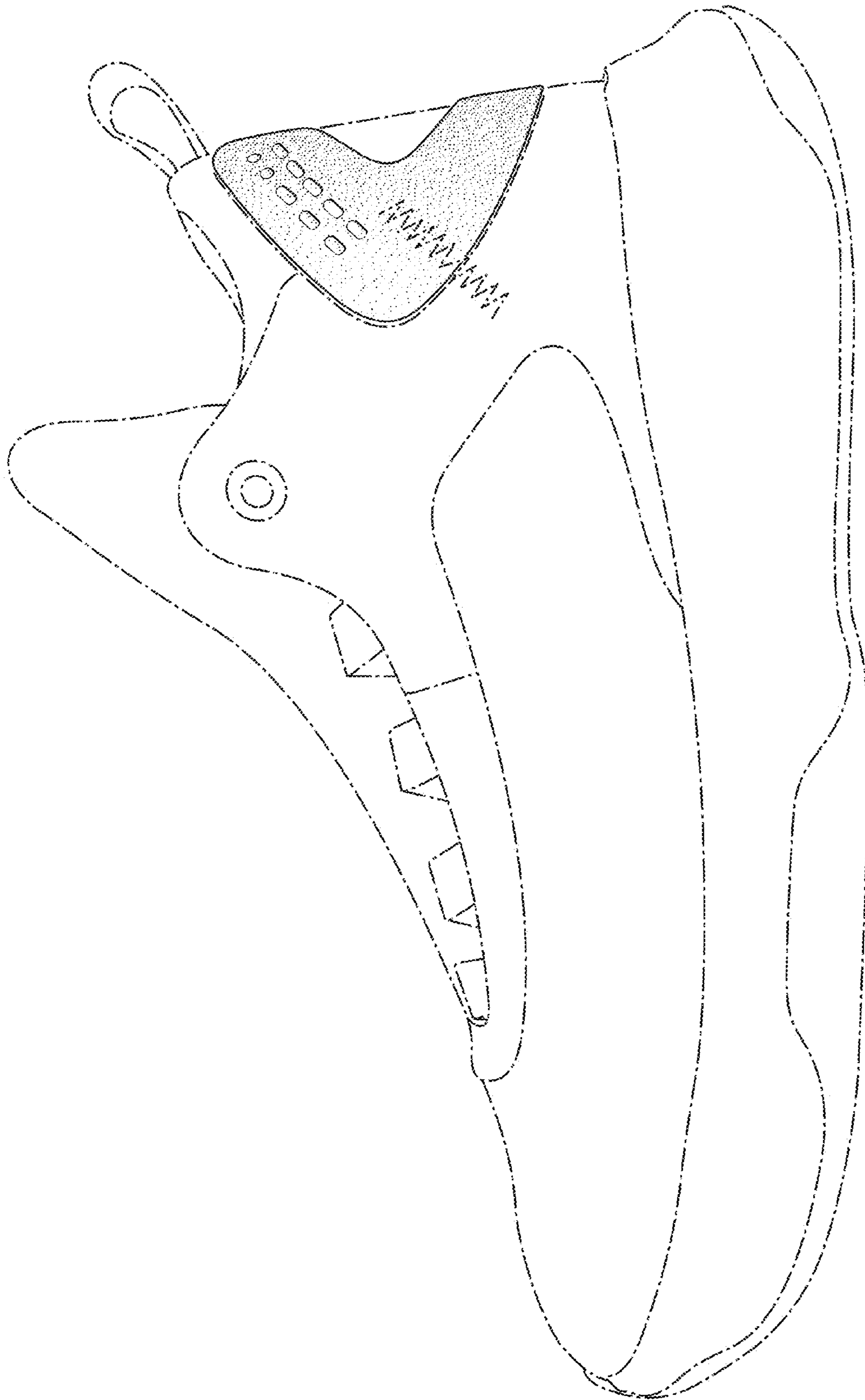

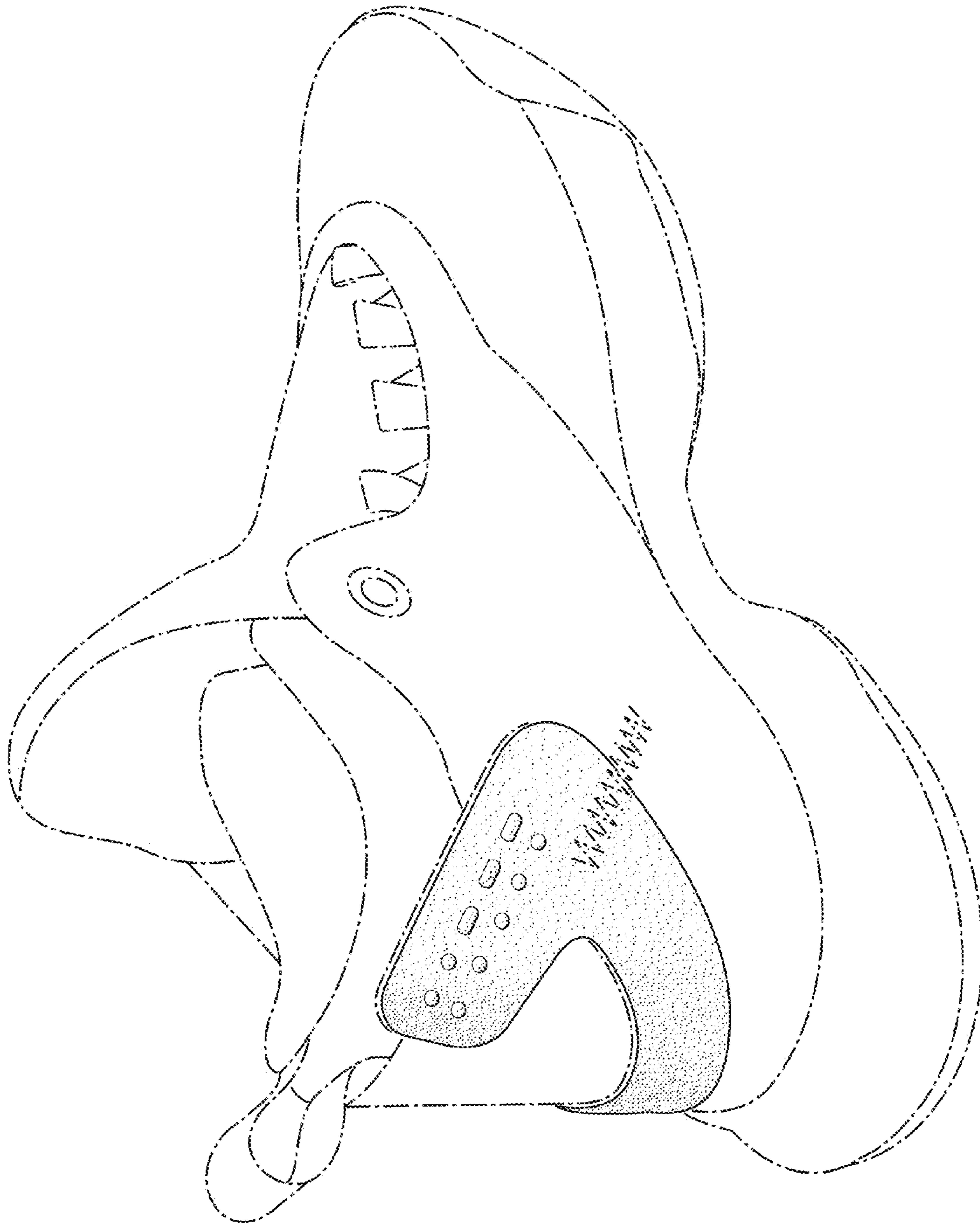

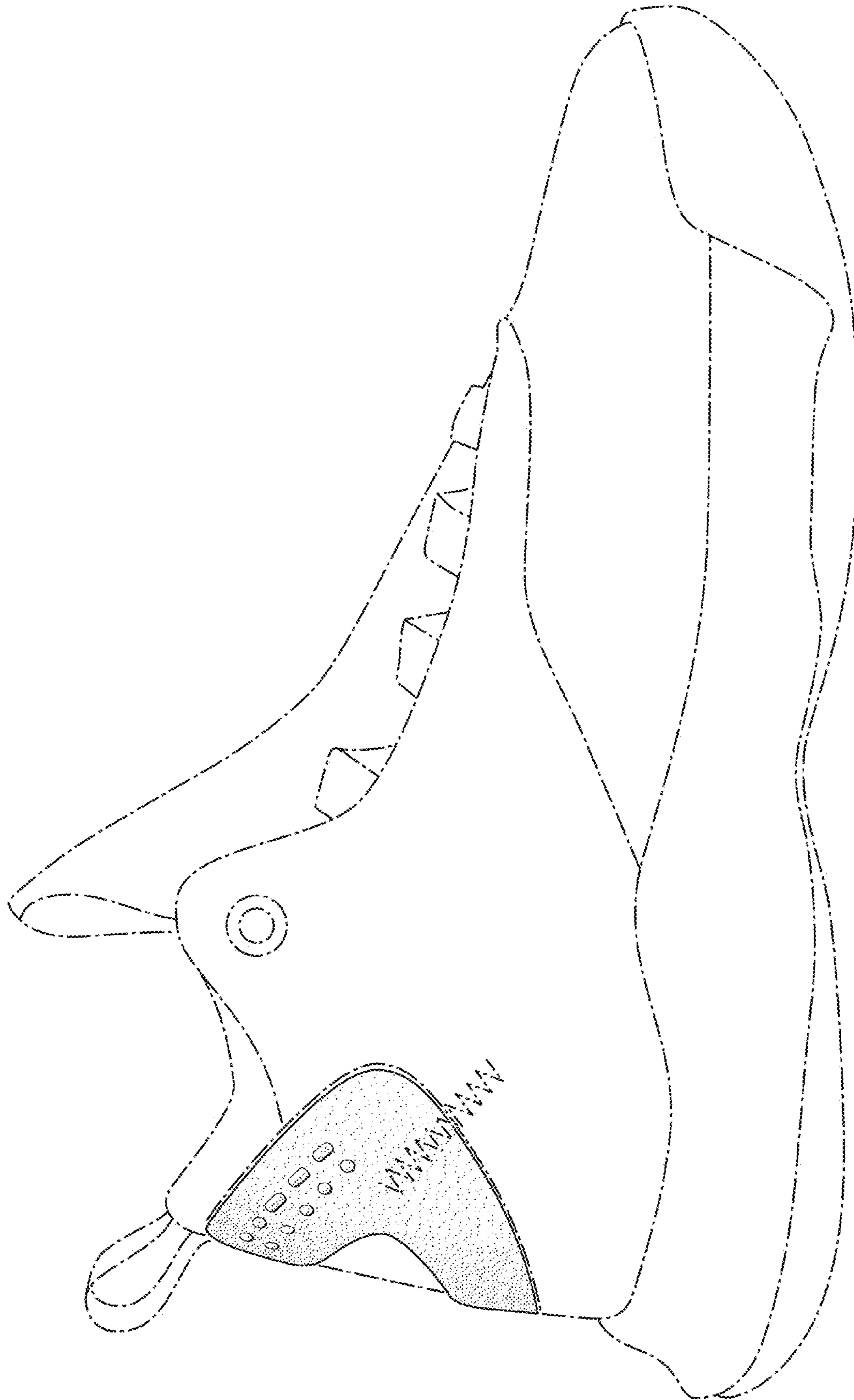

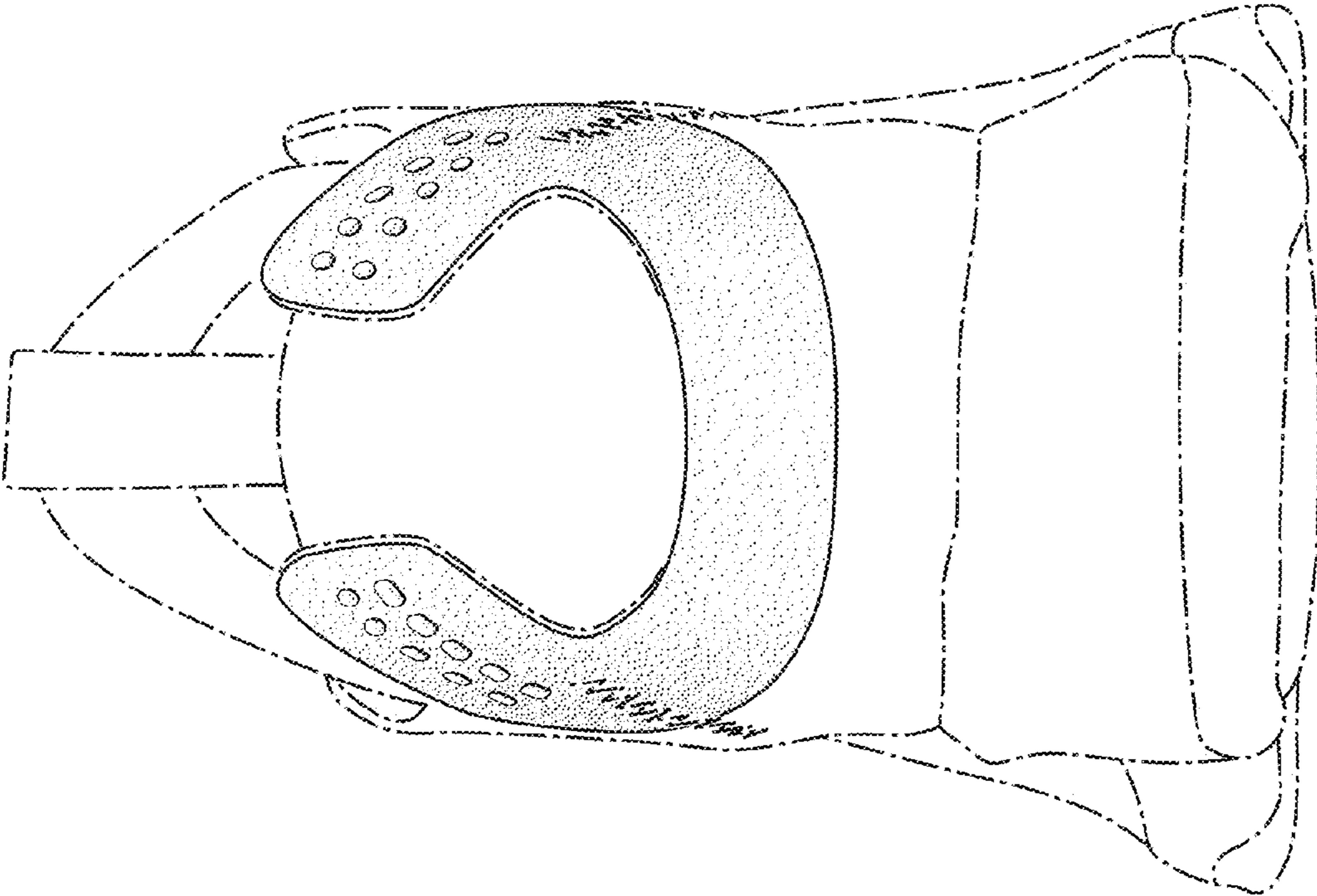

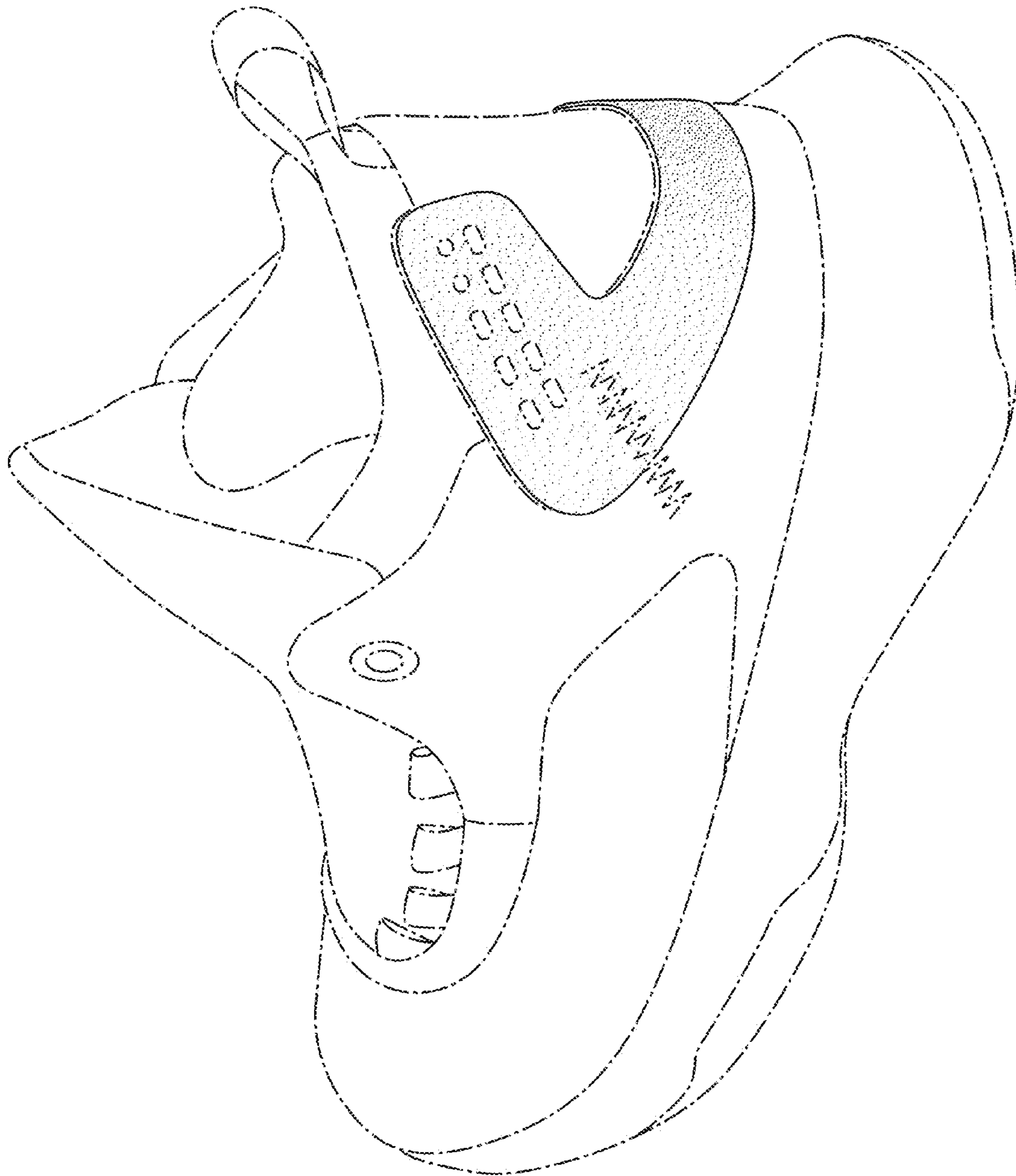

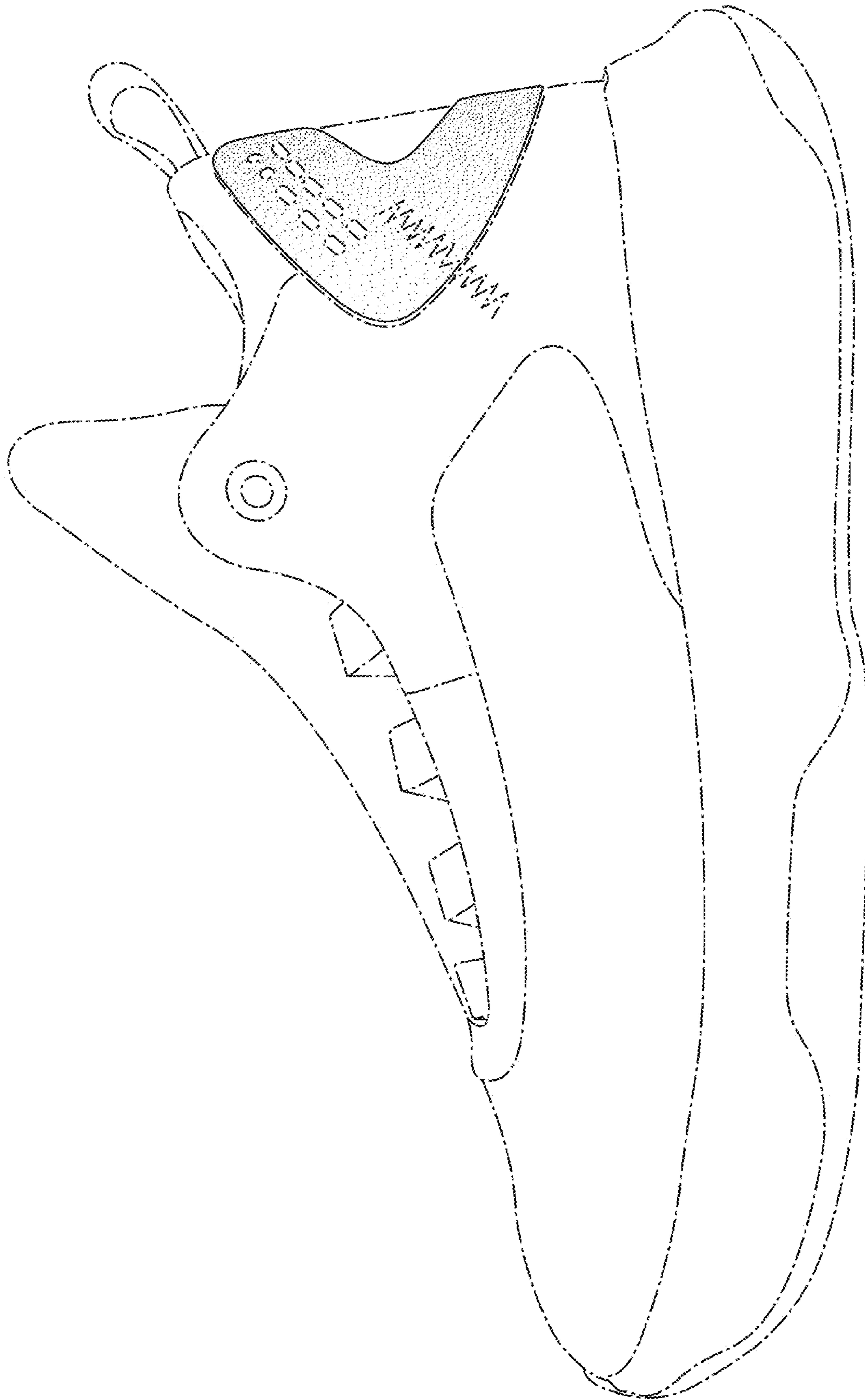

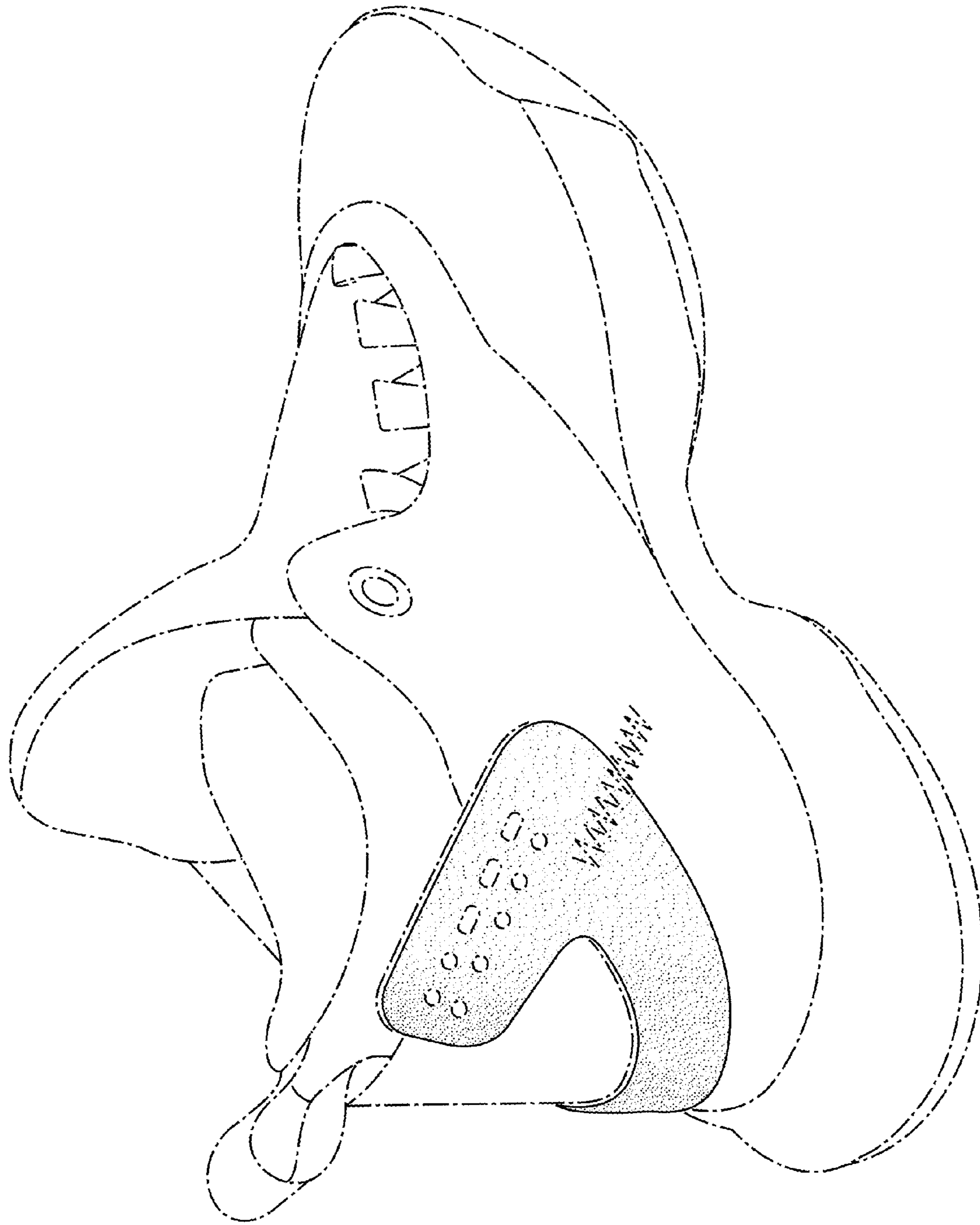

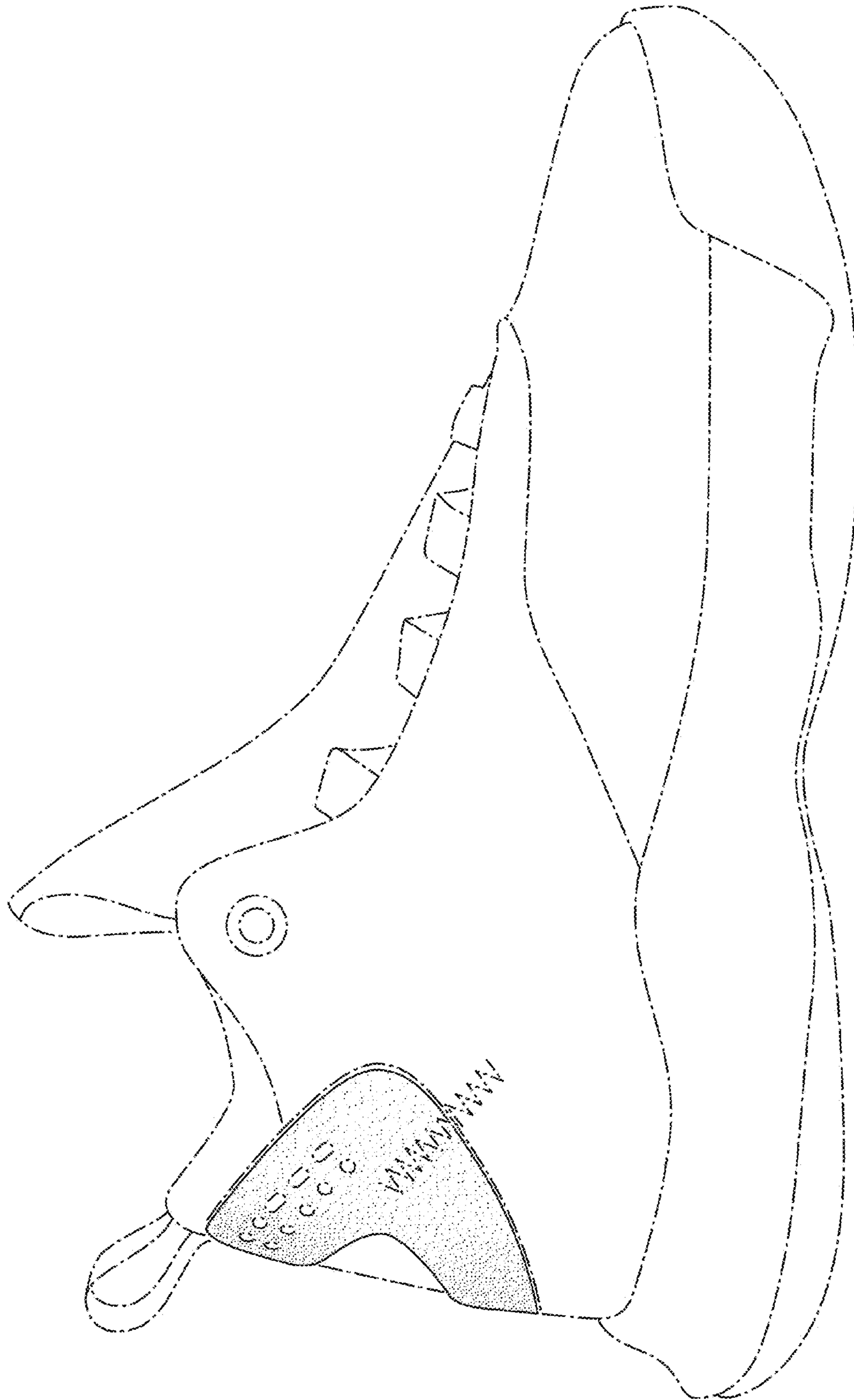

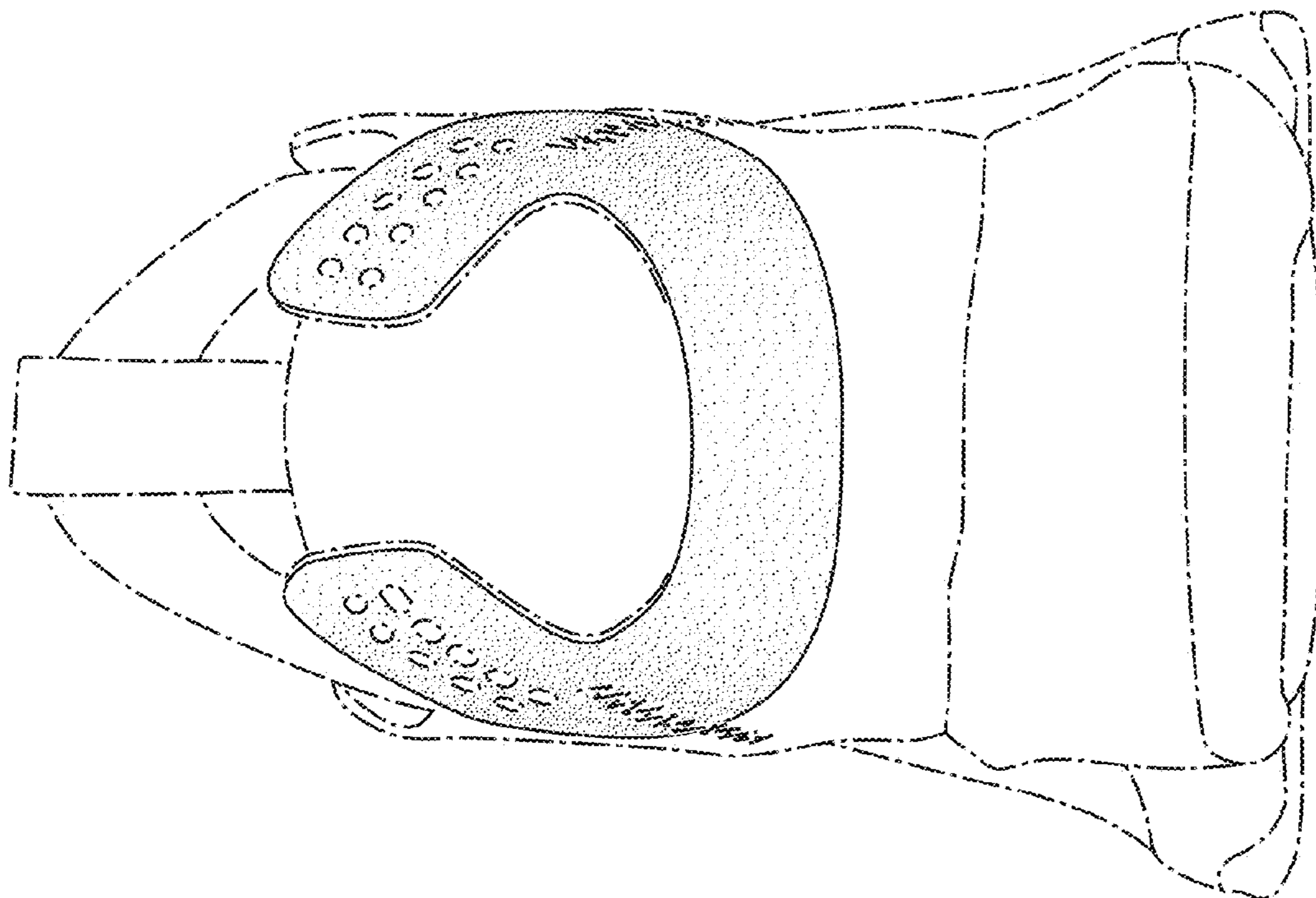
