(57) **CLAIM**

I claim the ornamental design for a pillow with concealed compartments, as shown and described.

DESCRIPTION

FIG. 1 is a top view showing my new design for a pillow with concealed compartments;

FIG. 2 is a bottom view showing the design of FIG. 1;

FIG. 3 is a front side view showing the design of FIG. 1;

FIG. 4 is a right side view showing the design of FIG. 1;

FIG. 5 is a rear side view showing the design of FIG. 1;

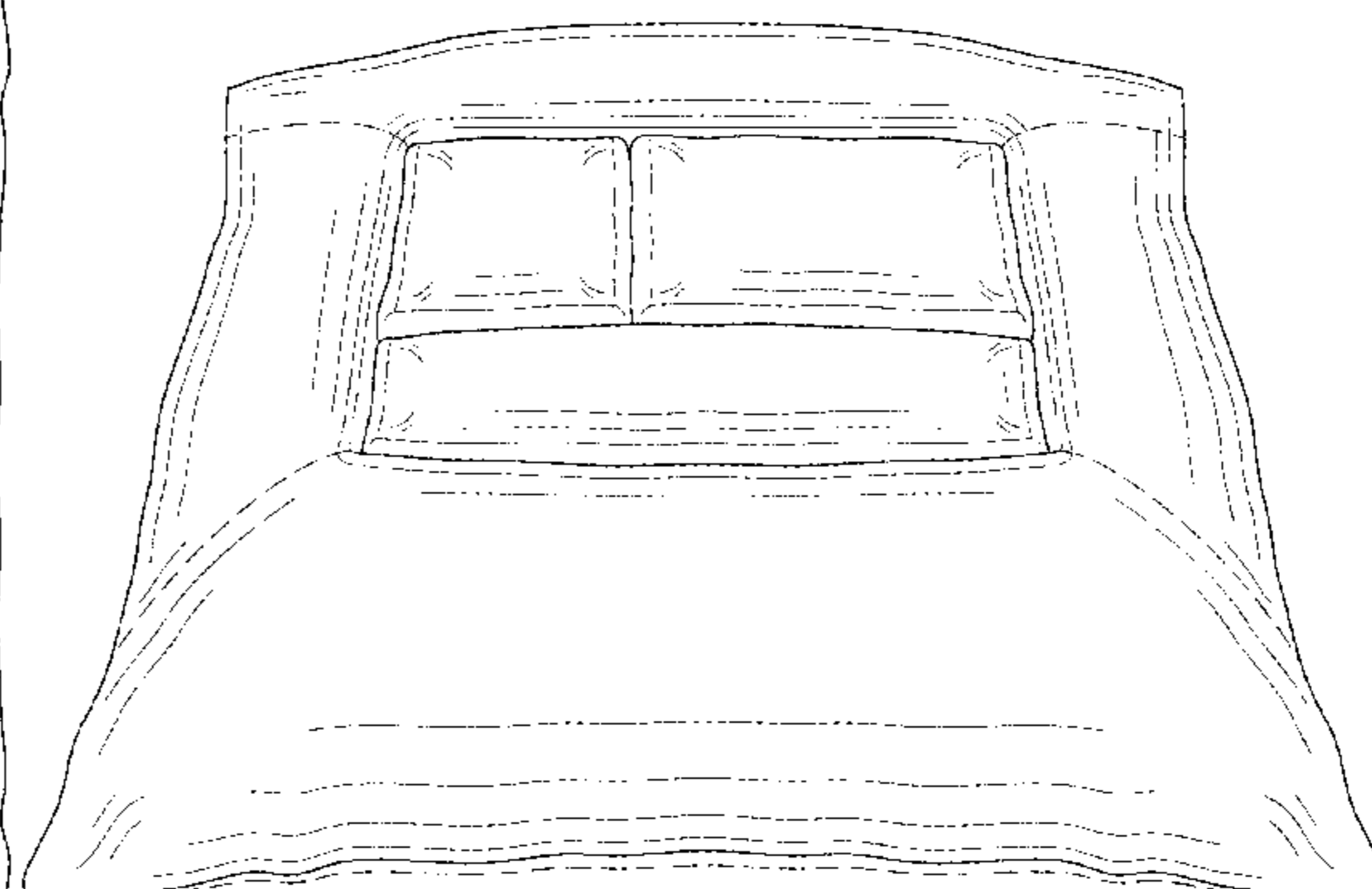
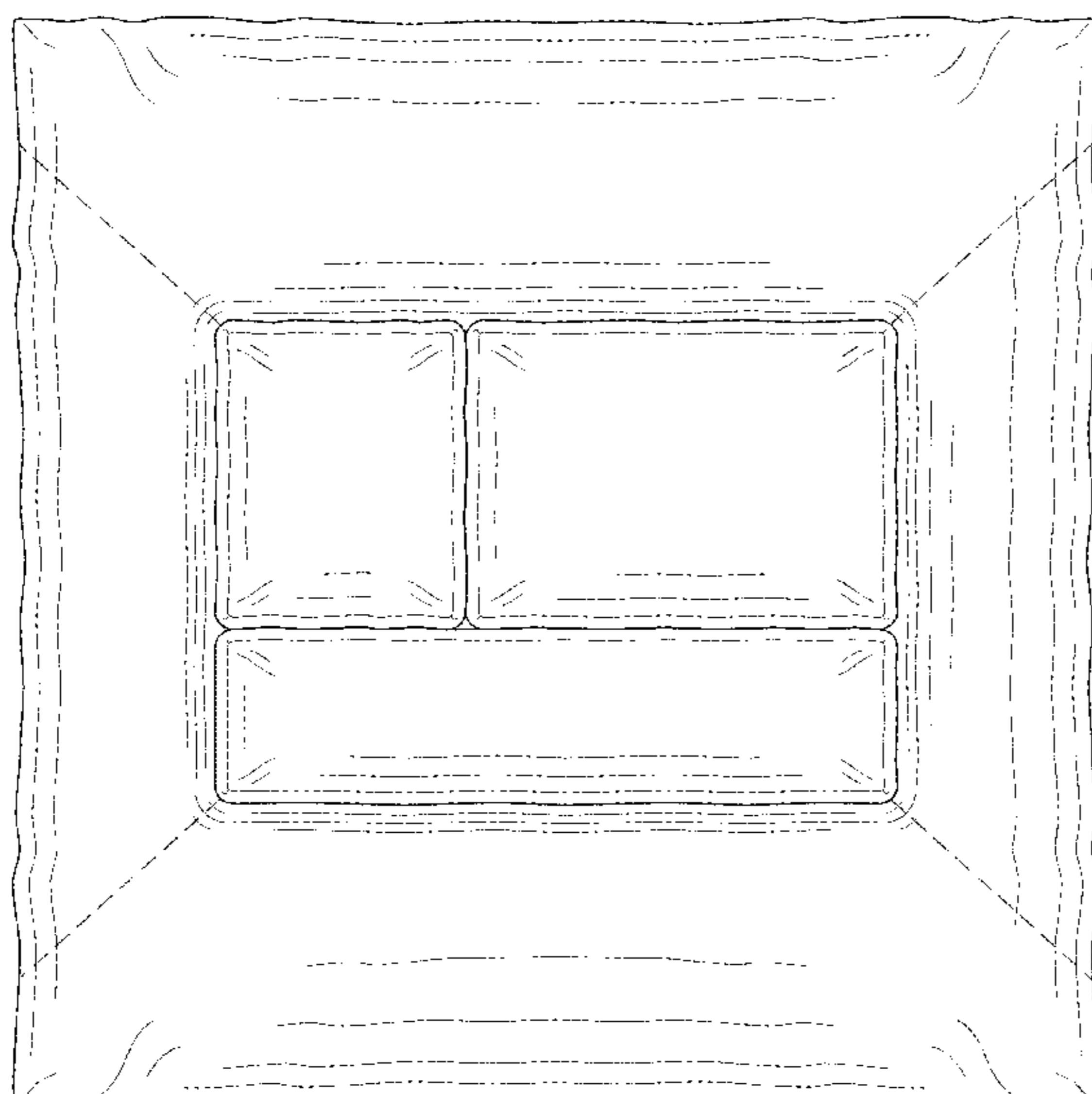
FIG. 6 is a left side view showing the design of FIG. 1;

FIG. 7 is a perspective view showing the design of FIG. 1; and,

FIG. 8 is a second perspective view showing the design of FIG. 1.

In FIGS. 2-8, the broken lines depicting the bottom portion of the pillow with concealed compartments form no part of the claimed design. In FIGS. 1, 4, and 6-8, the broken lines depicting lines of stitching on the top portion of the pillow form a part of the claimed design.

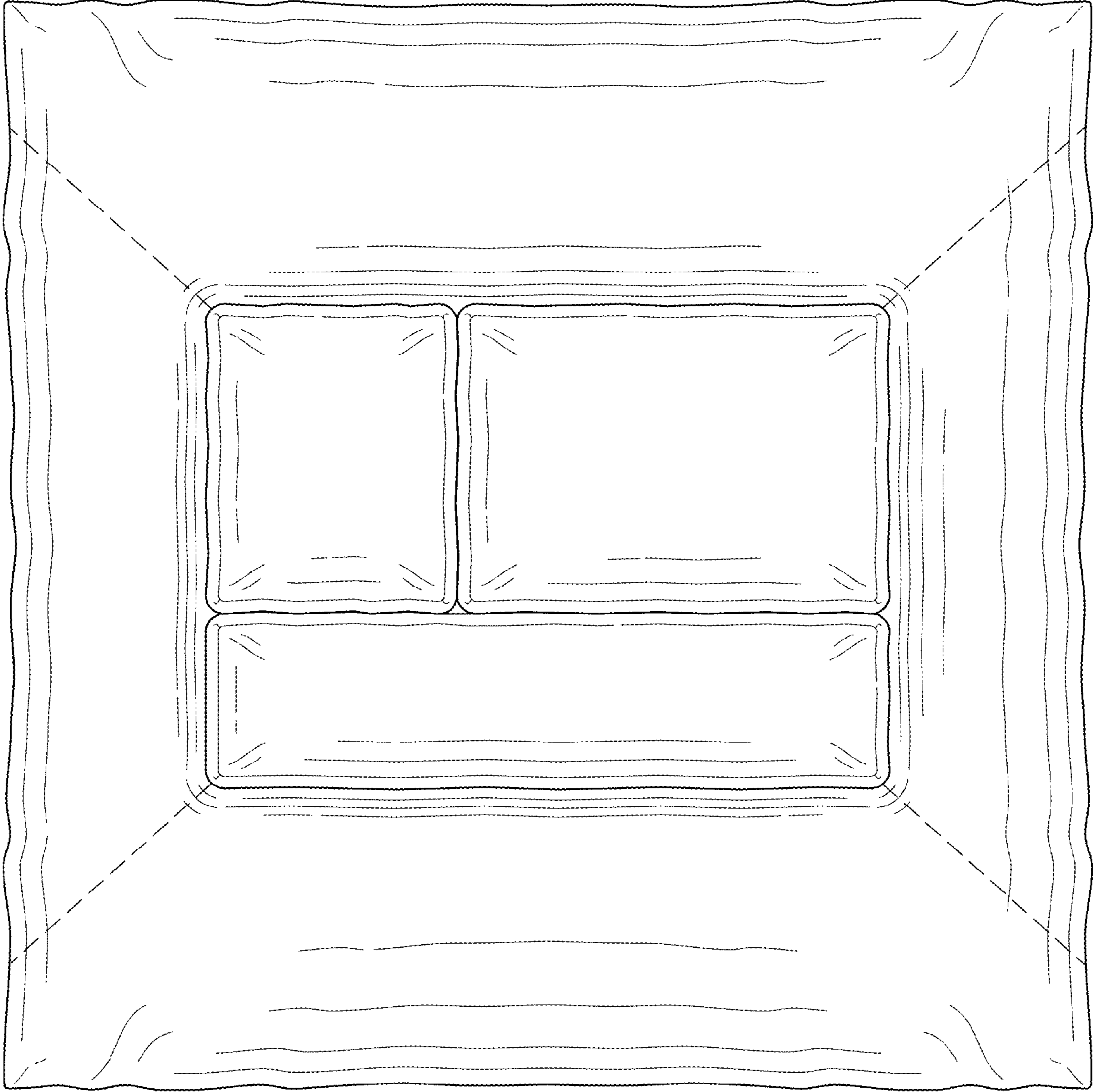

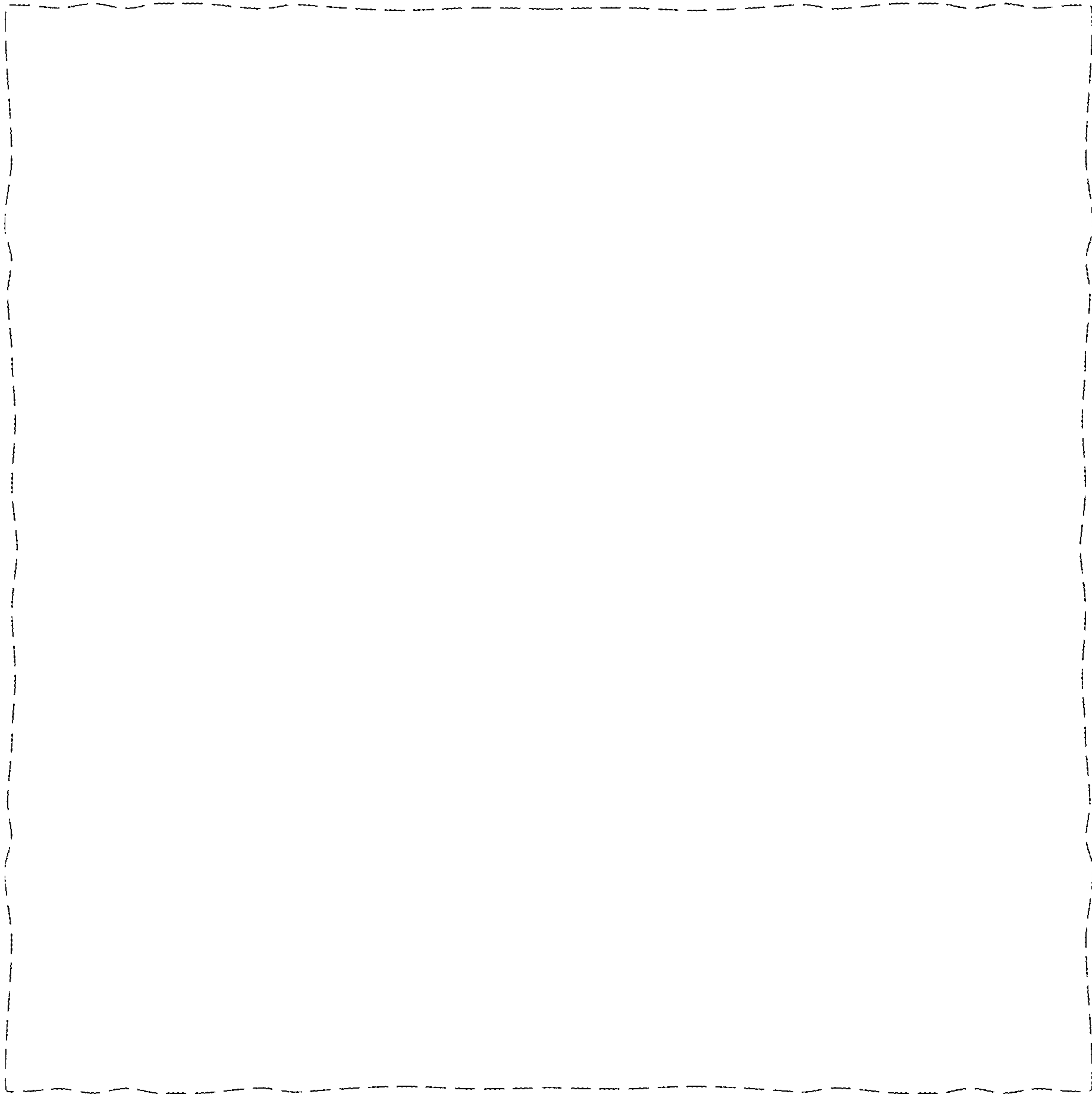

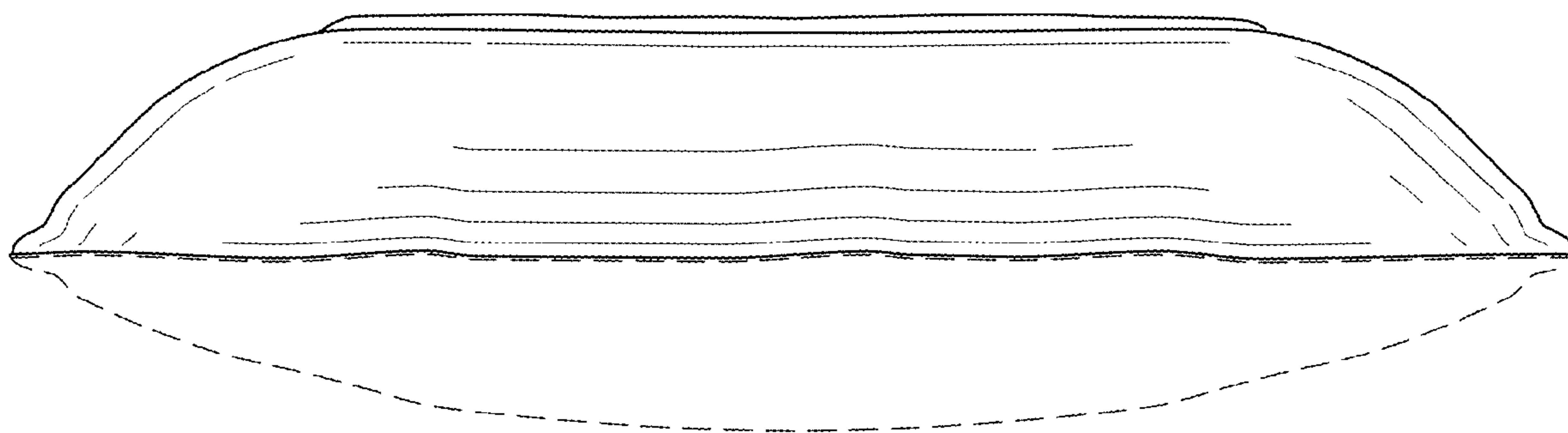

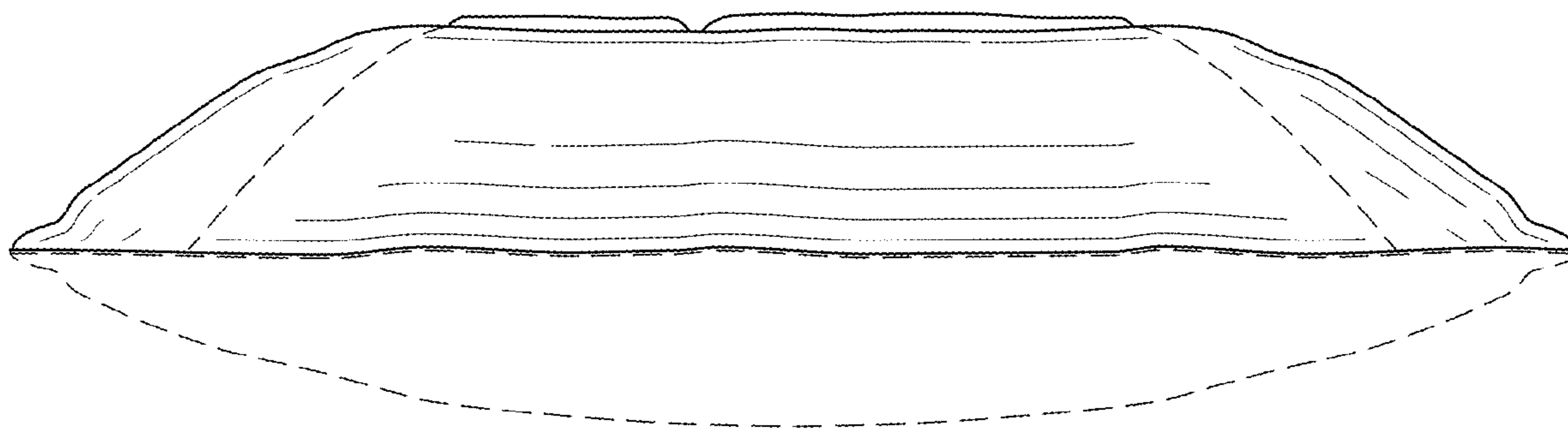

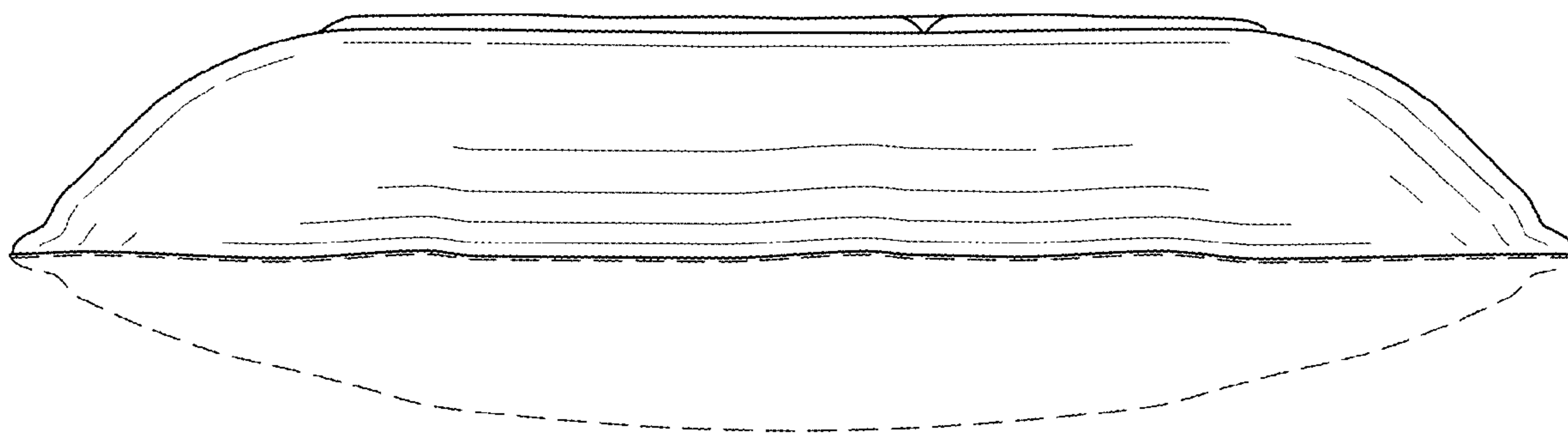

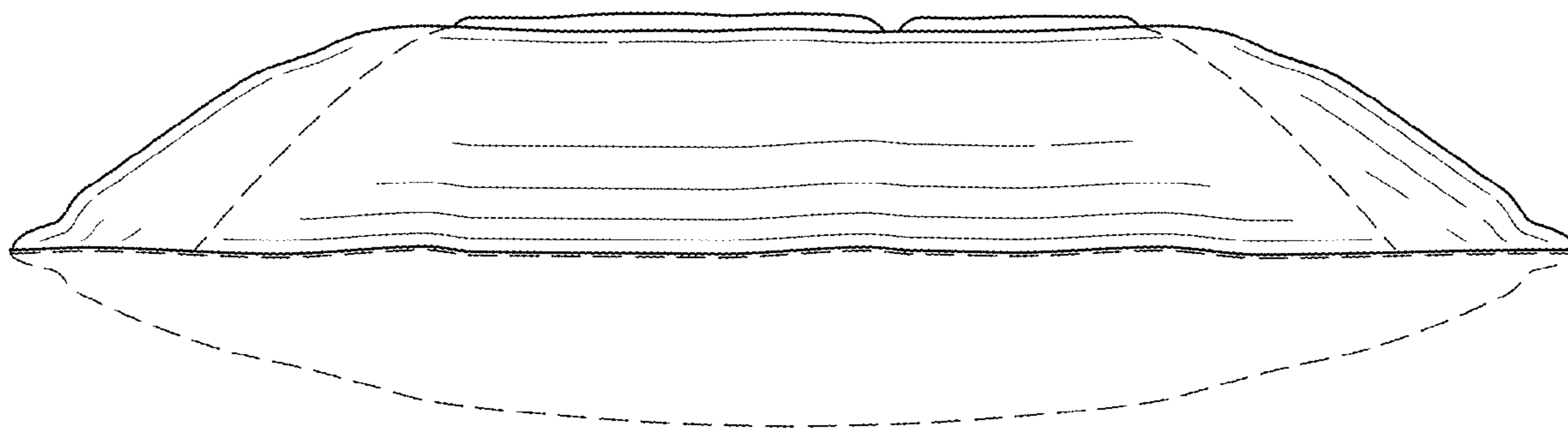

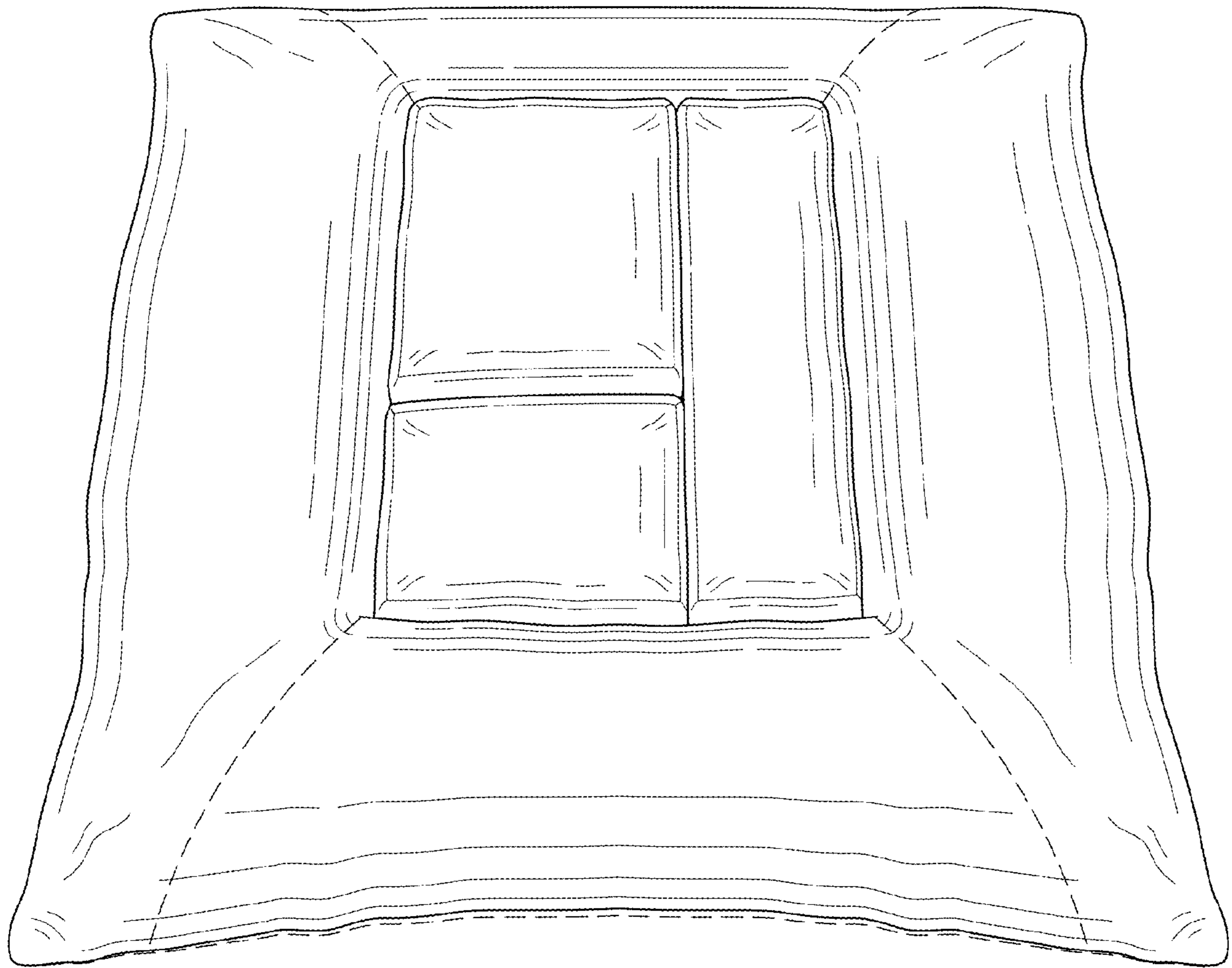

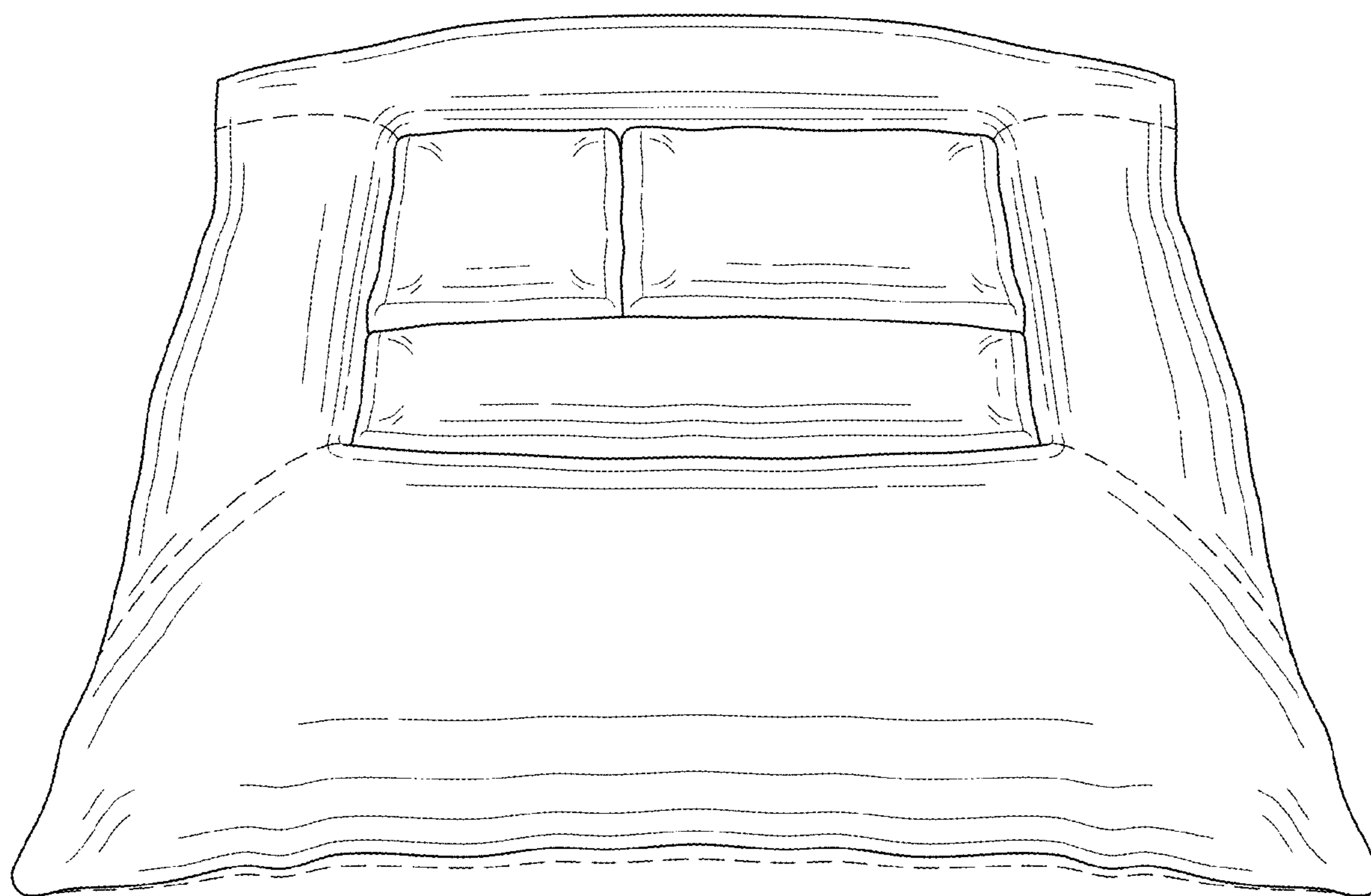
