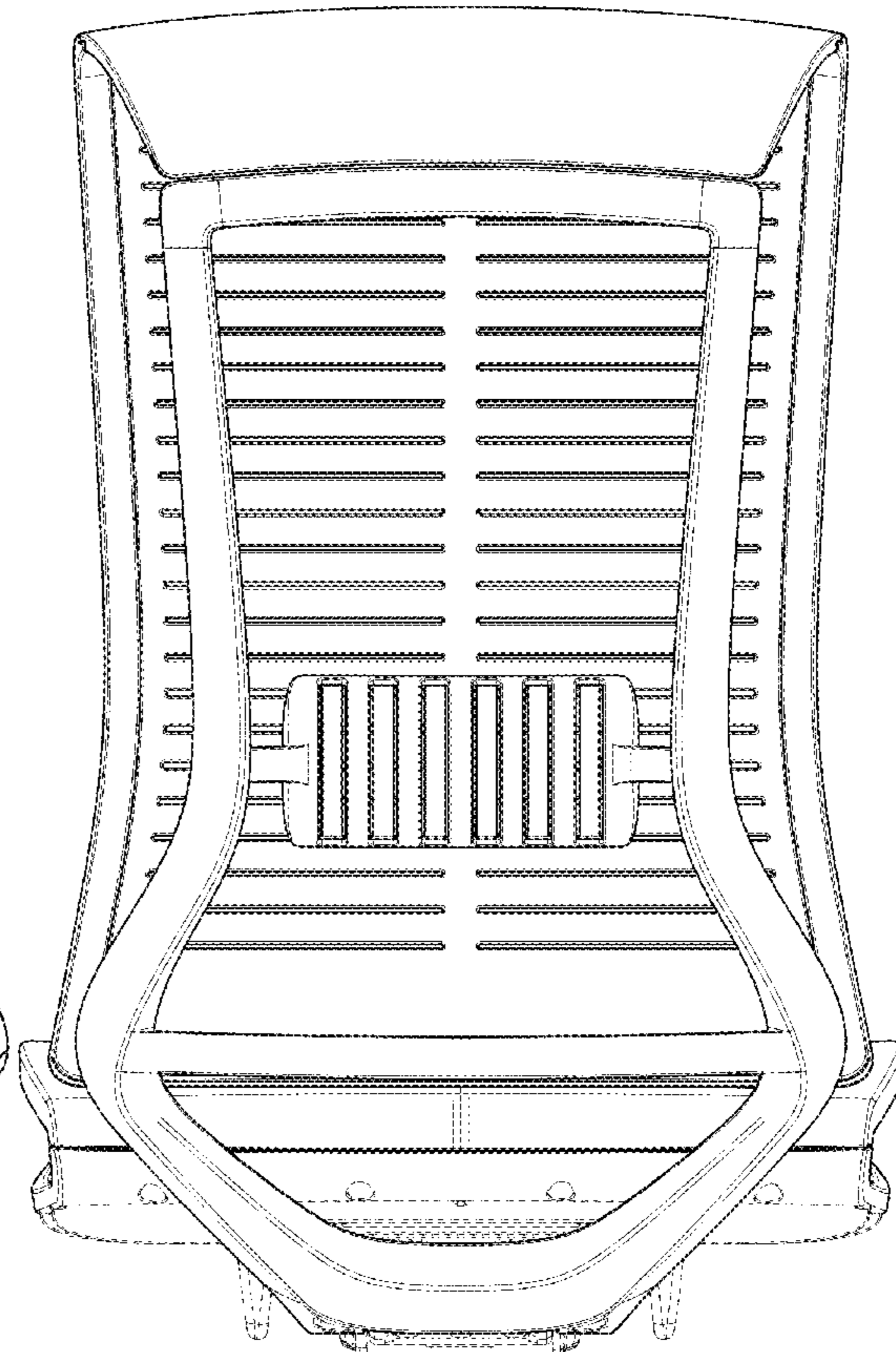
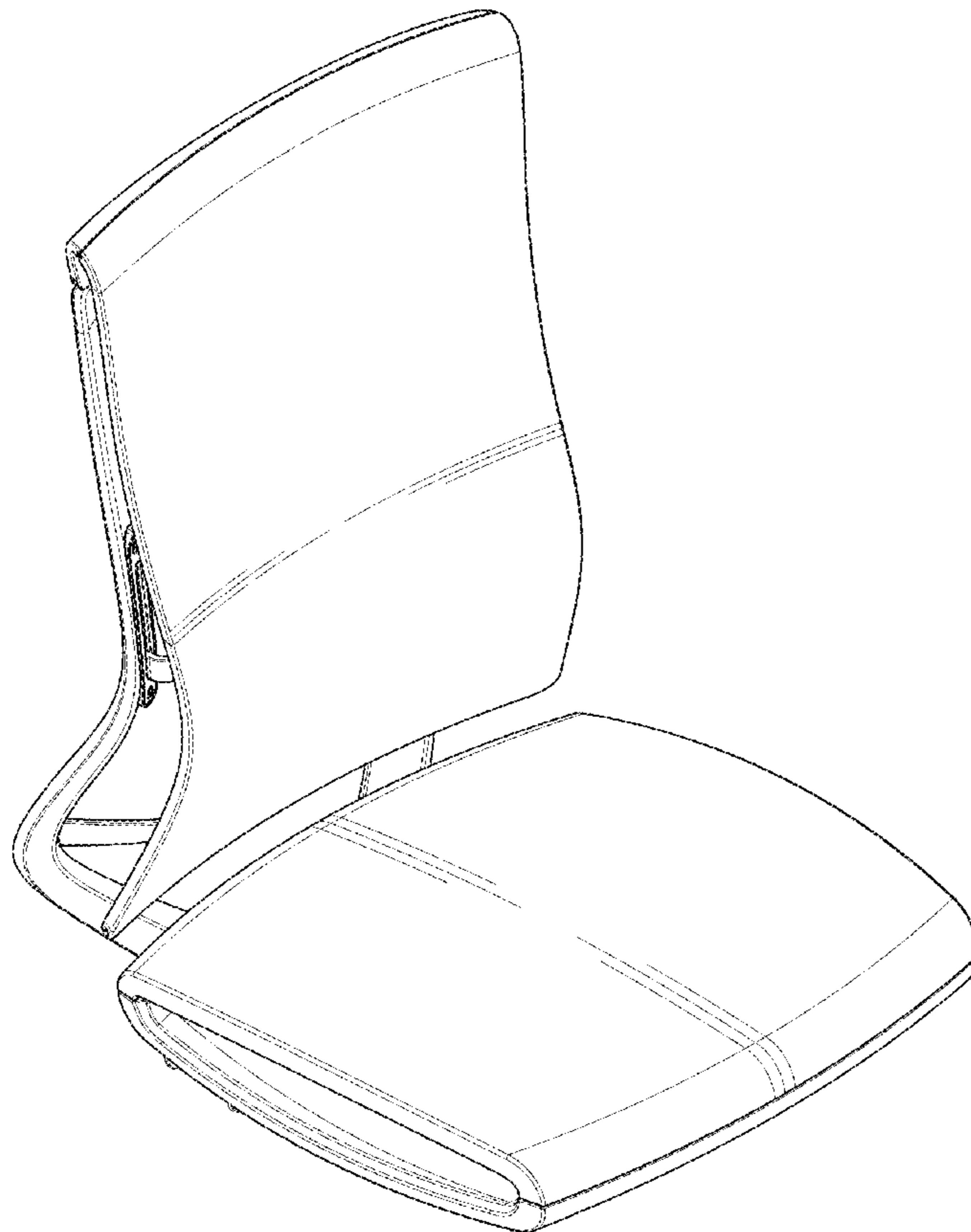

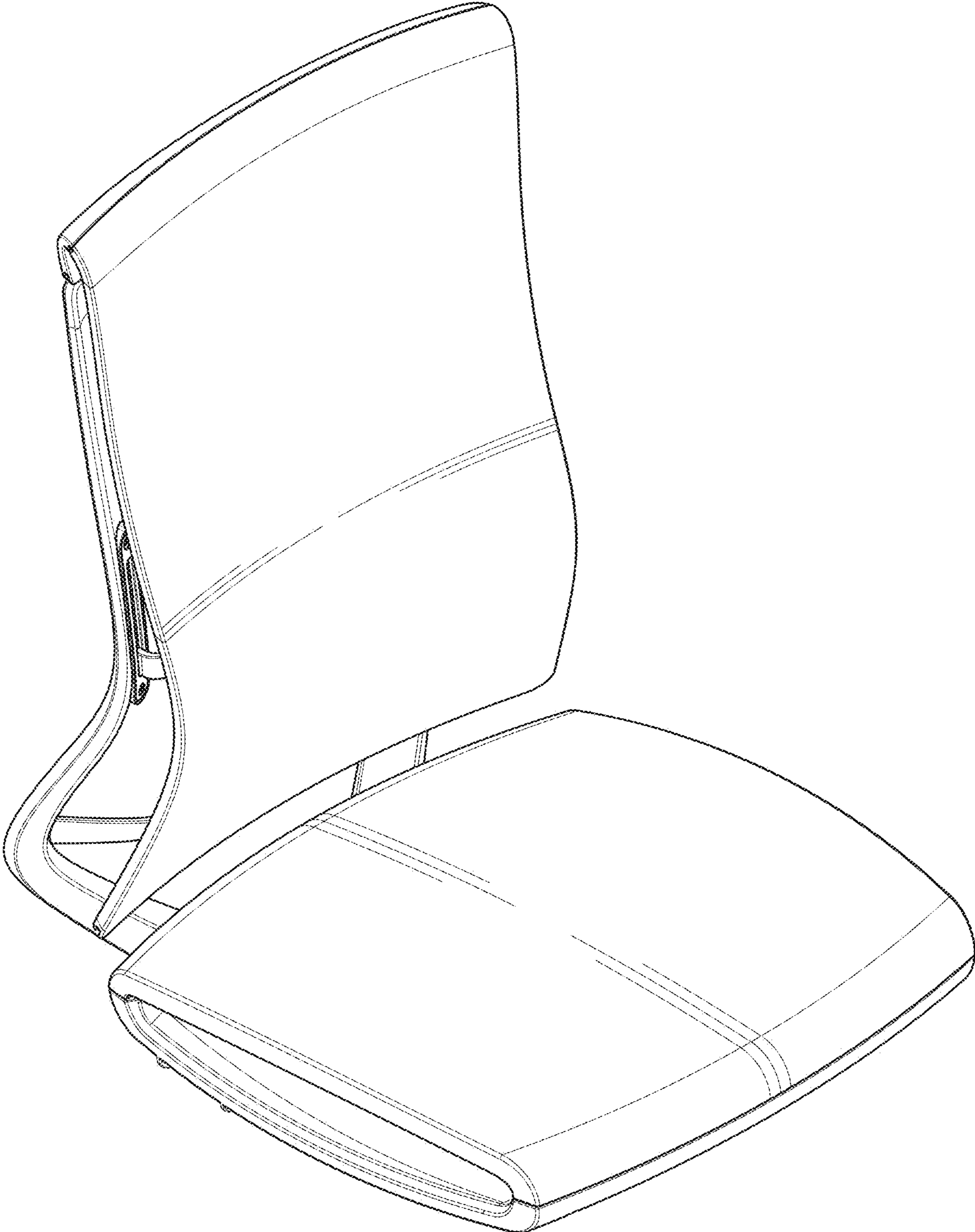
The ornamental design for the backrest and seat for a chair, as shown and described.

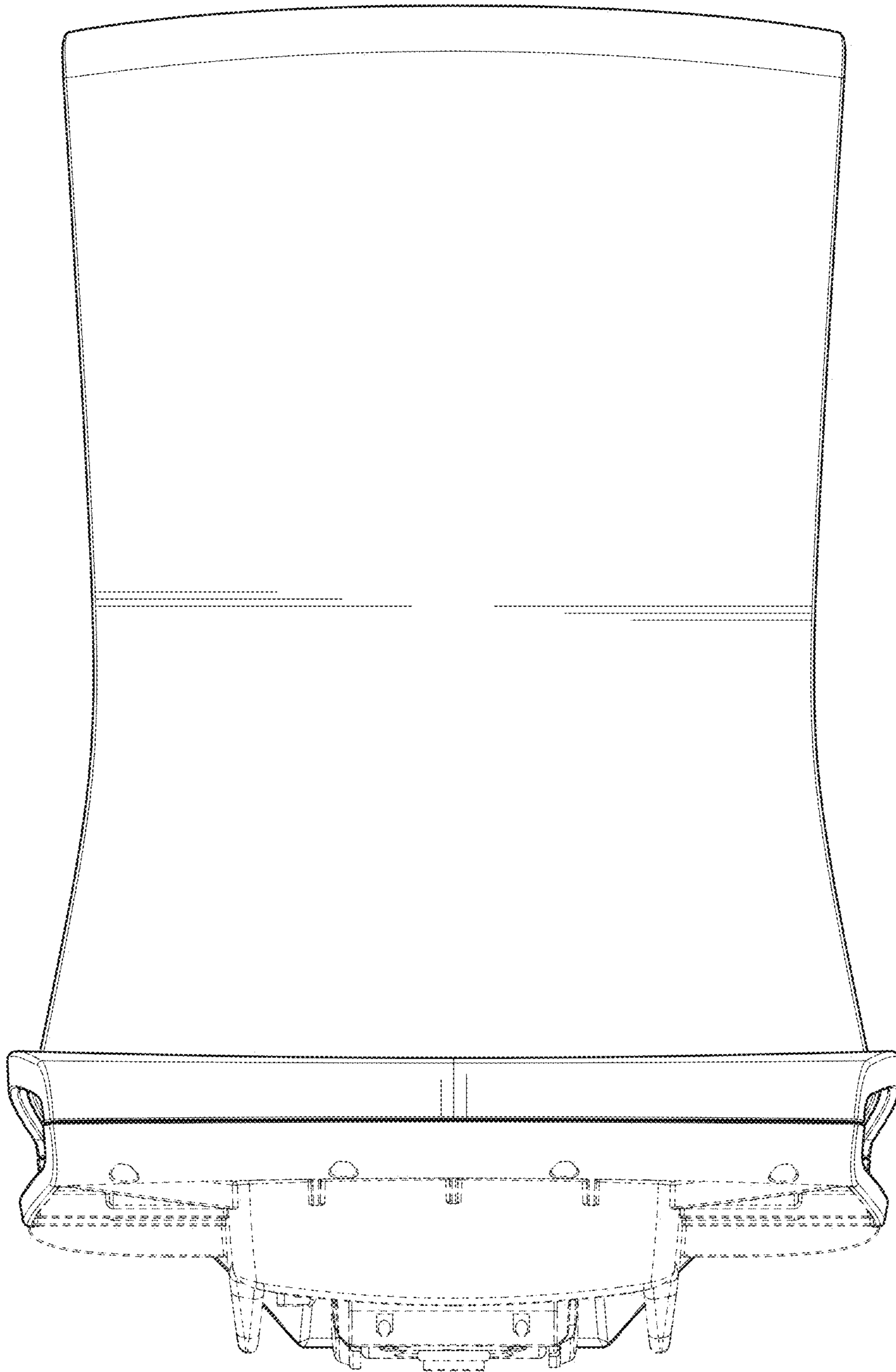

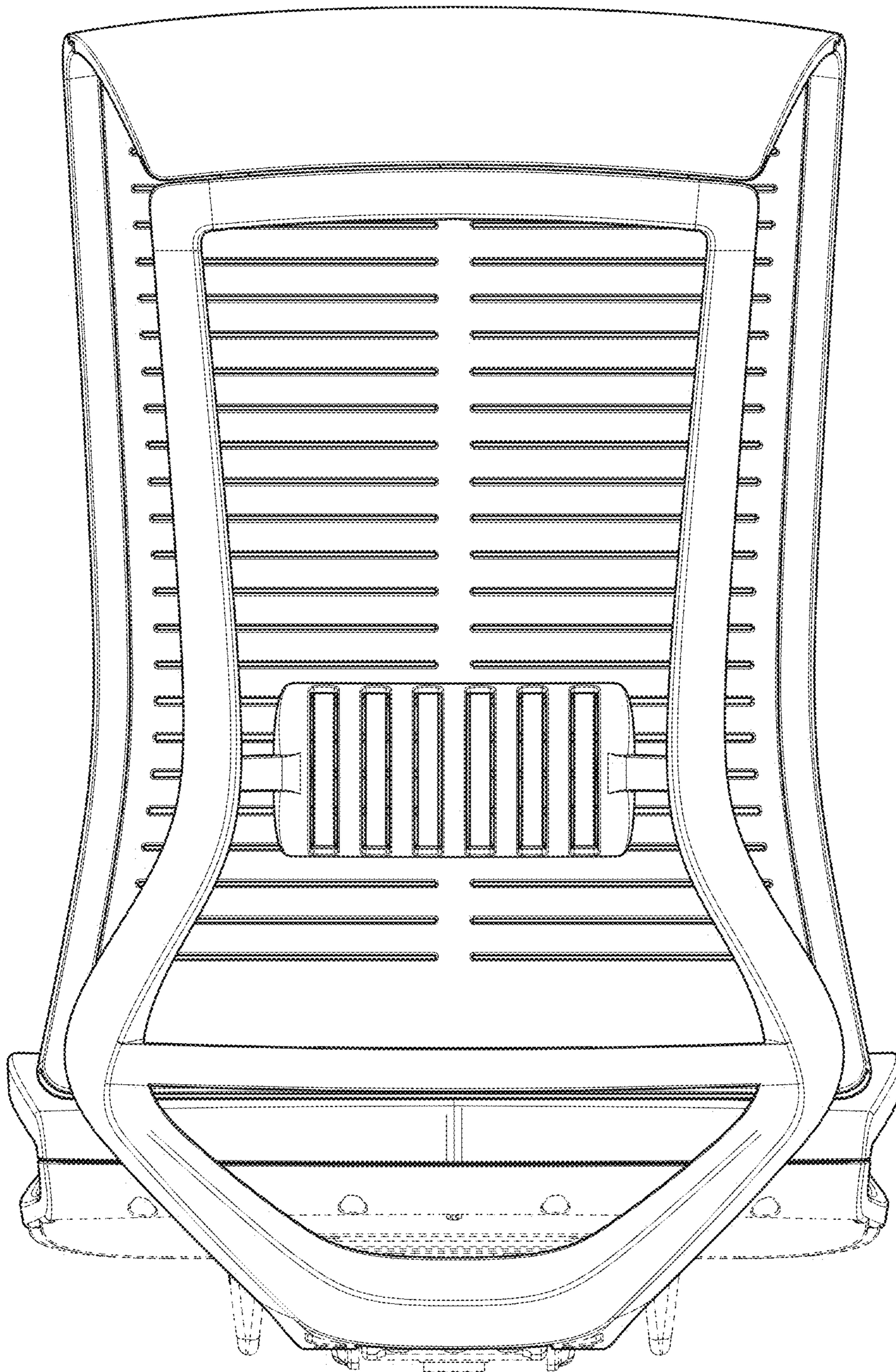

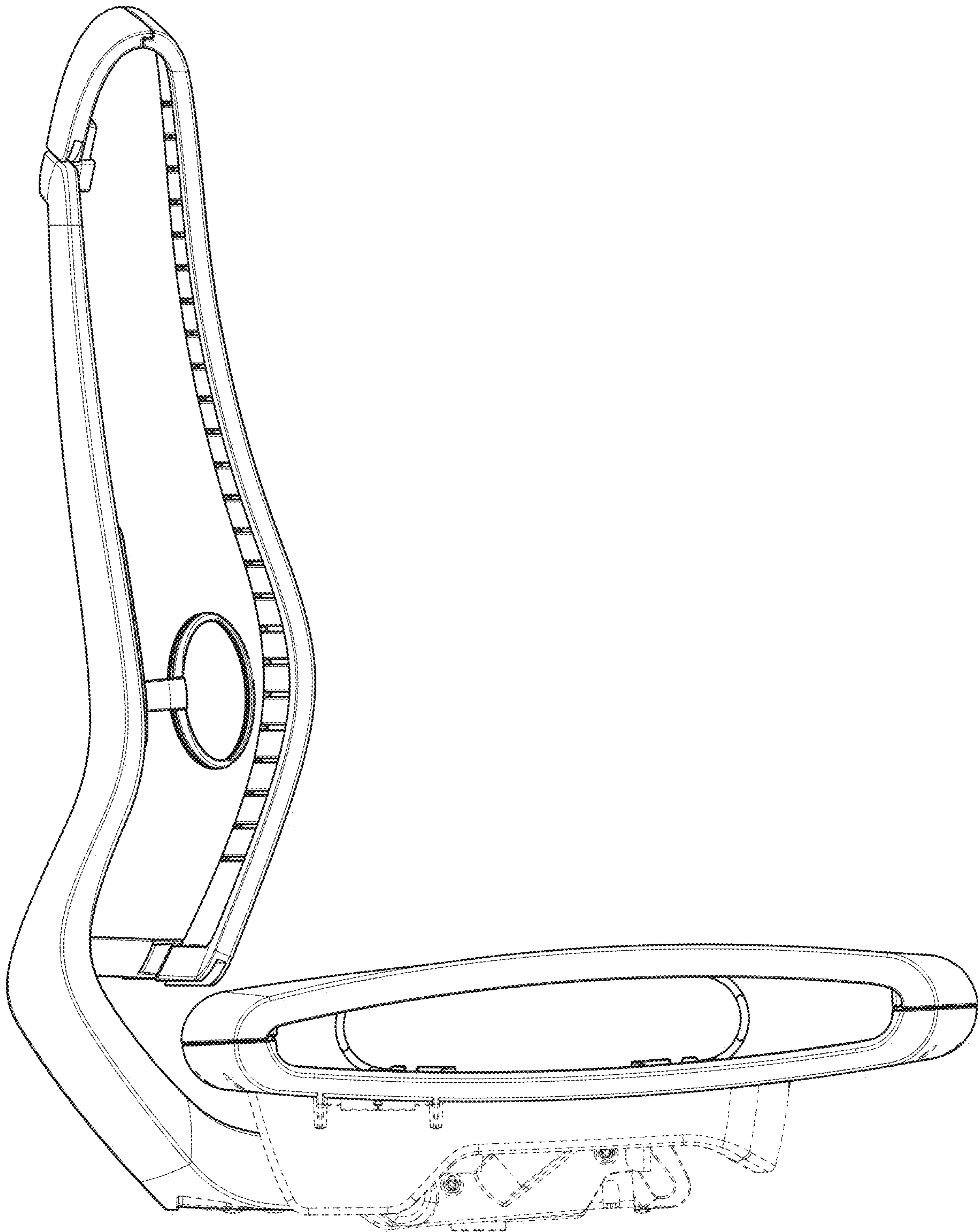

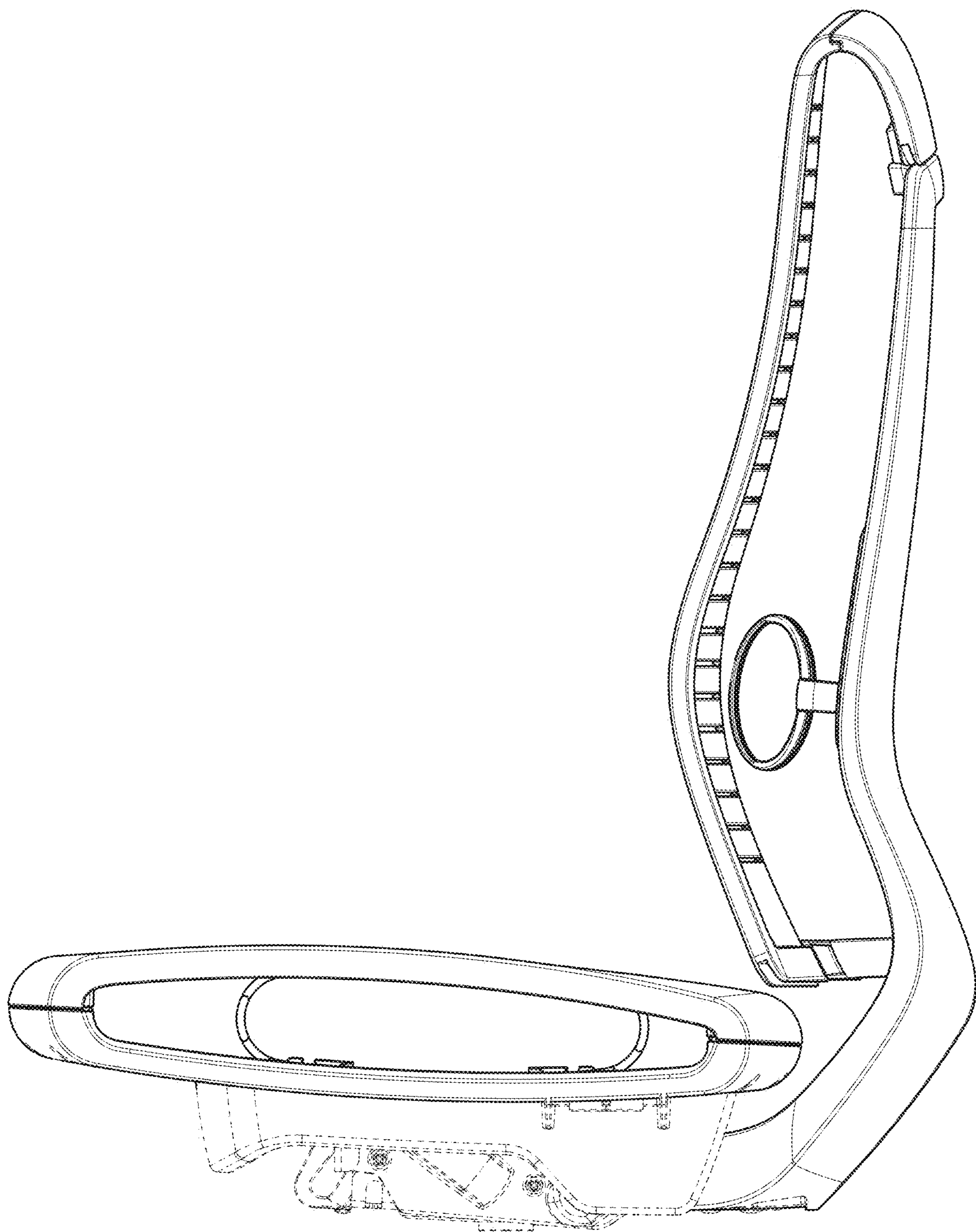
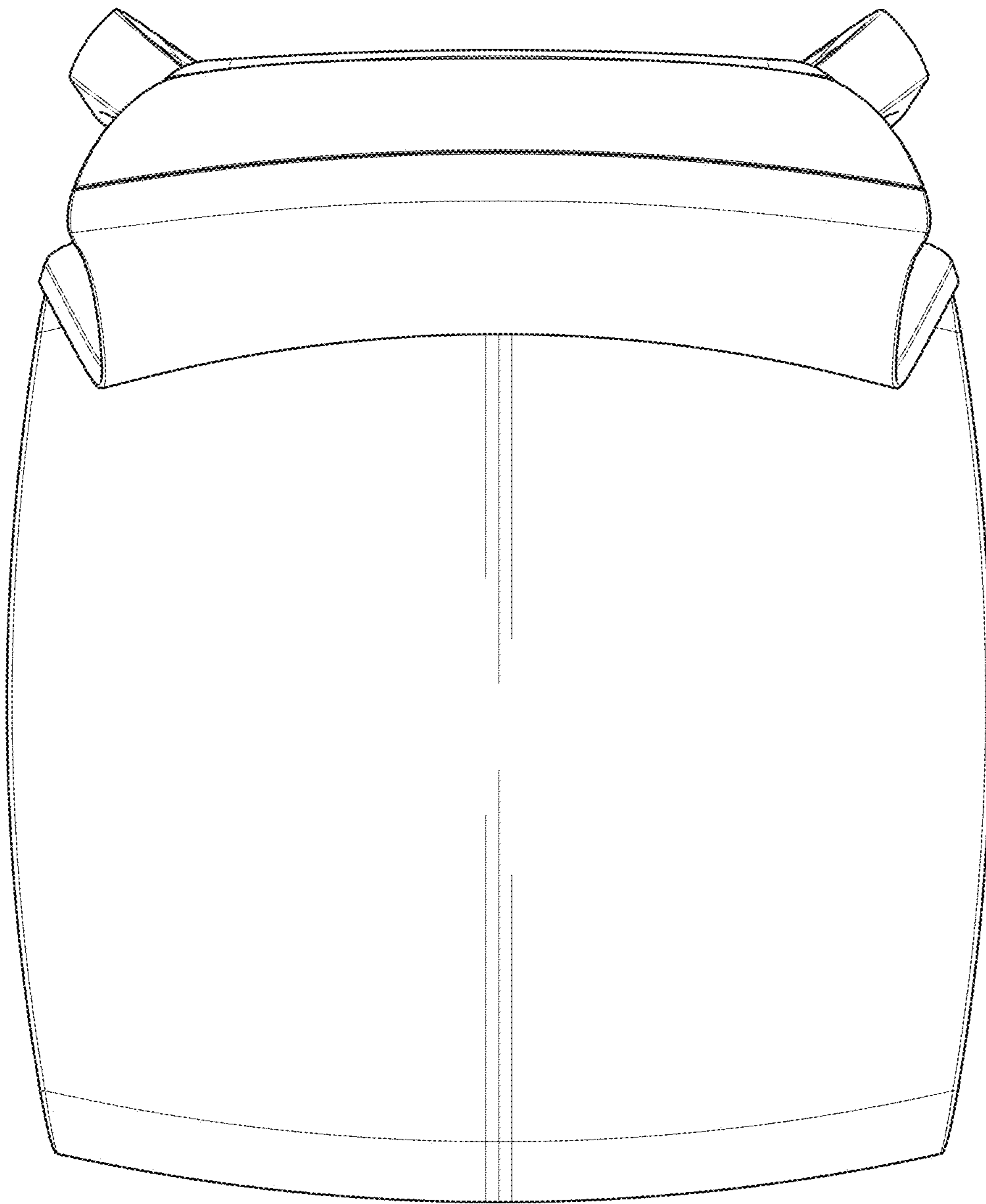

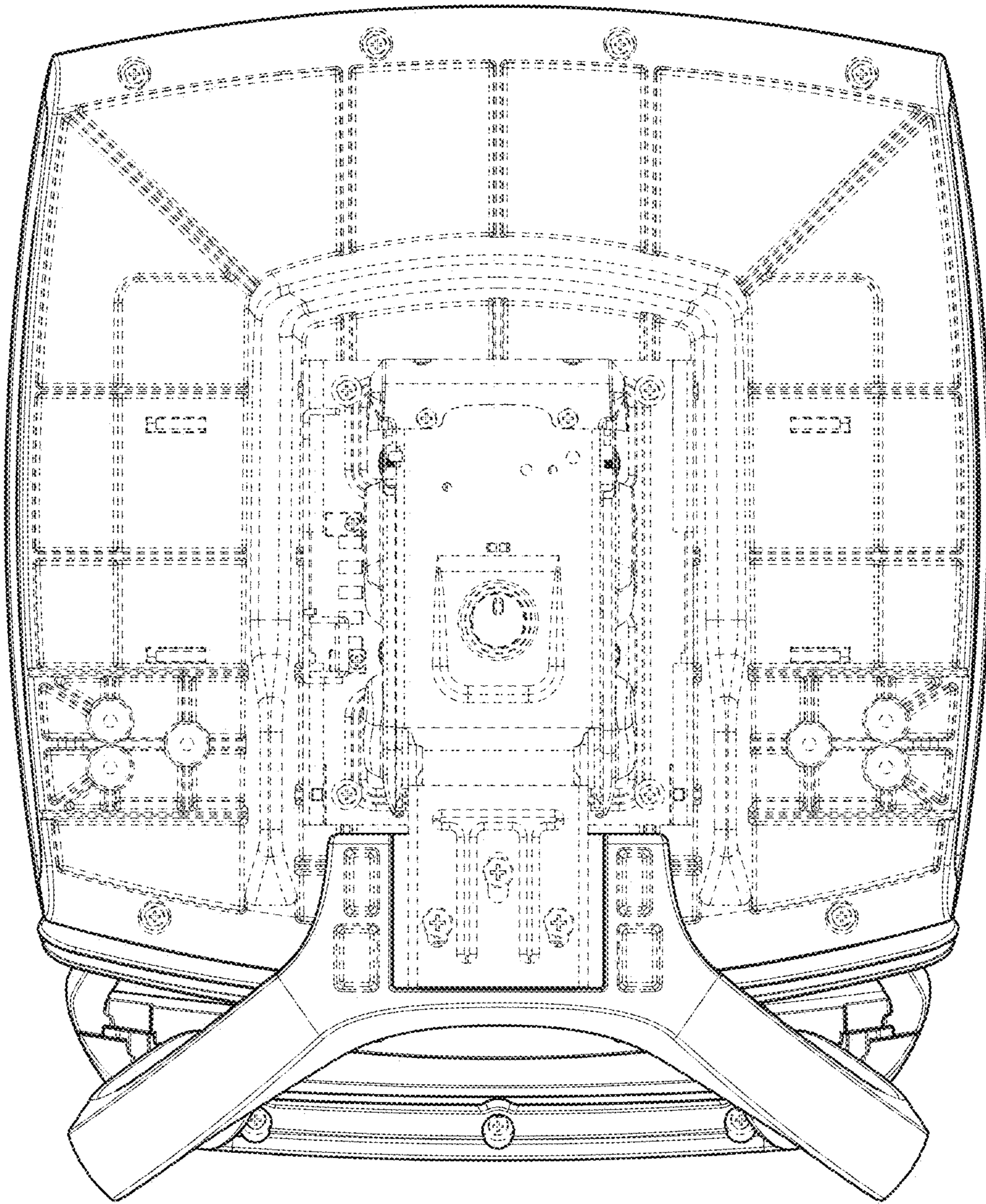
