(57) **CLAIM**

The ornamental design for an aerosol bottle for dispensing a foam hair care composition, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an aerosol bottle for a foam hair care composition, embodying our new design;

FIG. 5 is a left side view thereof;

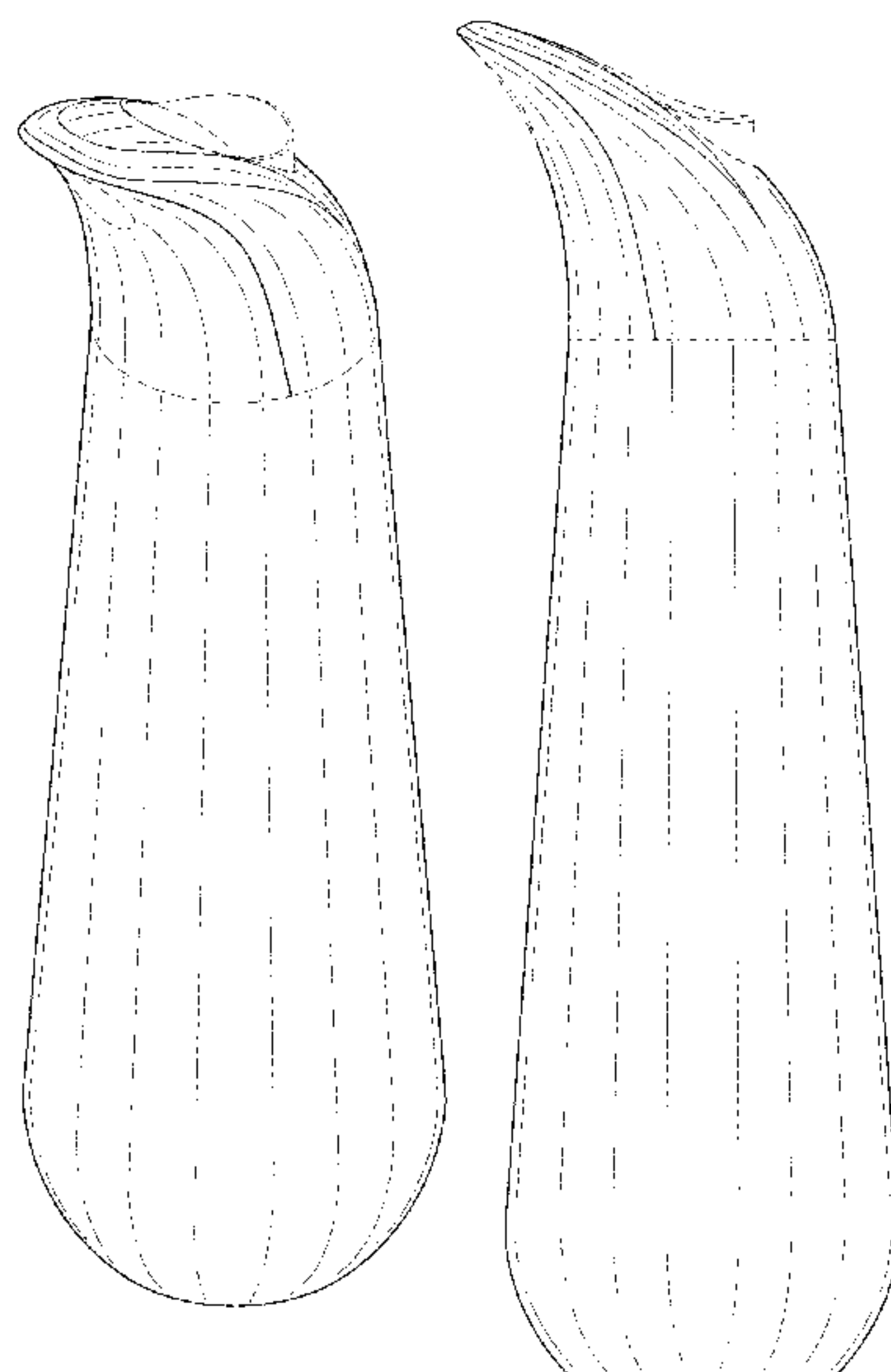
FIG. 6 is a top view thereof; and,

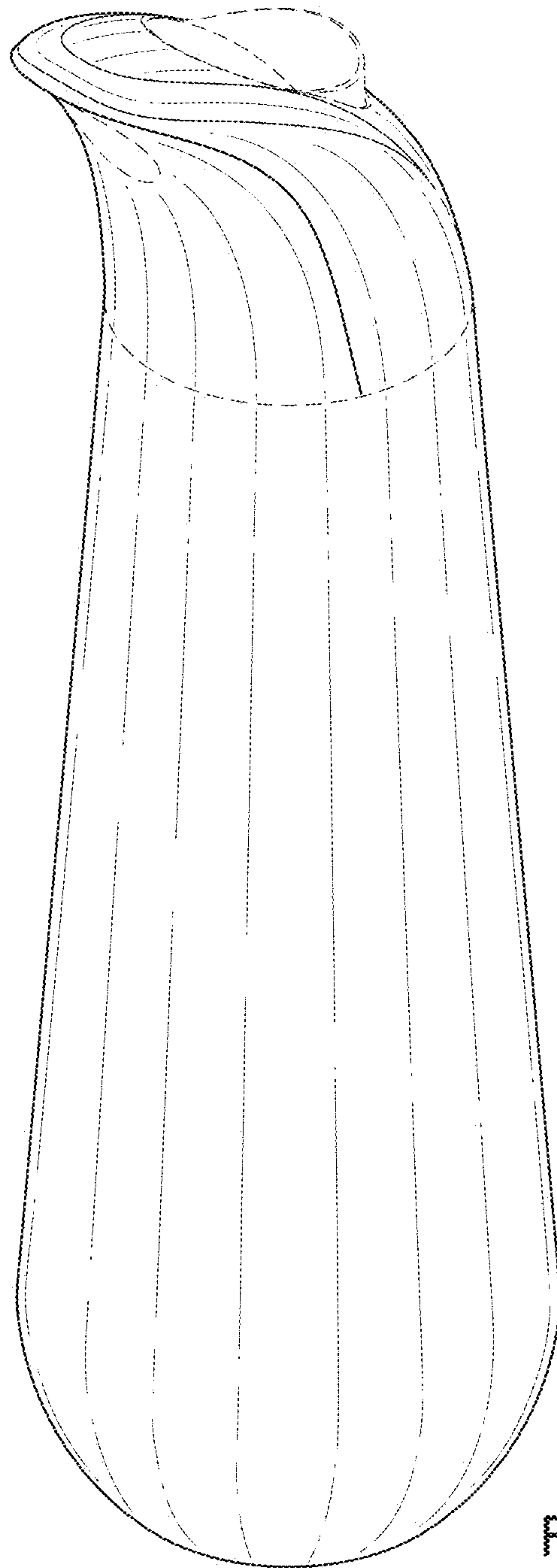

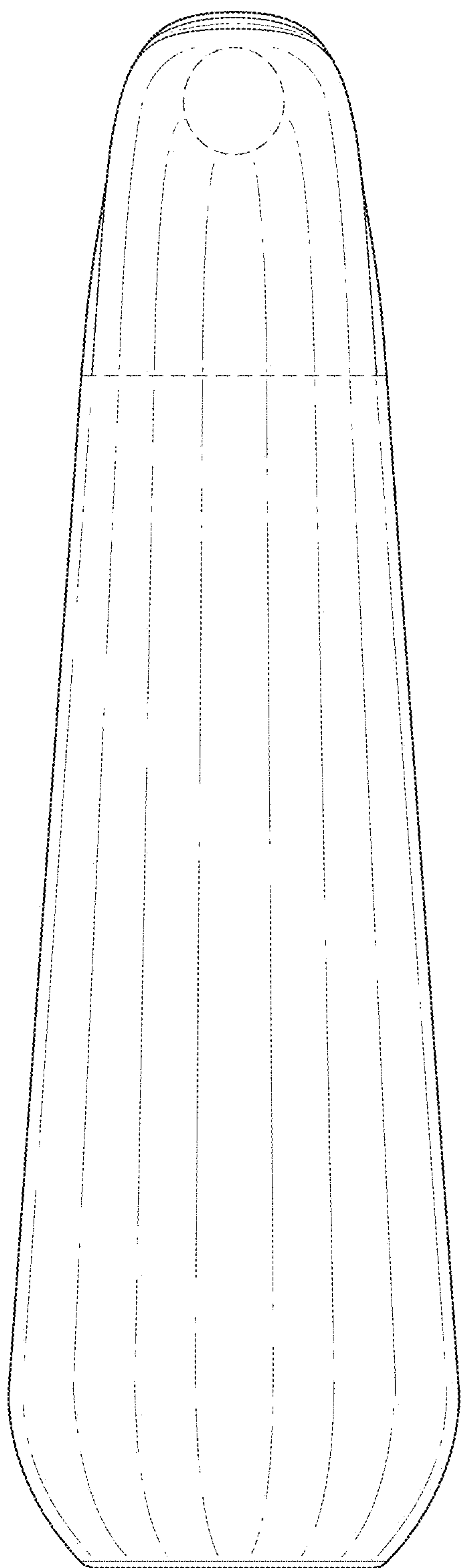

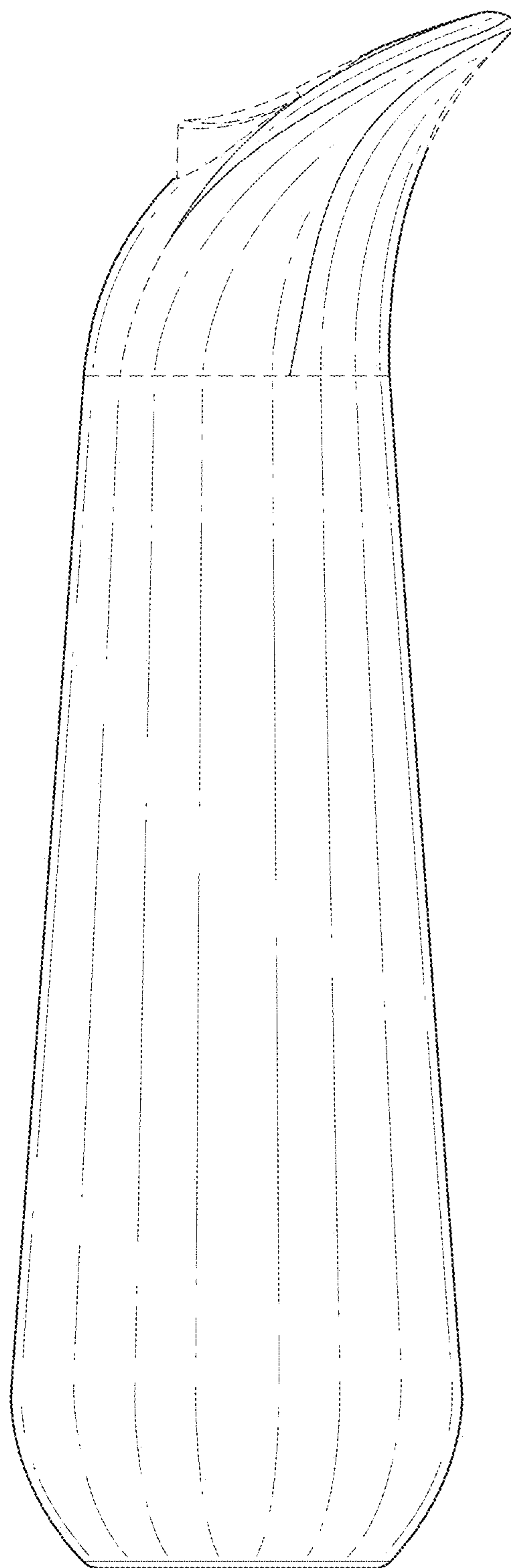

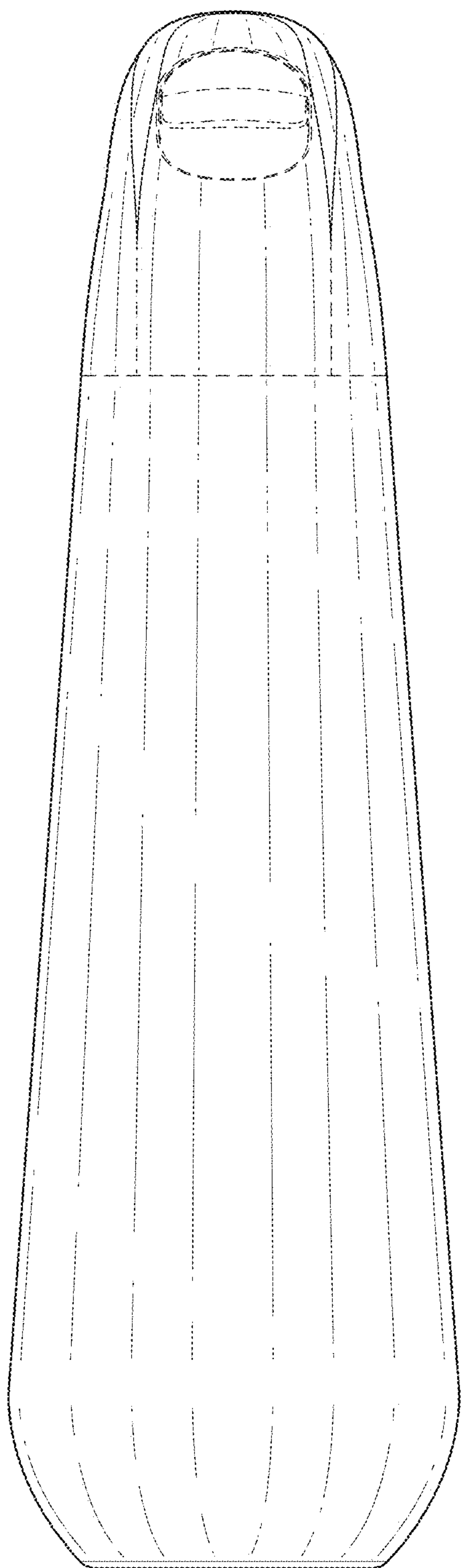

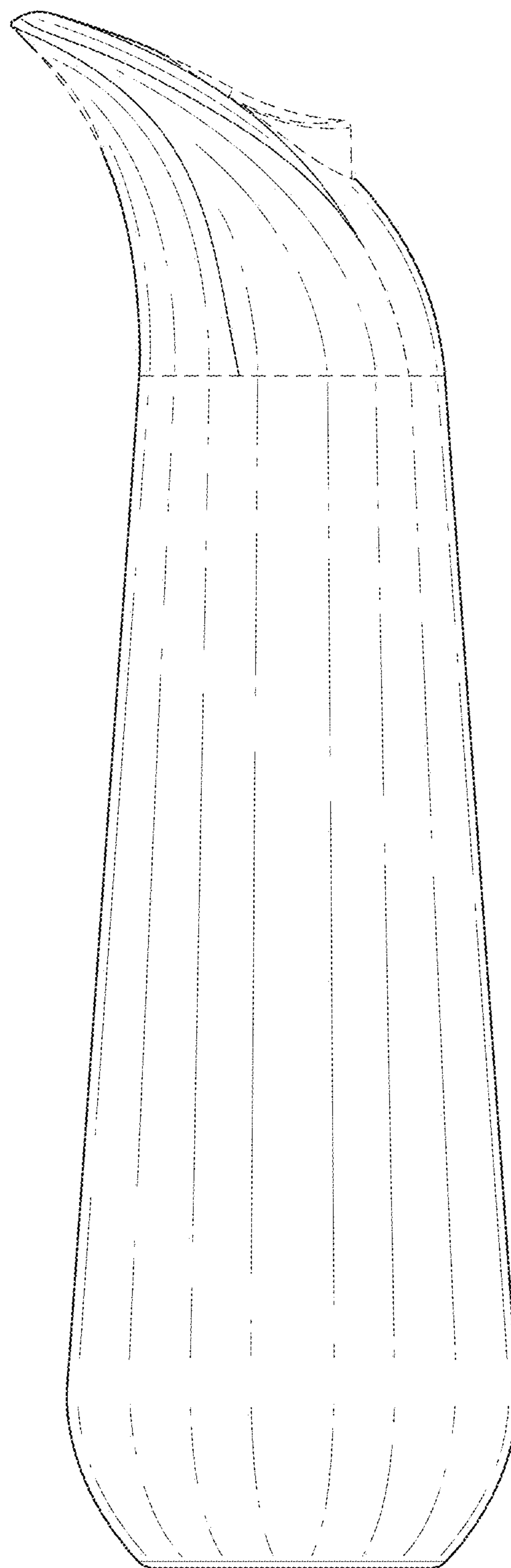

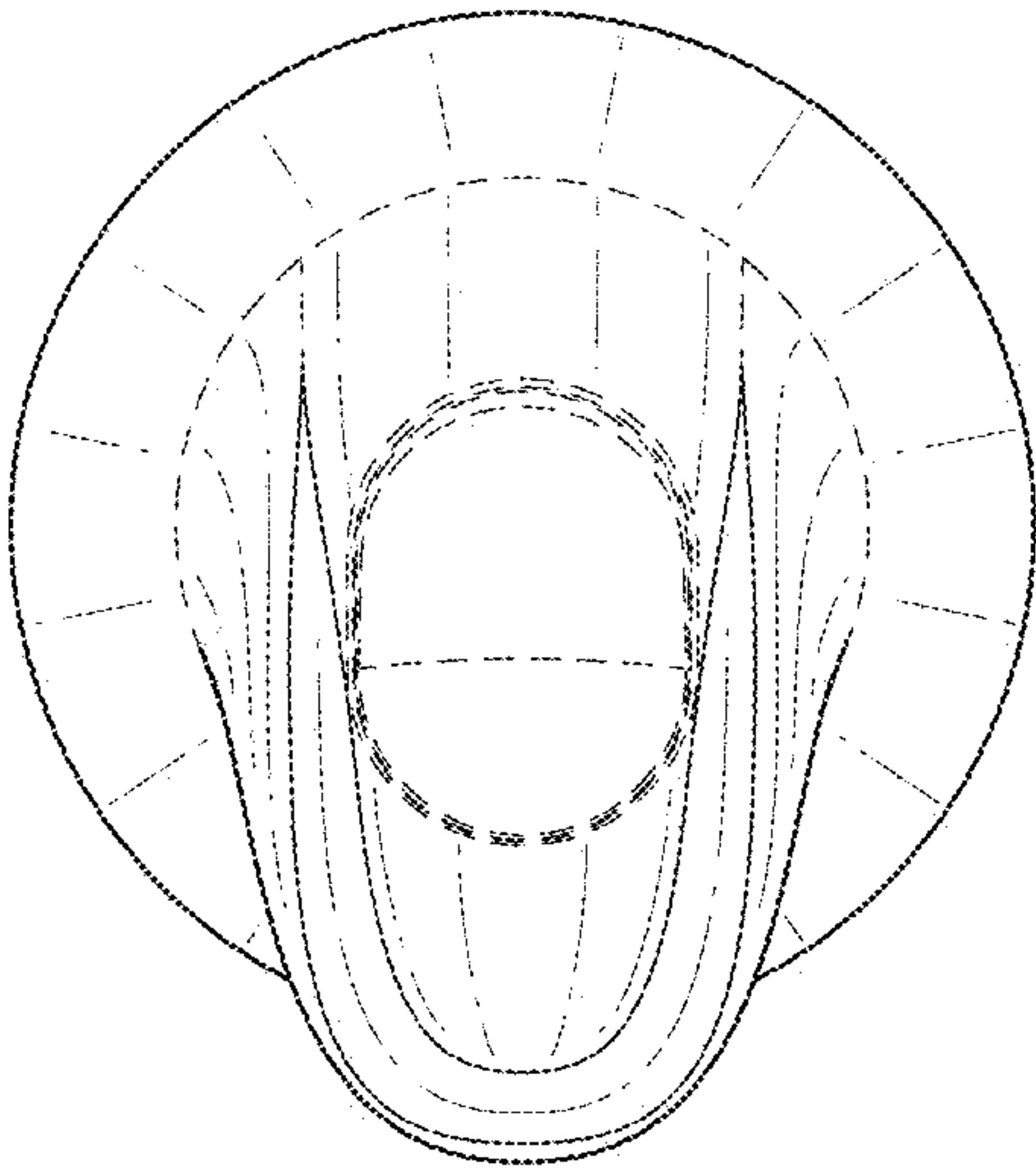

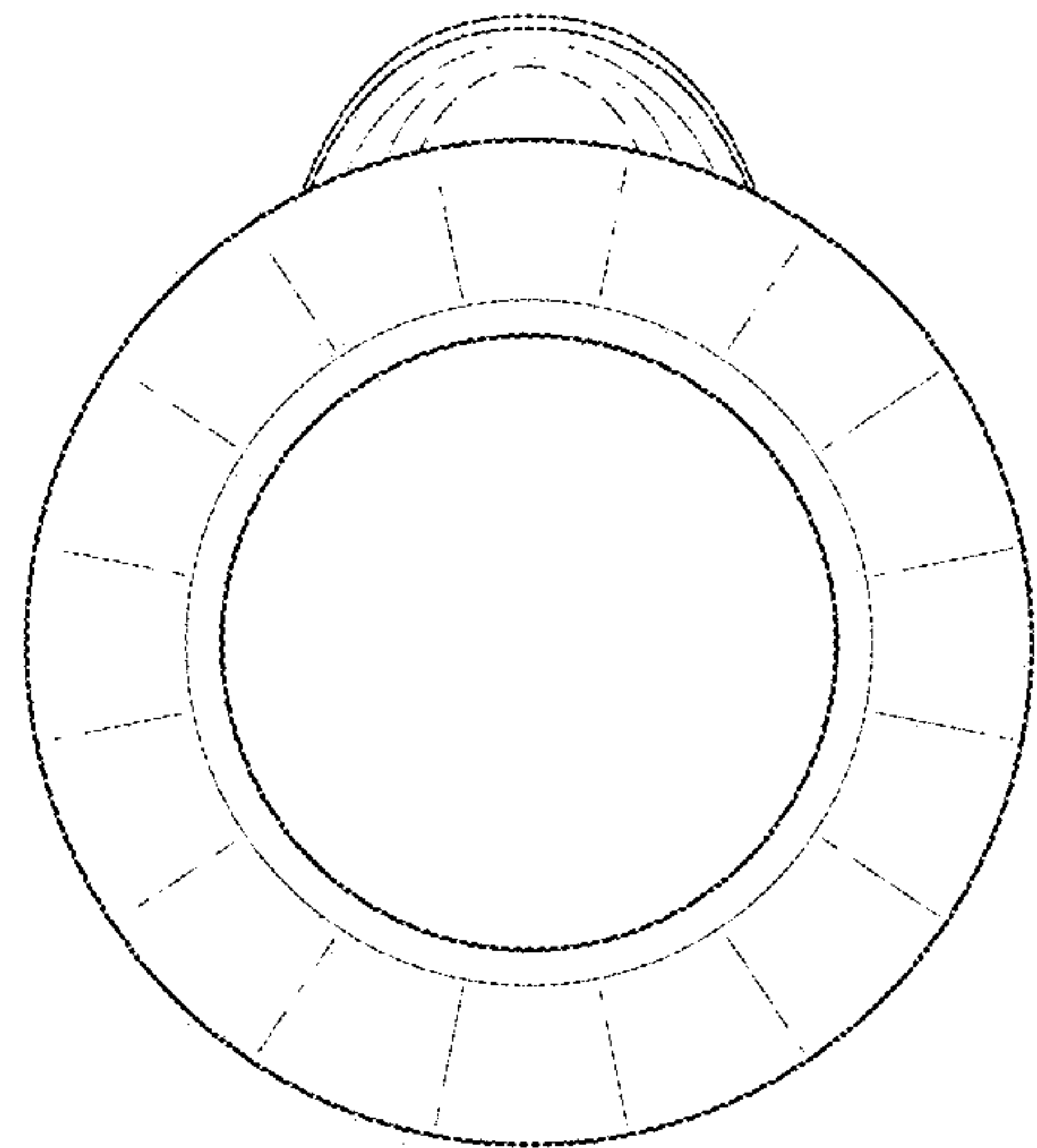
