FIG. 7 is a top left rear perspective view of a layout and measuring tool in accordance with our design; and,

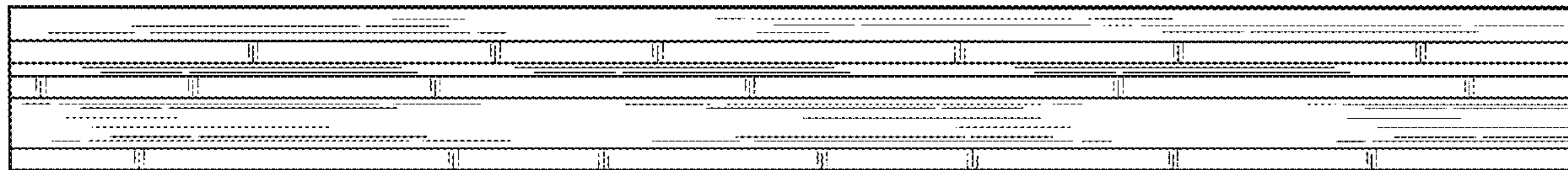
FIG. 8 is a bottom left front perspective view of a layout and measuring tool in accordance with our design.

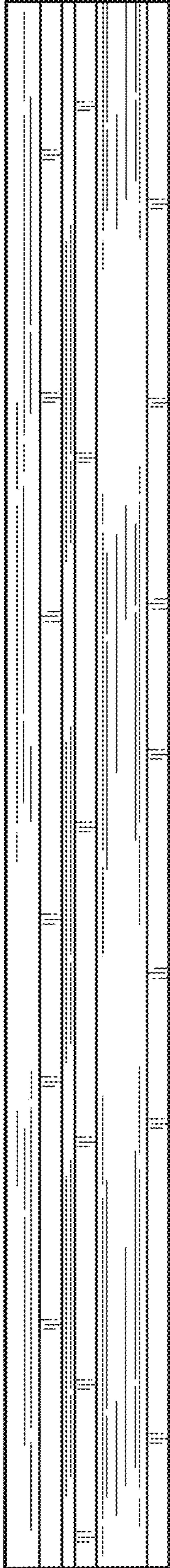

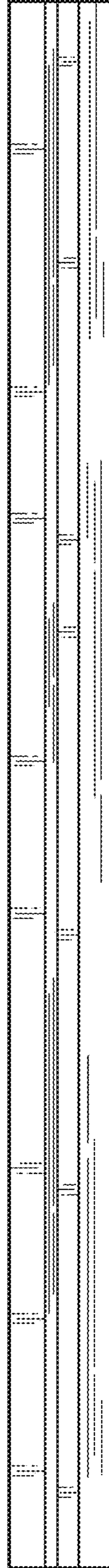

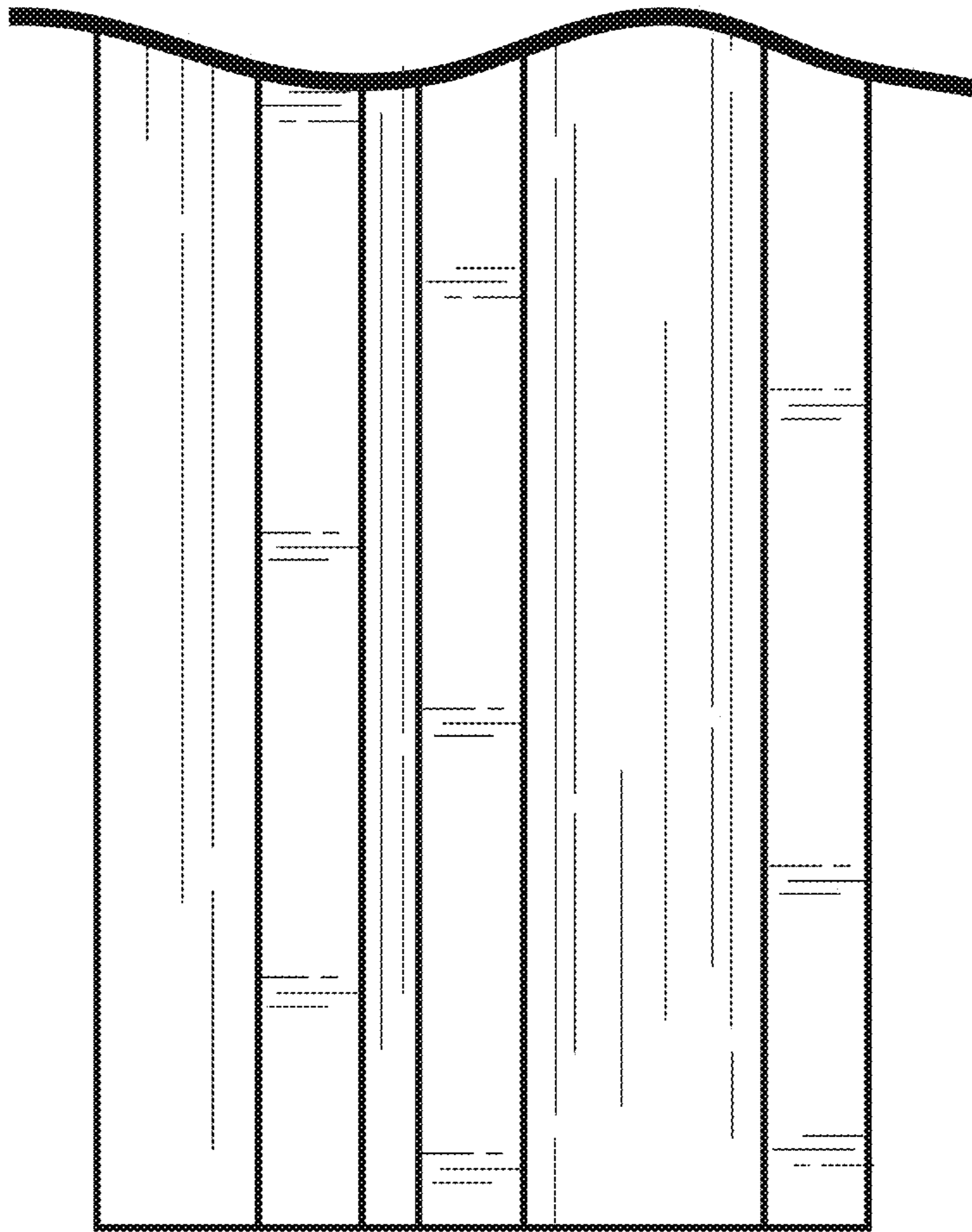

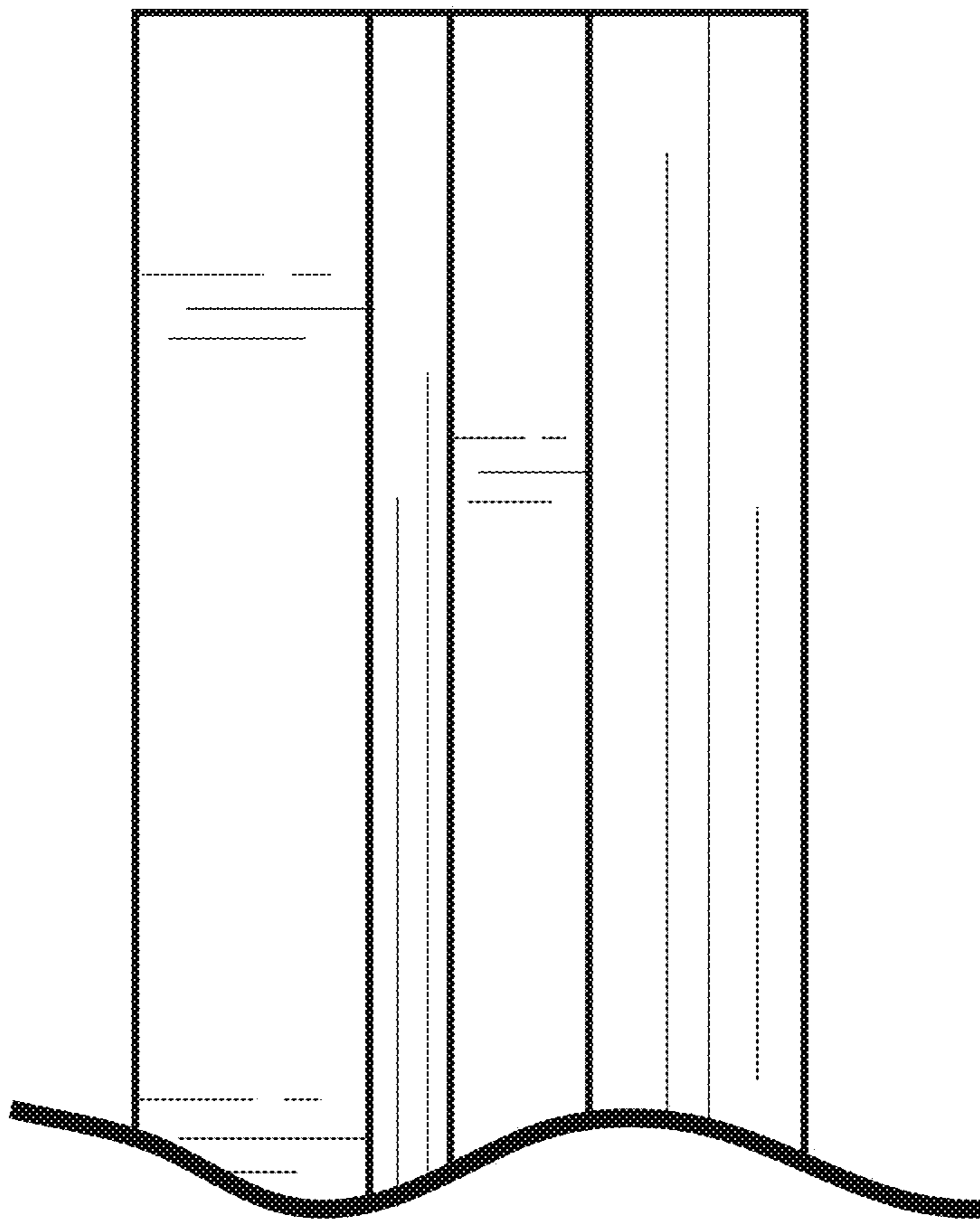

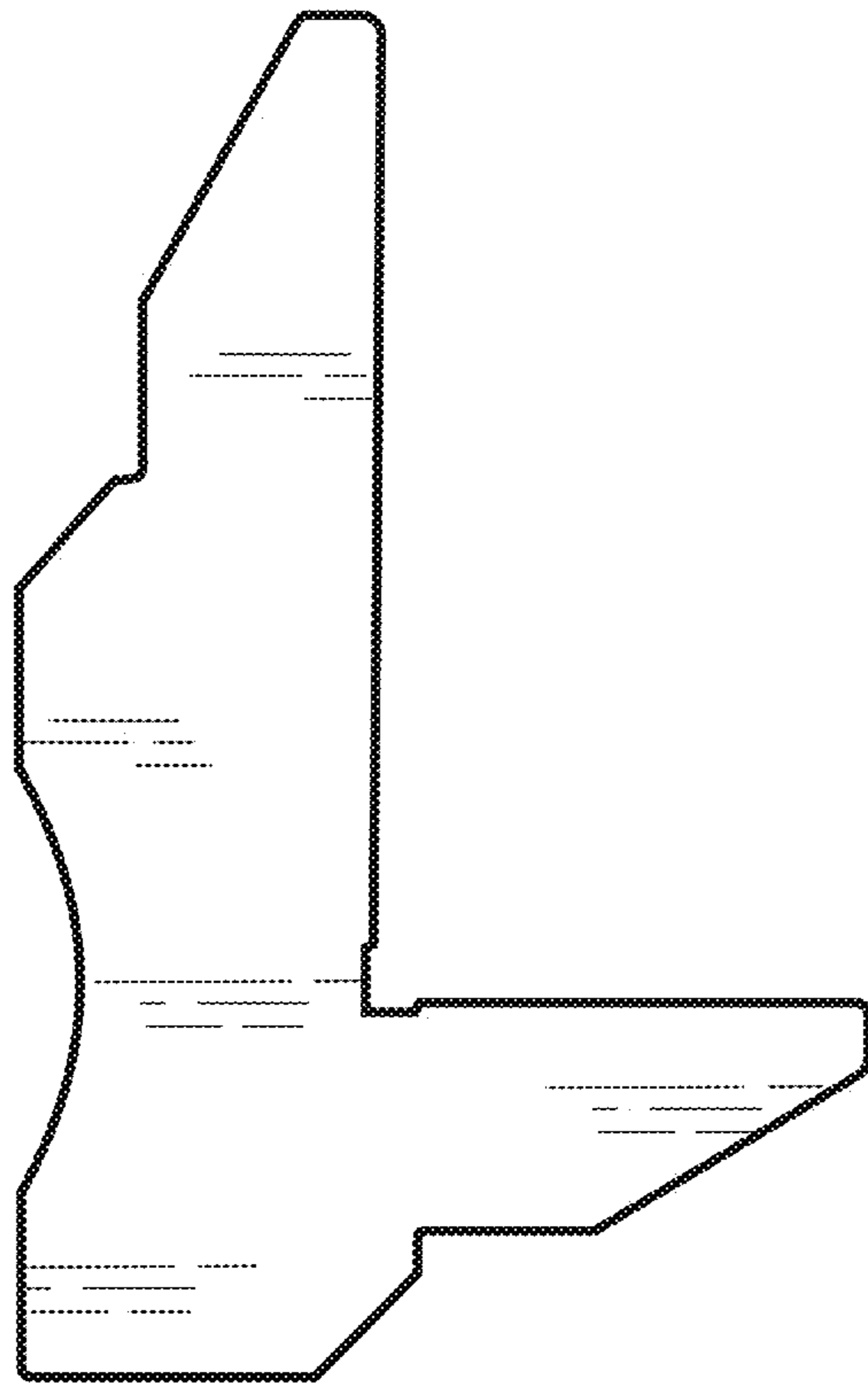

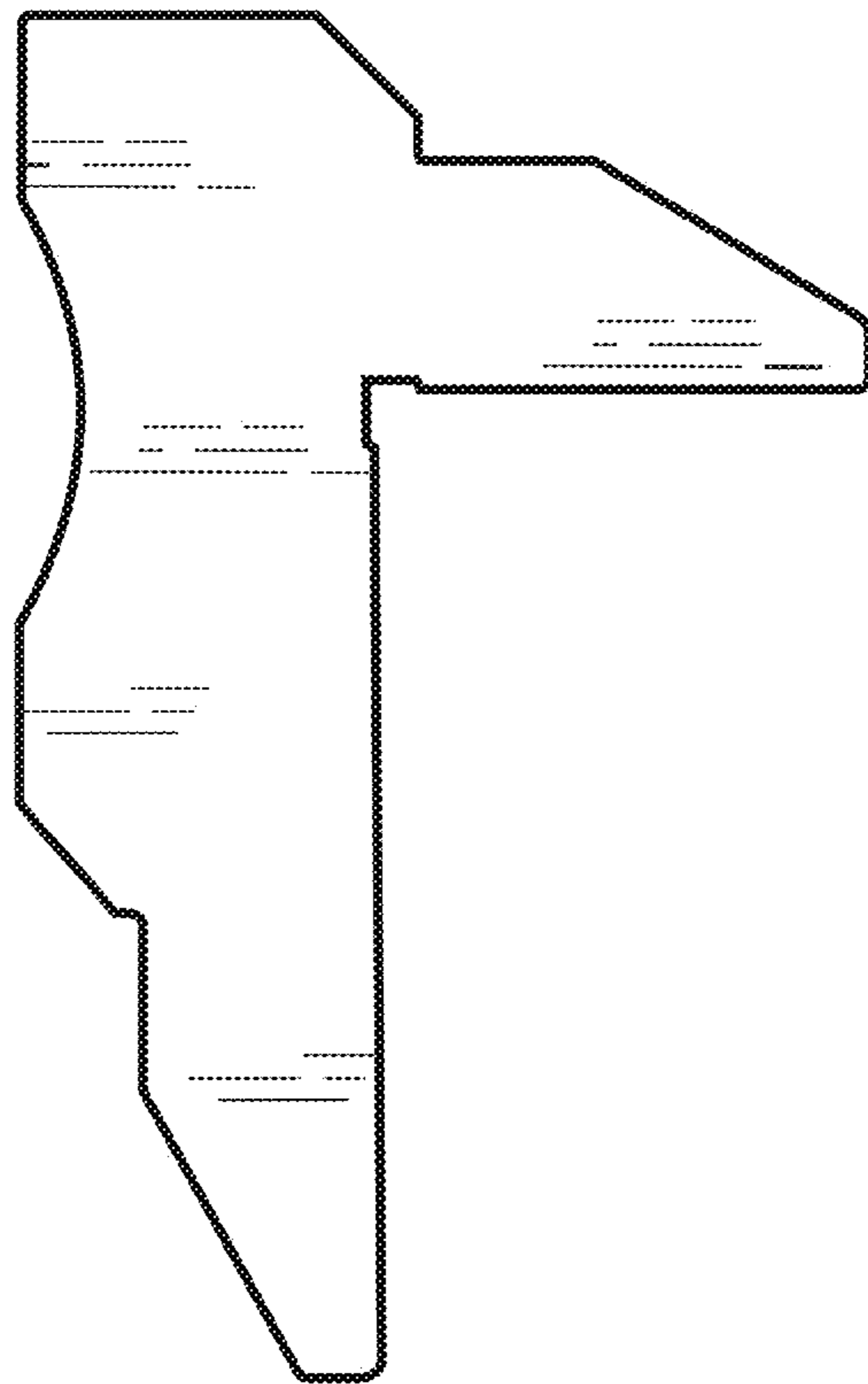

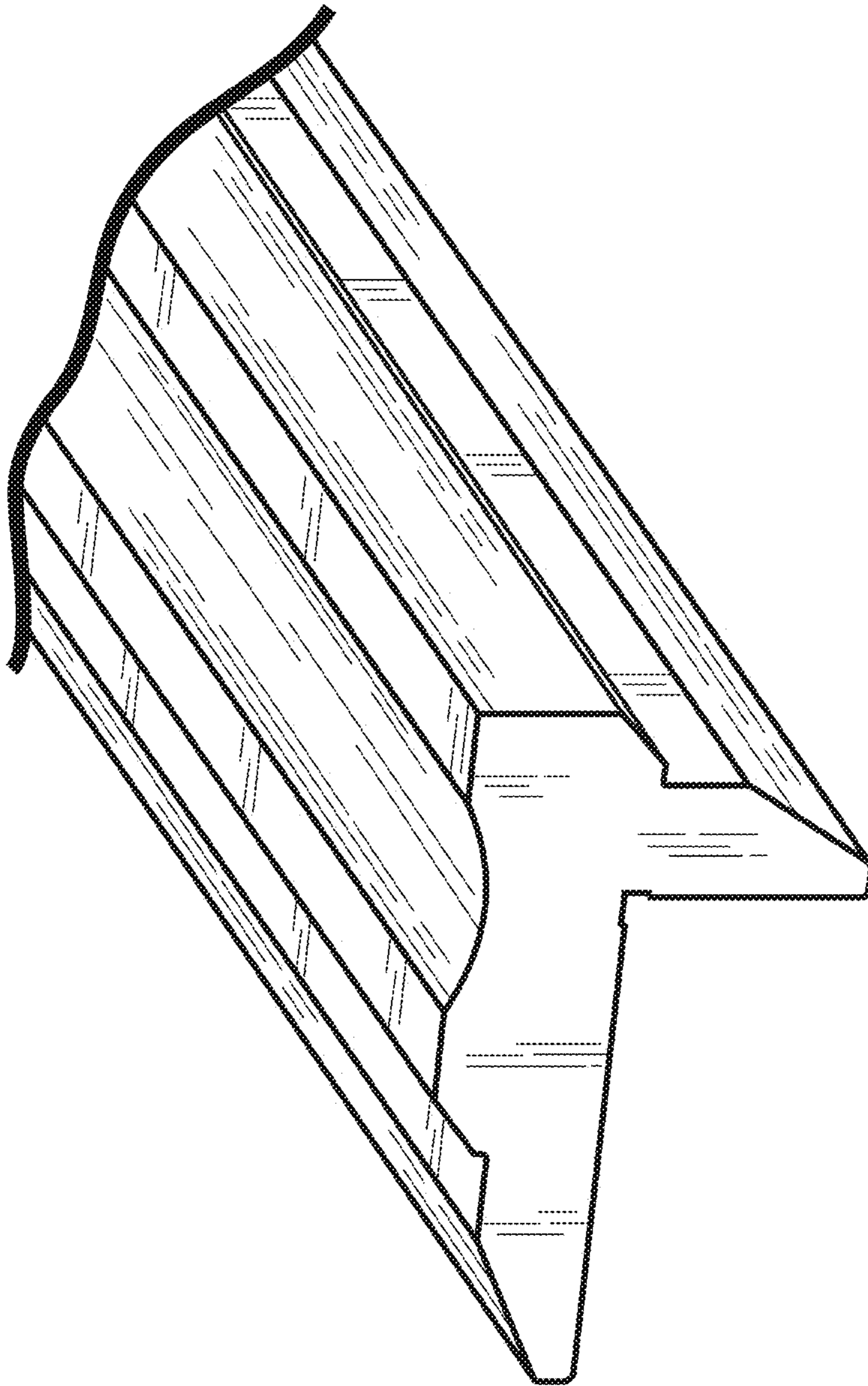

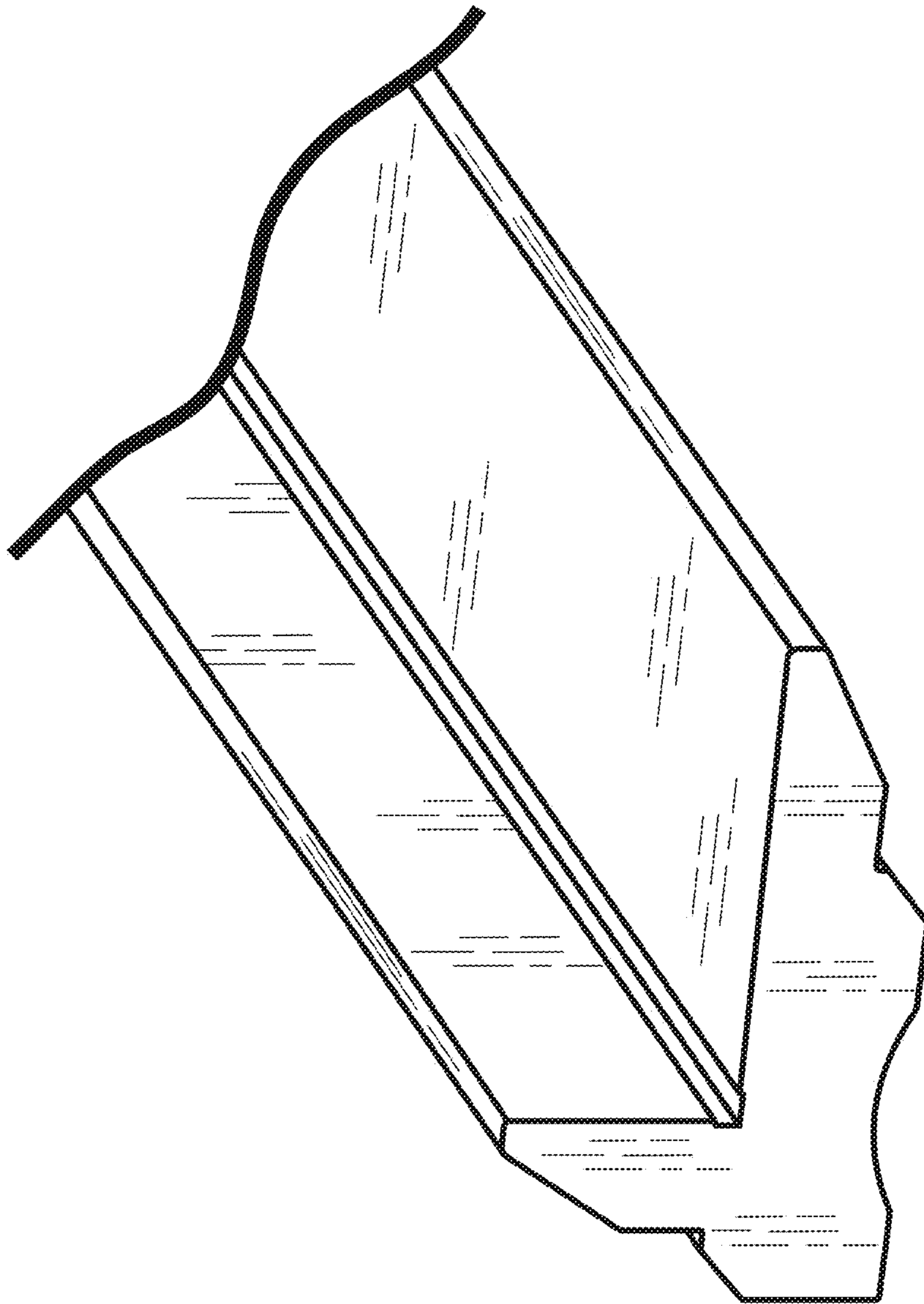
