**DESCRIPTION**

FIG. 7 is a left side elevational view of the microphone;

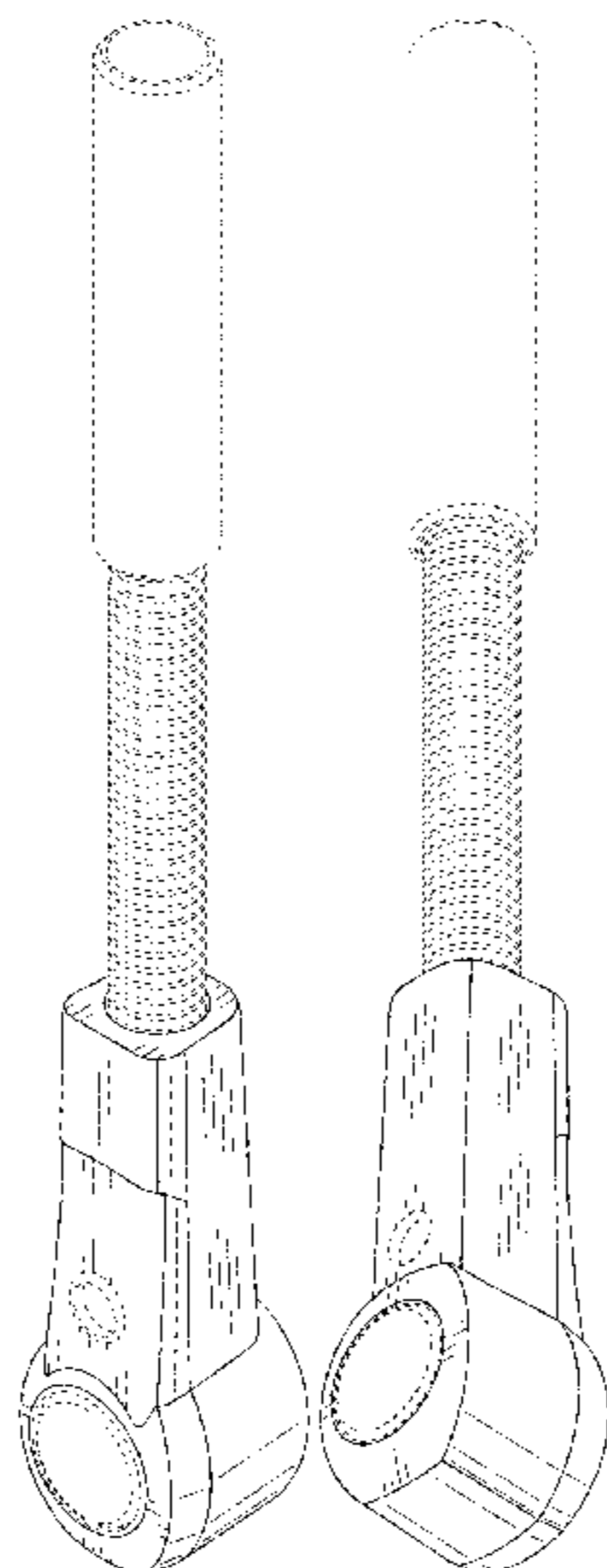
FIG. 8 is a right side elevational view of the microphone;

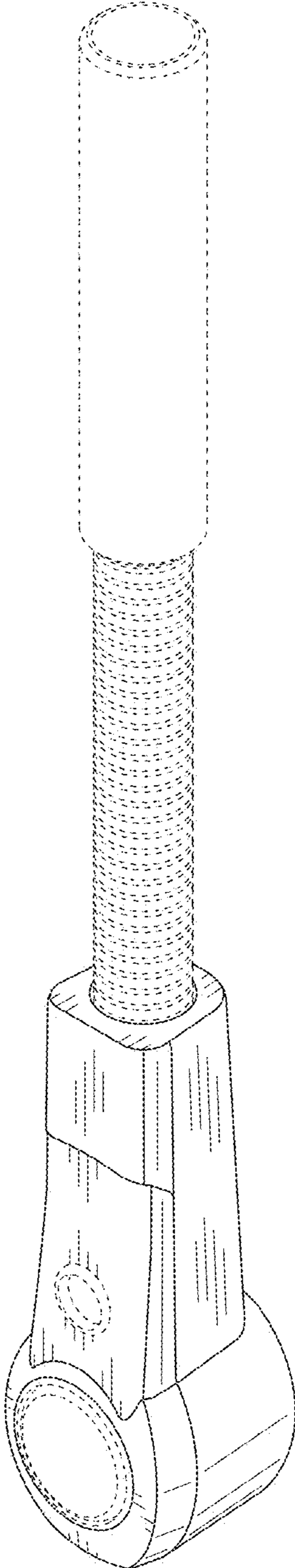

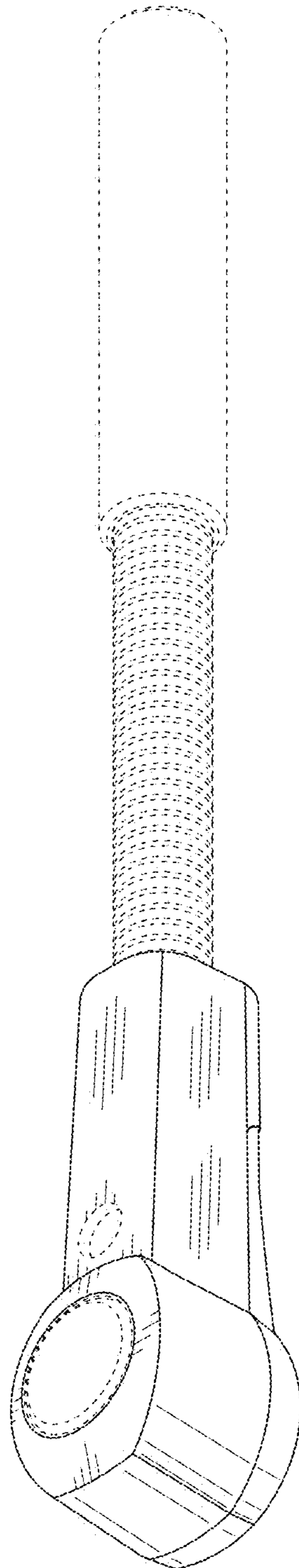

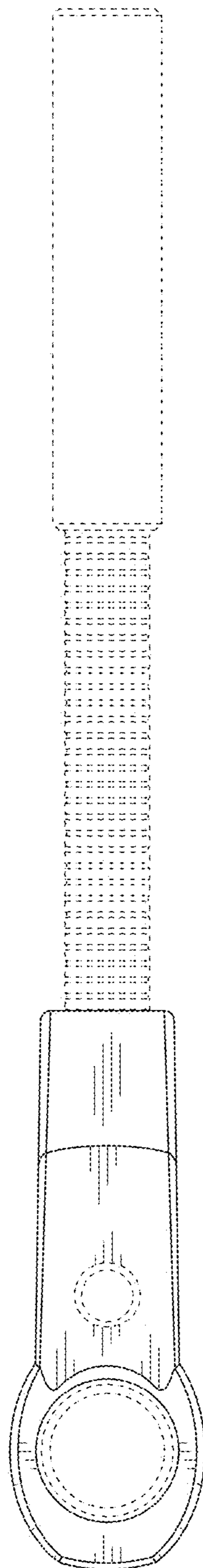

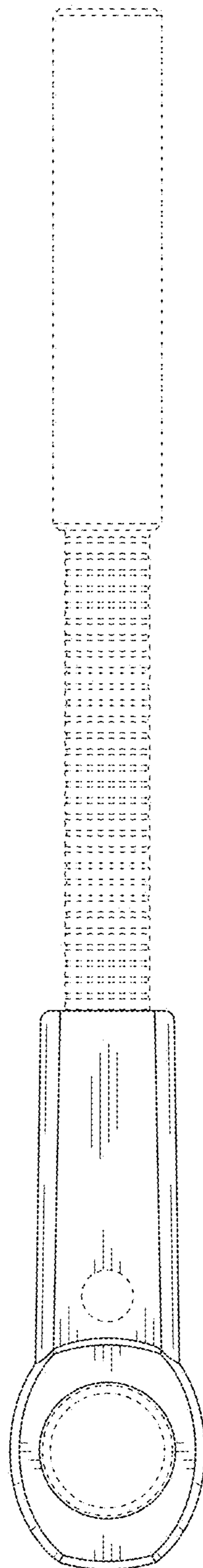

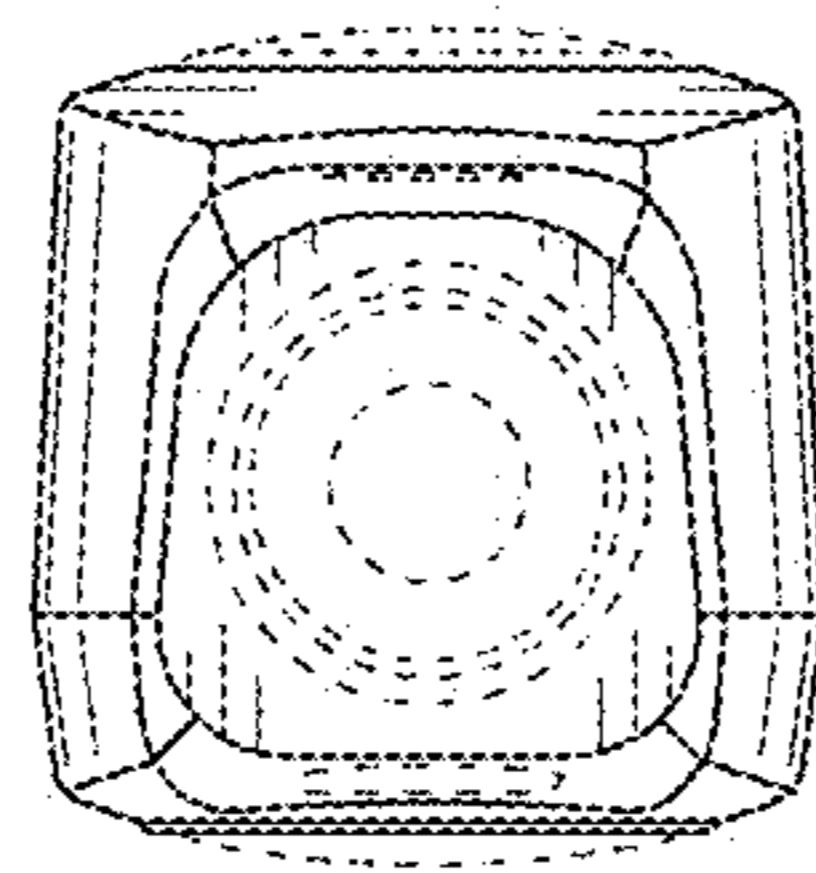

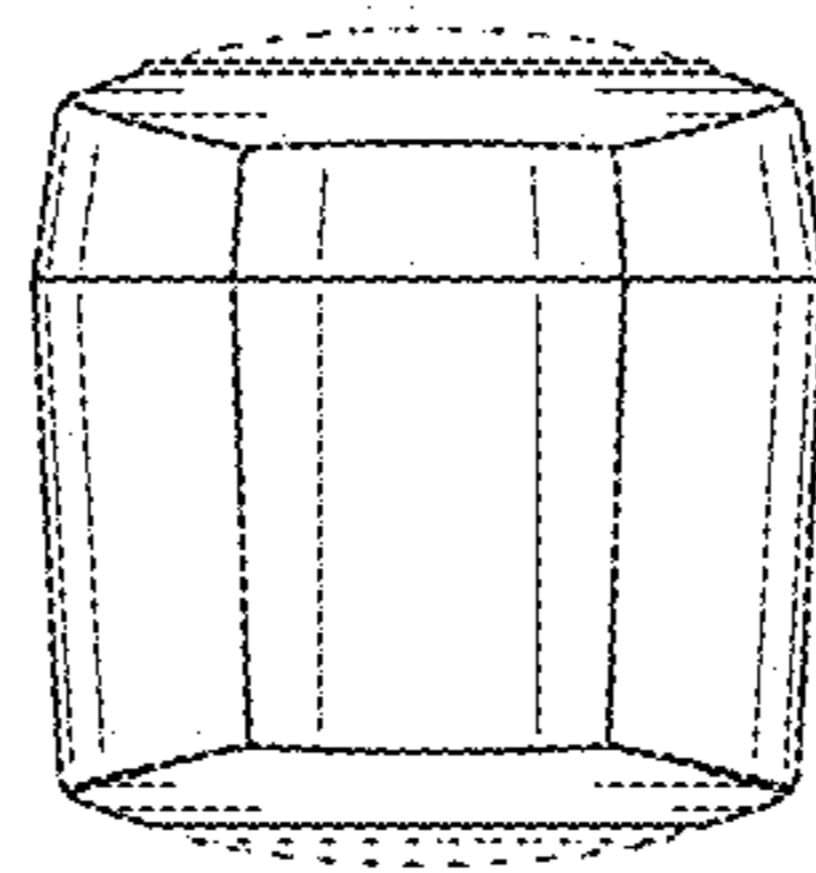

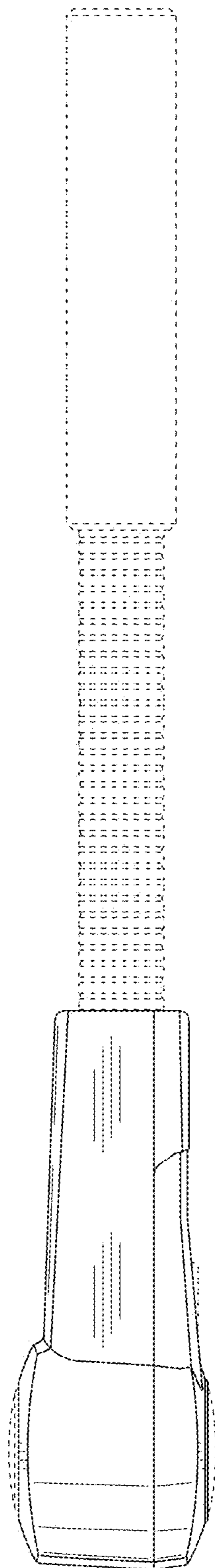

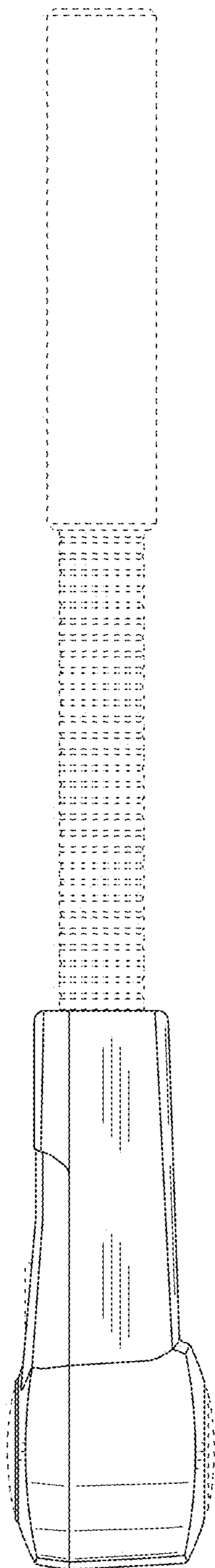
